The ornamental design for an illuminated multiple-ovular zippered binder, as shown and described.

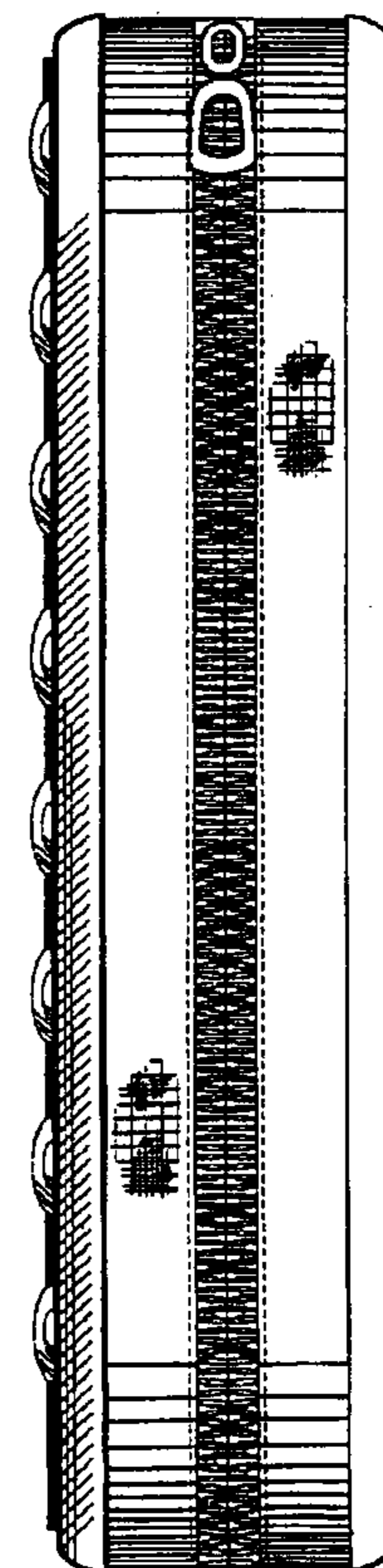
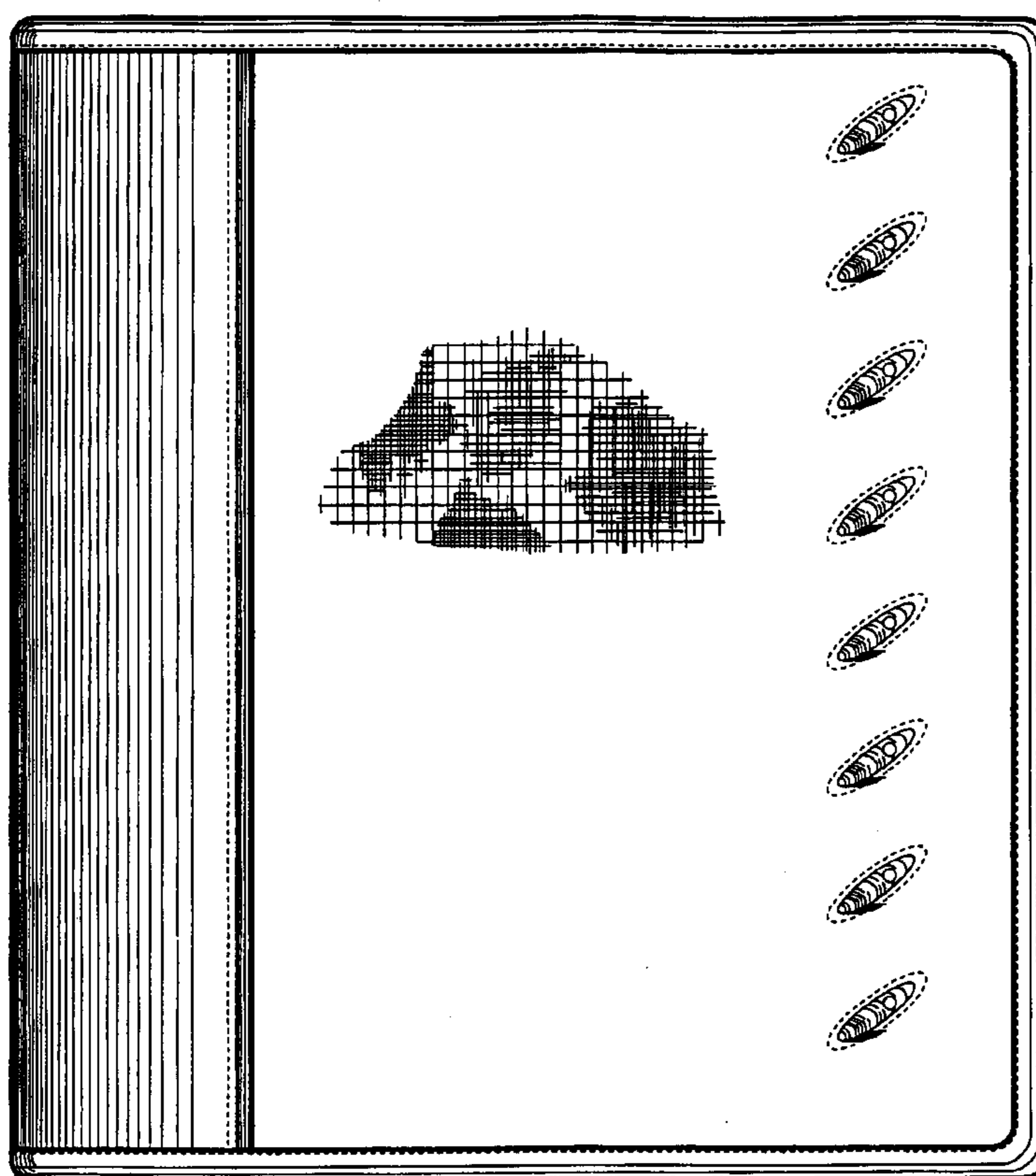
**DESCRIPTION**

FIG. 1 is a front elevational view of an illuminated multiple-ovular zippered binder showing my design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a right-side elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is an enlarged plan view thereof; and, FIG. 6 is an enlarged bottom plan view thereof.

The short broken lines in the drawings represent a pattern of stitching.

The fragmentary criss-cross pattern shown in the drawings represents material and is understood to be distributed uniformly over the surfaces on which it is shown.

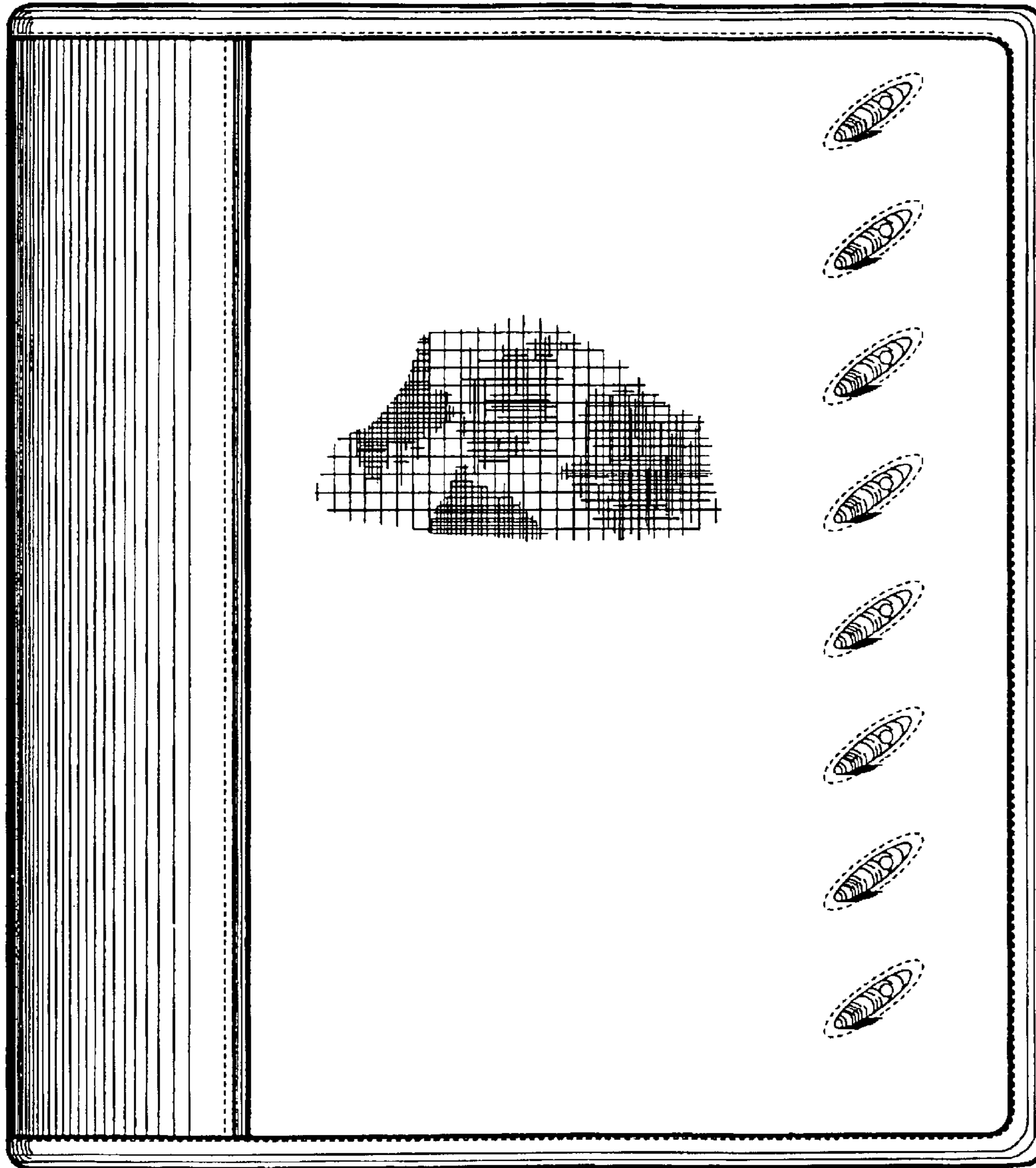

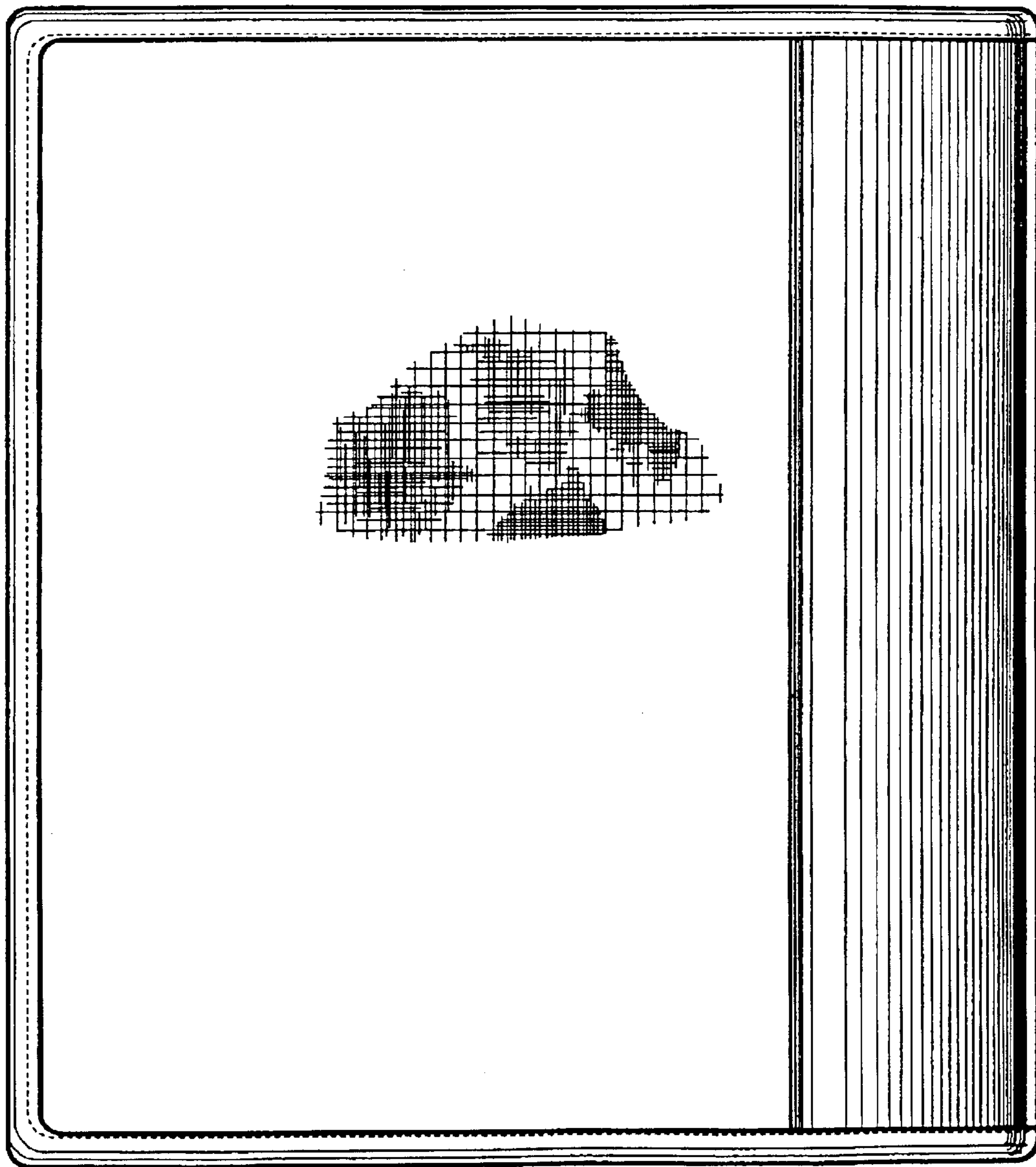

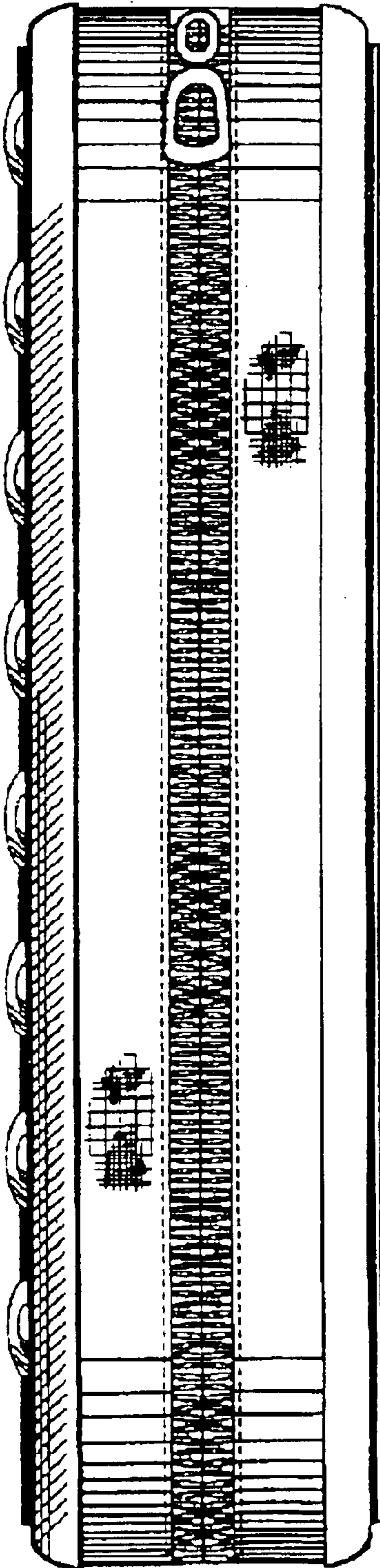

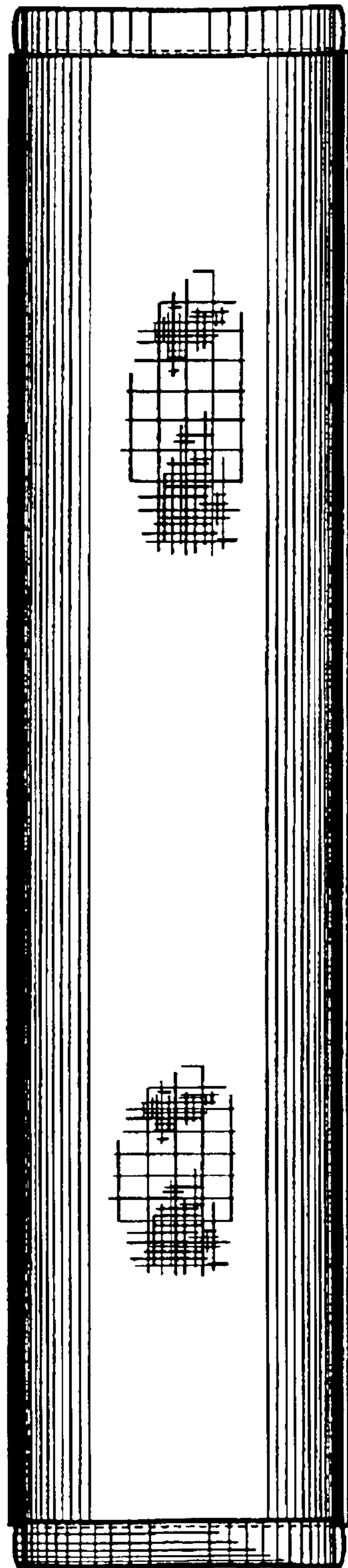

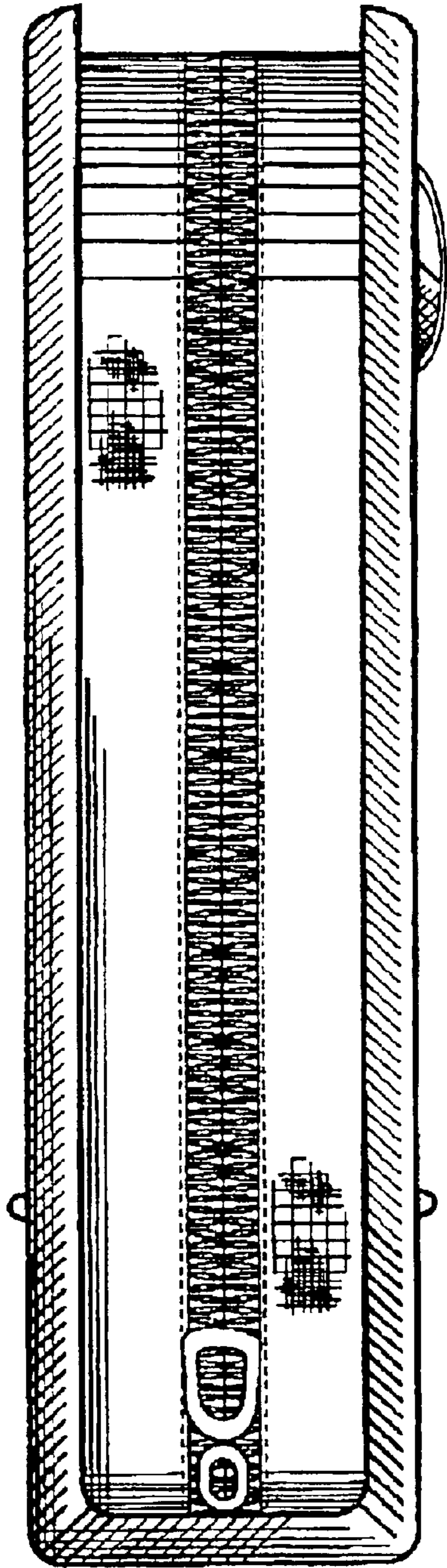

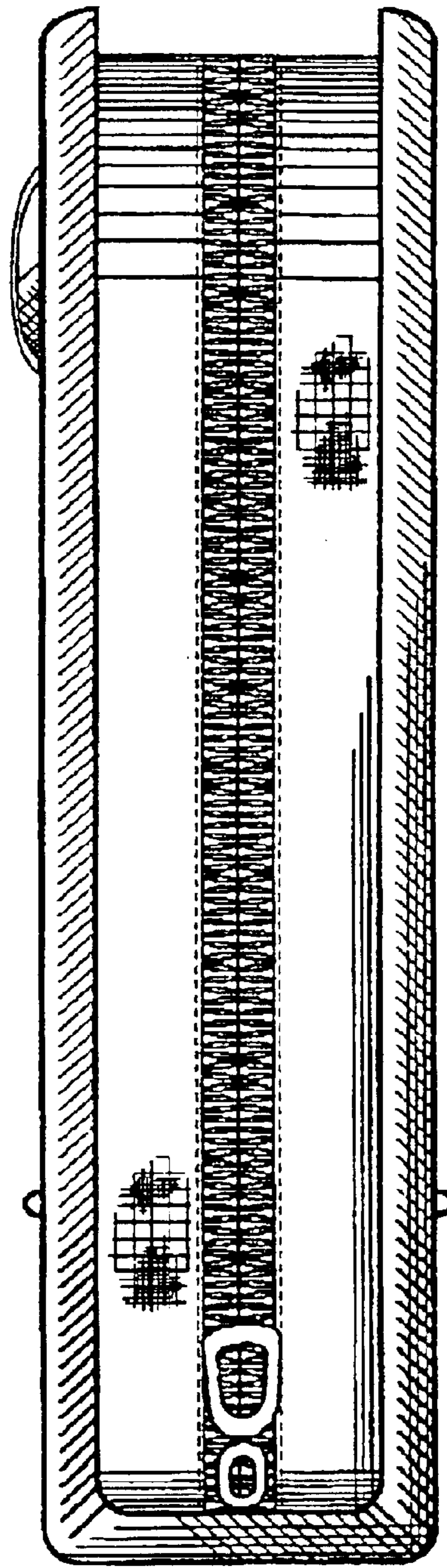
