FIG. 1 is a perspective view of an antiperspirant and/or deodorant product showing the new design;

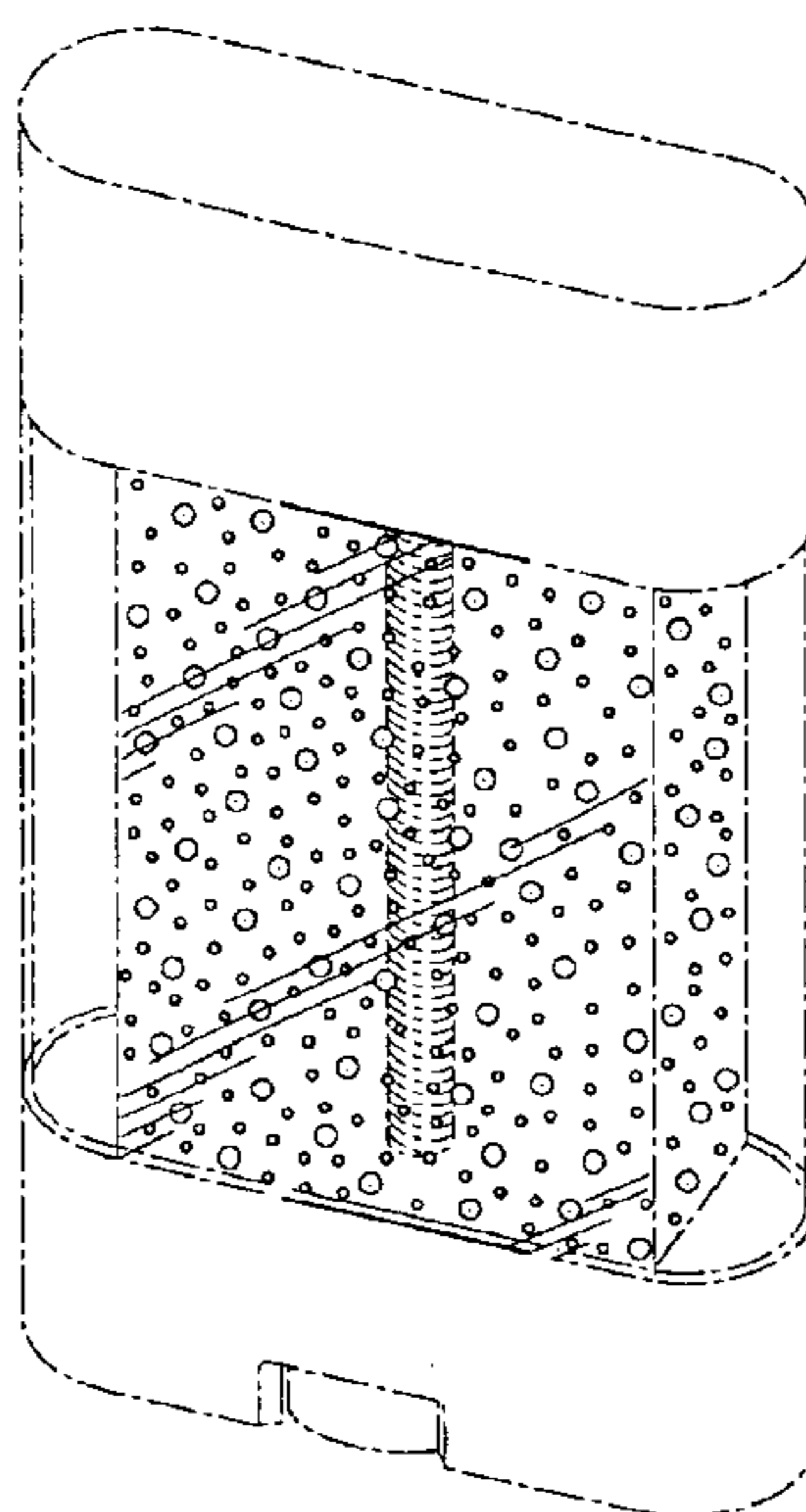
FIG. 2 is a front elevation view of the antiperspirant and/or deodorant product of FIG. 1, the rear elevation view being a mirror image thereof; and,

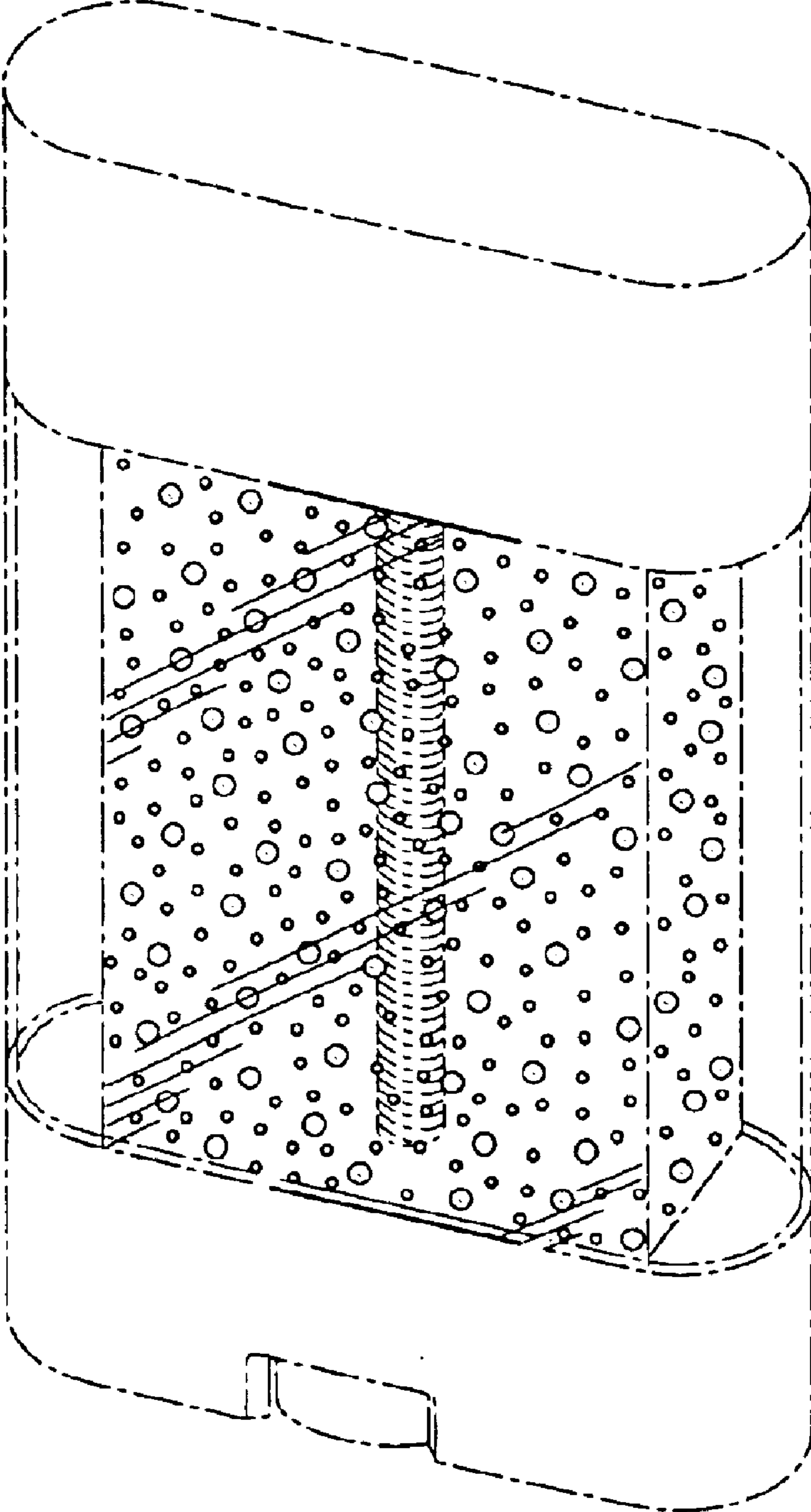

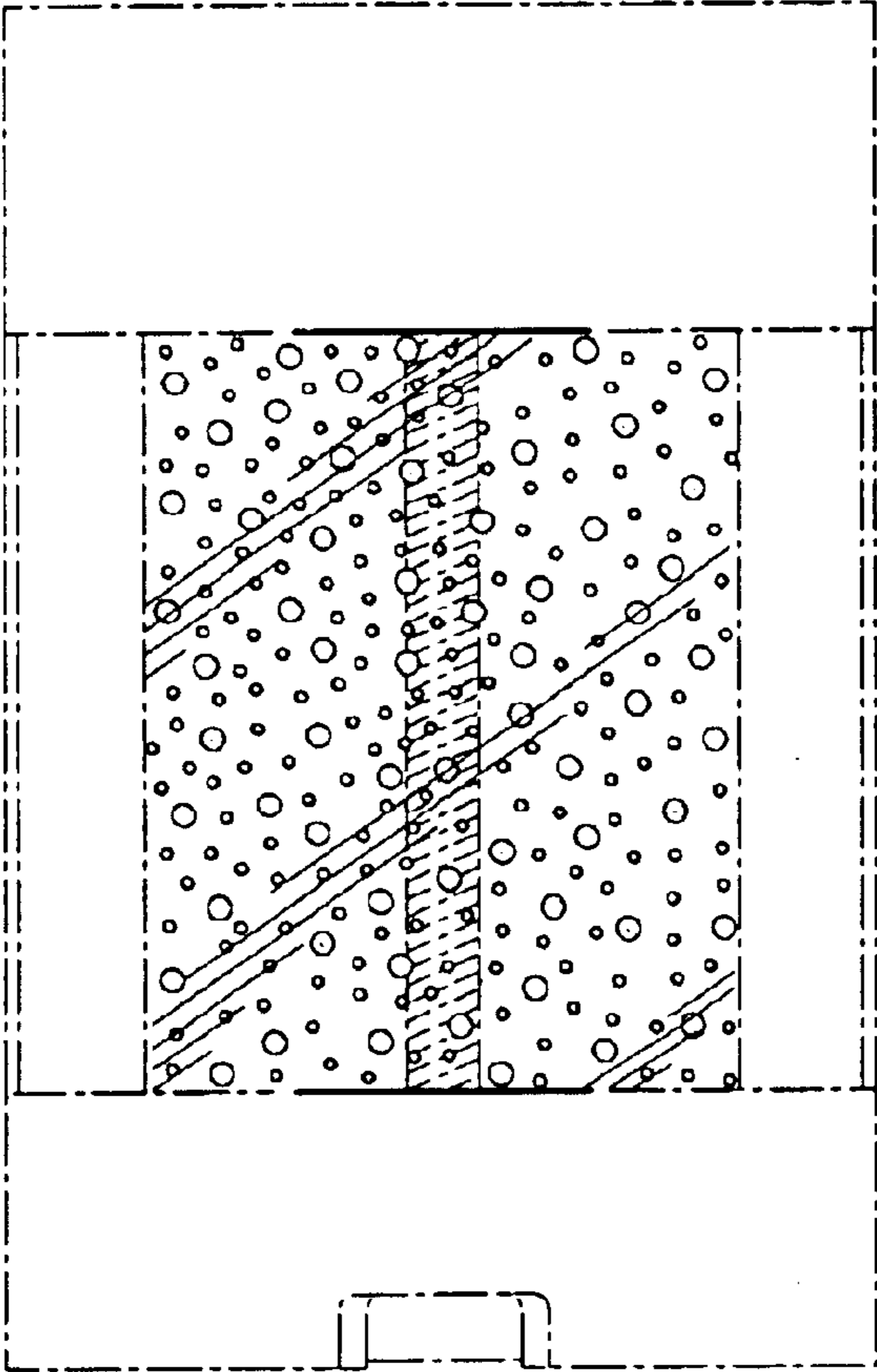
