(57) **CLAIM**

The ornamental design for a self cutting hair clipper, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of the present hair clipper;

FIG. 2 is a front view of same;

FIG. 3 is a right side view of same;

FIG. 4 is a rear view of the hair clipper of FIG. 1;

FIG. 5 is a left side view of same;

FIG. 6 is a top view of the hair clipper of FIG. 1 as shown in a first rotated position;

FIG. 7 is a bottom view of the hair clipper of FIG. 1;

FIG. 8 is a top view of the hair clipper of FIG. 6 shown in a second rotated position;

FIG. 9 is a top perspective view of a second embodiment of the present hair clipper;

FIG. 10 is a front view of same;

FIG. 11 is a right side view of same;

FIG. 12 is a rear view of the hair clipper of FIG. 9;

FIG. 13 is a left side view of same;

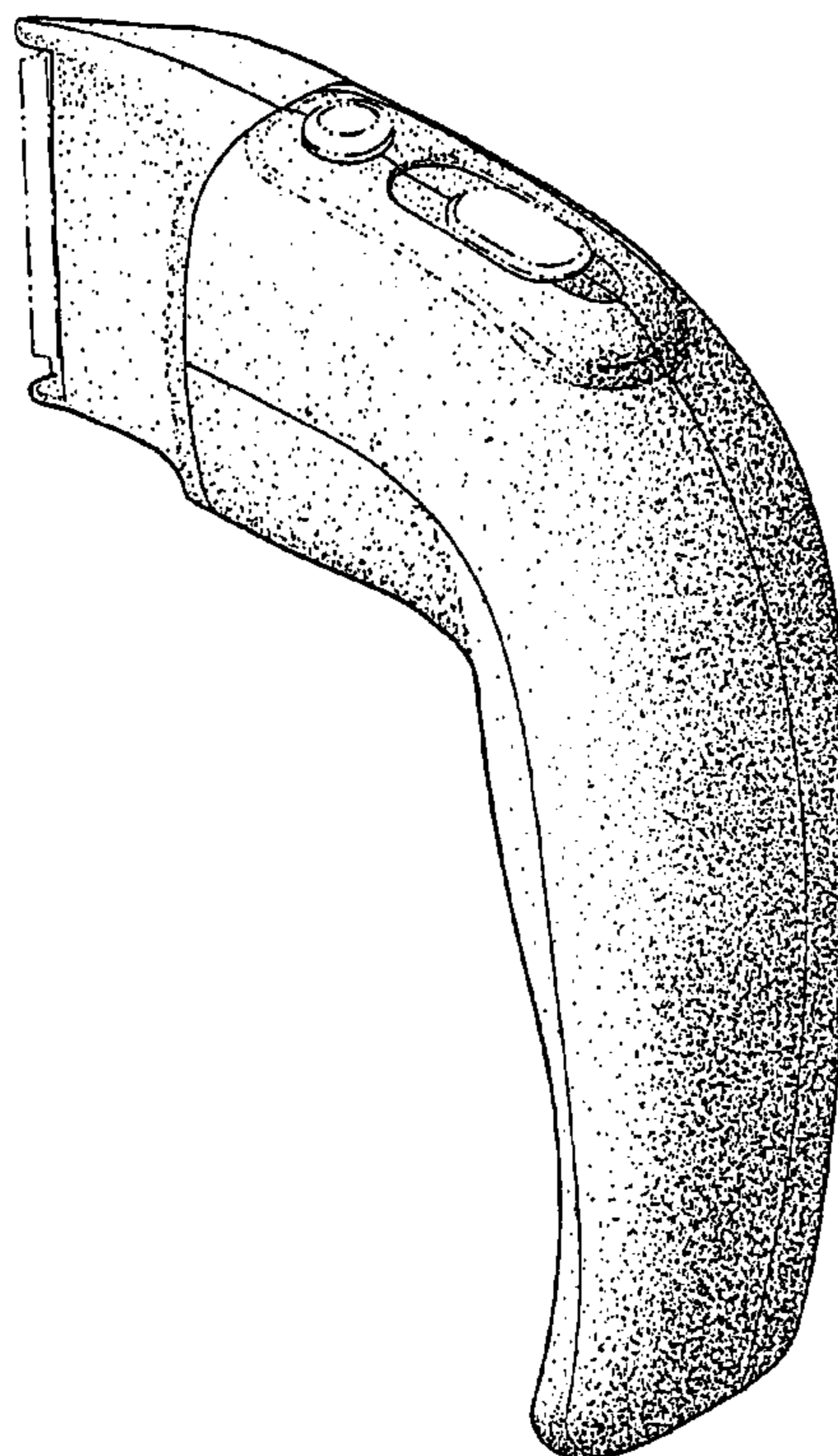
FIG. 14 is a top view of the hair clipper of FIG. 9 as shown in a first rotated position;

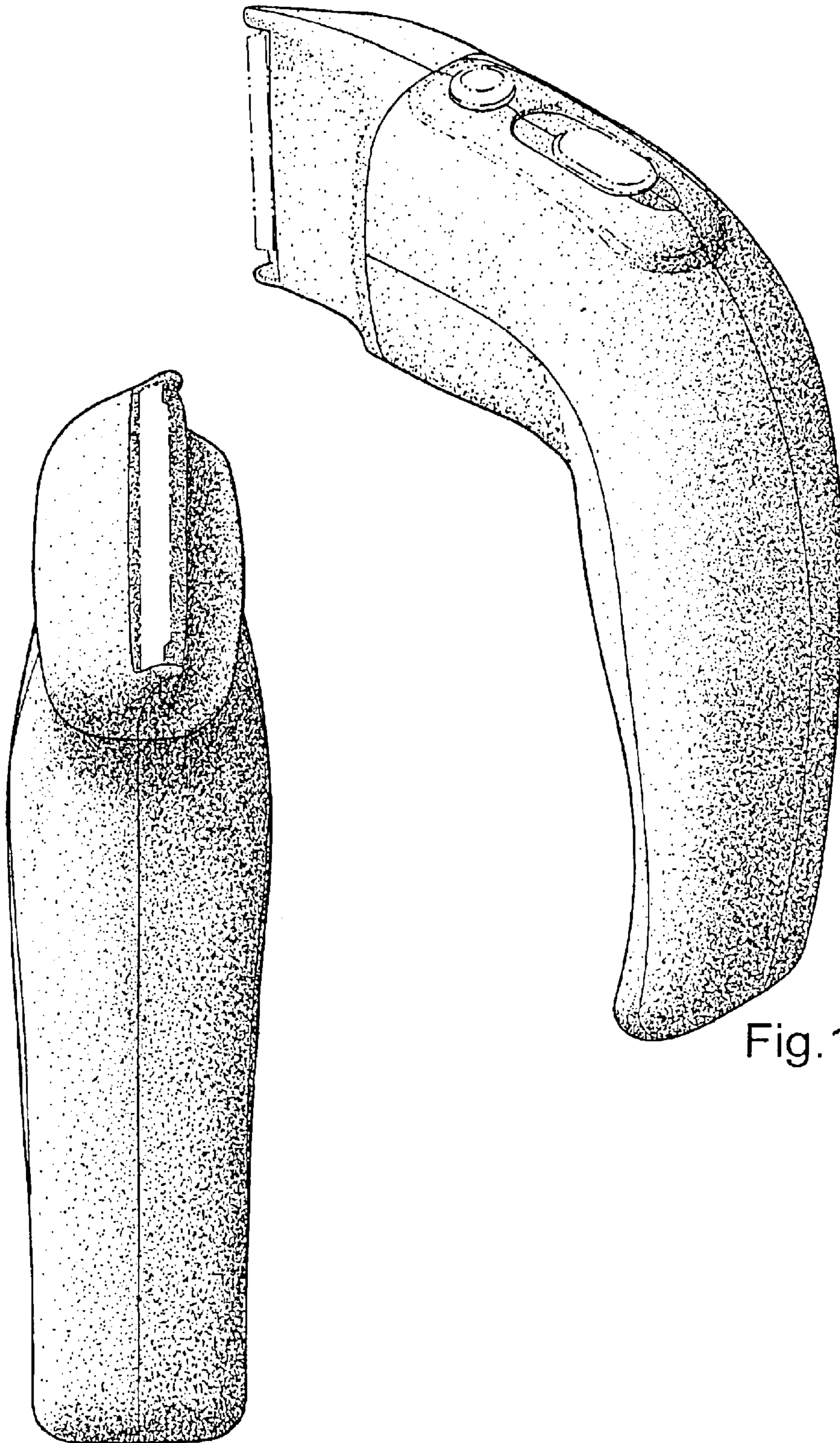

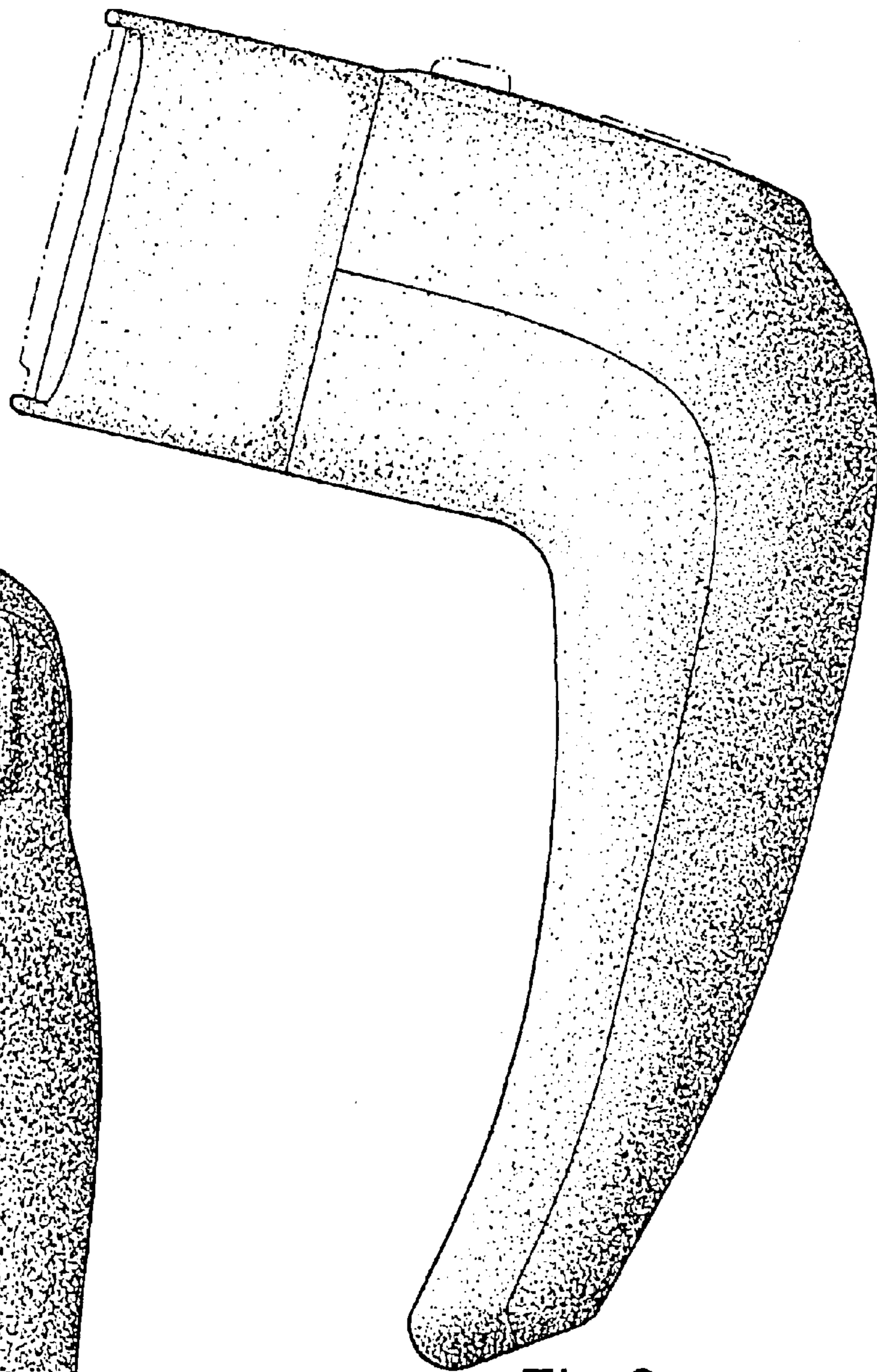

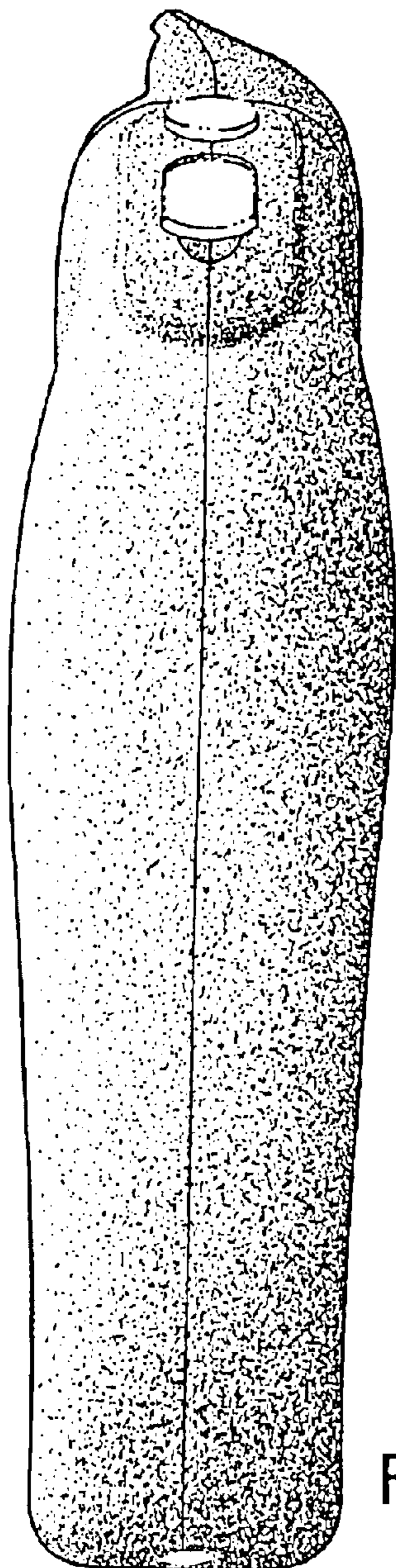

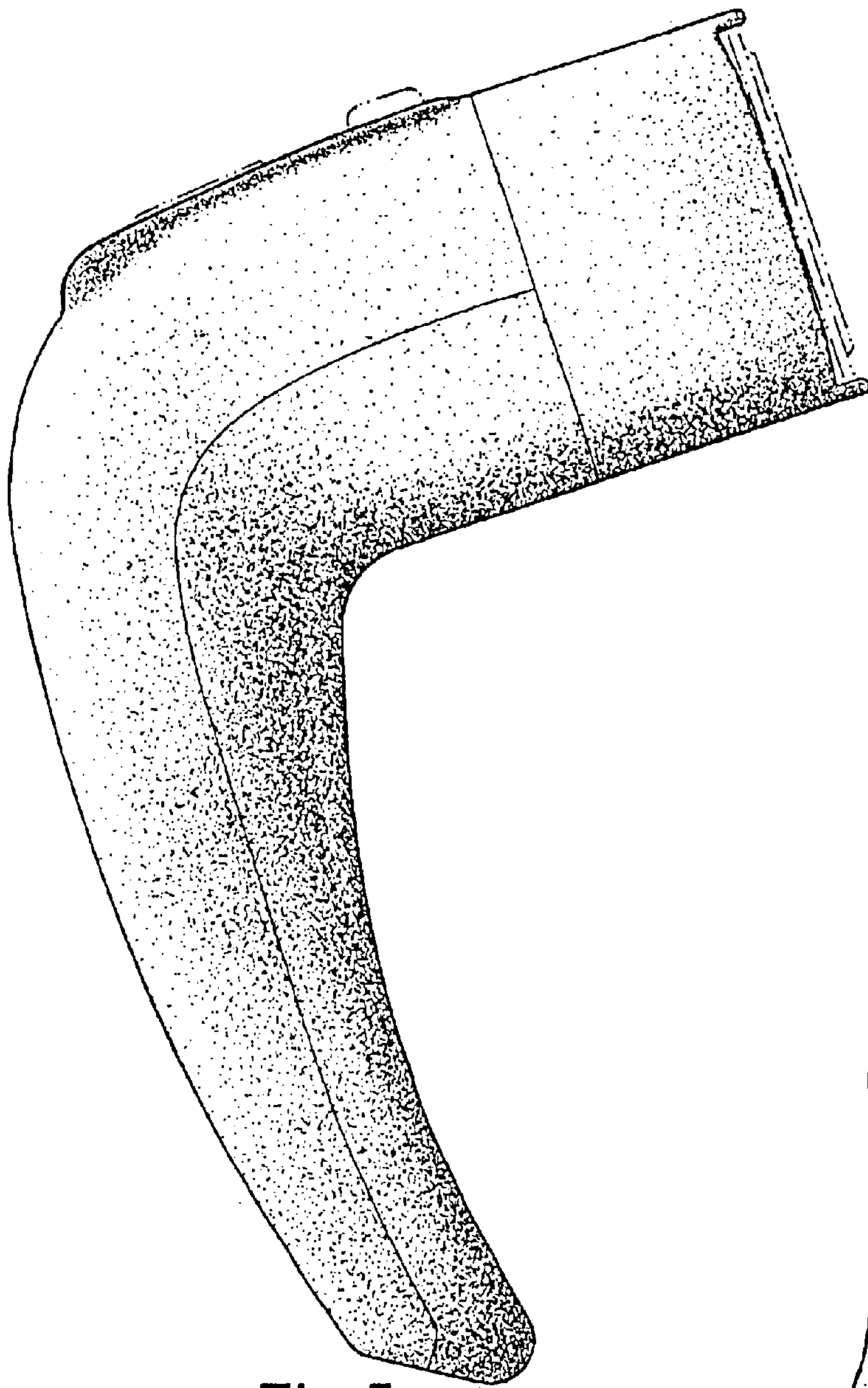

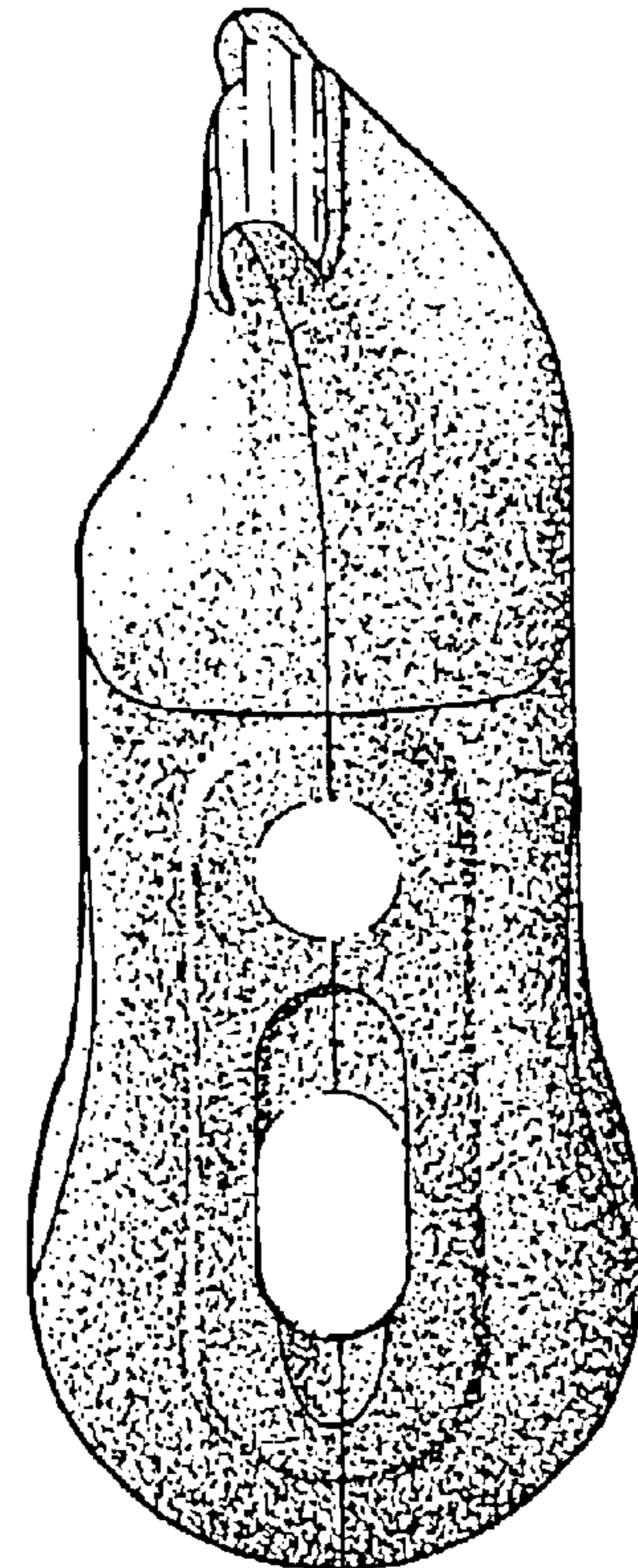

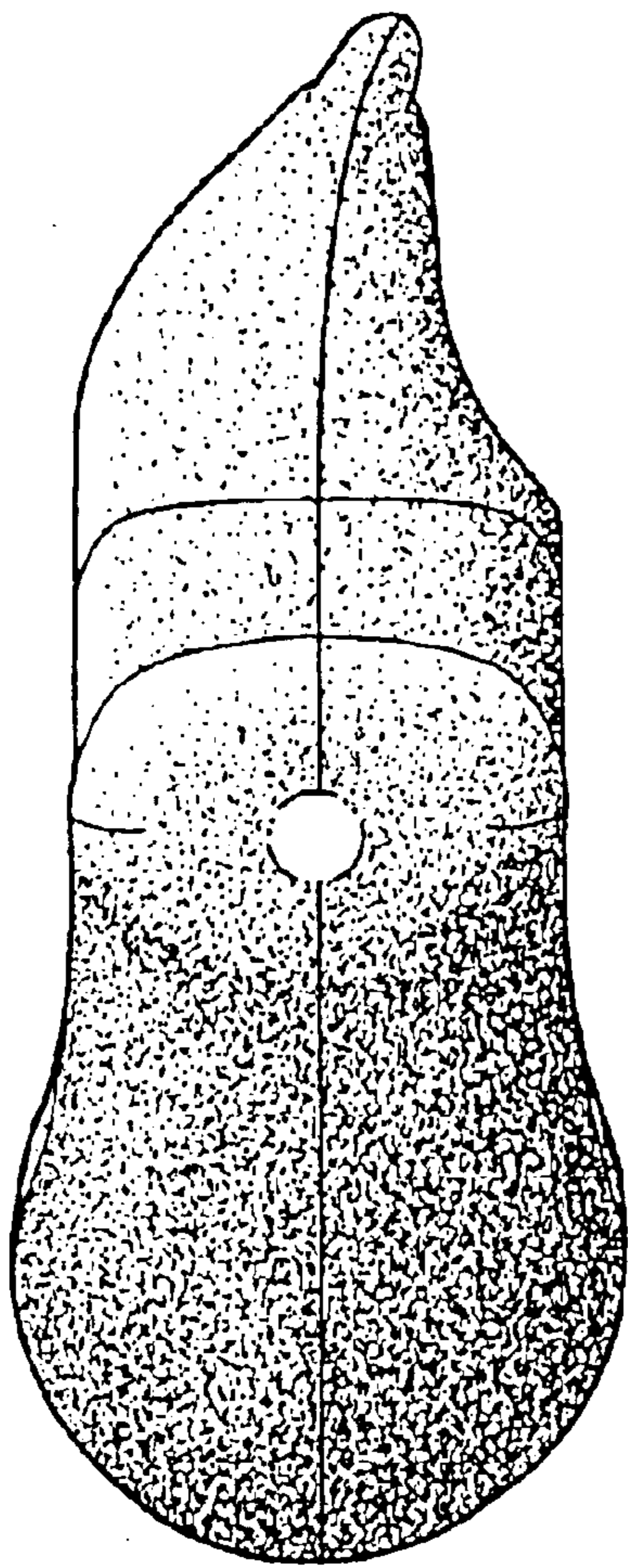

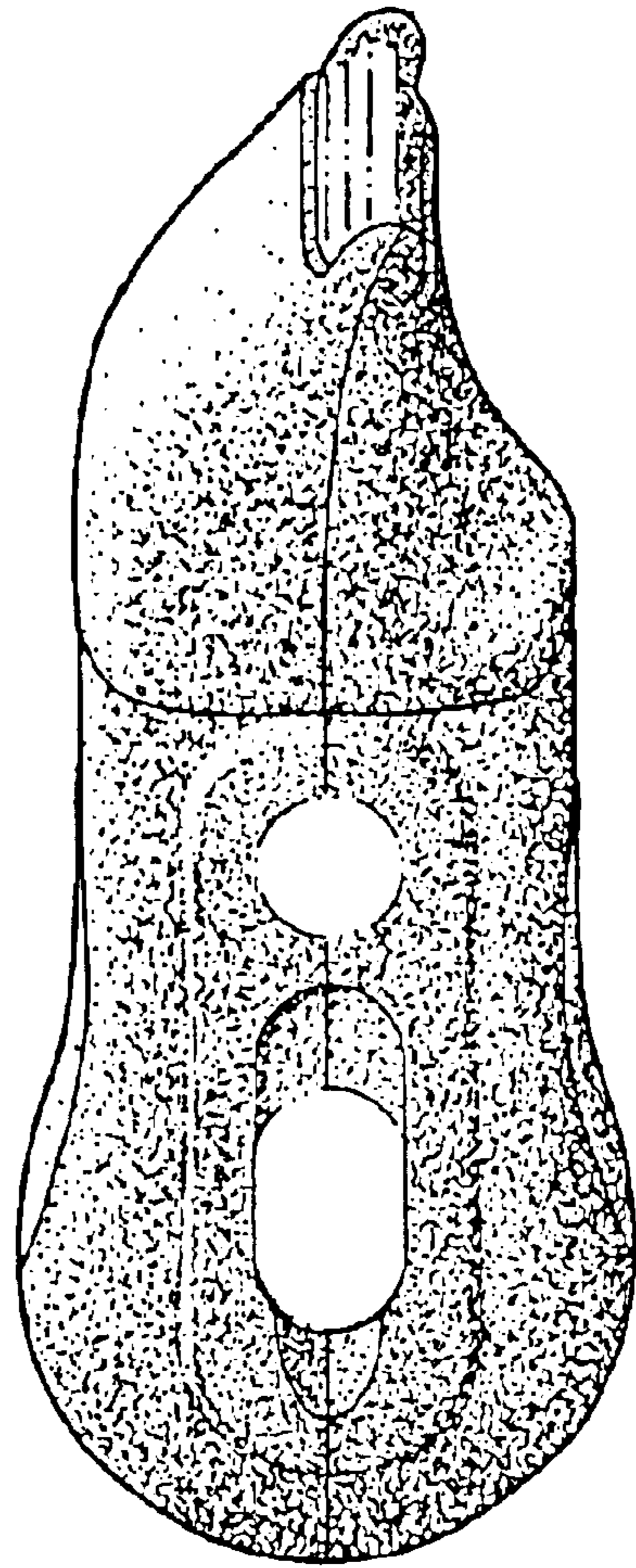

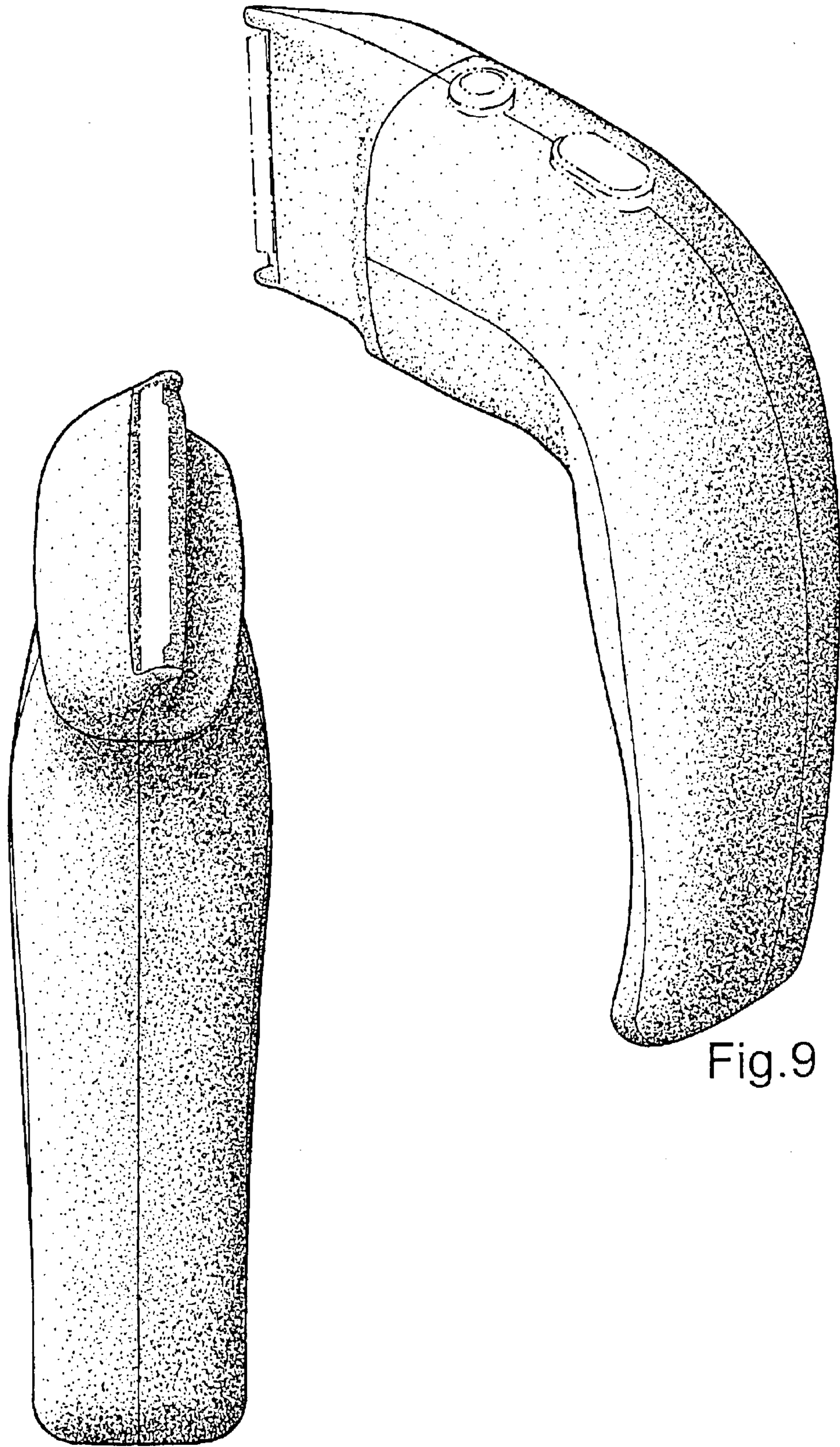

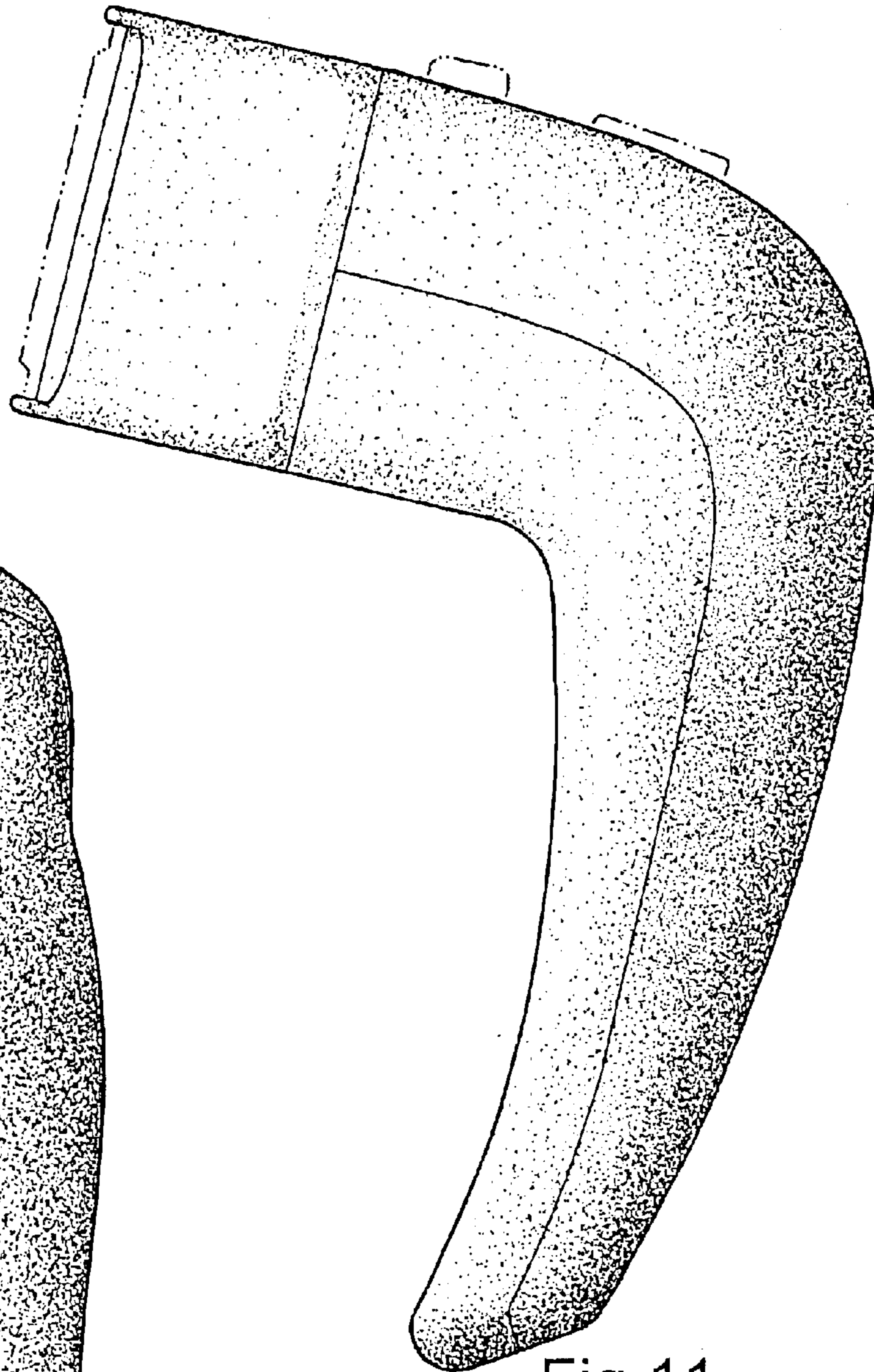

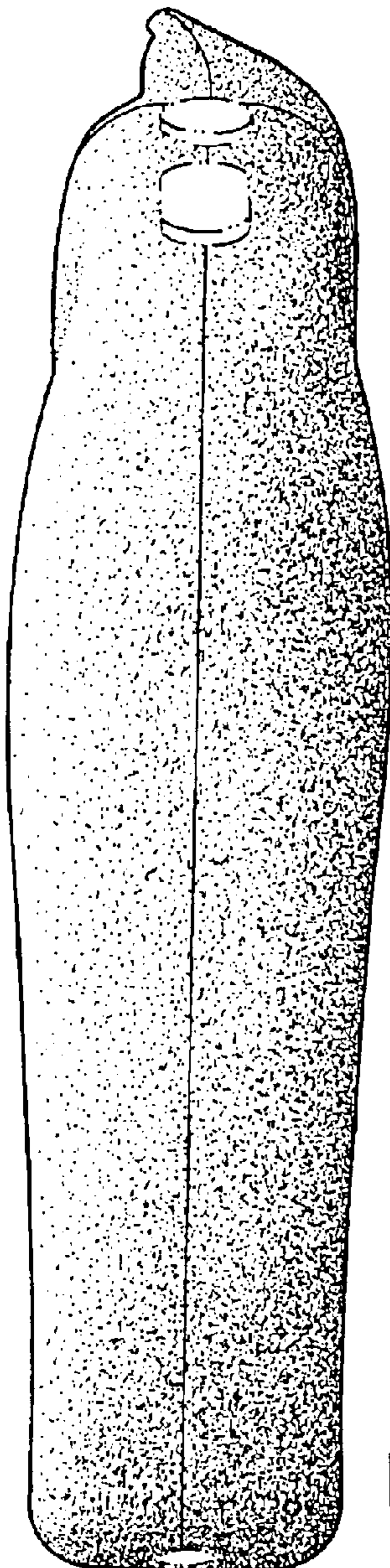

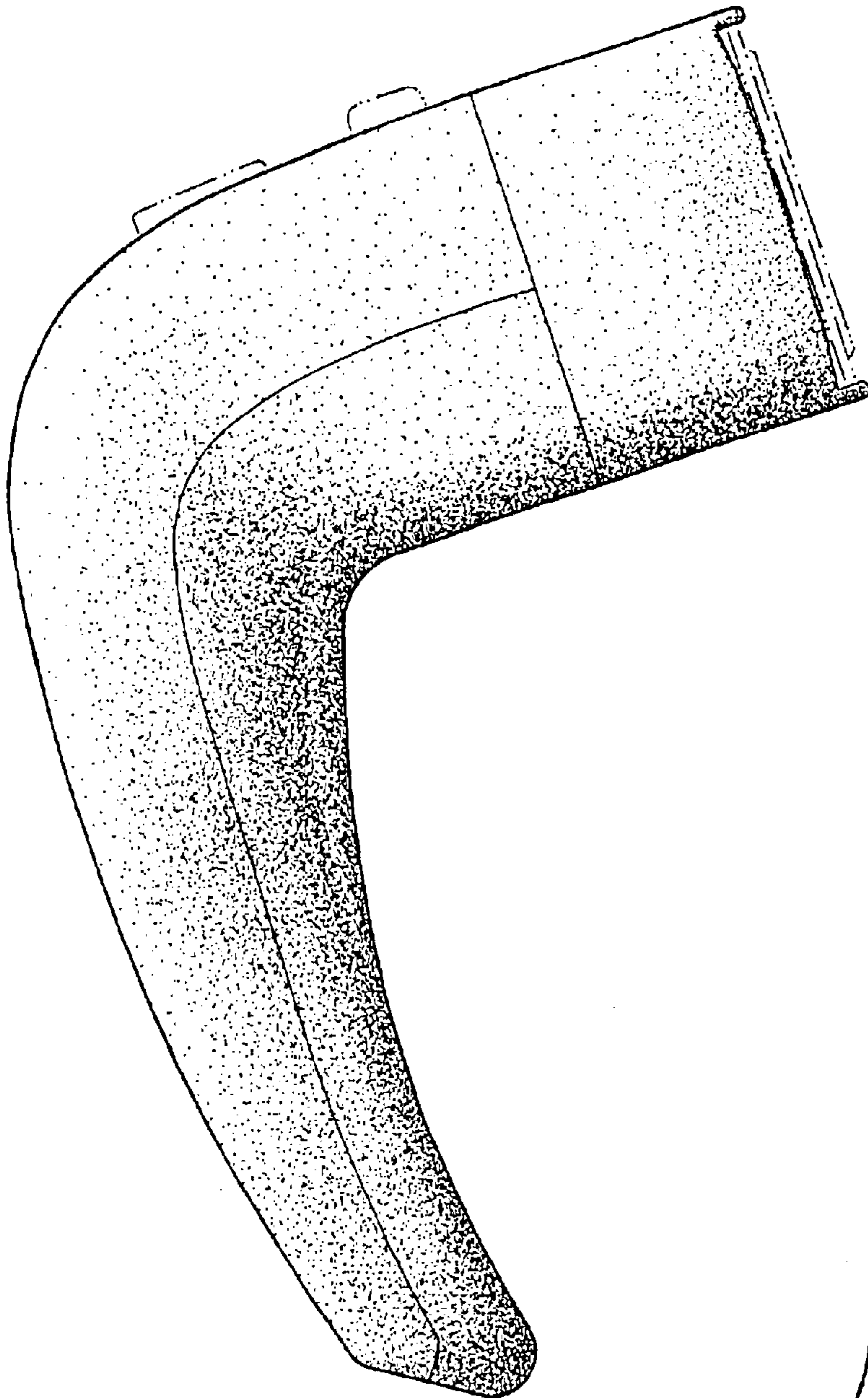

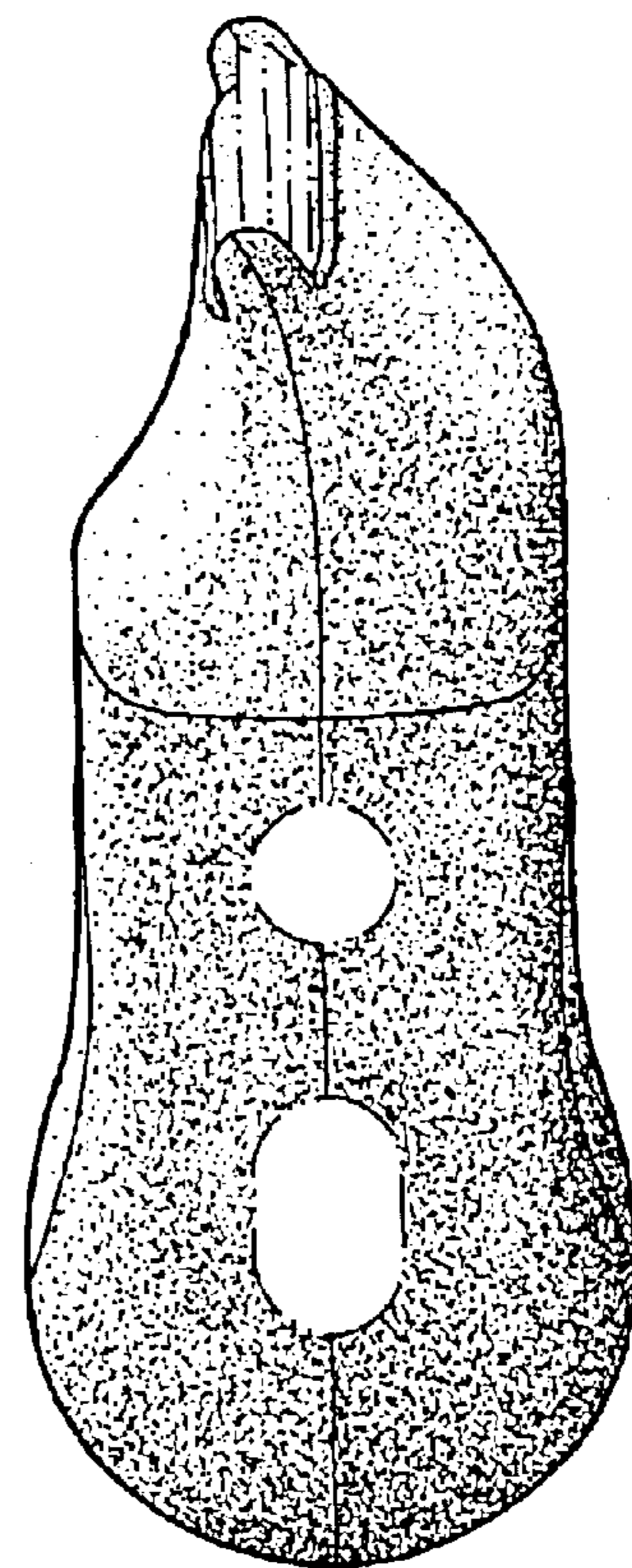

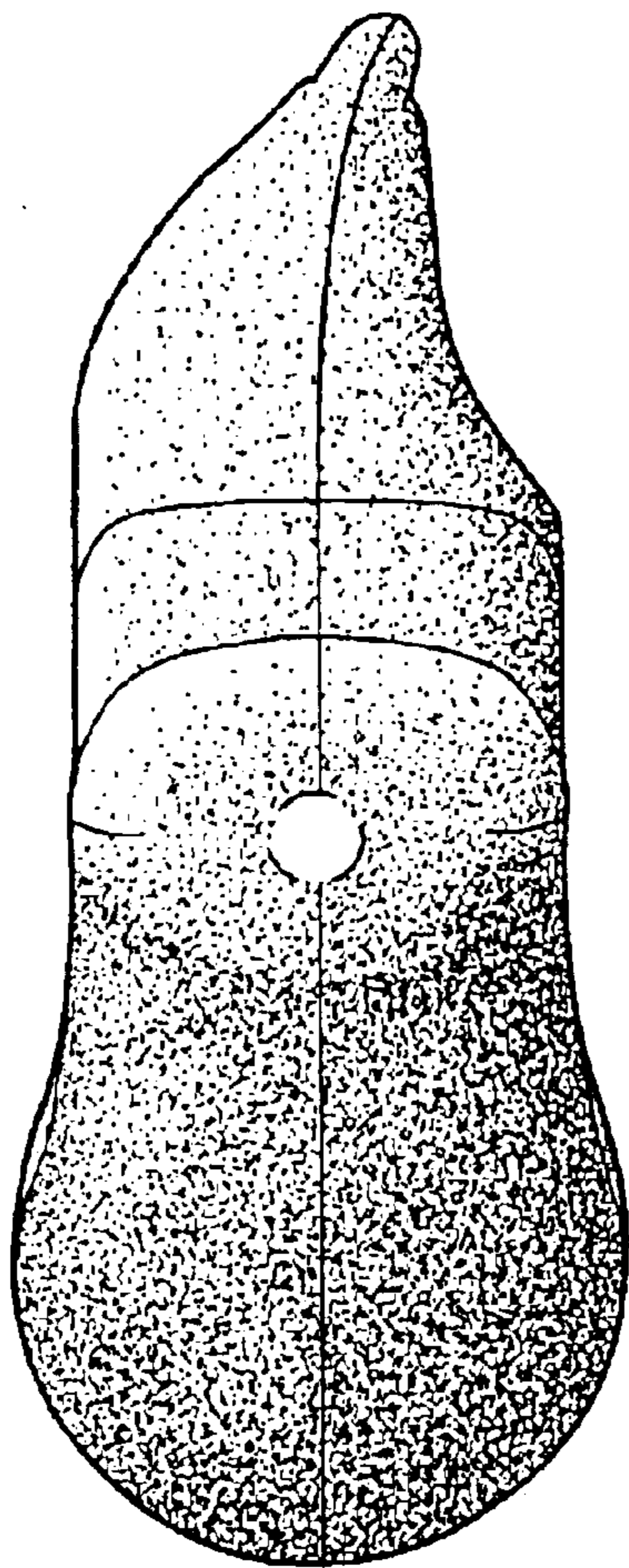

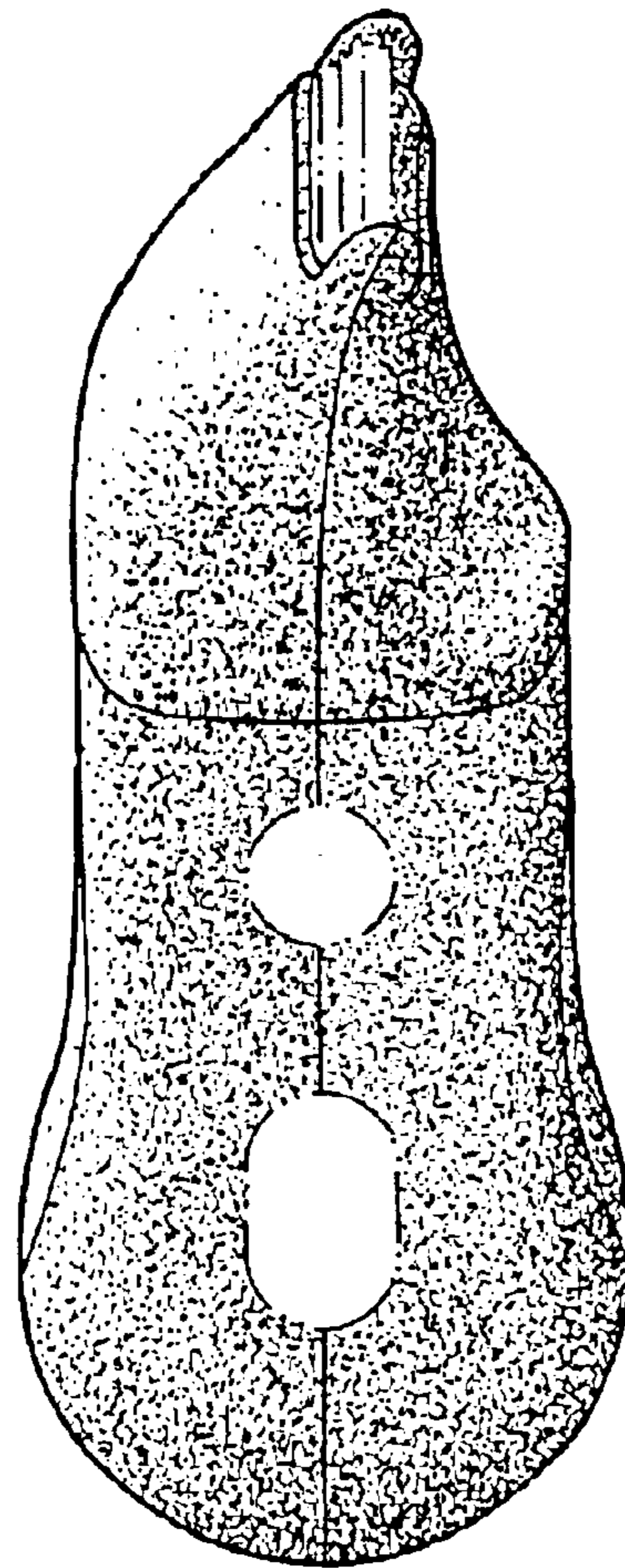
