FIG. 10 is a bottom perspective view thereof;

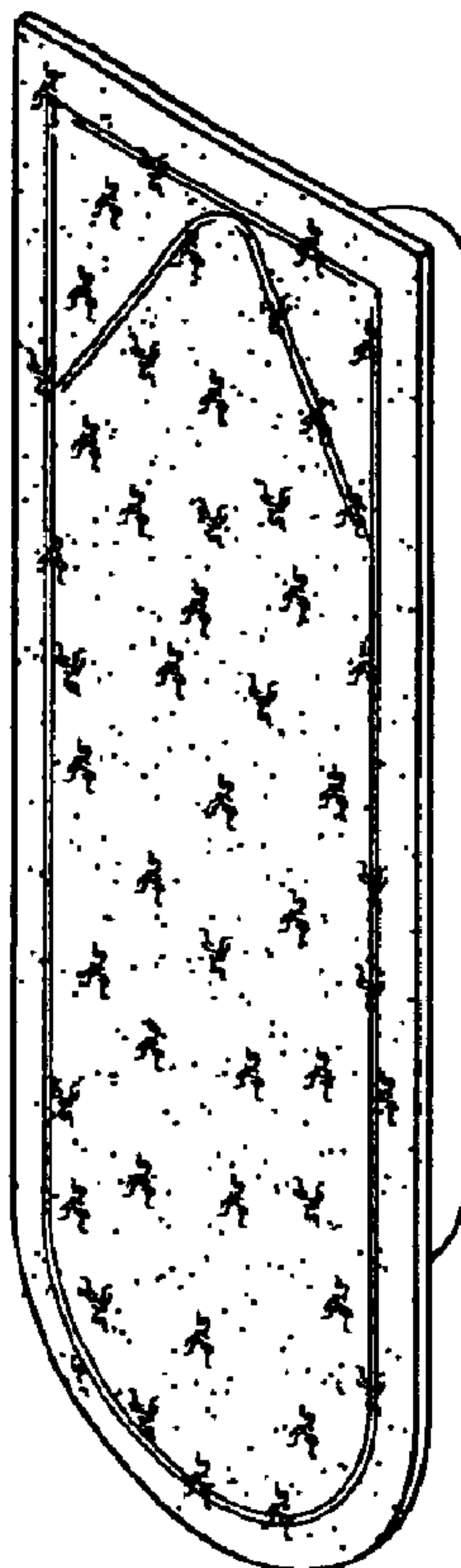
FIG. 11 is a left side elevational view thereof;

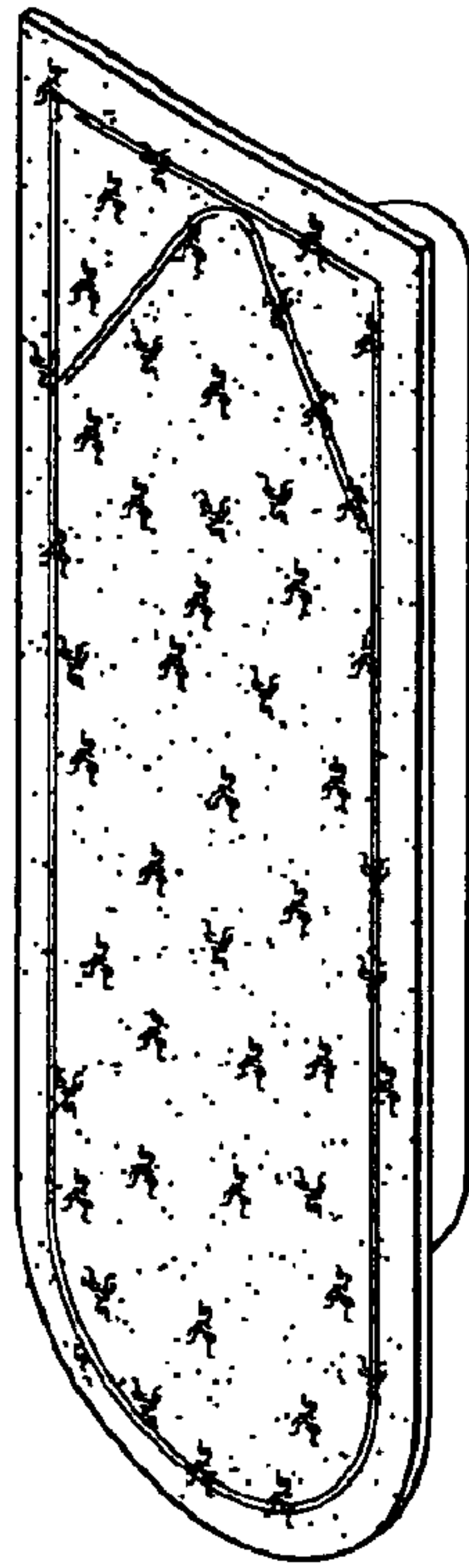

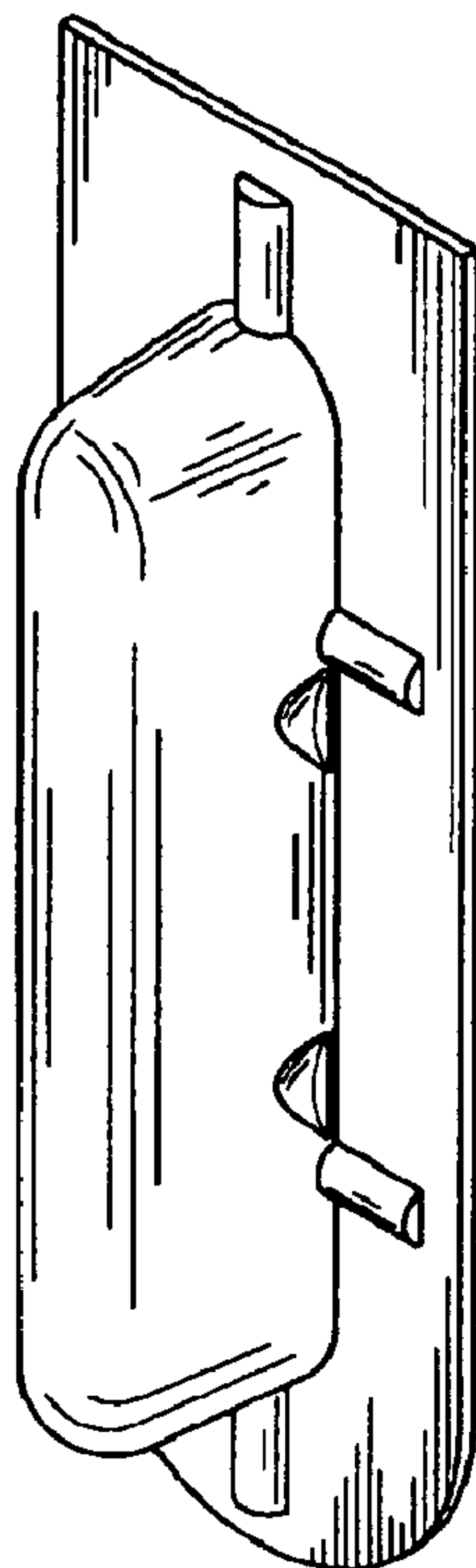

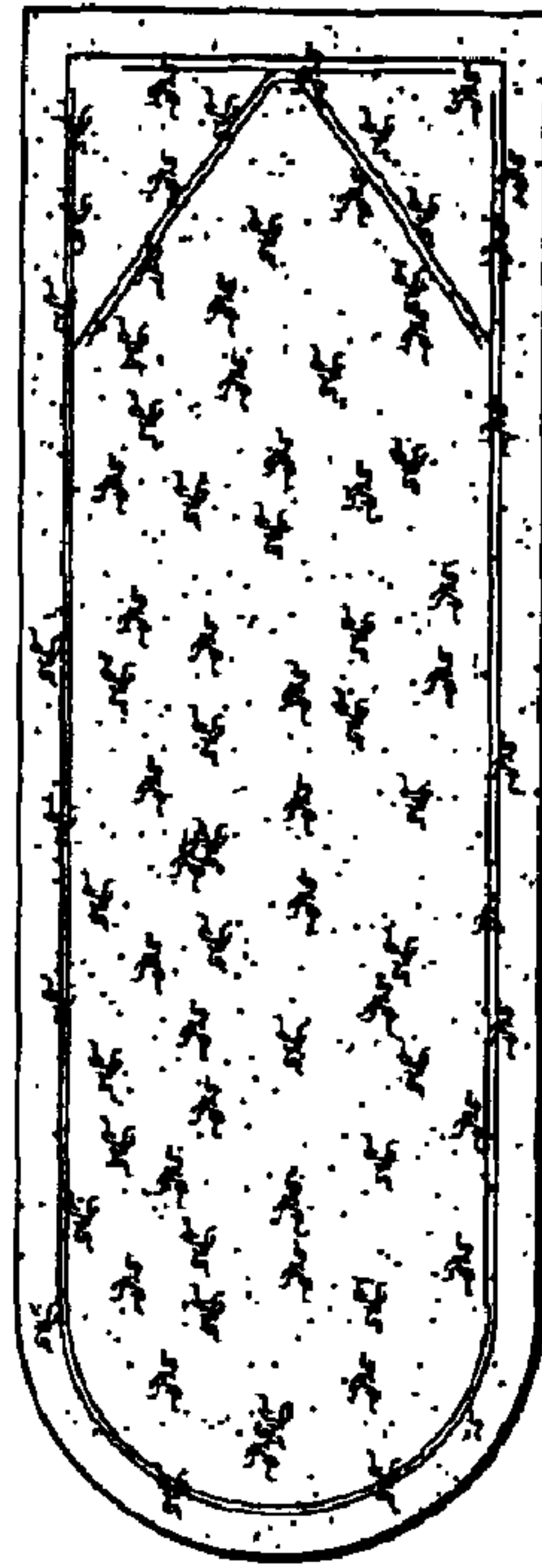

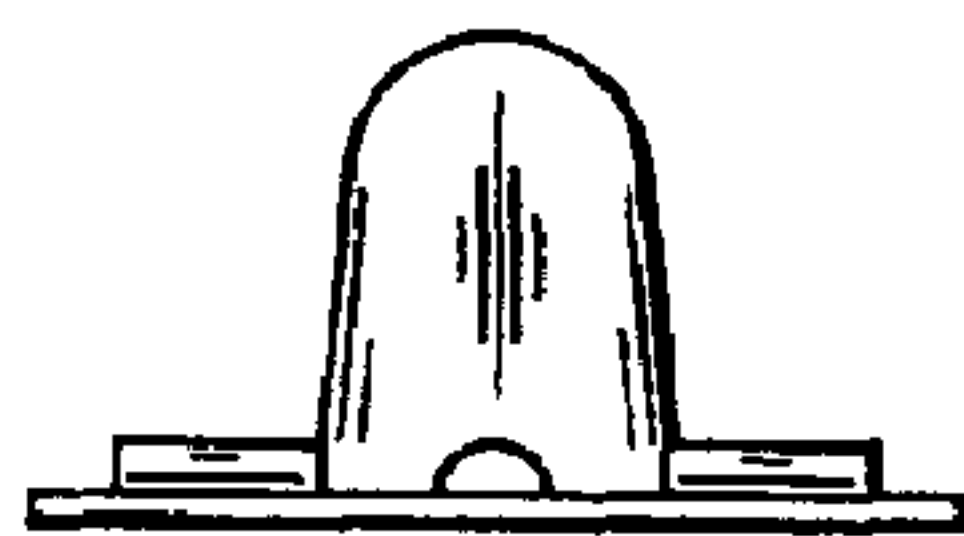

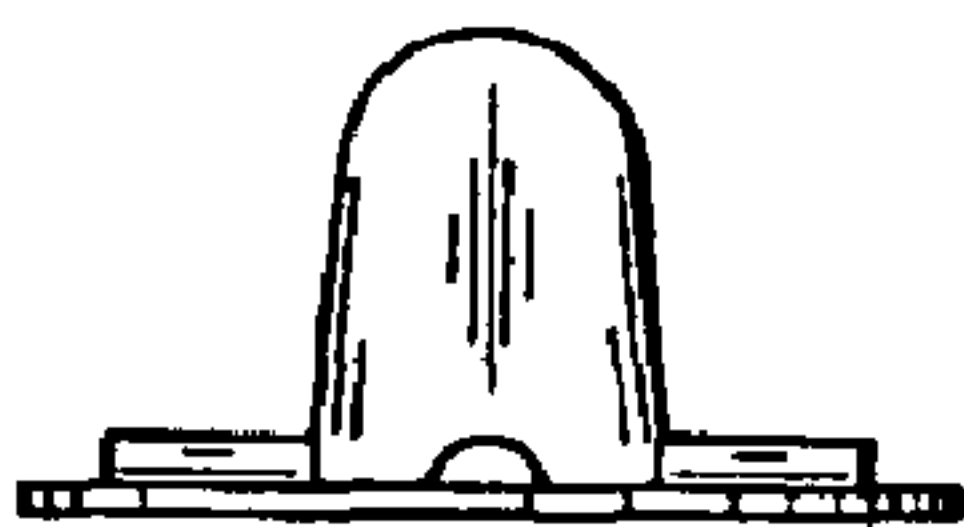

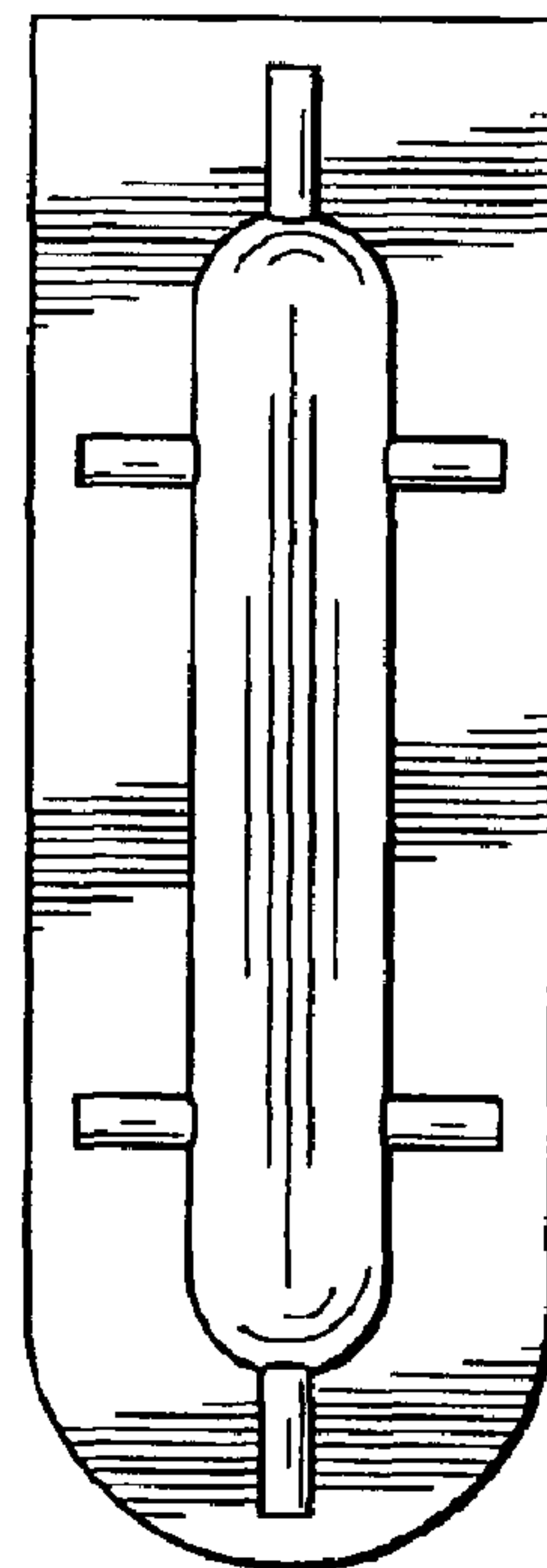

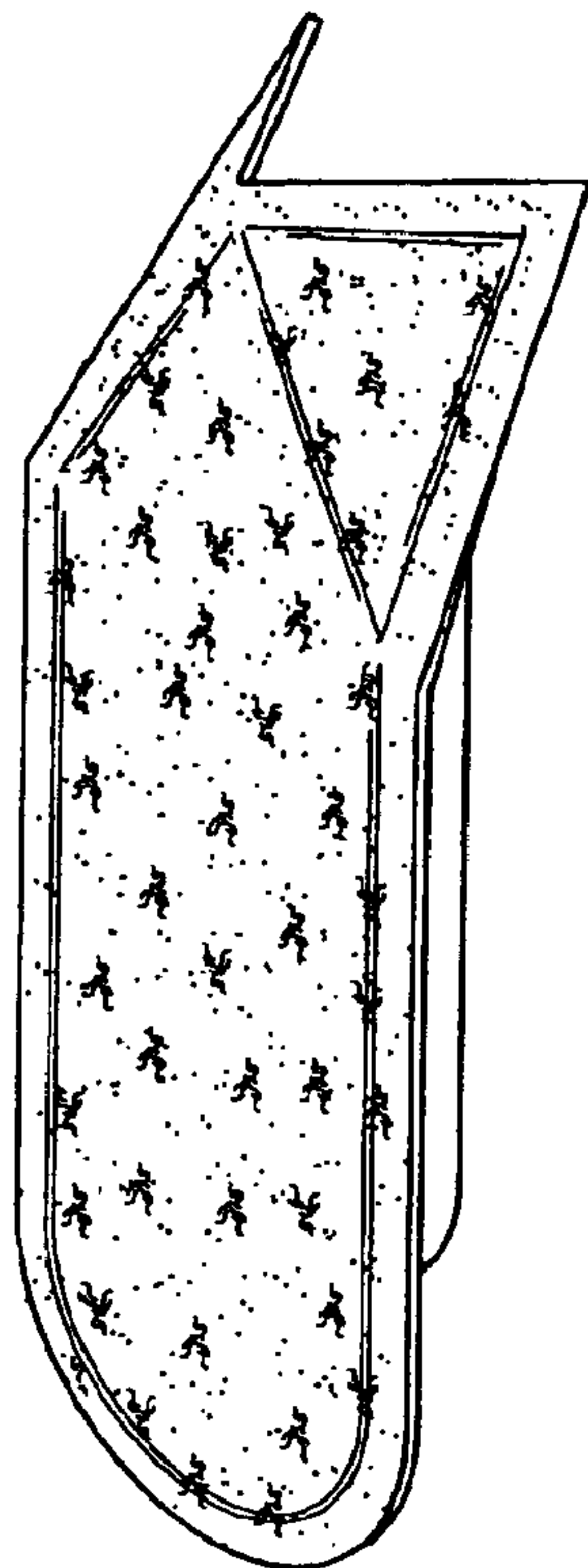

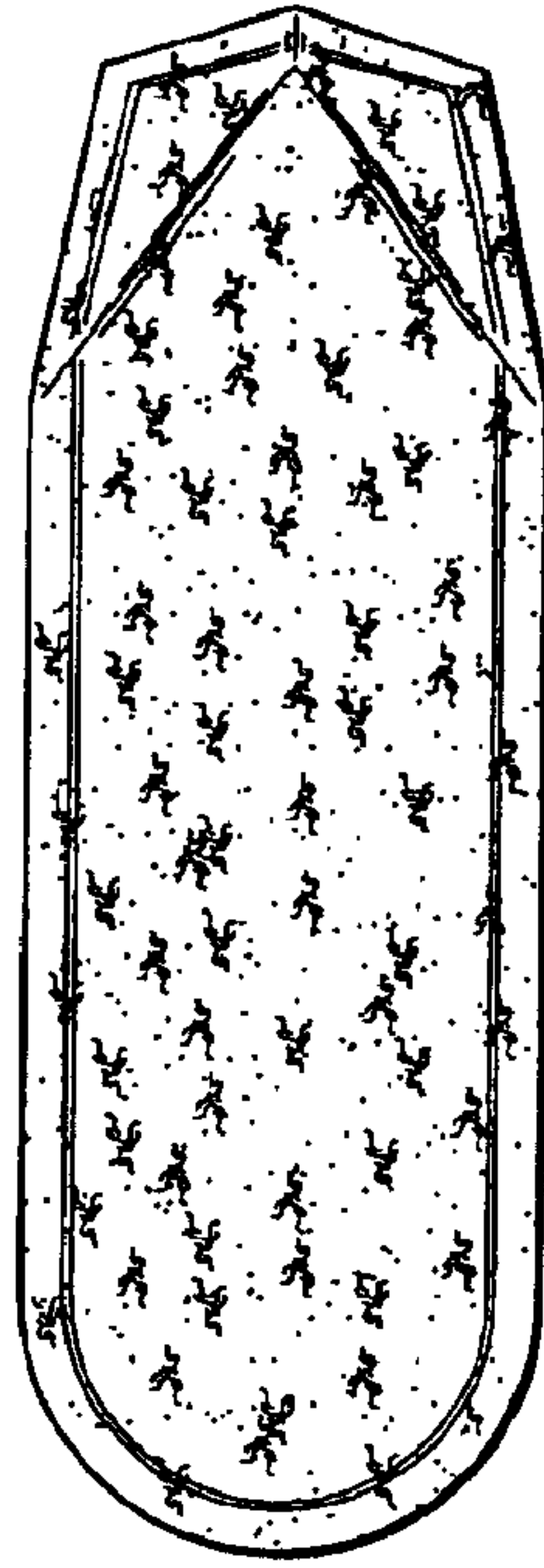

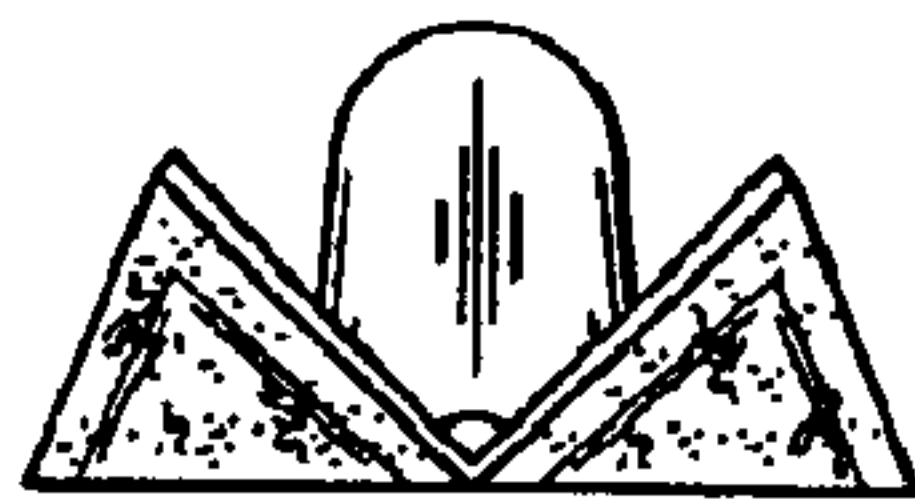

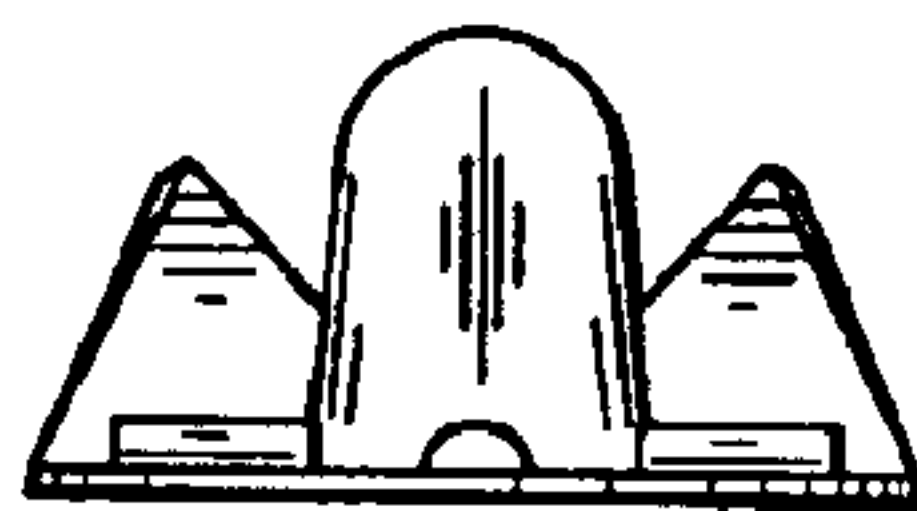

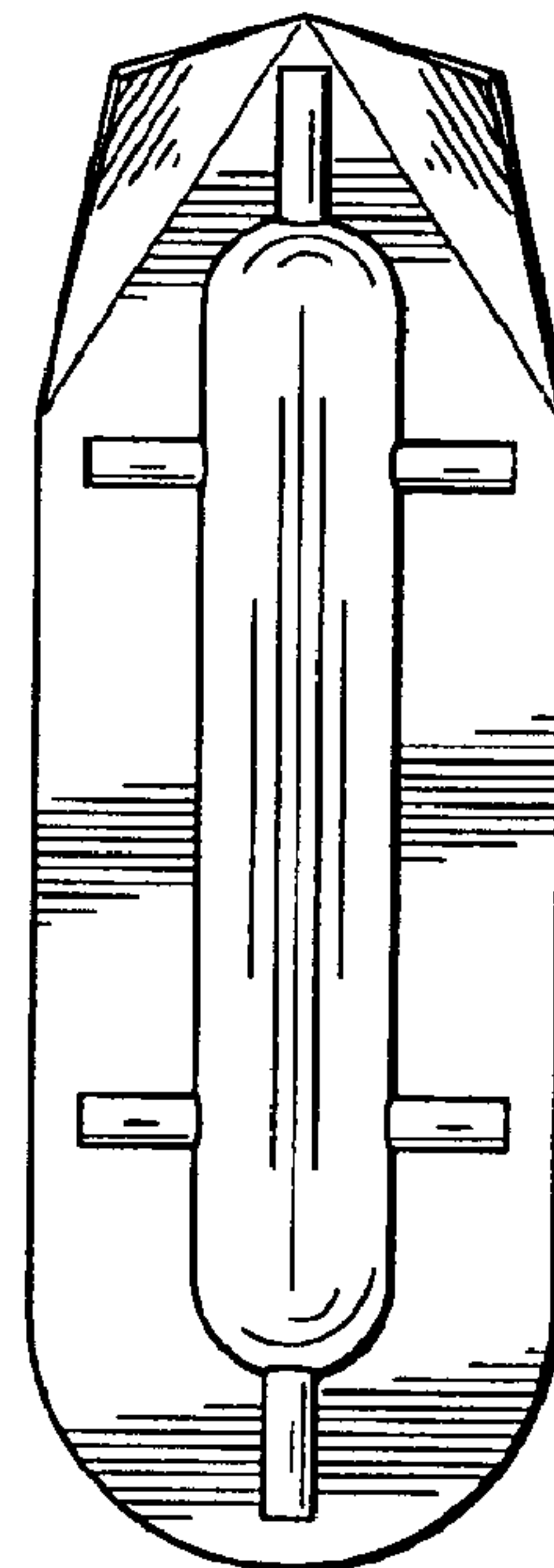
