FIG. 3 is a side view showing the present invention.

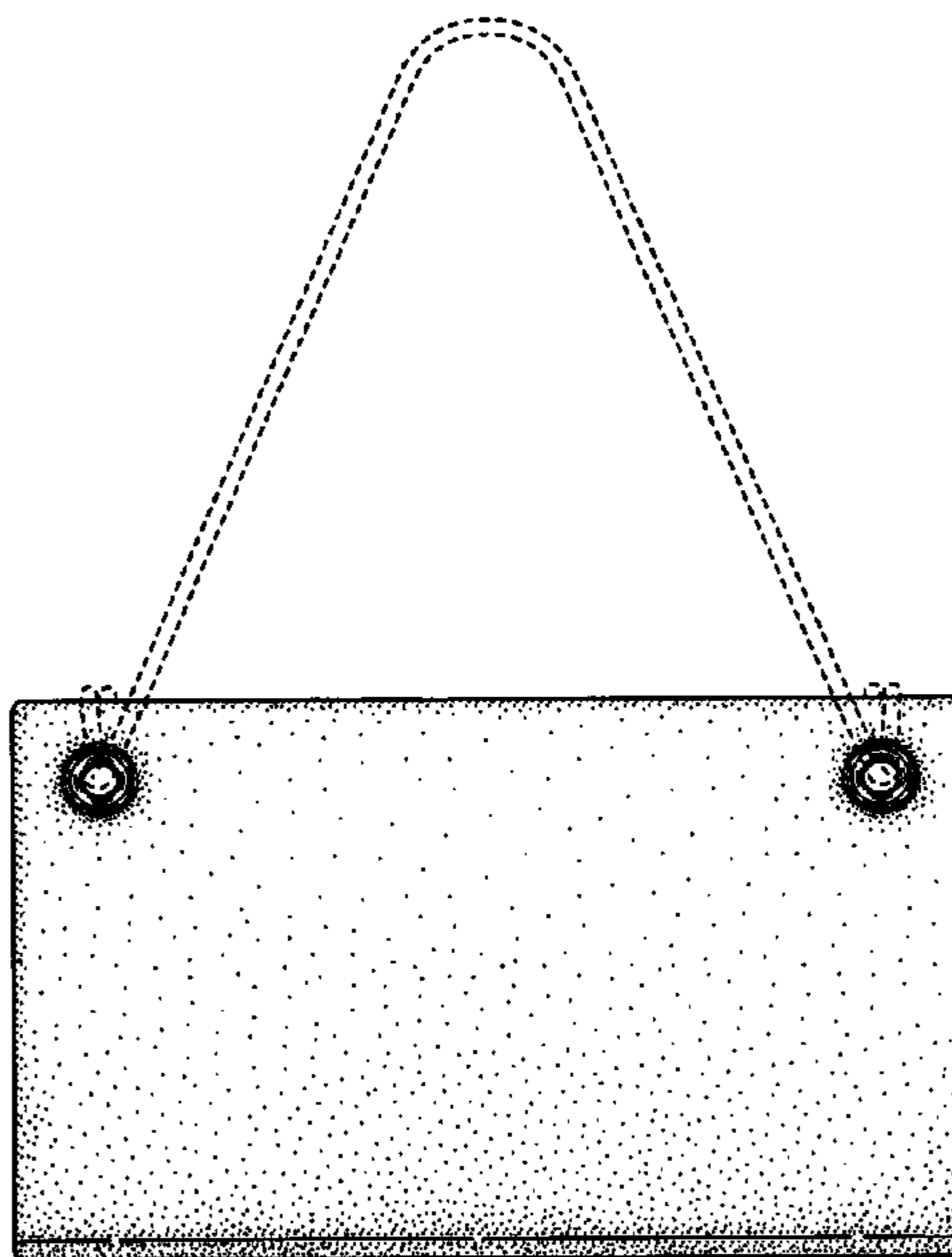
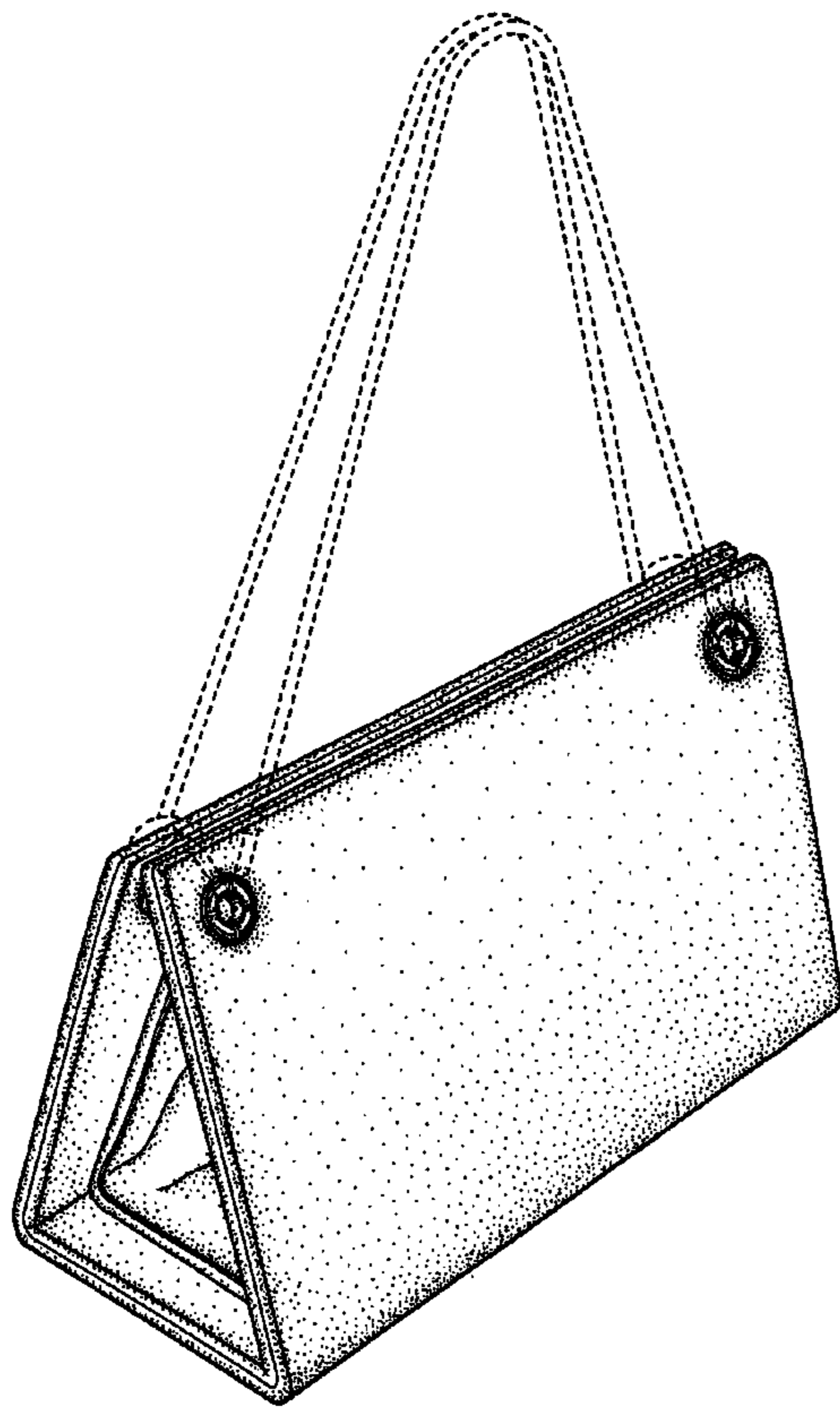
FIG. 4 is a bottom view showing the present invention.

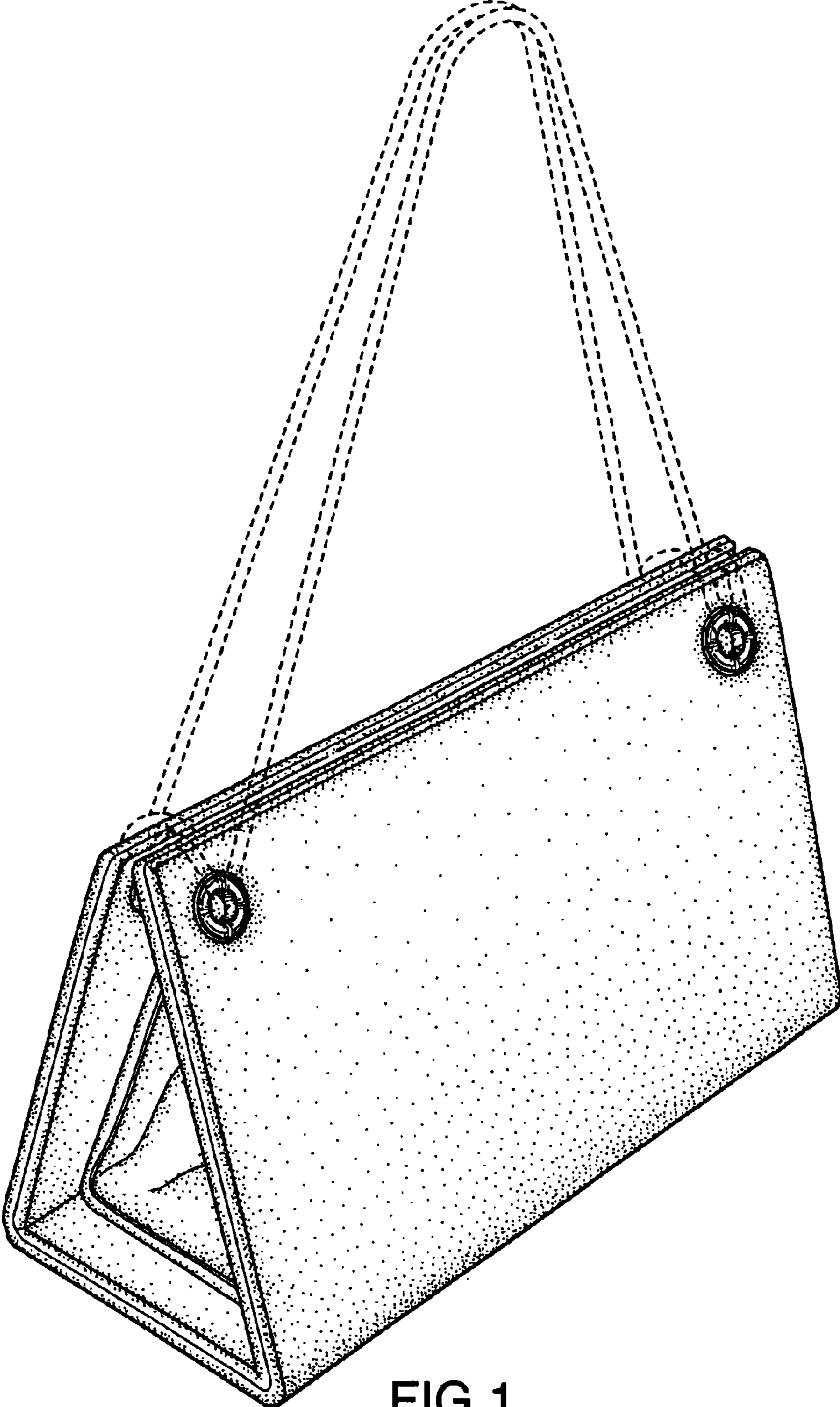

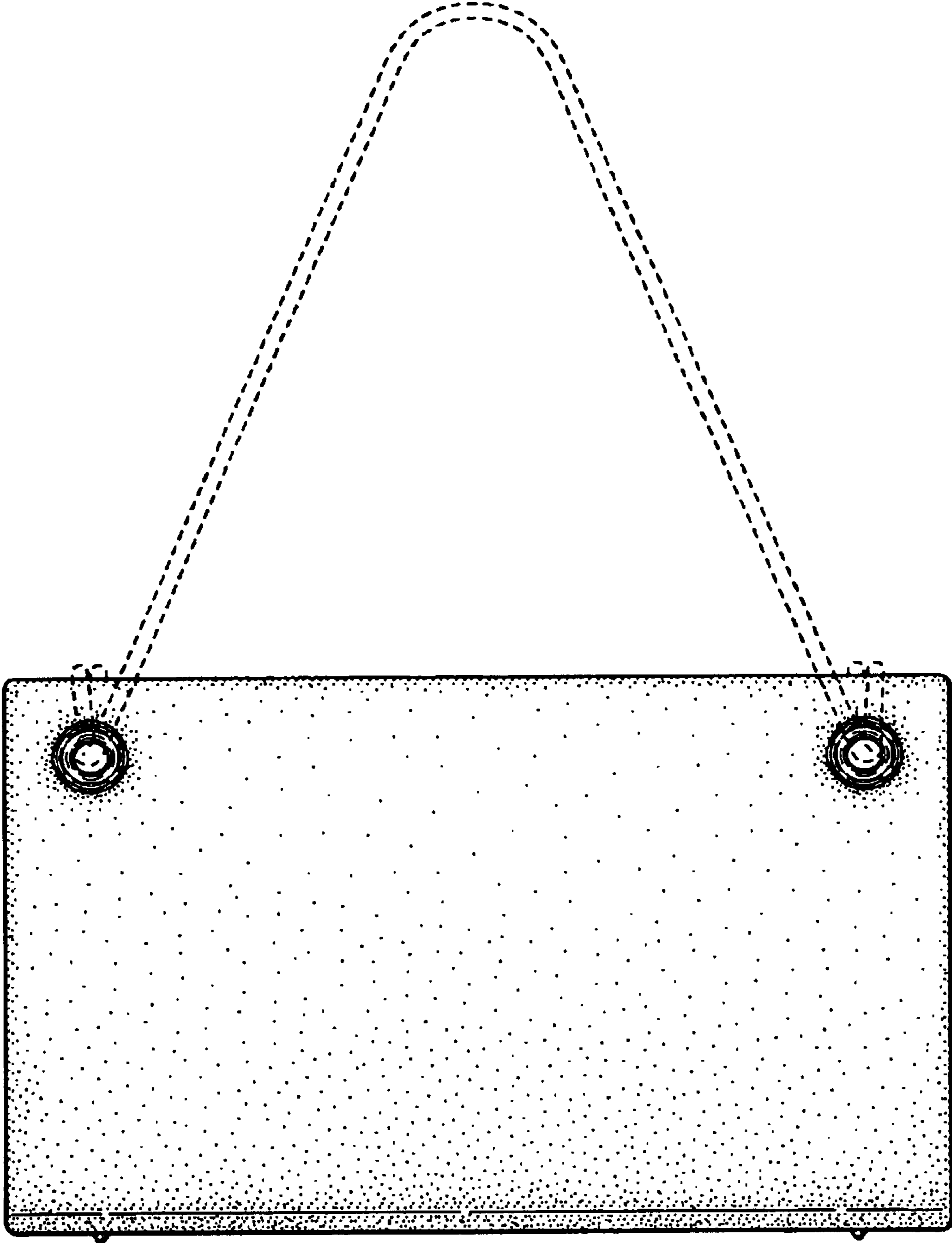

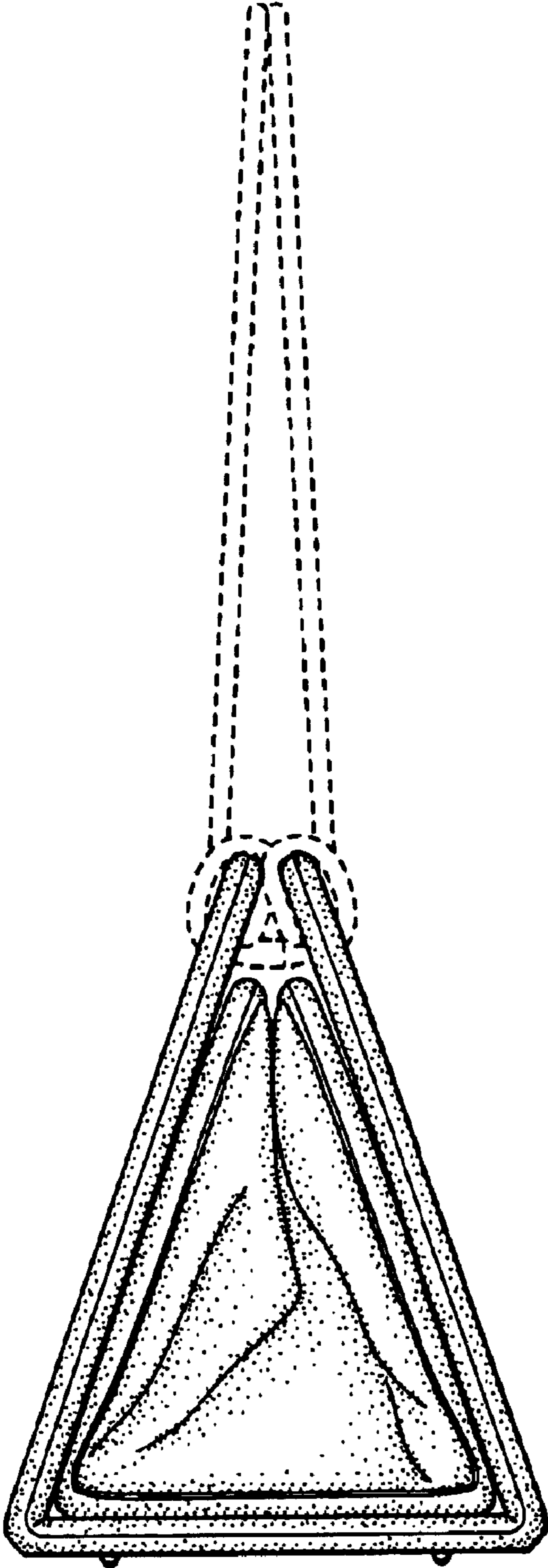

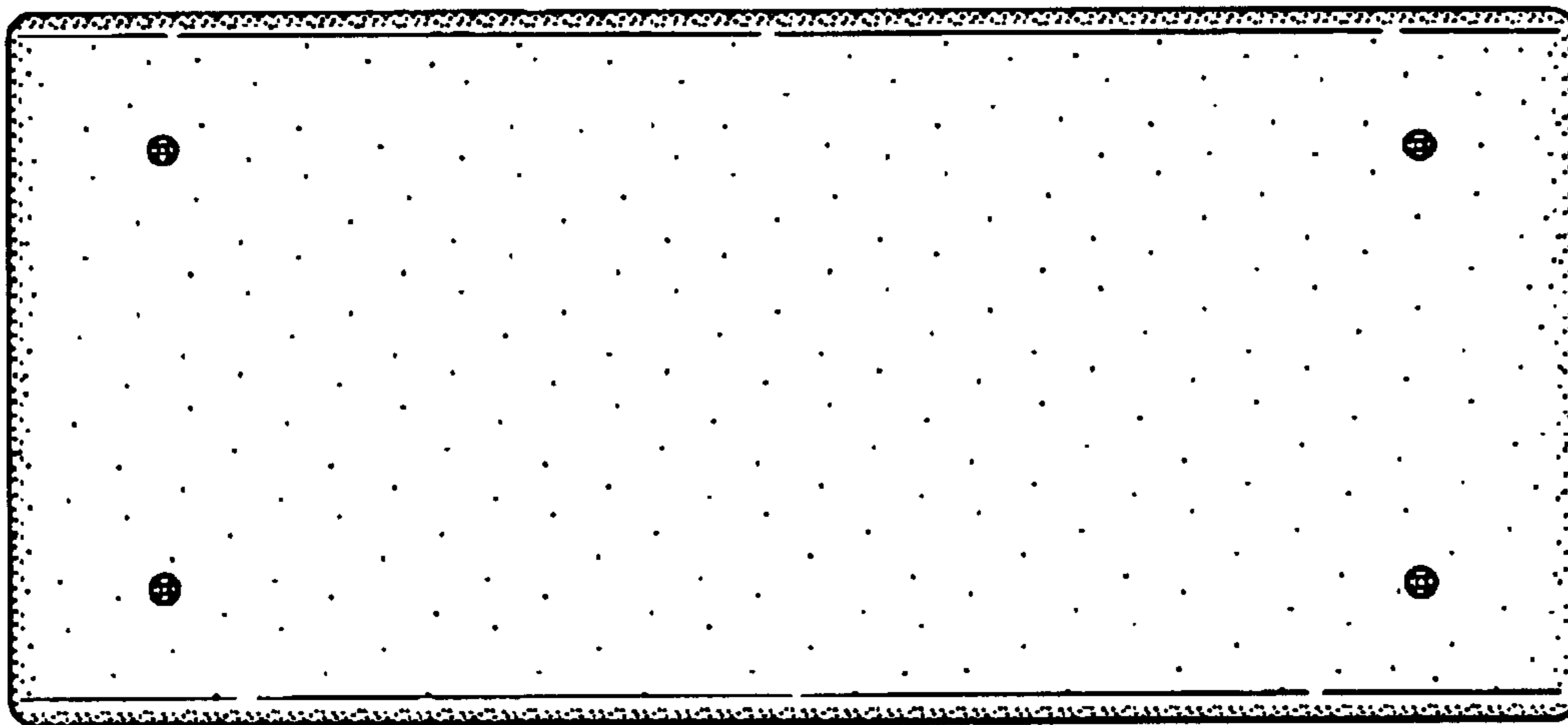

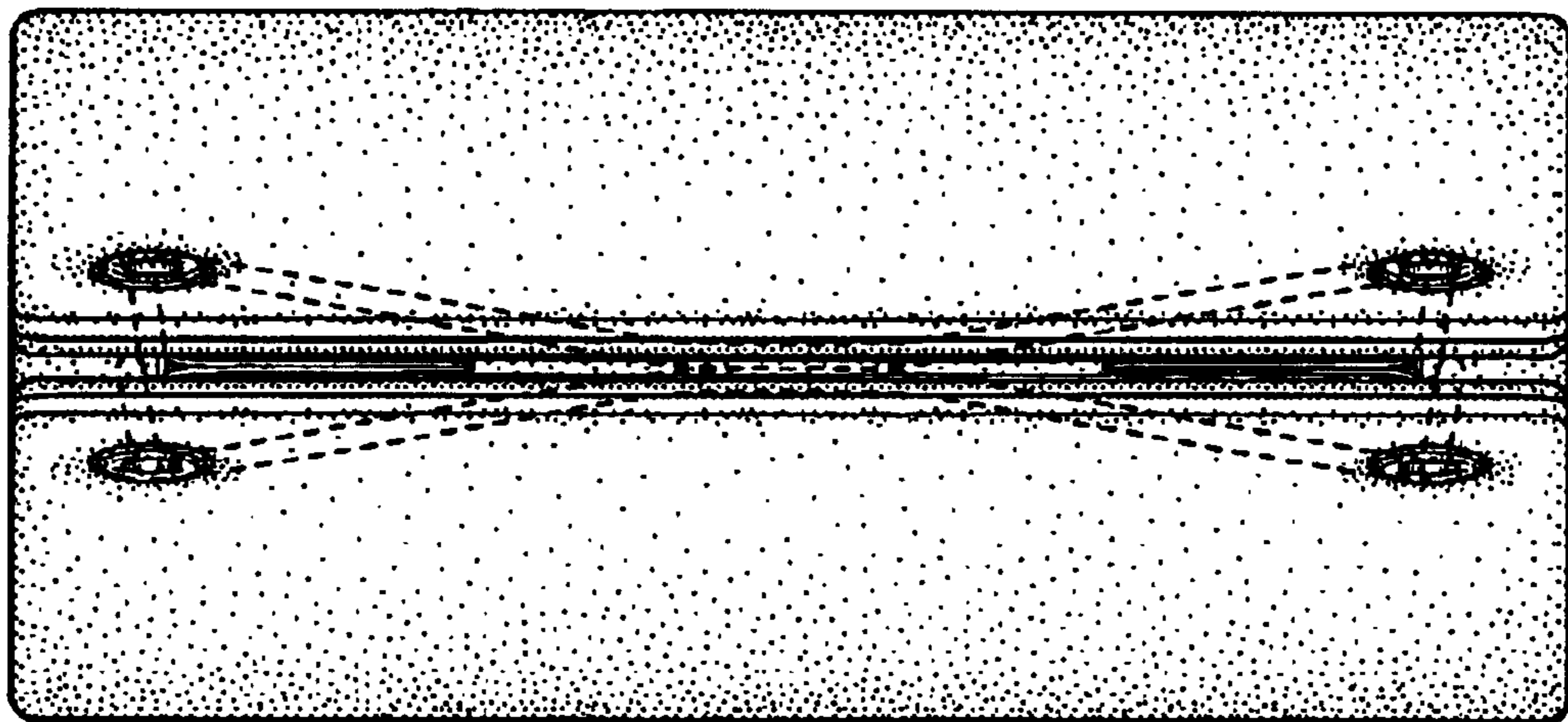

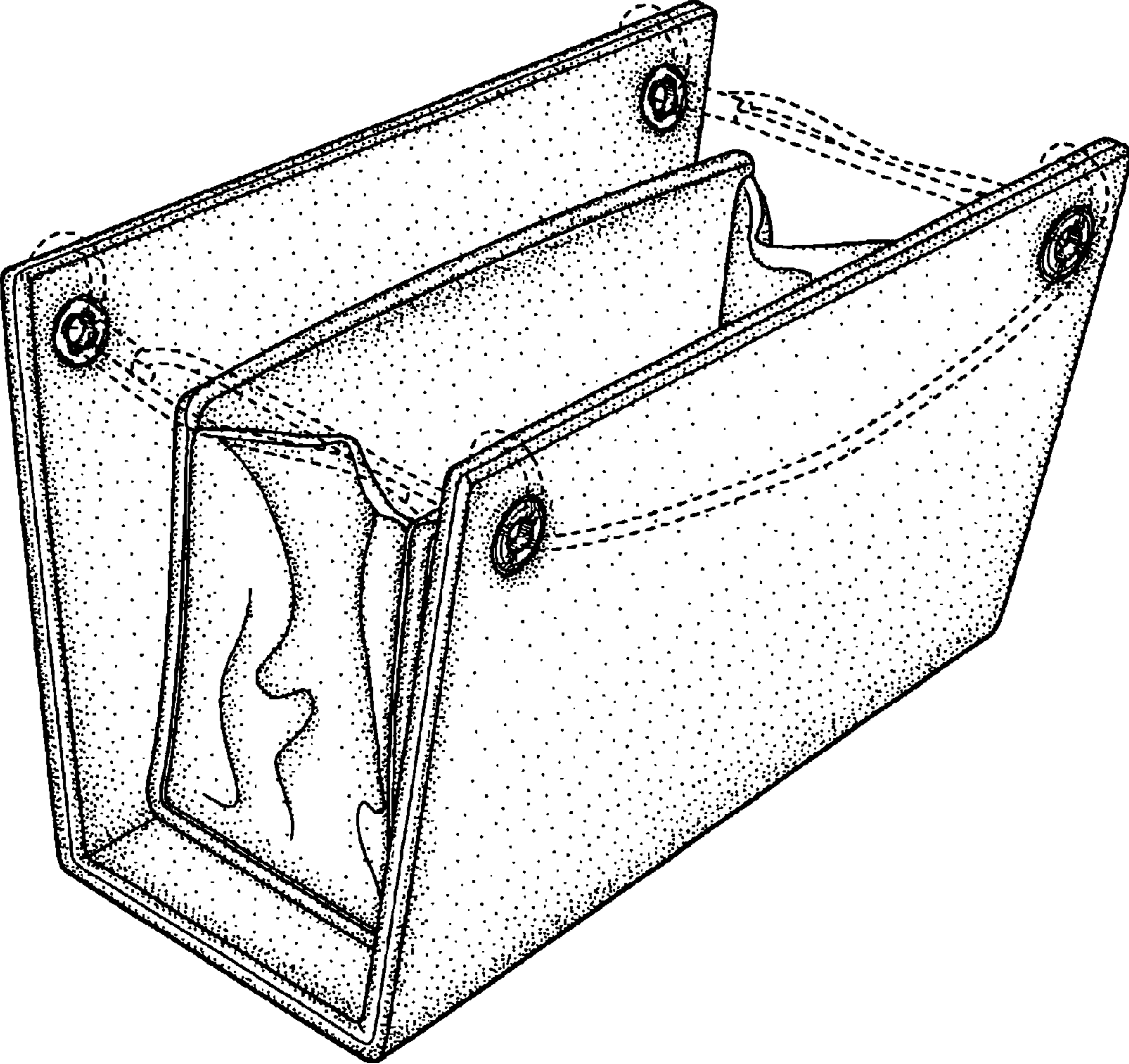
