FIG. 3 is a rear view of the coffee machine illustrated in FIG. 1;

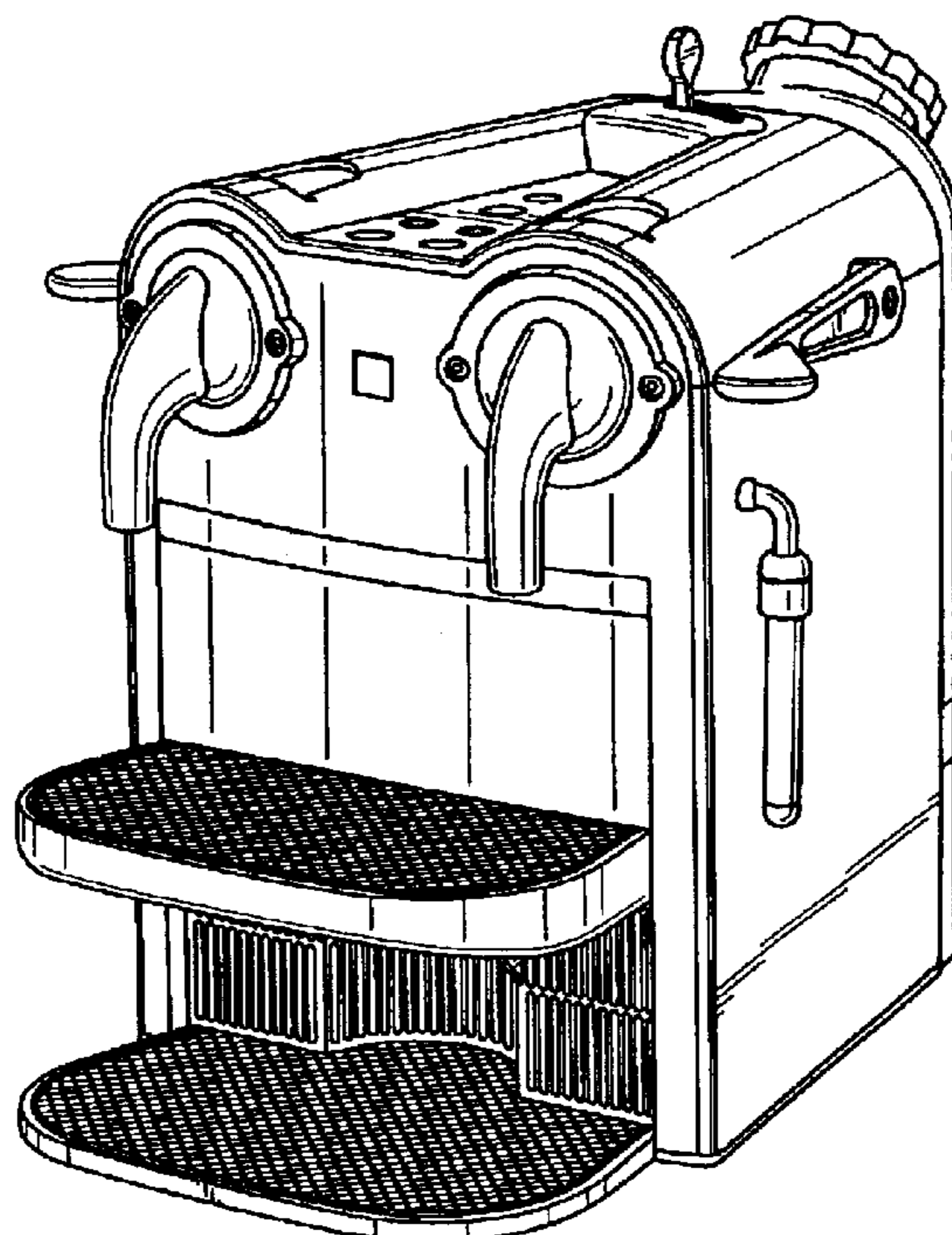
FIG. 4 is a first side view of the coffee machine illustrated in FIG. 1;

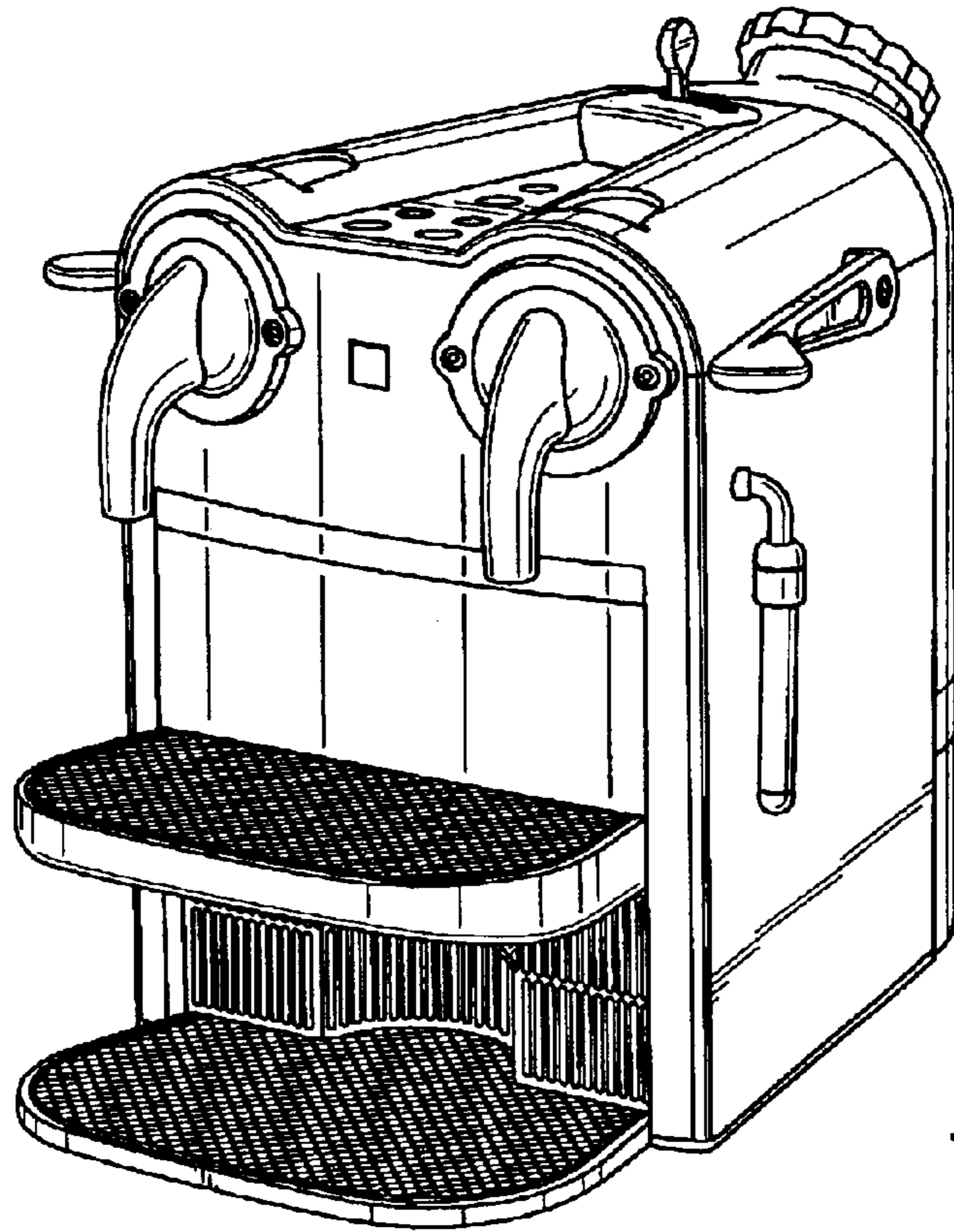

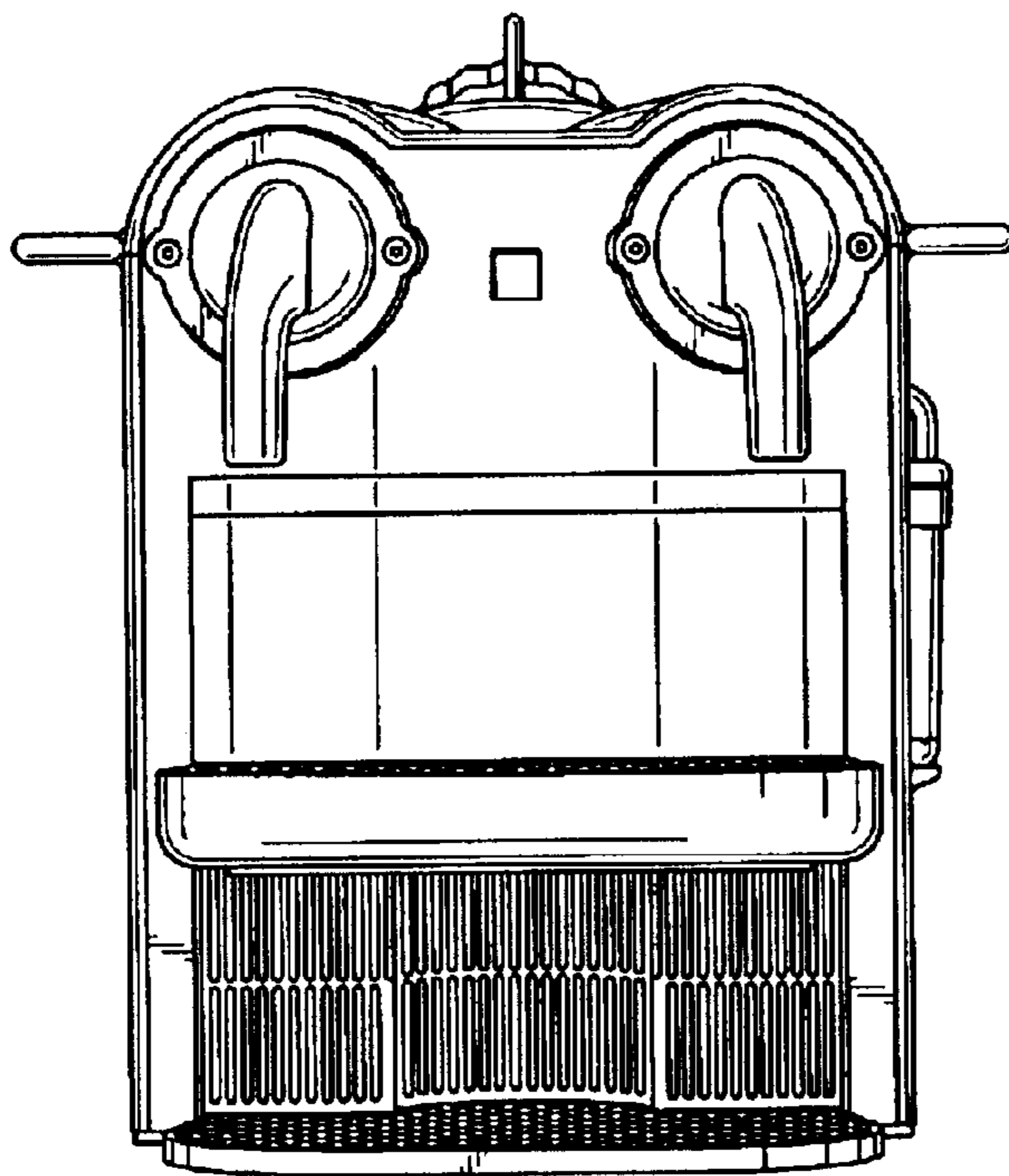

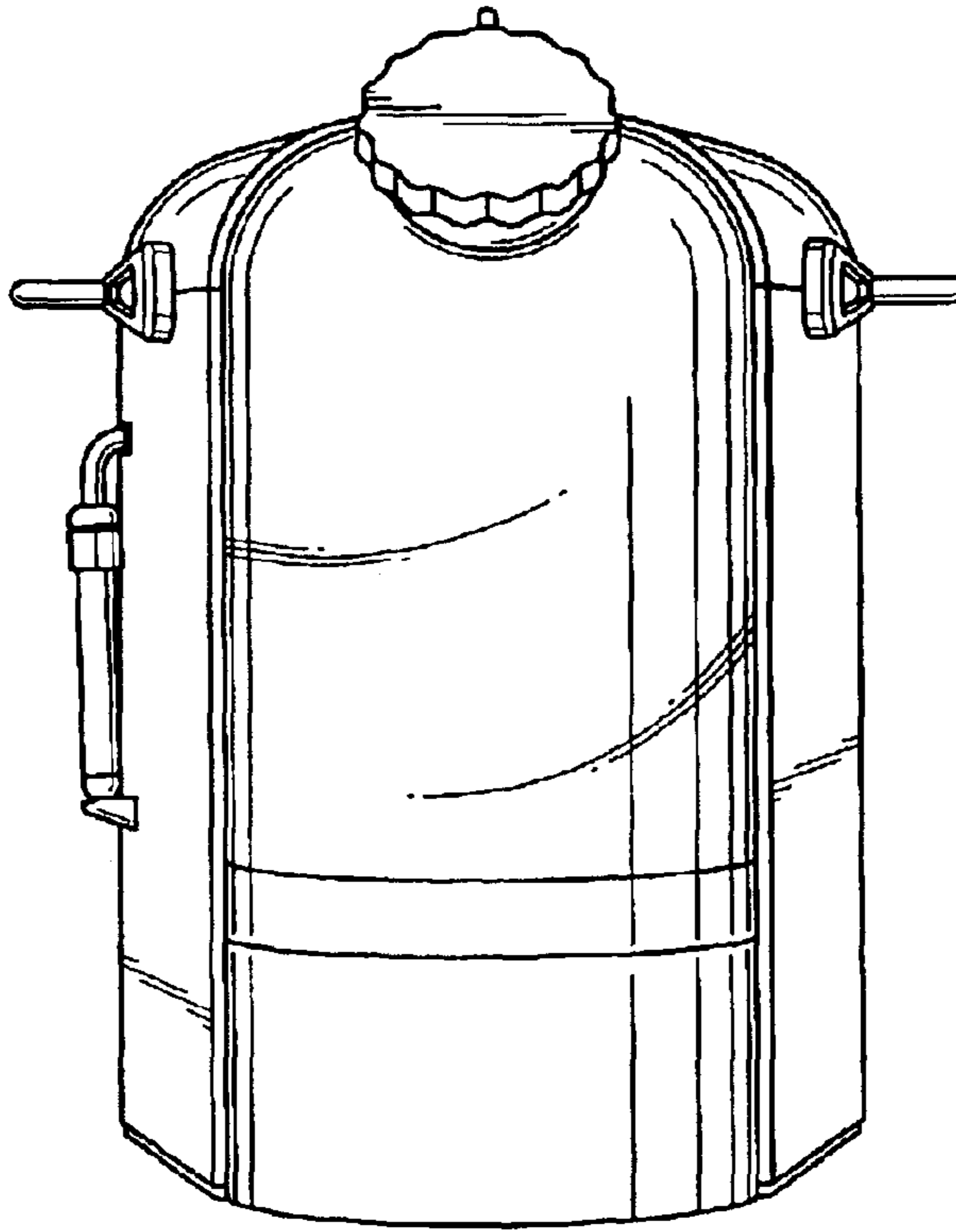
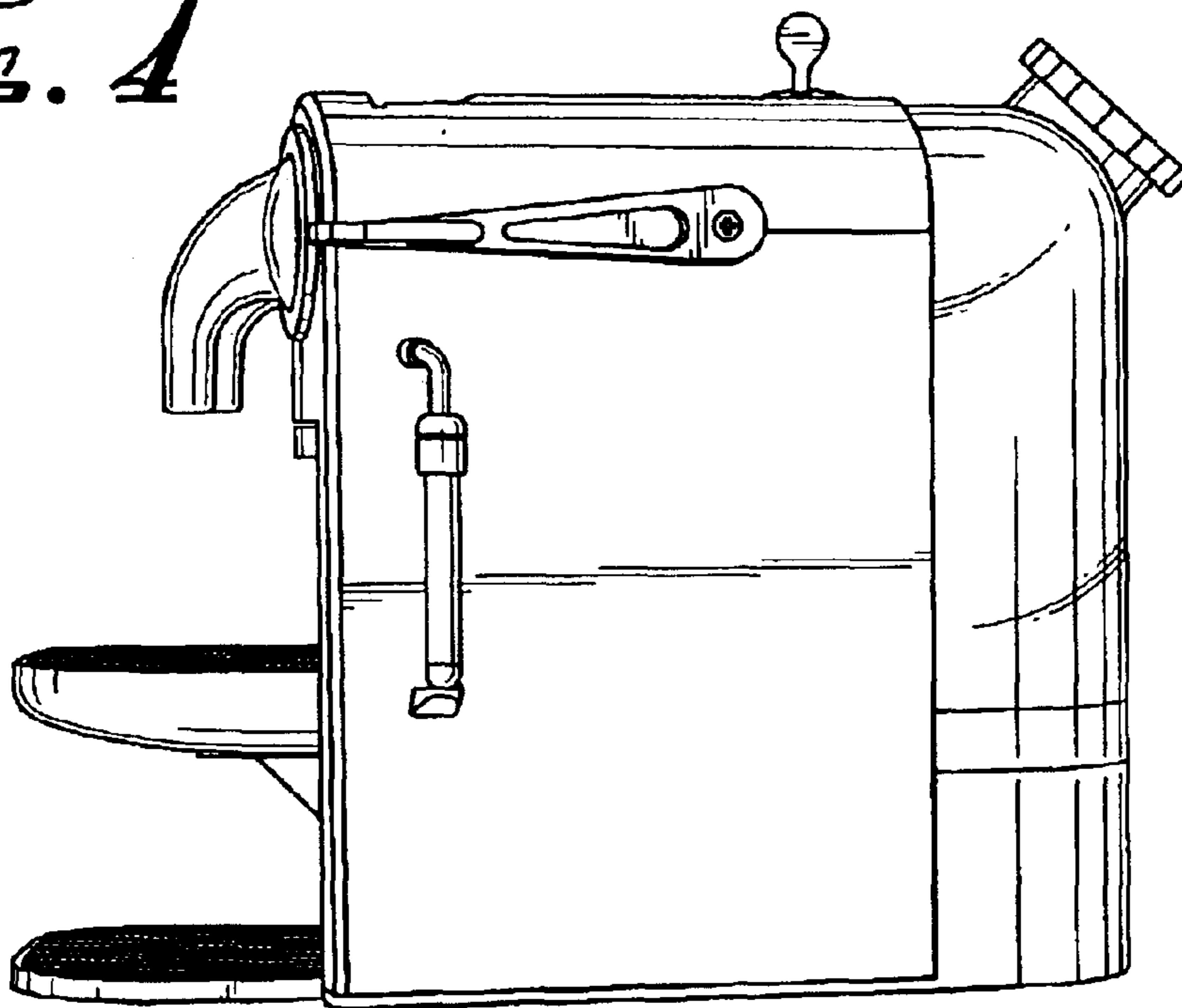

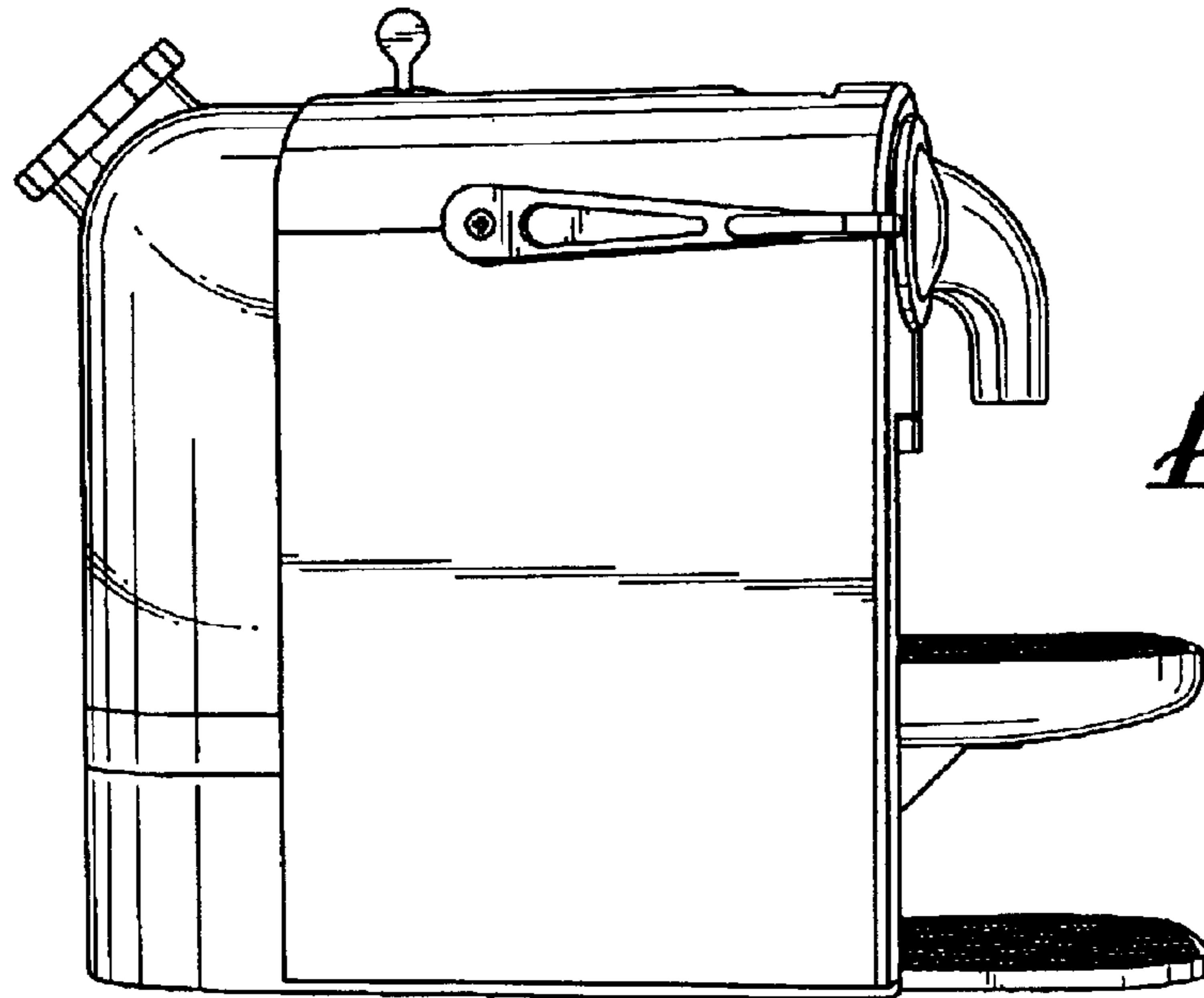

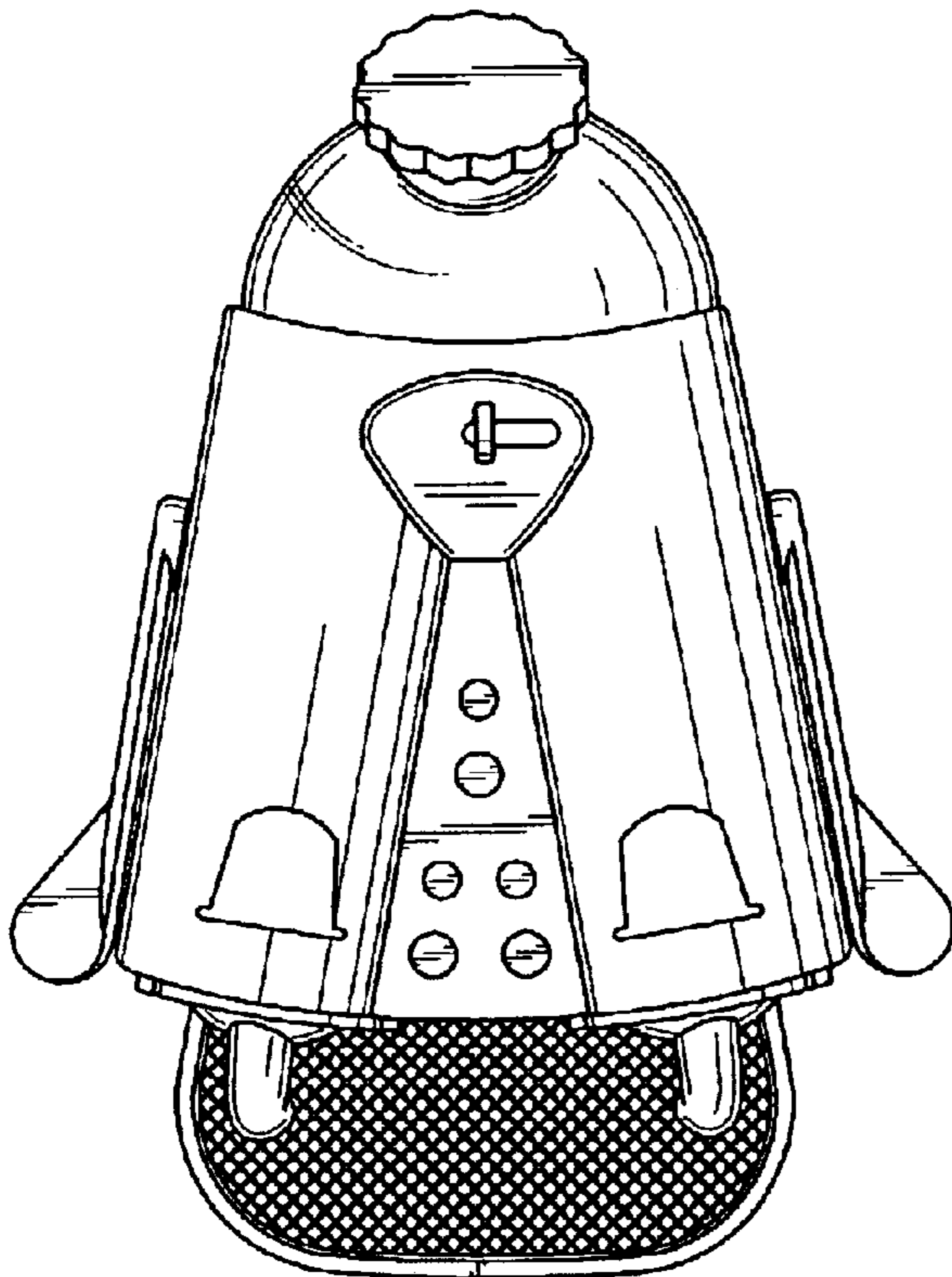

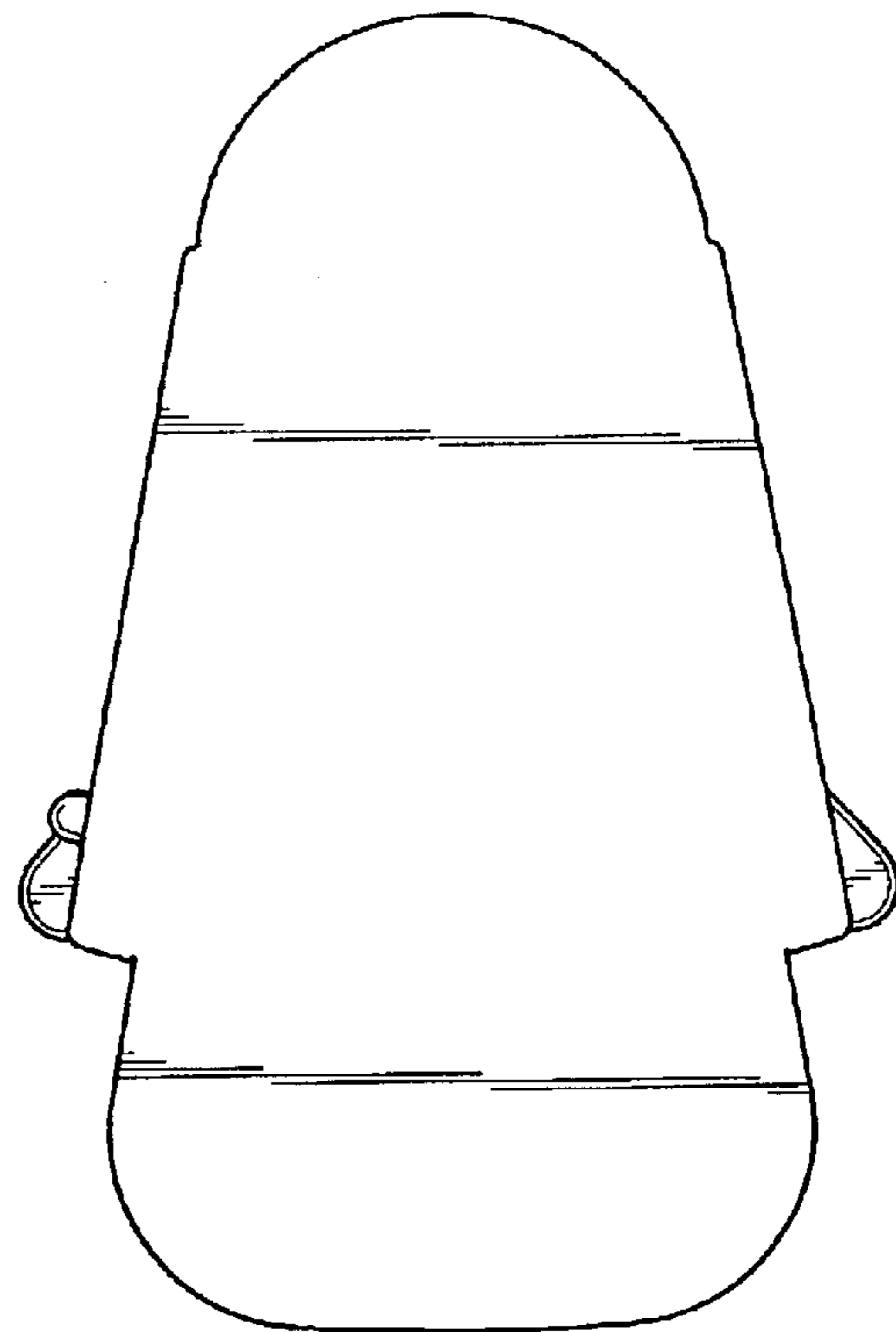
