The ornamental design for an album, as shown and described.

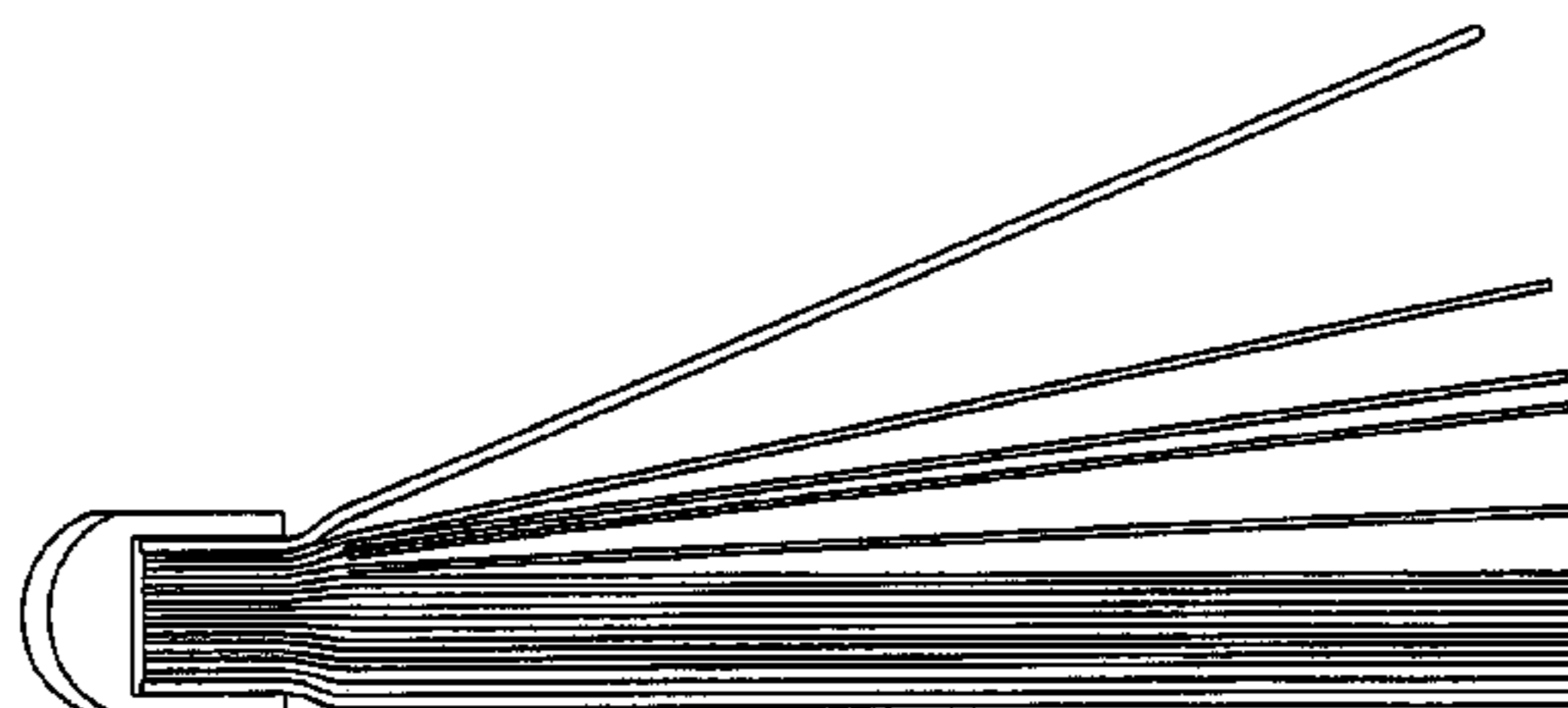
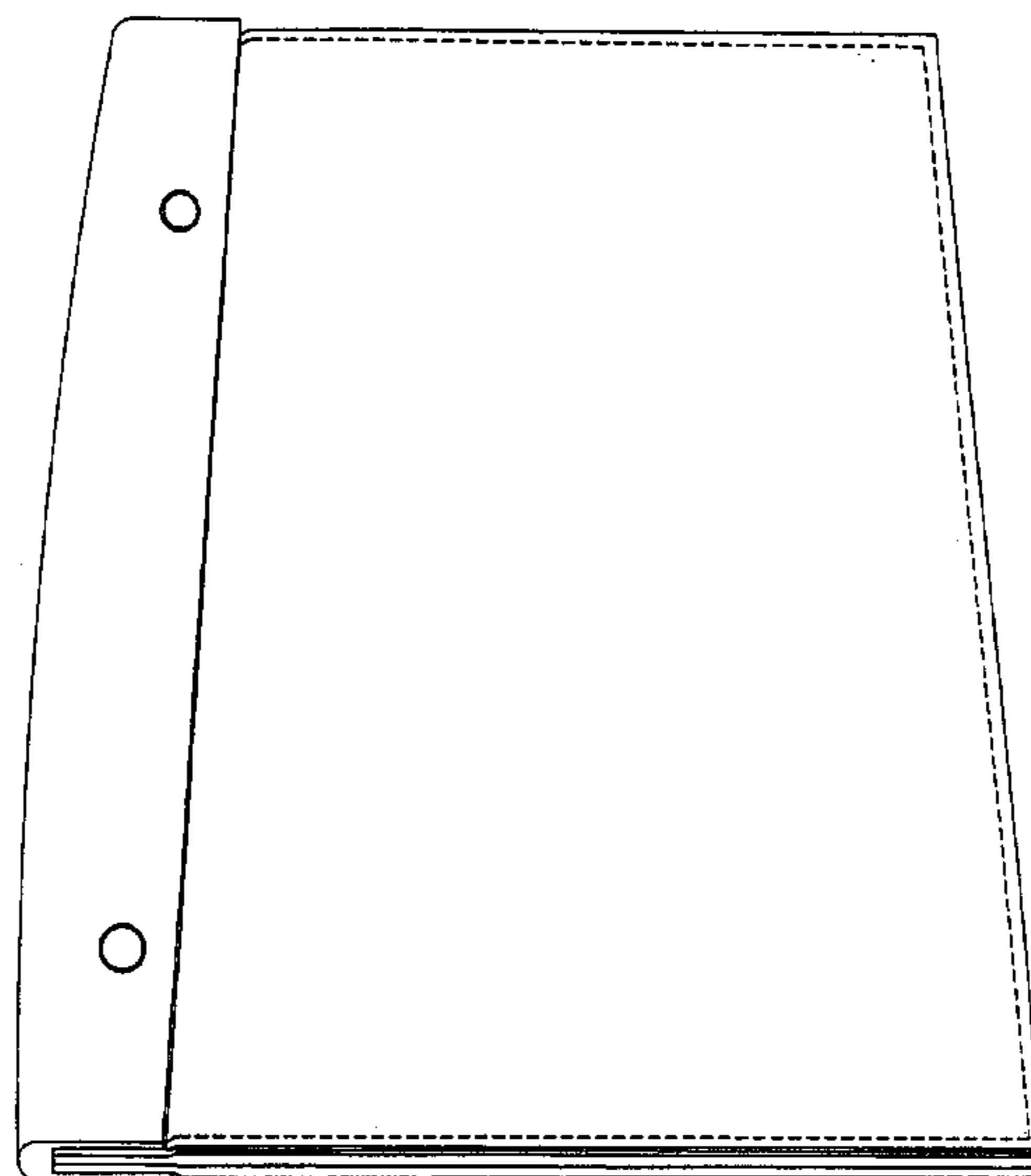
DESCRIPTION

FIG. 1 is a perspective view of the album of the invention; FIG. 2 is an end view of the album of the invention in a closed arrangement; and,

FIG. 3 is an end view of the album of the invention similar to that of FIG. 2 except with the album opened.

The broken lines shown in FIG. 1 are intended to represent a pattern of stitching.

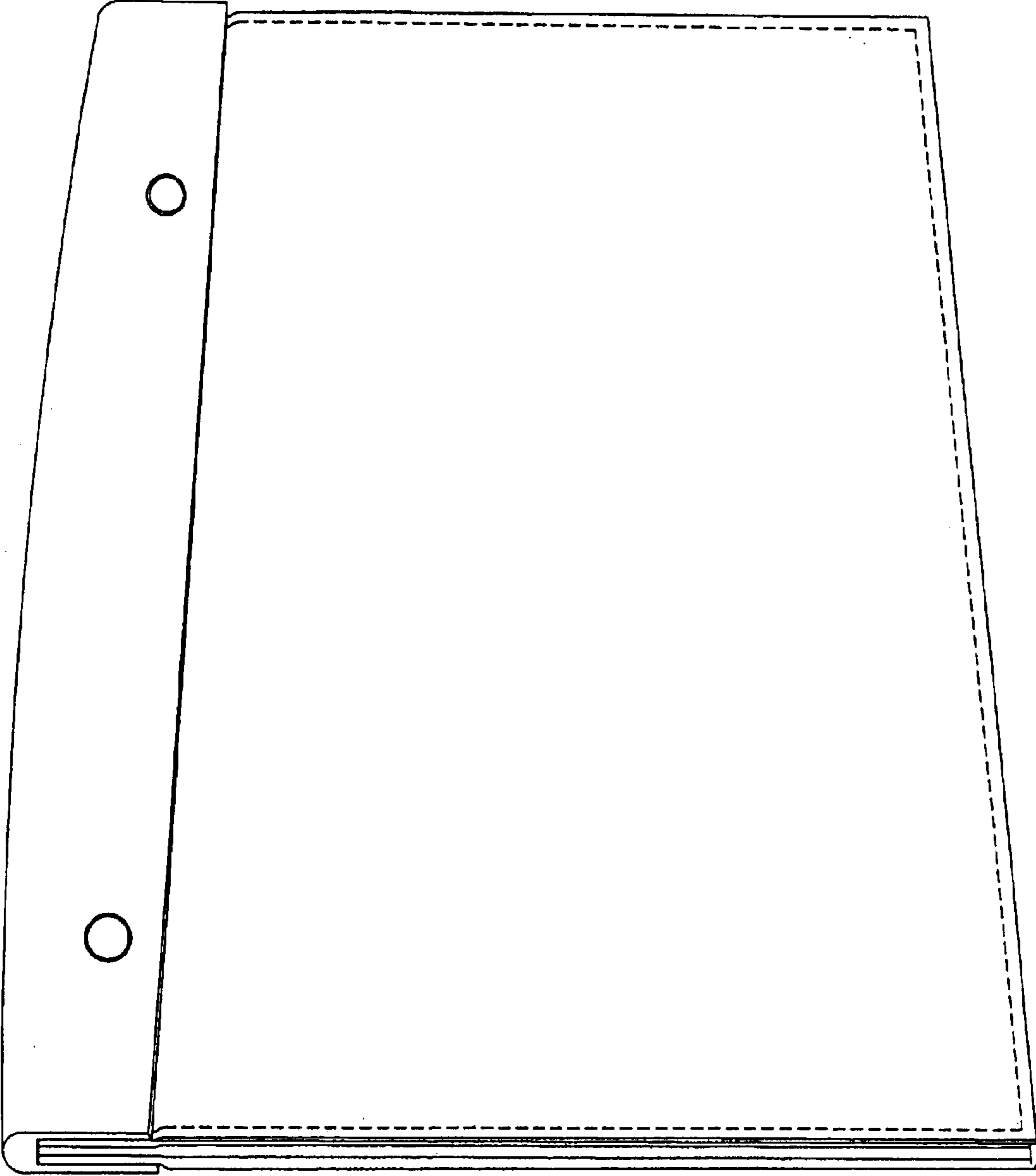

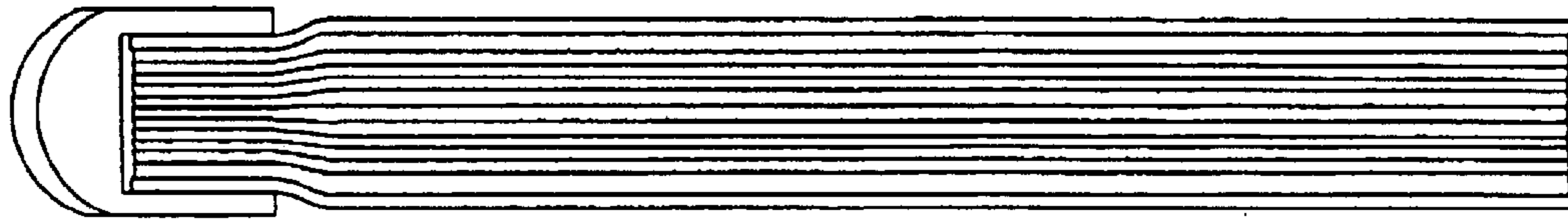

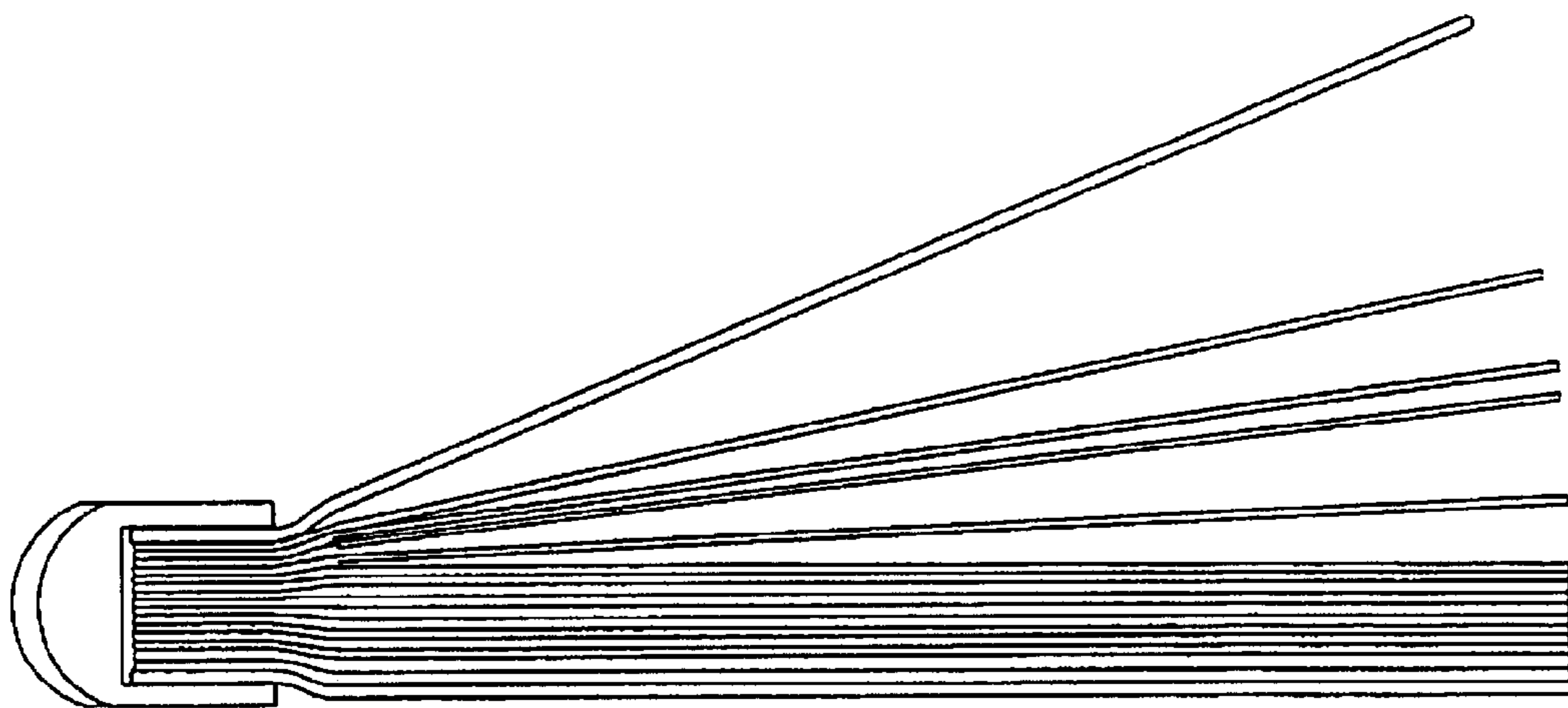
