FIG. 1 is a perspective view from below of a lighting fixture in accordance with my design;

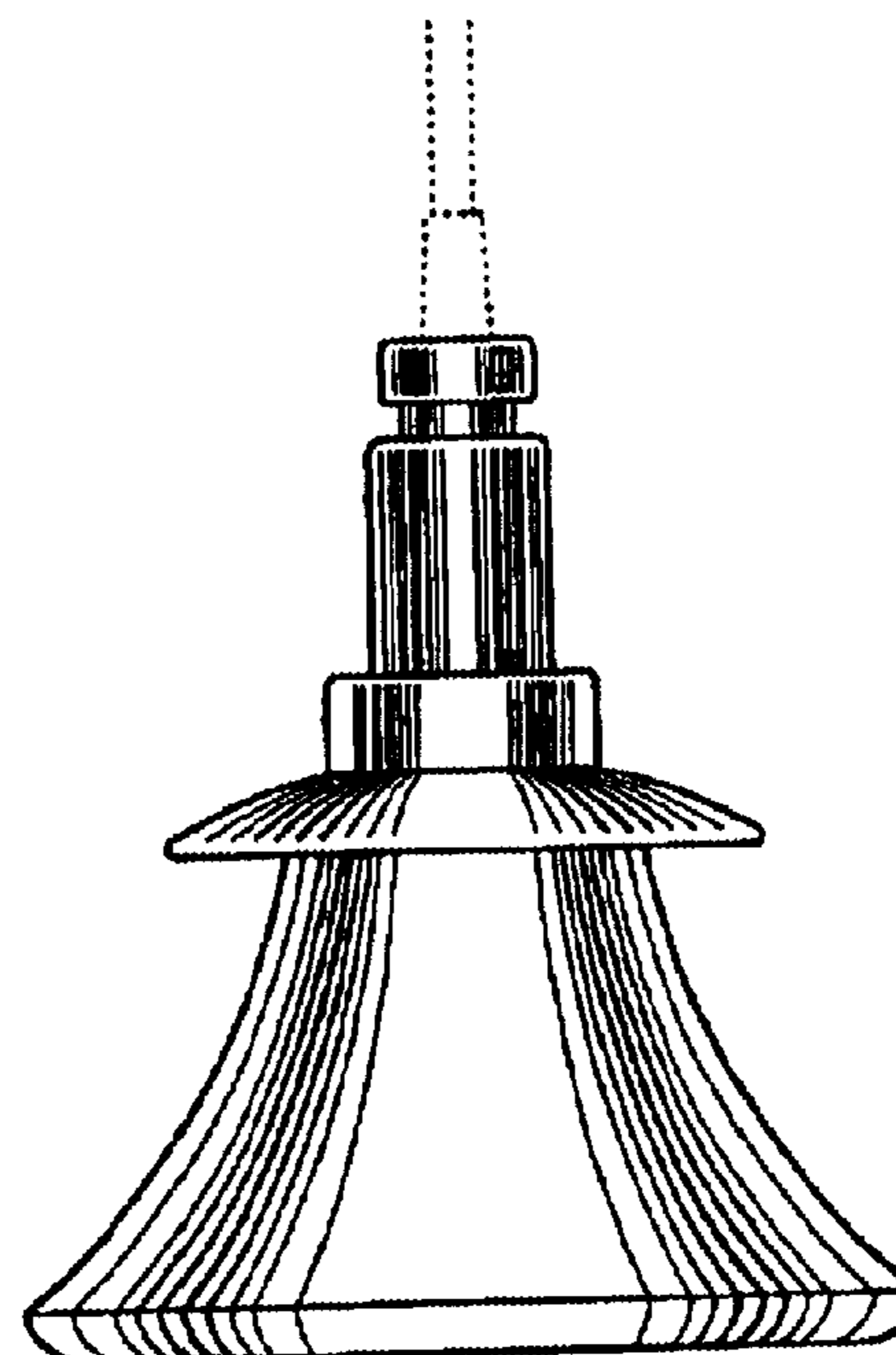
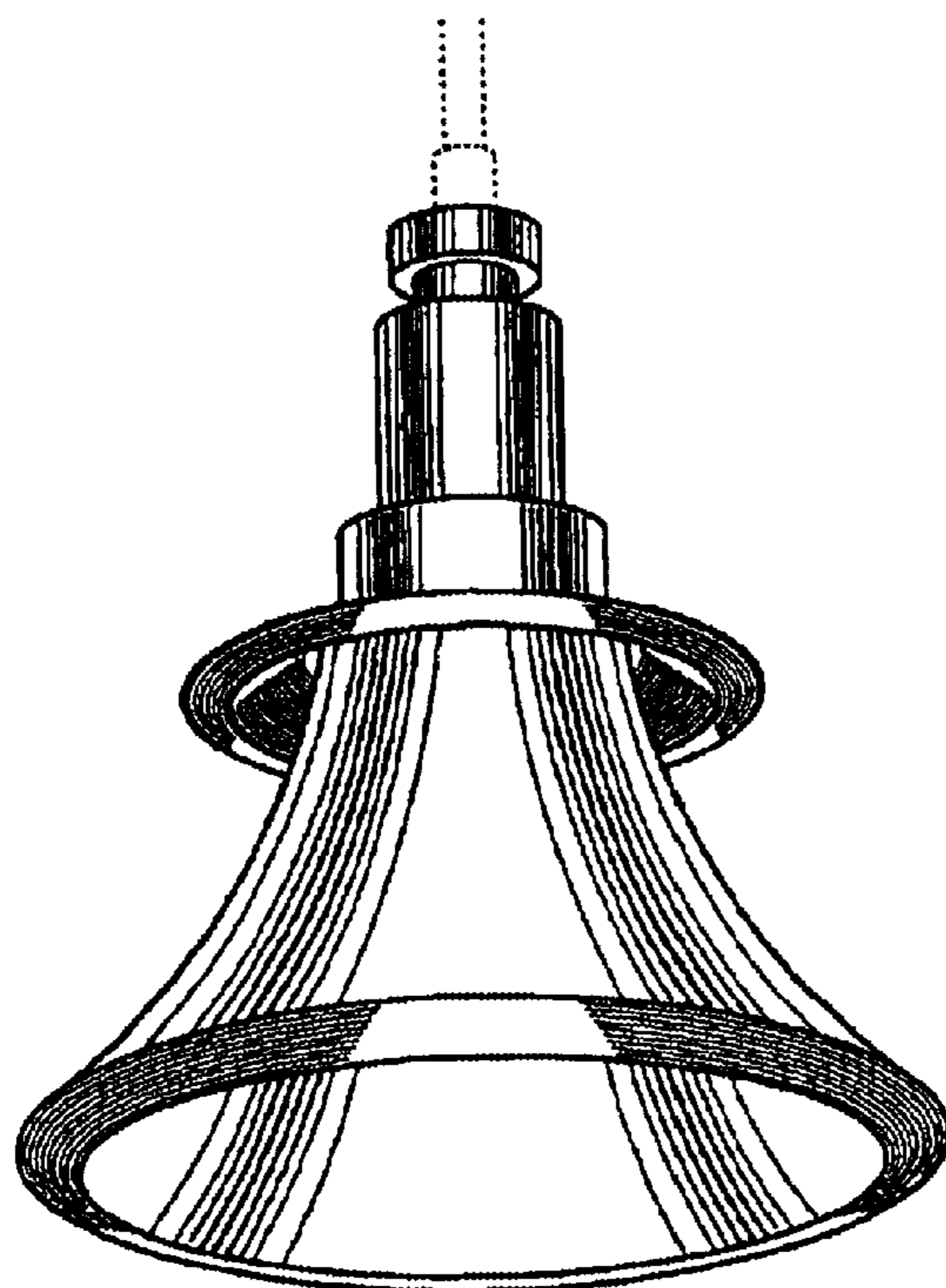
FIG. 2 is a side elevation view of the lighting fixture in accordance with my design;

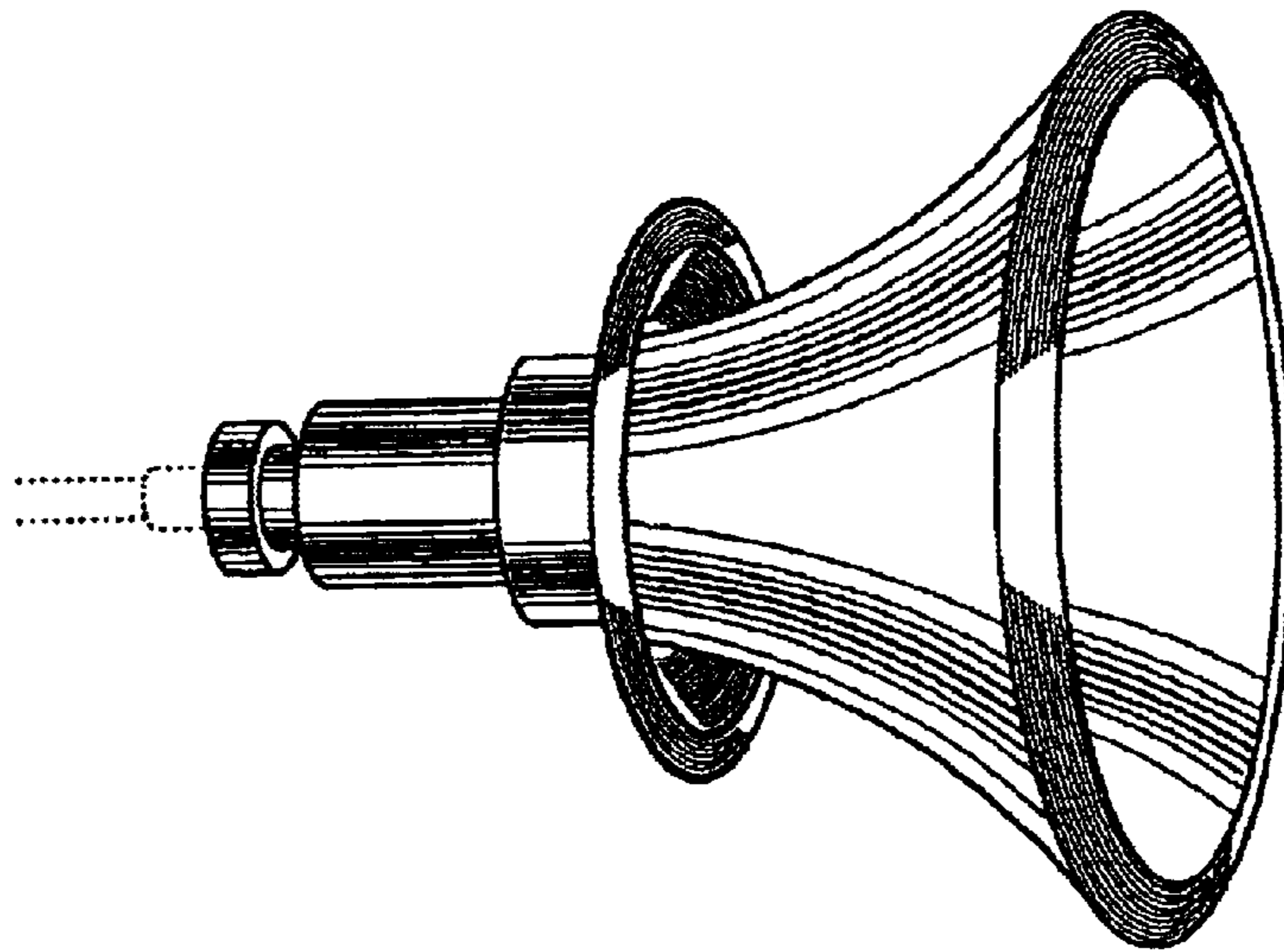

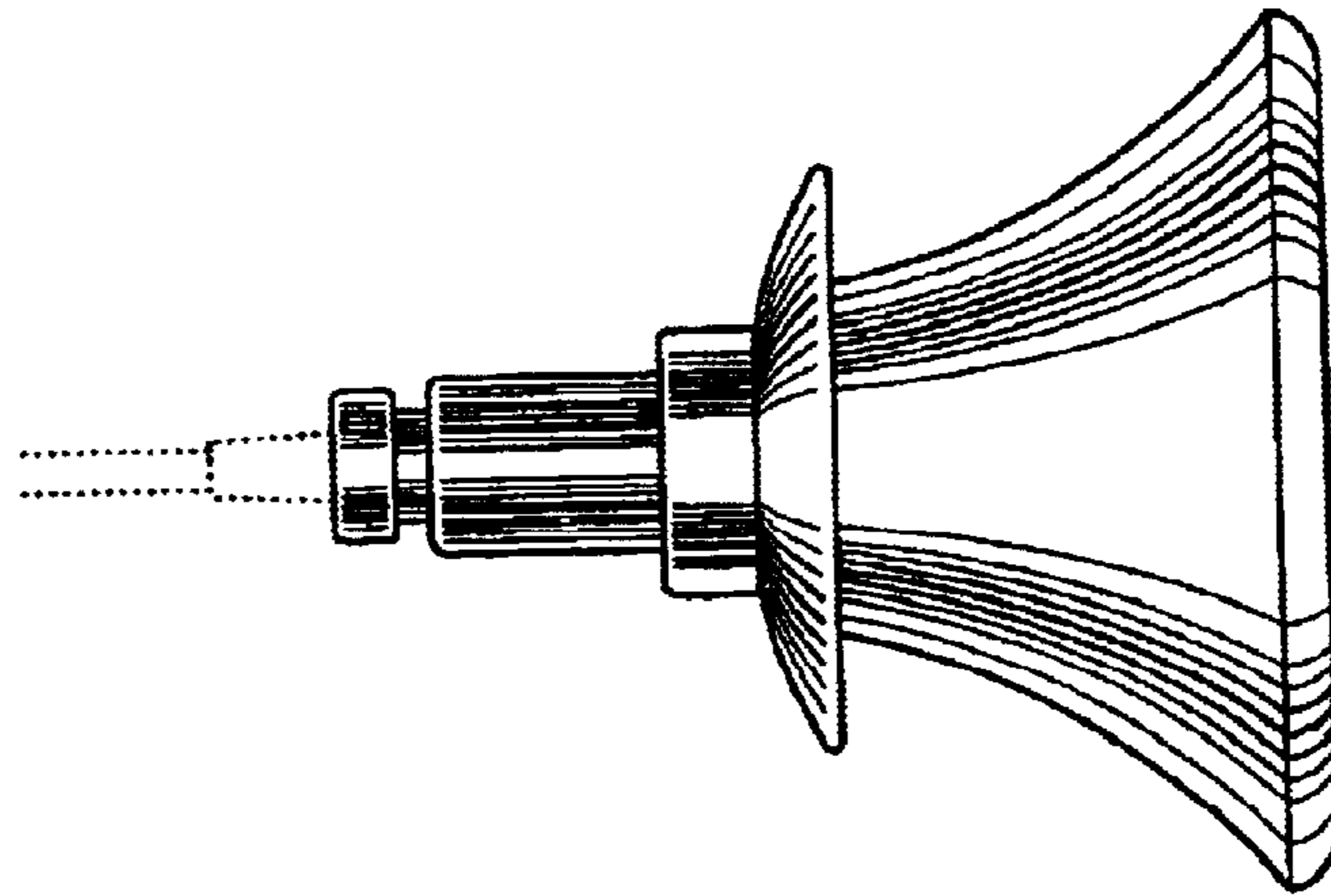

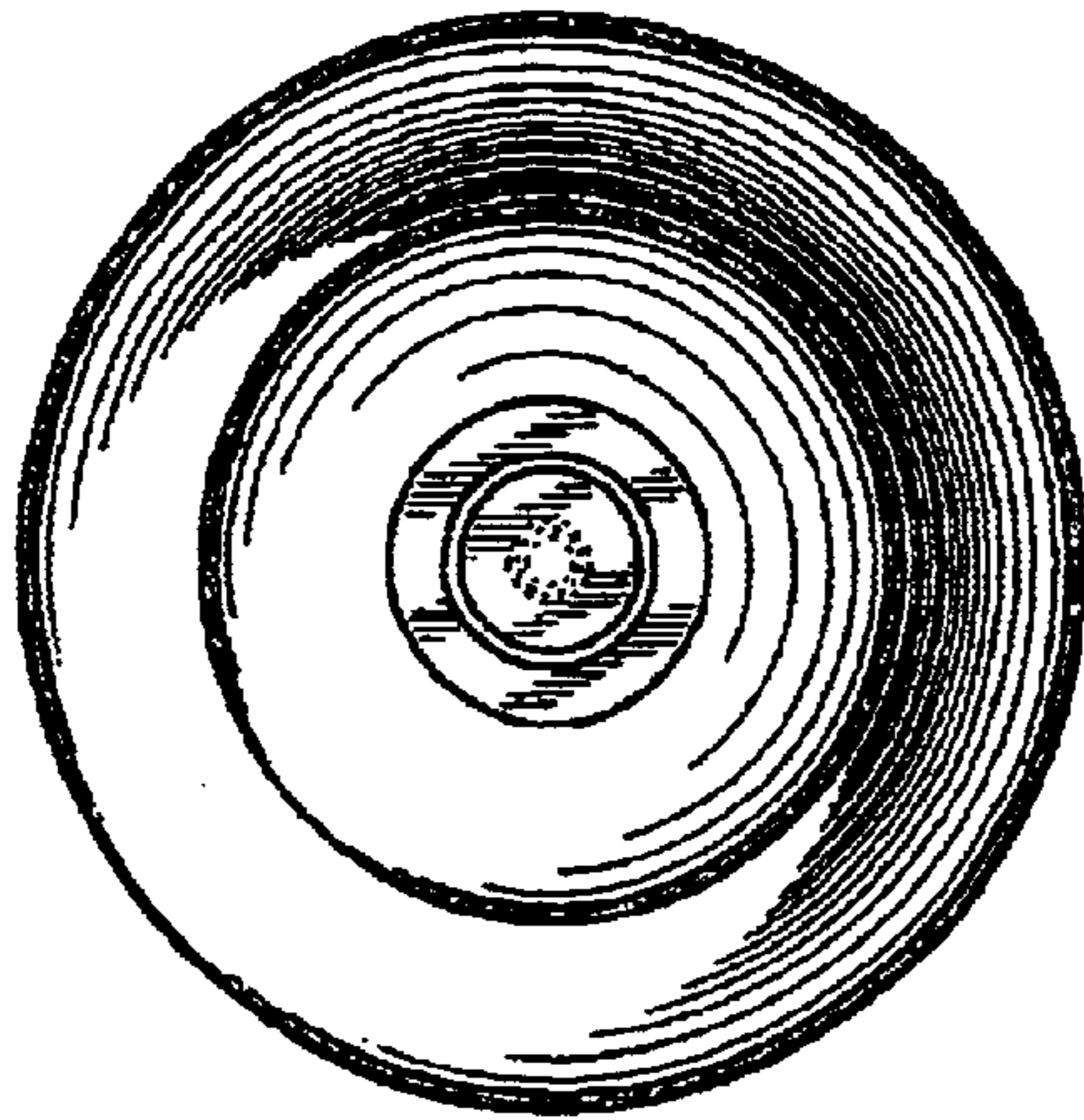

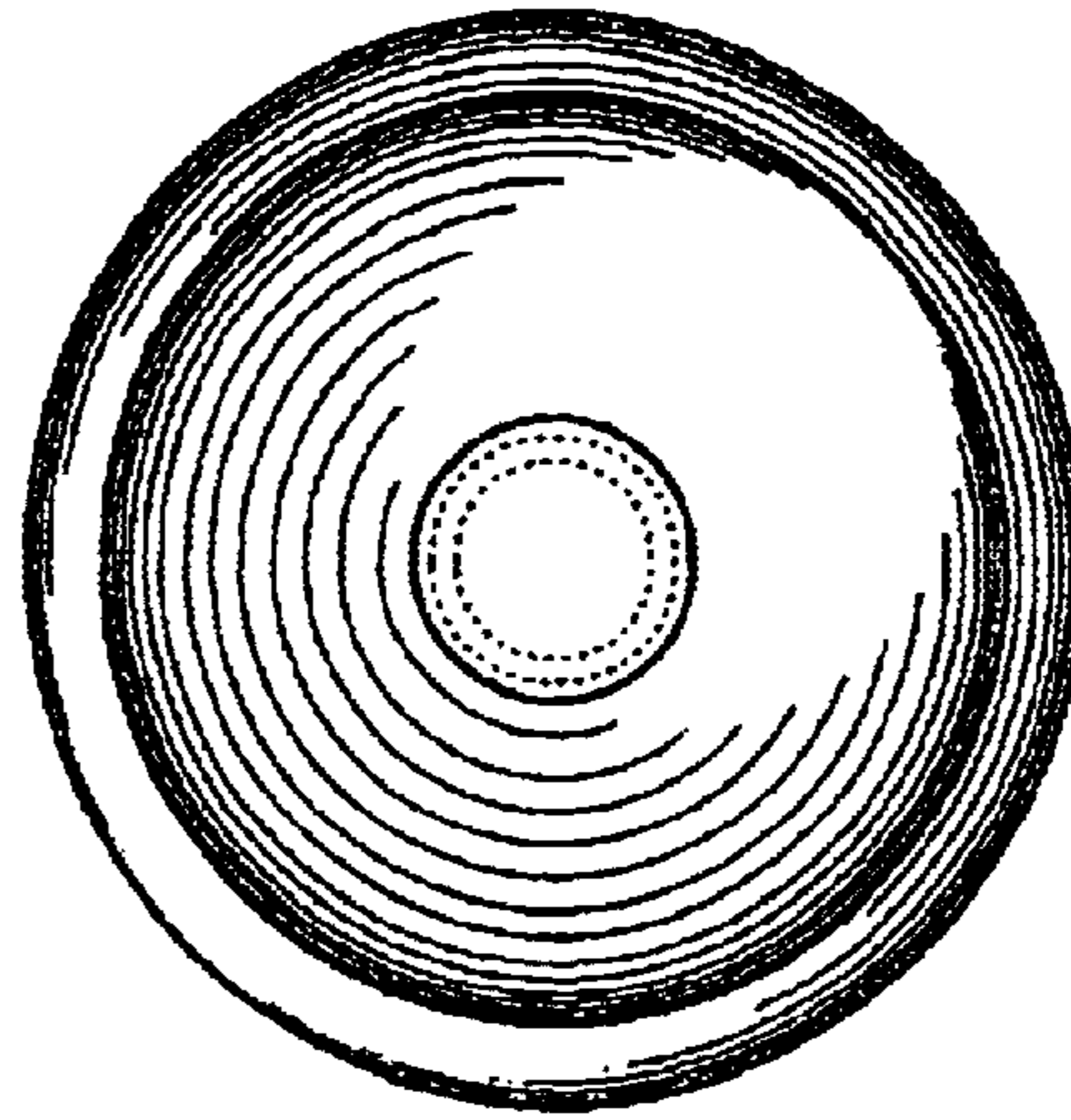
