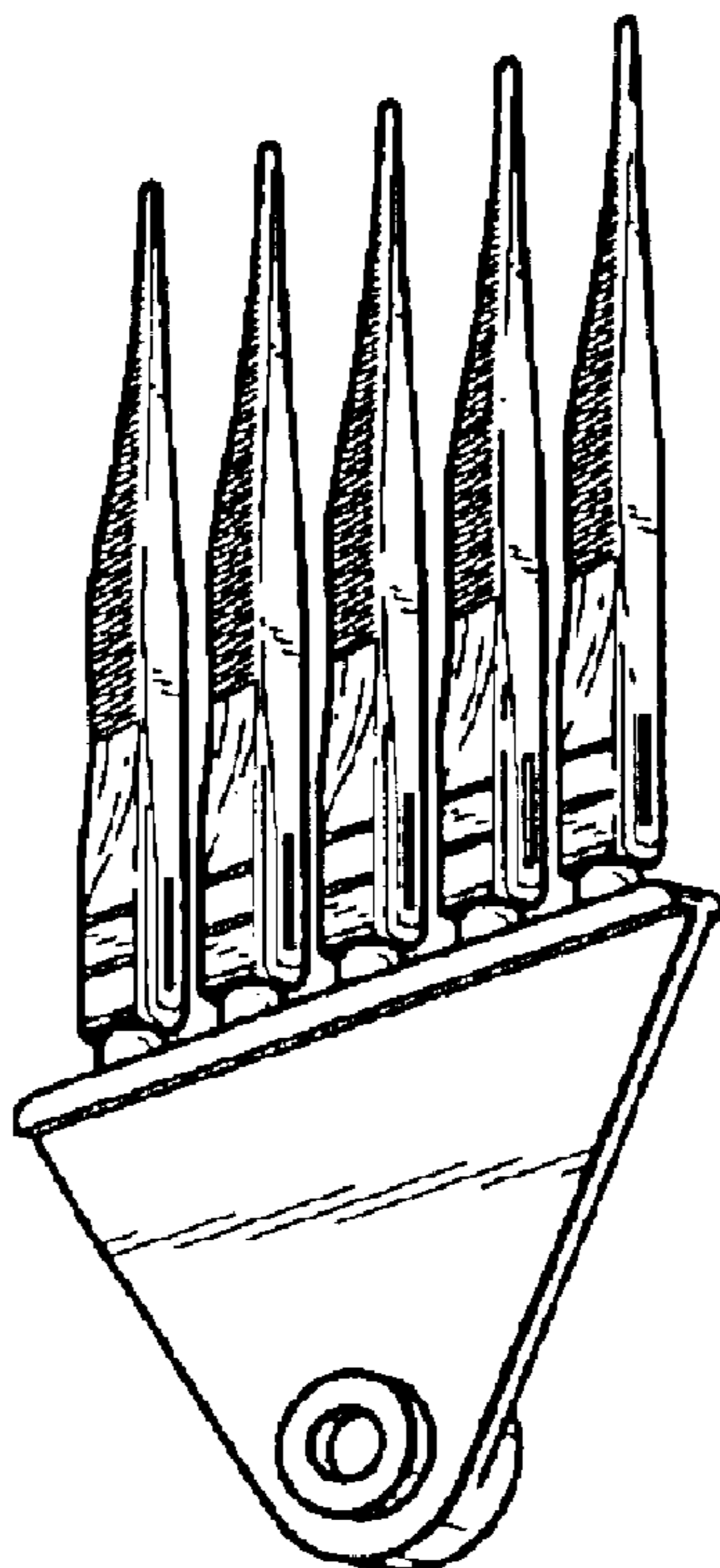
FIG. 1 is a perspective view of a toothpick magazine showing the new design;

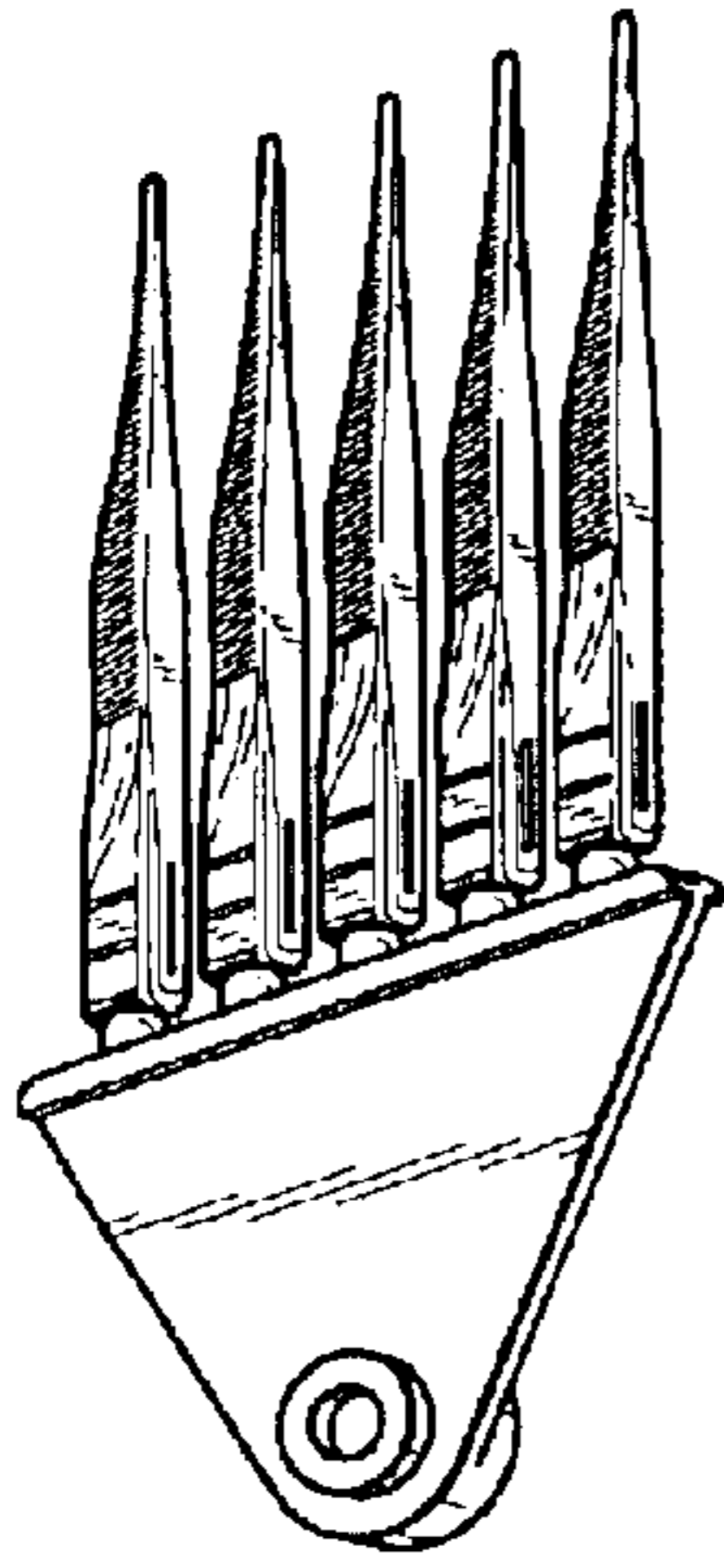

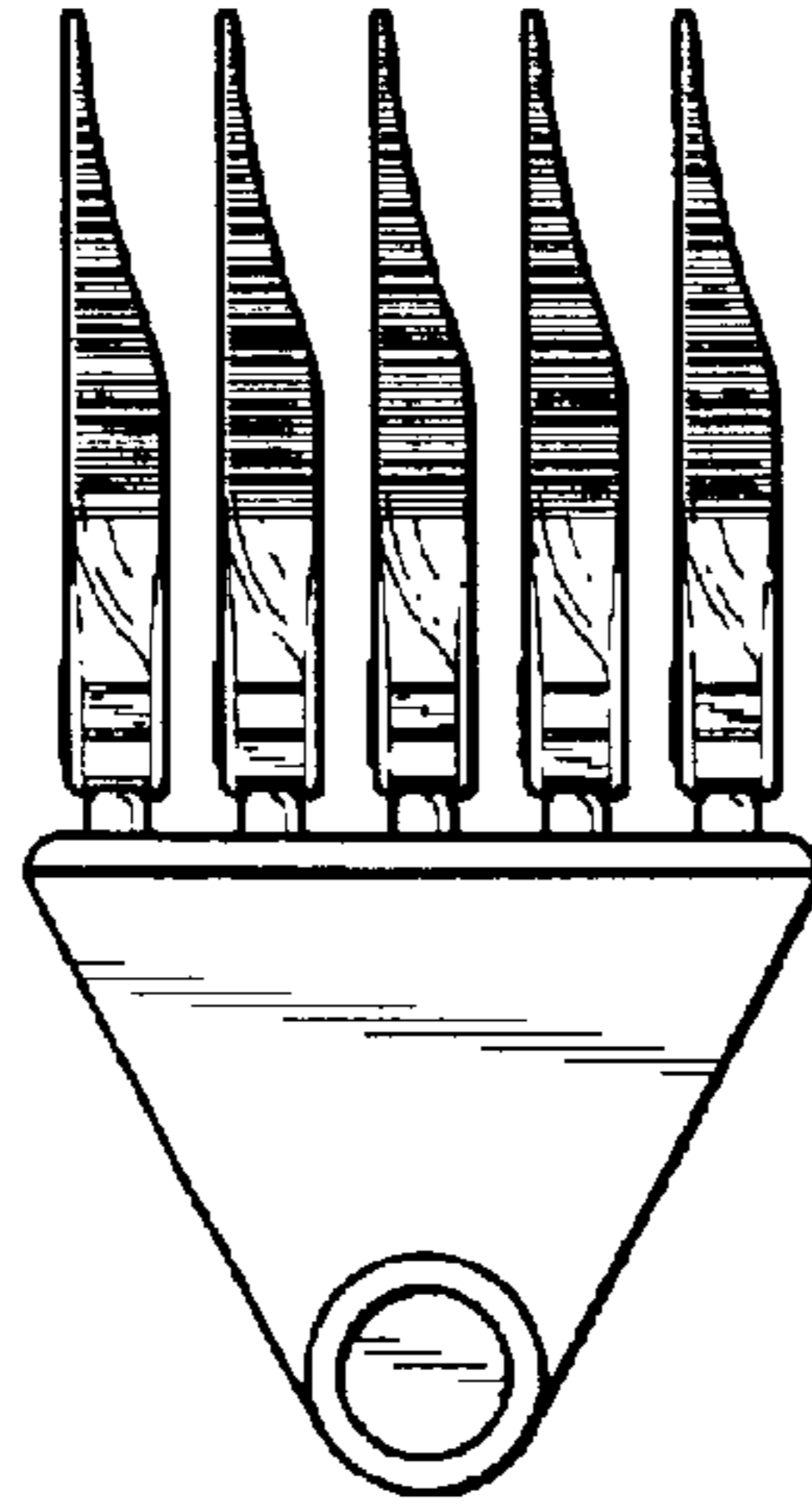

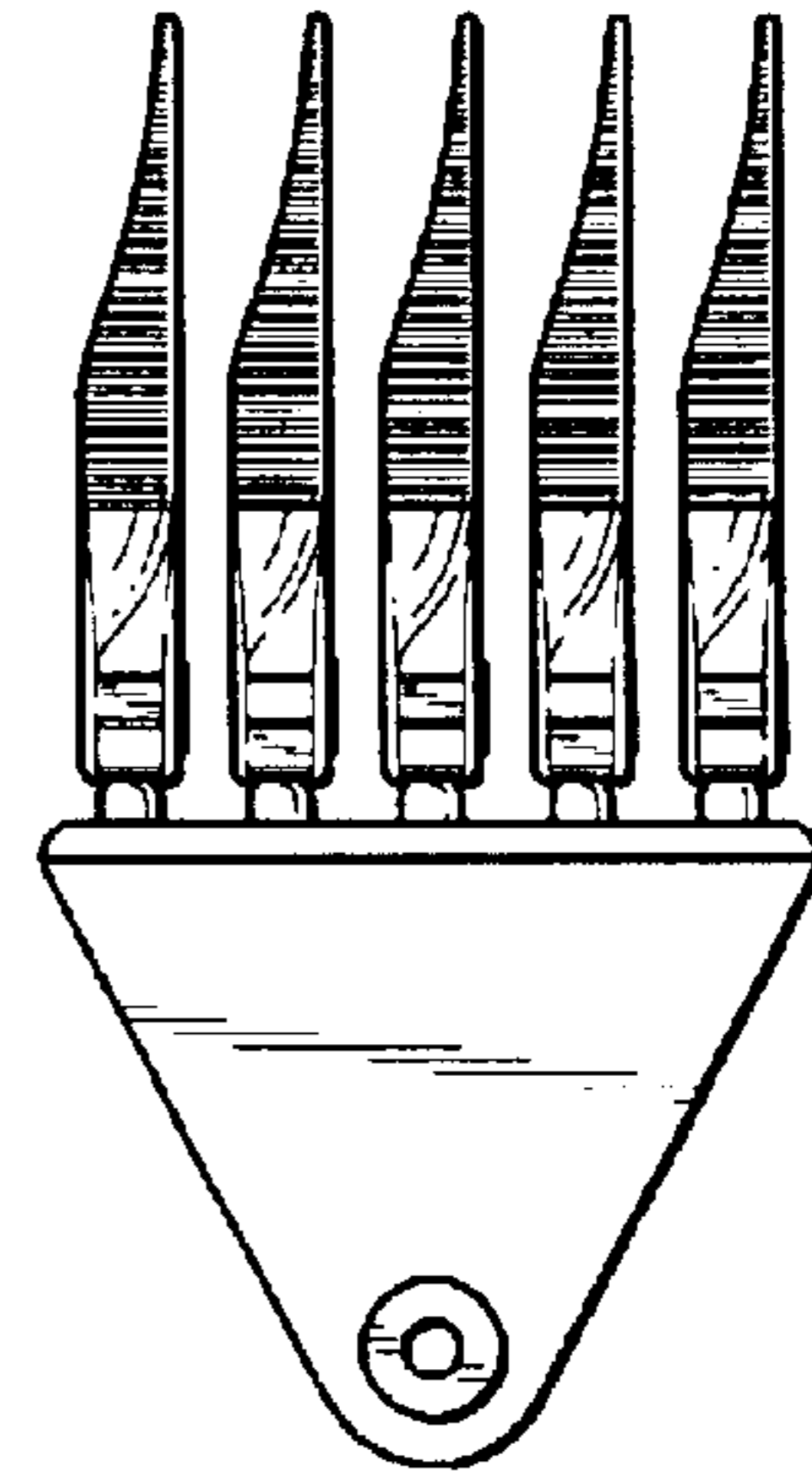
