We claim the ornamental design for a pet chew with 8 buttons, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pet chew with 8 buttons of the invention;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a right side elevational view thereof; and,
FIG. 7 is a left side elevational view thereof.

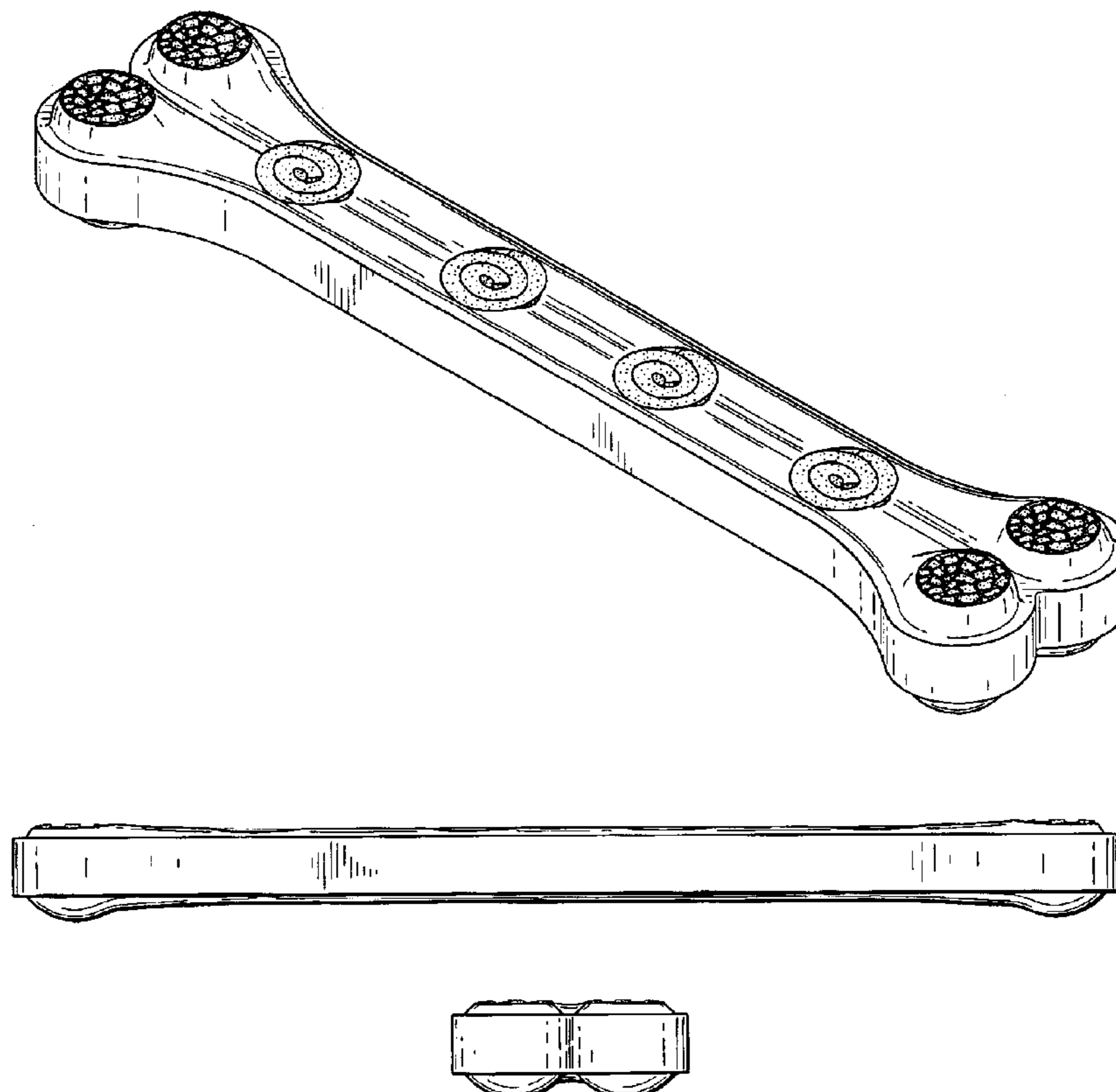

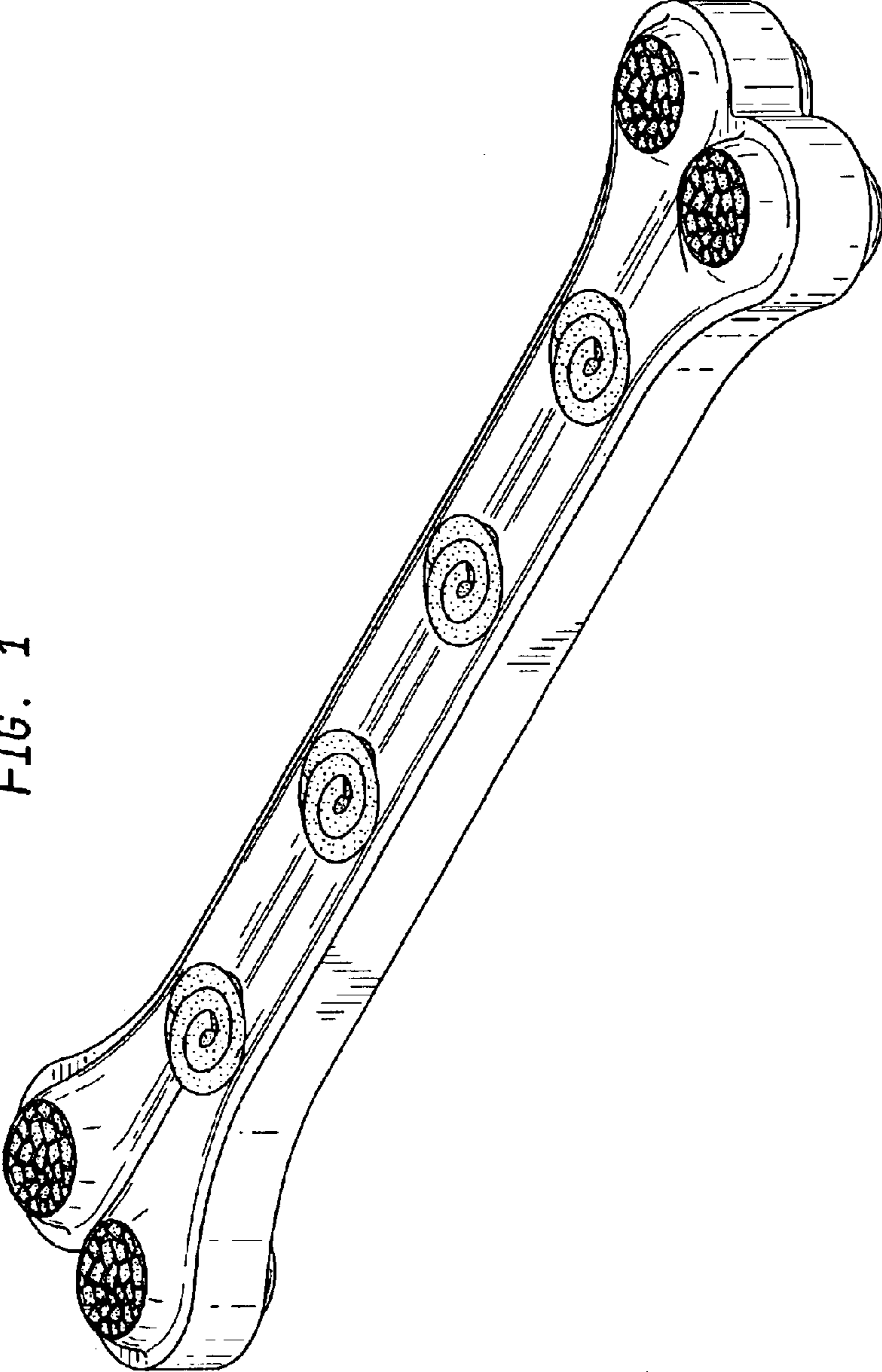

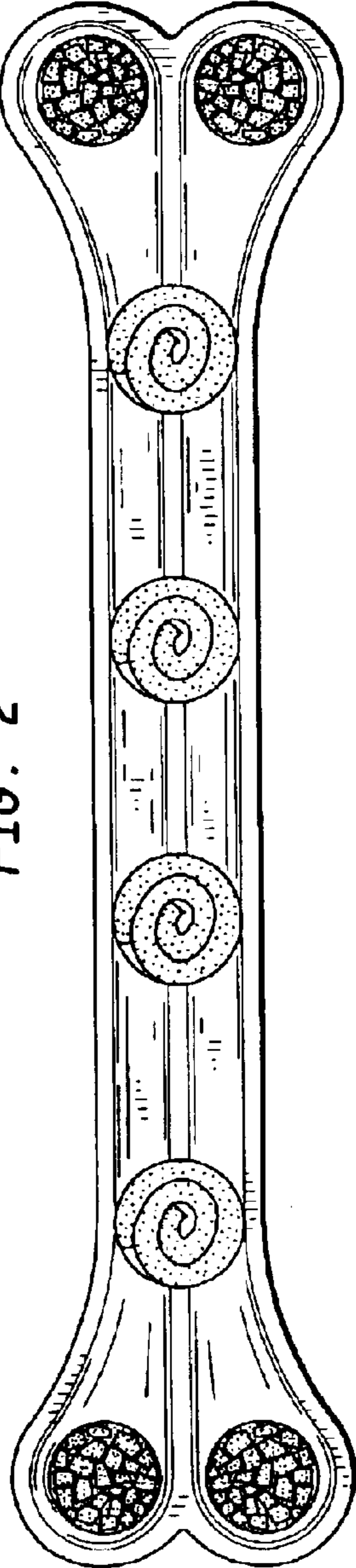

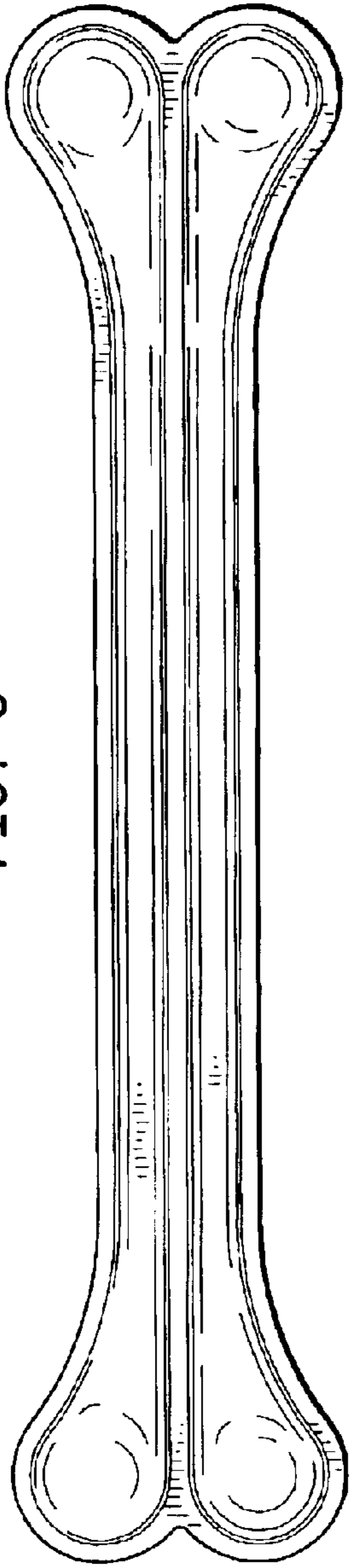

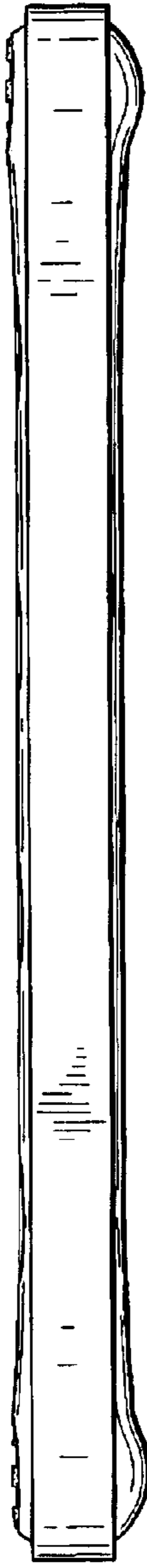

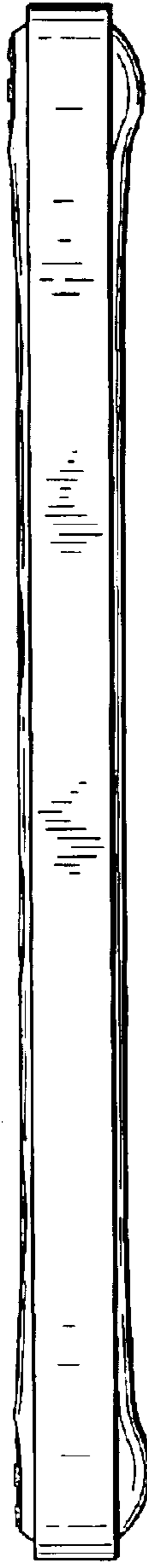

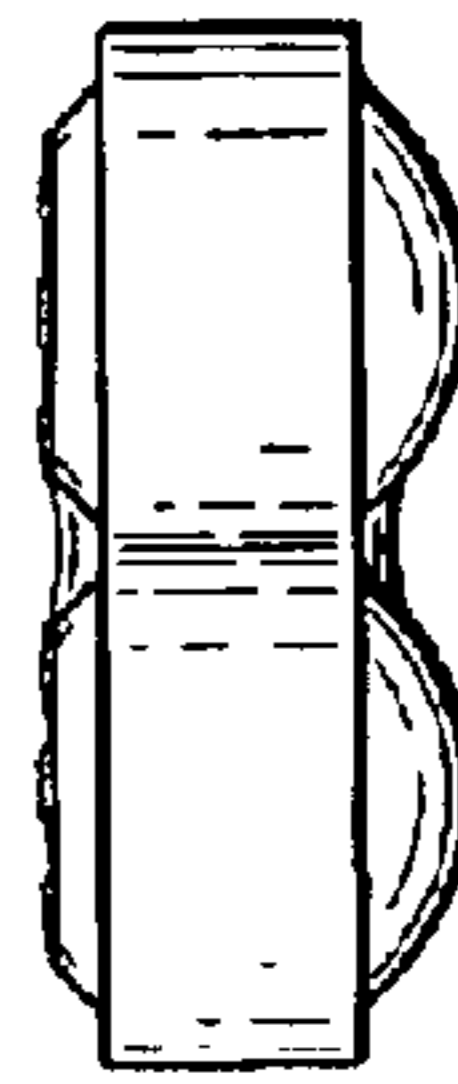
