The ornamental design for a wheeled support for holding articles of clothing on hangers, as shown and described.

DESCRIPTION

FIG. 4 is a left side elevational view thereof.

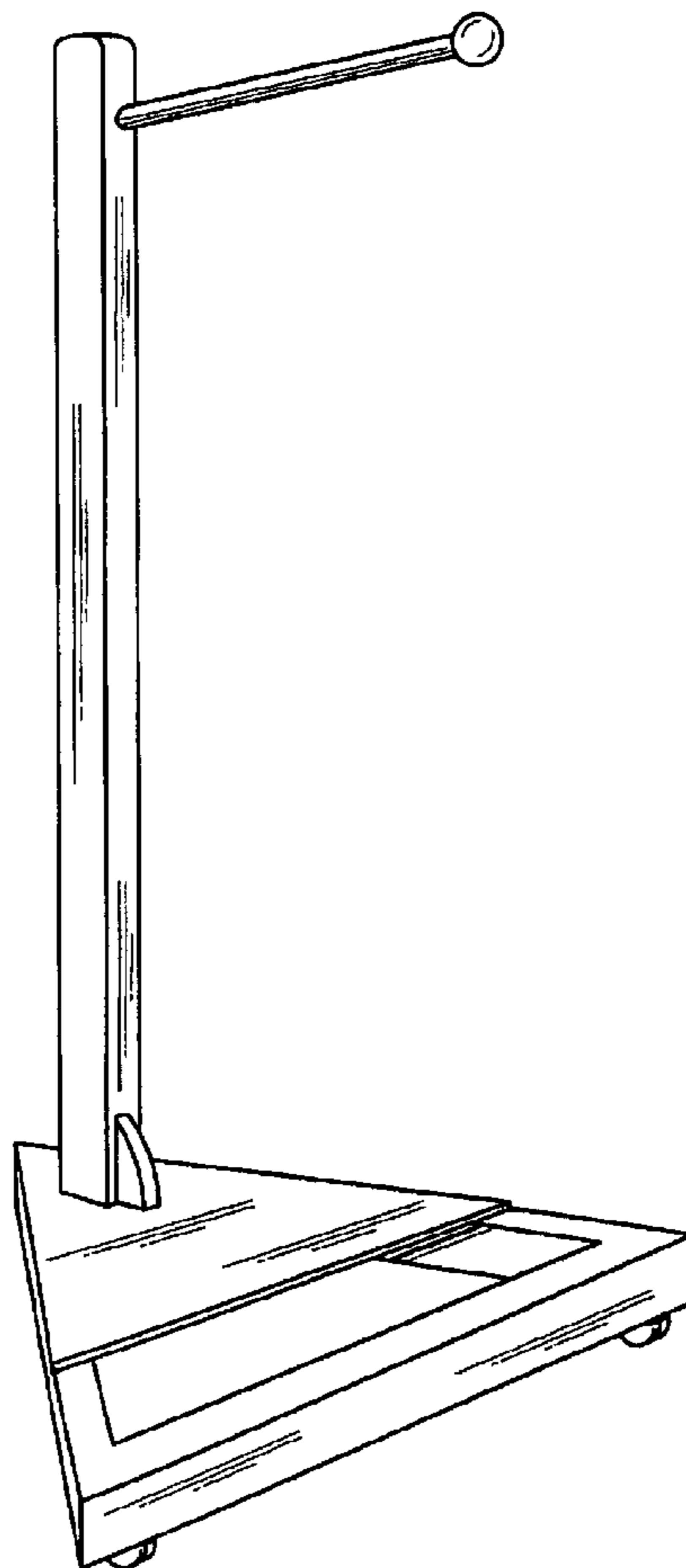
FIG. 5 is a right side elevational view thereof.

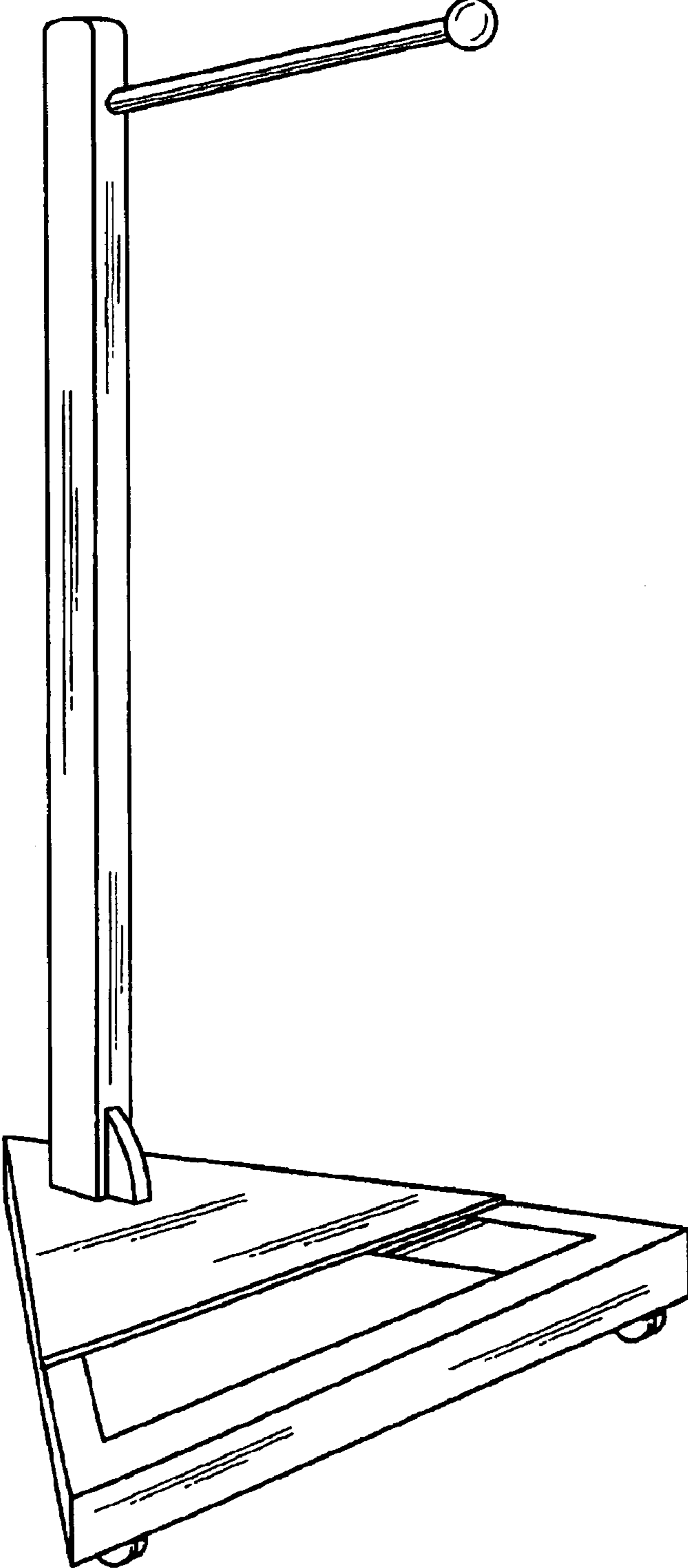

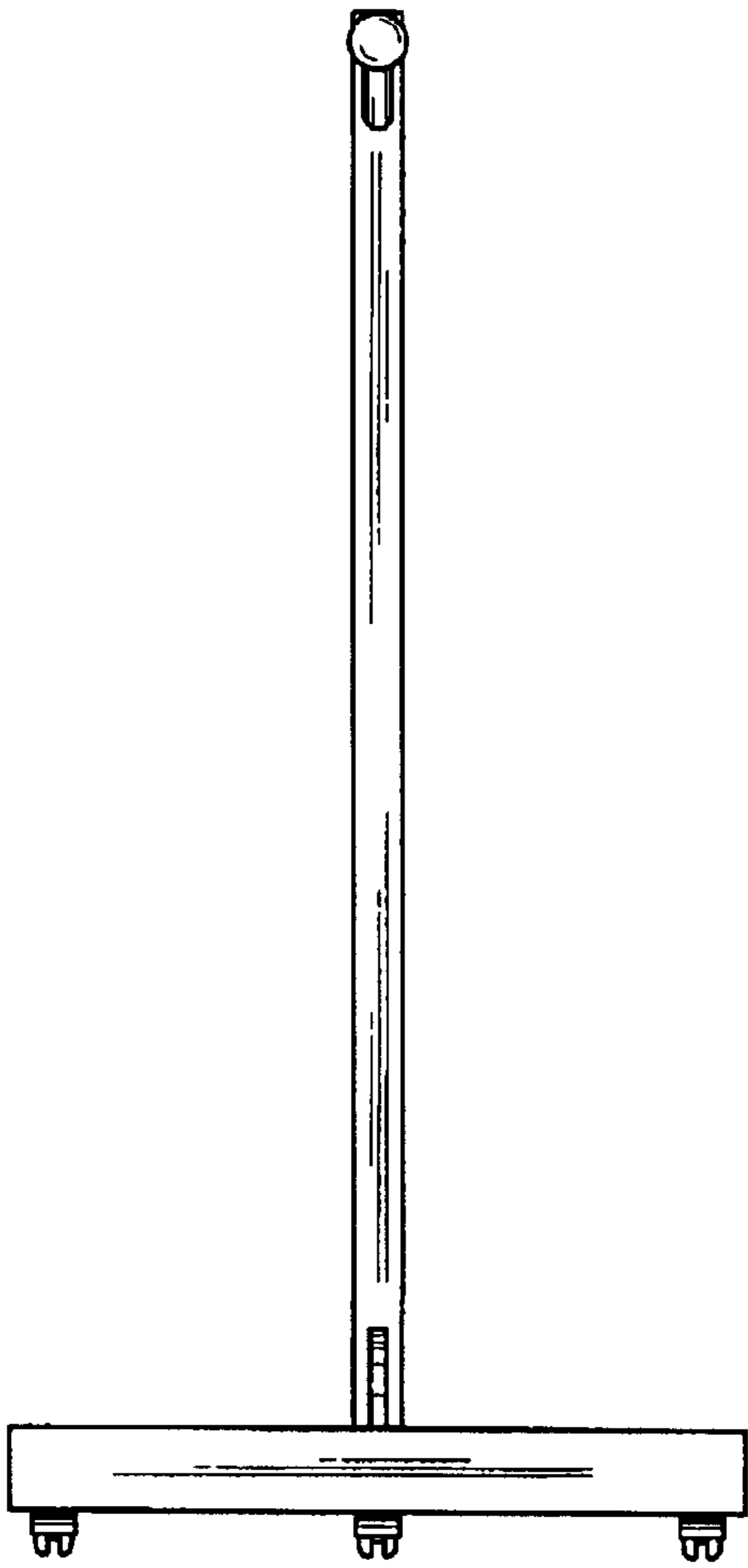

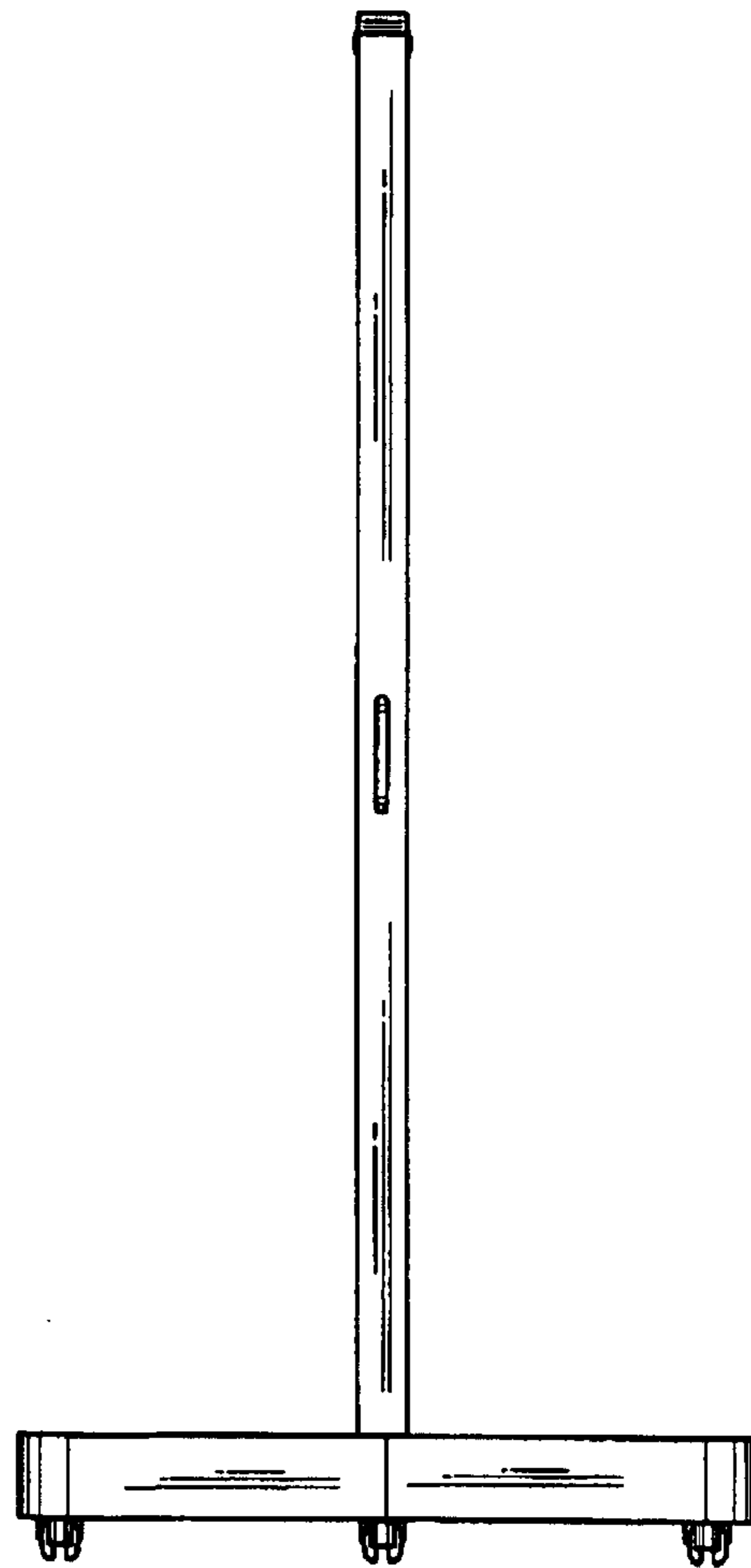

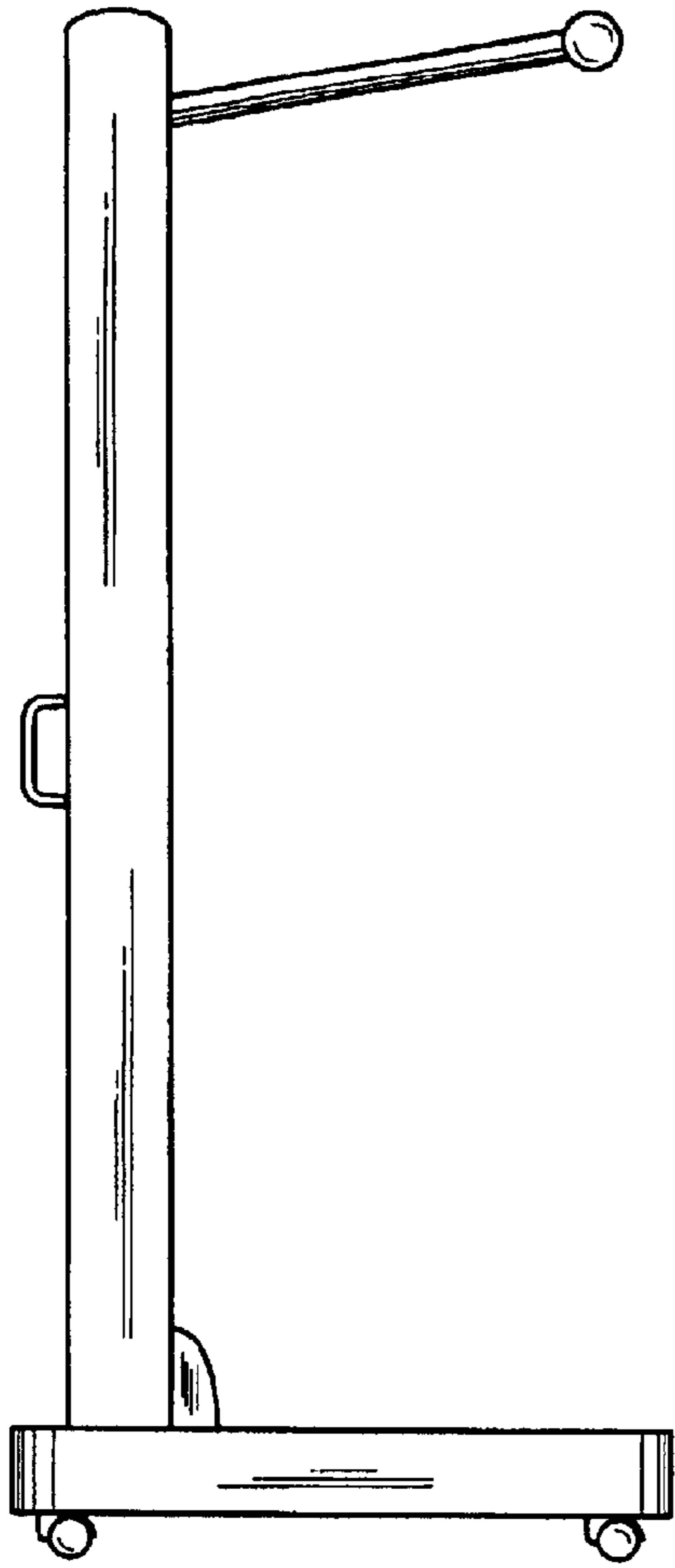

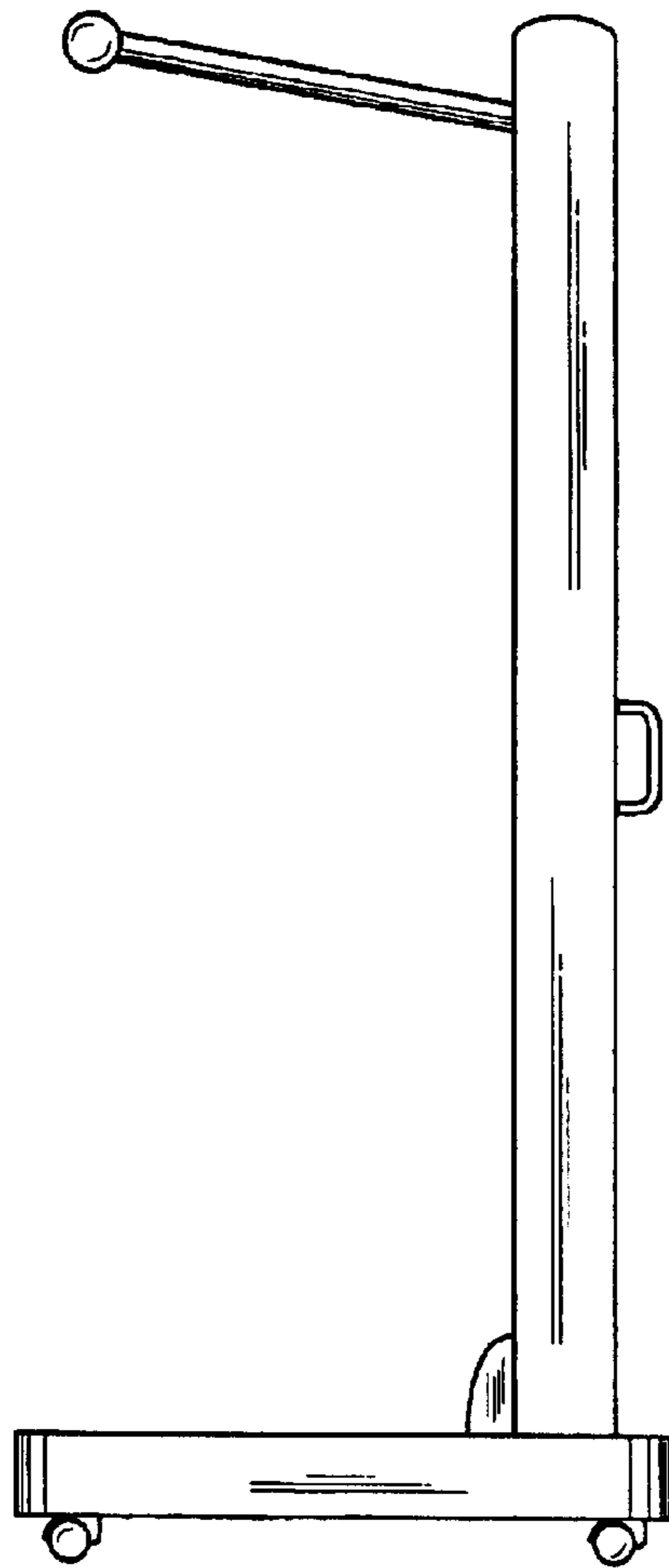

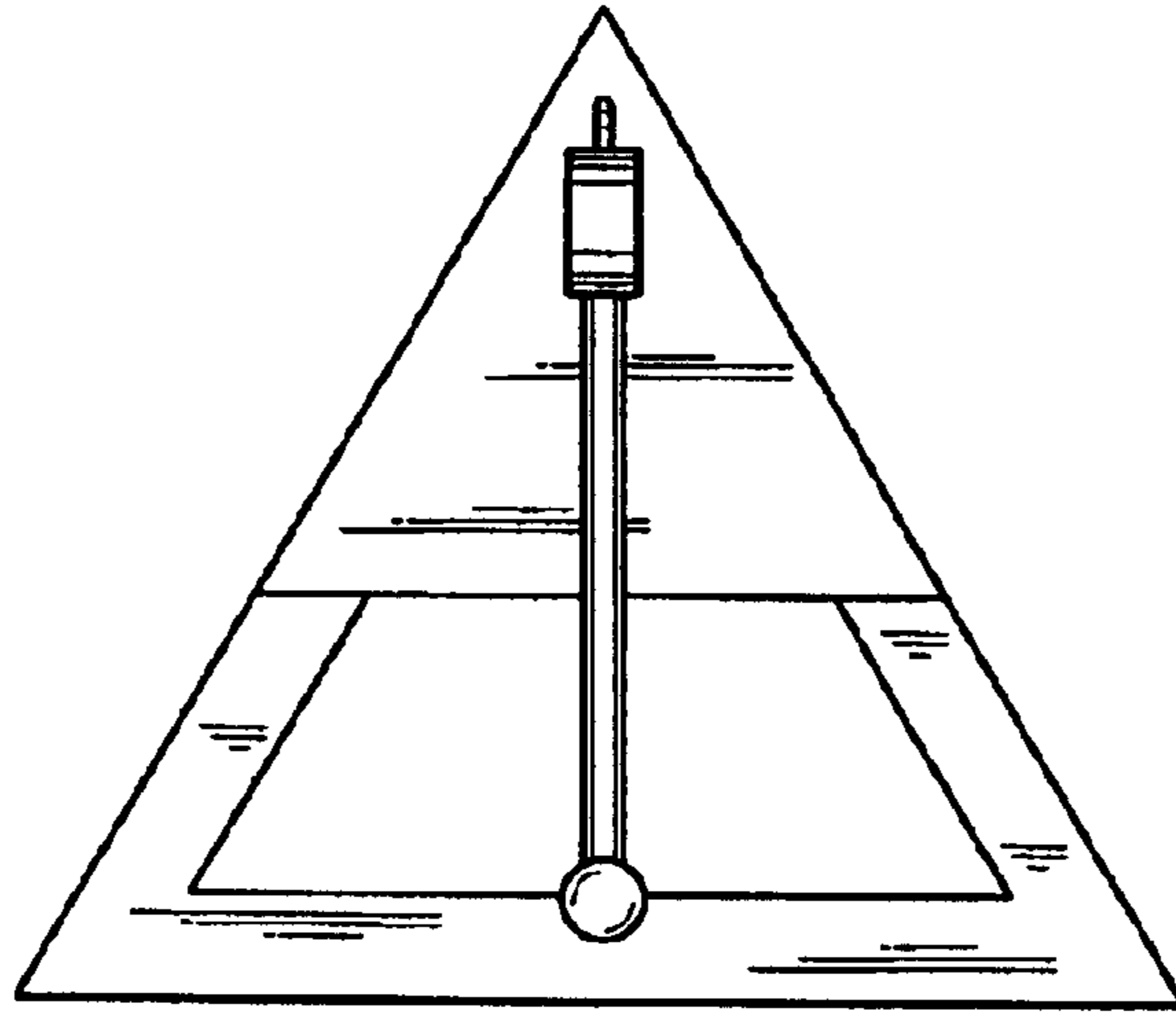

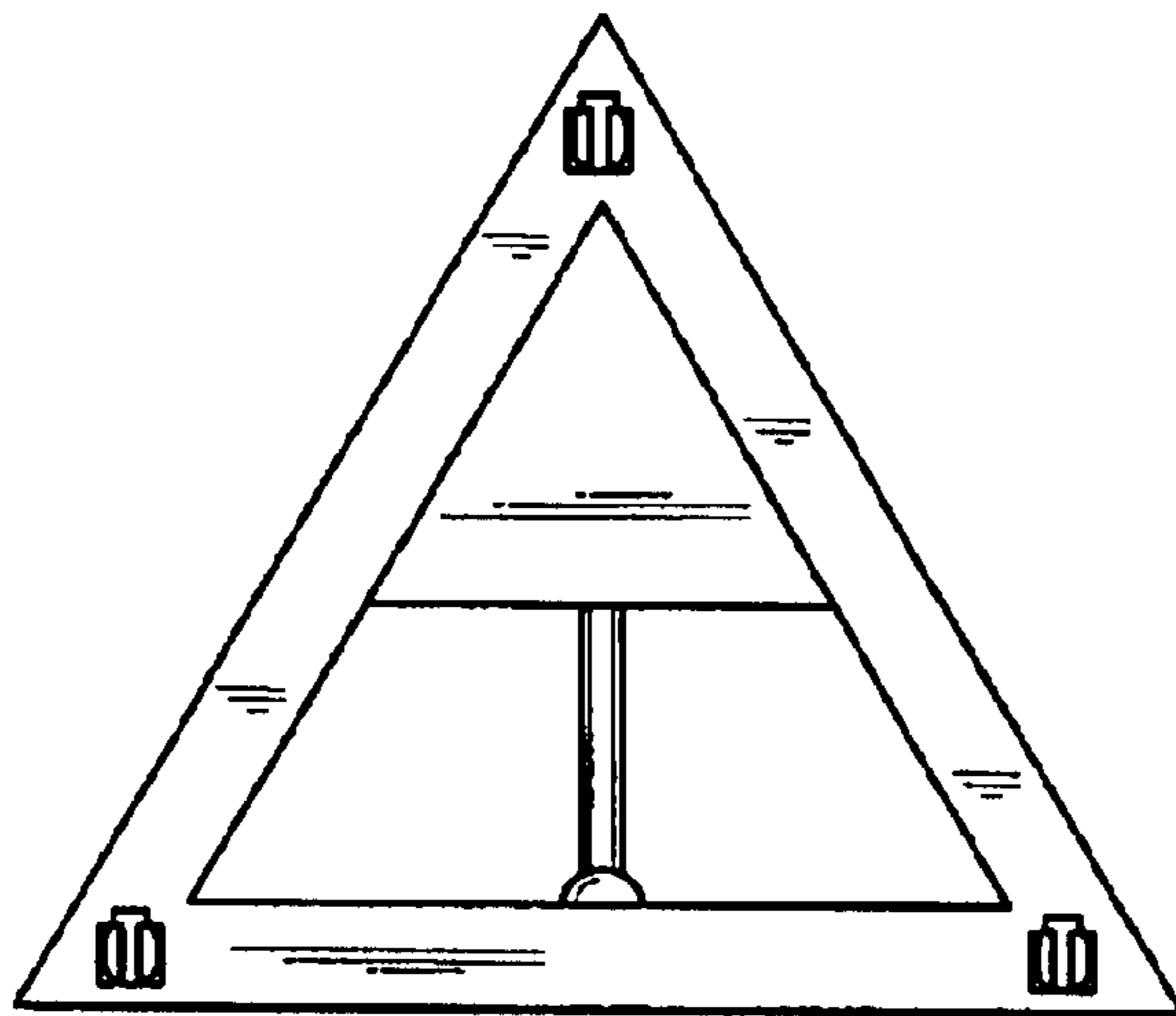

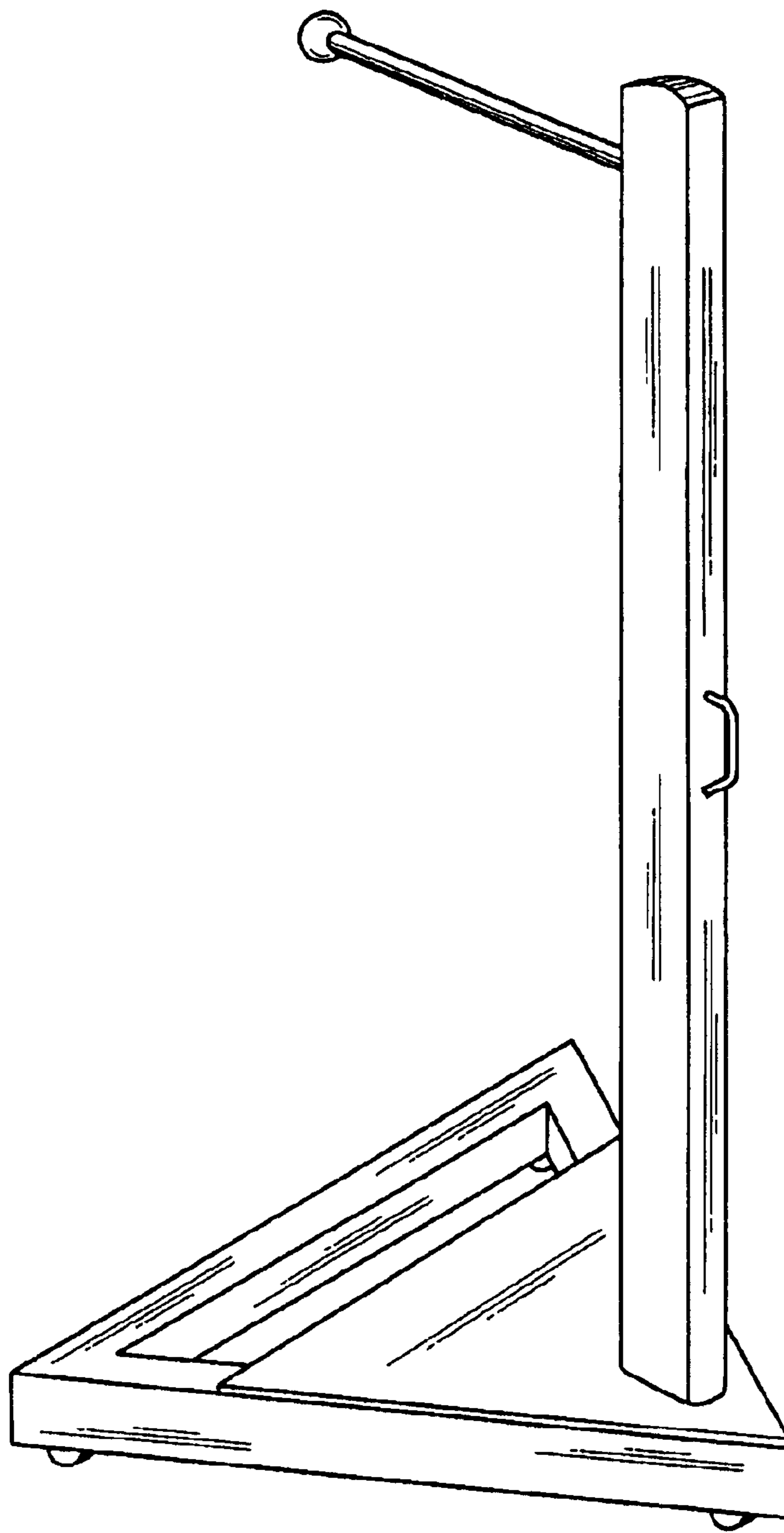
