The ornamental design of a table top, as shown.

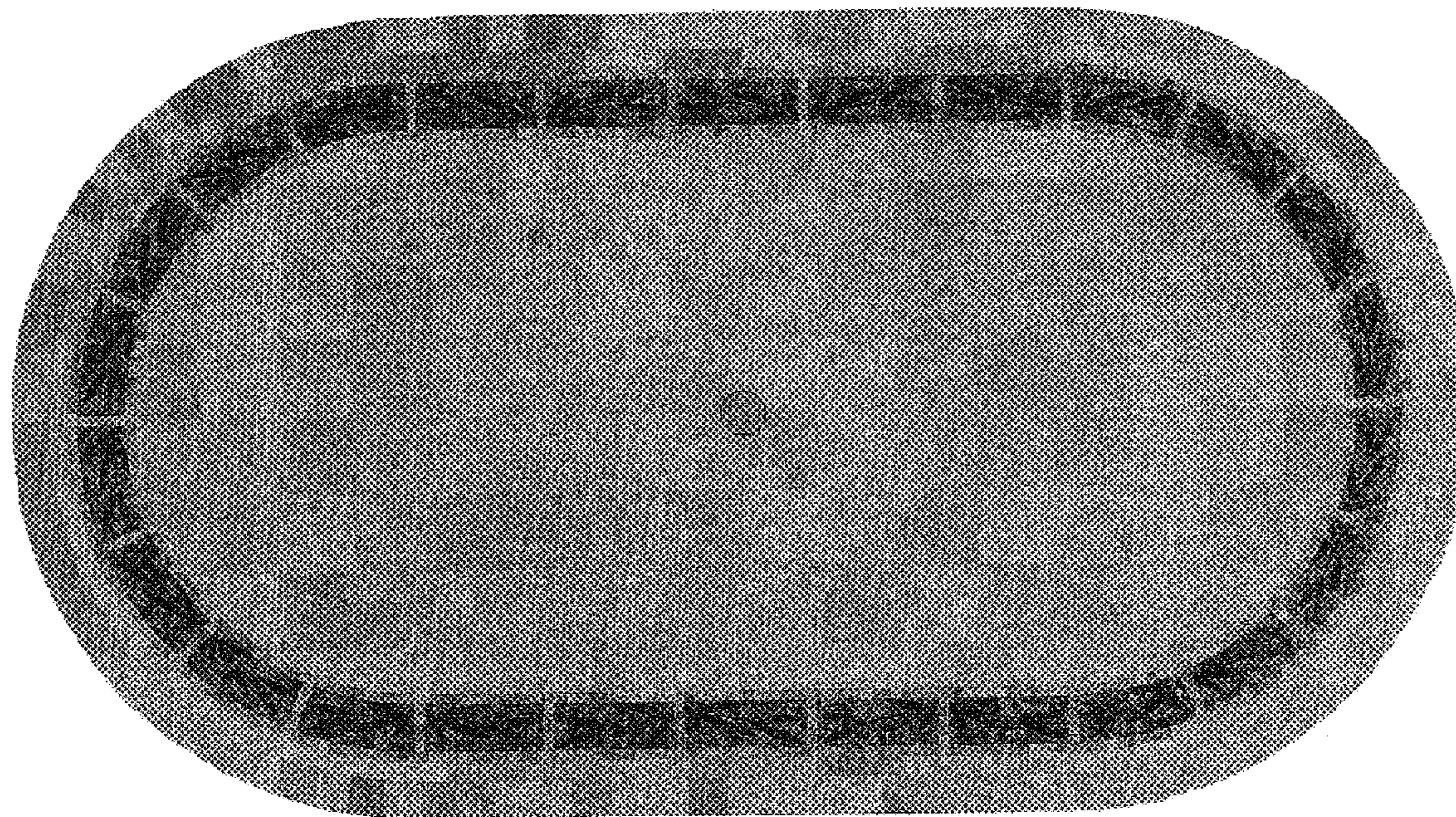
**DESCRIPTION**

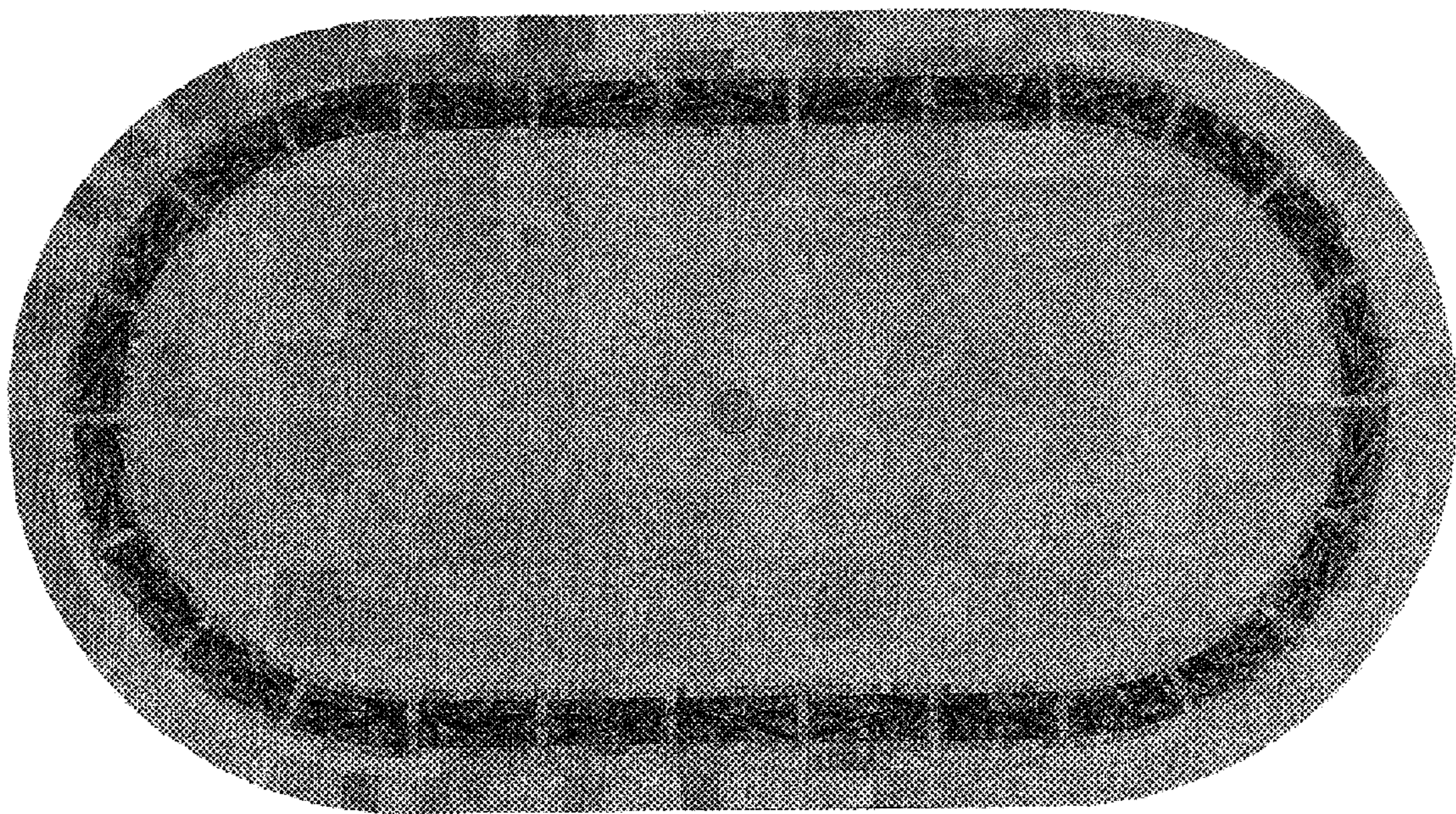

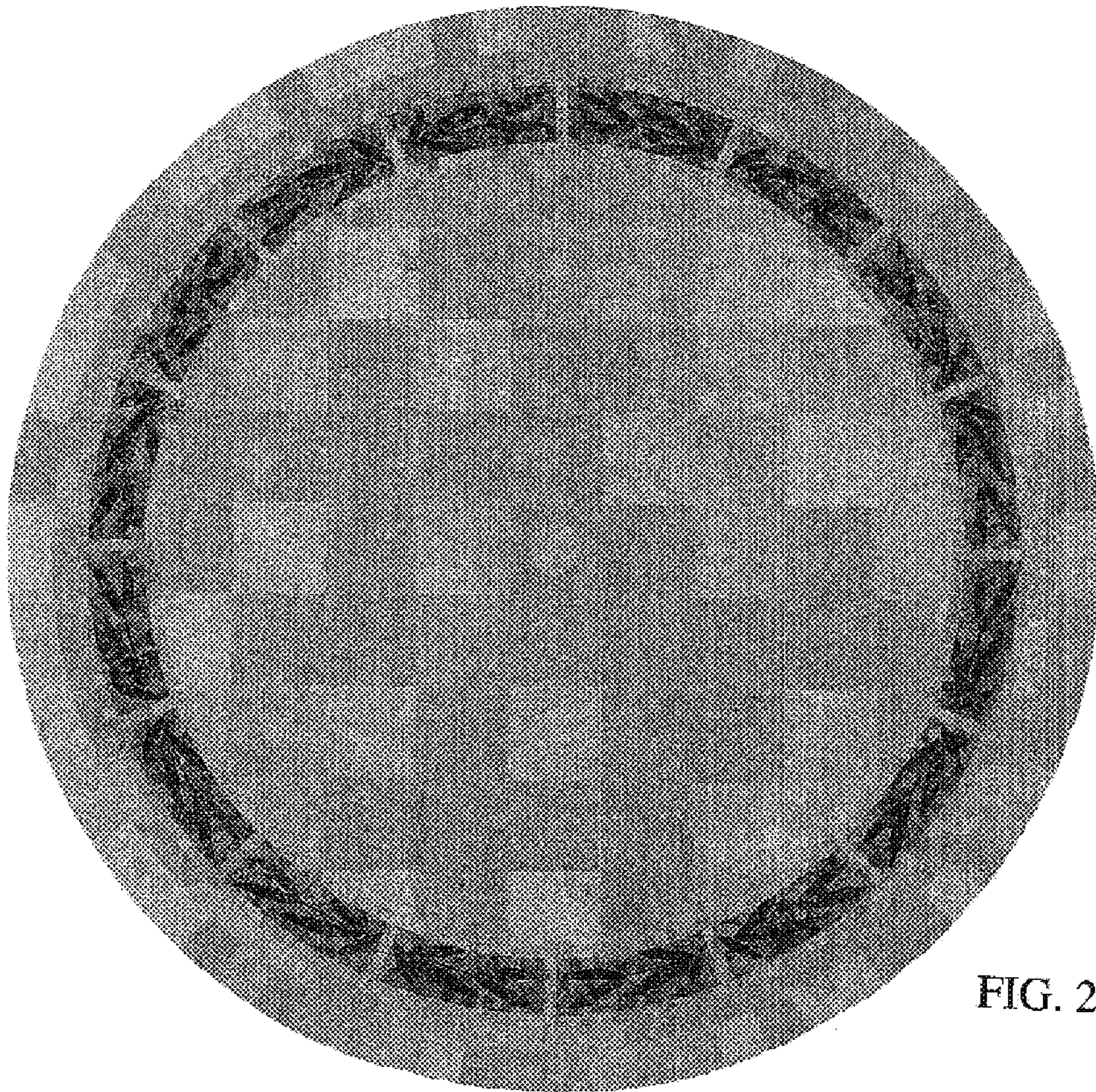
