(57) **CLAIM**

The ornamental design for a multi-step oval rosette mounting bracket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multi-step oval rosette mounting bracket showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a side view thereof; FIG. 4 is a bottom view thereof; and, FIG. 5 is a backside view thereof.
