(57) **CLAIM**

The ornamental design for a safety lock for seat belt buckle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevated view of a safety lock for seat belt buckle showing my new design;

FIG. 2 is a rear elevated view of the safety lock for seat belt buckle;

FIG. 3 is a right side elevated view of the safety lock for seat belt buckle;

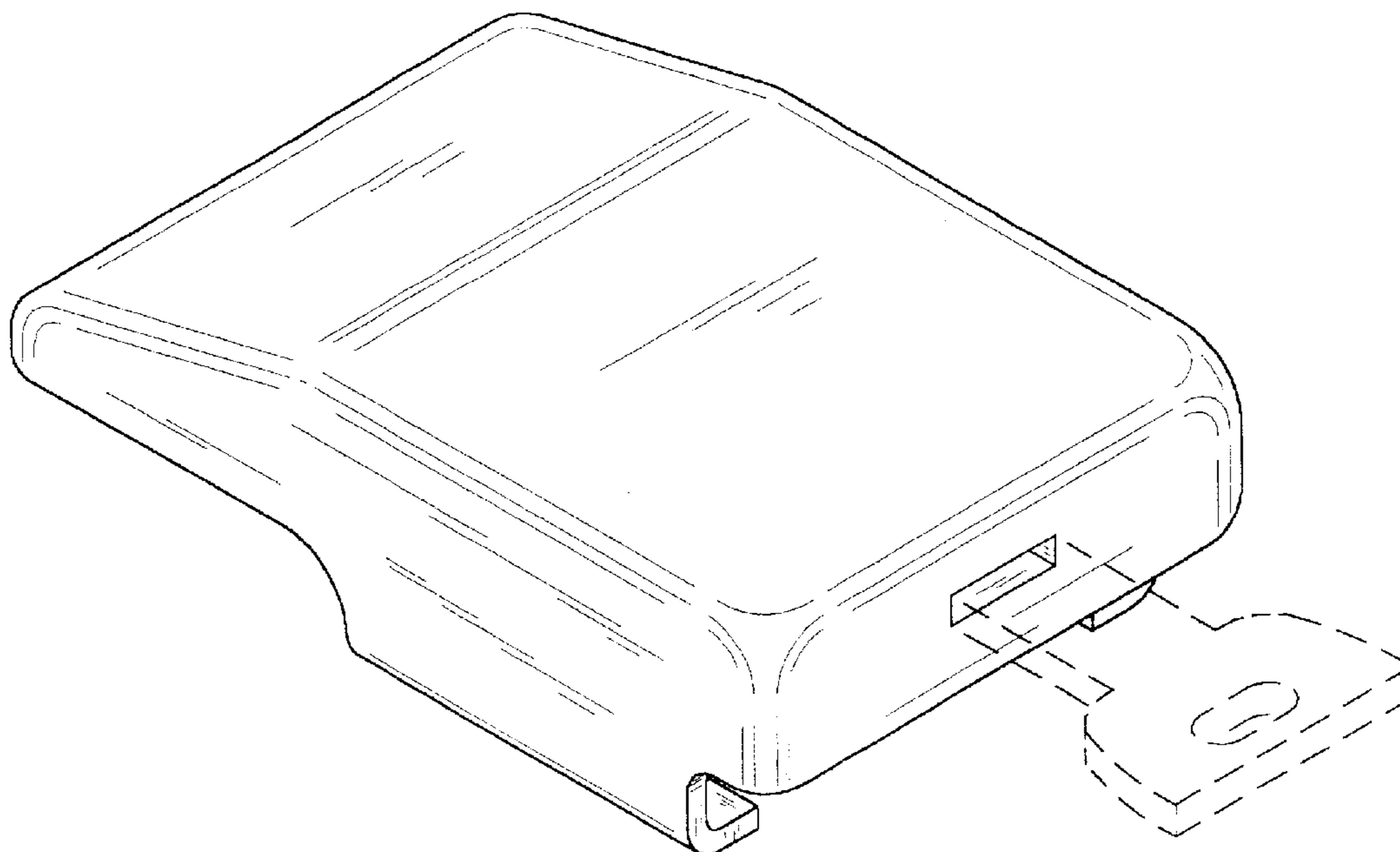
FIG. 4 is a left side elevated view of the safety lock for seat belt buckle;

FIG. 5 is a top view of the safety lock for seat belt buckle; and,

FIG. 6 is a perspective view of the safety lock for seat belt buckle.

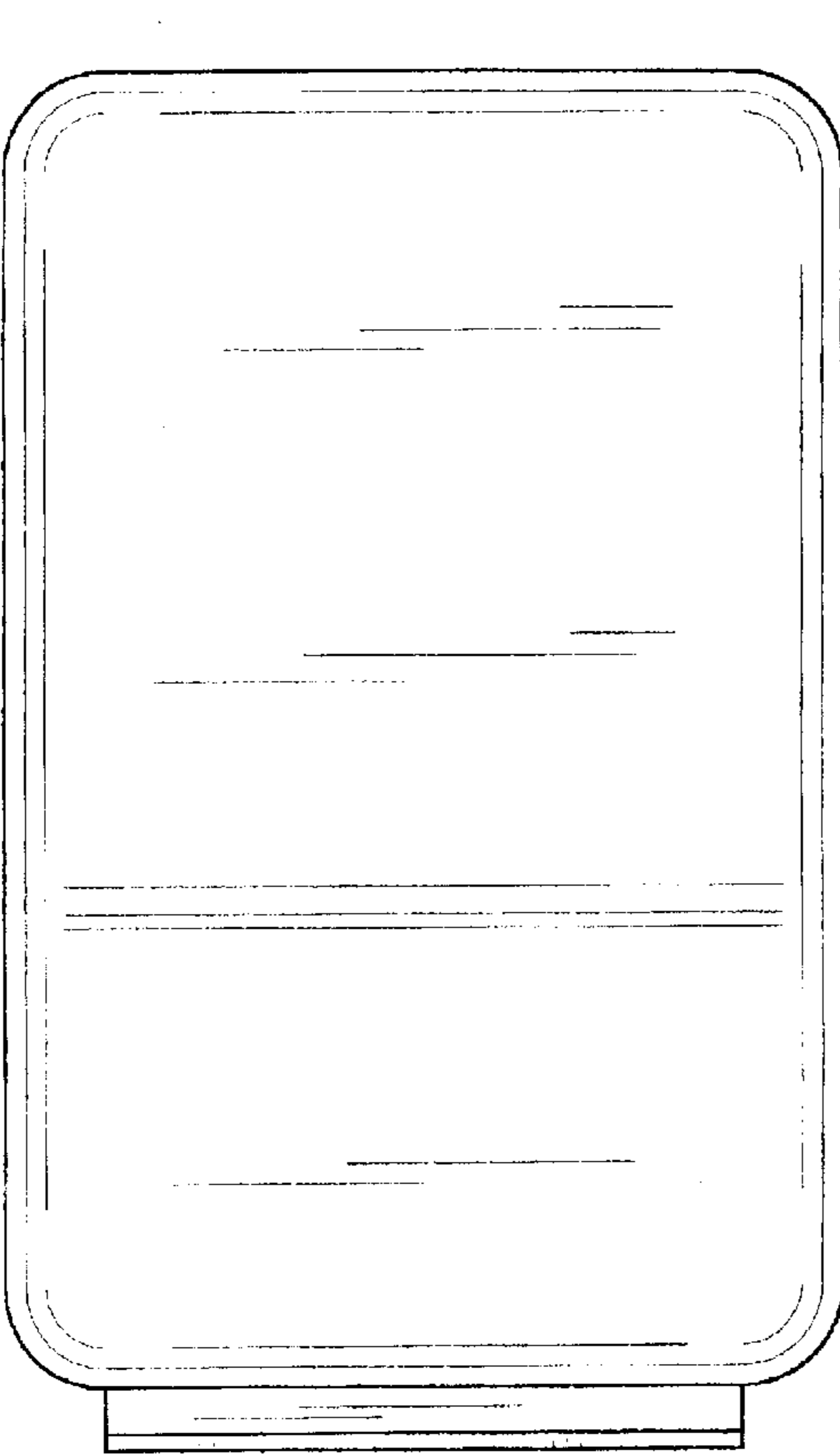

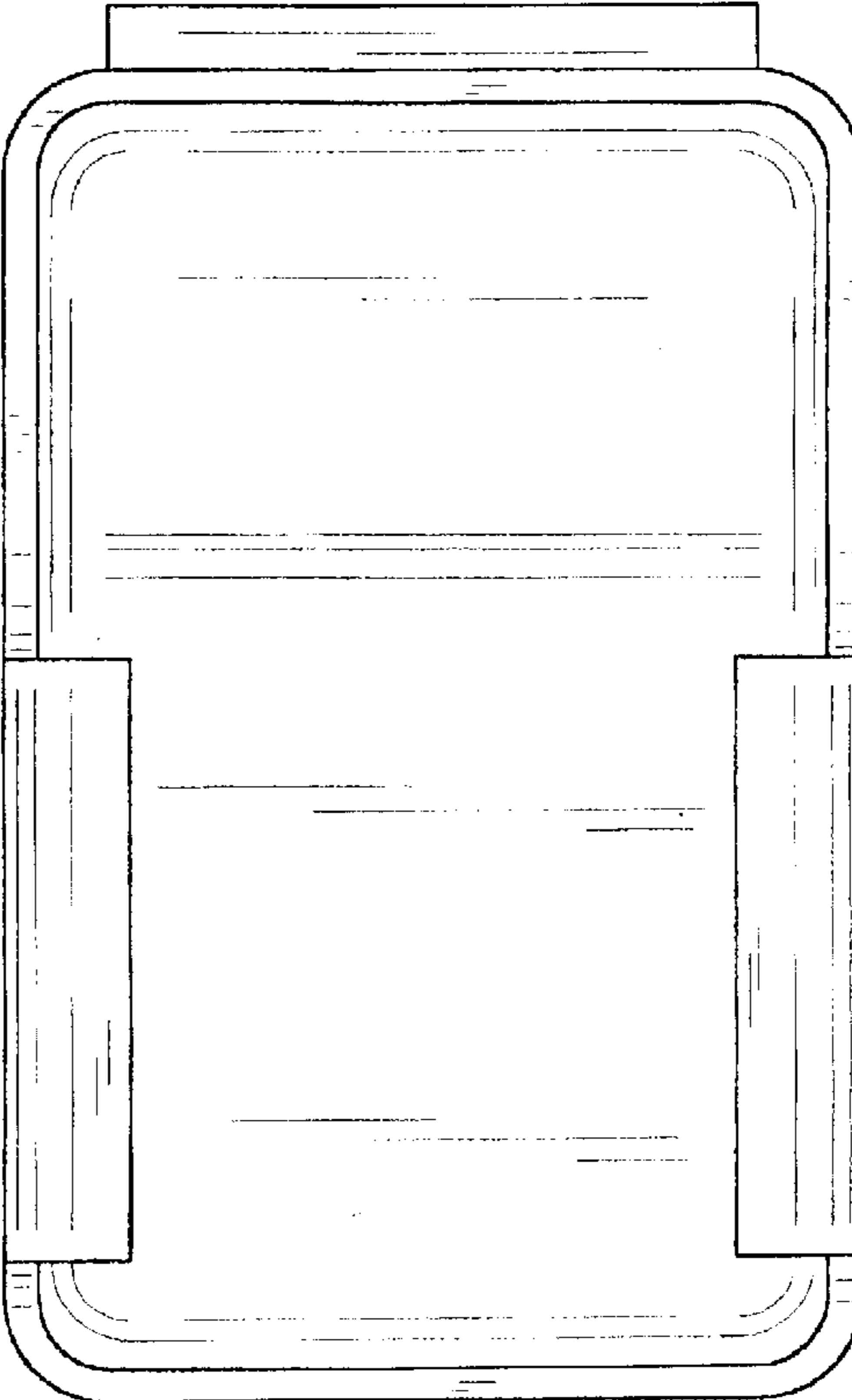

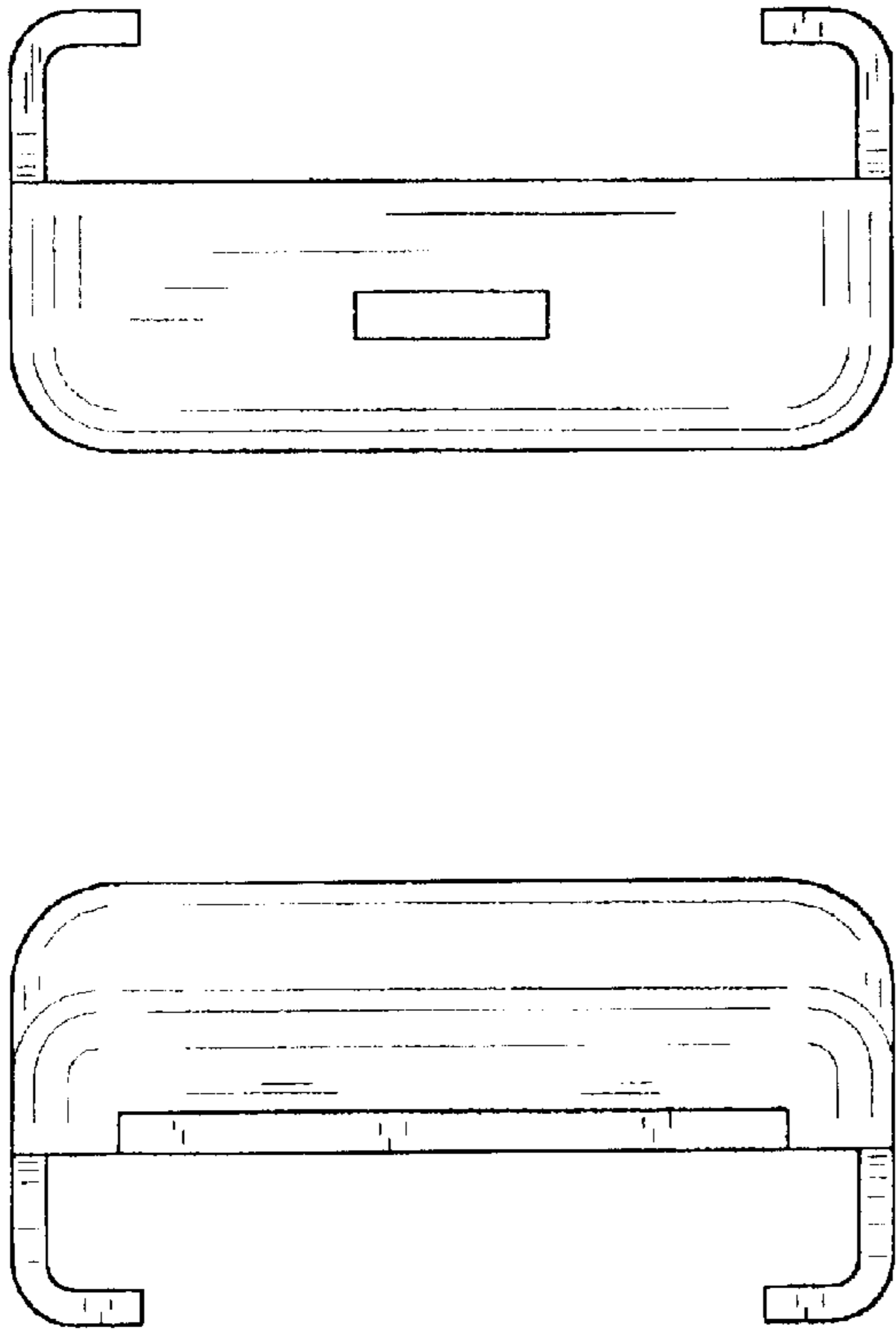

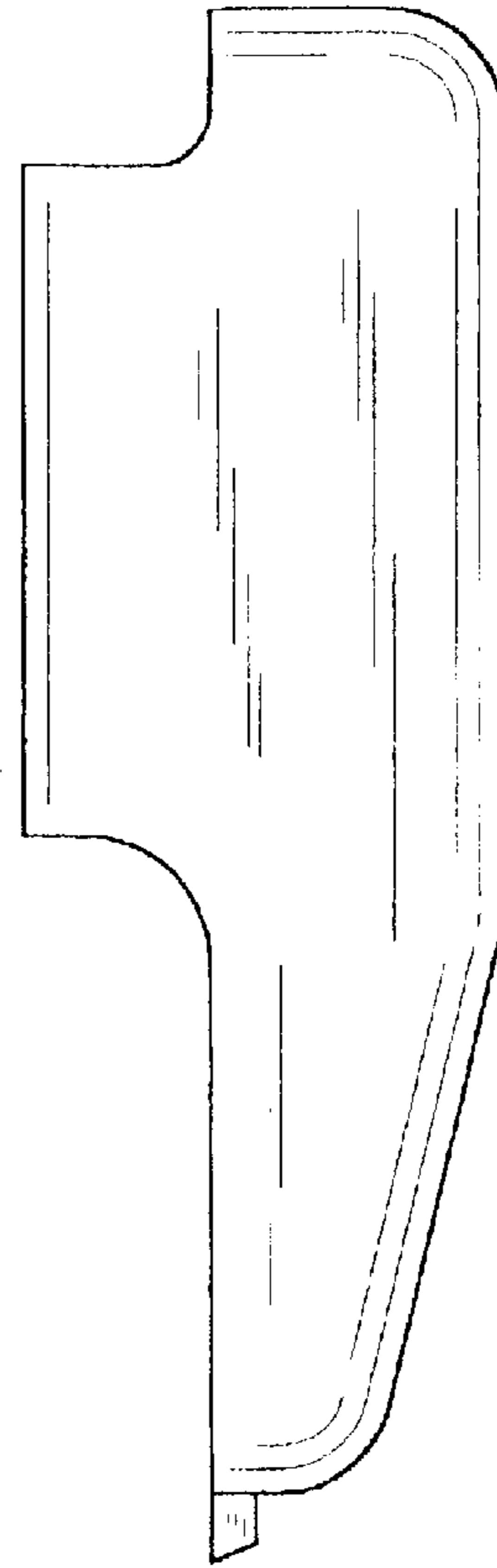

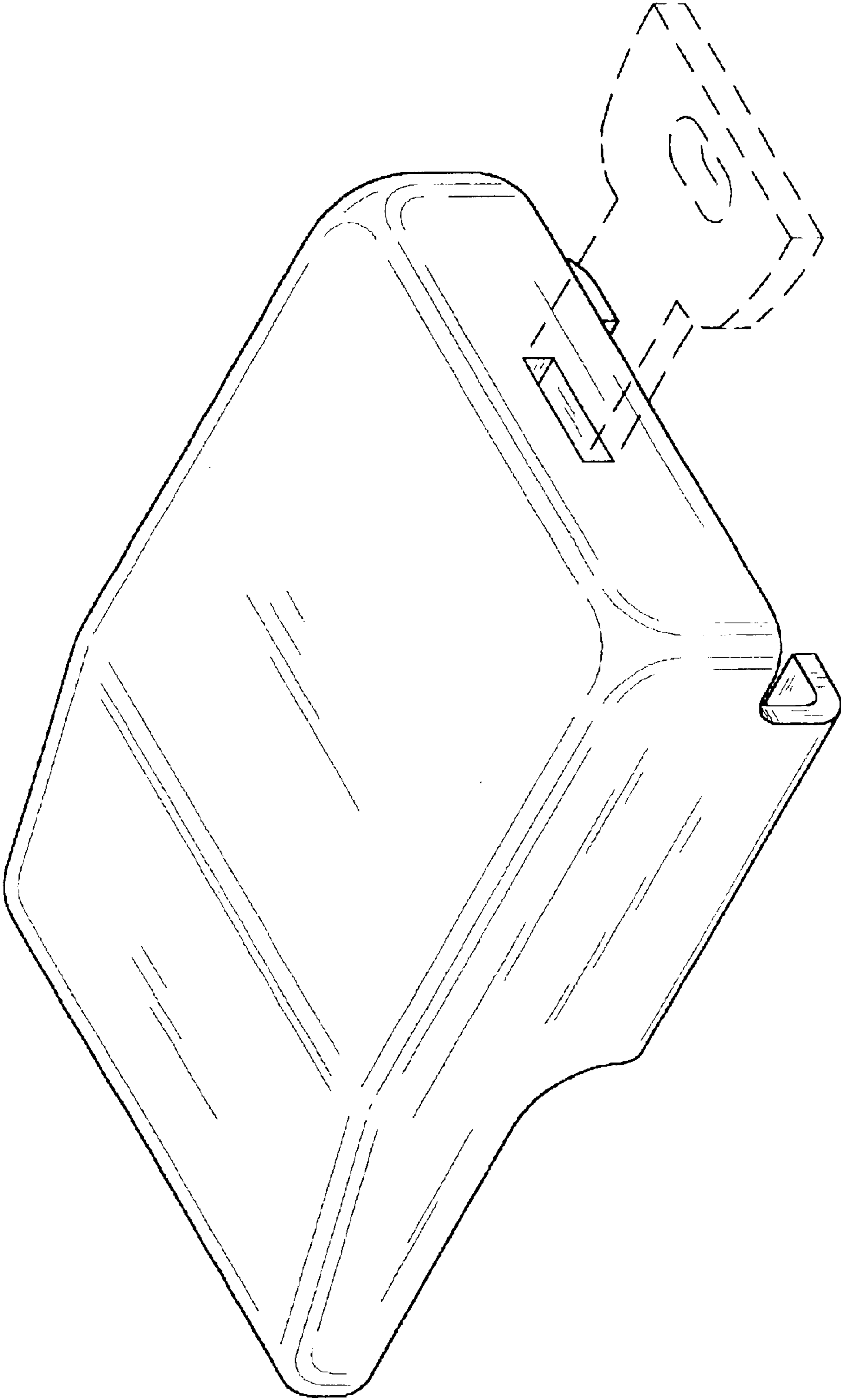
