The ornamental design for a hook attachment device, as shown and described.

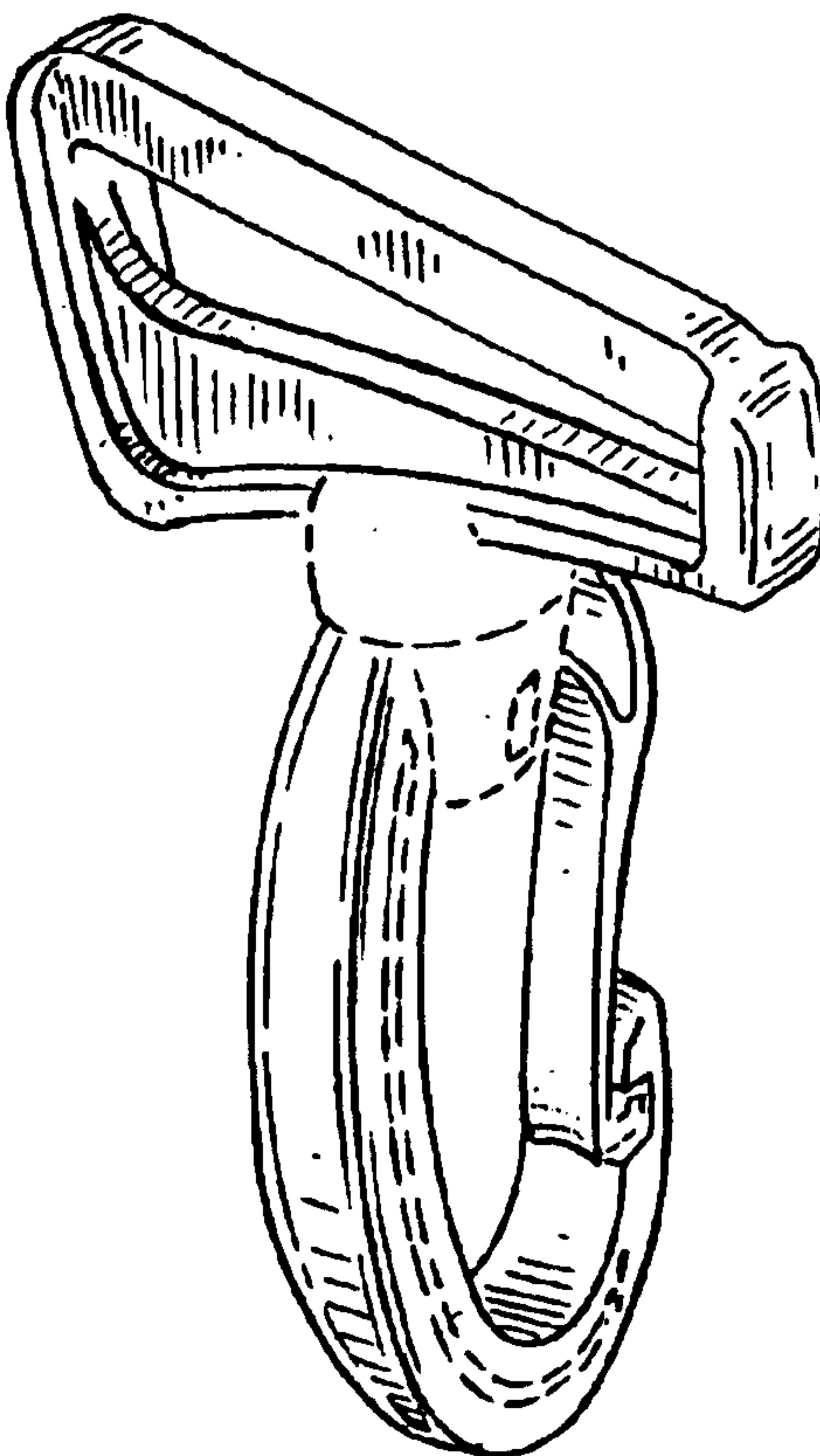
DESCRIPTION

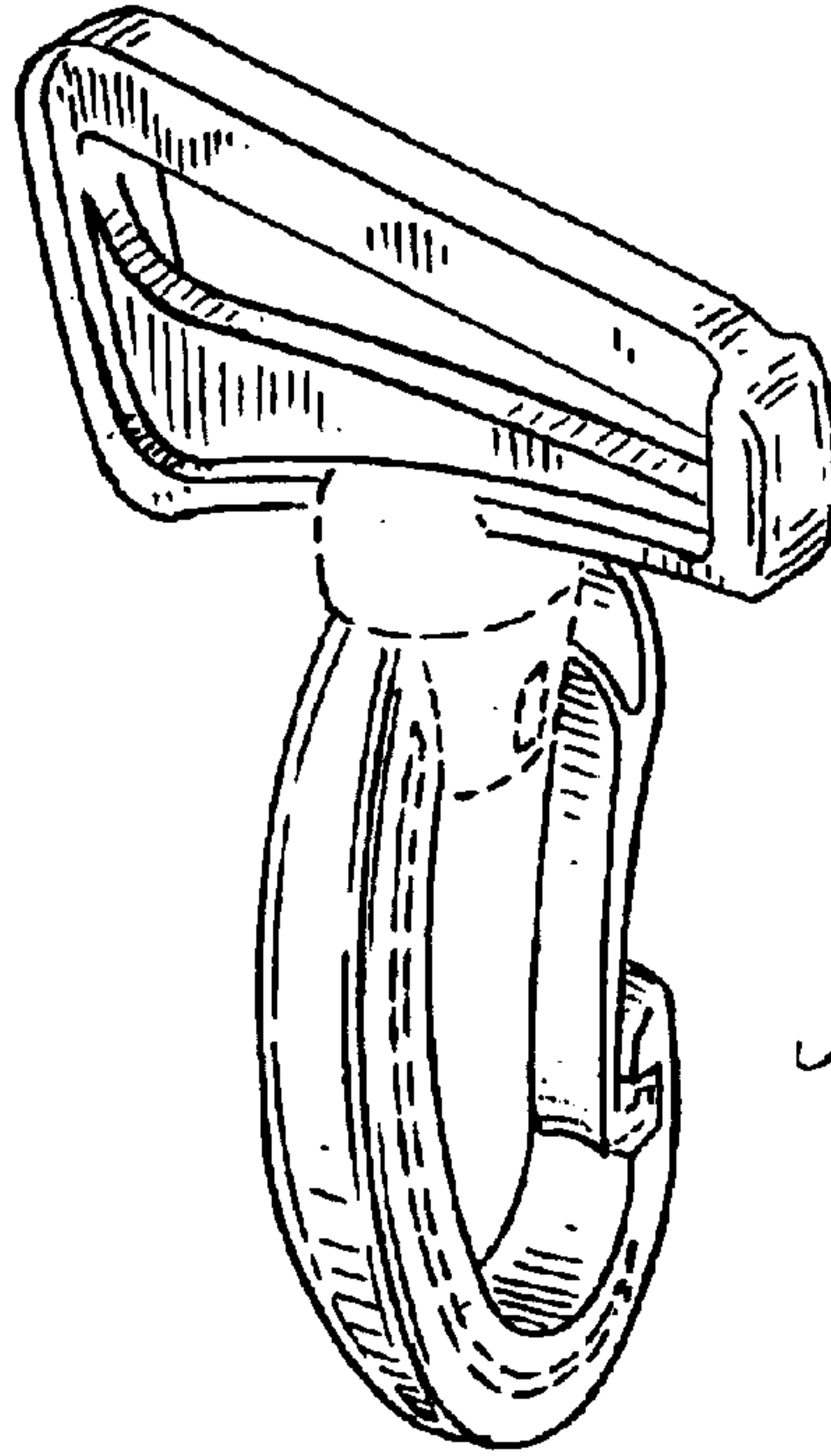

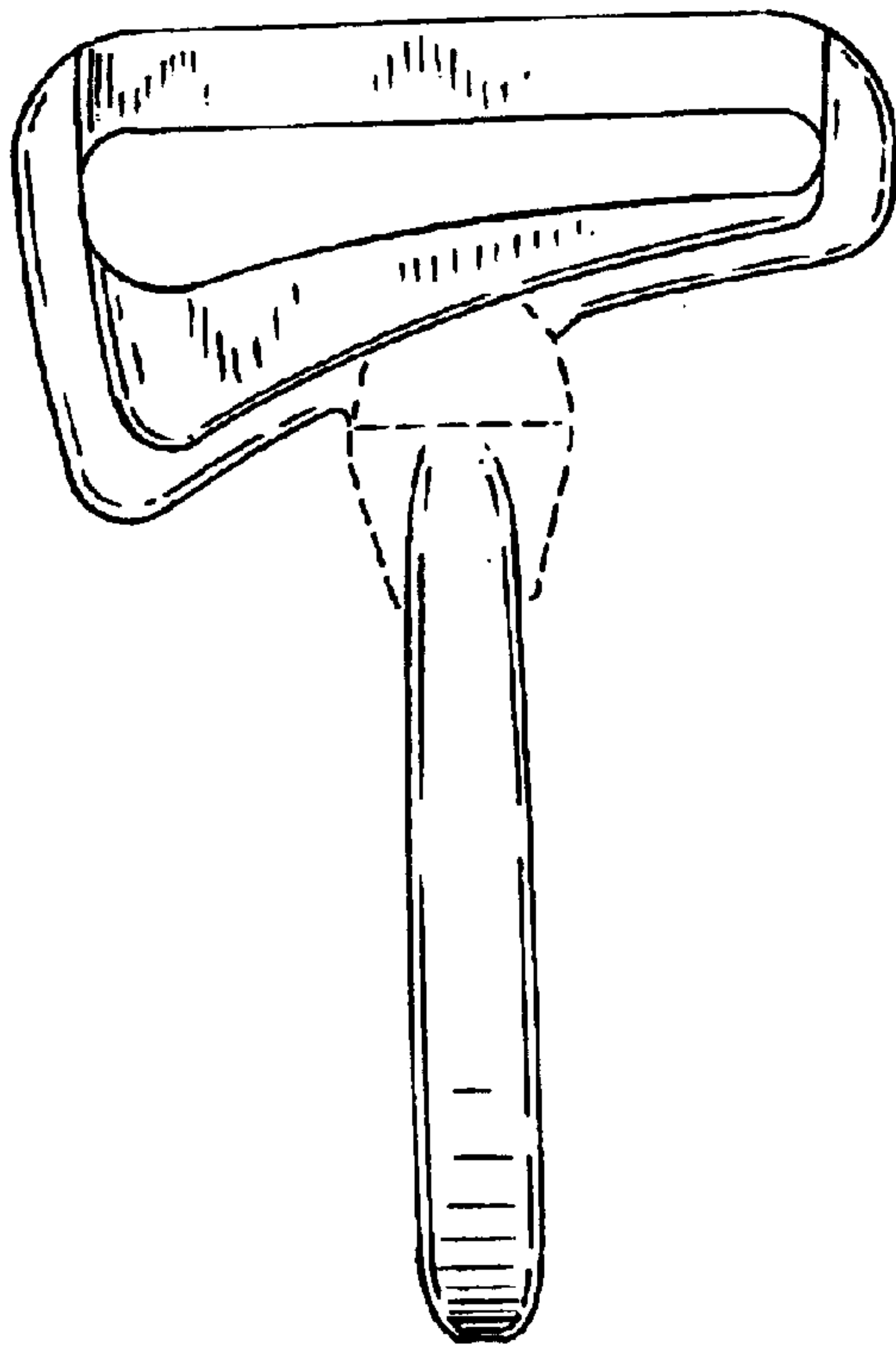

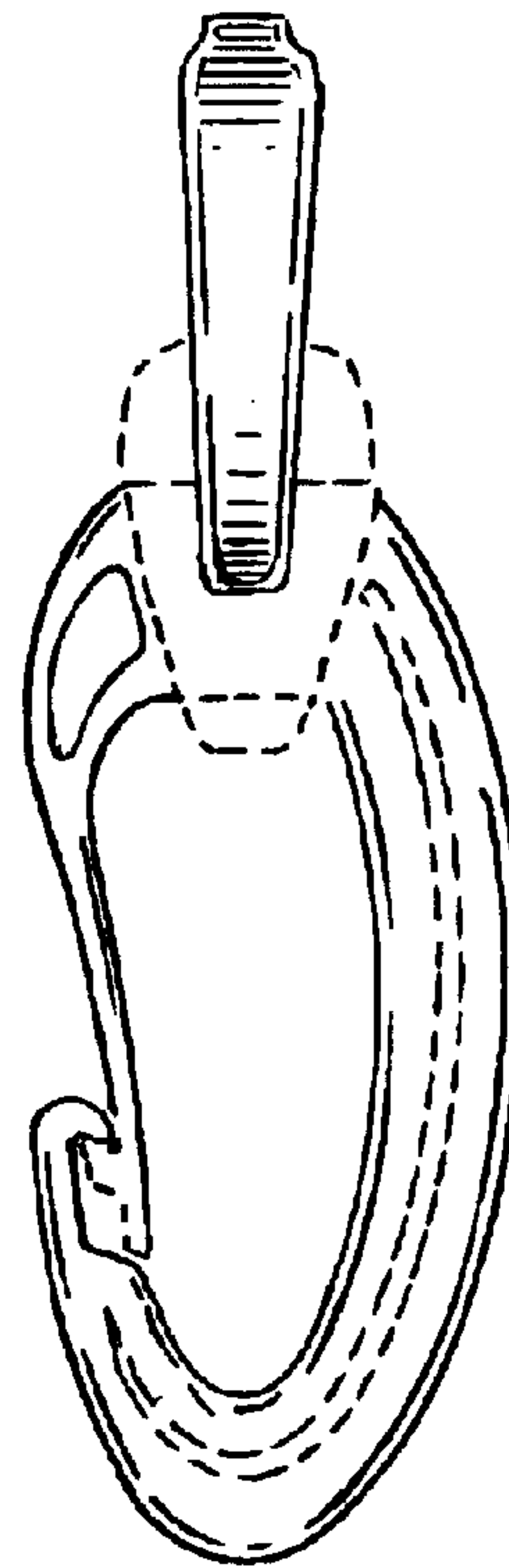

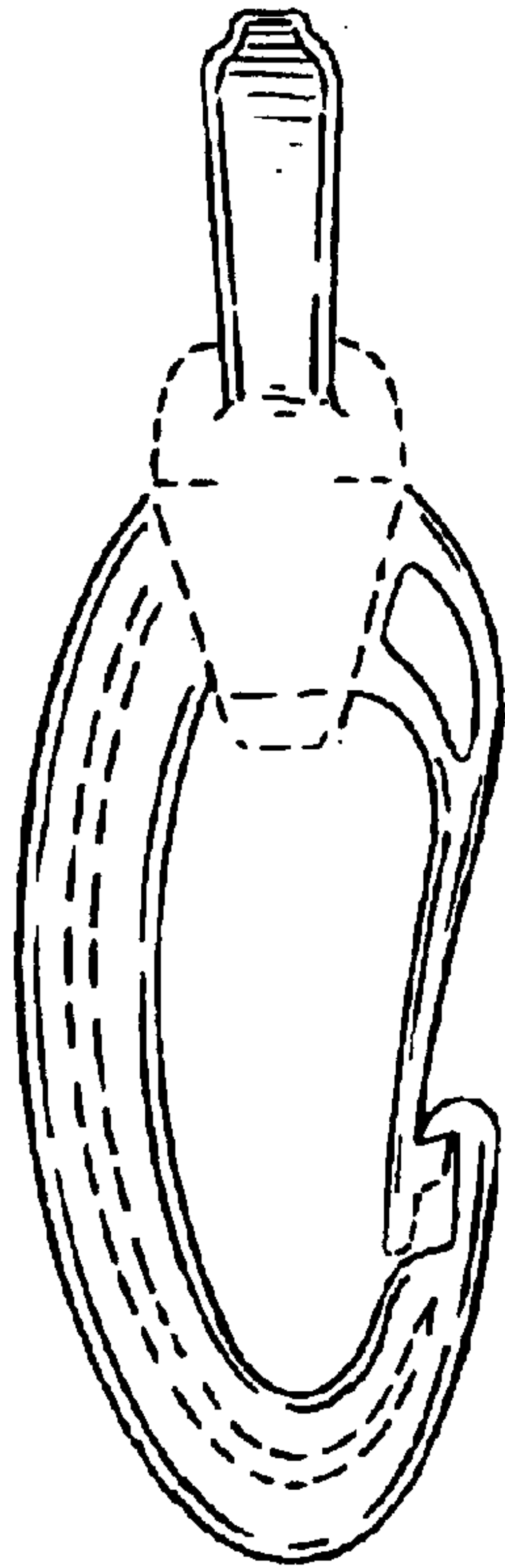

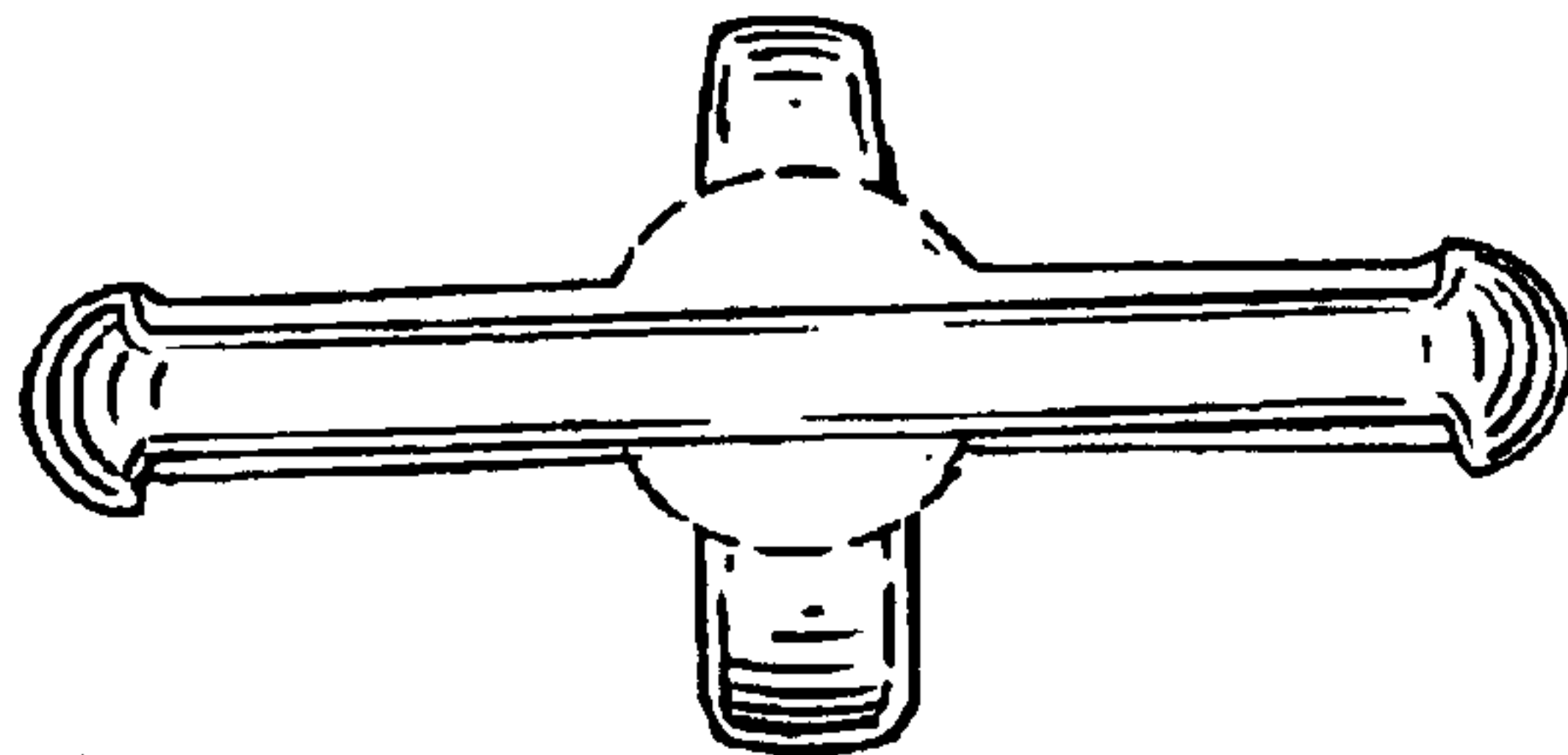

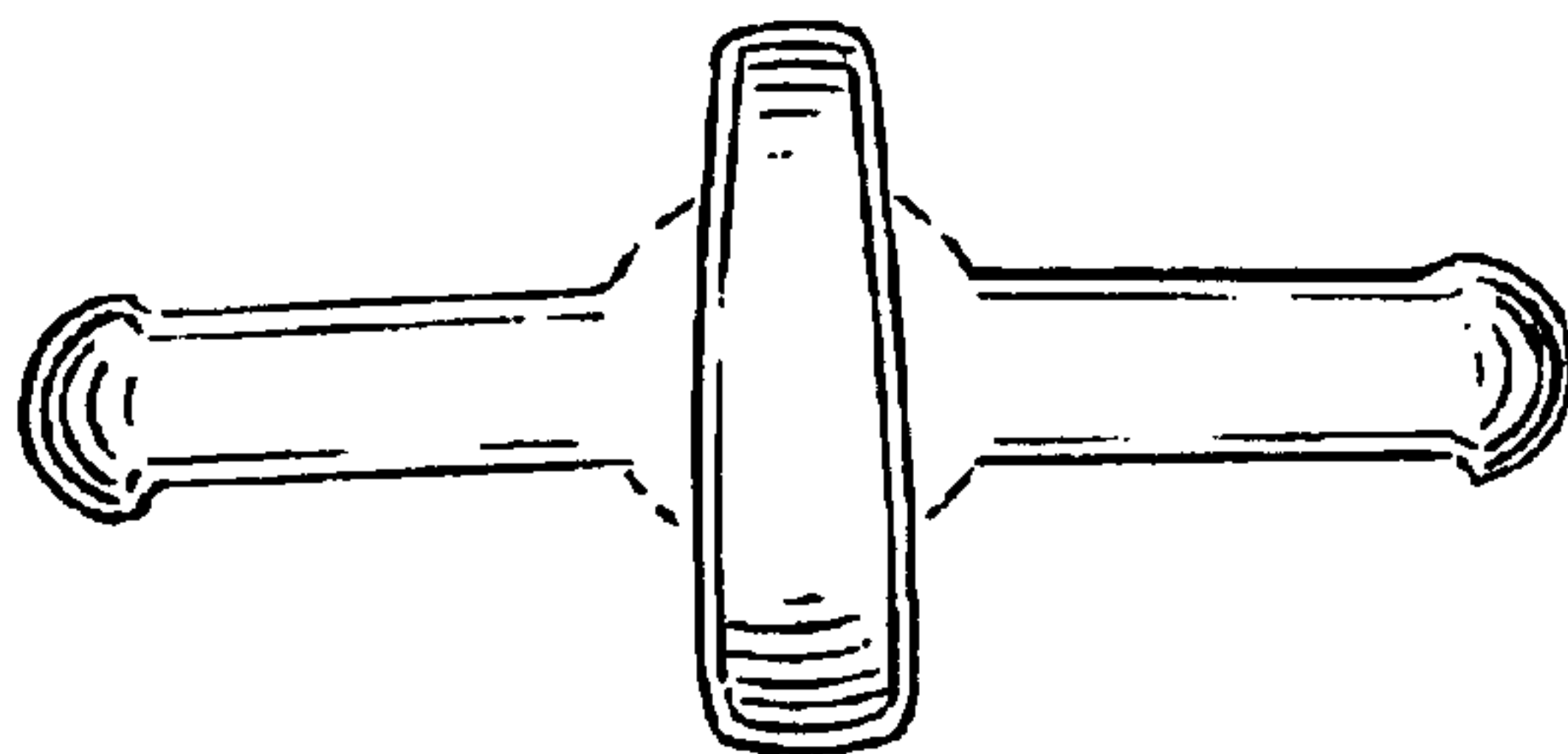
