FIG. 14 is a right side elevational view thereof.

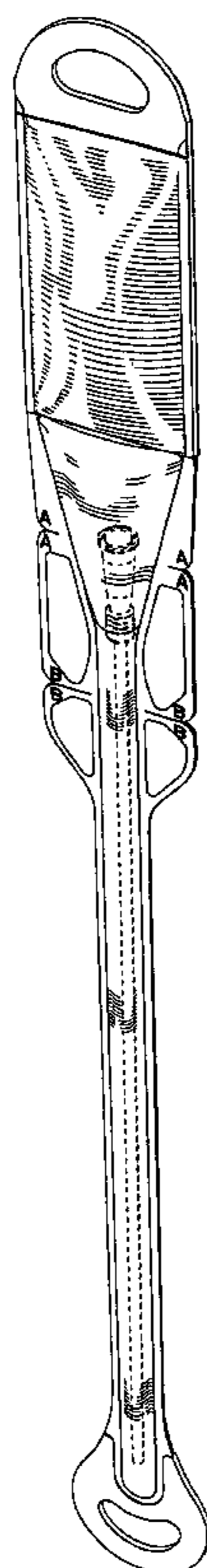

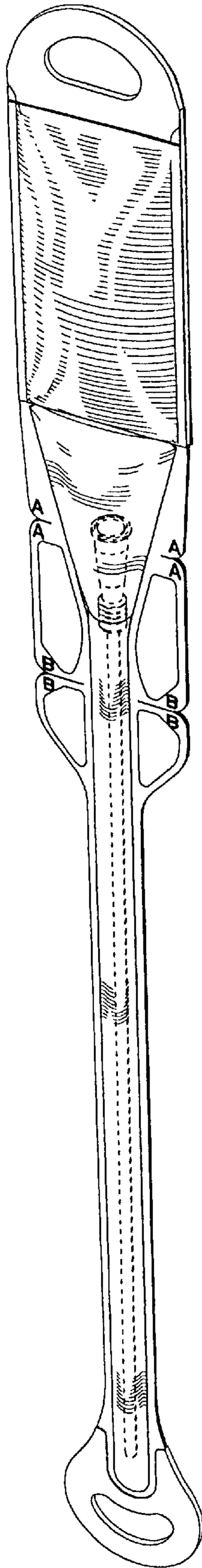

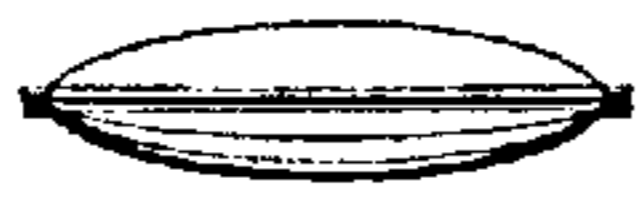

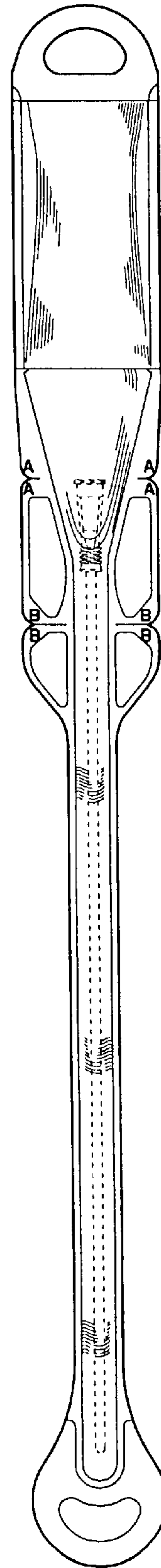

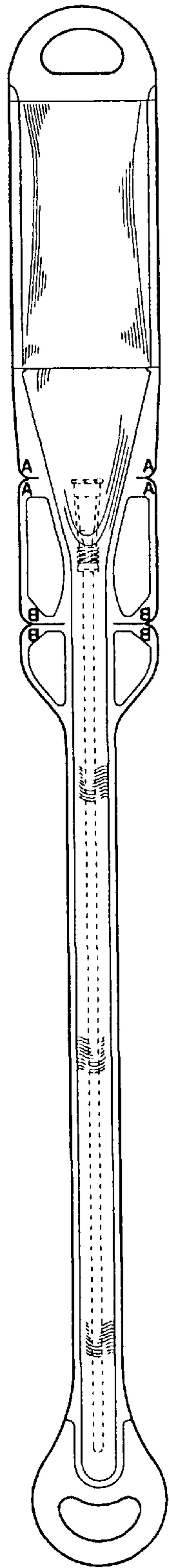

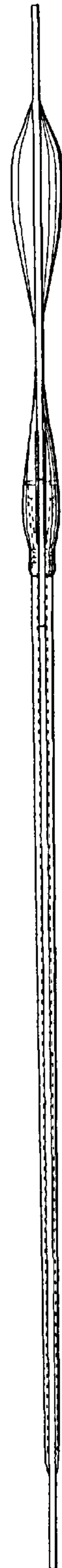

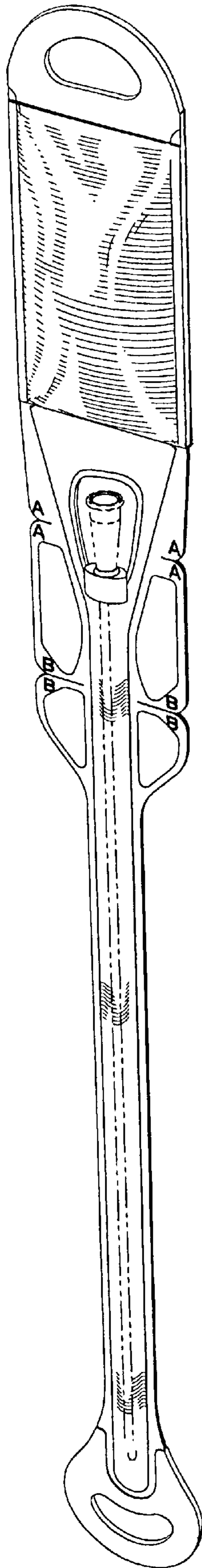

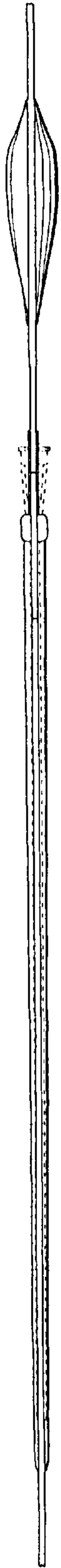

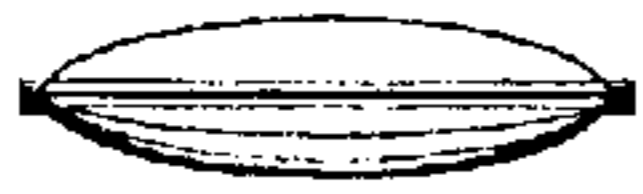

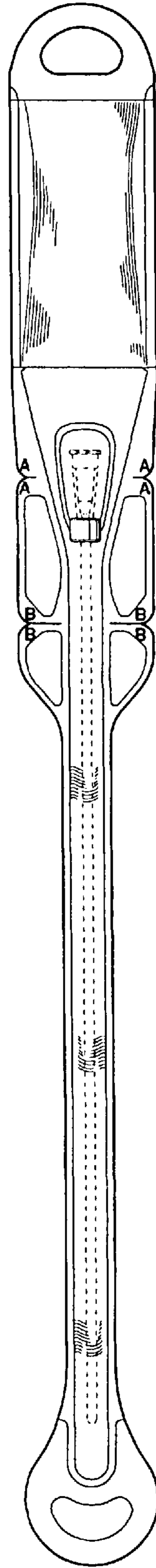

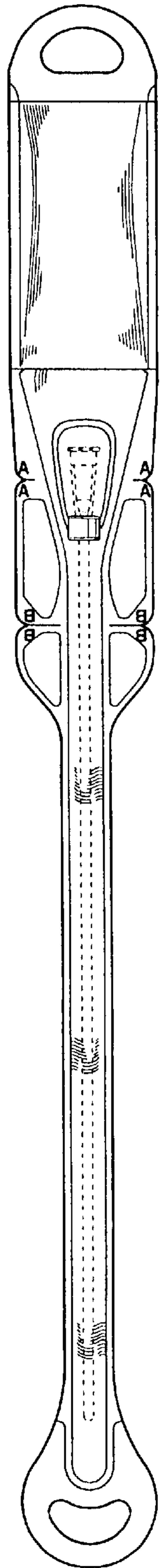

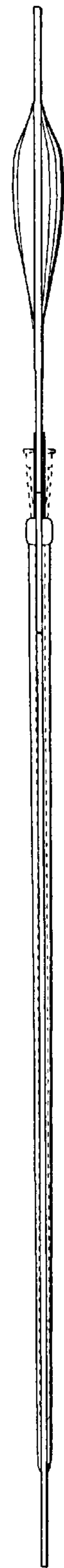
