(57) **CLAIM**

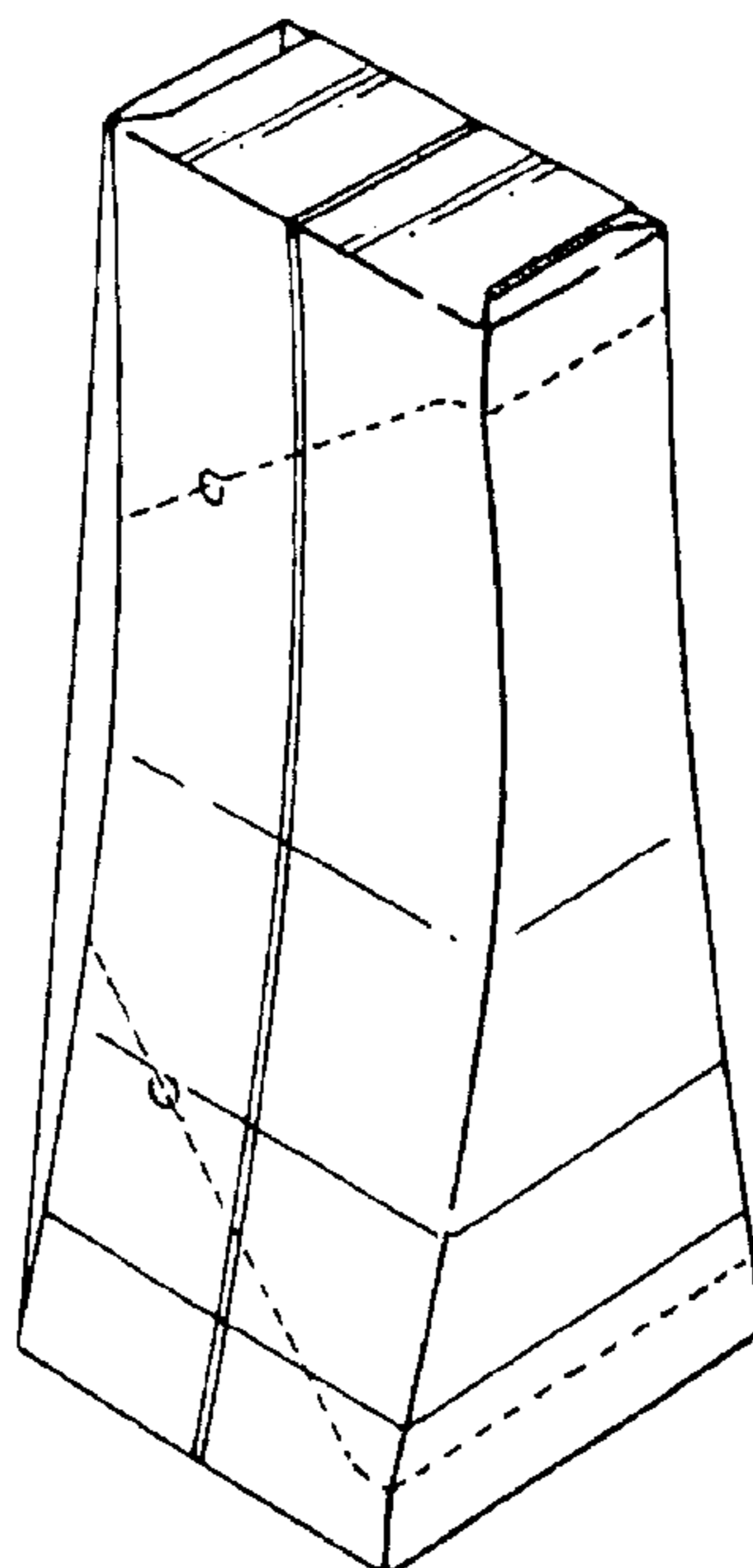
The ornamental design for a pantiliner package, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pantiliner package embodying my design;
FIG. 2 is a front view thereof, the back view being a mirror image in appearance;
FIG. 3 is right side view thereof, the left side view being a mirror image in appearance;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.

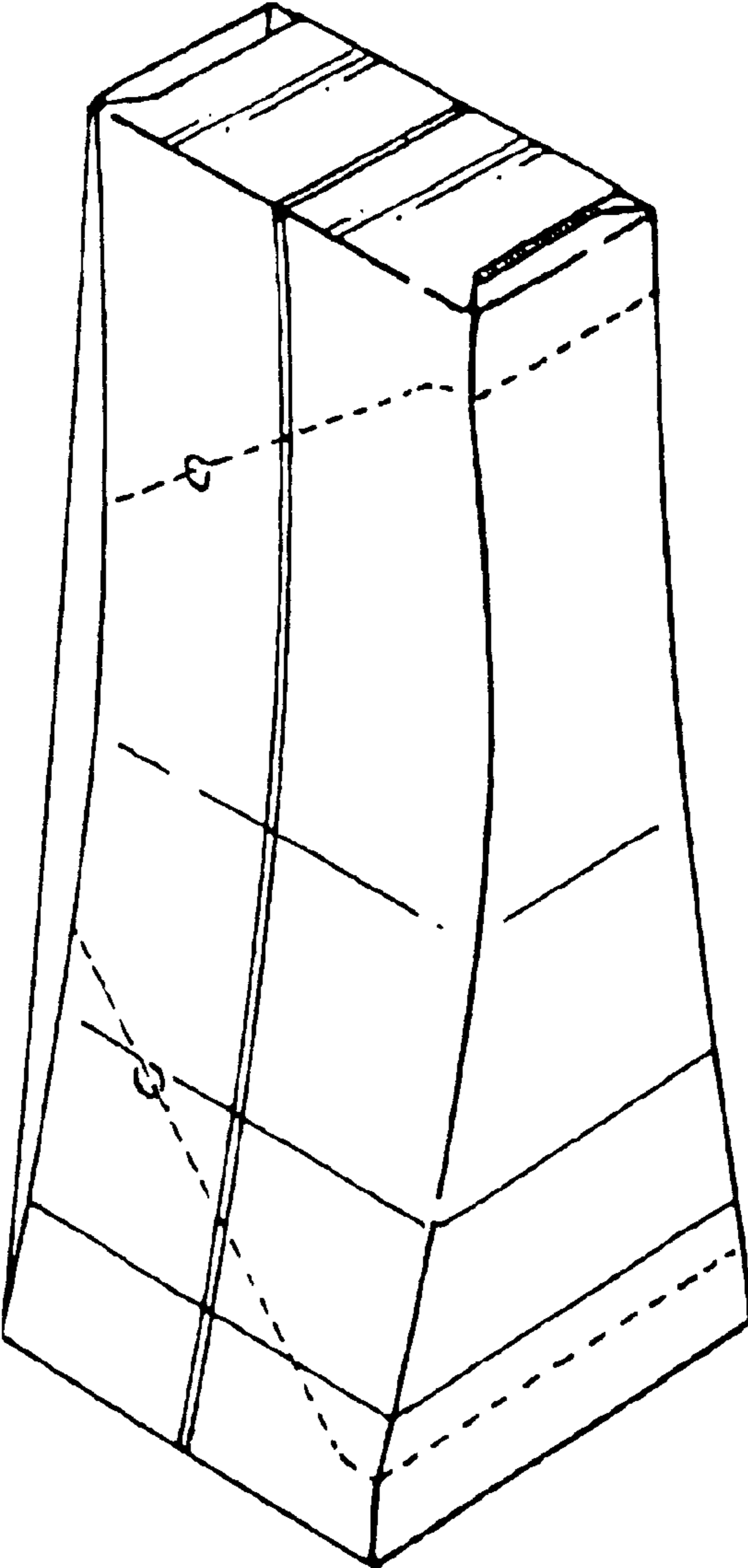

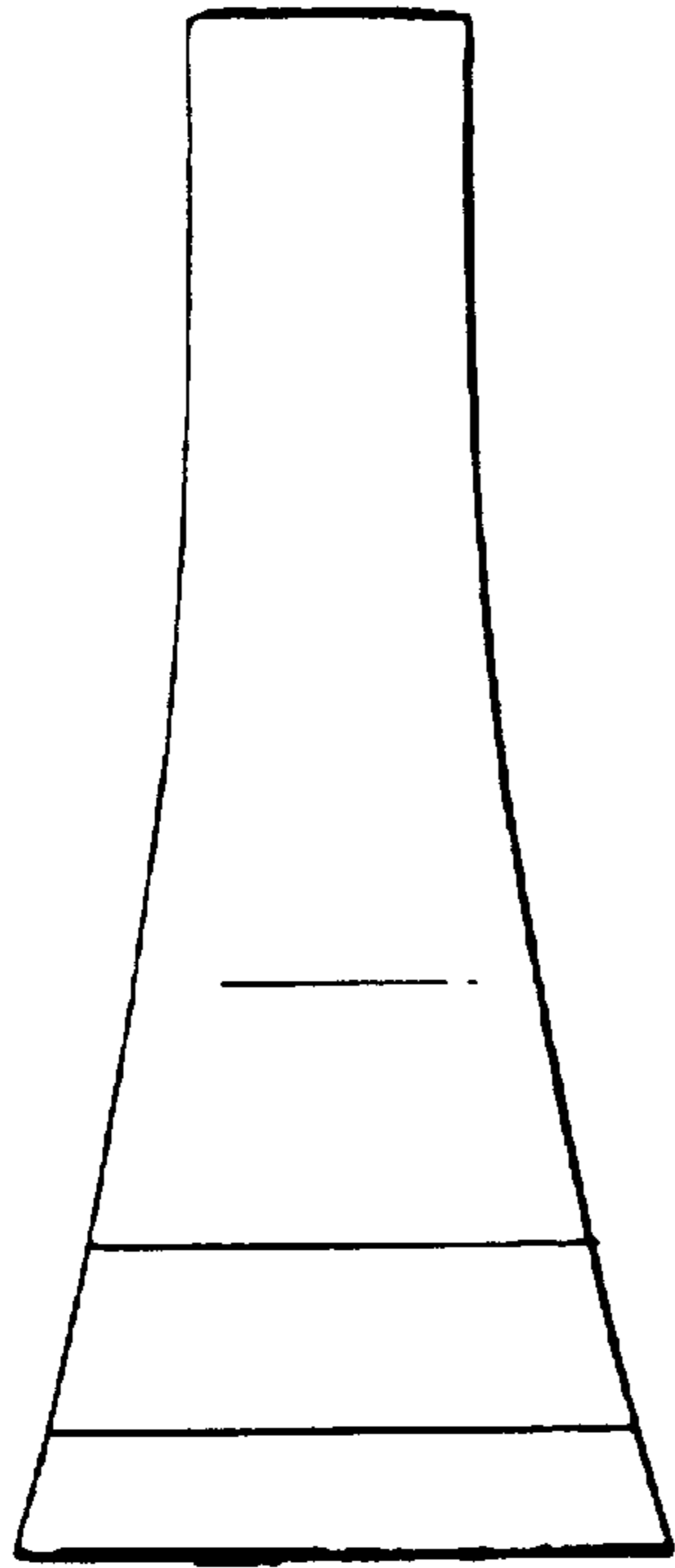

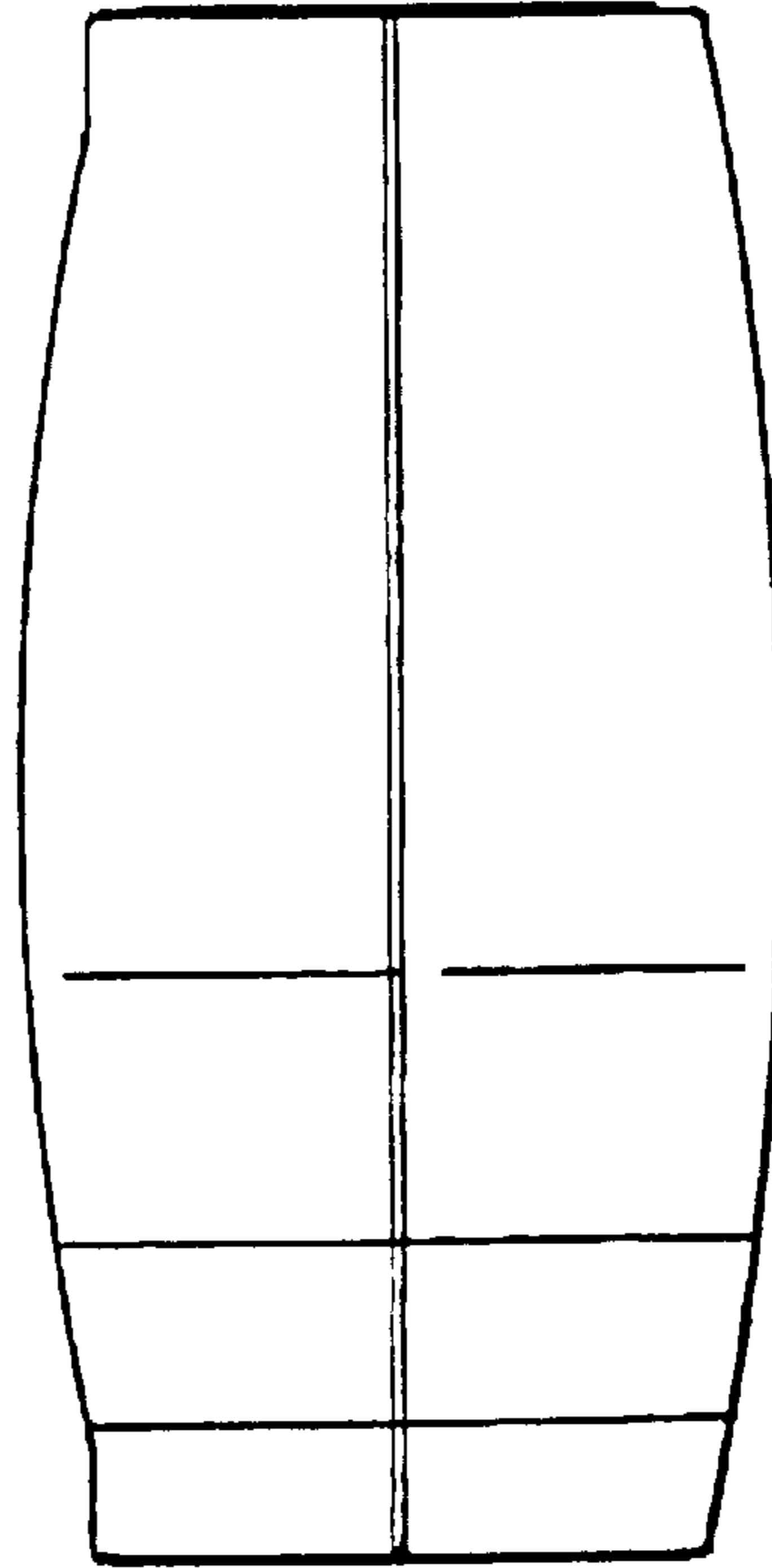

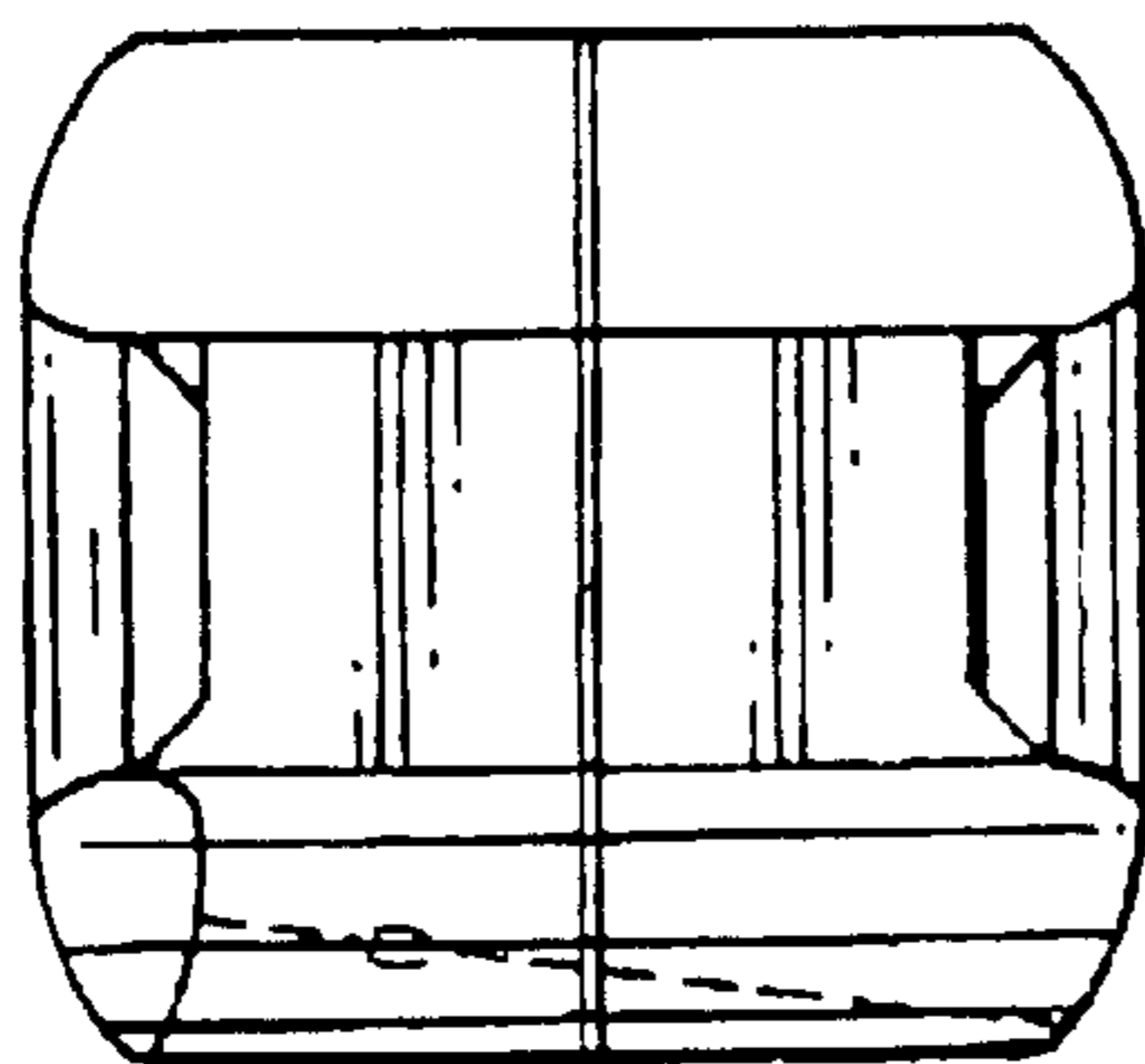

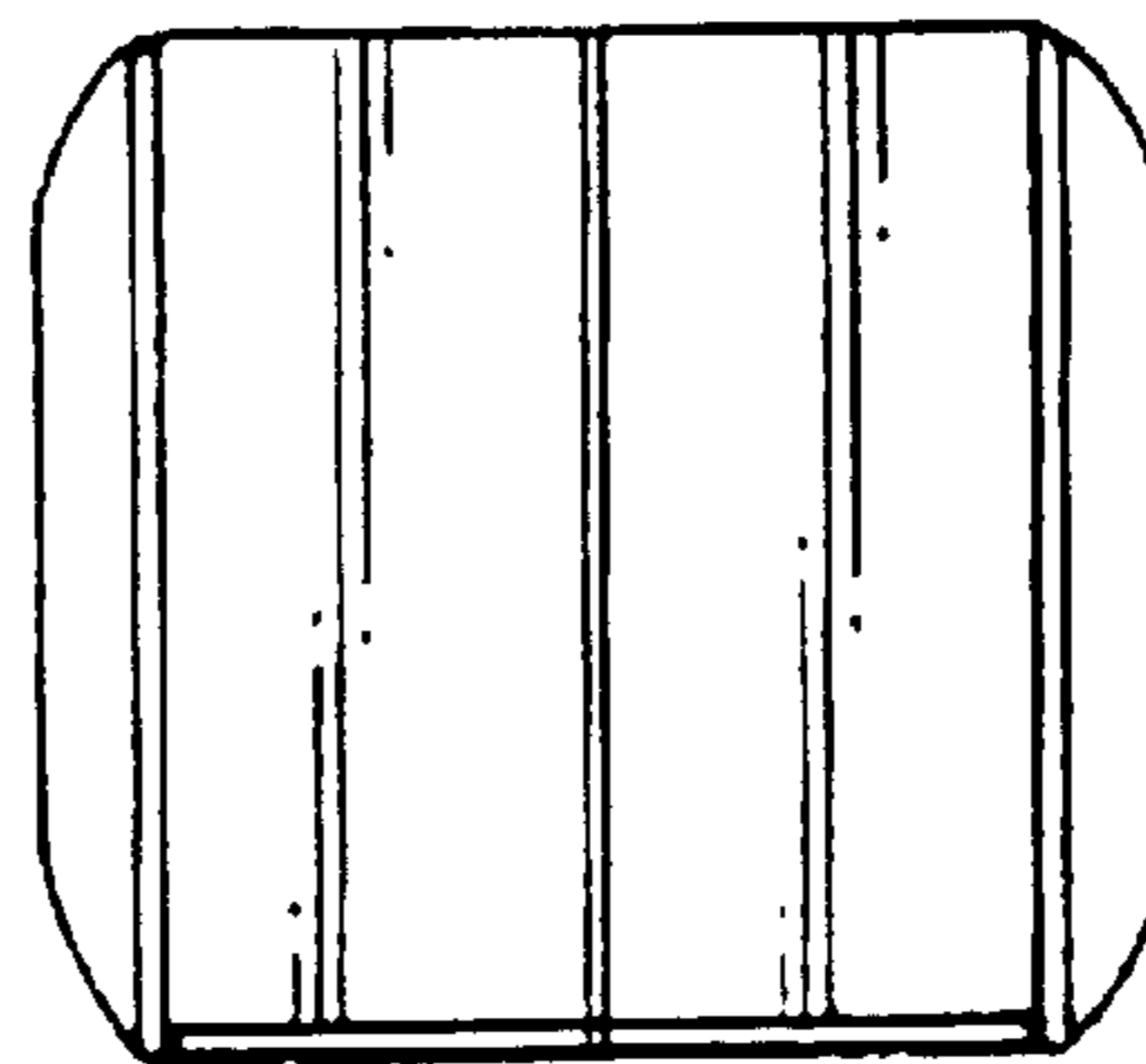
