DESCRIPTION

FIG. 1 is a top and right front perspective view of a bottle
showing my design;

FIG. 2 is a front elevational view thereof;

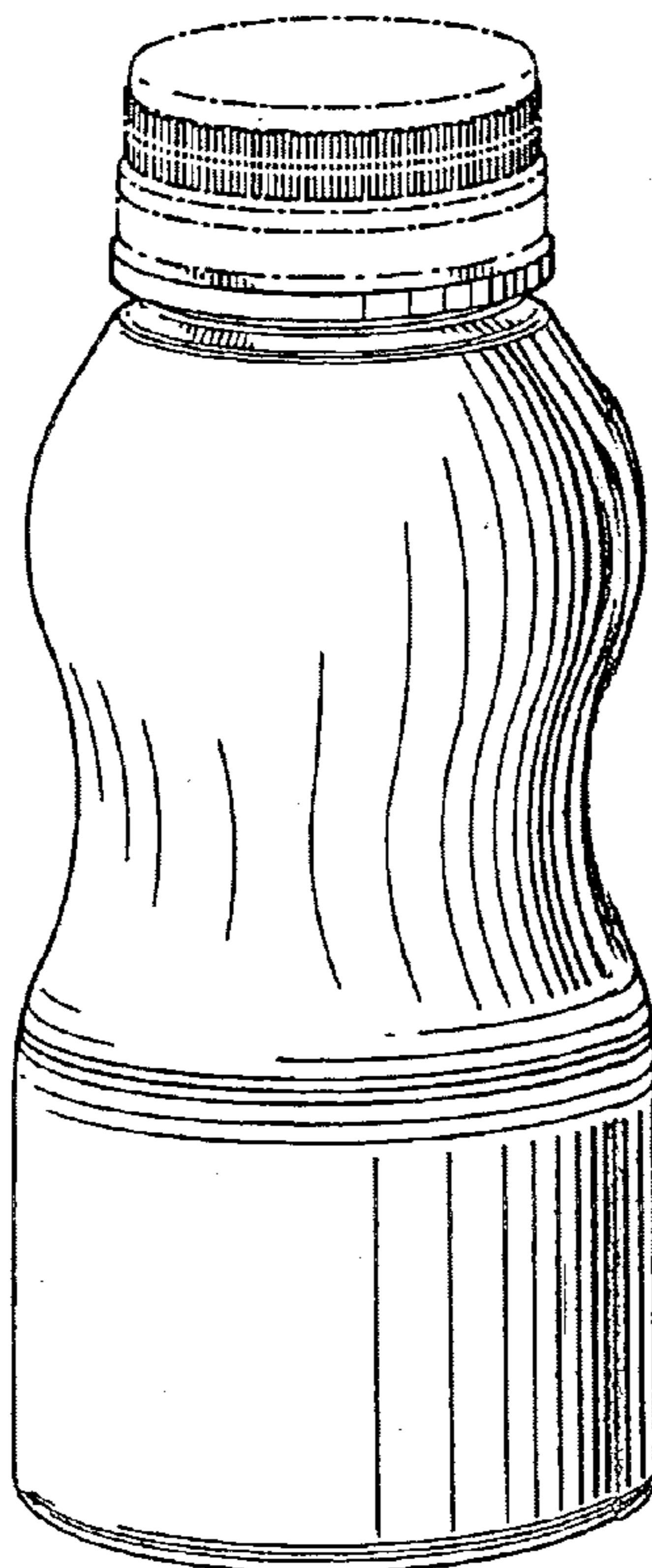
FIG. 3 is a right side elevational view thereof, the left side

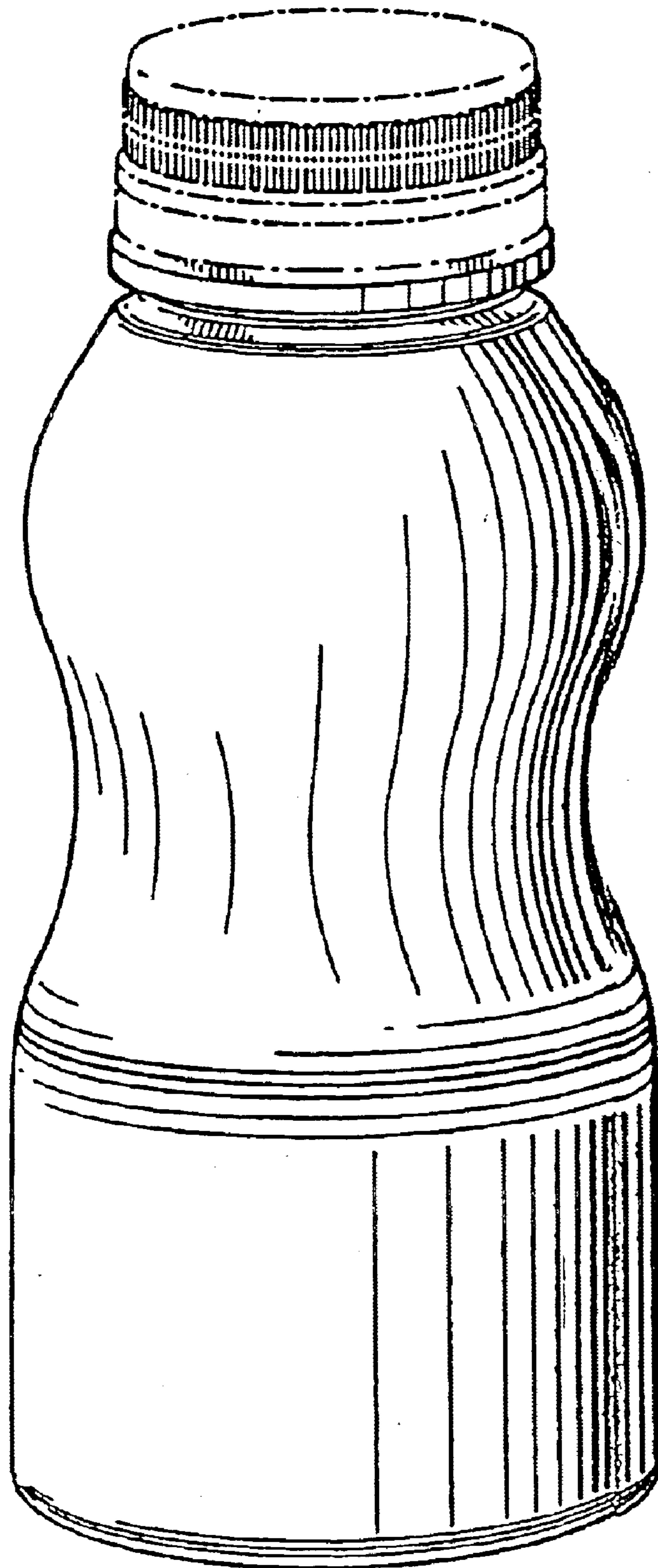

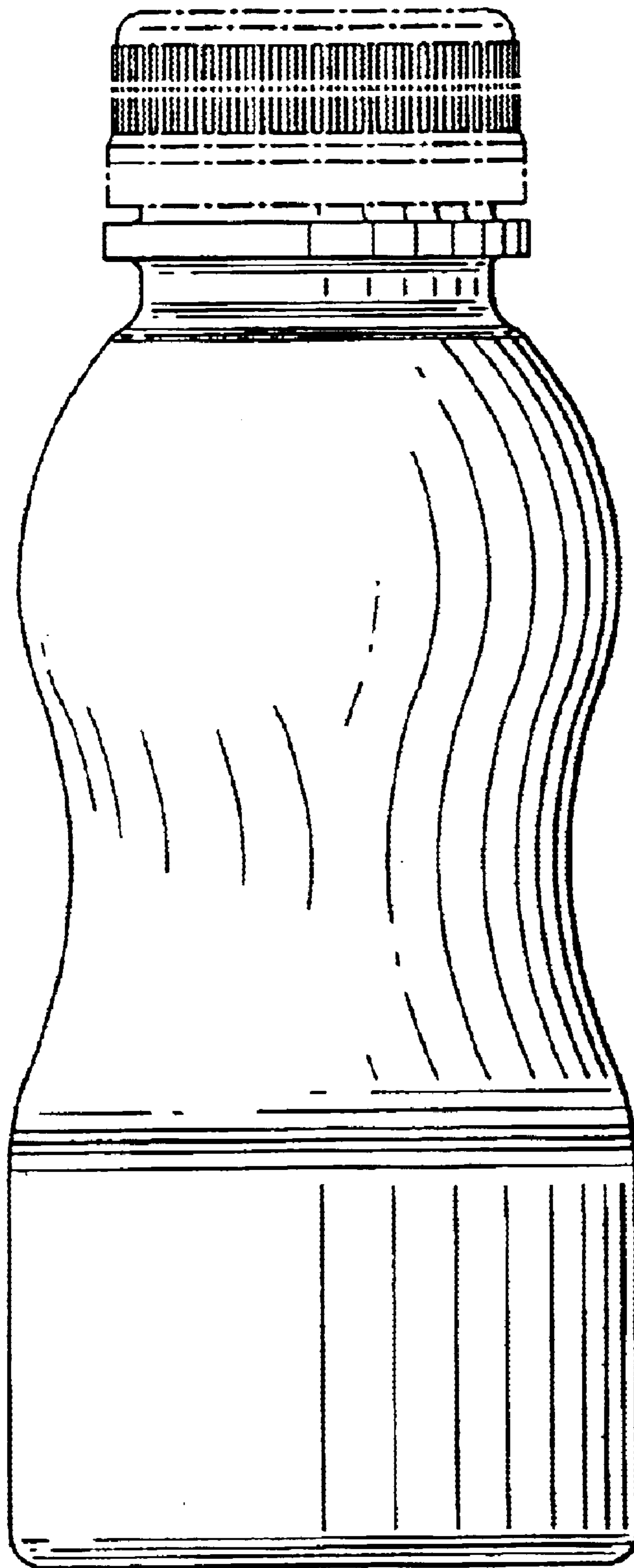

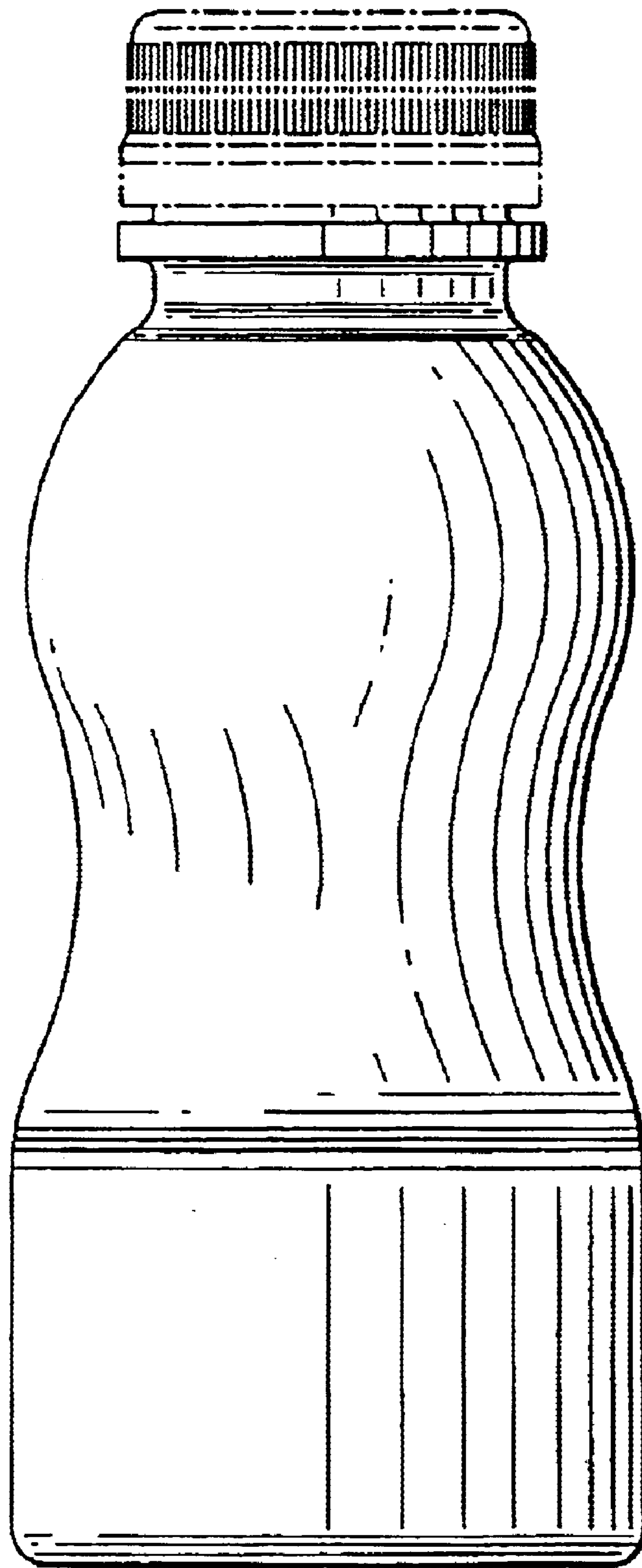

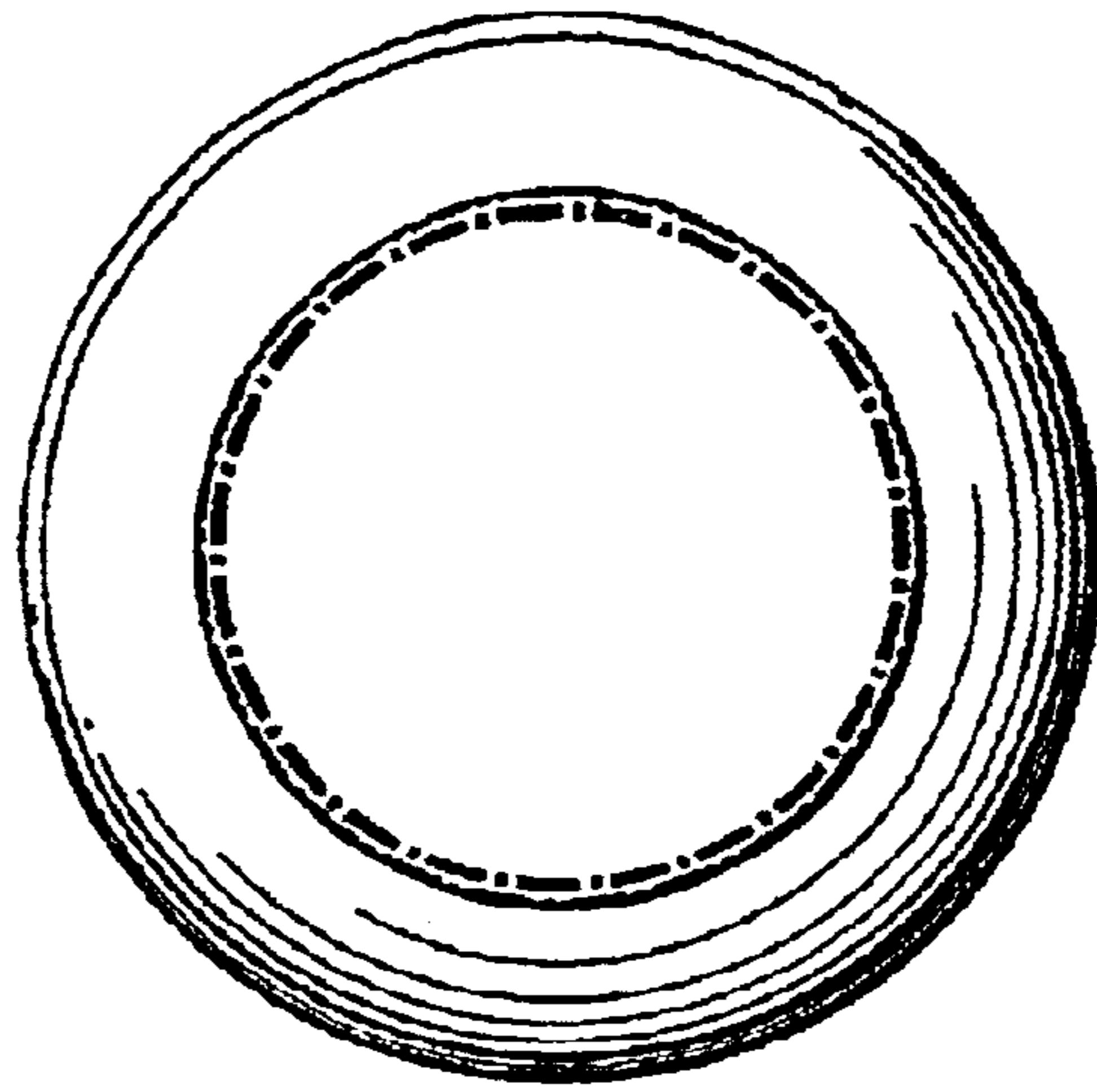

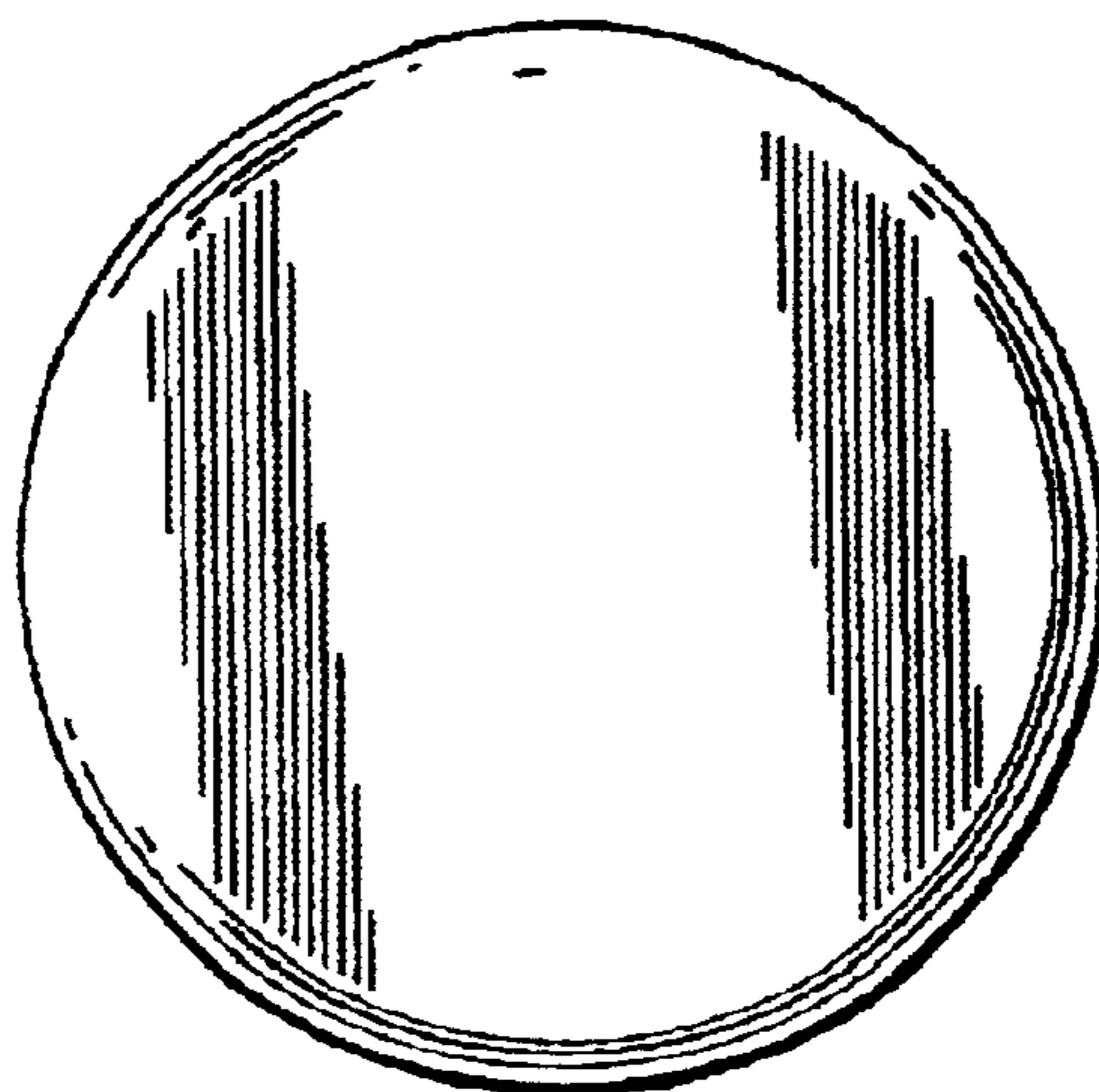
