DESCRIPTION

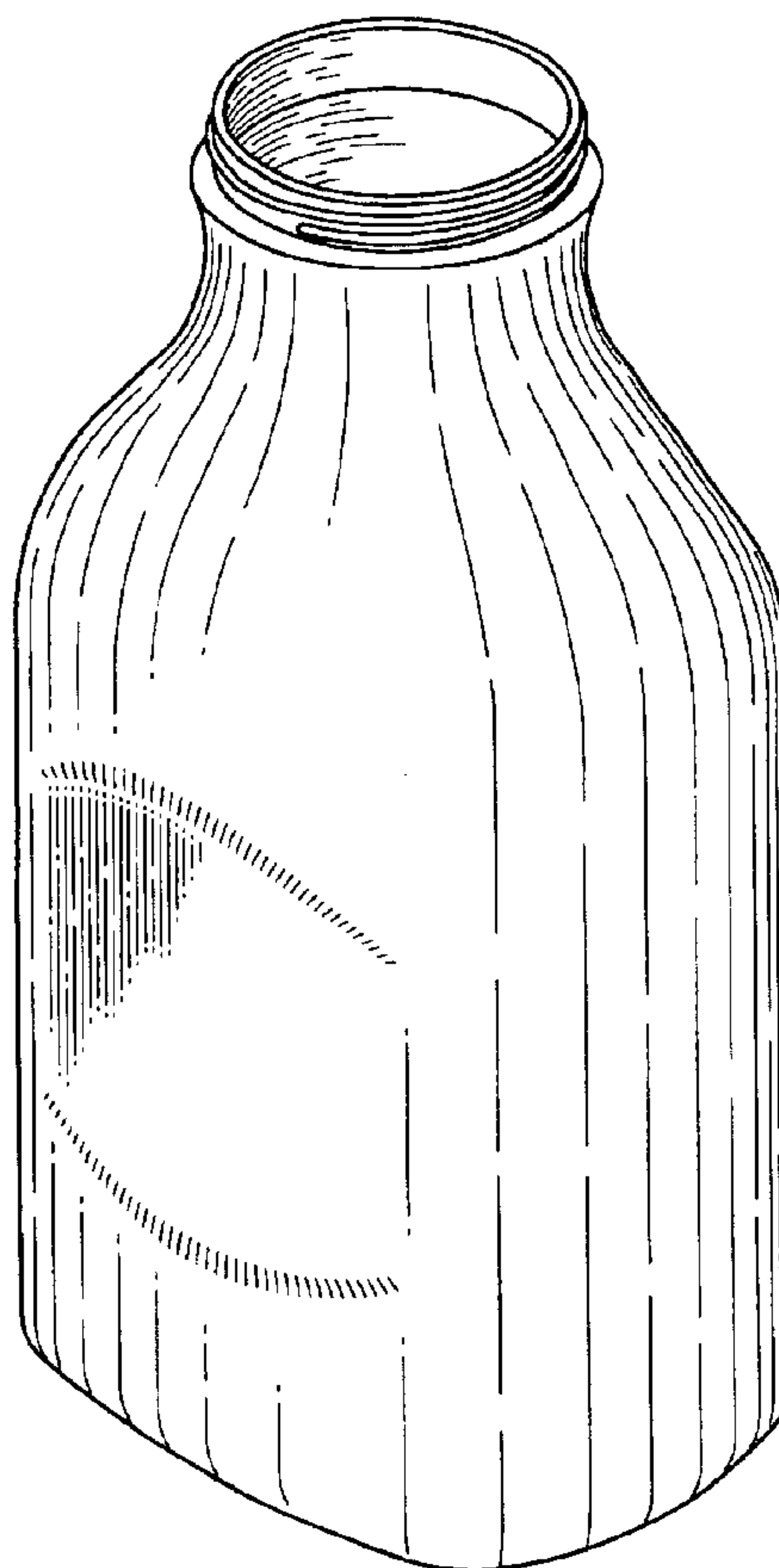
FIG. 1 is a perspective view of the non-dairy creamer jar of the inventive design;

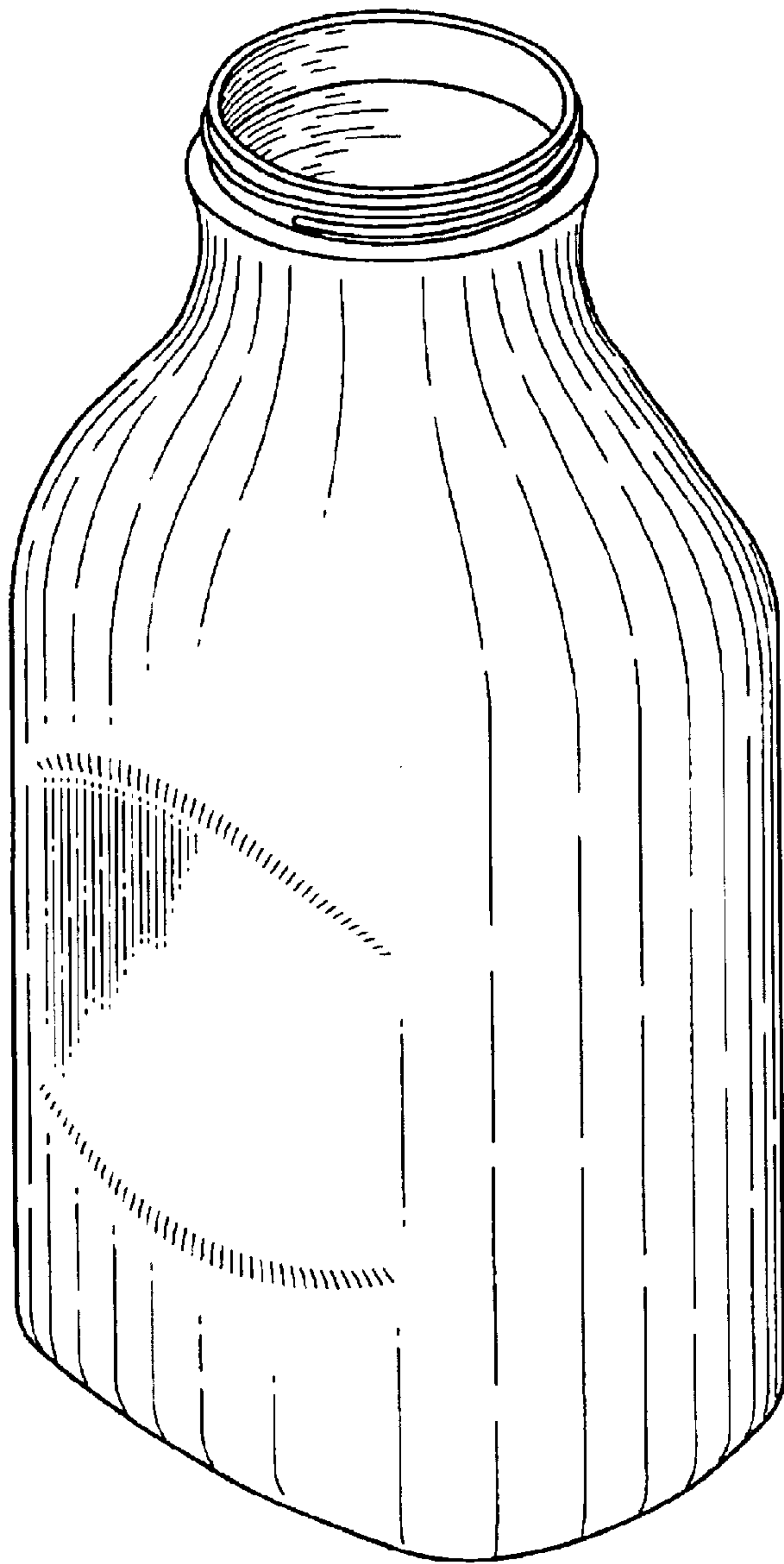

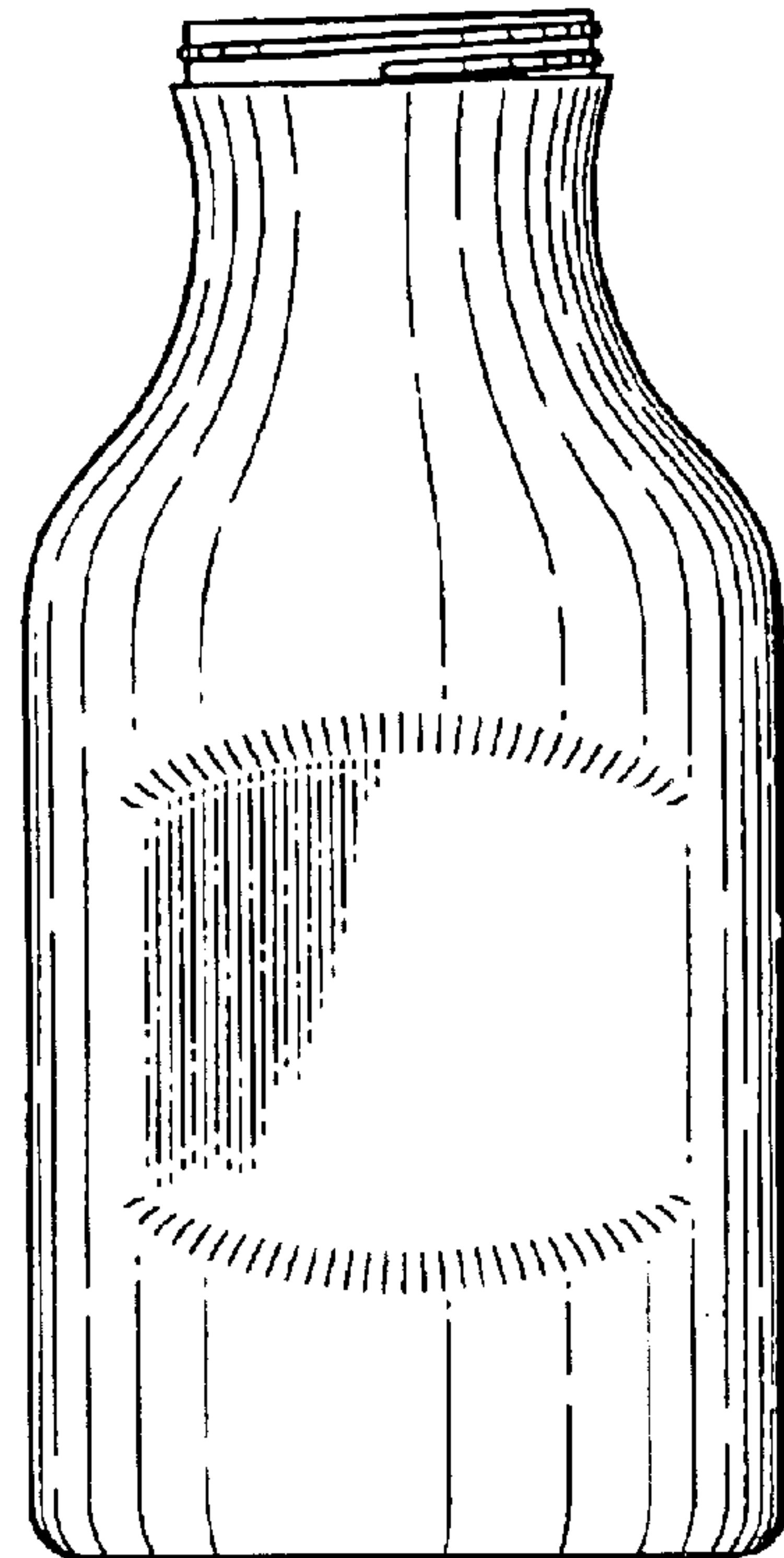

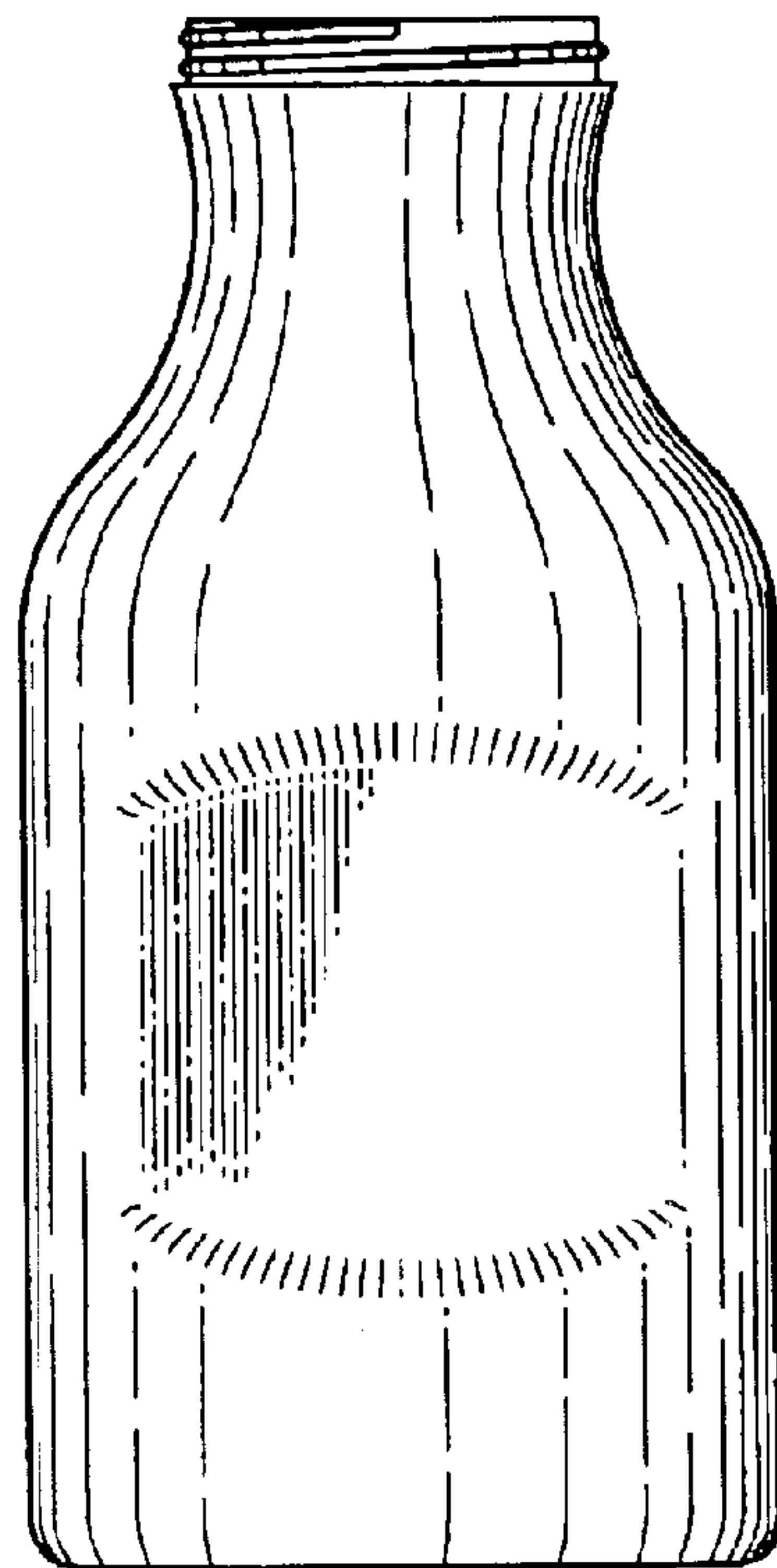

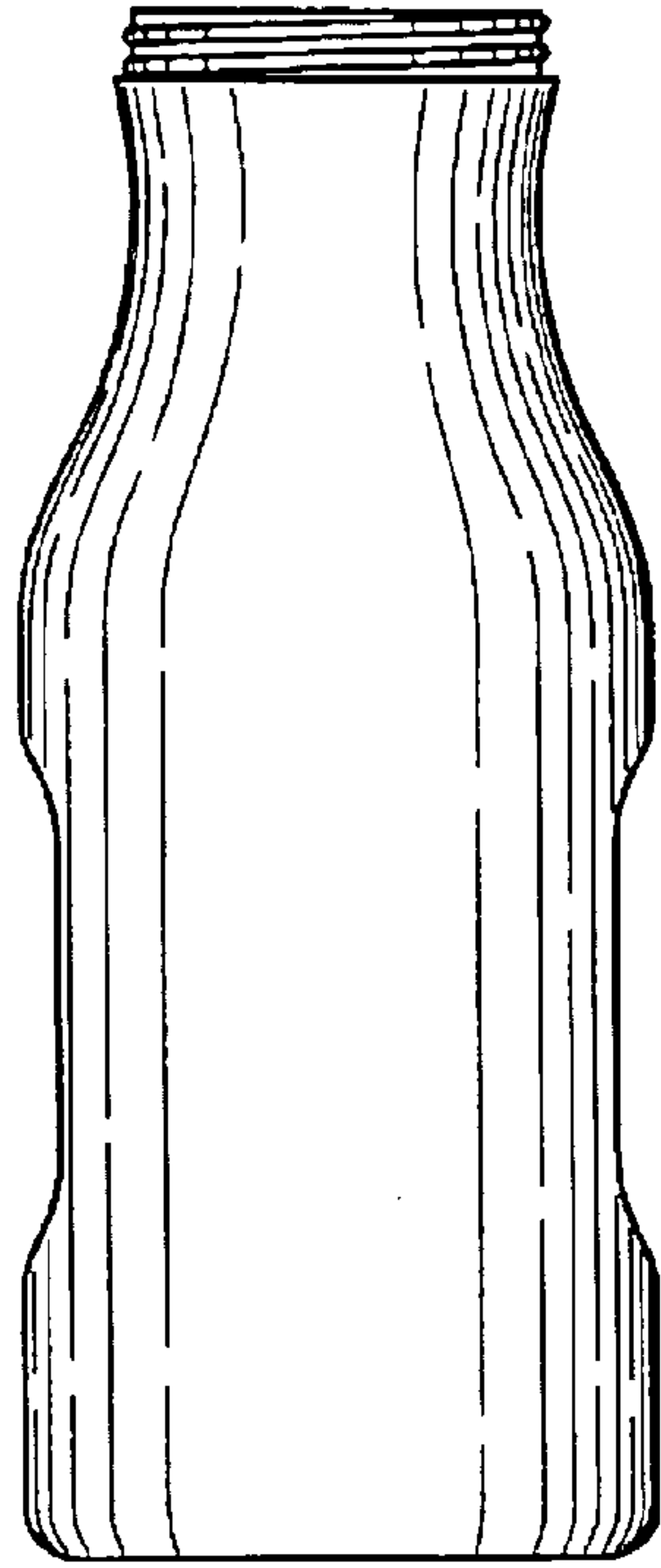

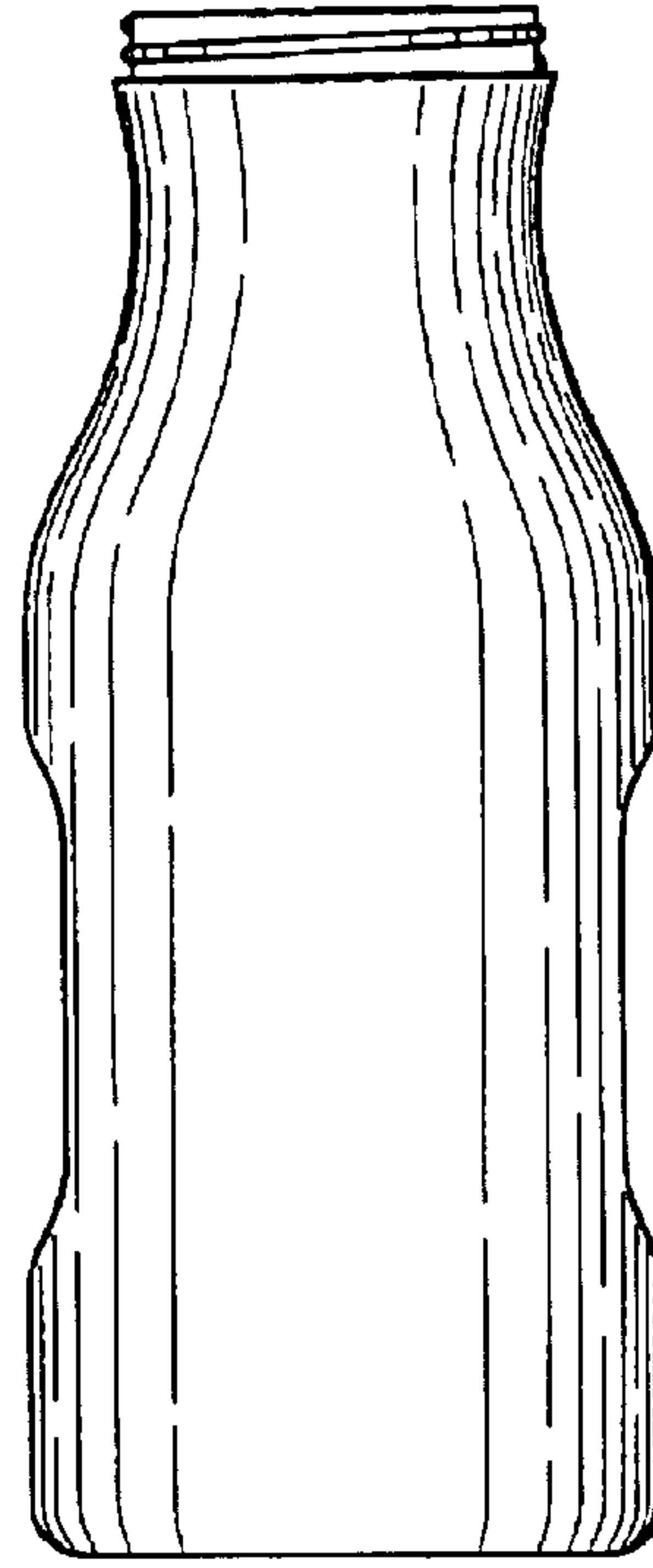

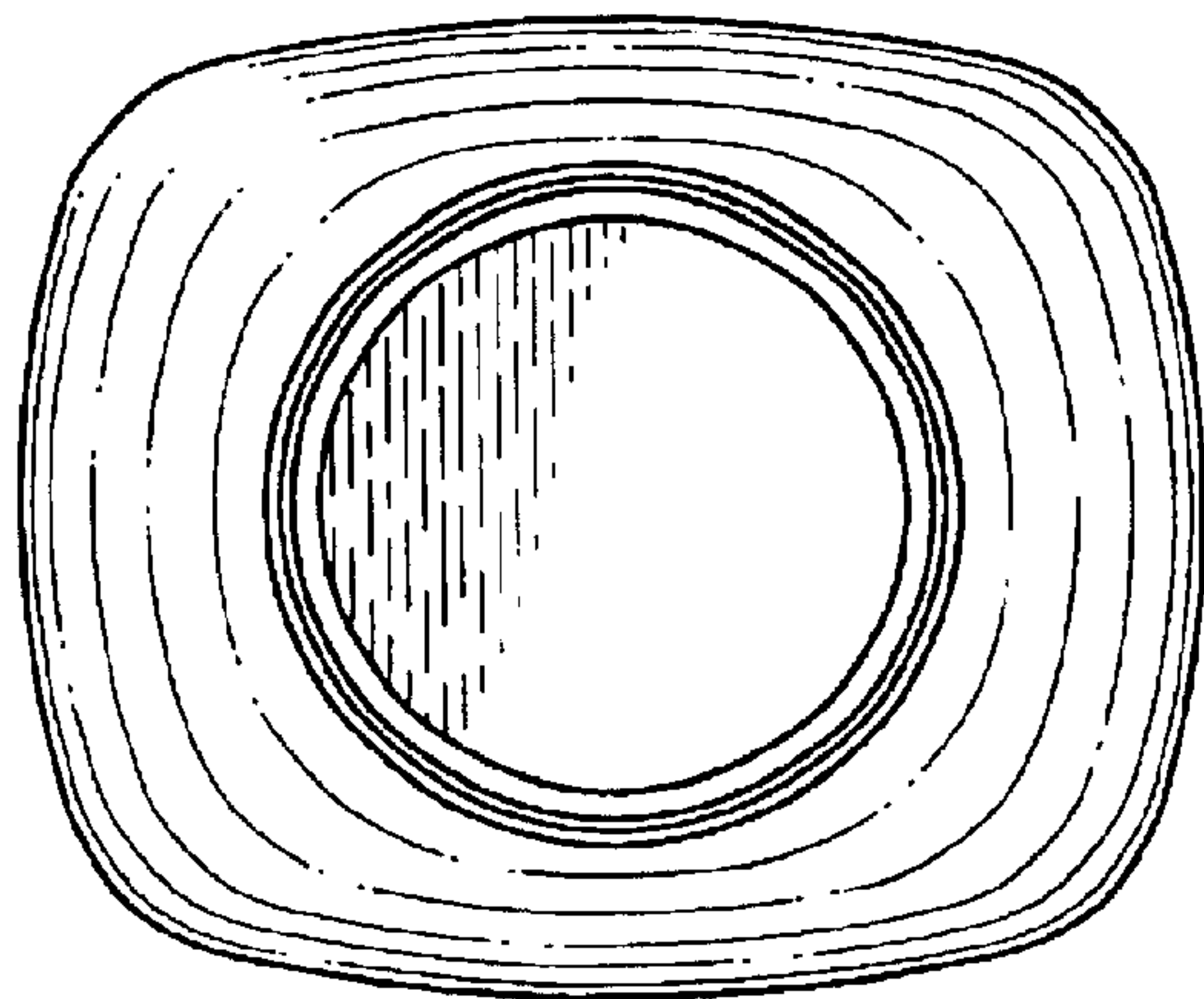

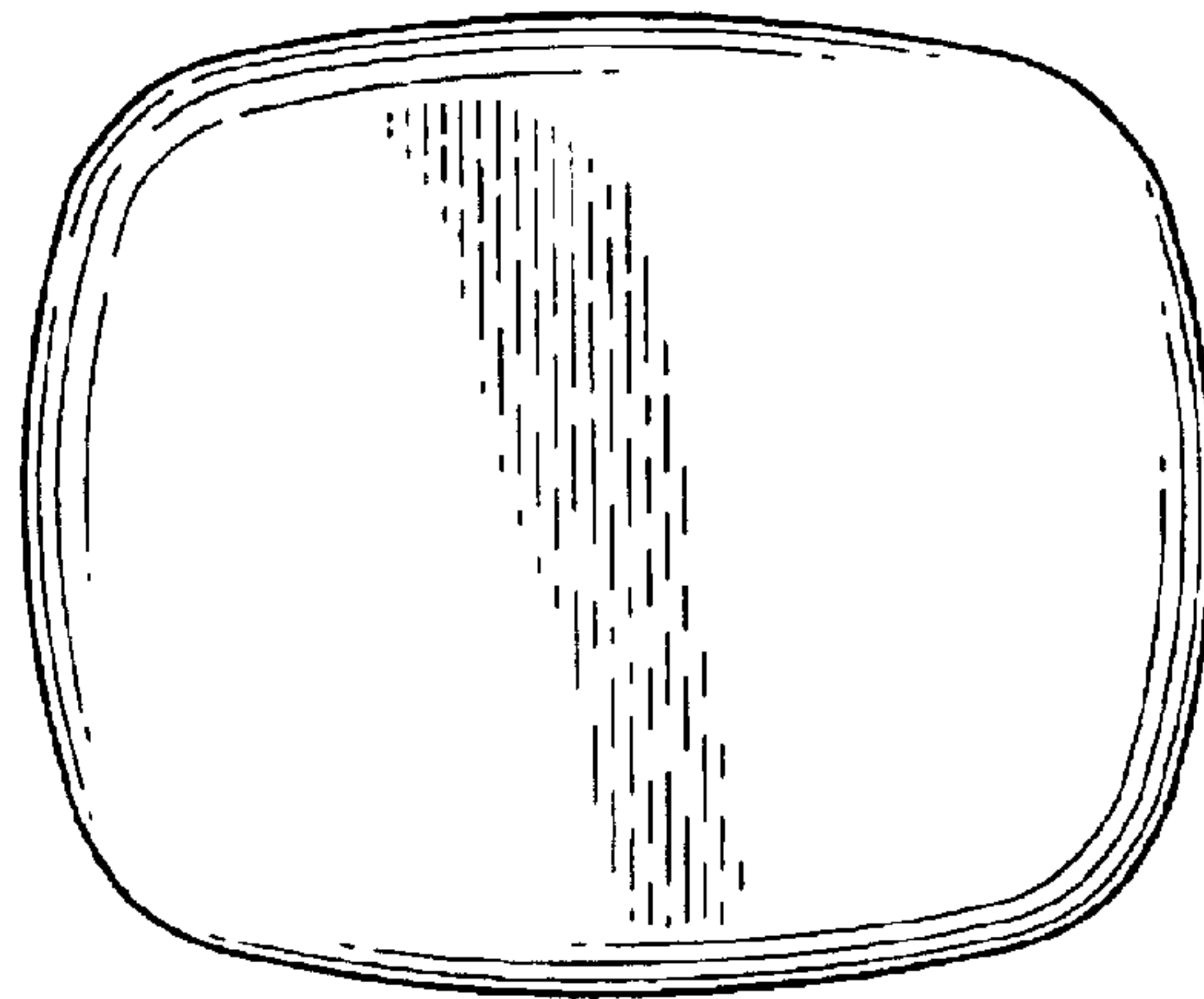
