**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and right side of a wristwatch showing my new design;

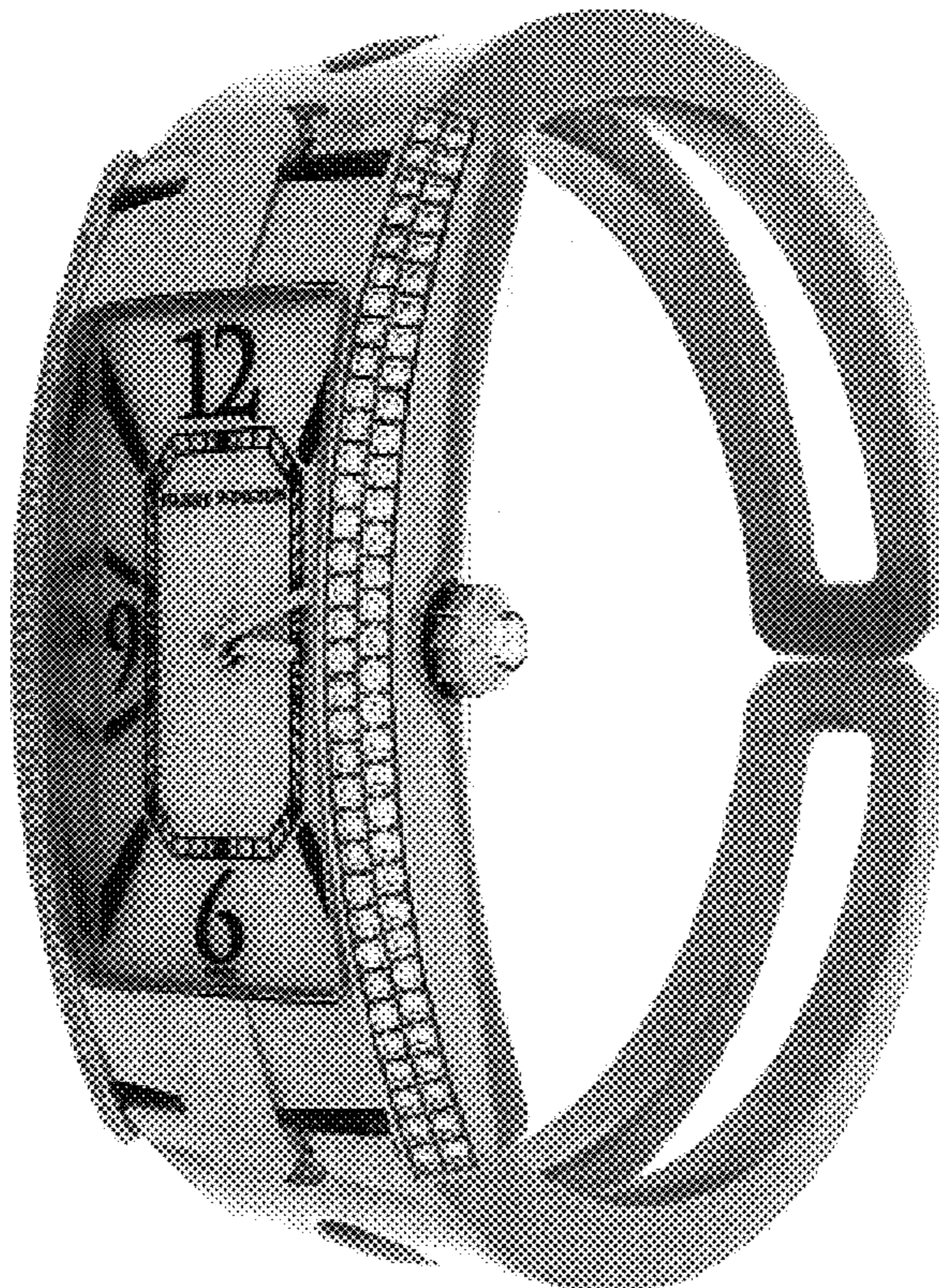

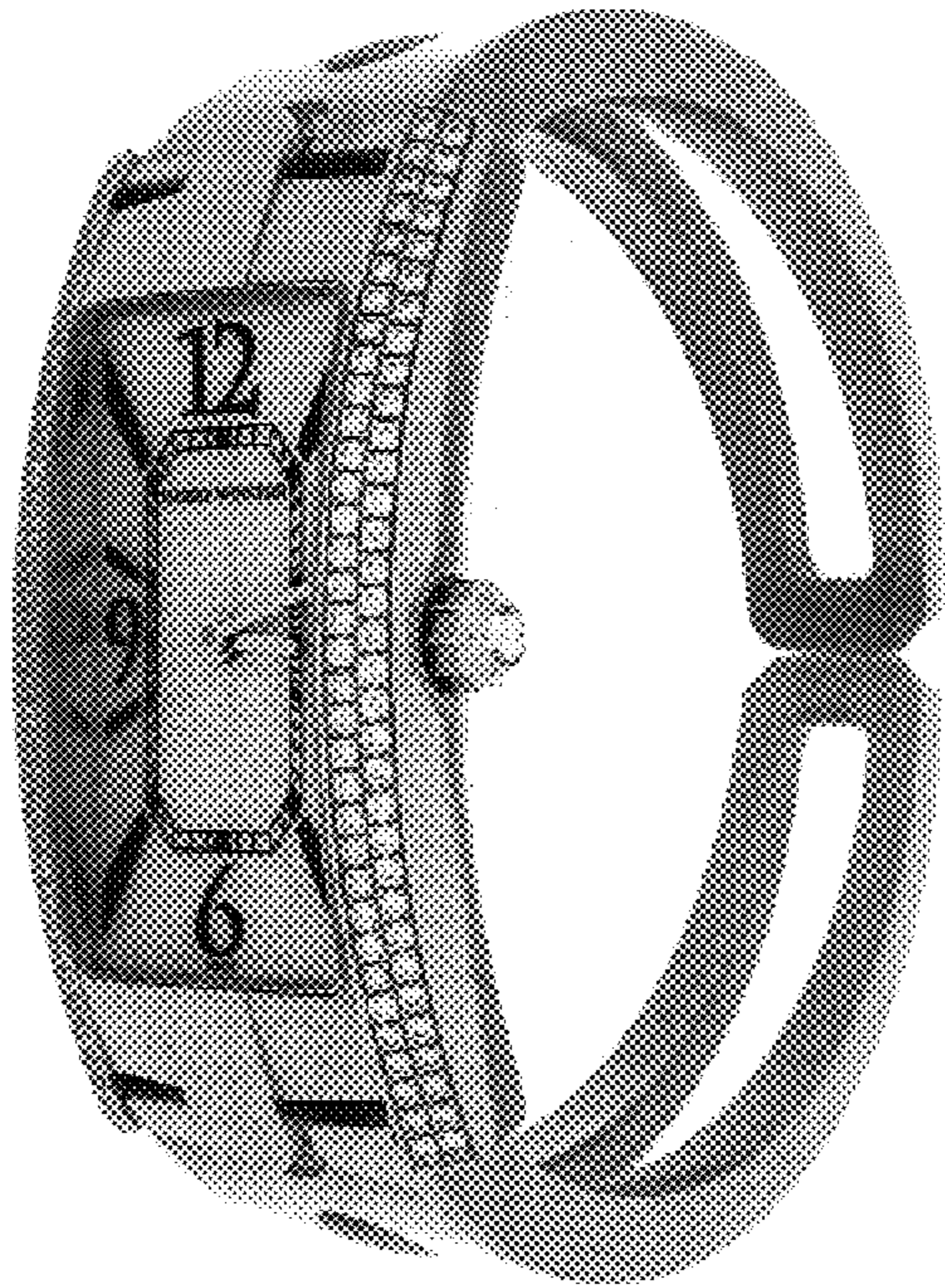

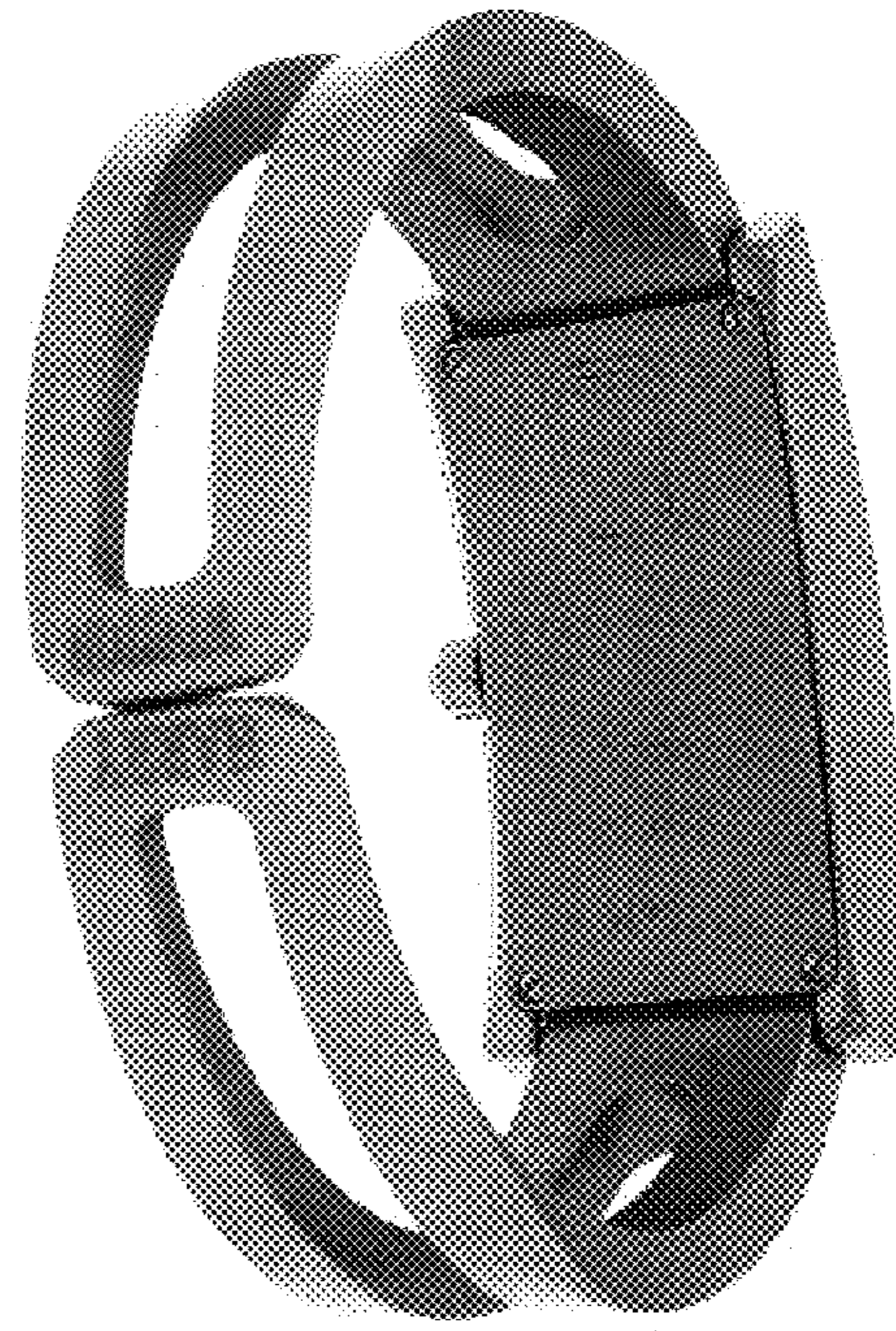

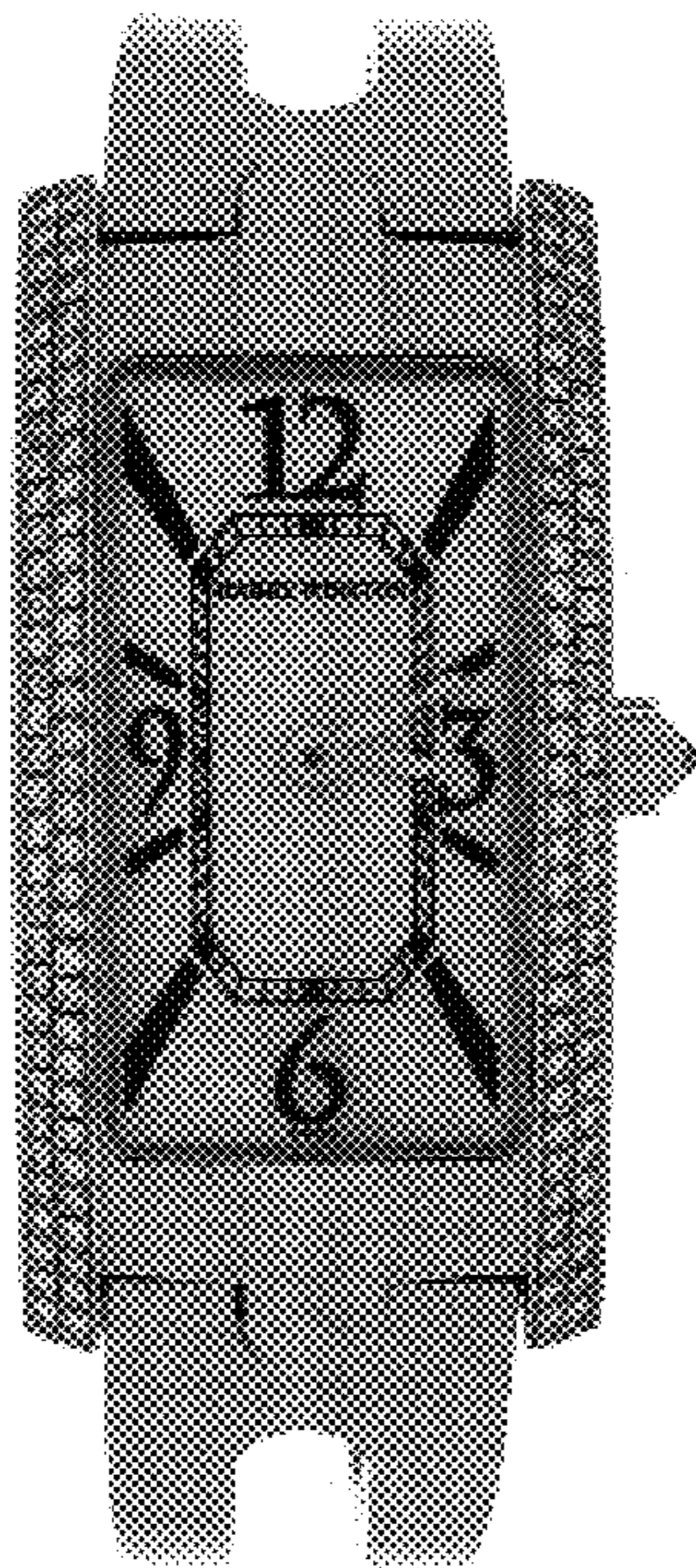

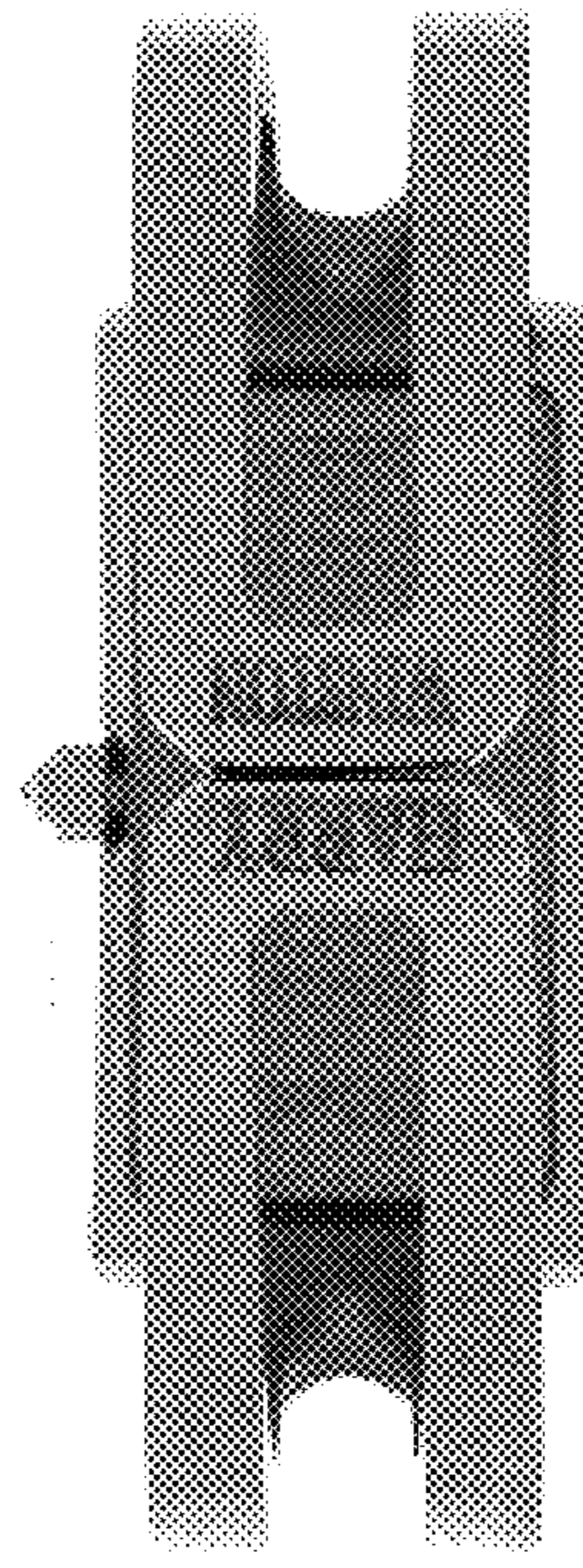

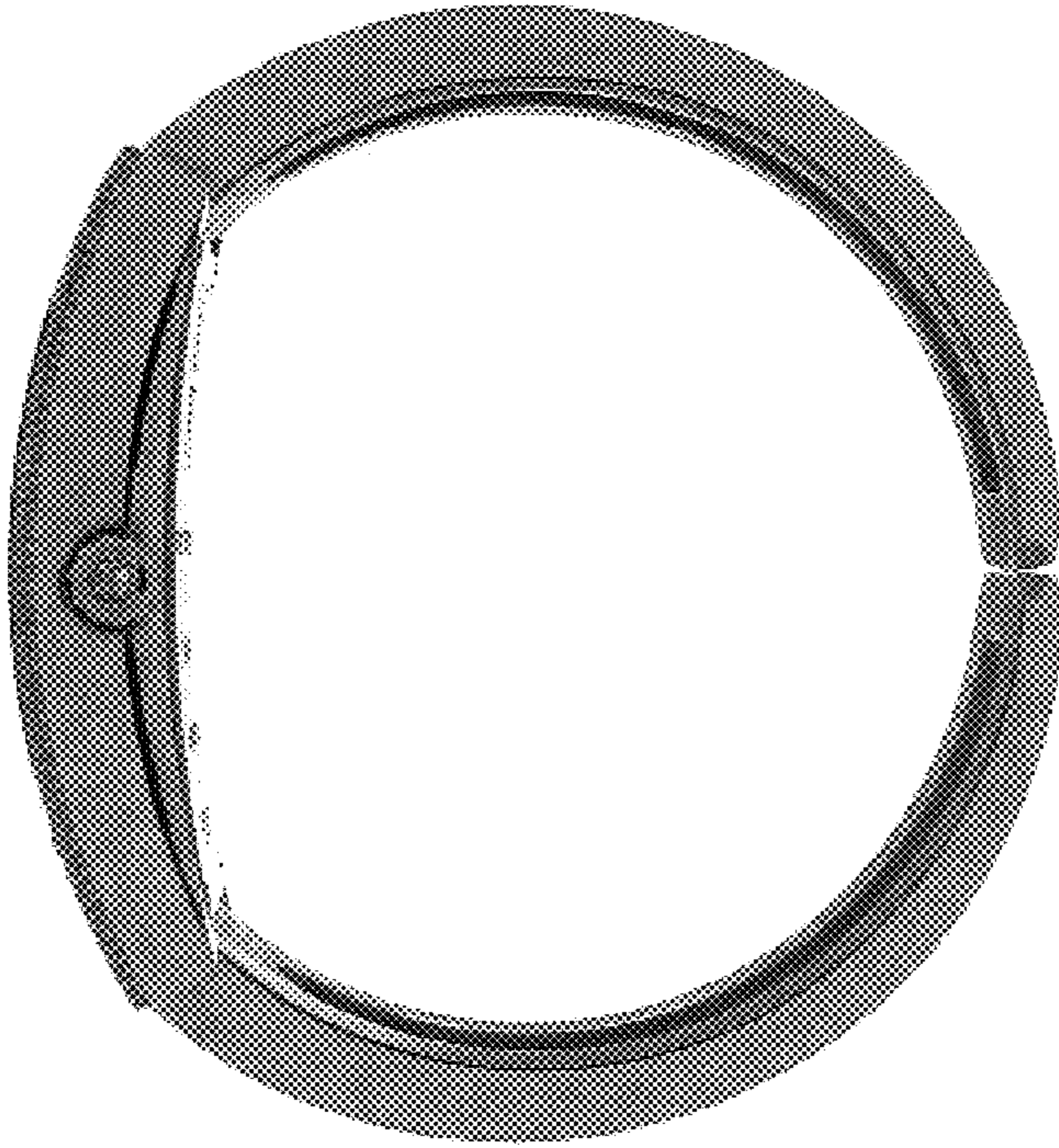

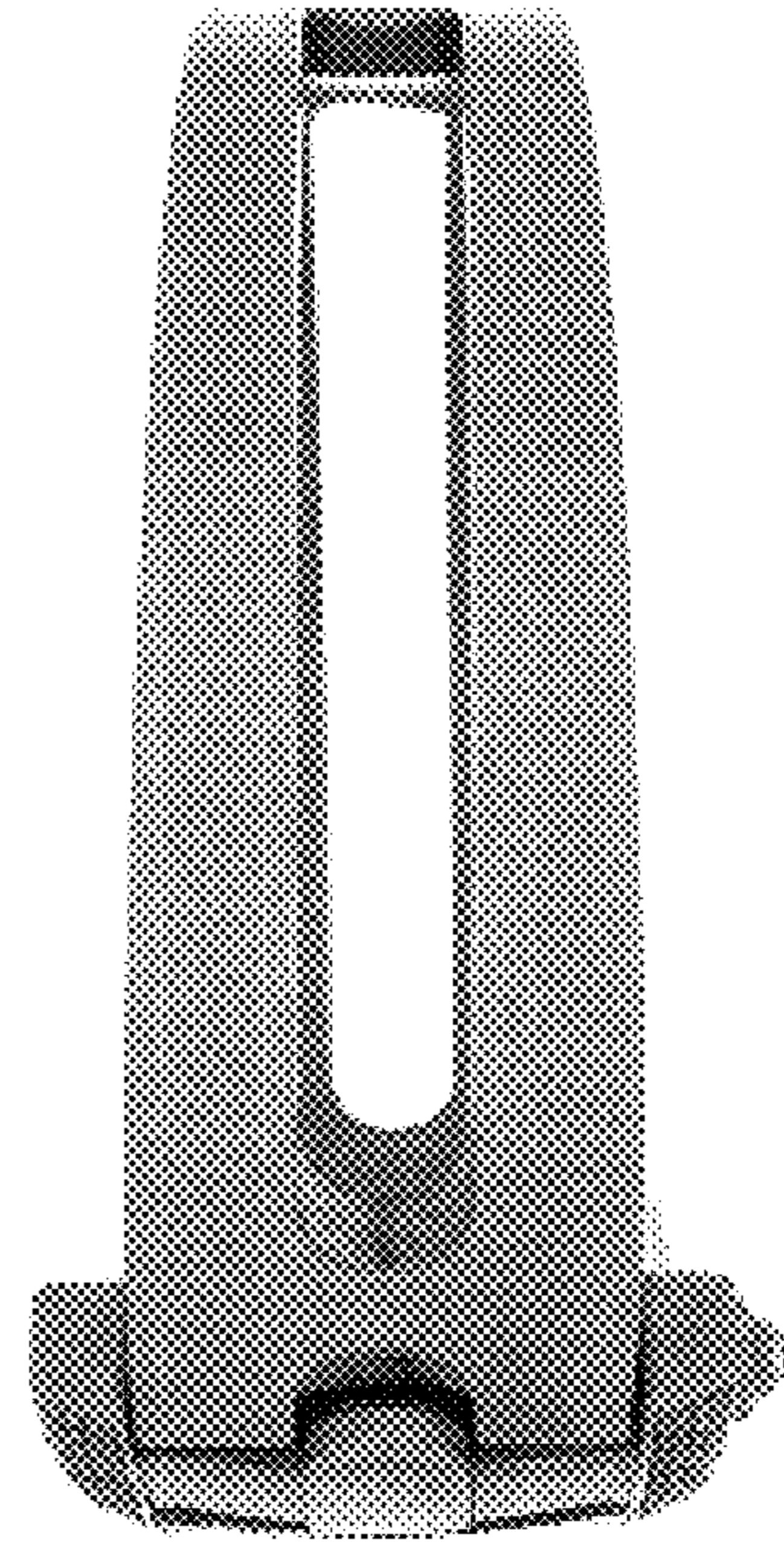

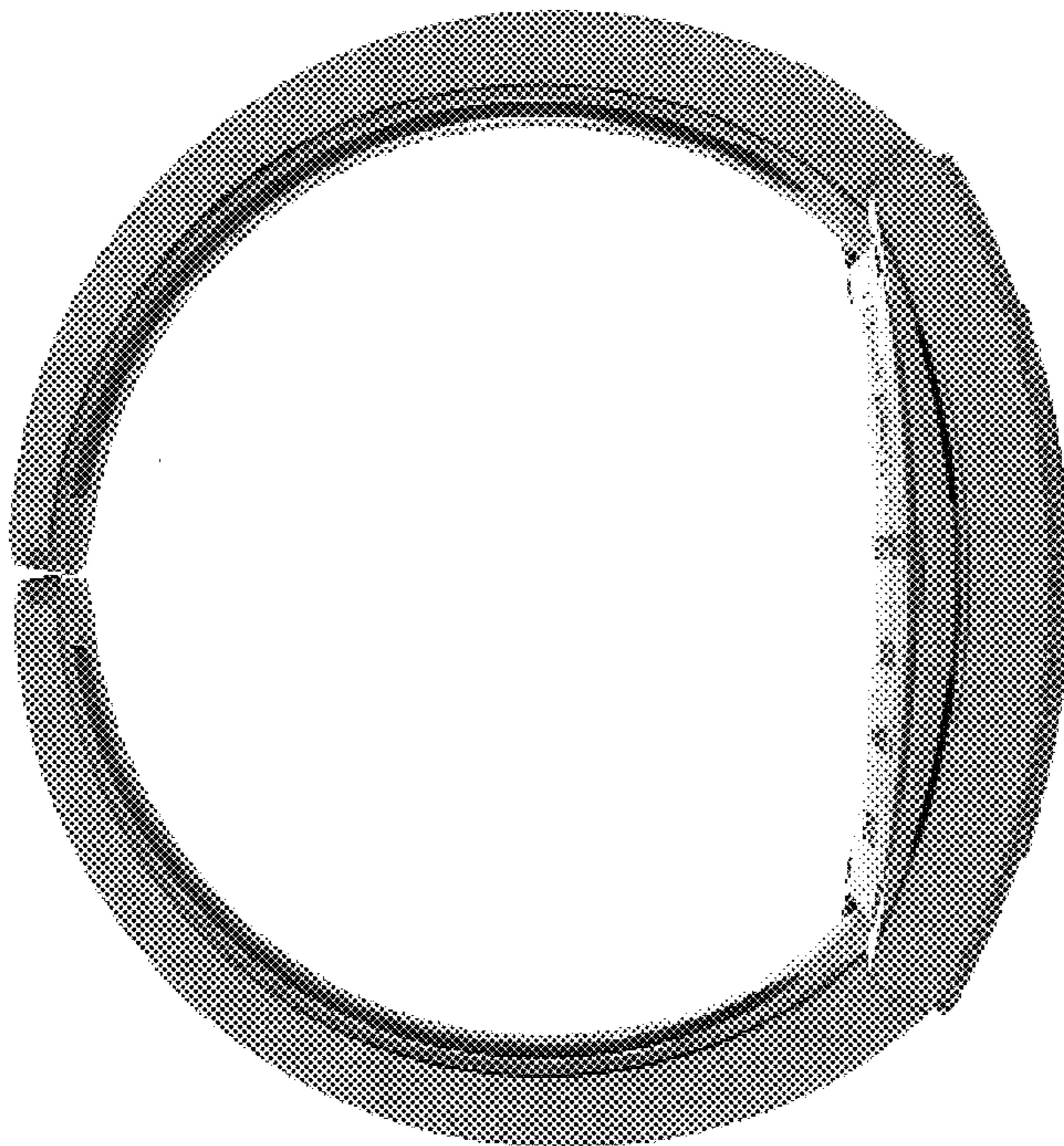
