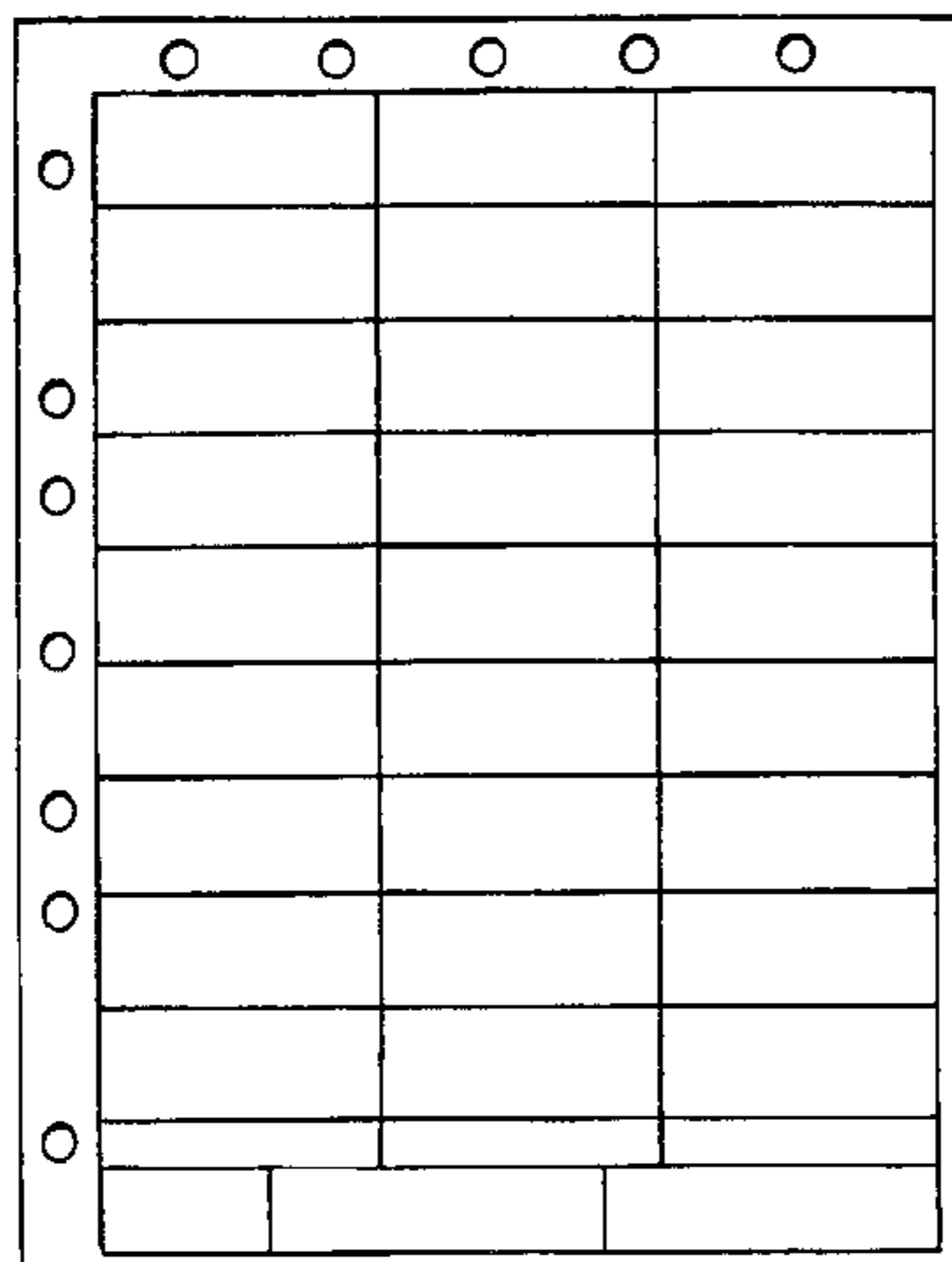
(57) **CLAIM**

The ornamental design for the medical label sheet, as shown.

DESCRIPTION

FIG. 1 is a front view of a medical label sheet according to the present invention.
FIG. 2 is a front perspective view of the medical label sheet of FIG. 1.
FIG. 3 is a front view of an alternative embodiment of a medical label sheet according to the present invention.
FIG. 4 is a front perspective view of the medical label sheet of FIG. 3.
FIG. 5 is a front view of another alternative embodiment of a medical label sheet according to the present invention; and, FIG. 6 is a front view of yet another alternative embodiment of a medical label sheet according to the present invention.

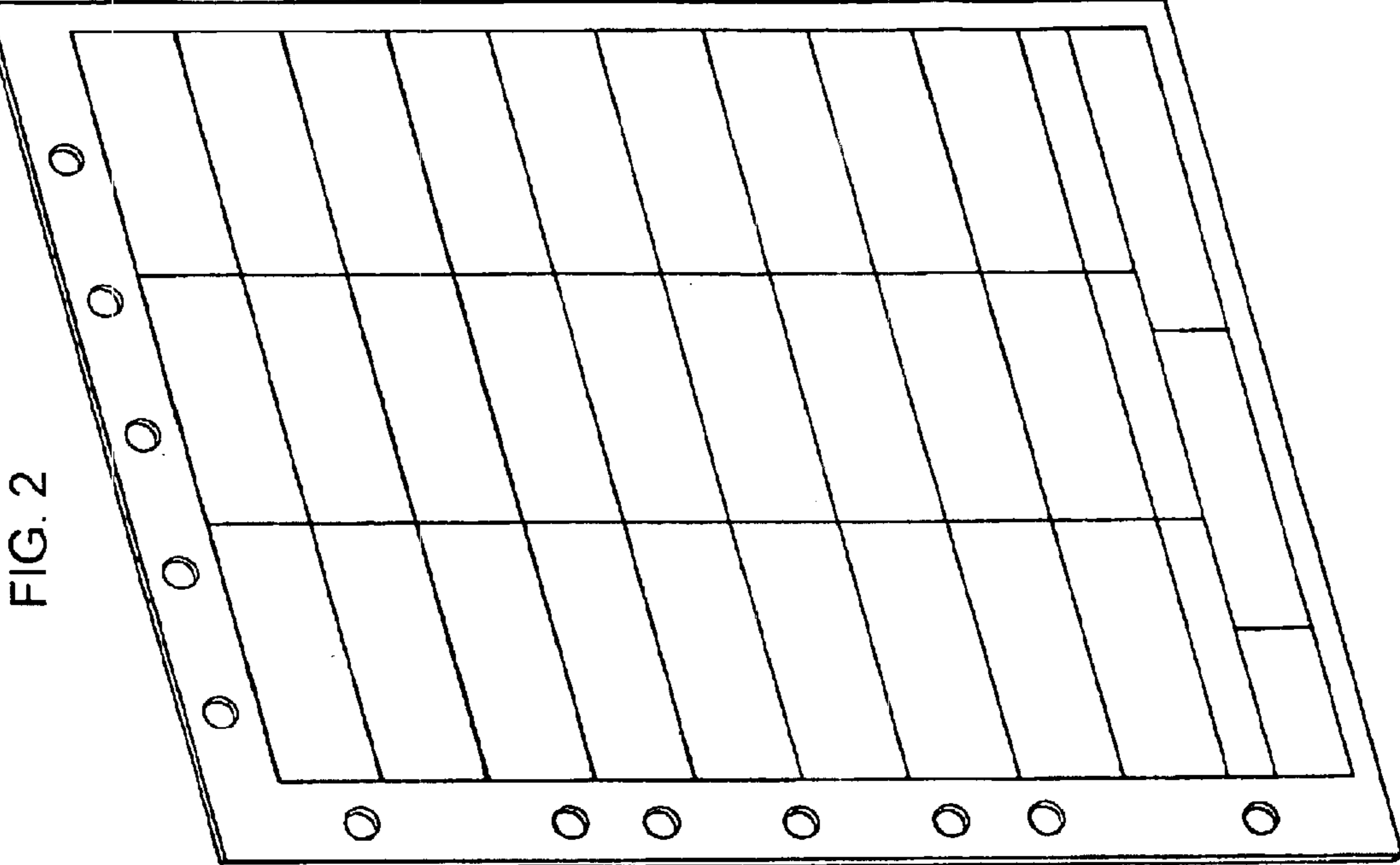

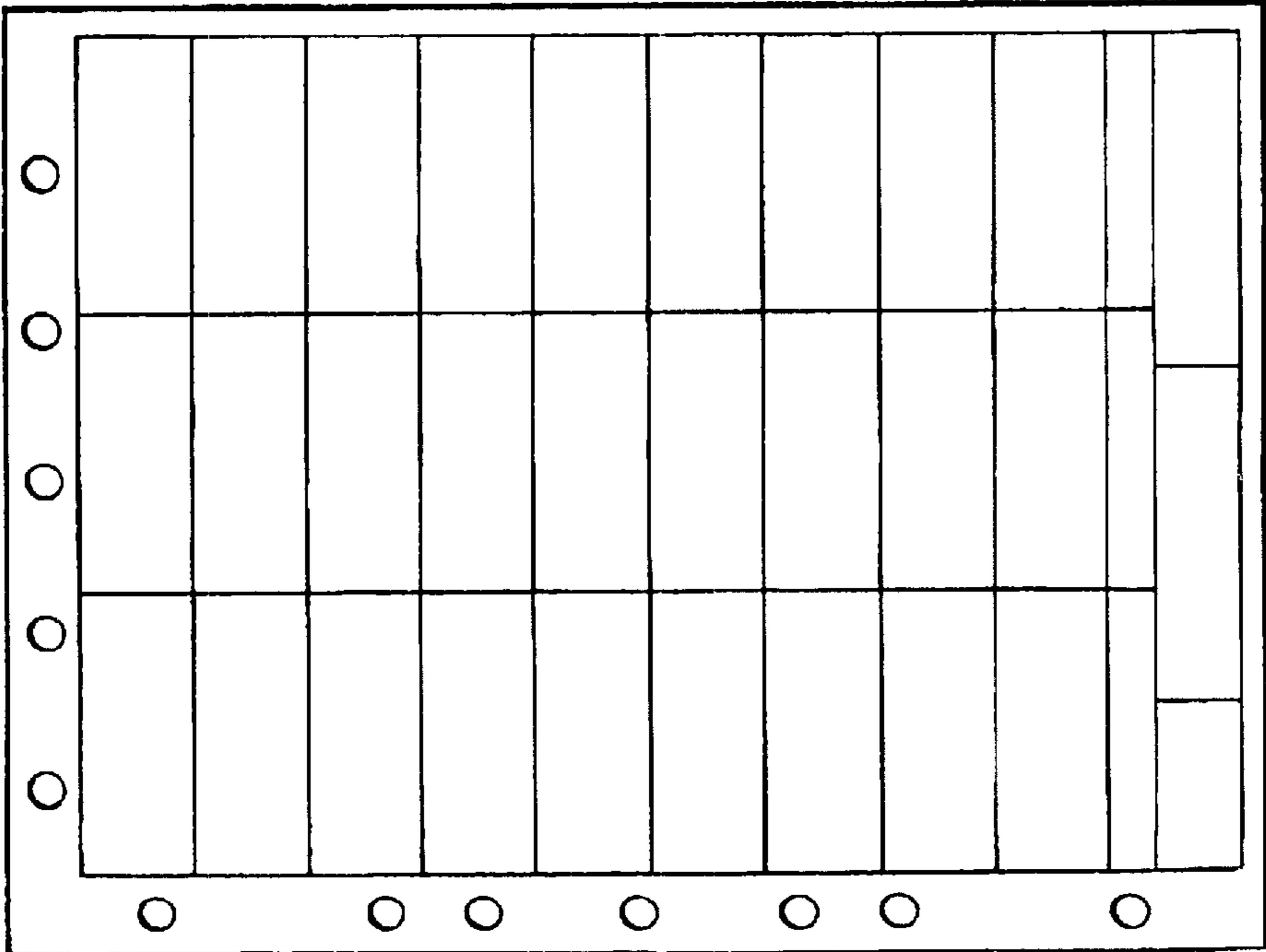

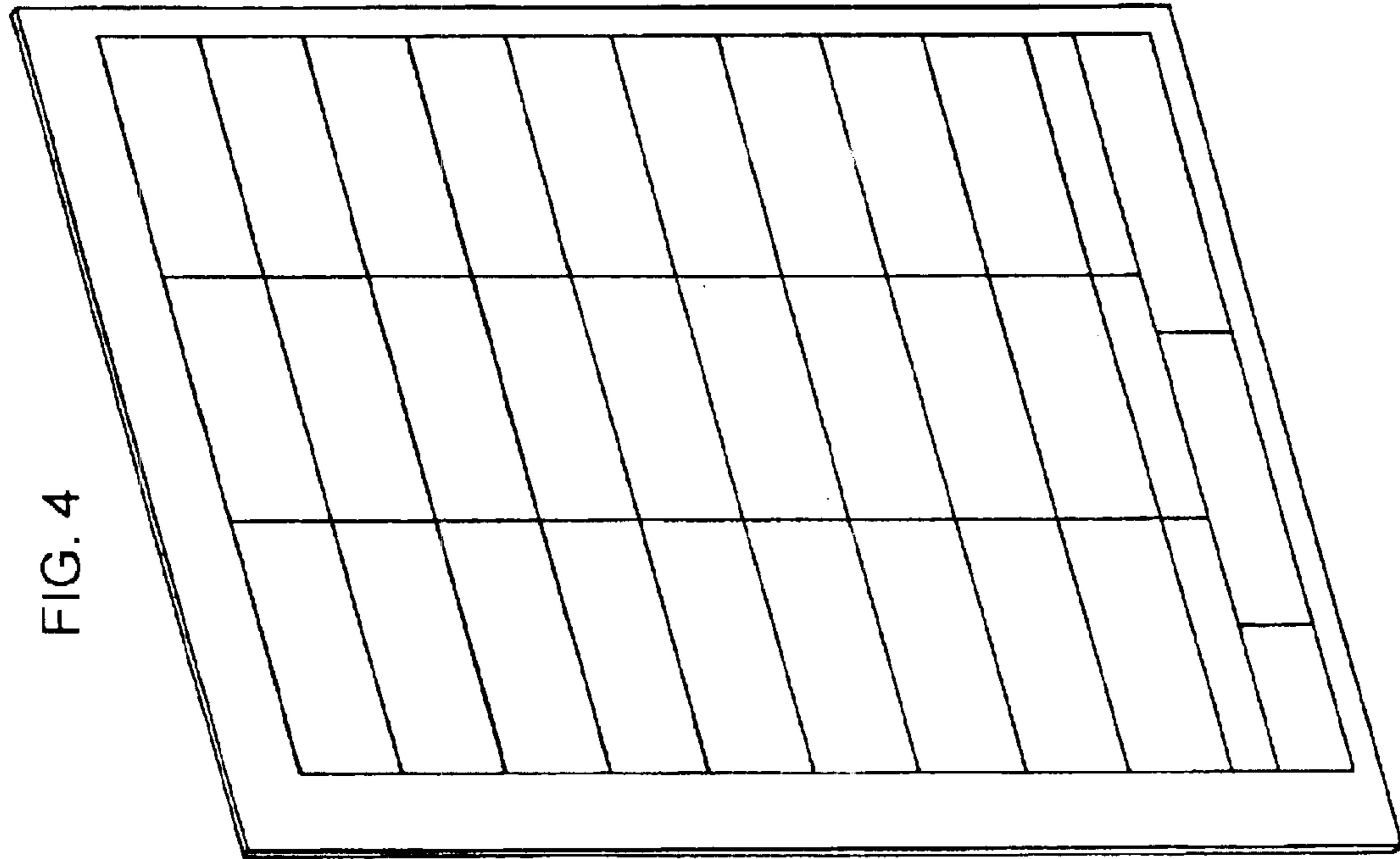

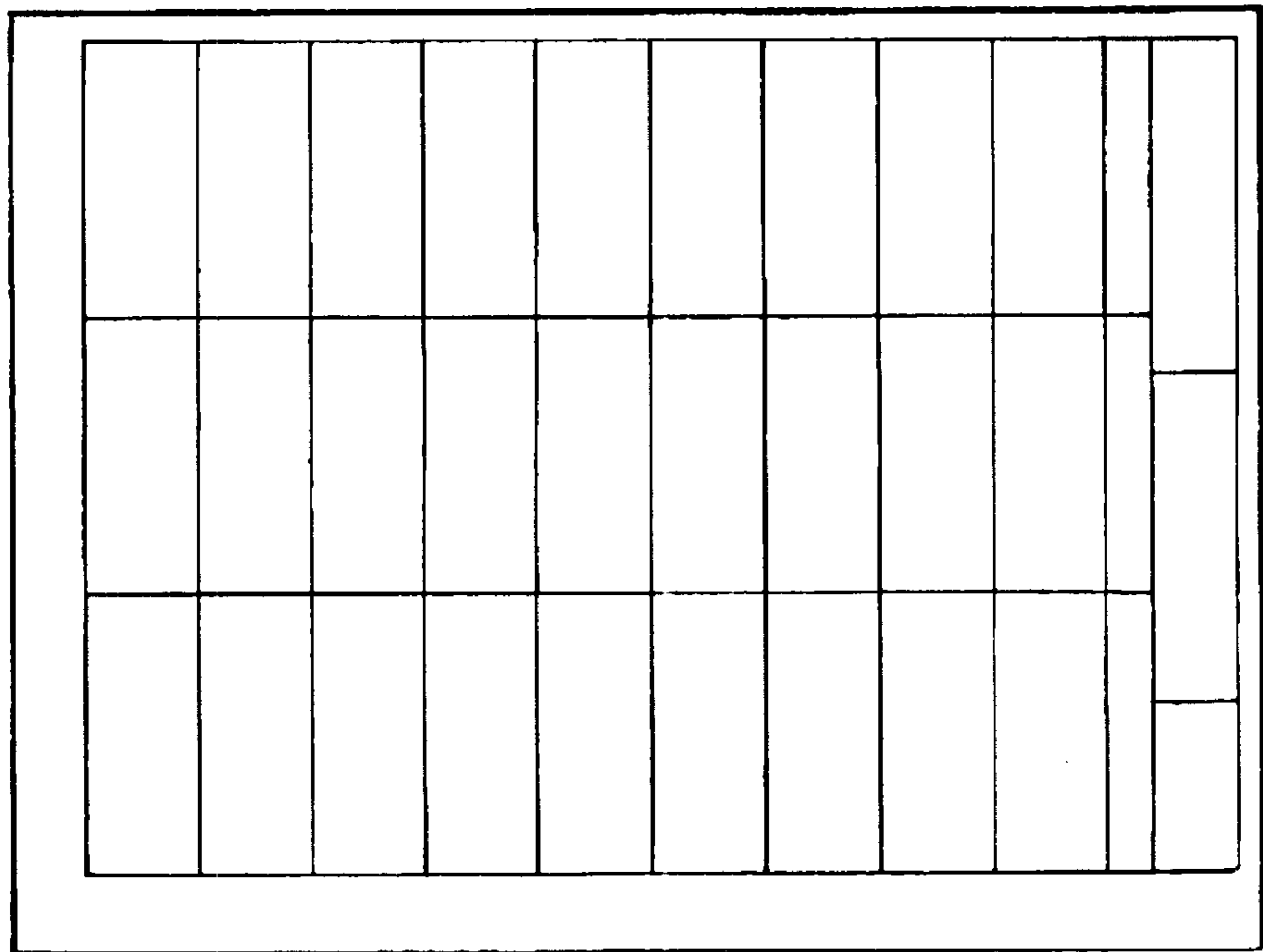

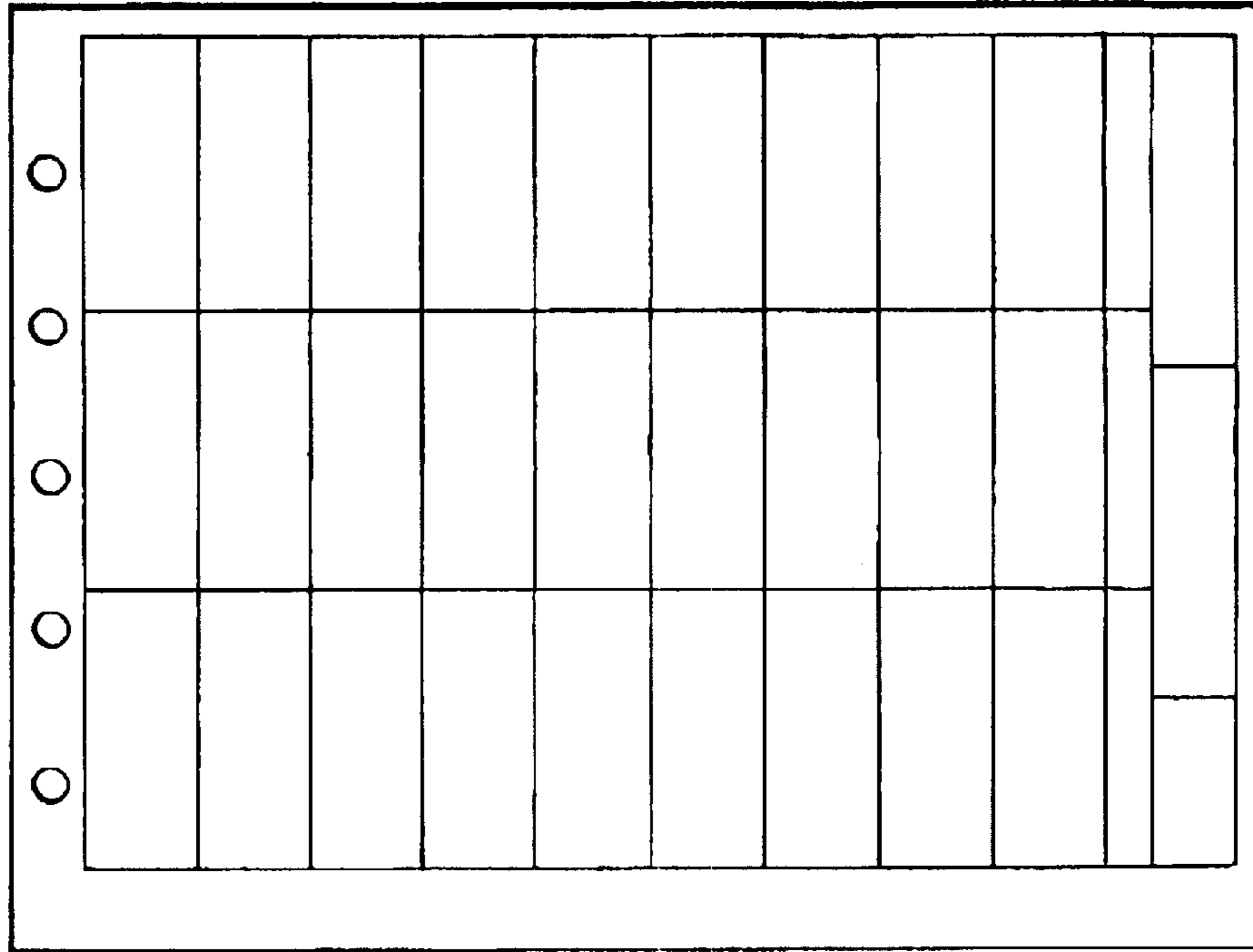
