FIG. 22 is a rear view of the third embodiment of a golf club head in accordance with our new design.

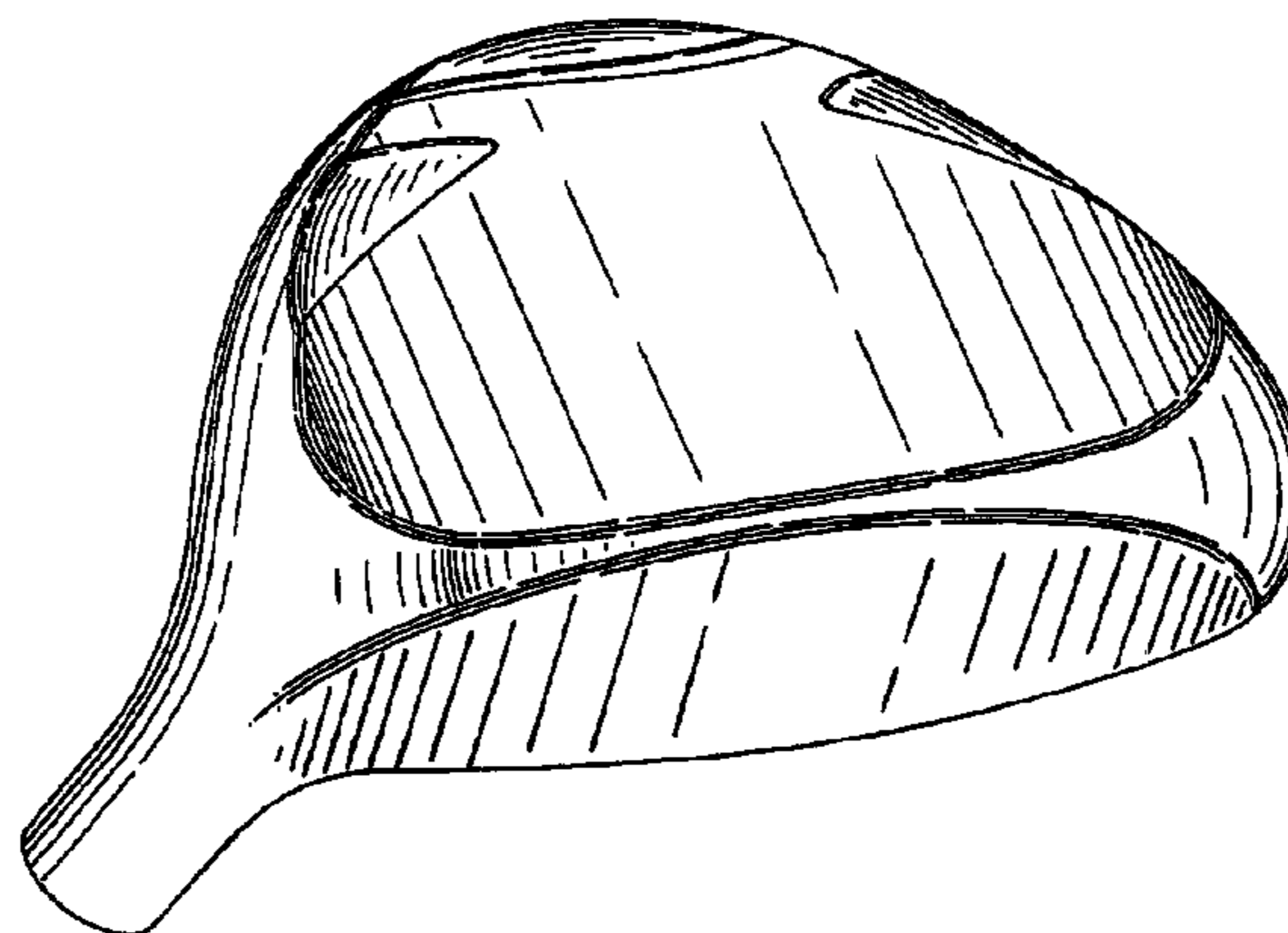


FIG. **23** is a left-side view of the third embodiment of a golf club head in accordance with our new design.

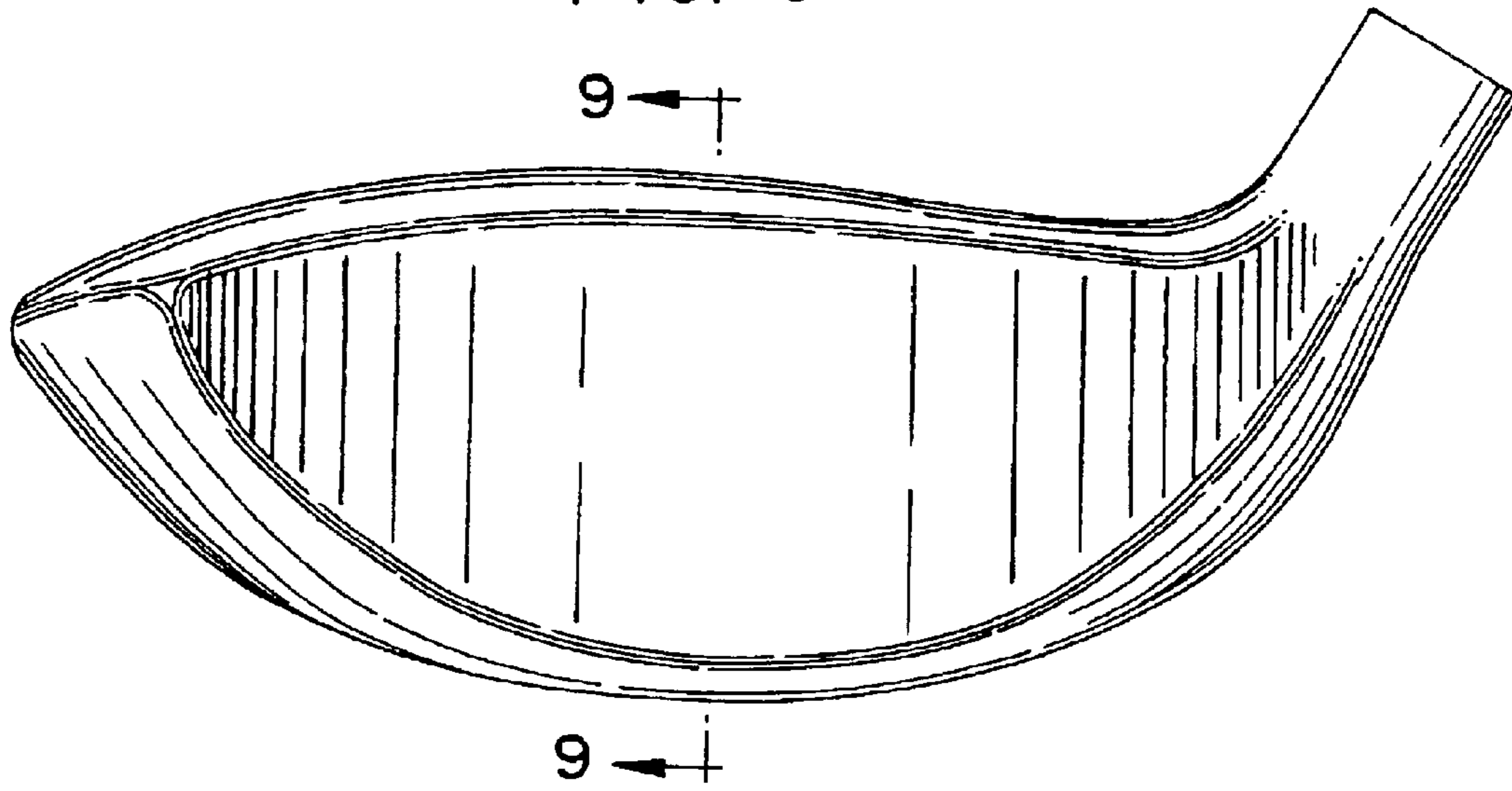

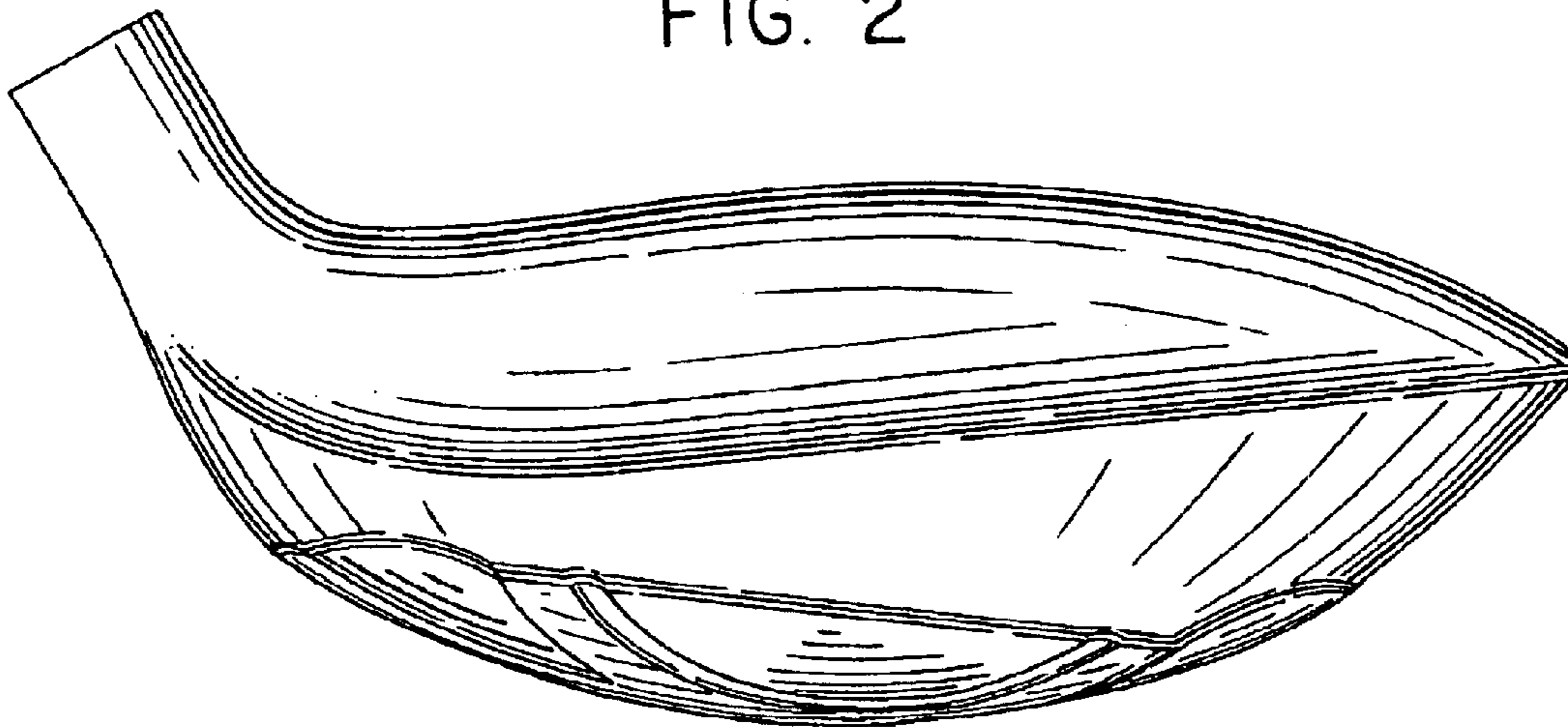

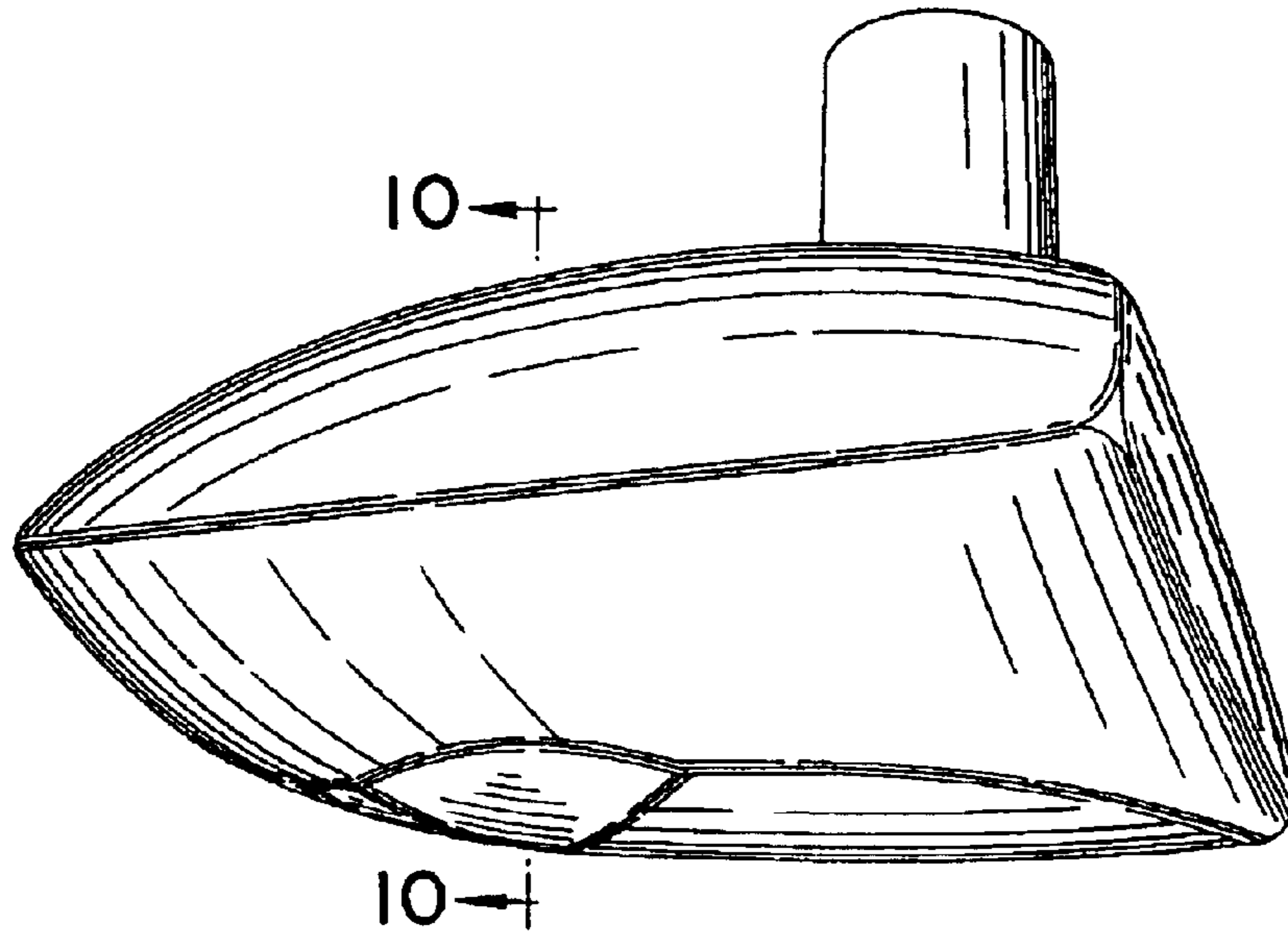

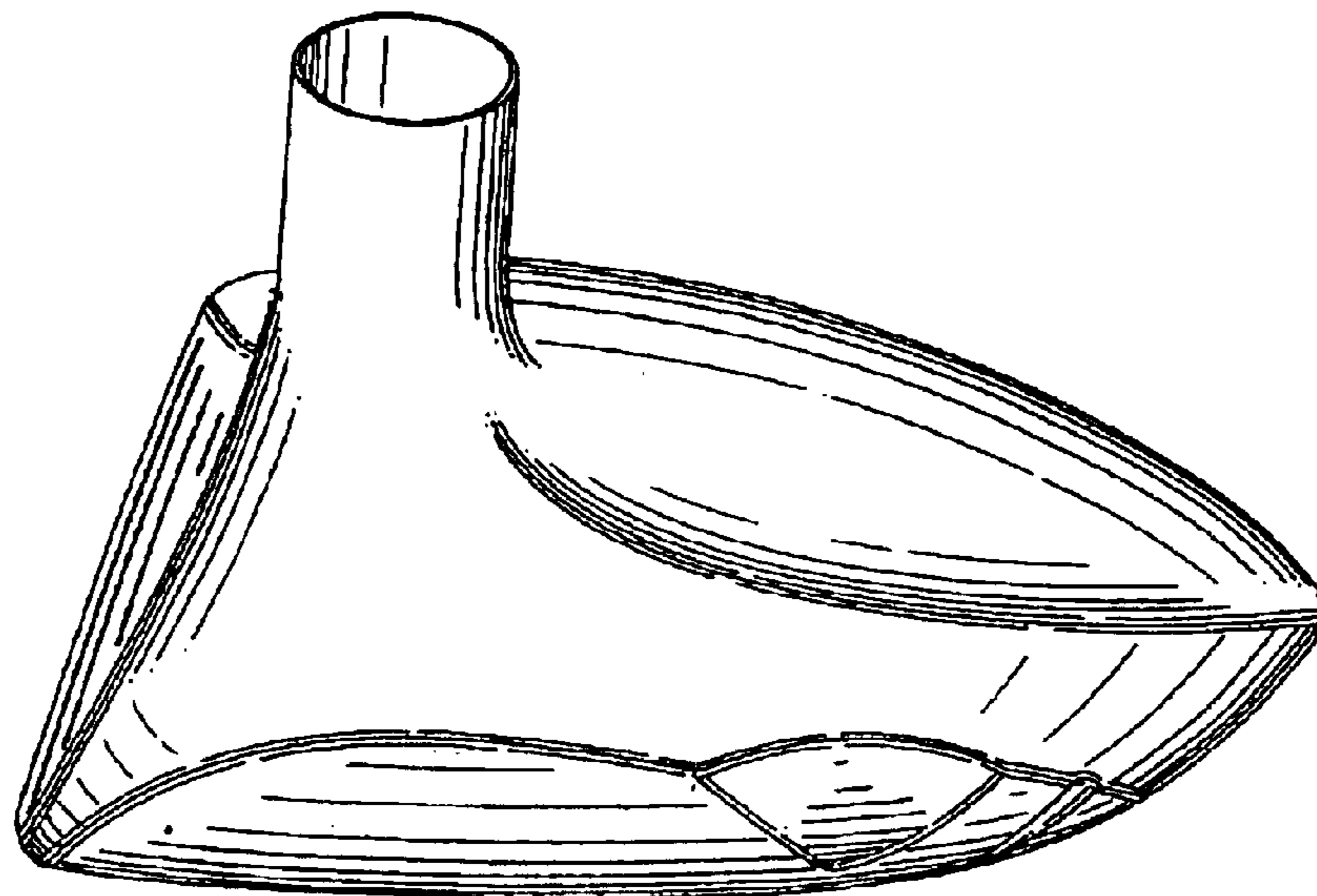

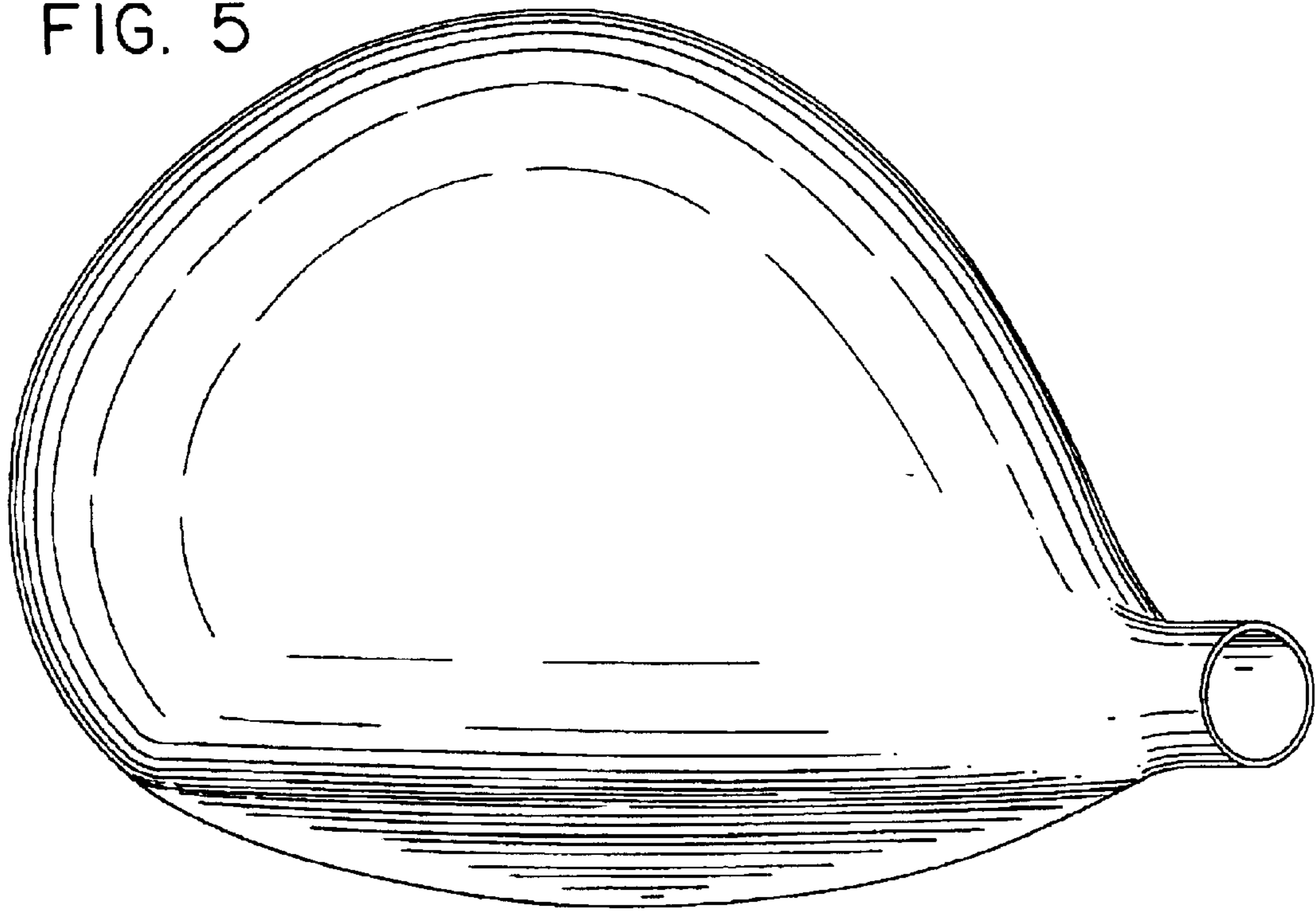

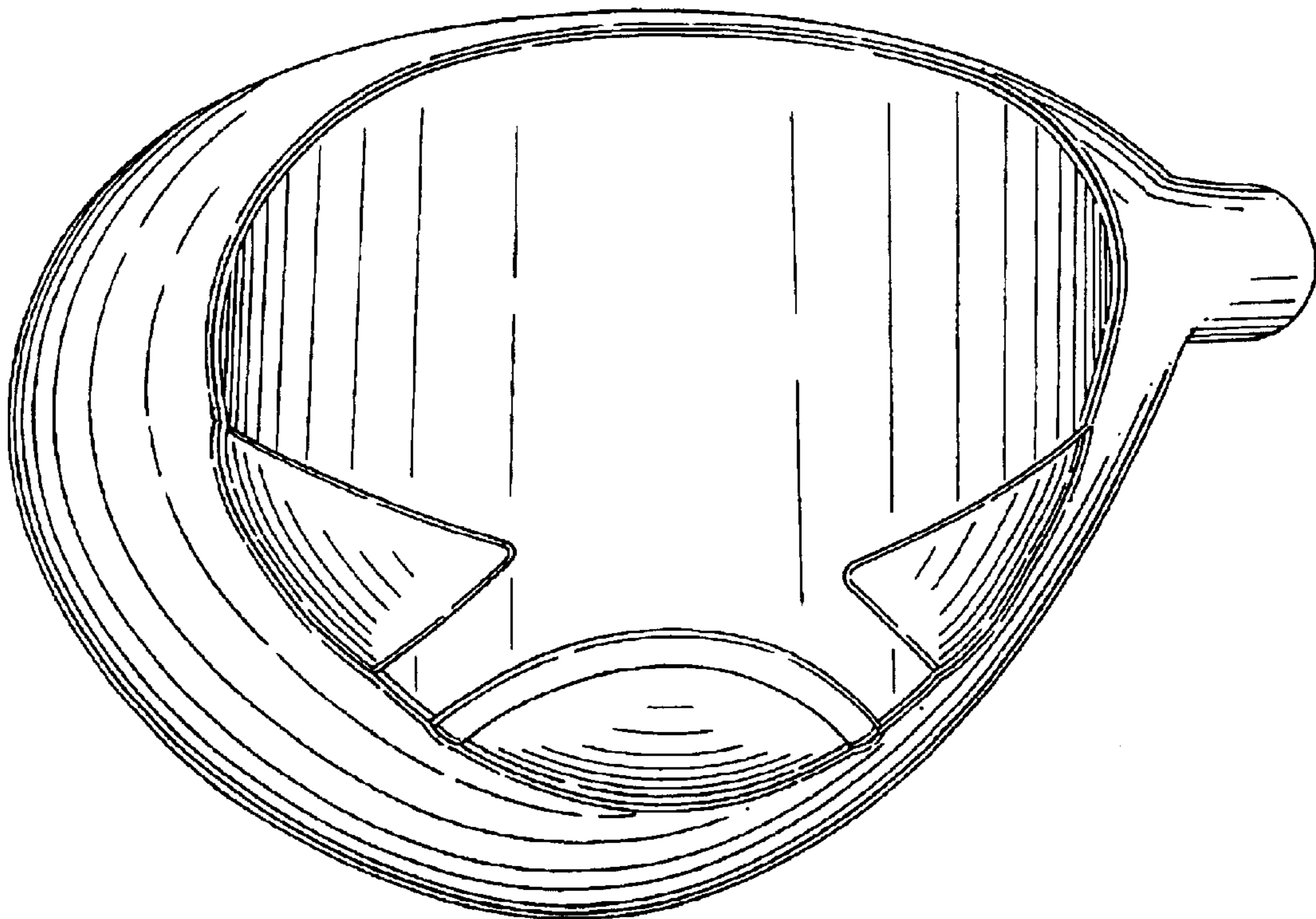

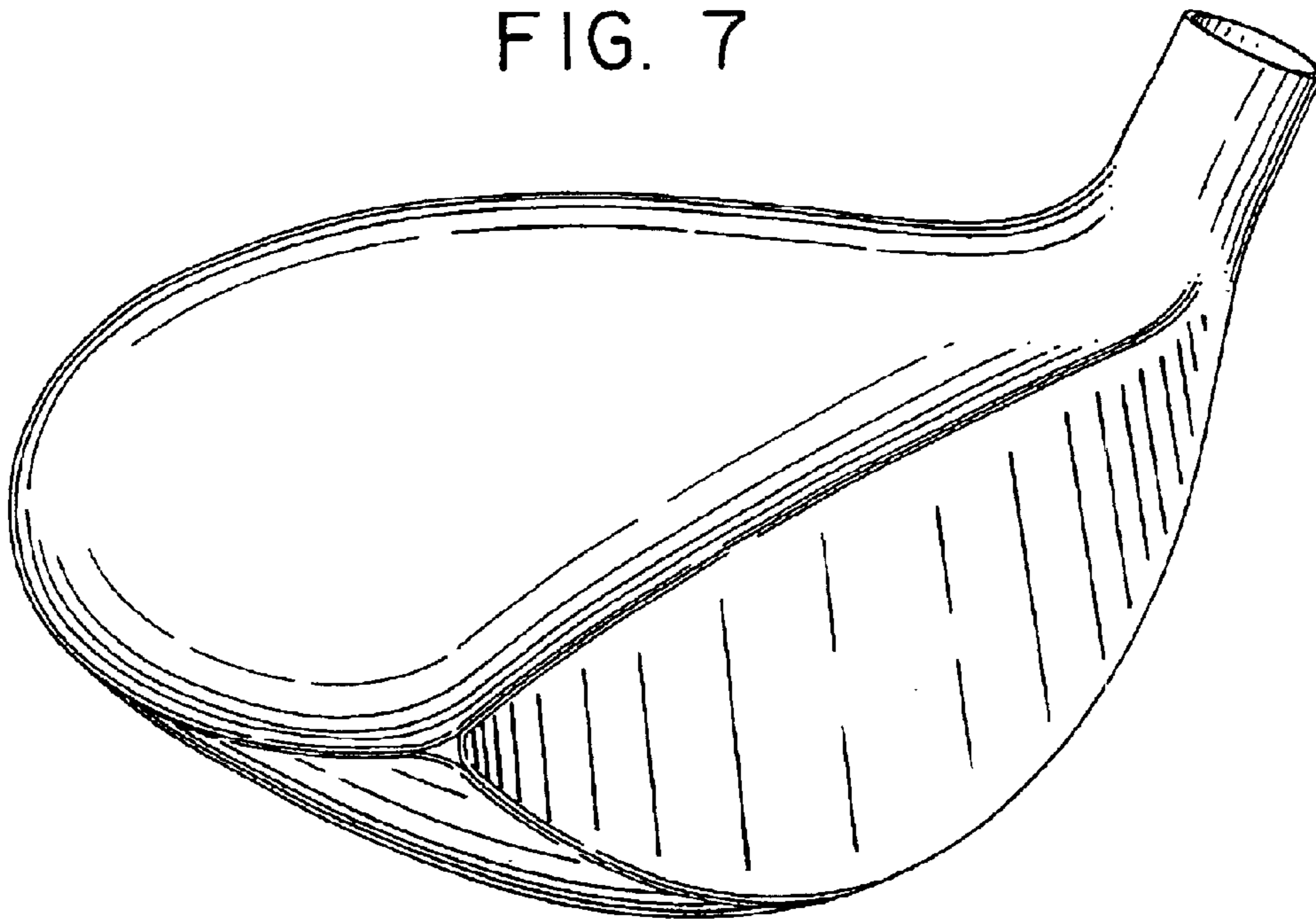

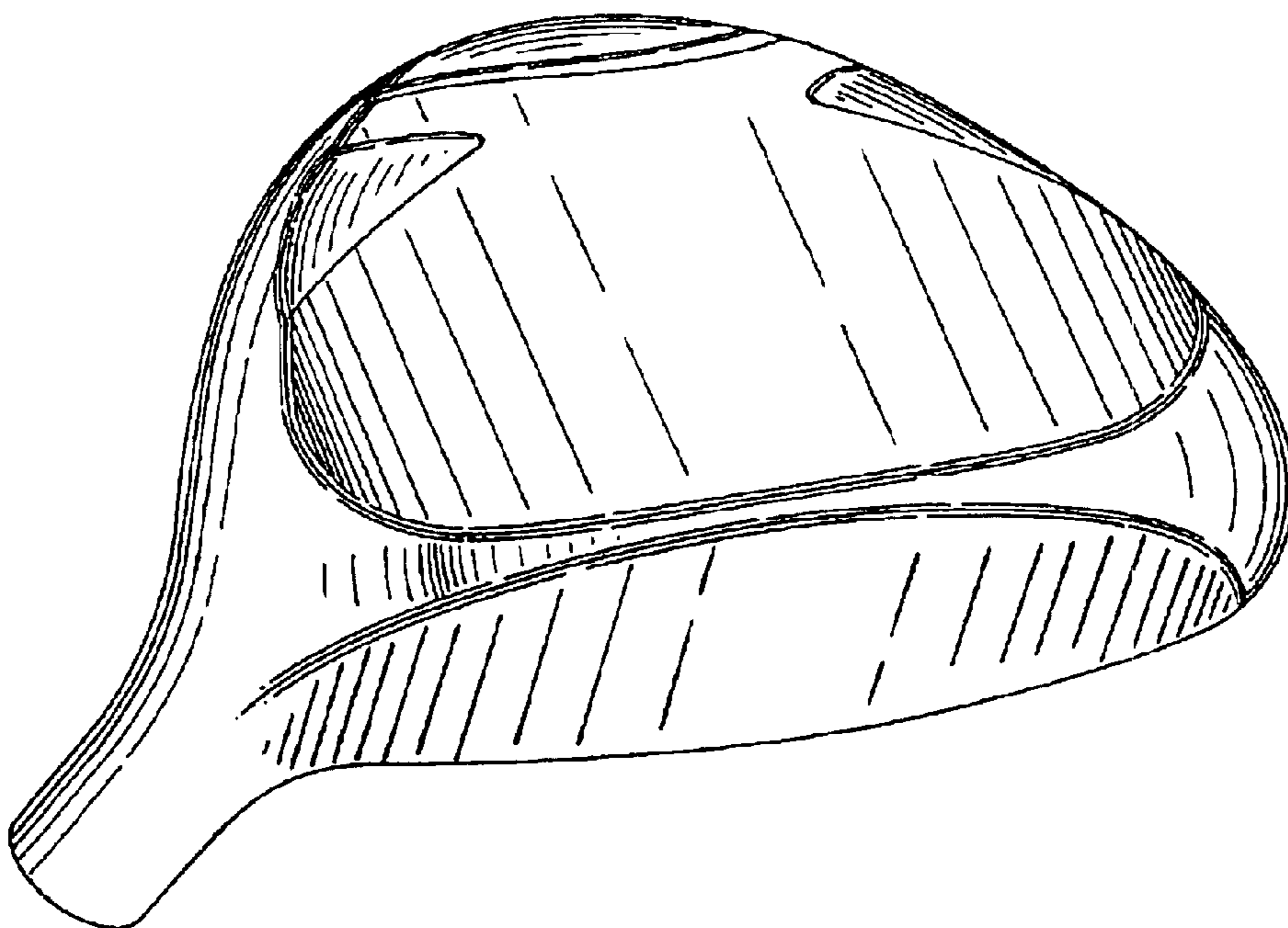

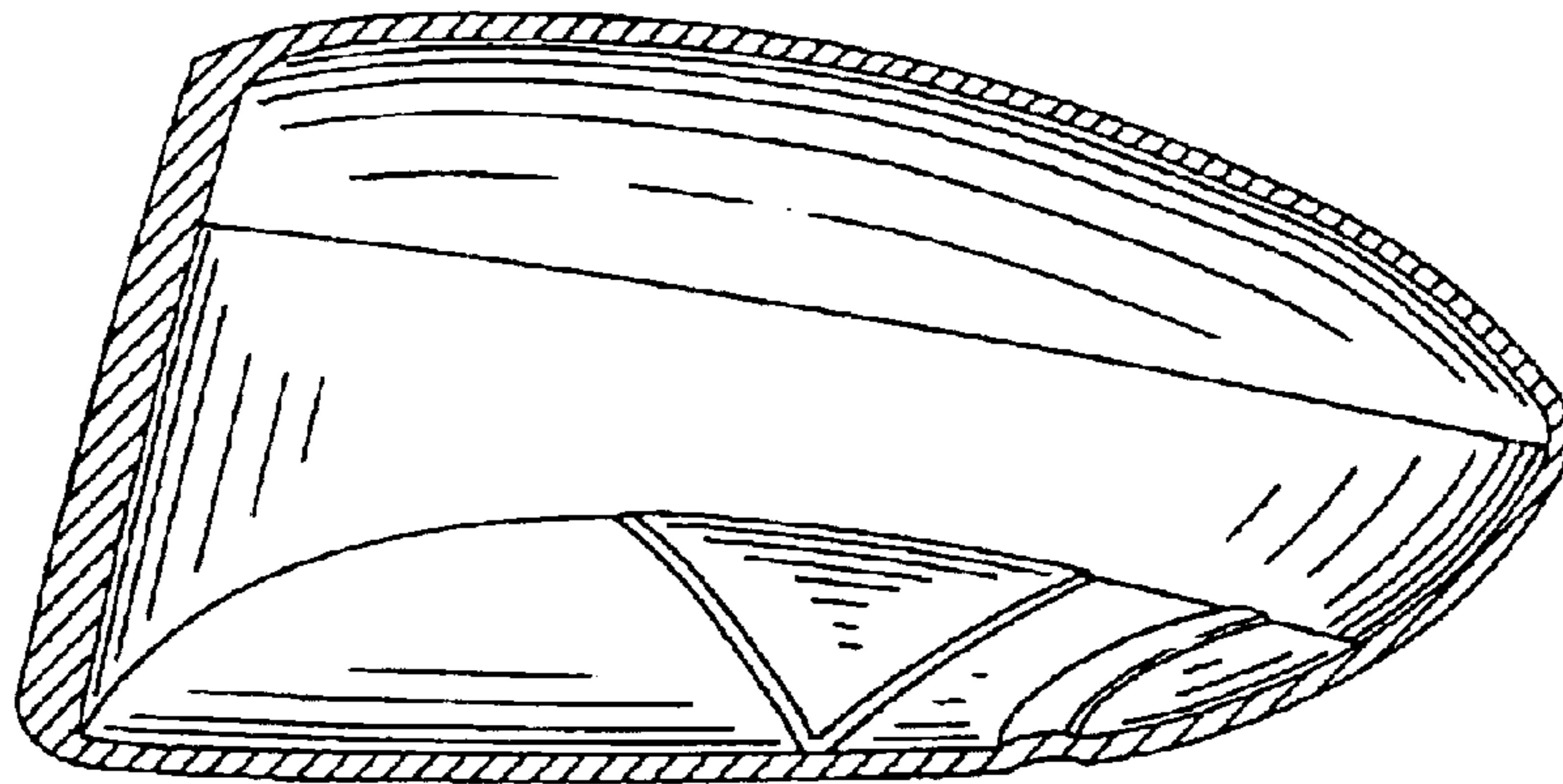

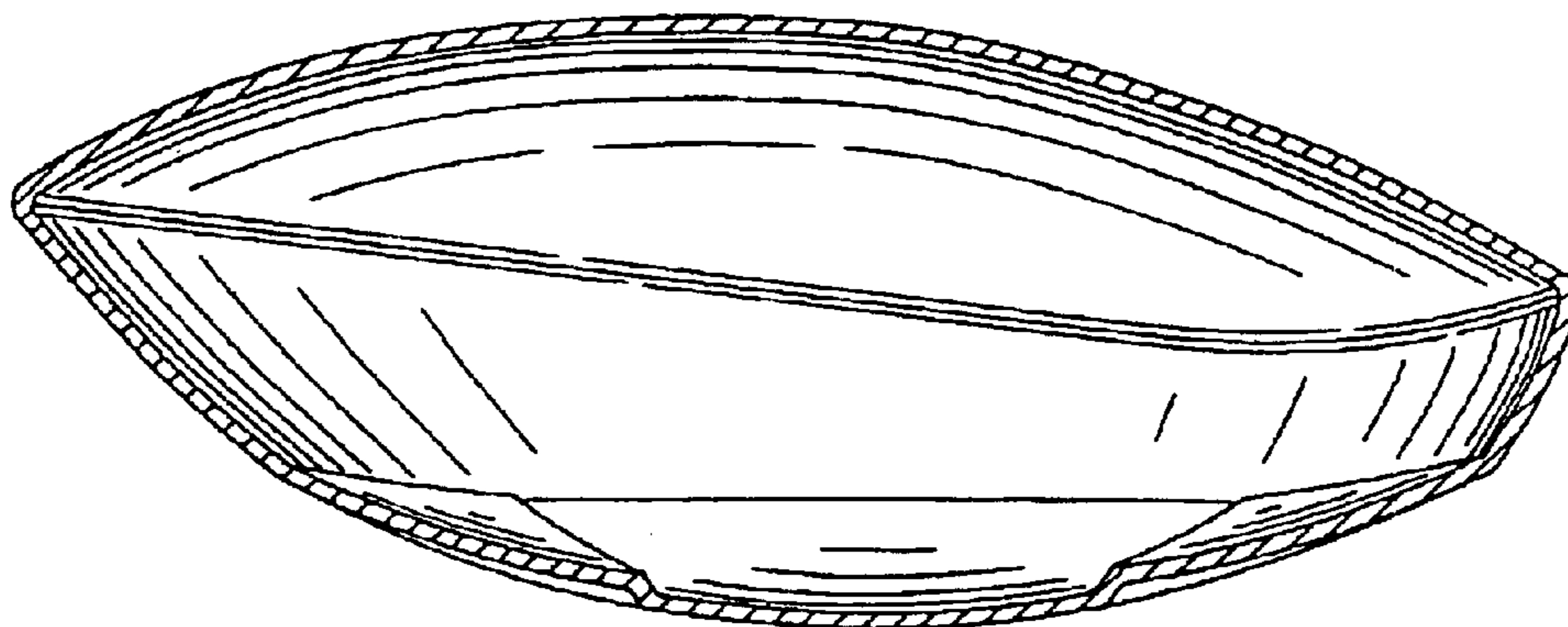

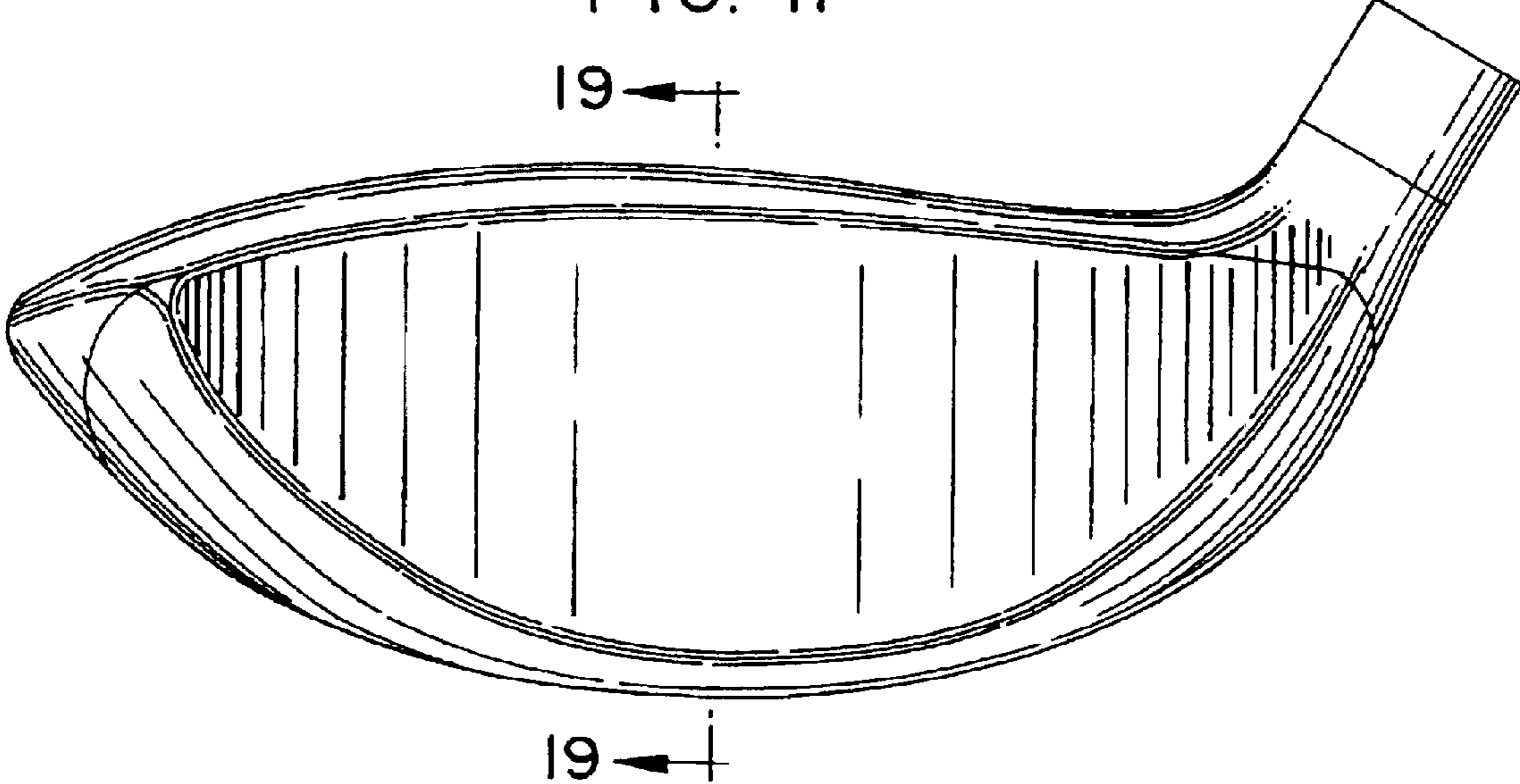

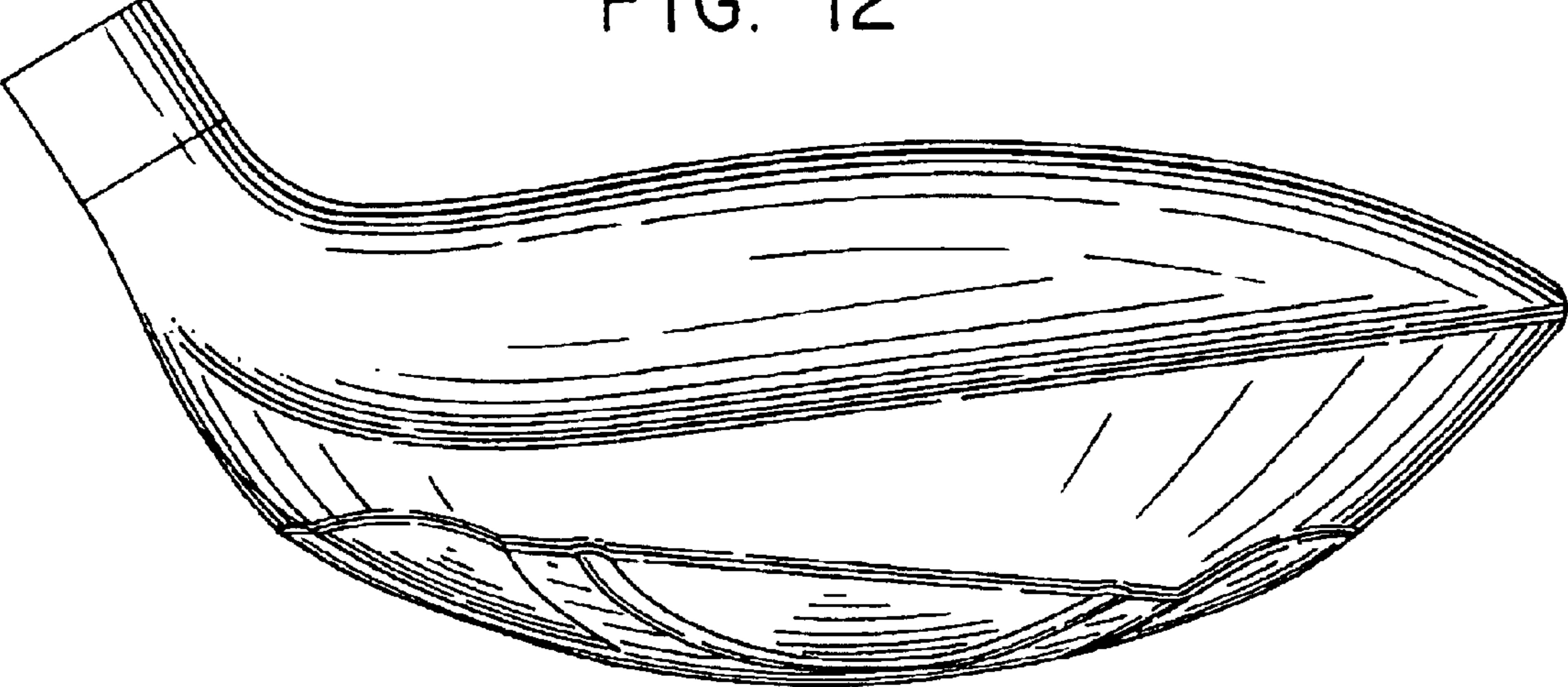

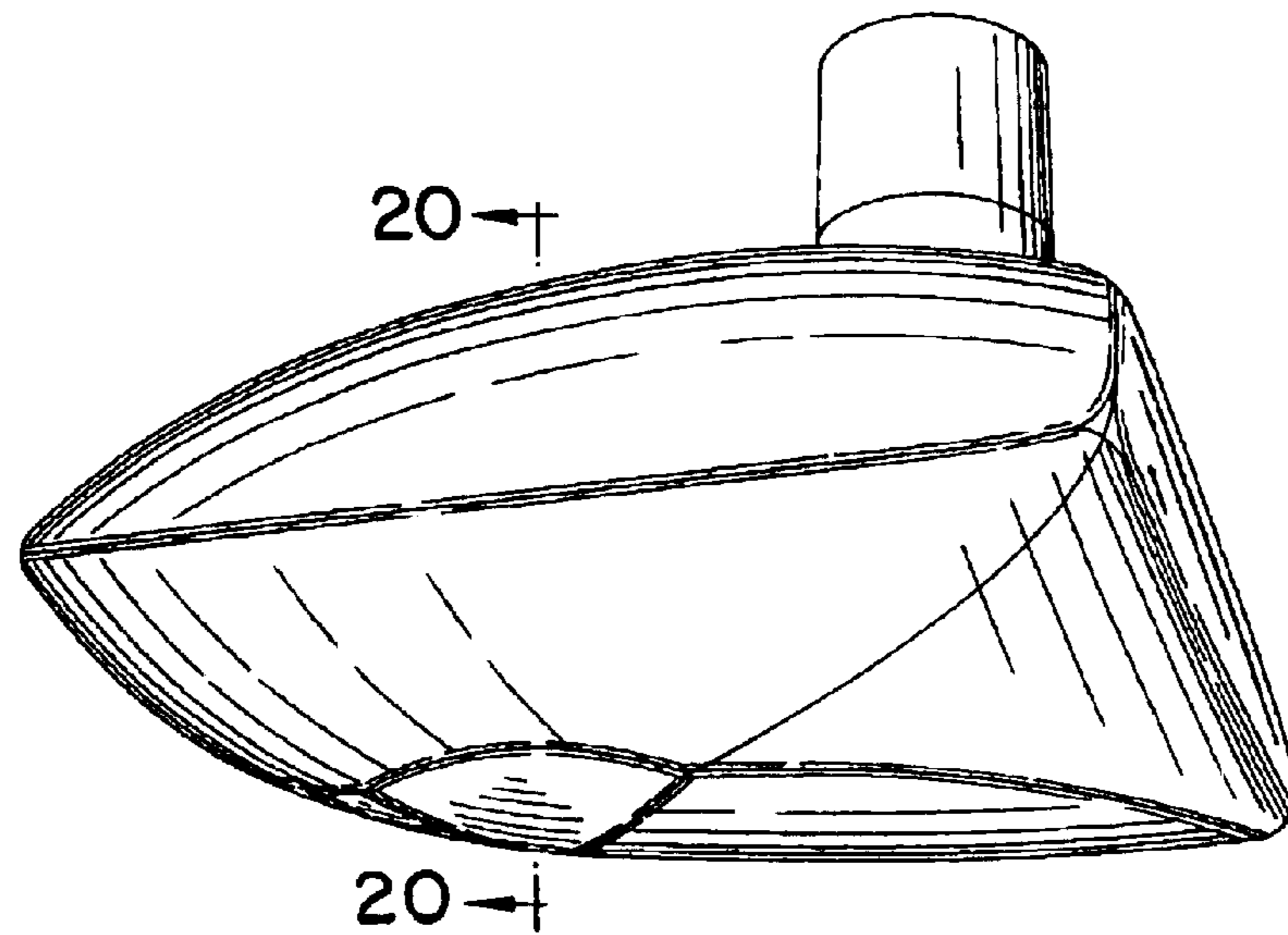

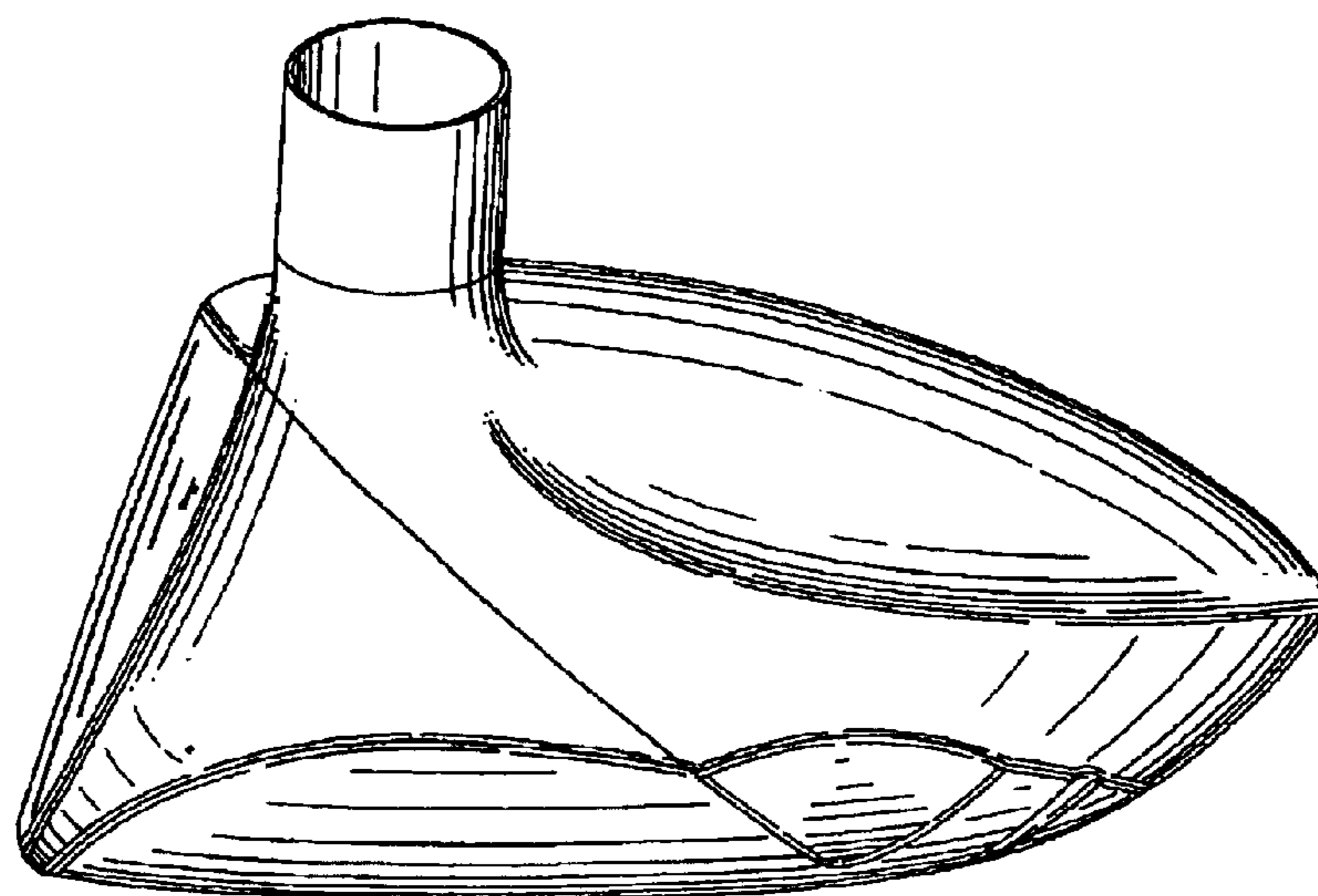

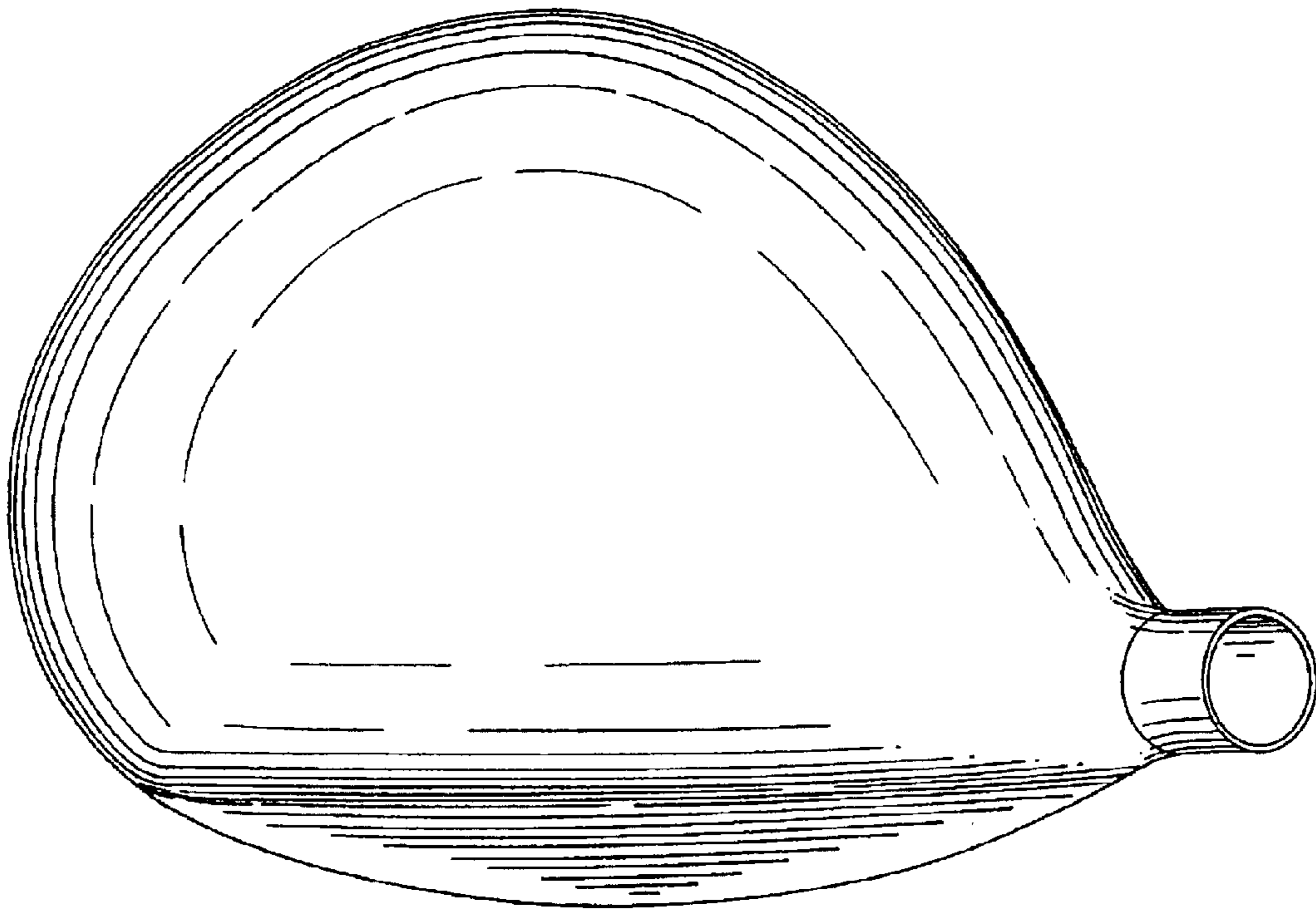

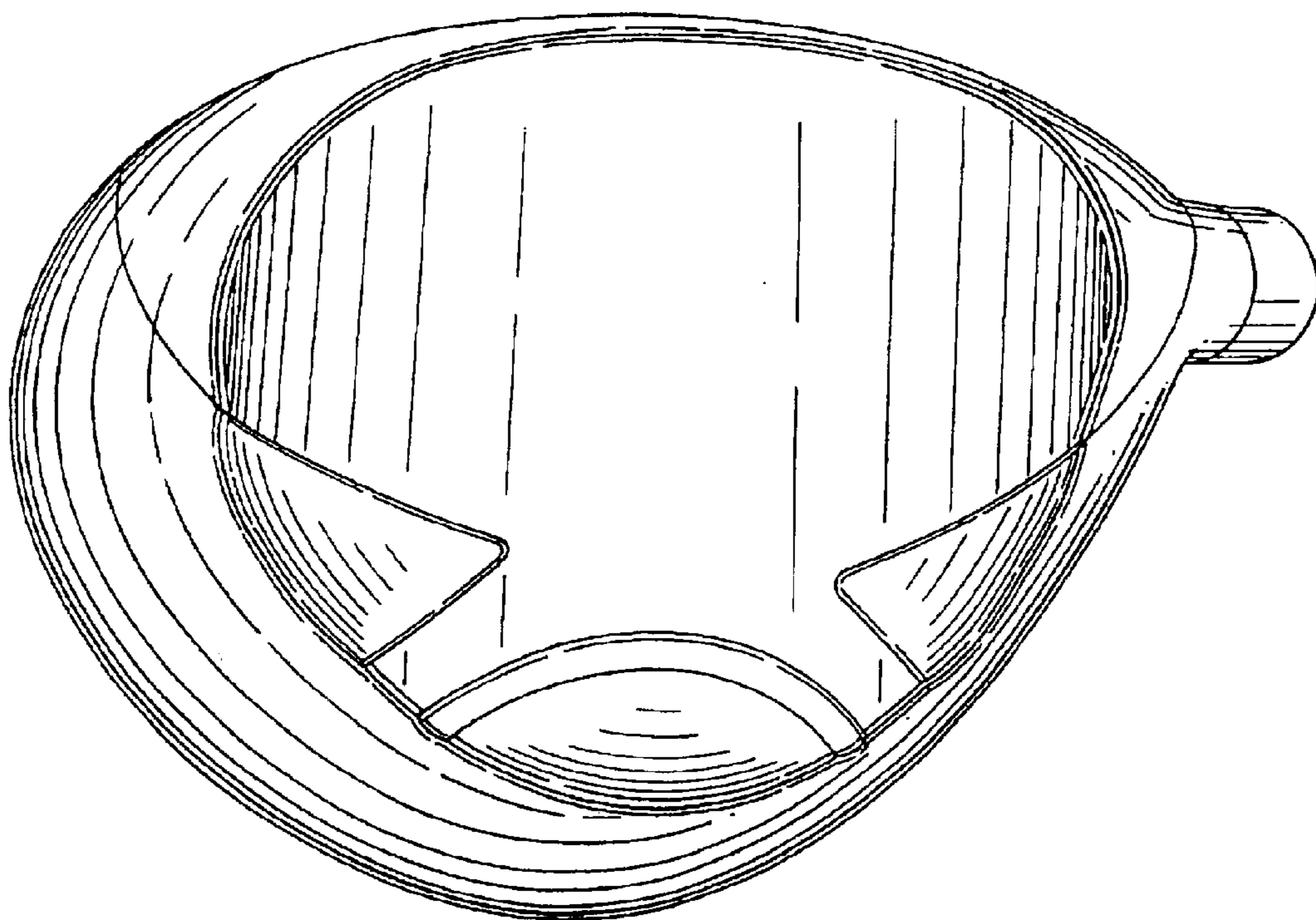

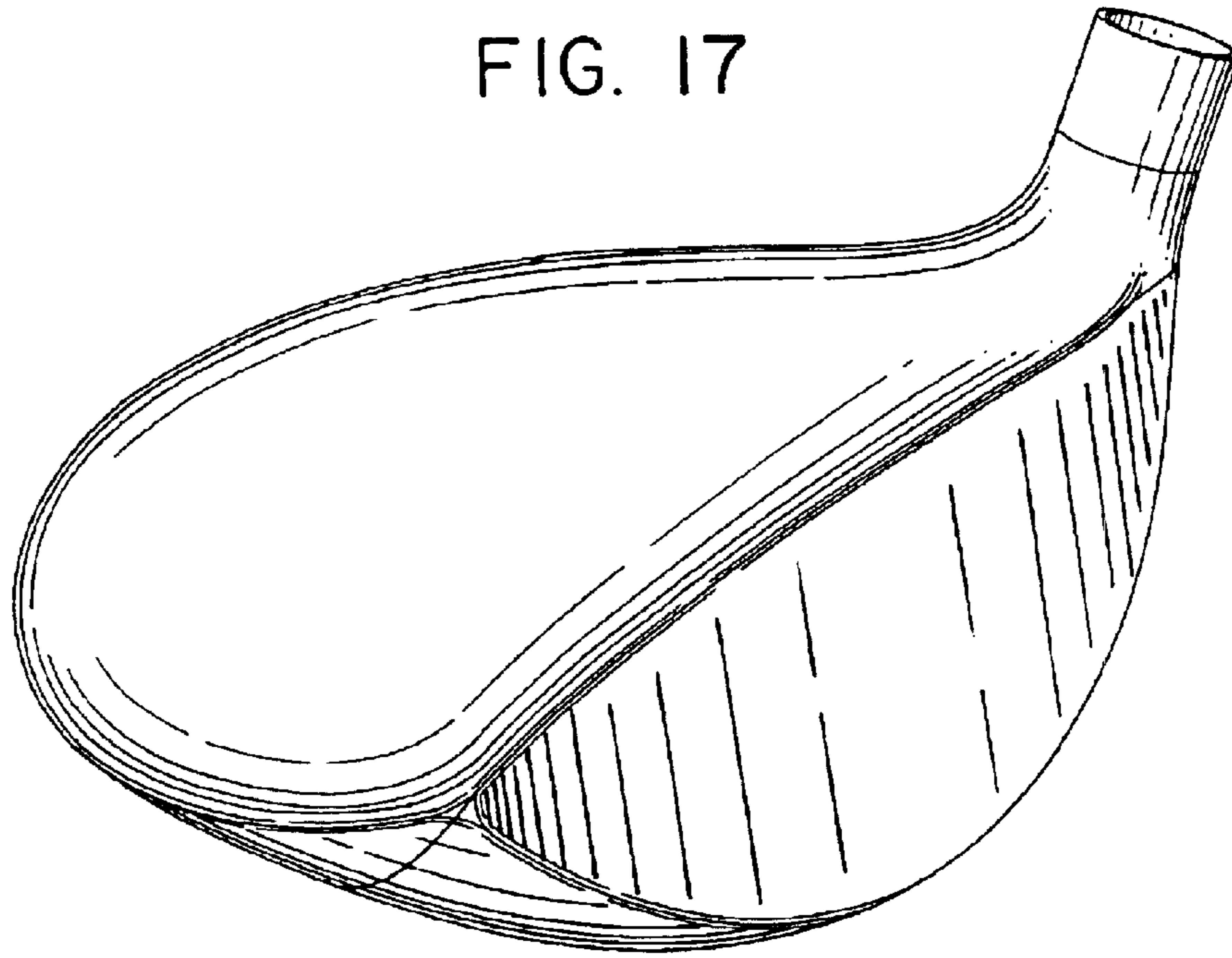

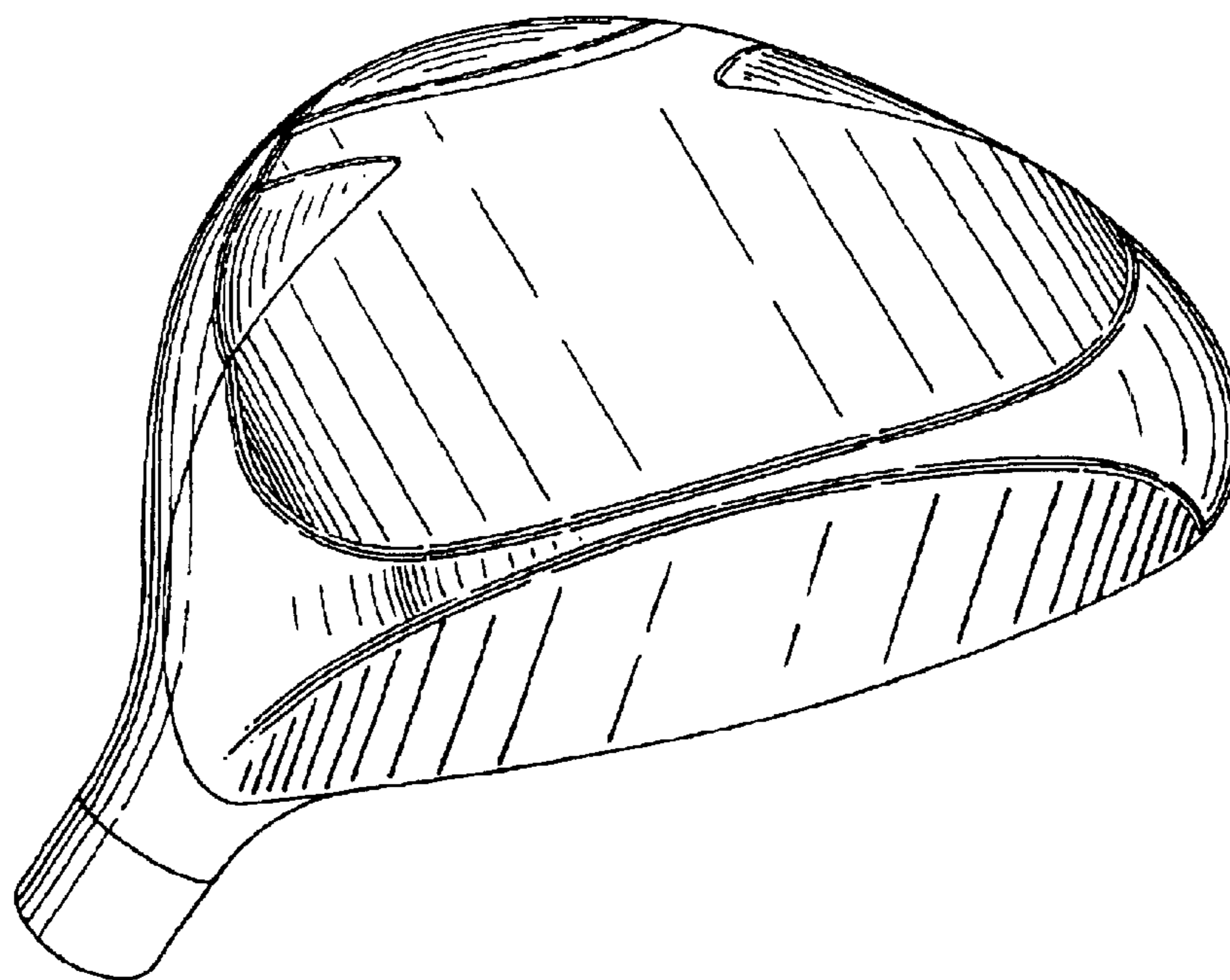

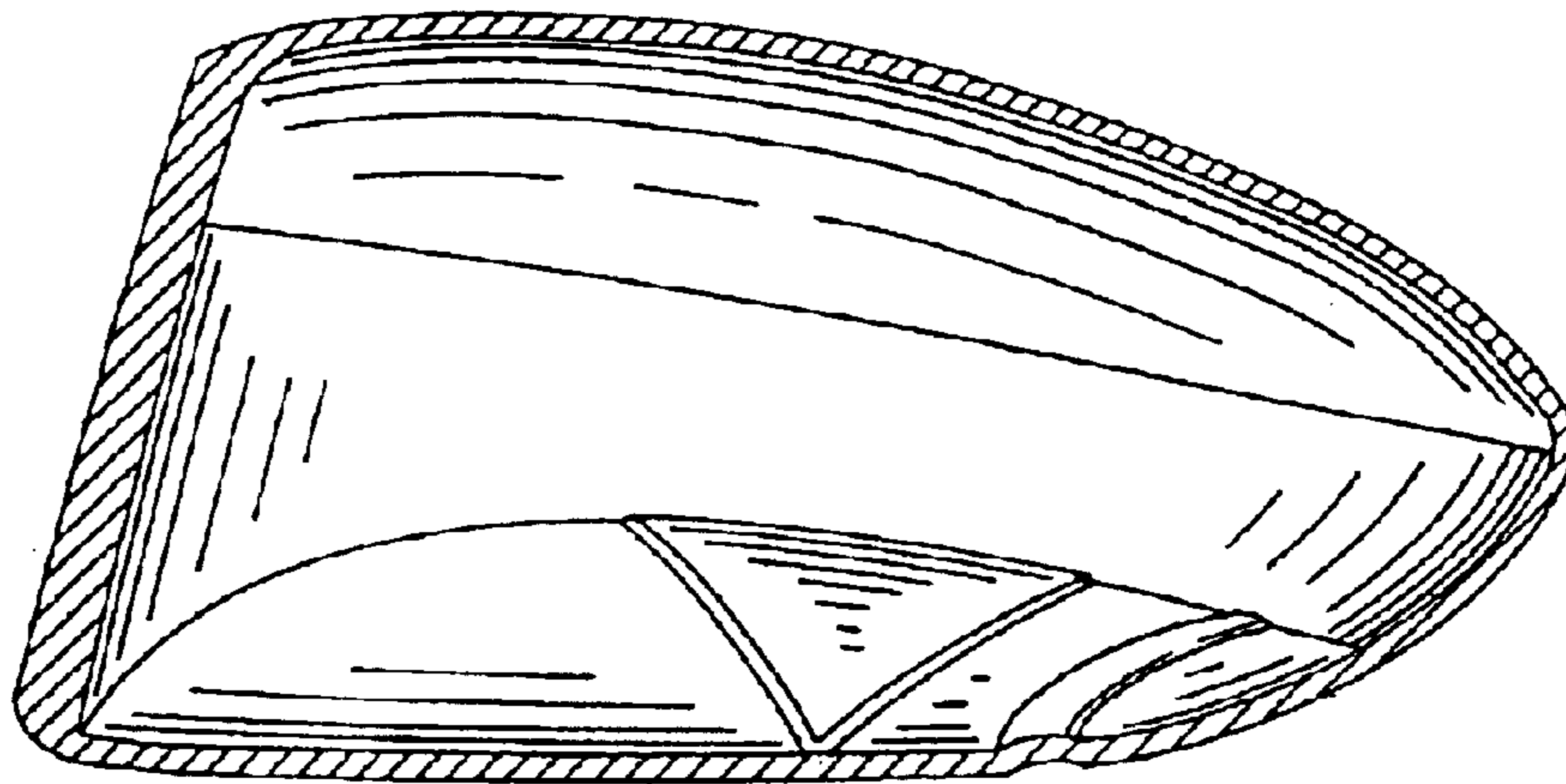

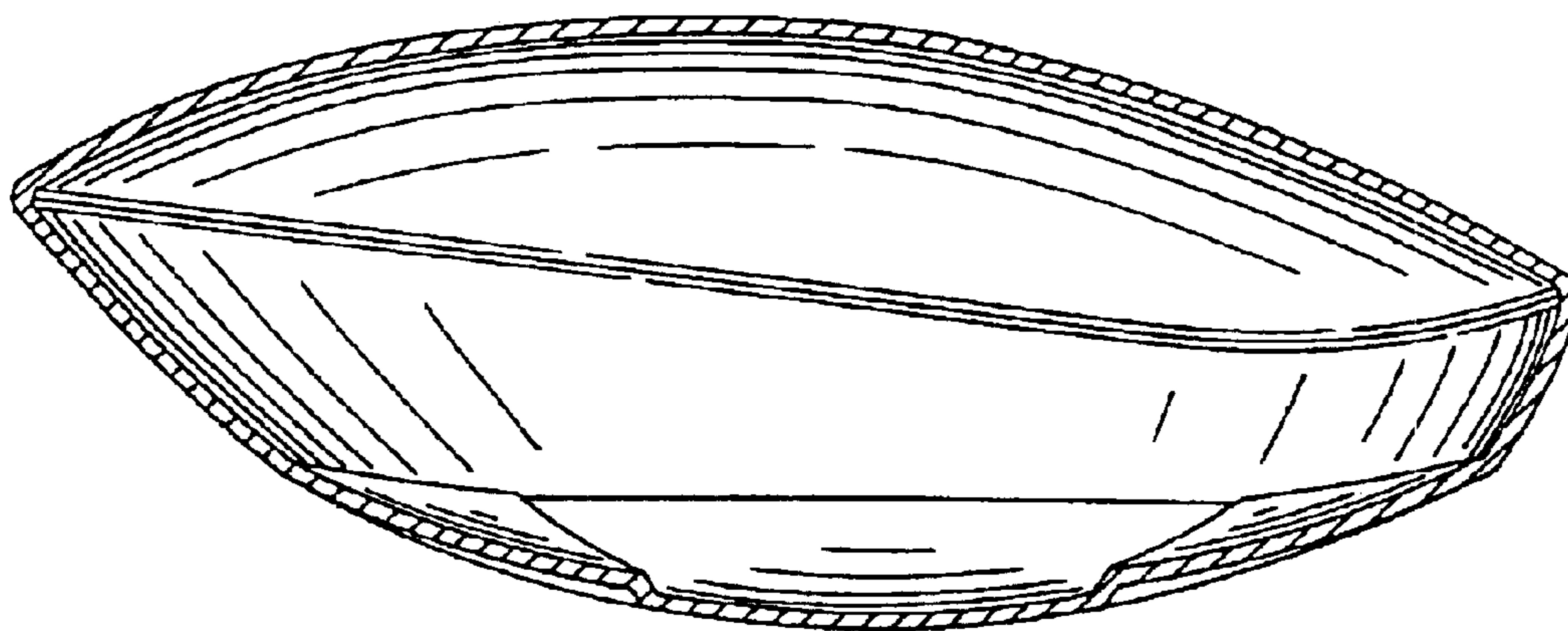

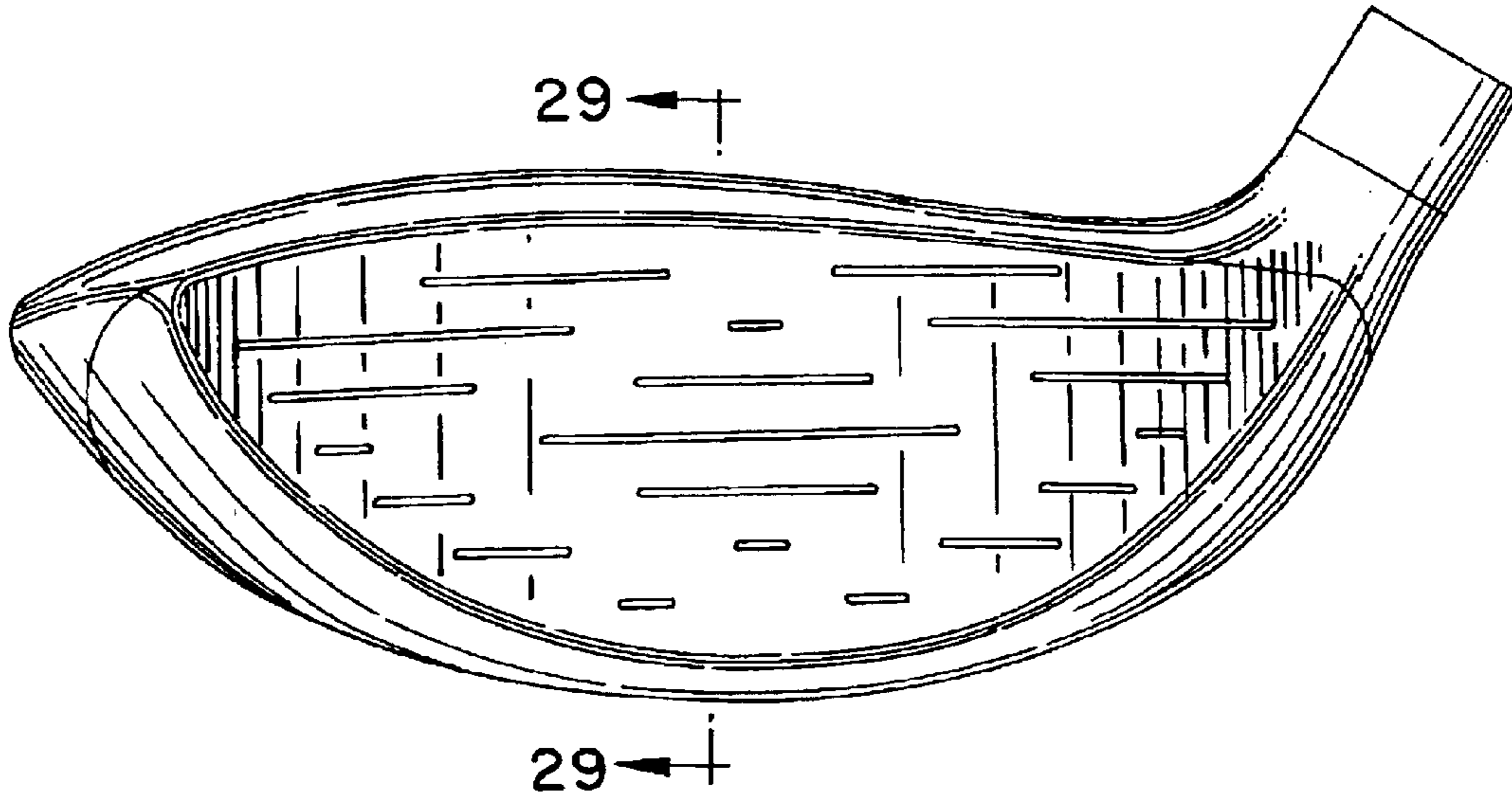

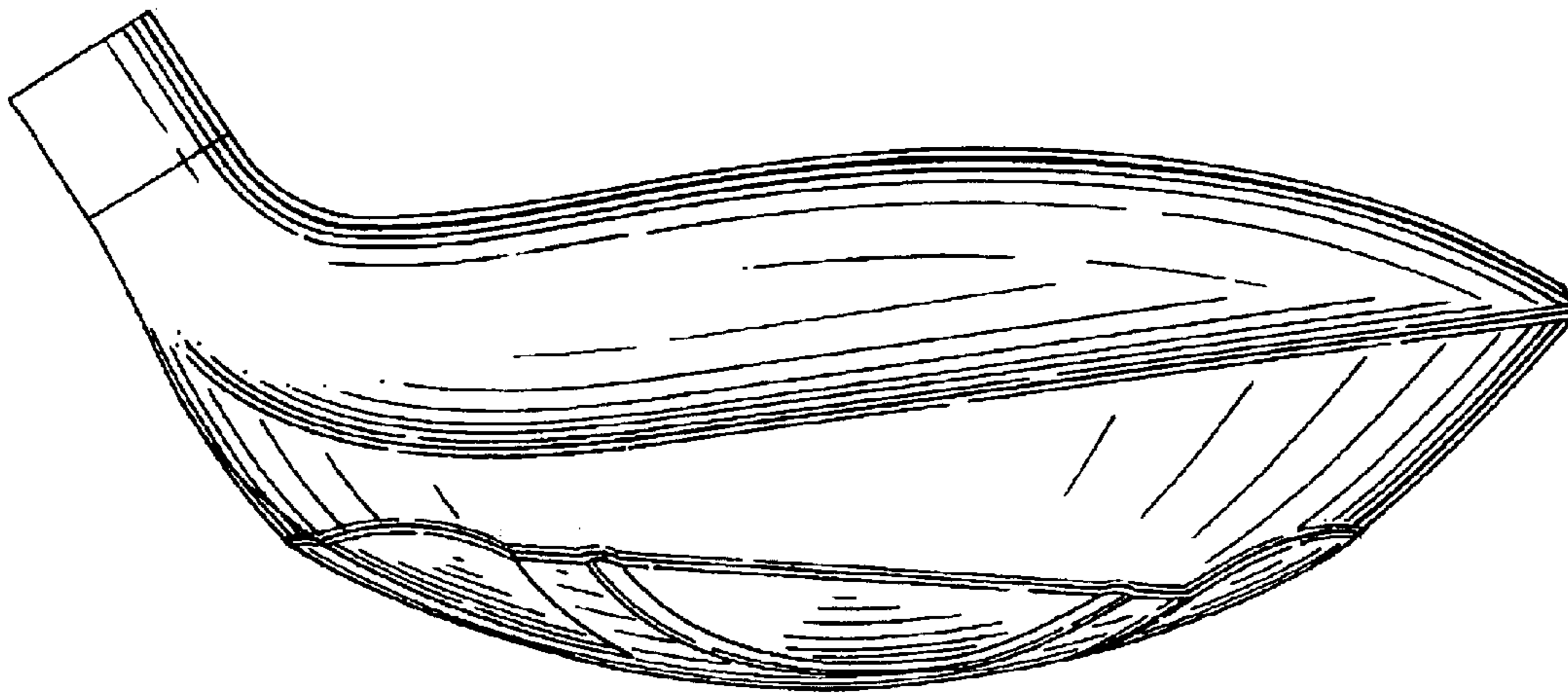

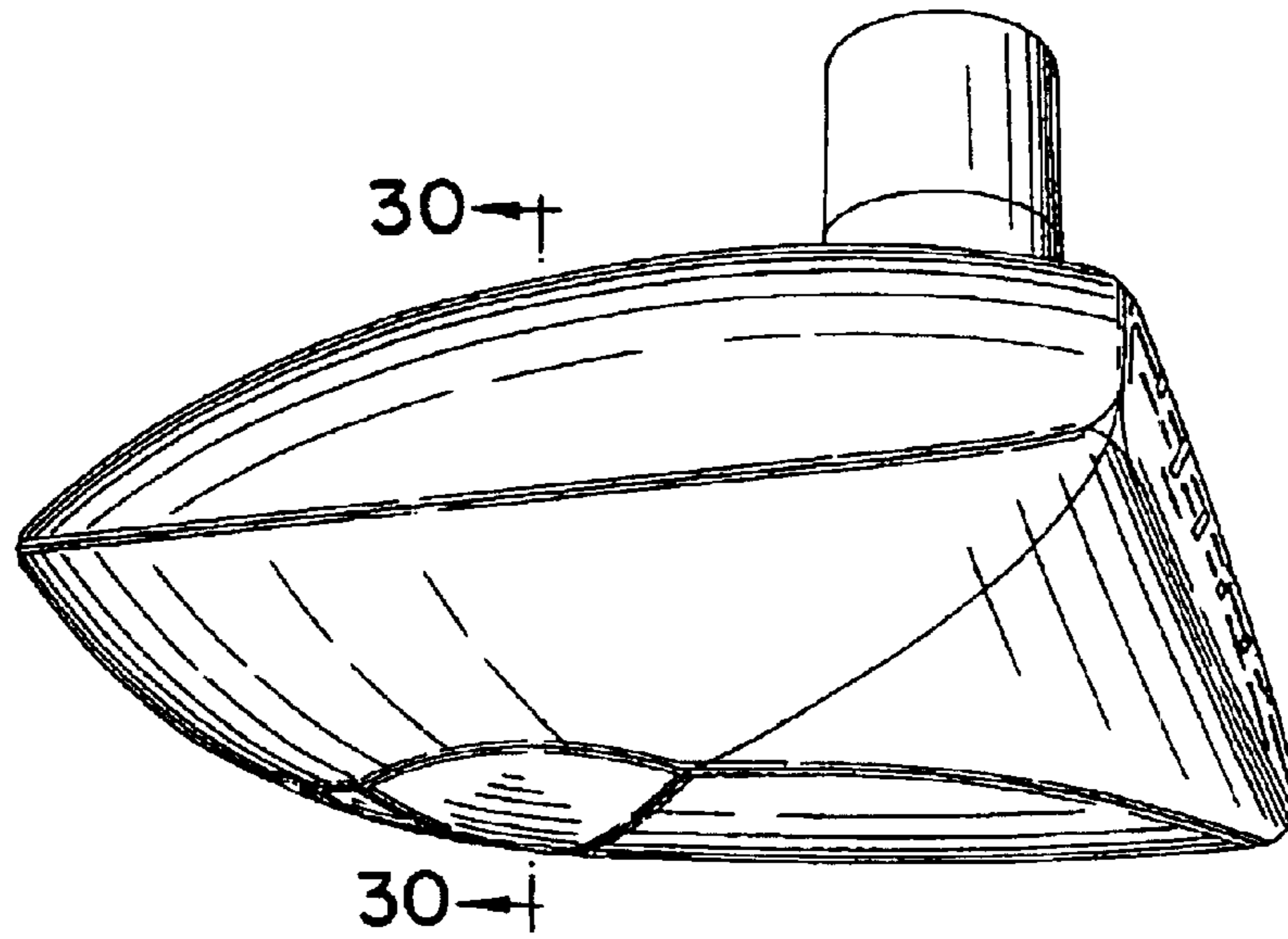

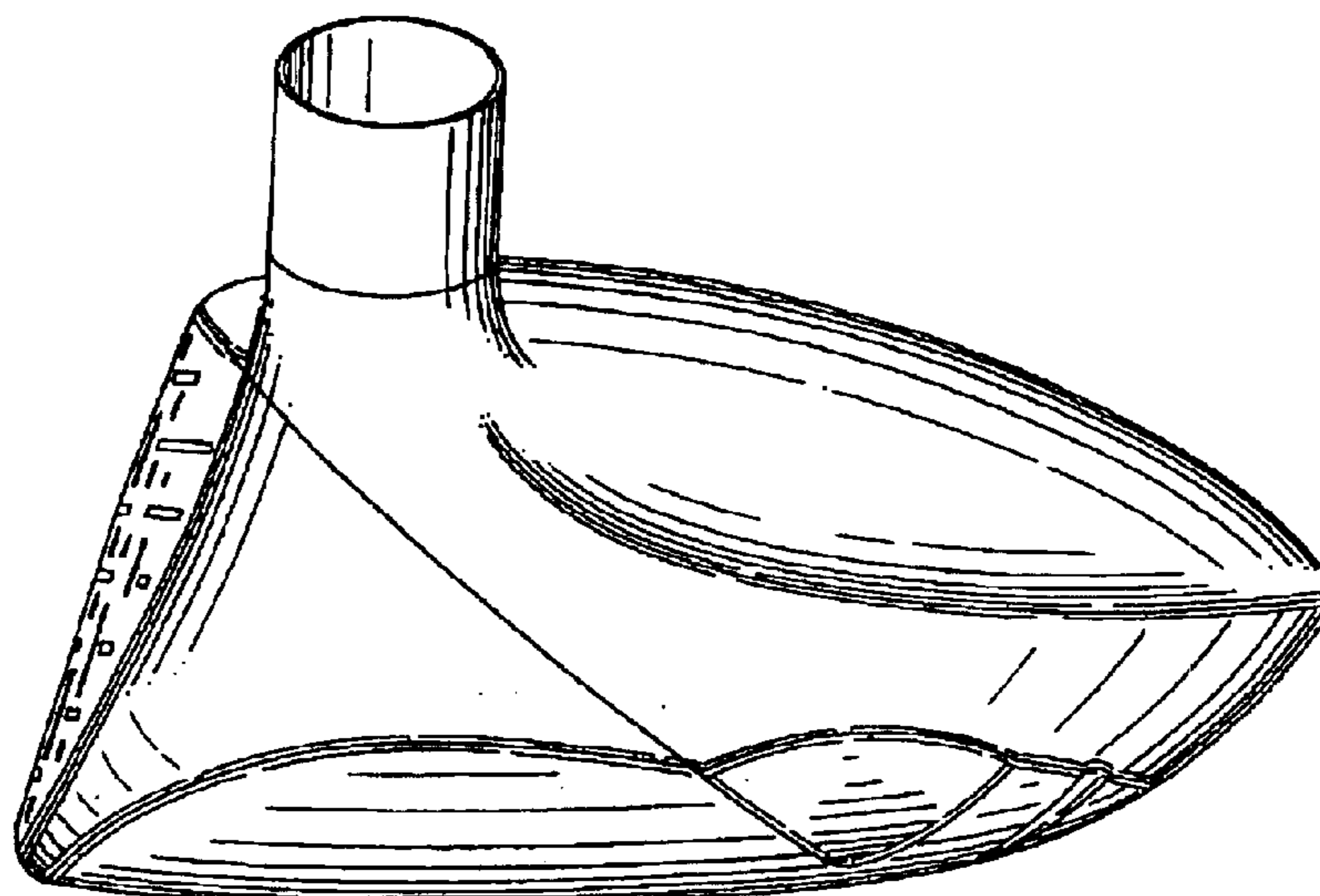

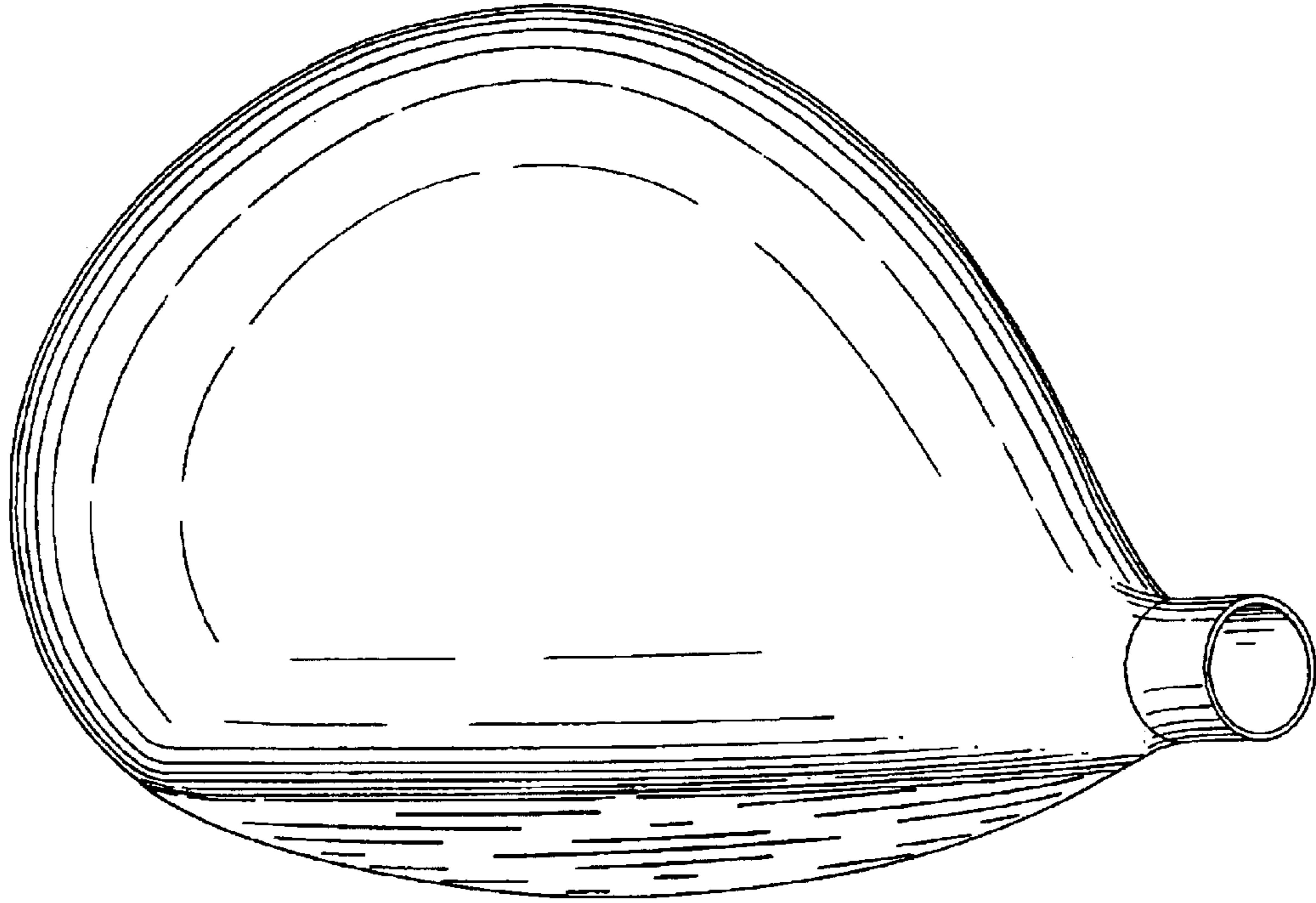

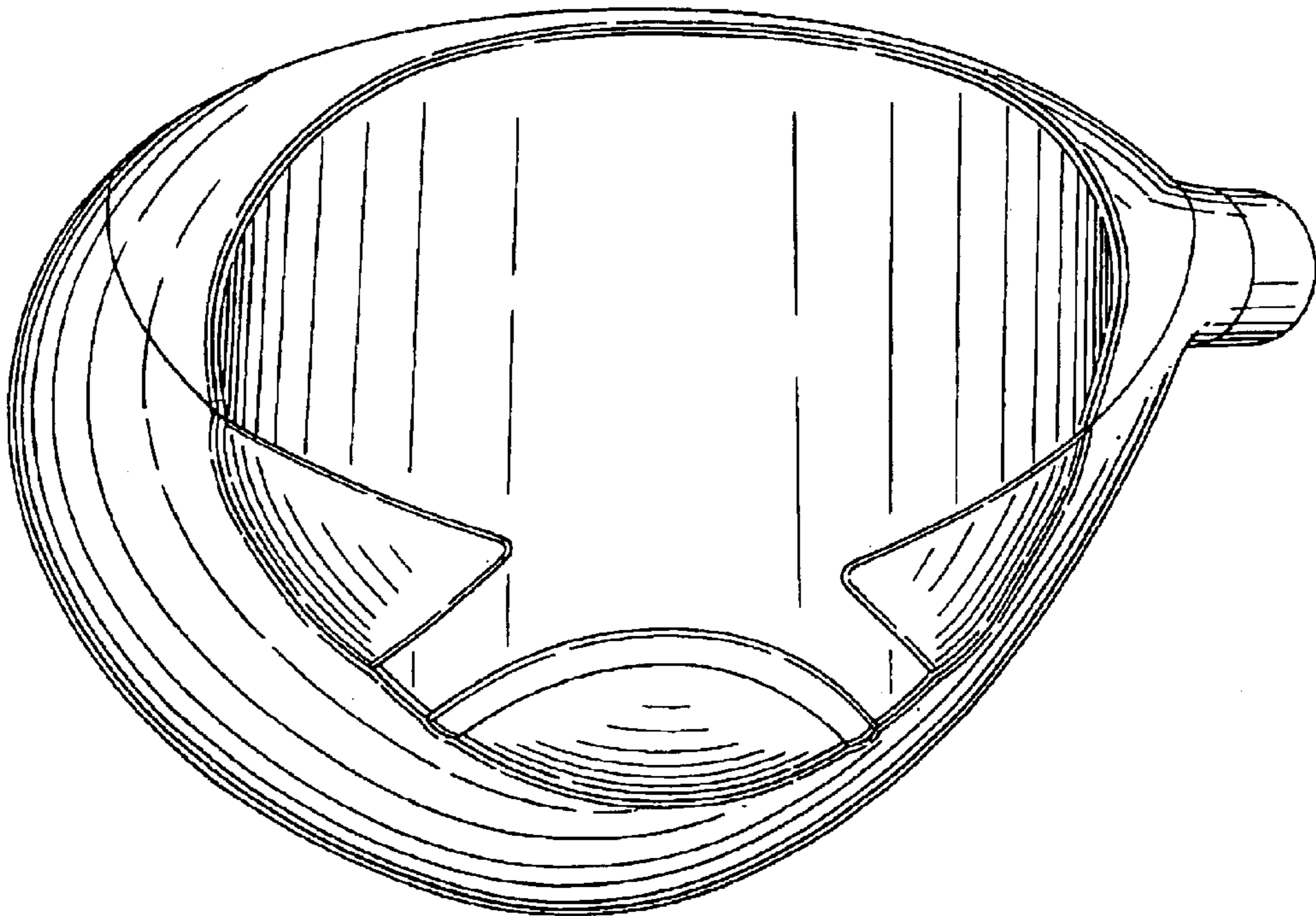

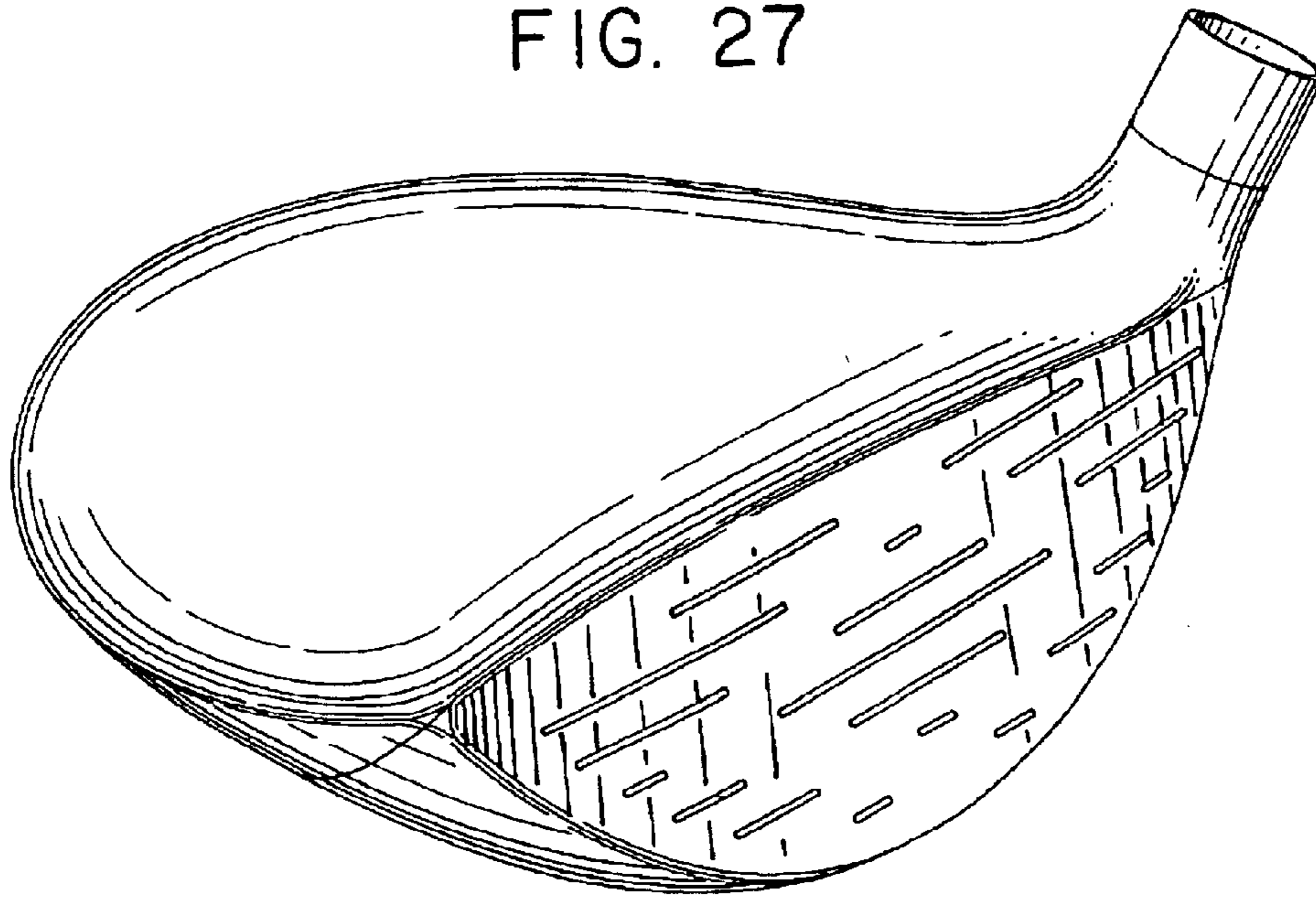

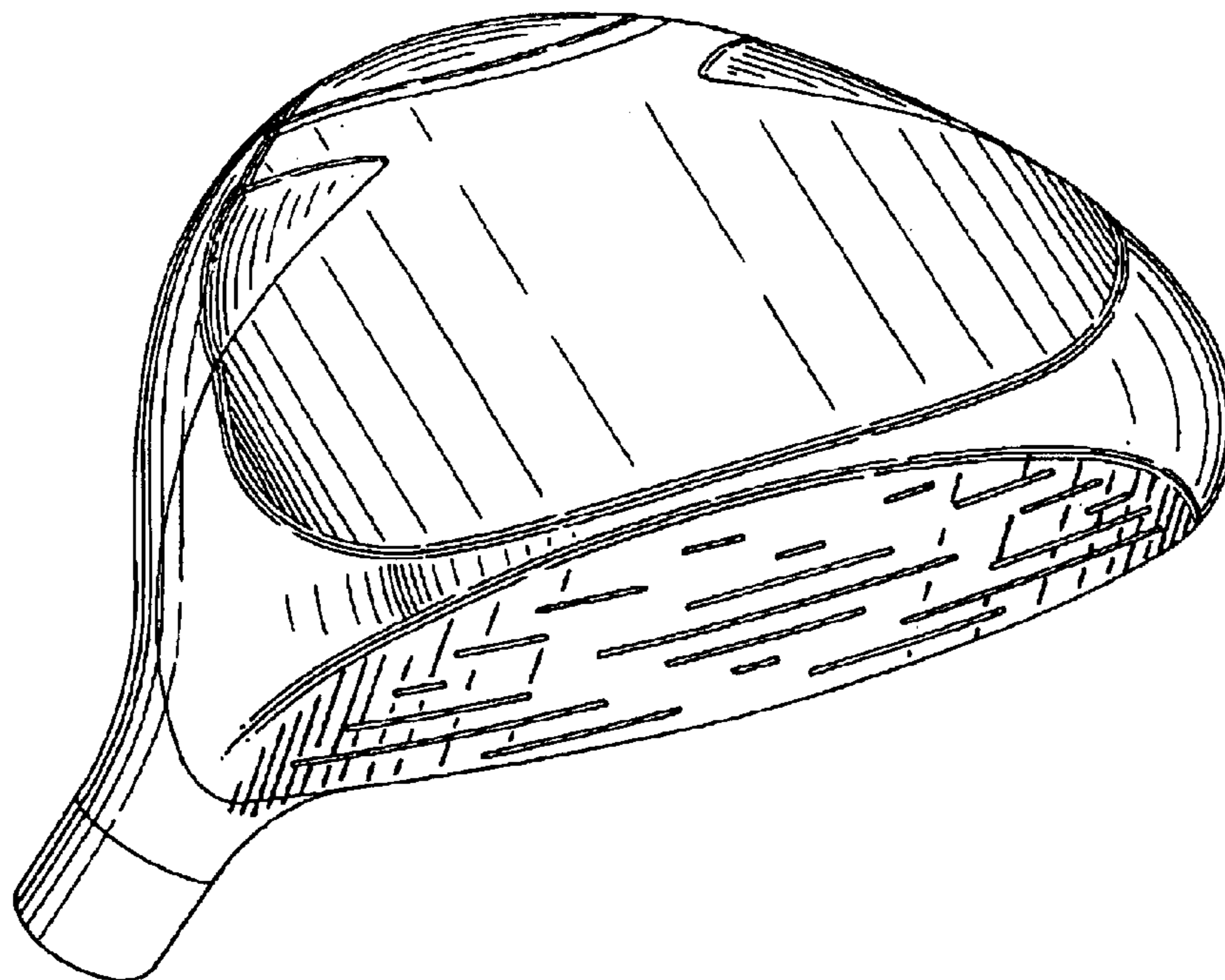

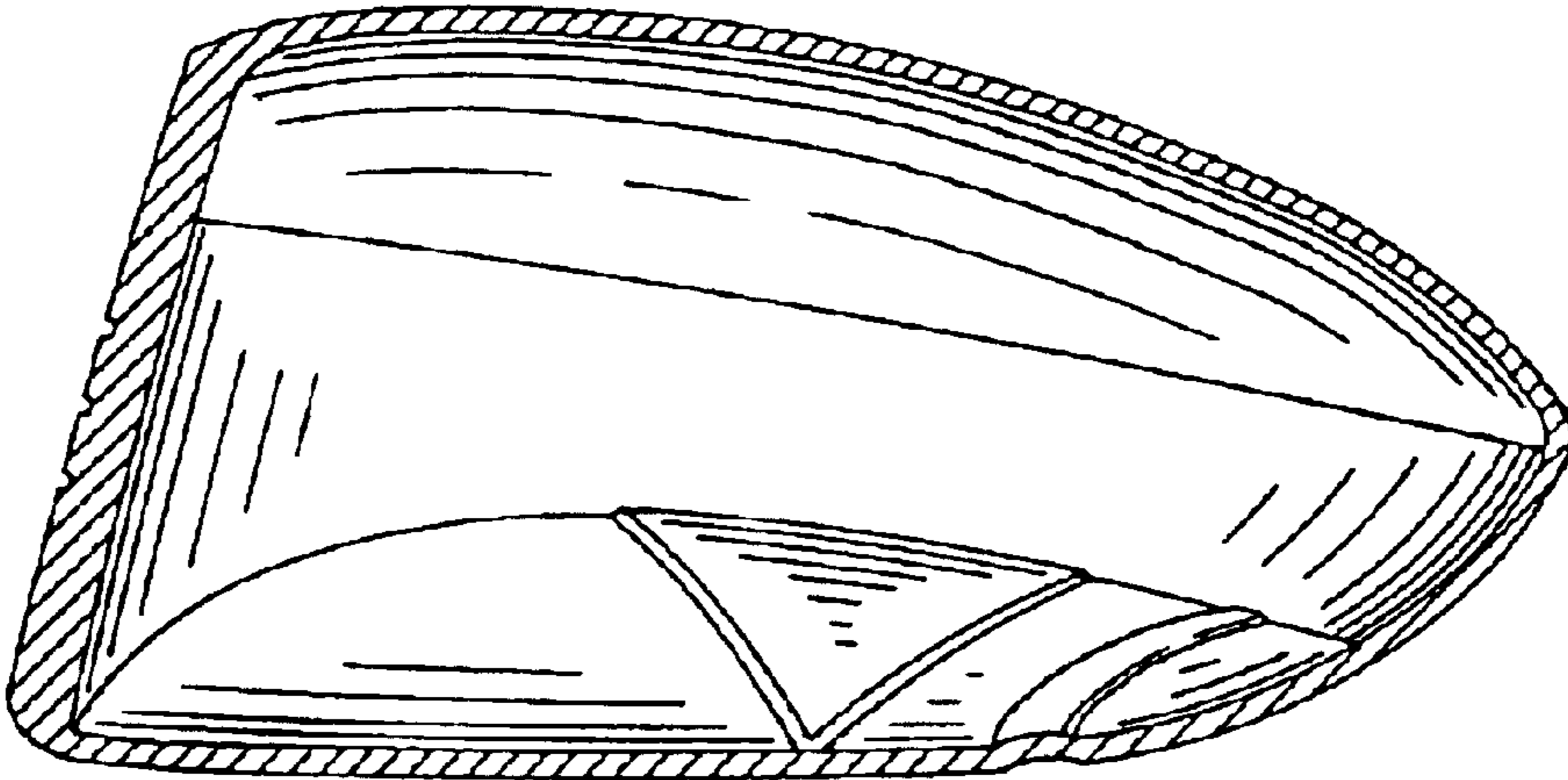
