(57) **CLAIM**

The ornamental design for a package for a tooth whitening system, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a package for a tooth whitening system, embodying the new design;

FIG. 2 is a top planar view of the package for a tooth whitening system of FIG. 1;

FIG. 3 is a bottom planar view of the package for a tooth whitening system of FIG. 1;

FIG. 4 is a rear elevational view of the package for a tooth whitening system of FIG. 1;

FIG. 5 is a side elevational view of the package for a tooth whitening system of FIG. 1, the opposite side elevational view thereof being the same;

FIG. 6 is a front elevational view of the package for a tooth whitening system of FIG. 1;

FIG. 7 is a perspective view of the present invention show in open position;

FIG. 8 is a top planar view of the package for a tooth whitening system of FIG. 7;

FIG. 9 is a bottom planar view of the package for a tooth whitening system of FIG. 7;

FIG. 10 is a front elevational view of the package for a tooth whitening system of FIG. 7;

FIG. 11 is a side elevational view of the package for a tooth whitening system of FIG. 7, the opposite side elevational view thereof being the same;

FIG. 12 is a rear elevational view of the package for a tooth whitening system of FIG. 7;

FIG. 13 is a perspective view of an alternative embodiment of the present invention;

FIG. 14 is a top planar view of the package for a tooth whitening system of FIG. 13;

FIG. 15 is a bottom planar view of the package for a tooth whitening system of FIG. 13;

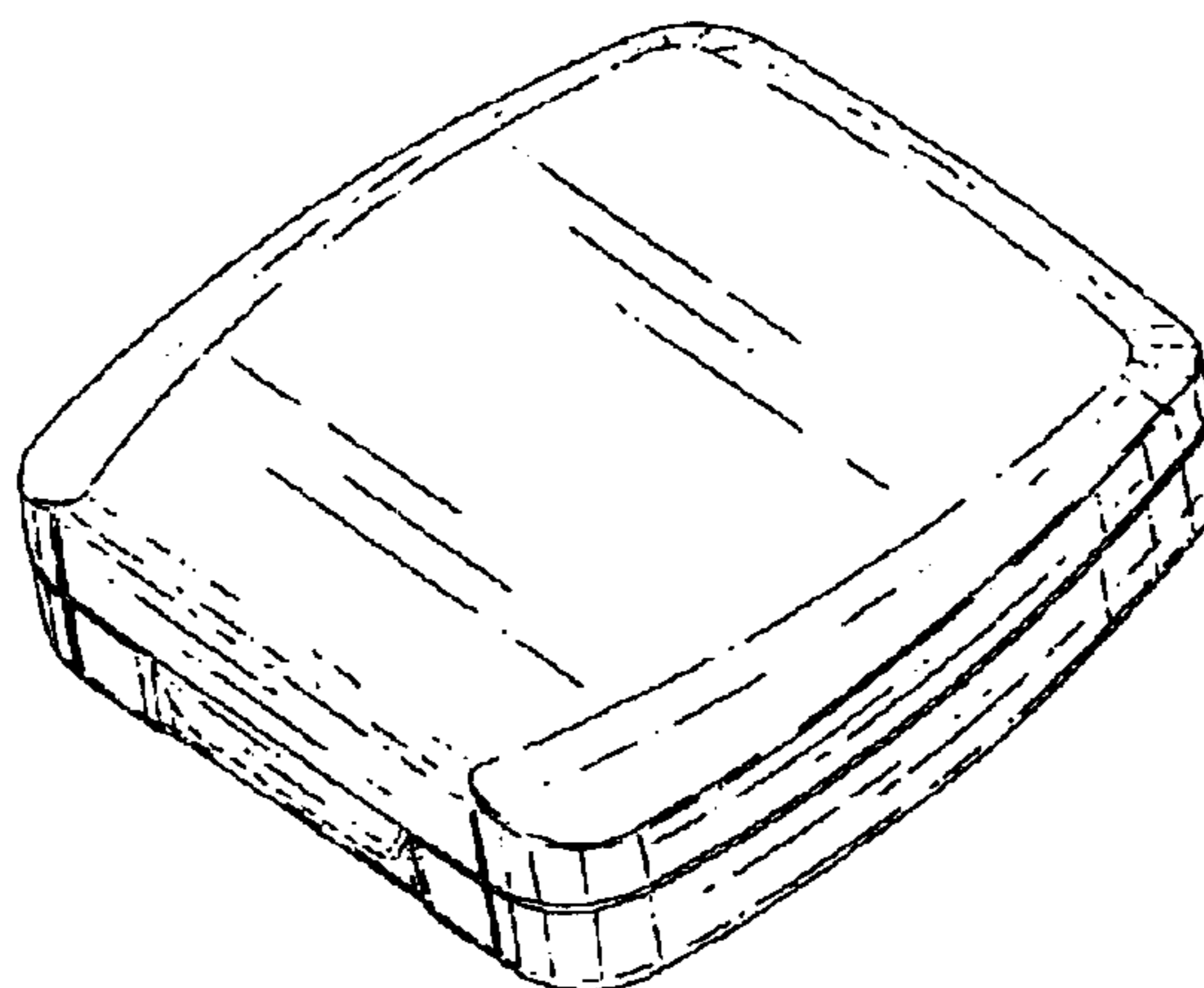
FIG. 16 is a front elevational view of the package for a tooth whitening system of FIG. 13;

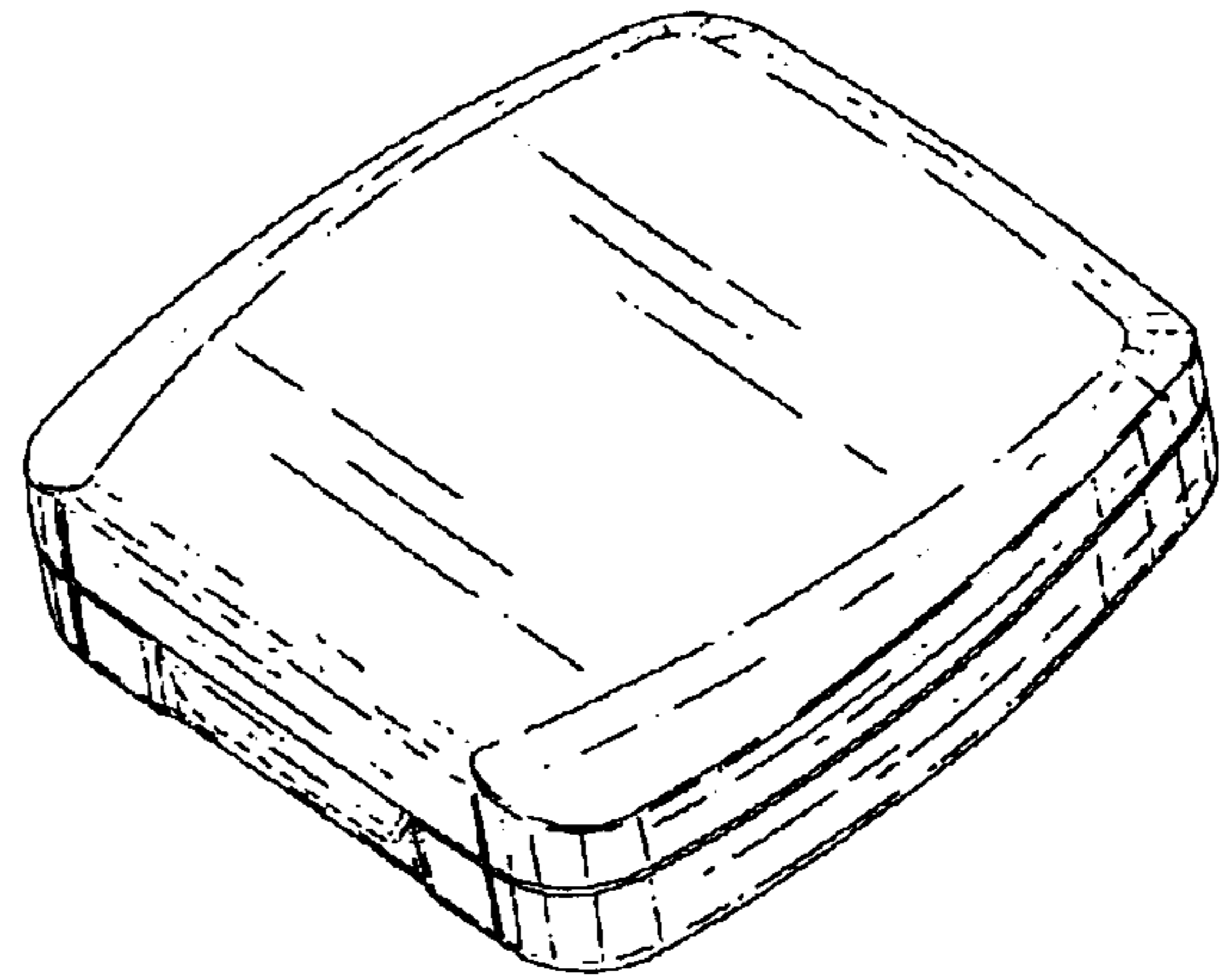

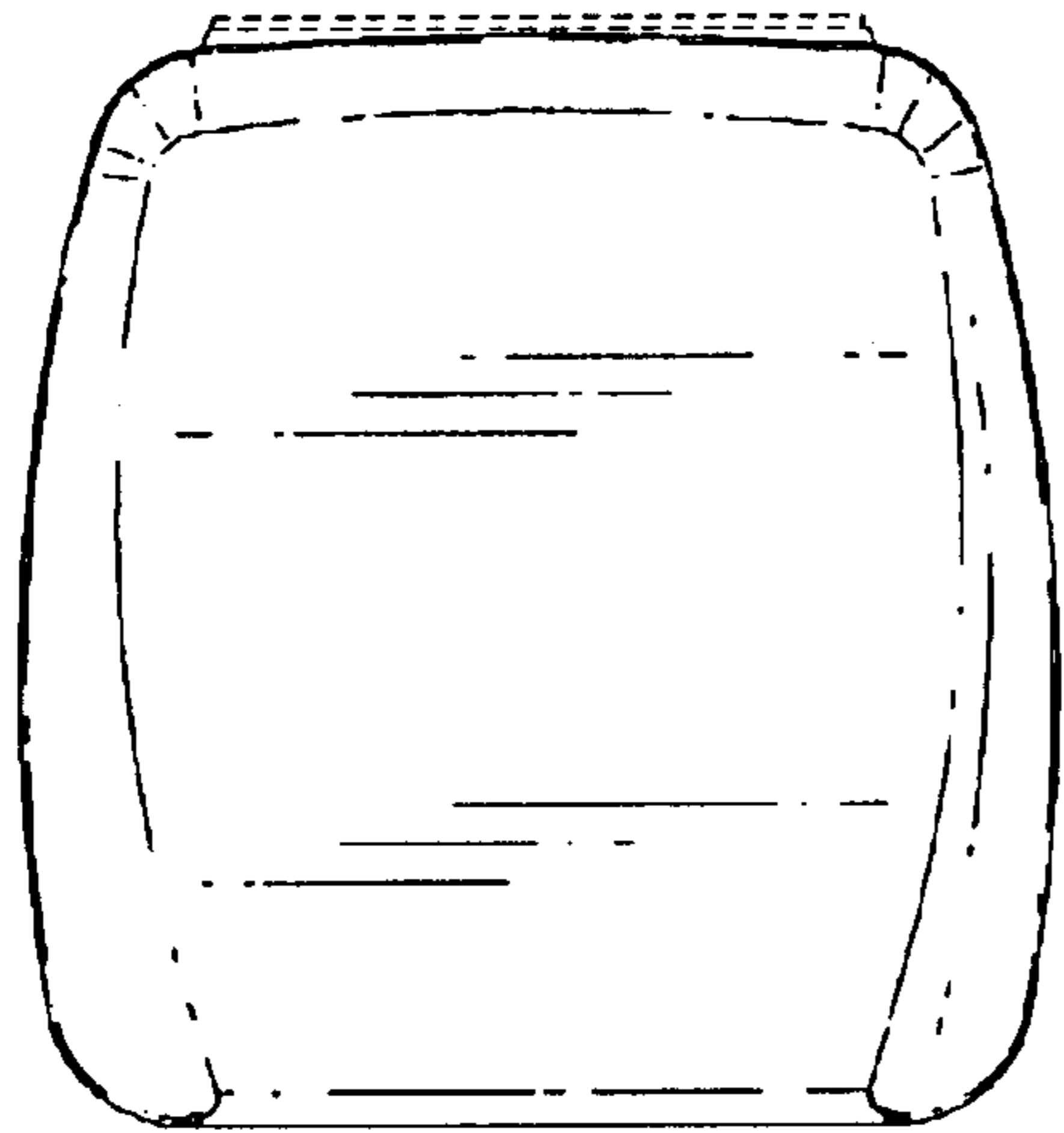

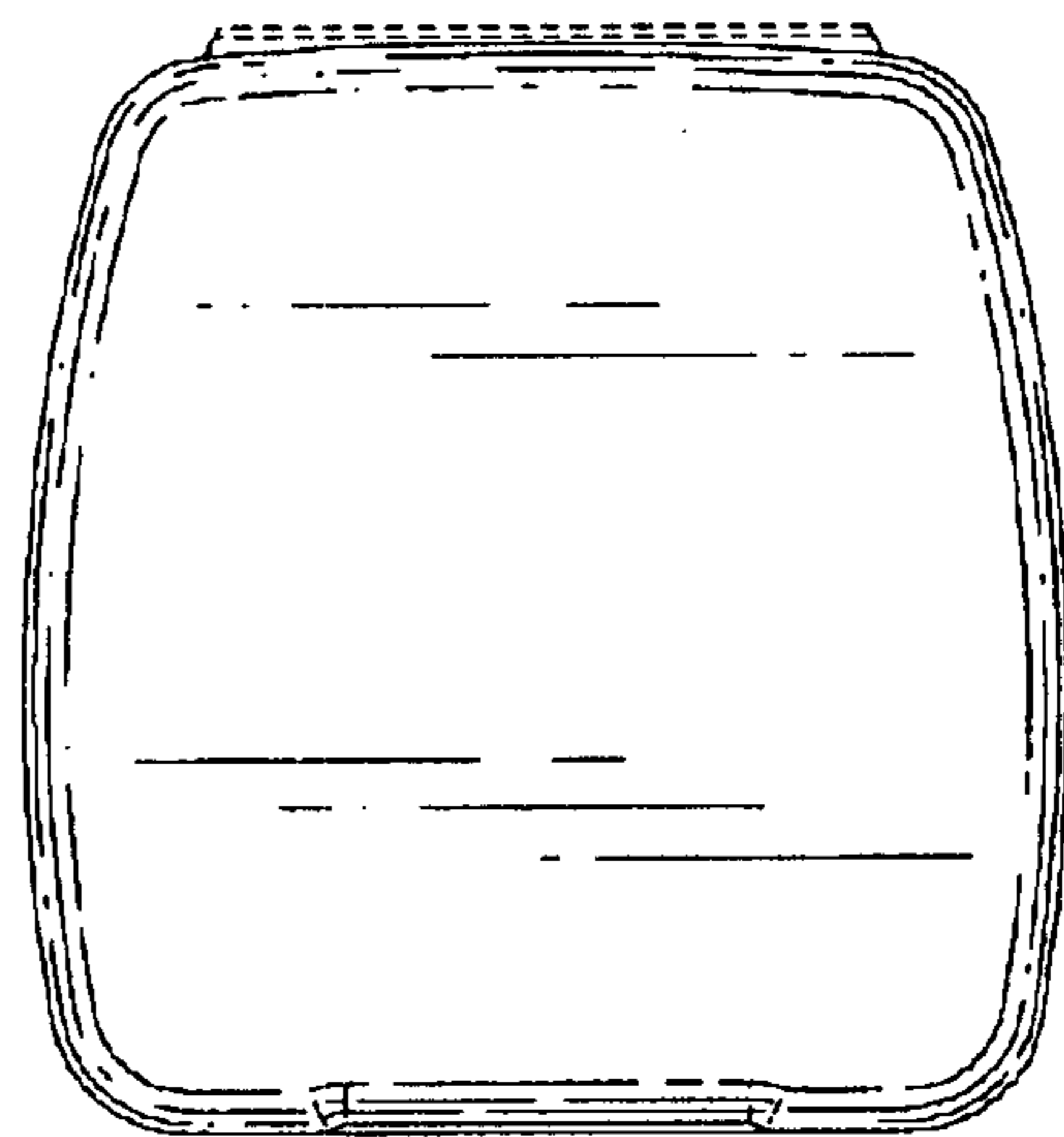

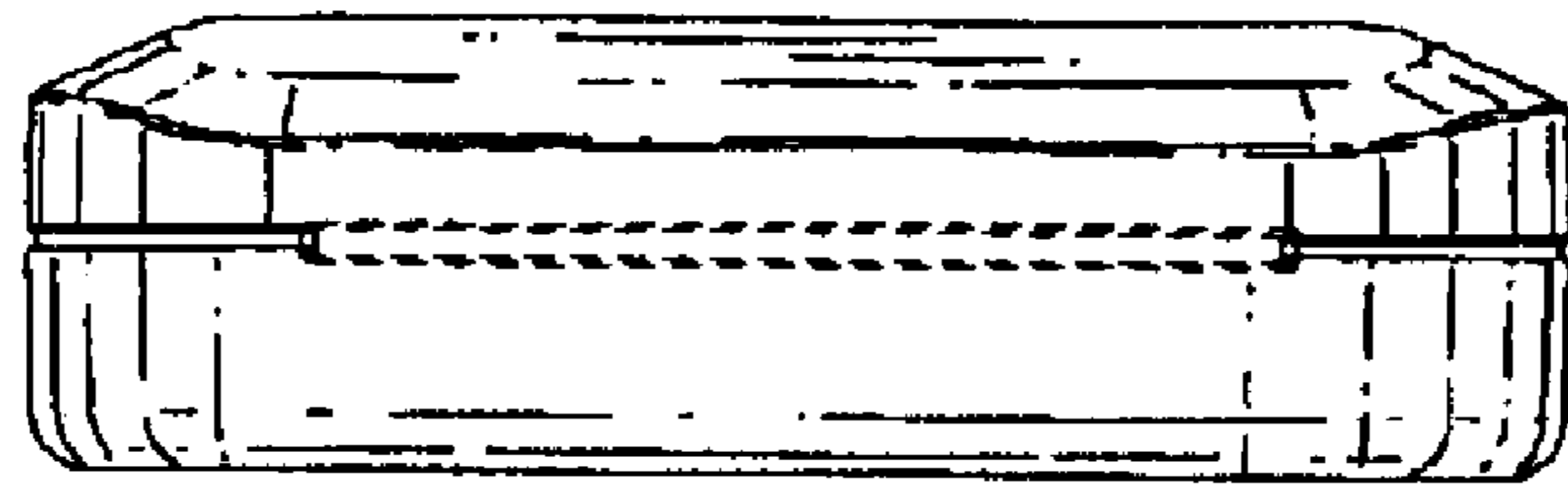

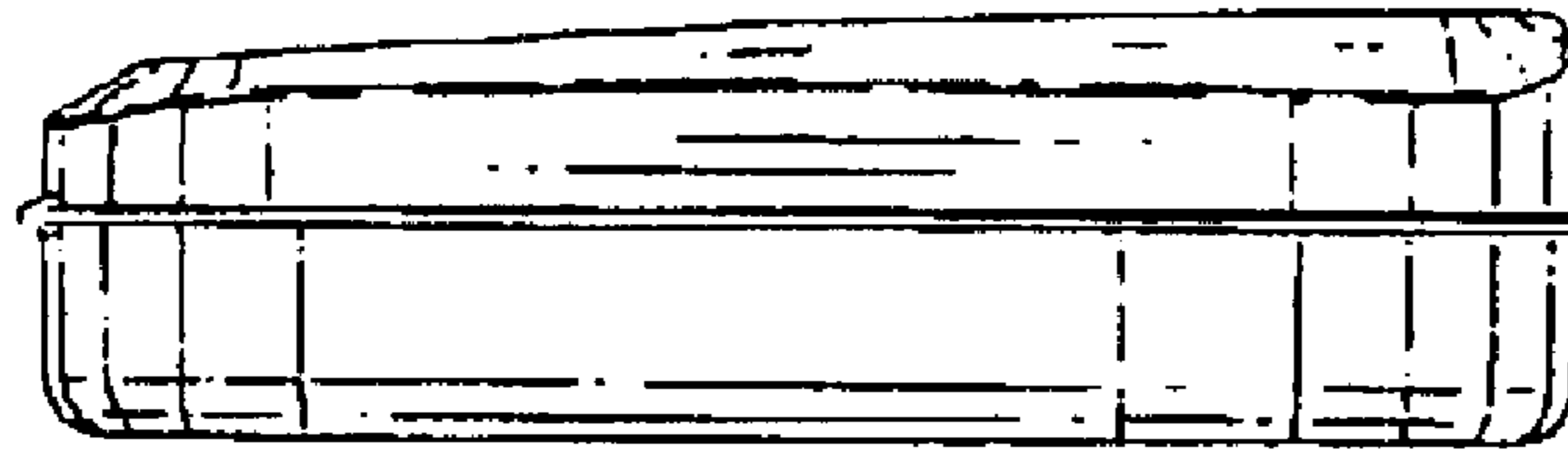

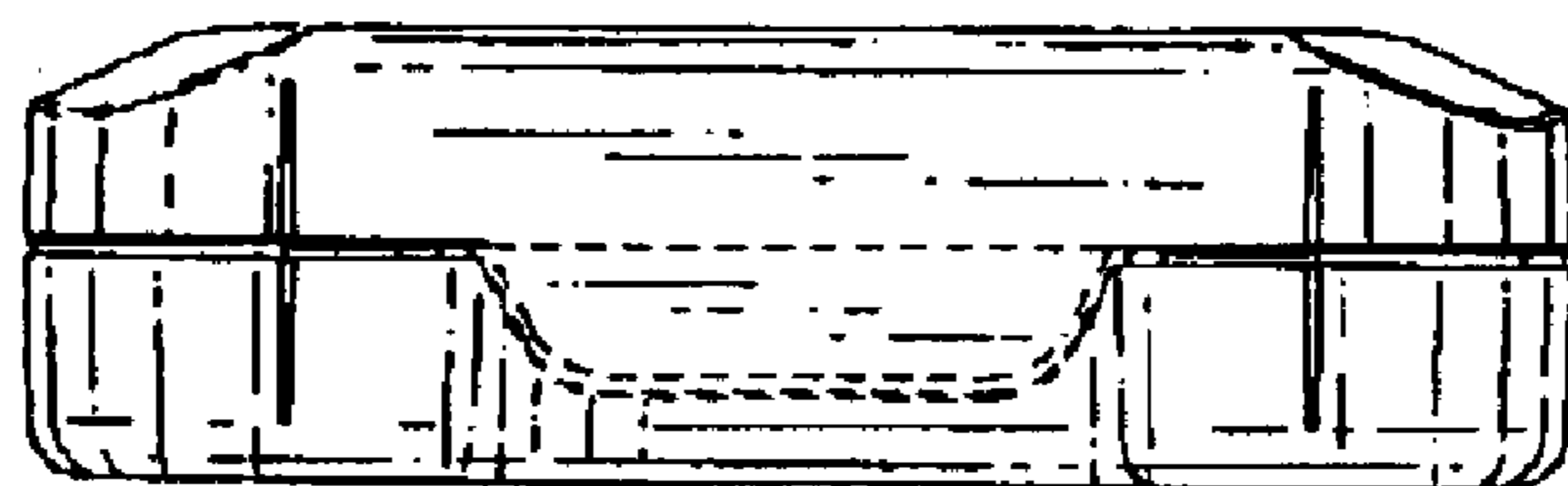

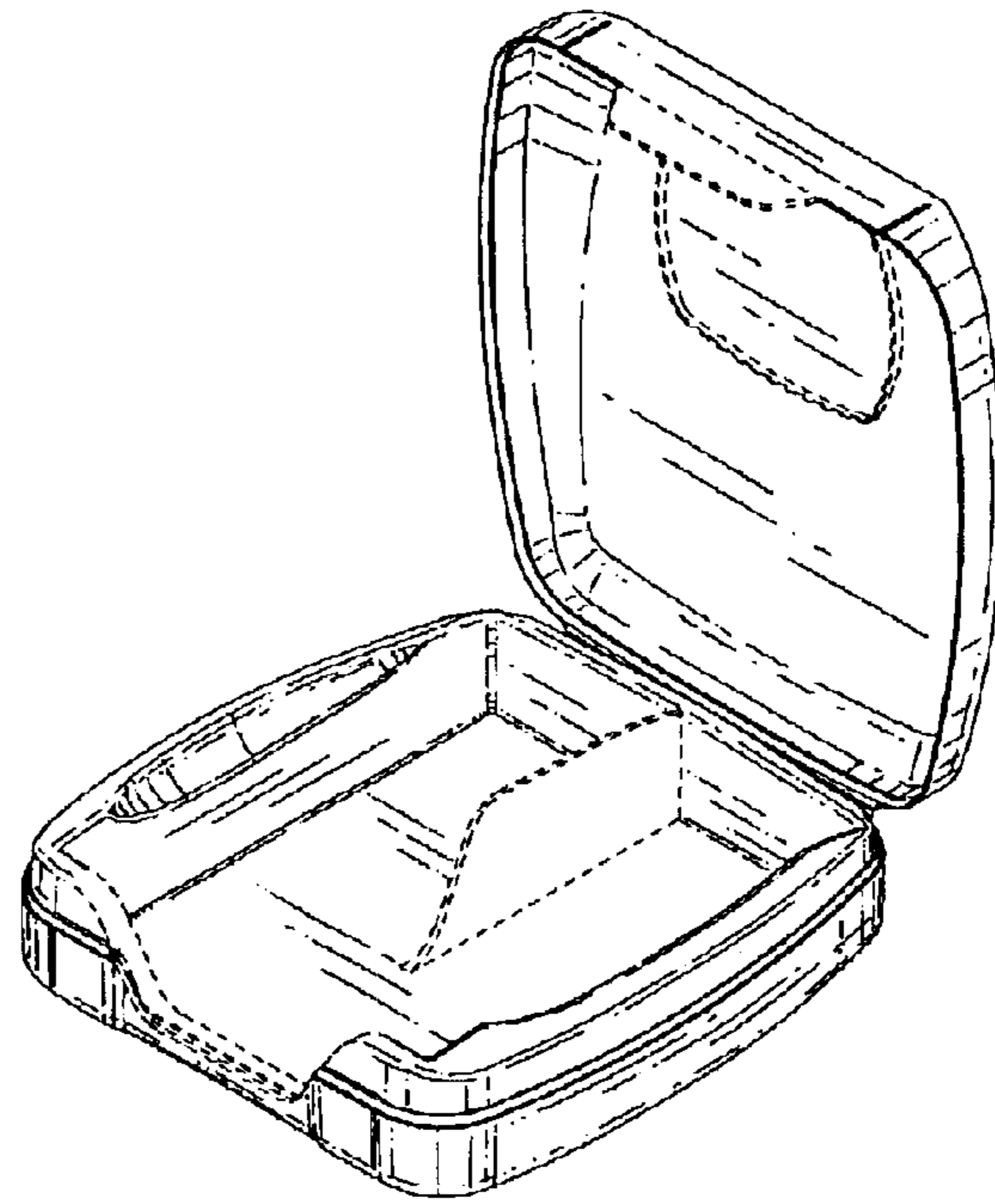

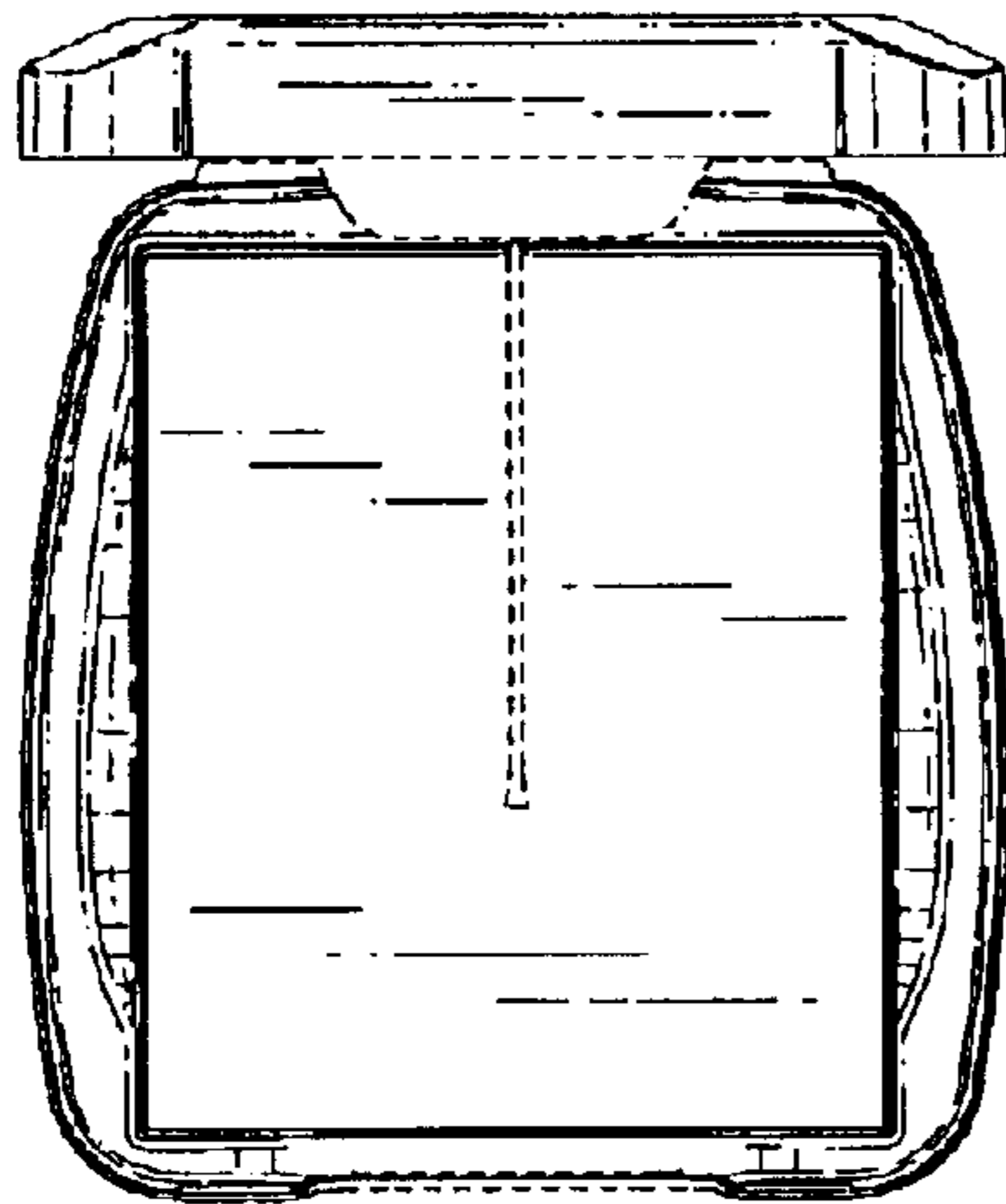

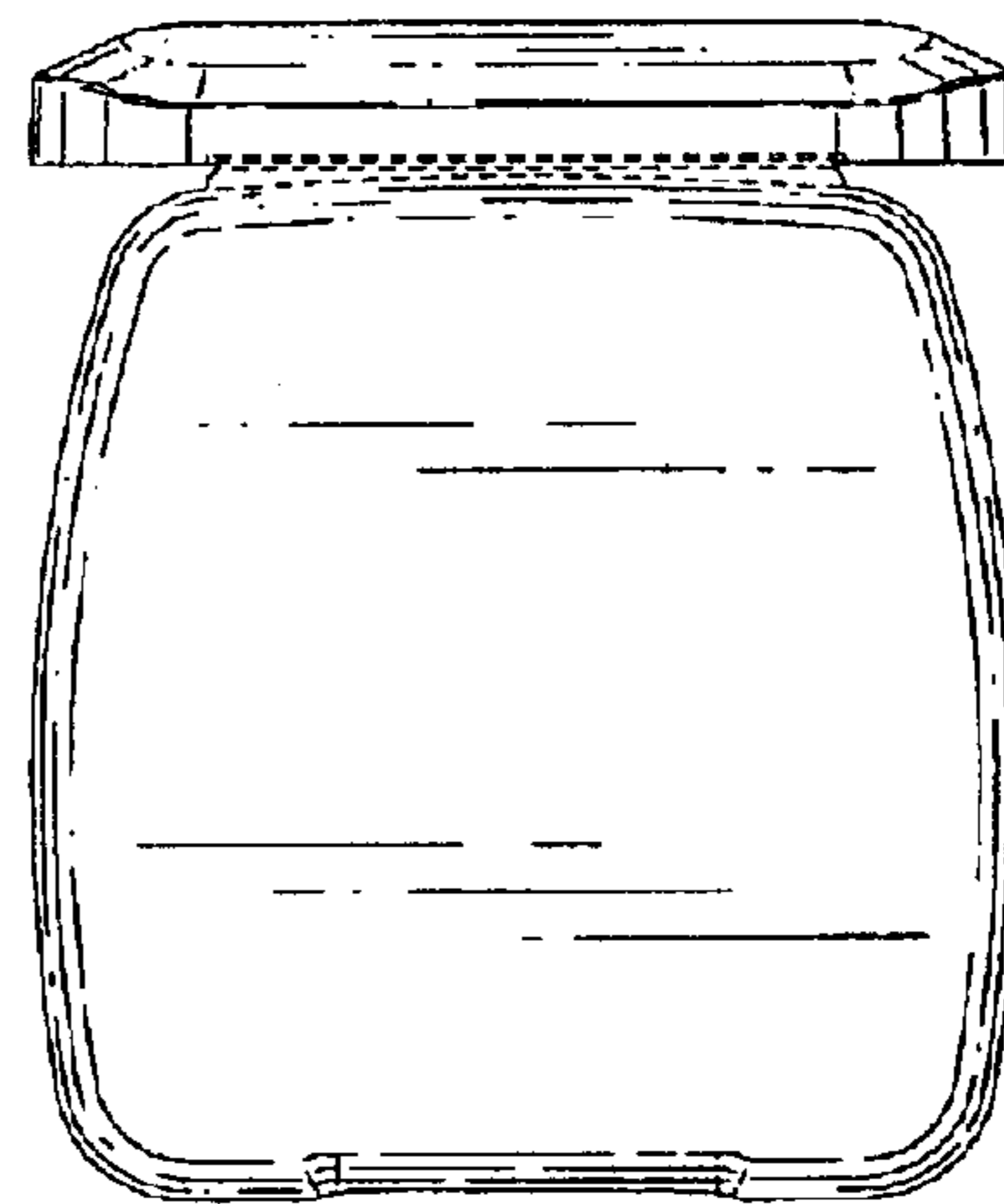

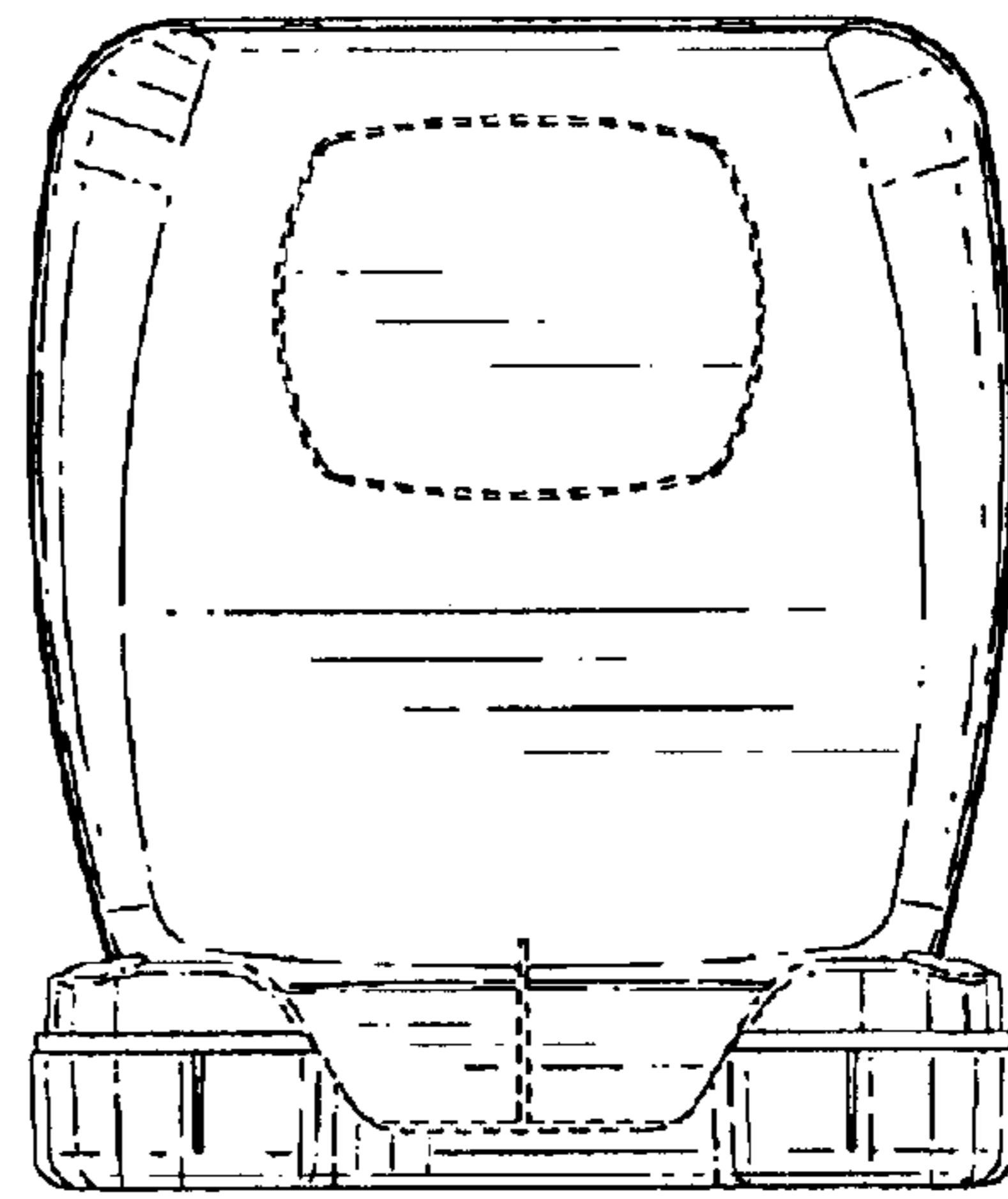

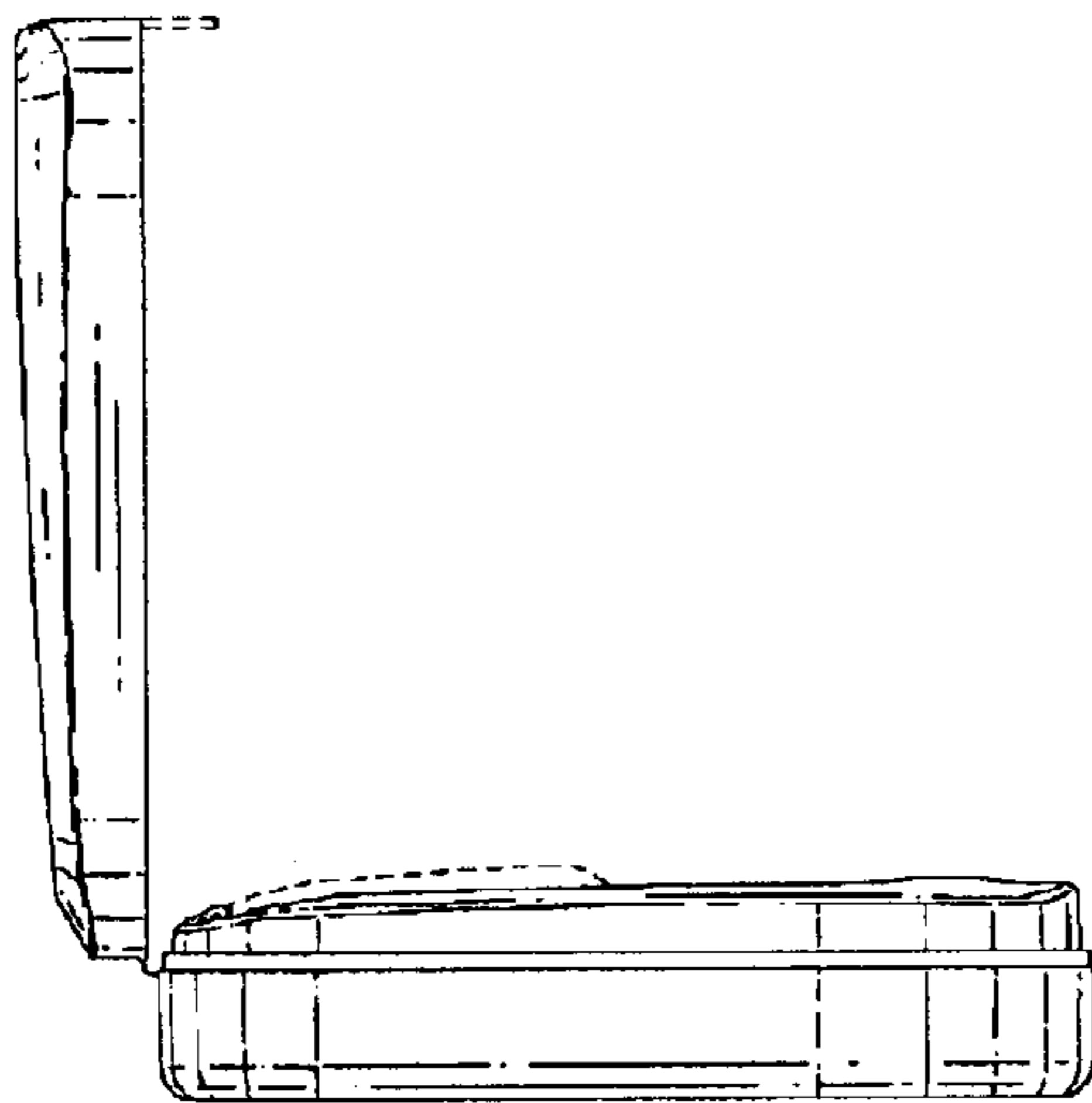

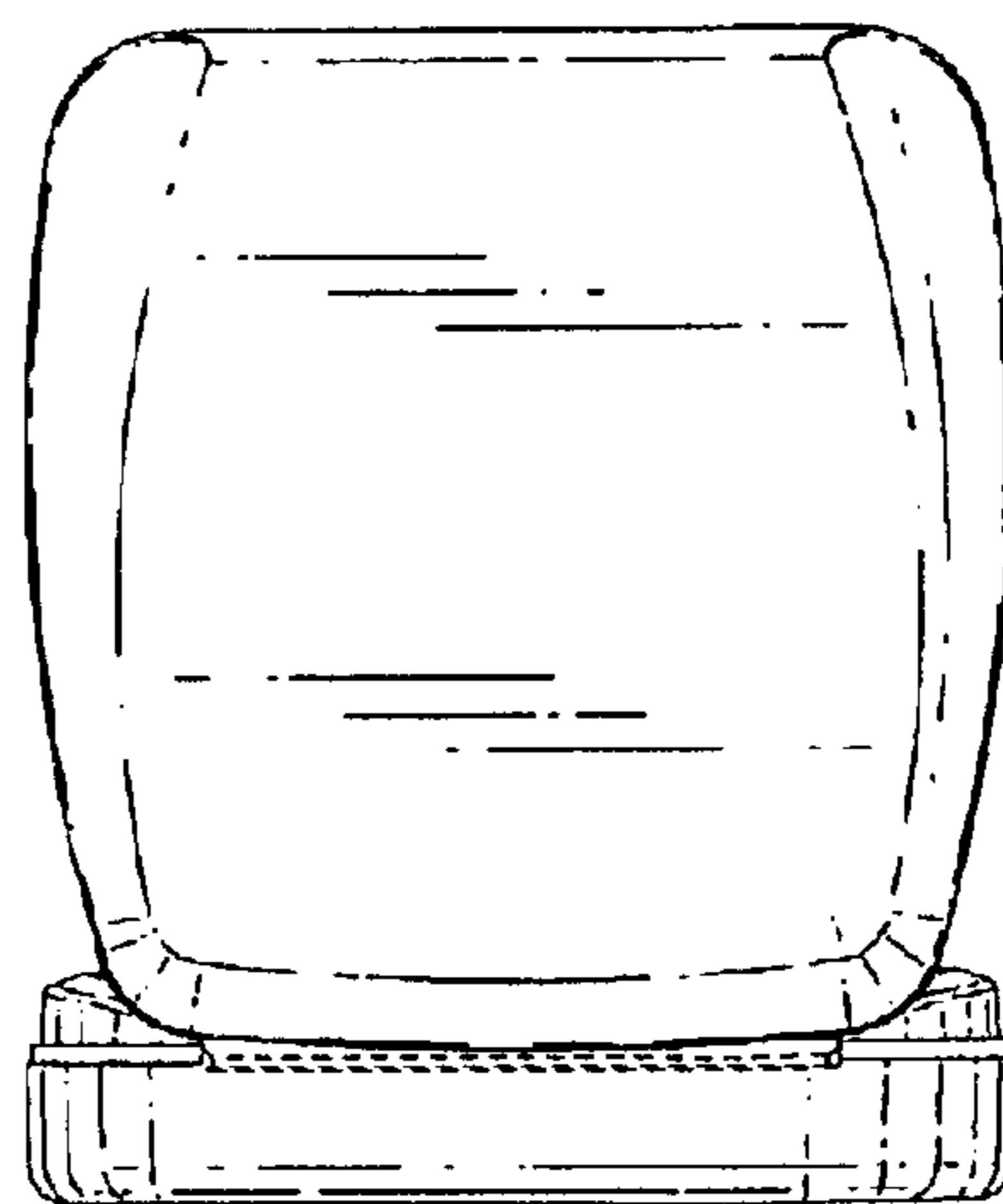

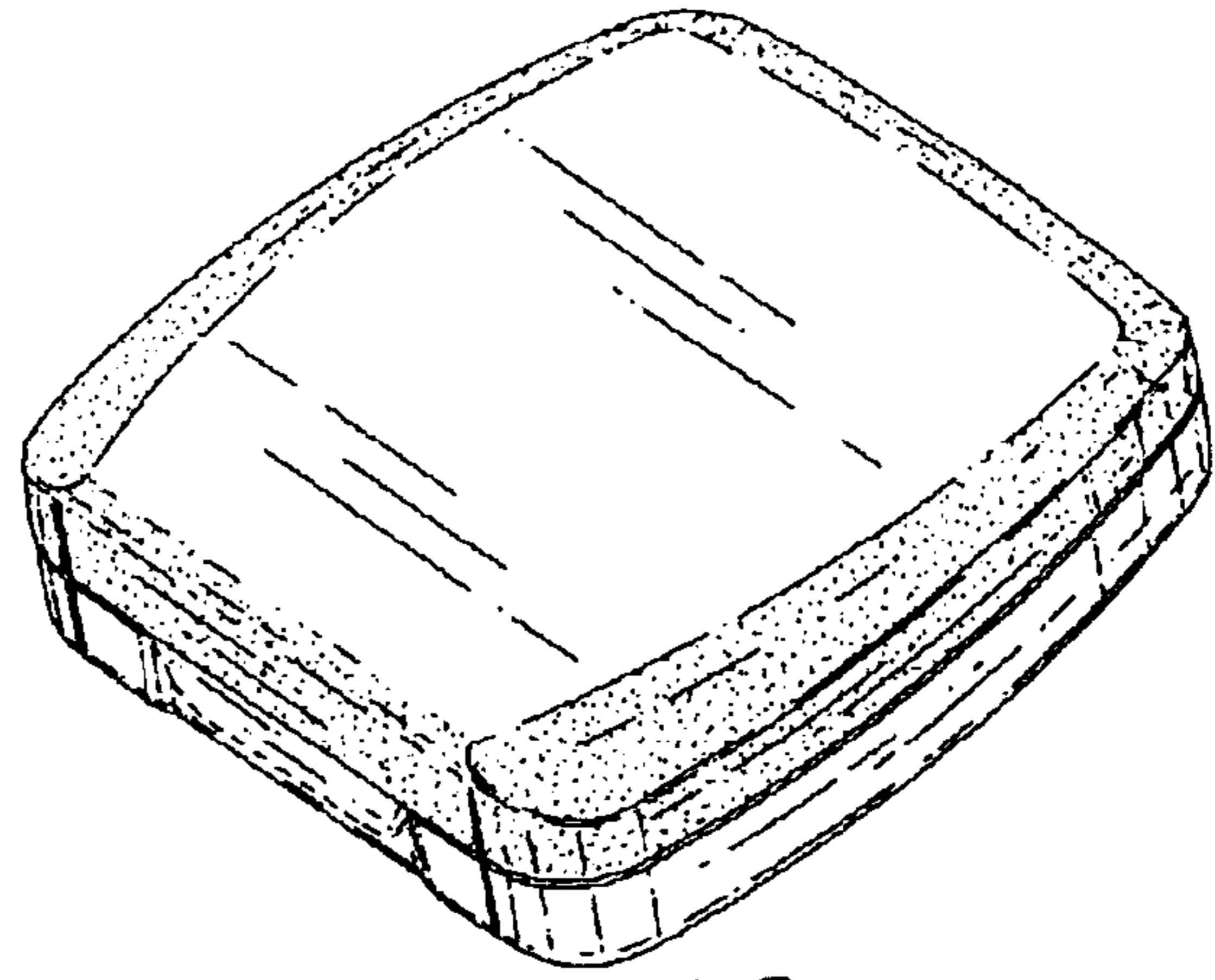

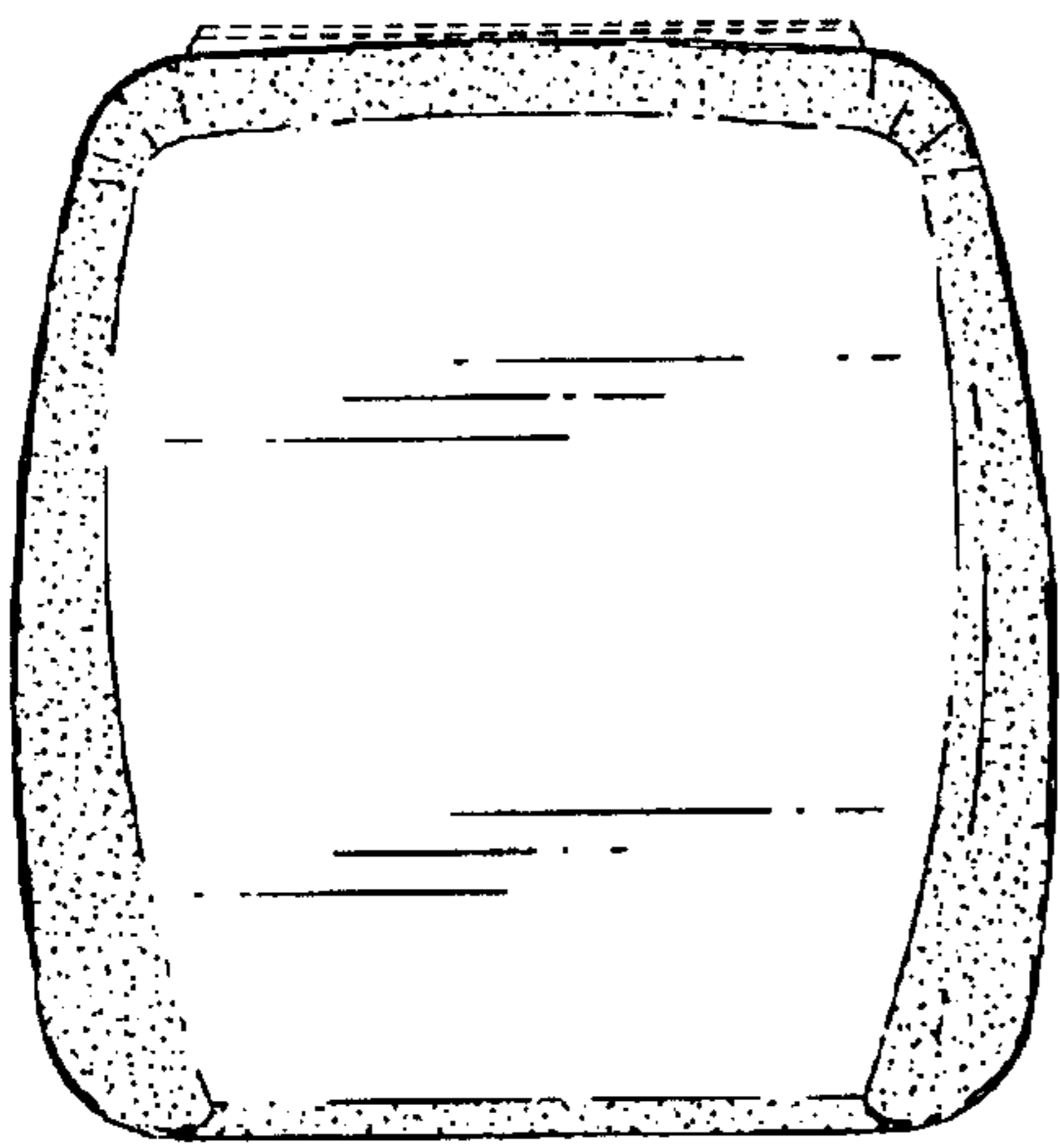

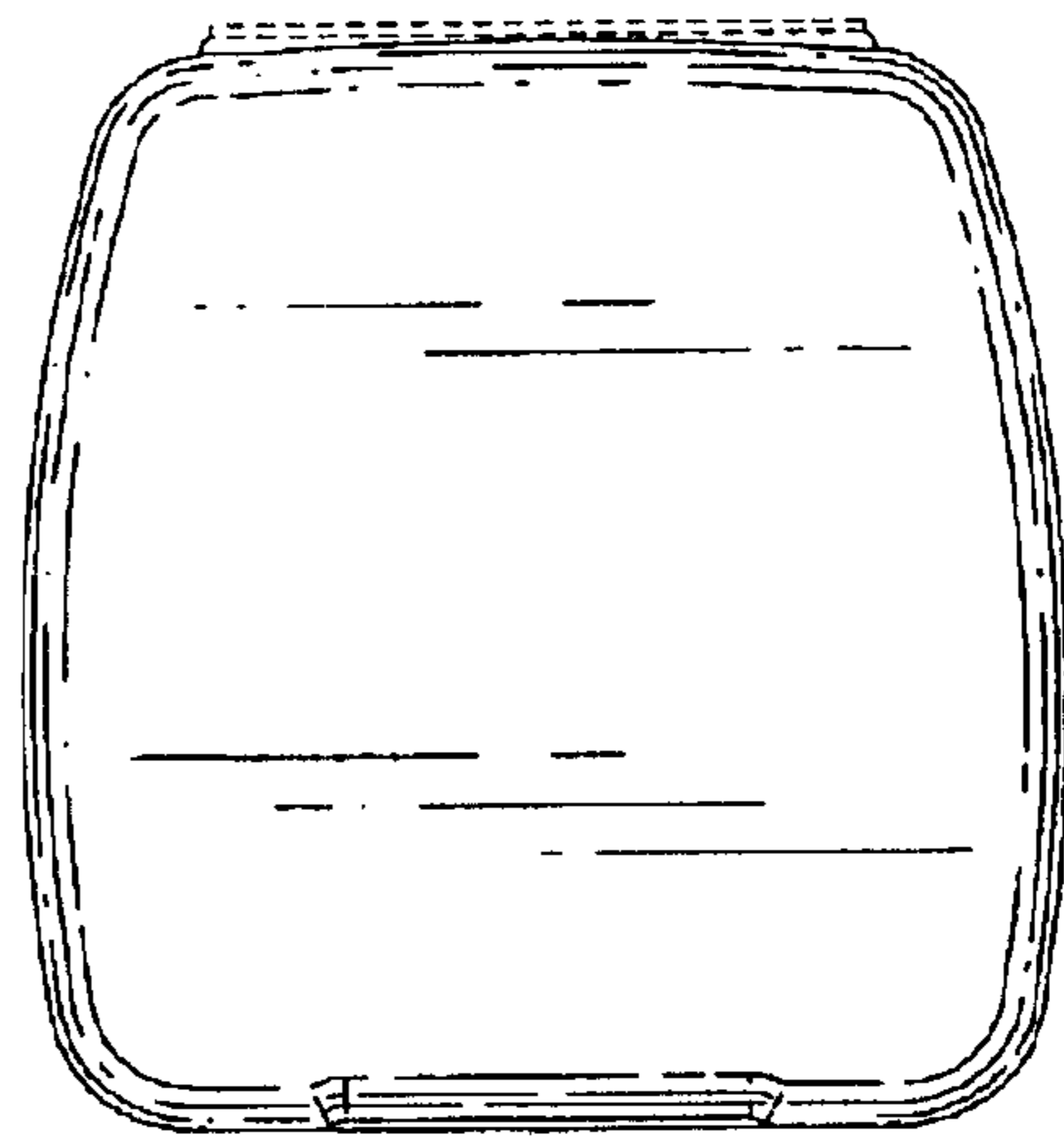

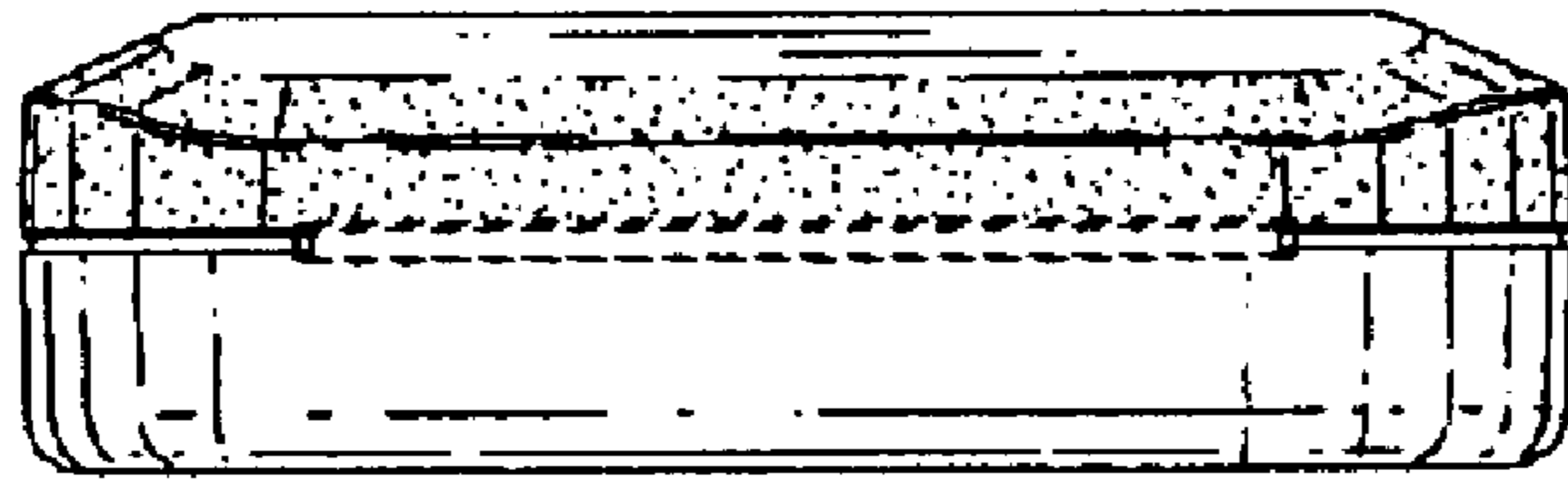

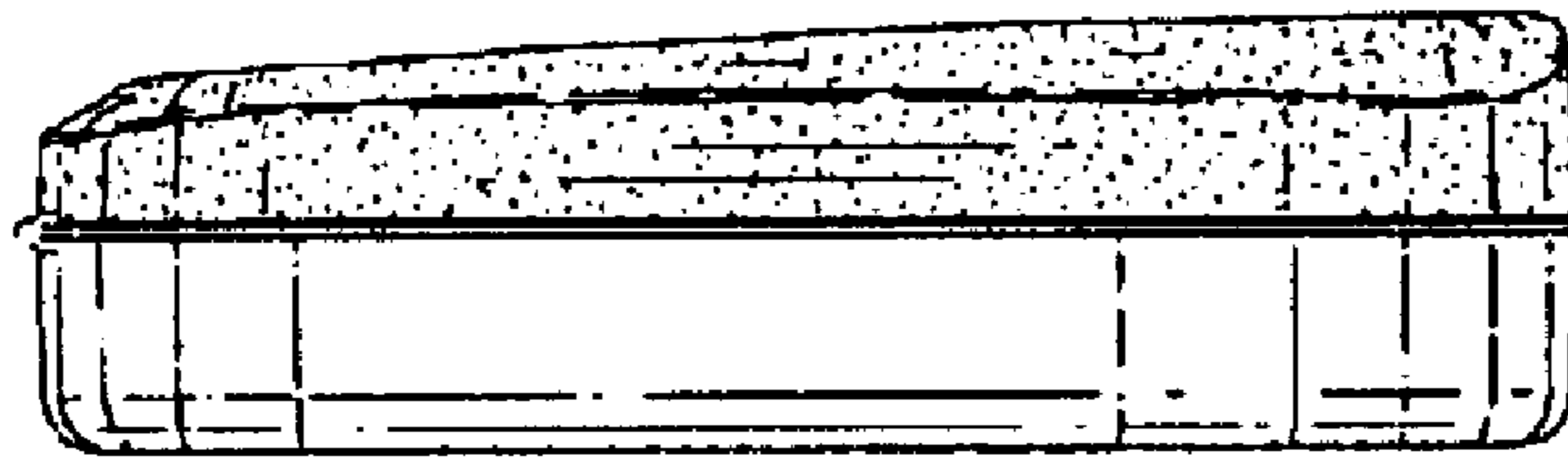

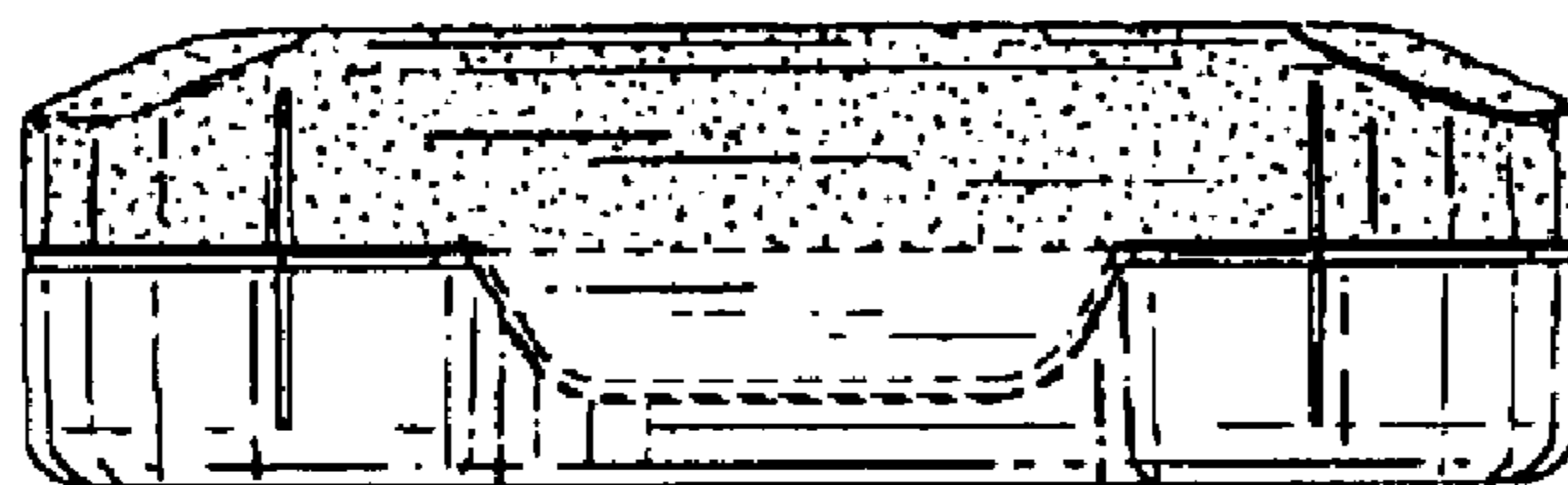
