**DESCRIPTION**

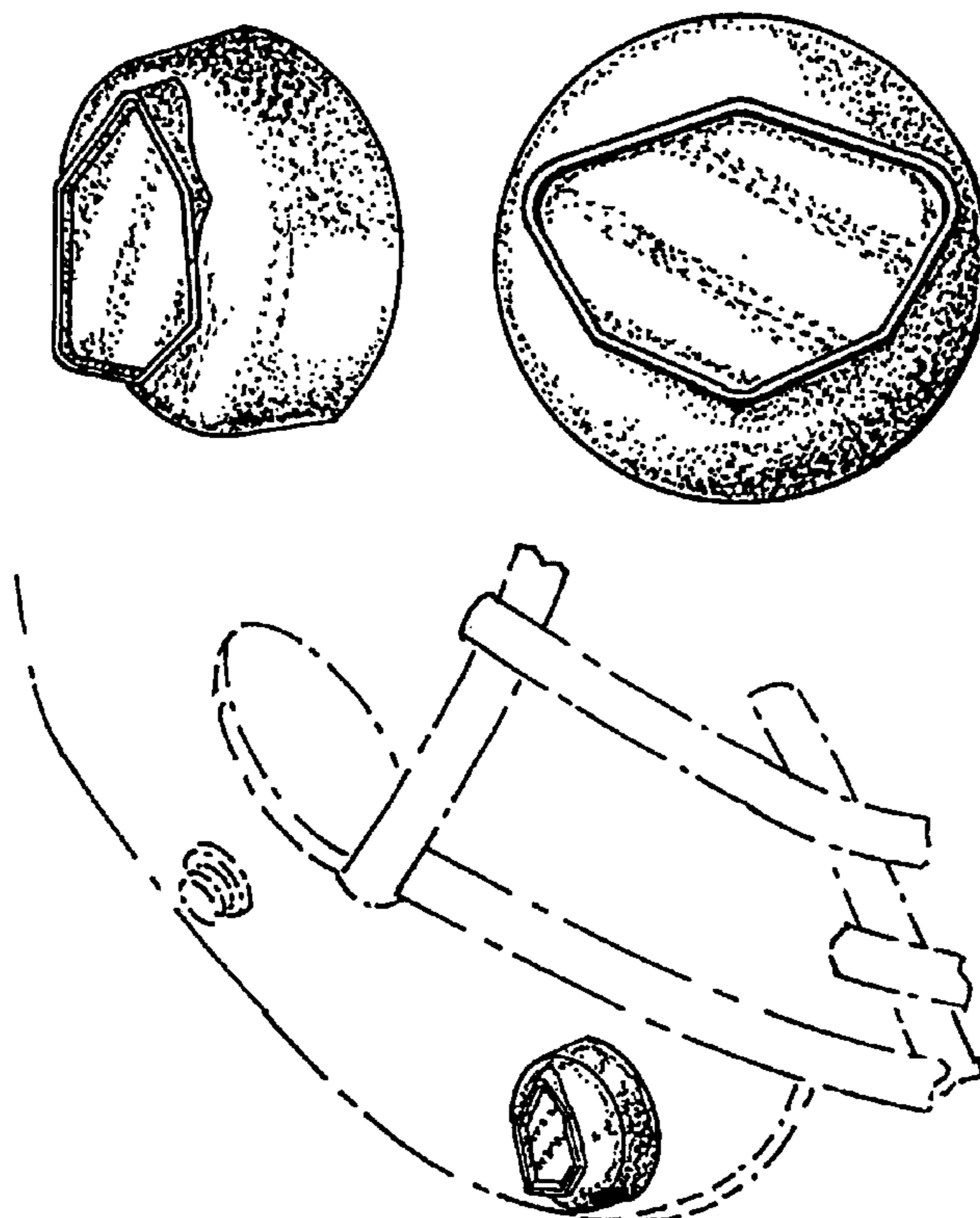
FIG. 1 is a front perspective view of a button logo cap showing our new design;

 The broken line drawings of the helmet are for illustrative environmental purposes only and form no part of the claimed design.

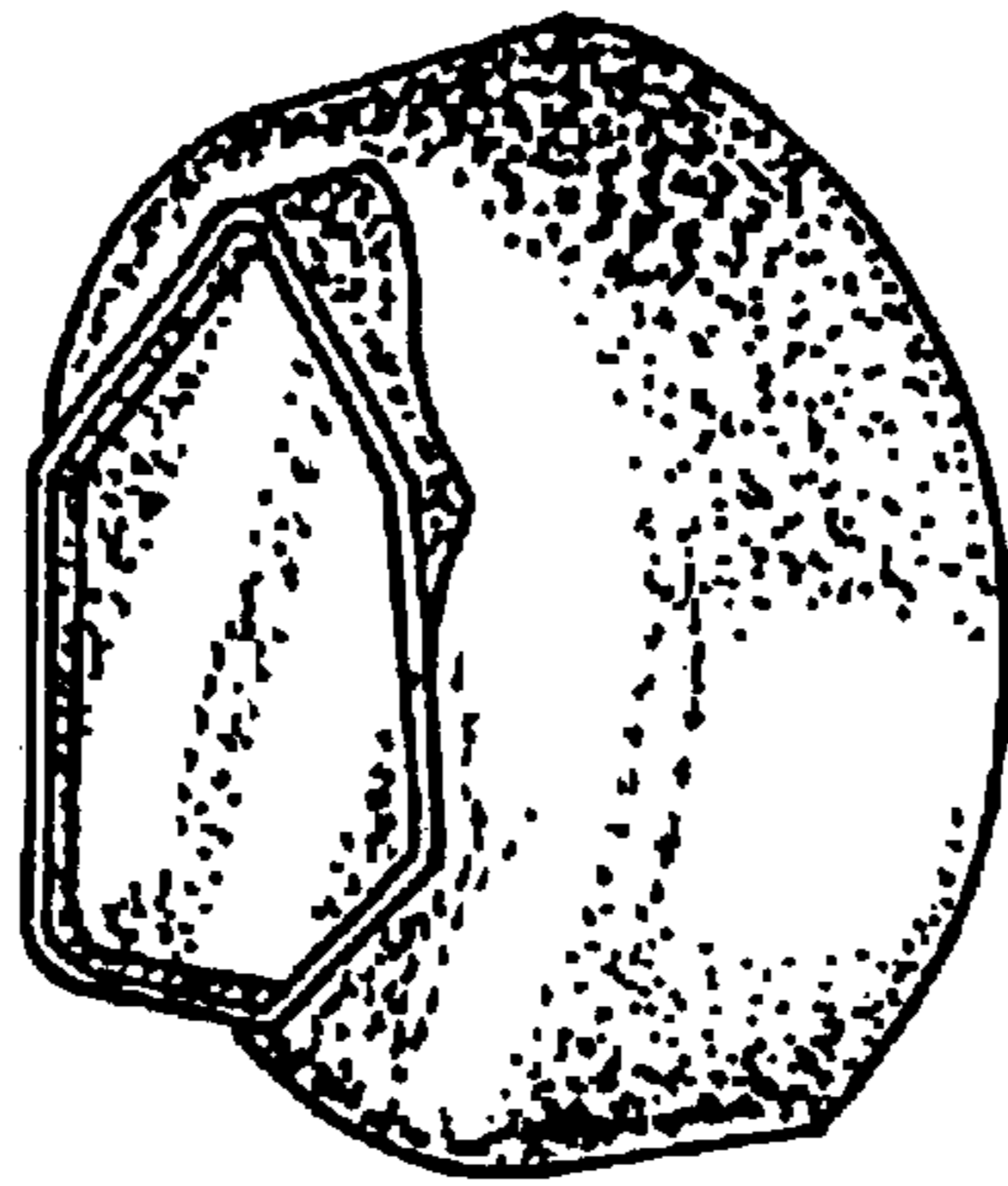

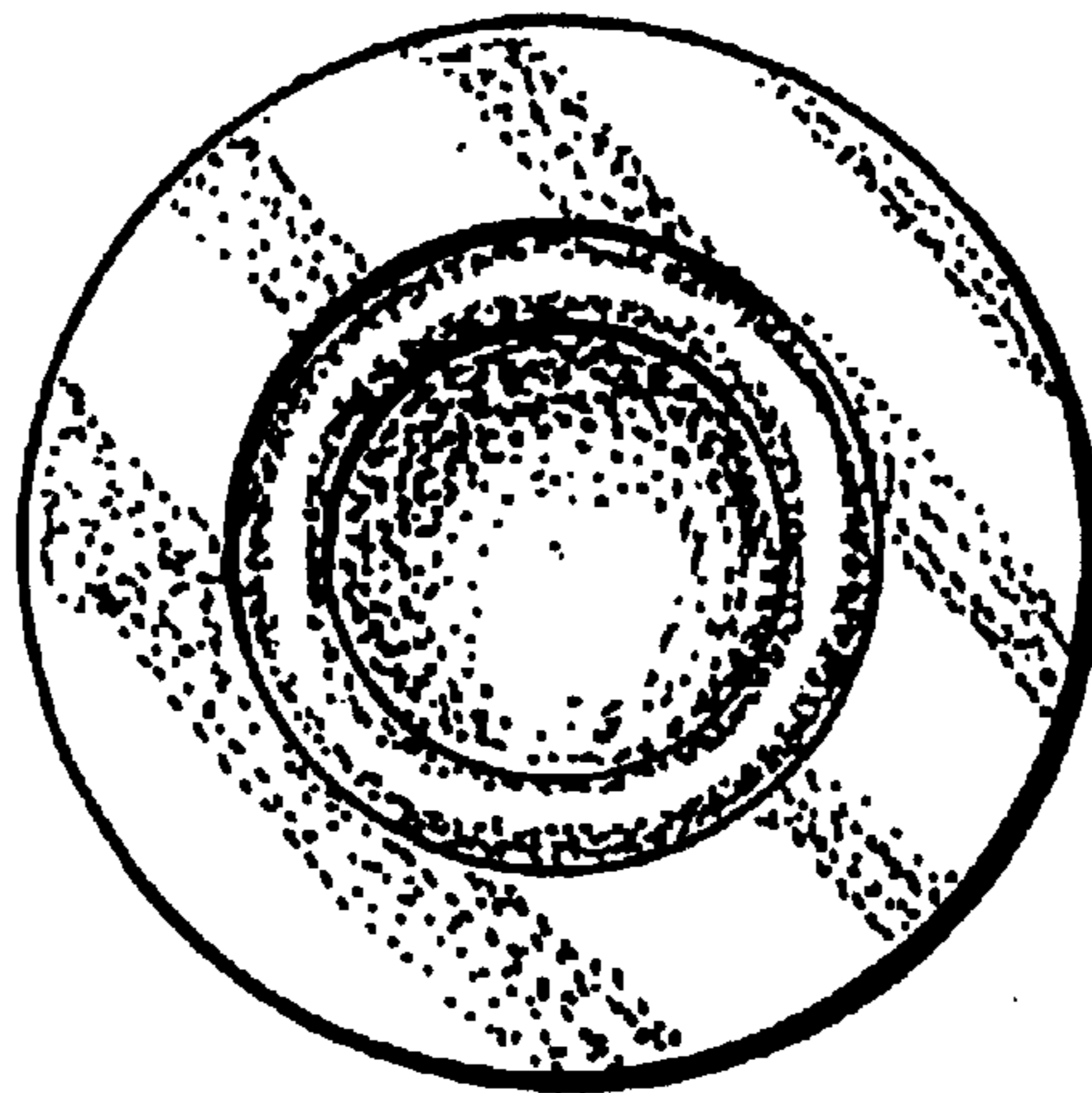

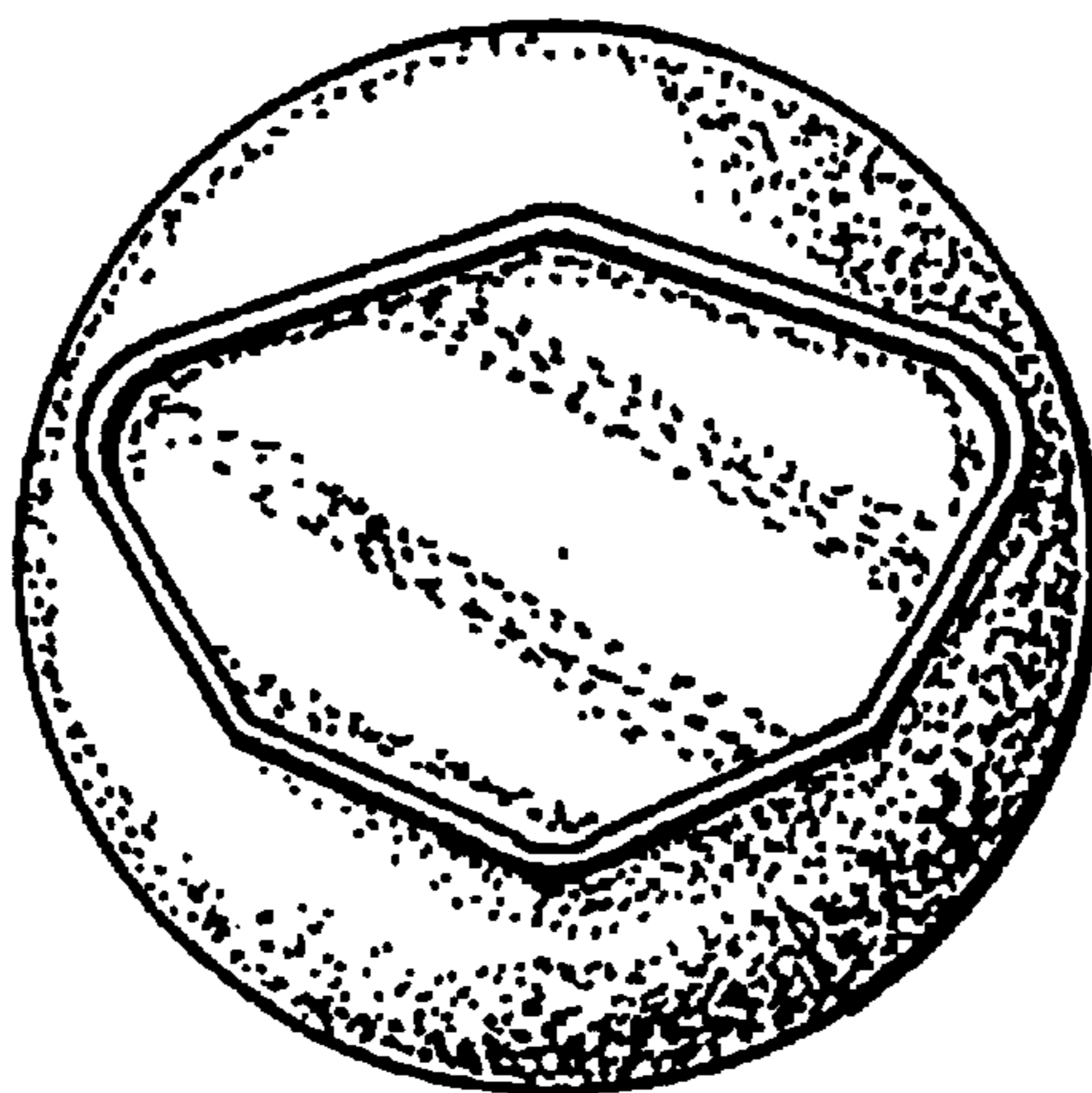




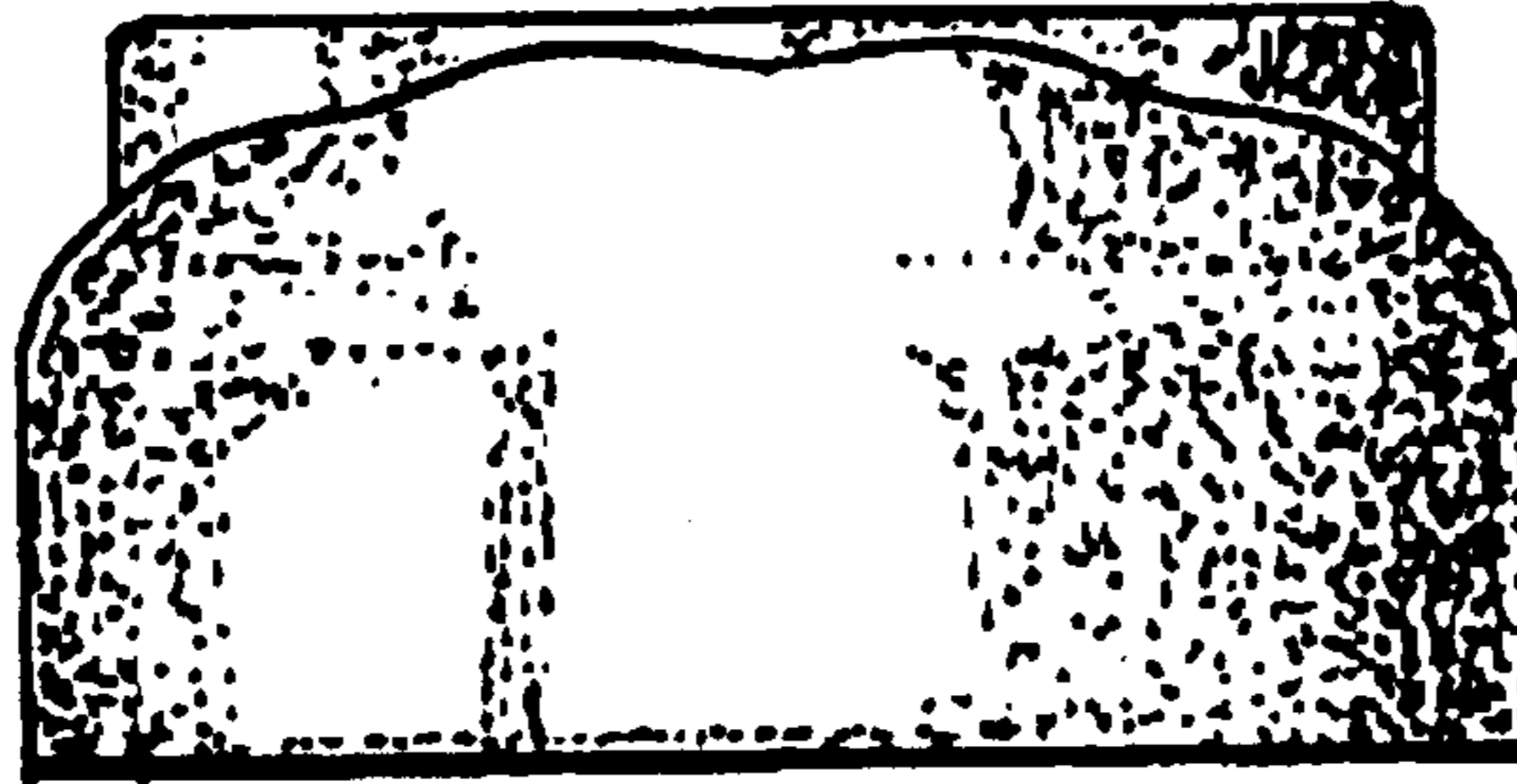

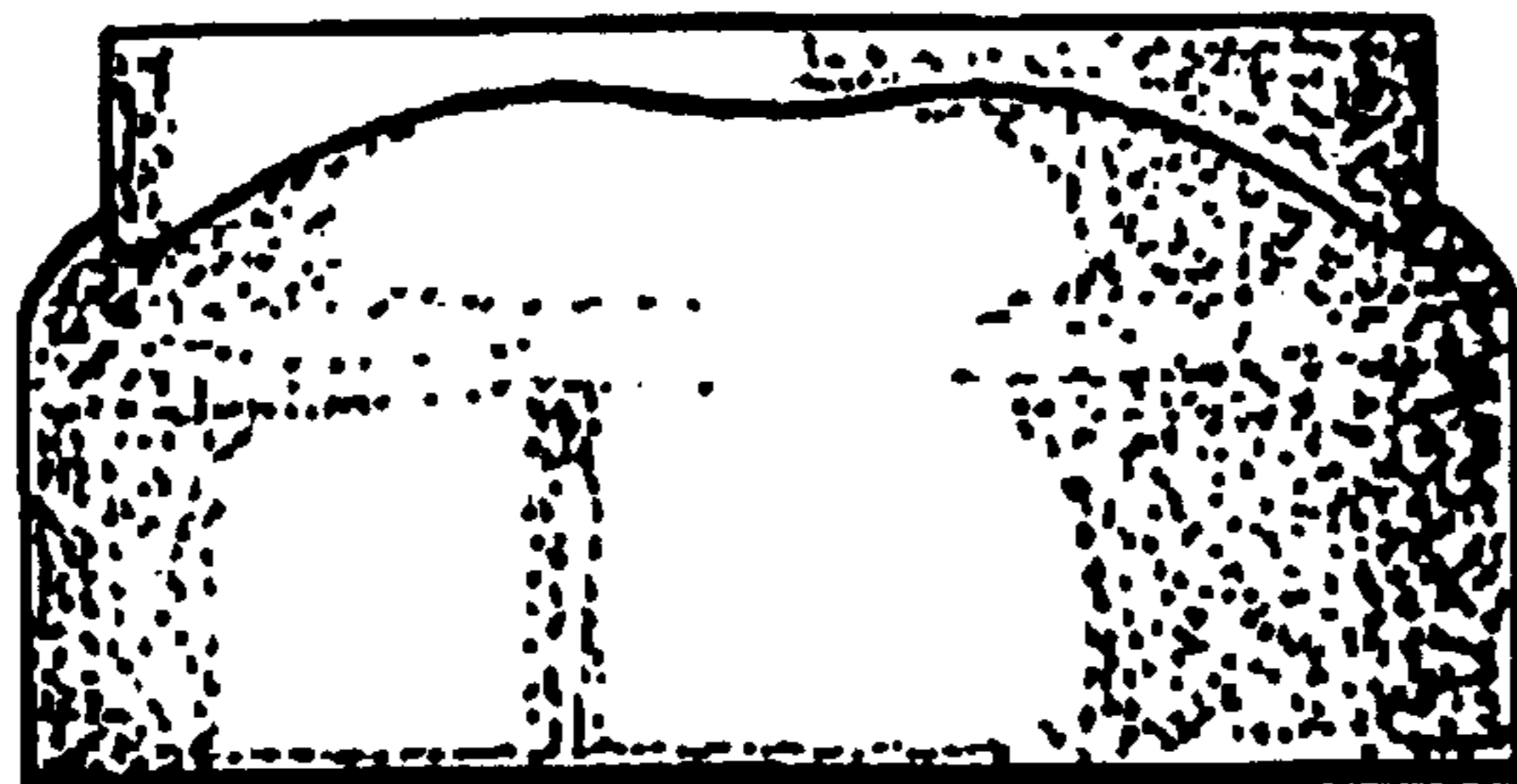

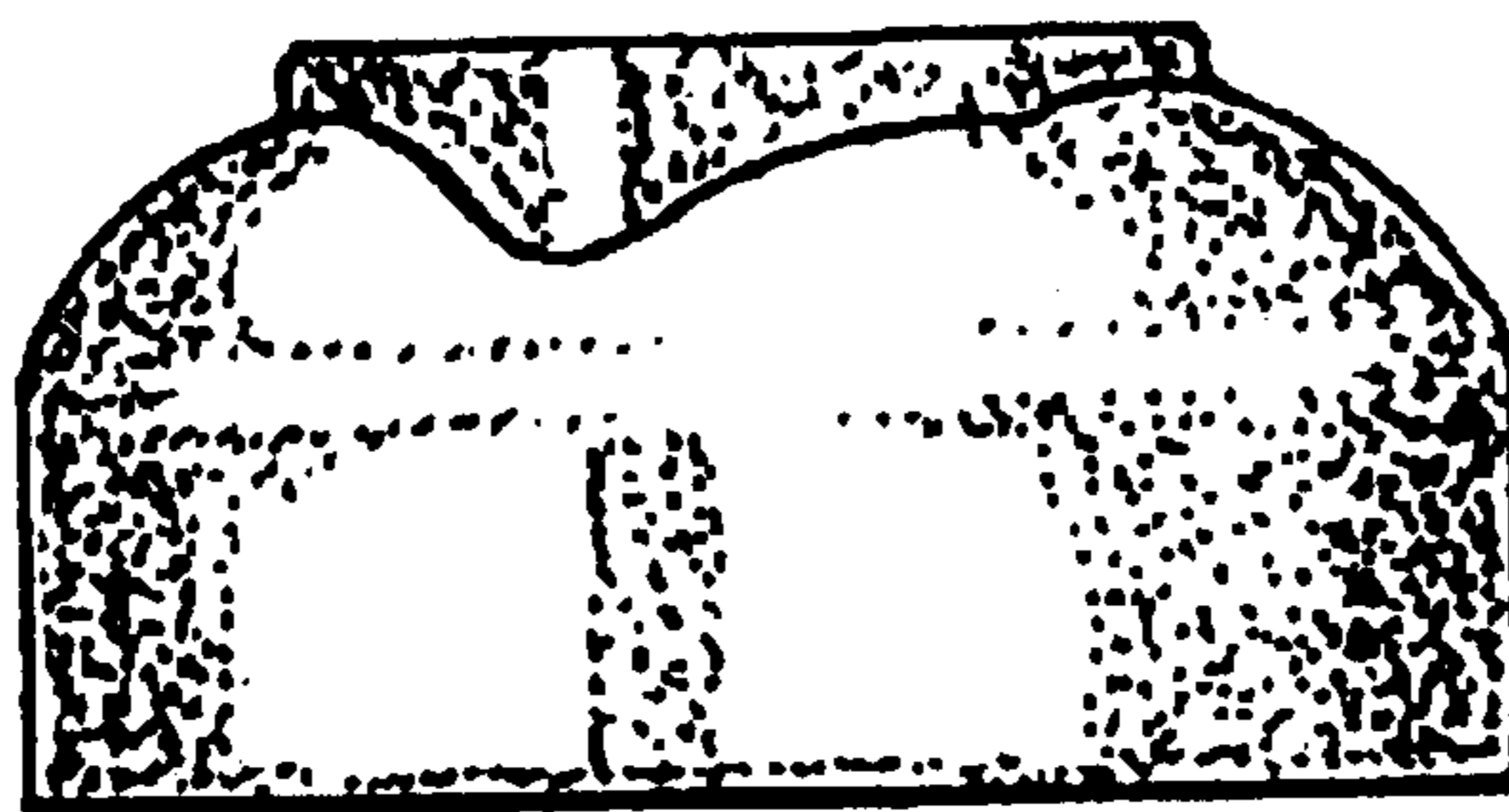

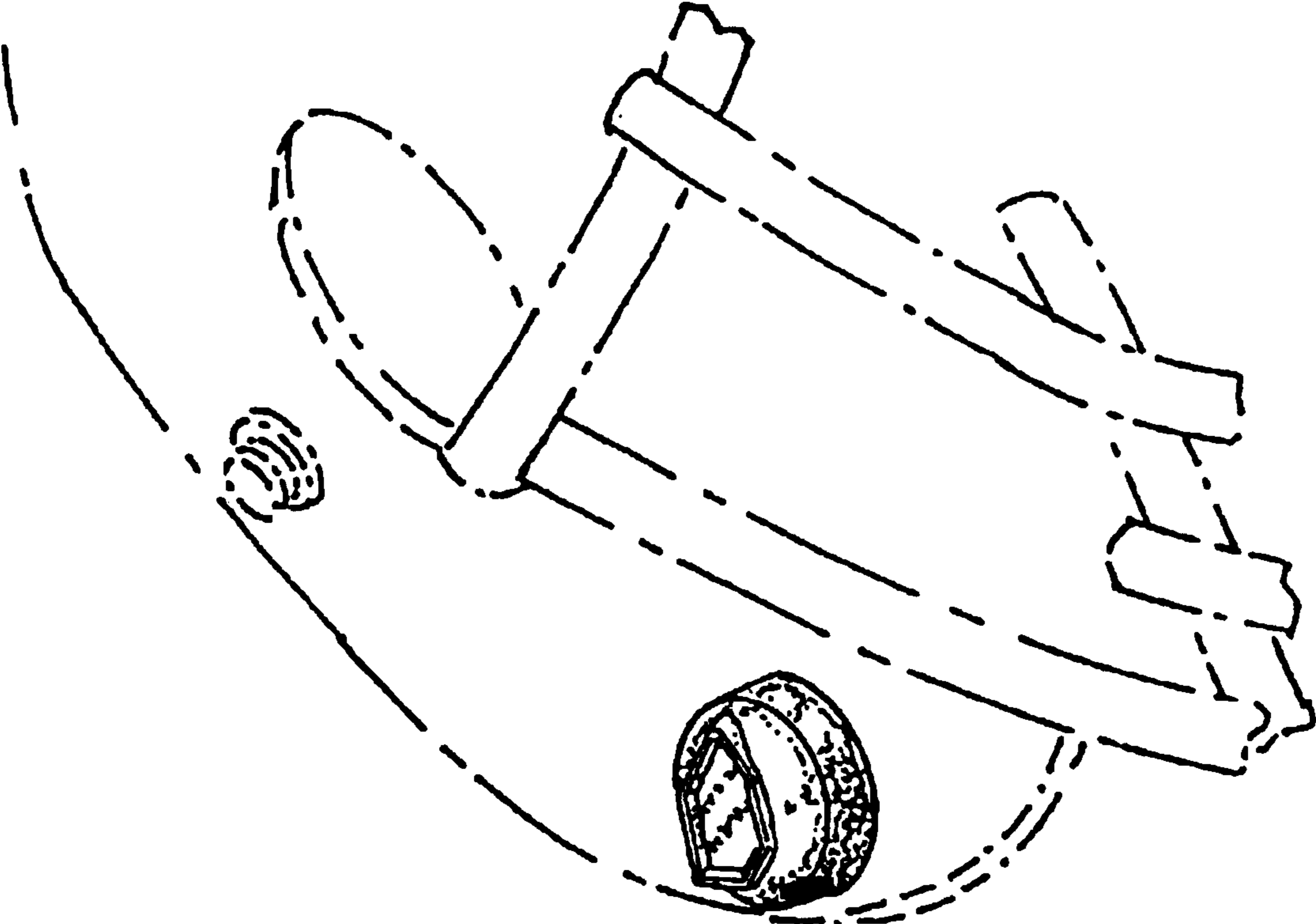
