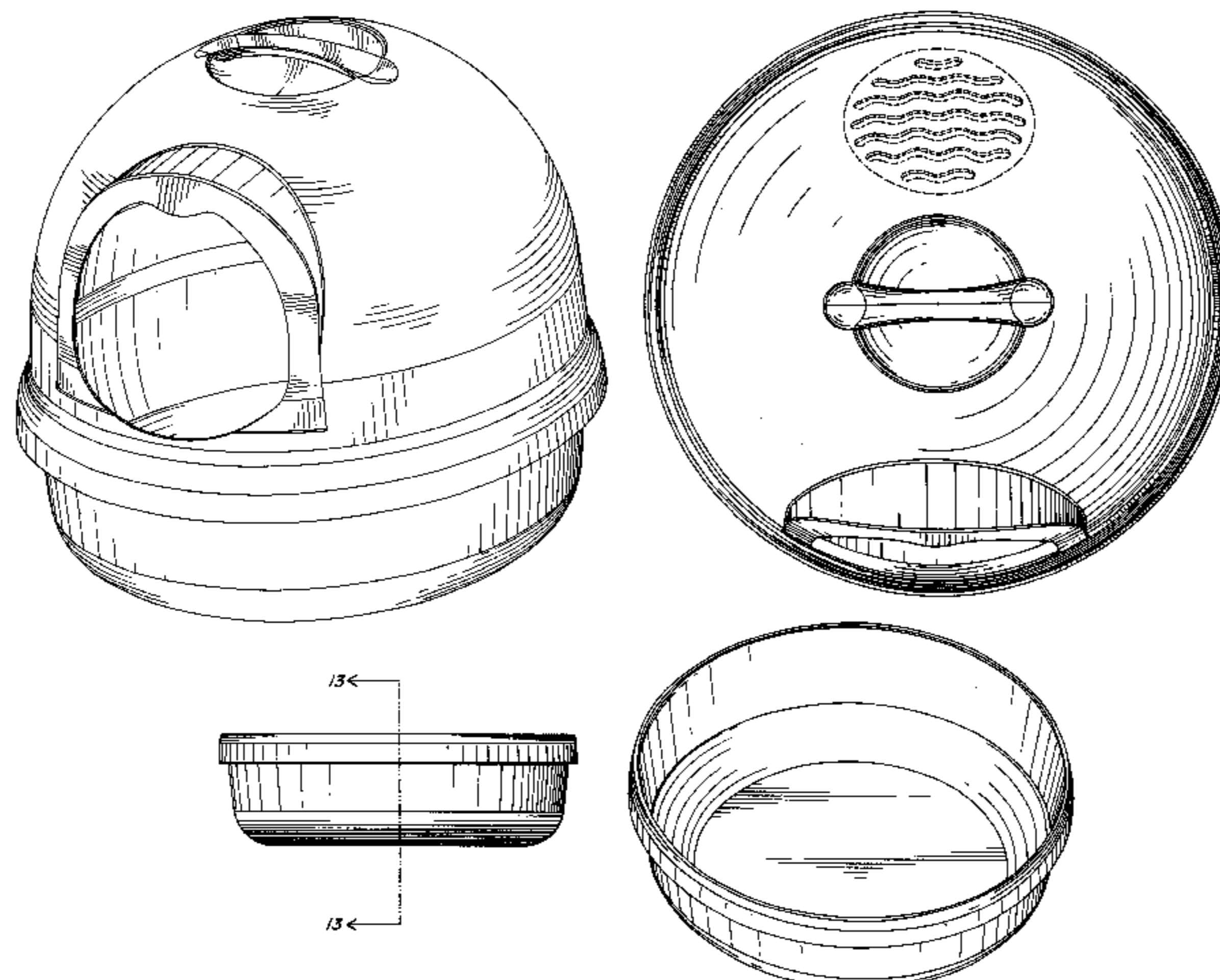
(57) **CLAIM**

The ornamental design for a domed cat litter box, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the front and right side of a domed cat litter box showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a right side elevational view thereof, the left side being a mirror image;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a rear view of the dome top thereof;
 FIG. 8 is a front view of FIG. 7;
 FIG. 9 is a perspective view of FIG. 7;
 FIG. 10 is a left side view of FIG. 7;
 FIG. 11 is a rear perspective view of FIG. 7;
 FIG. 12 is a side view of the base;
 FIG. 13 is a cross-sectional view taken along line 13—13 in FIG. 12;
 FIG. 14 is a top view of FIG. 12; and,
 FIG. 15 is a perspective view of FIG. 12.

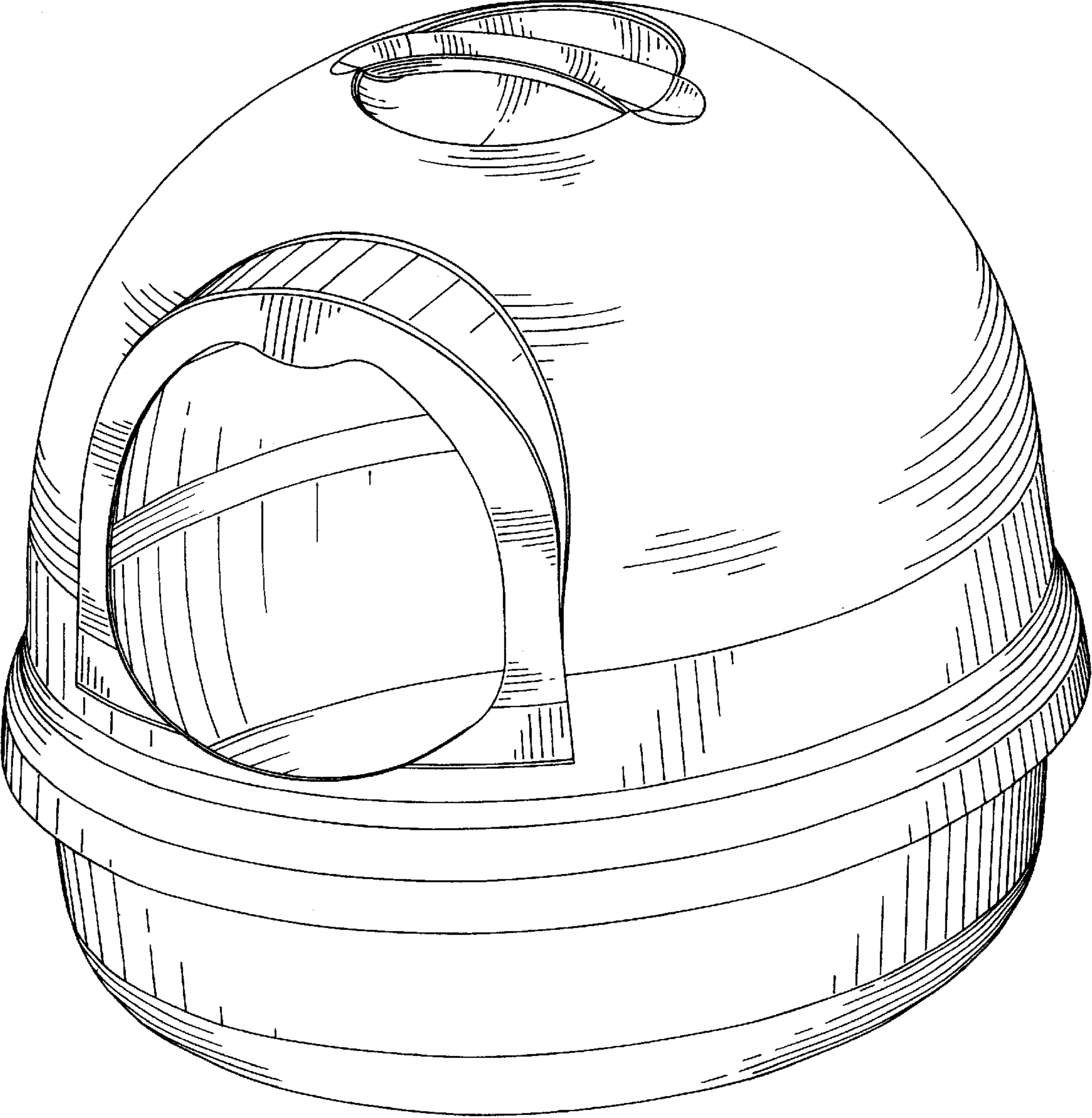

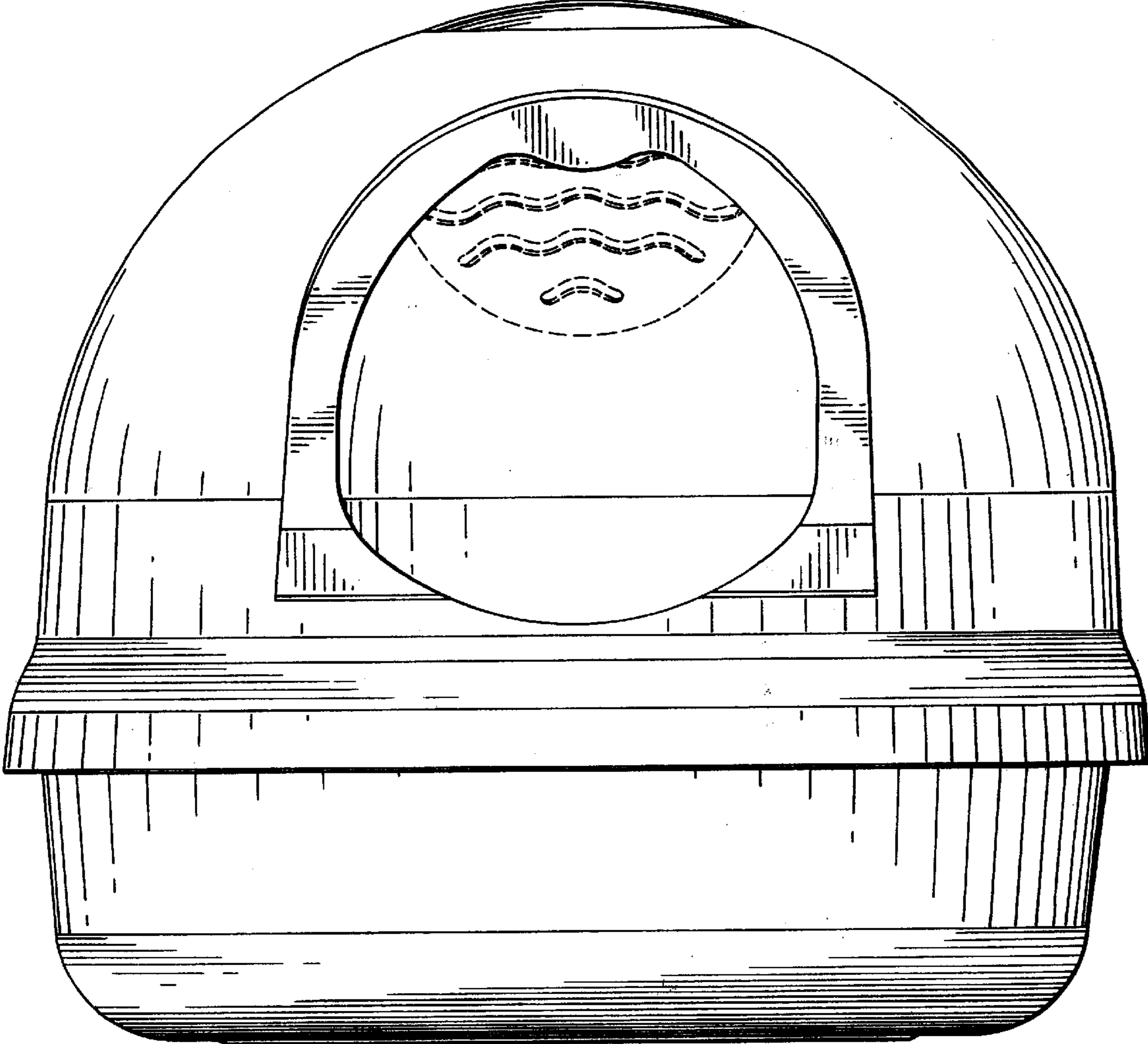

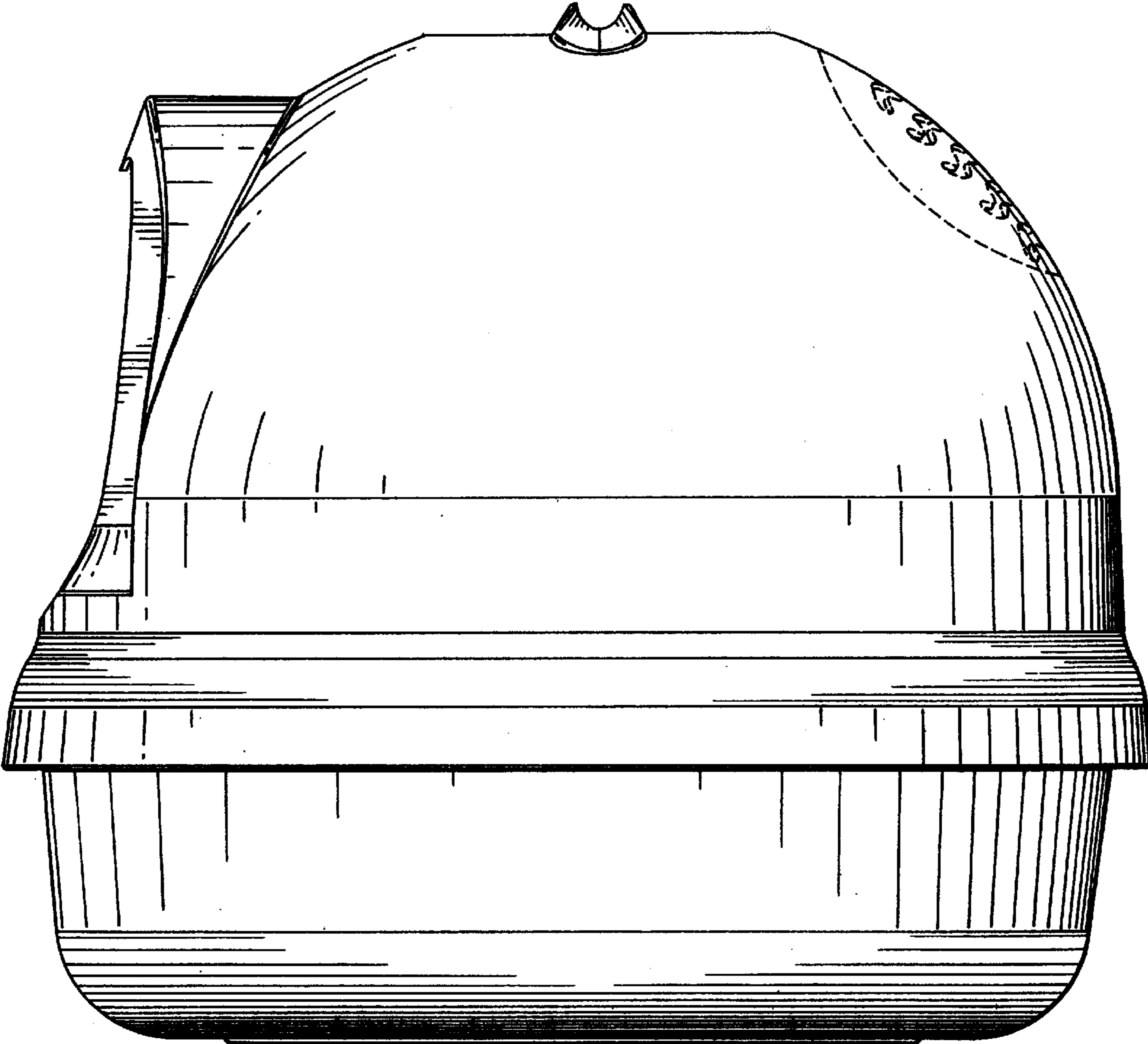

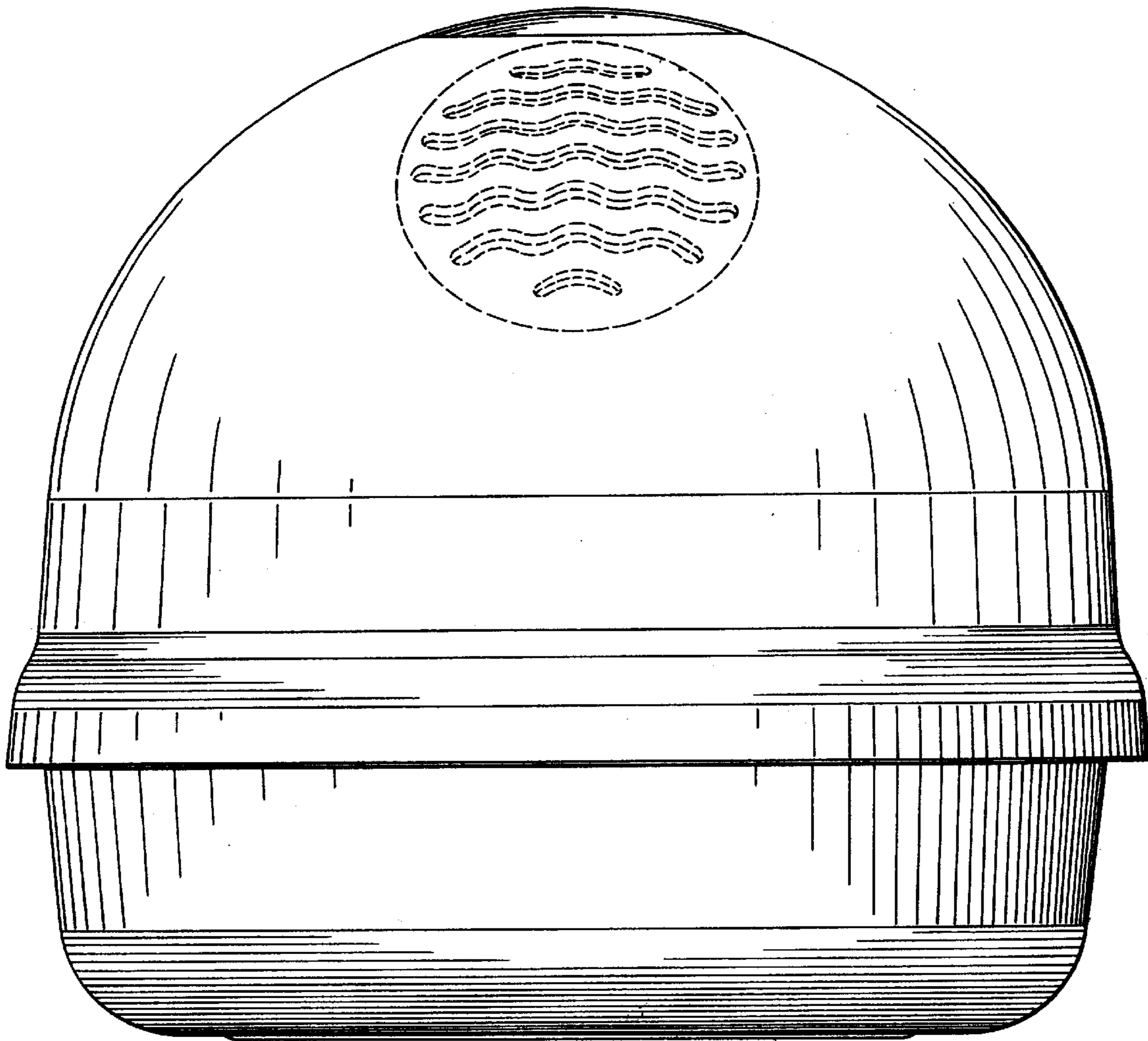

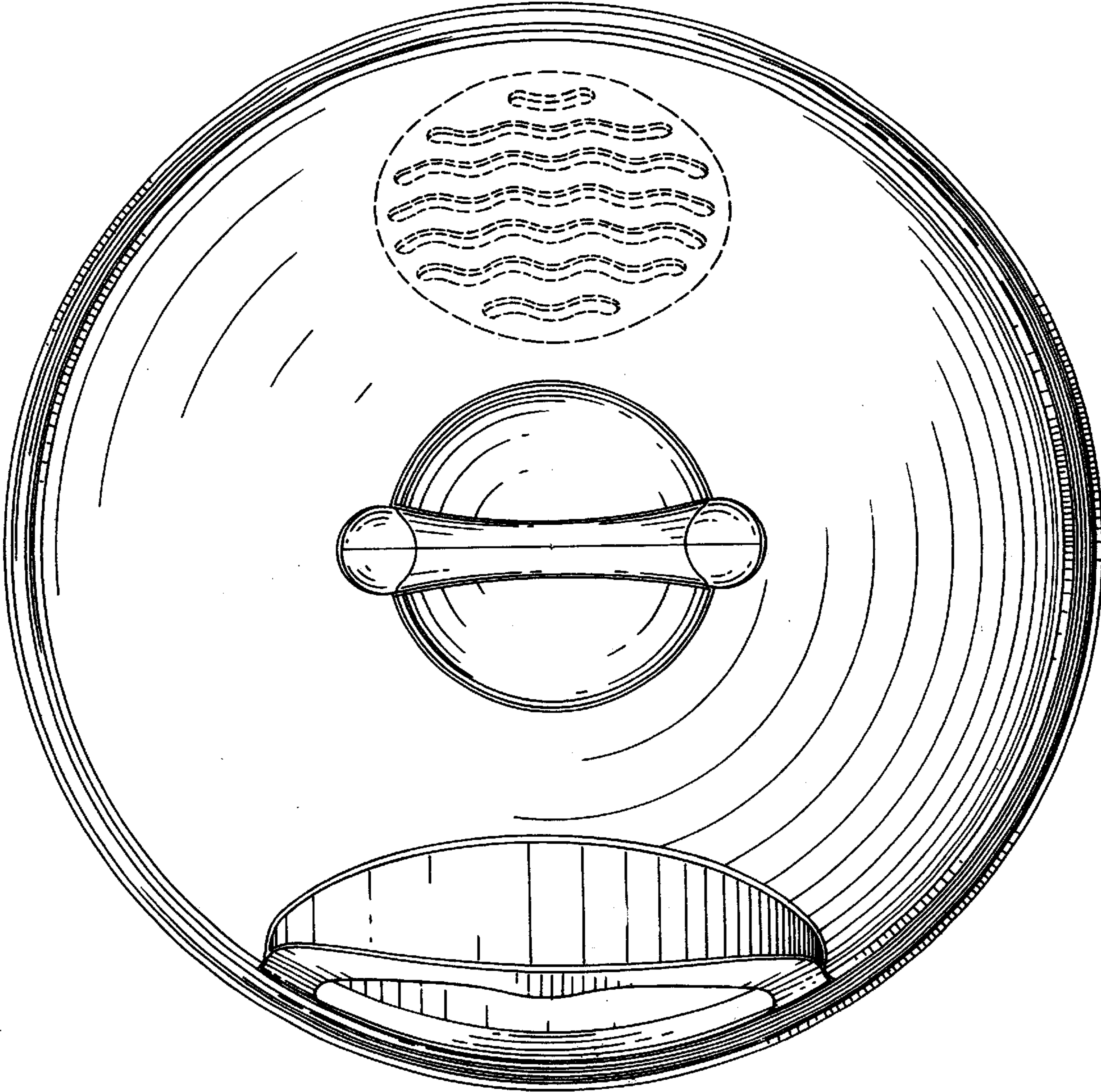

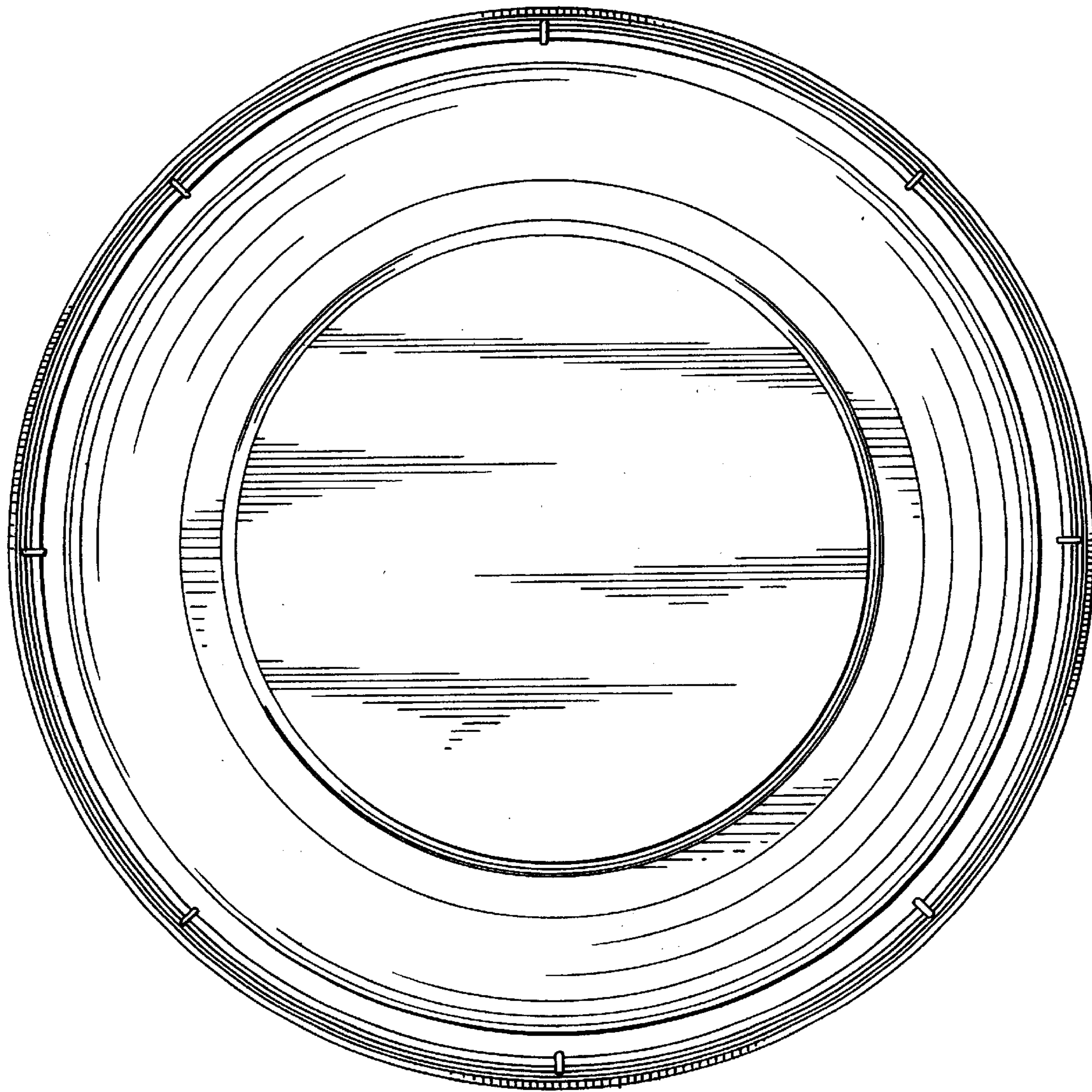

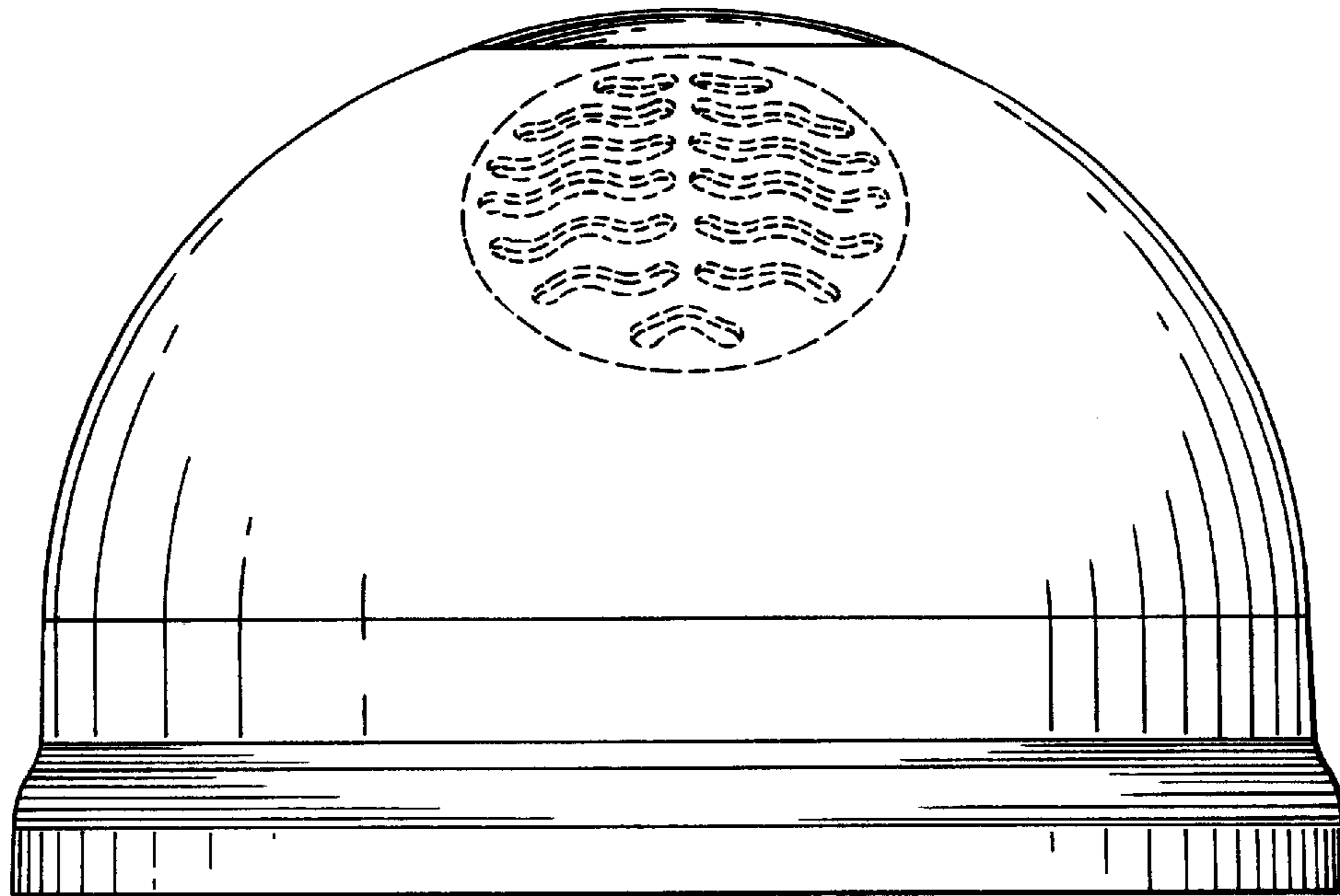

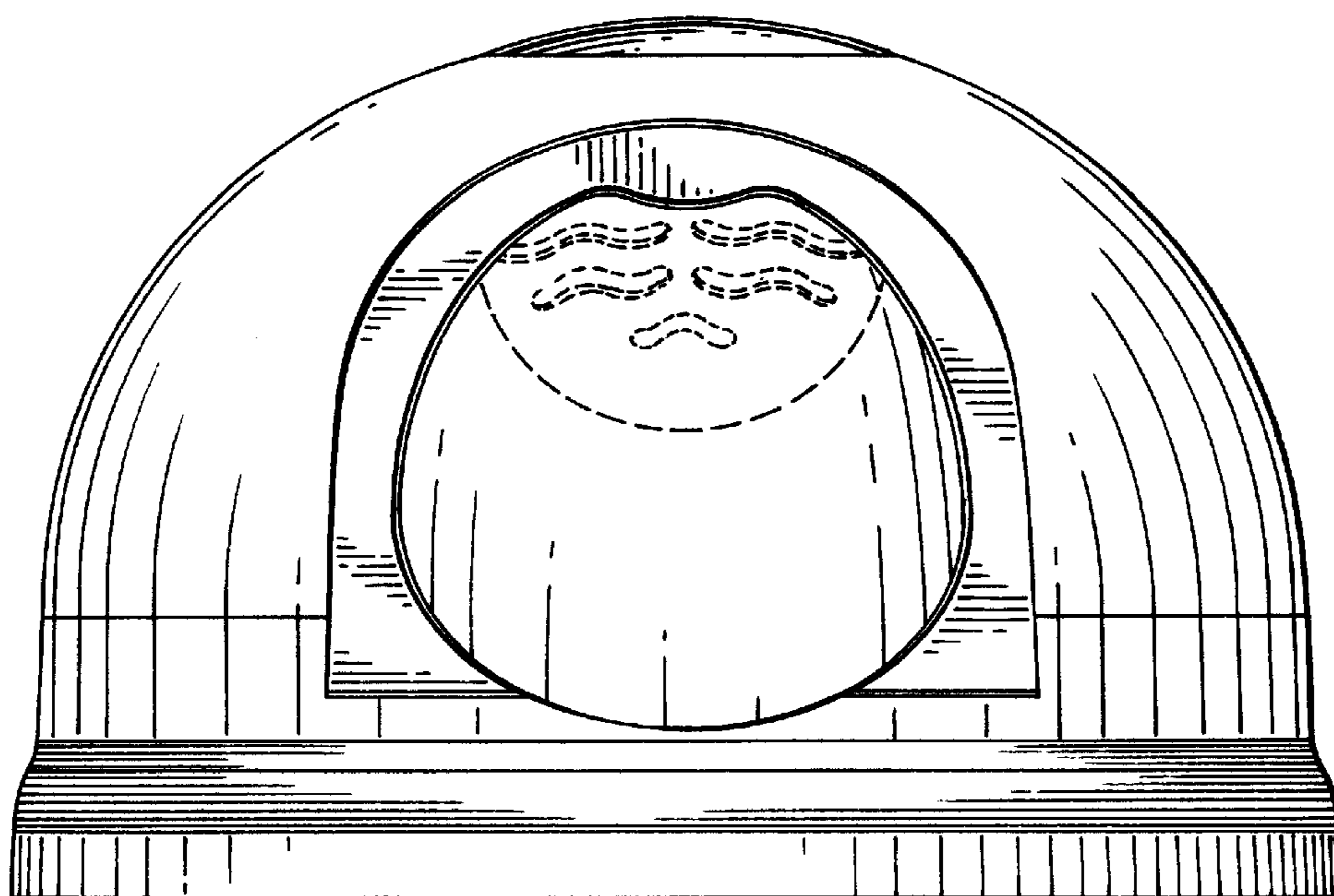

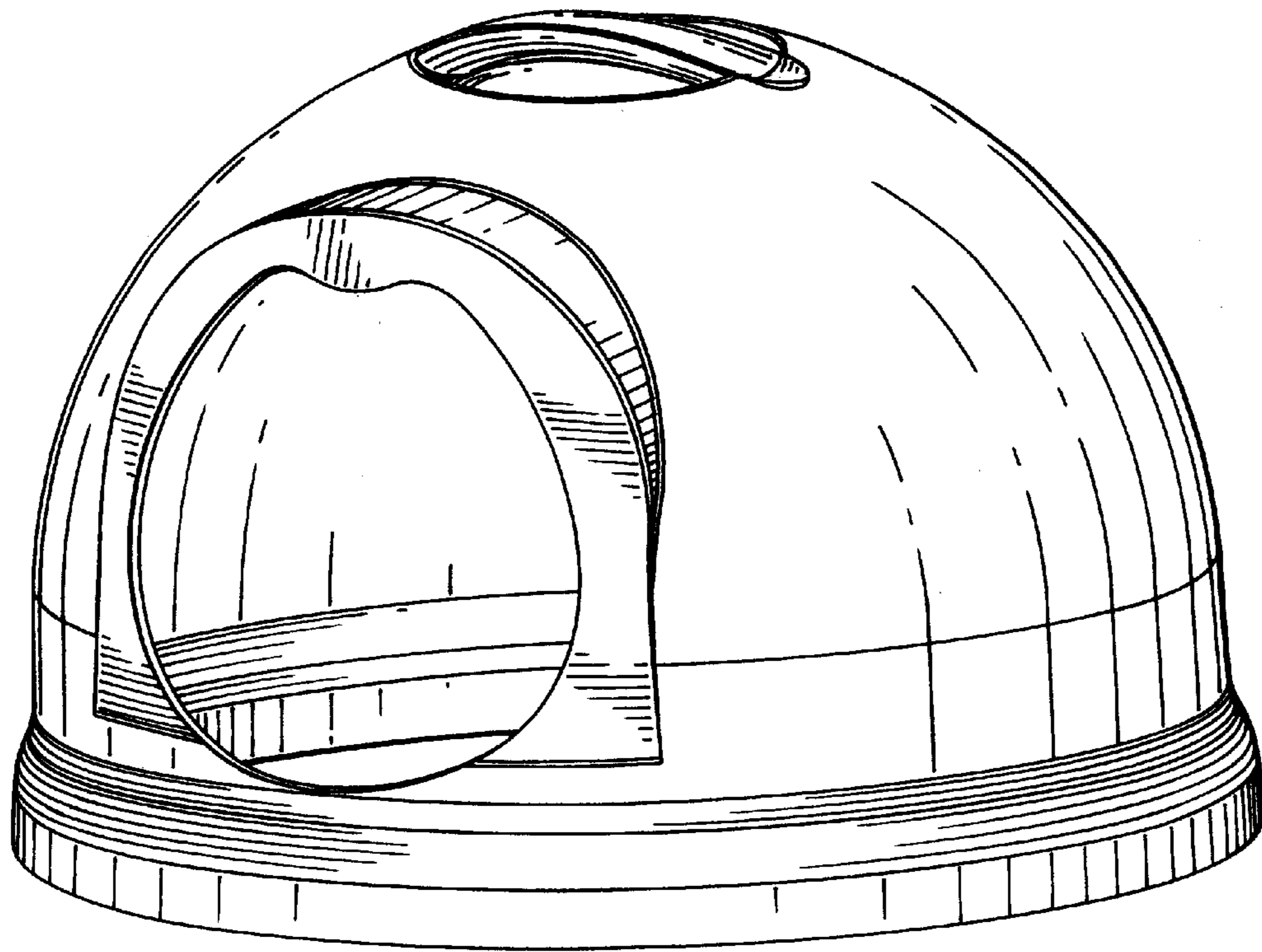

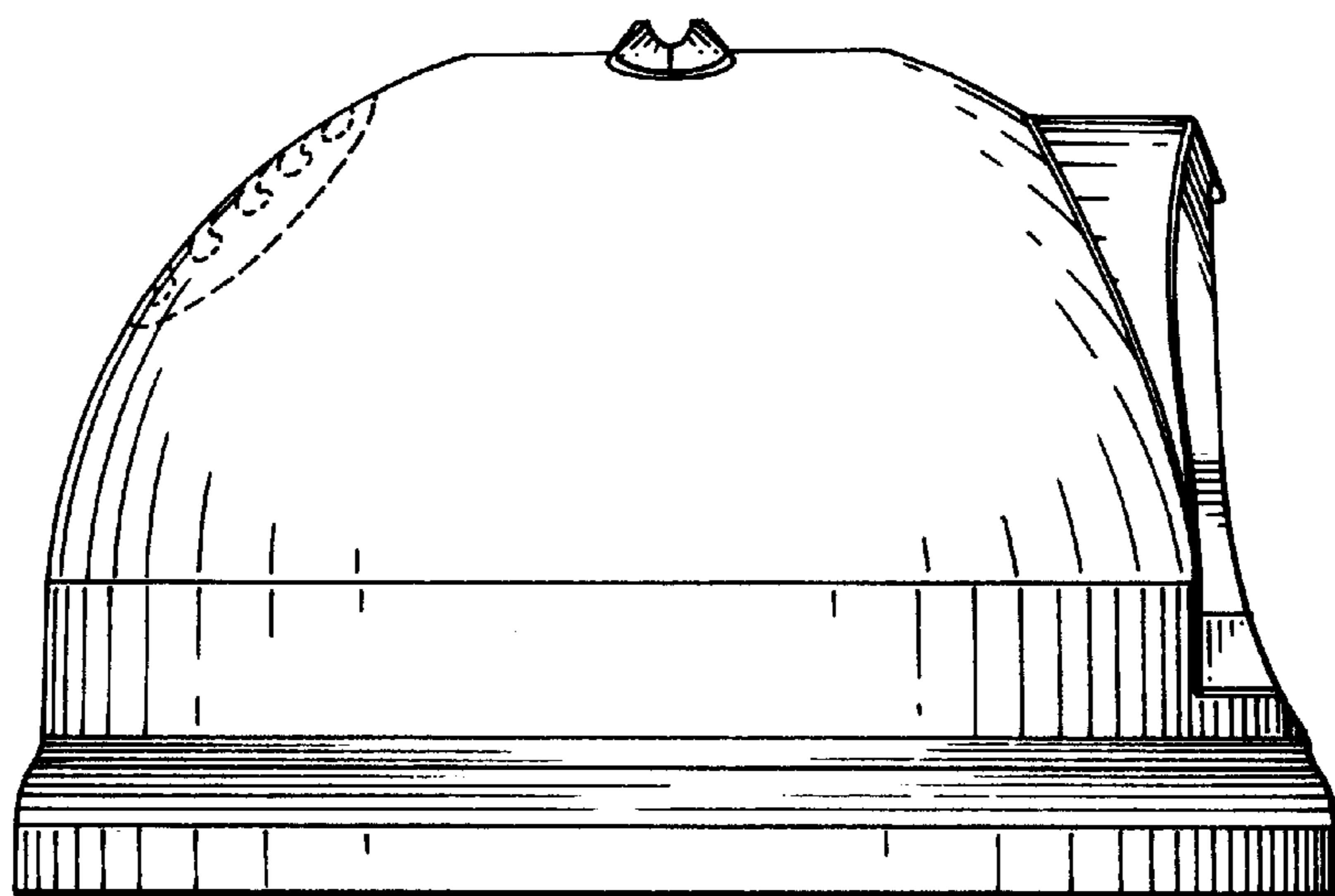

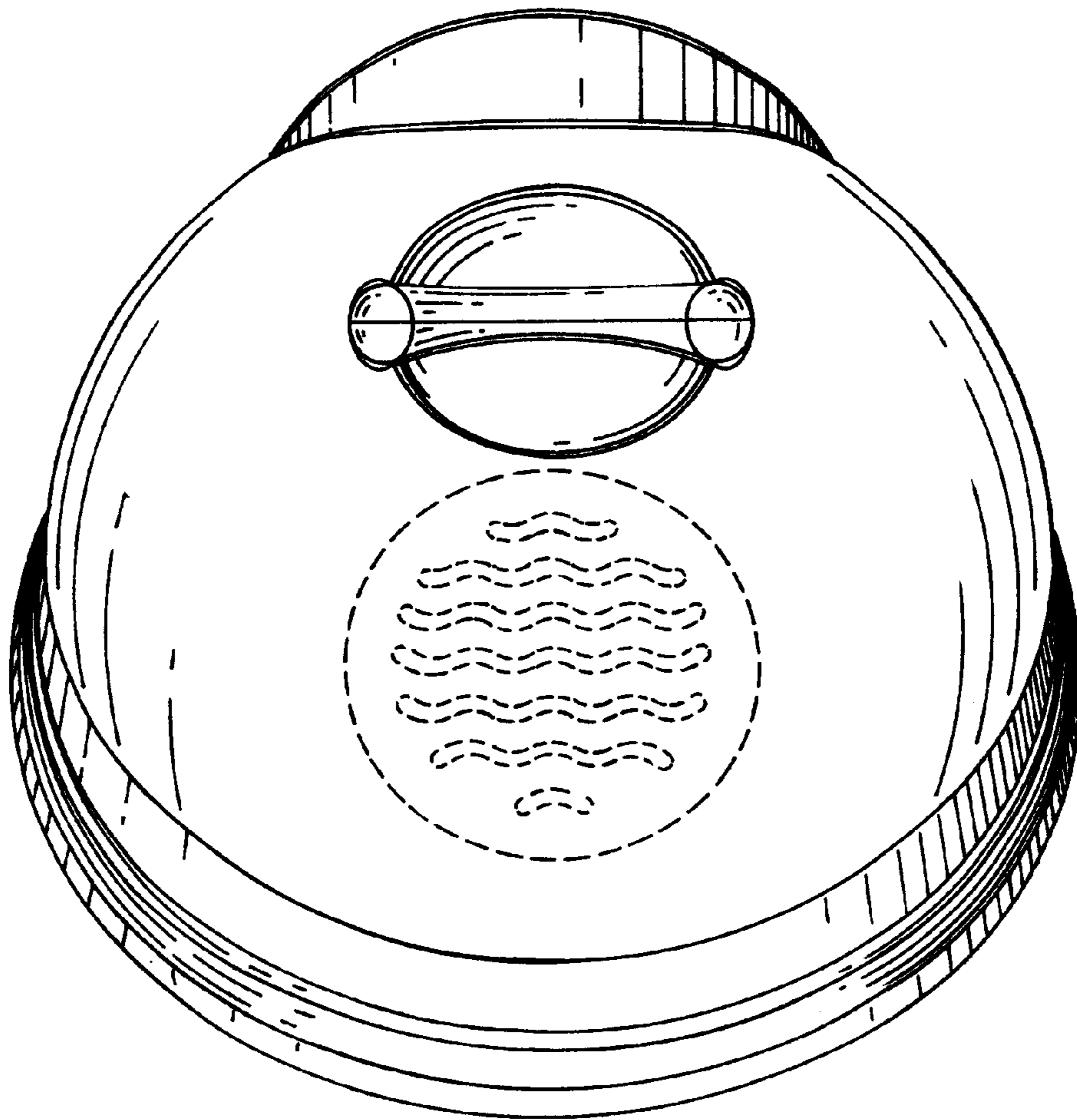

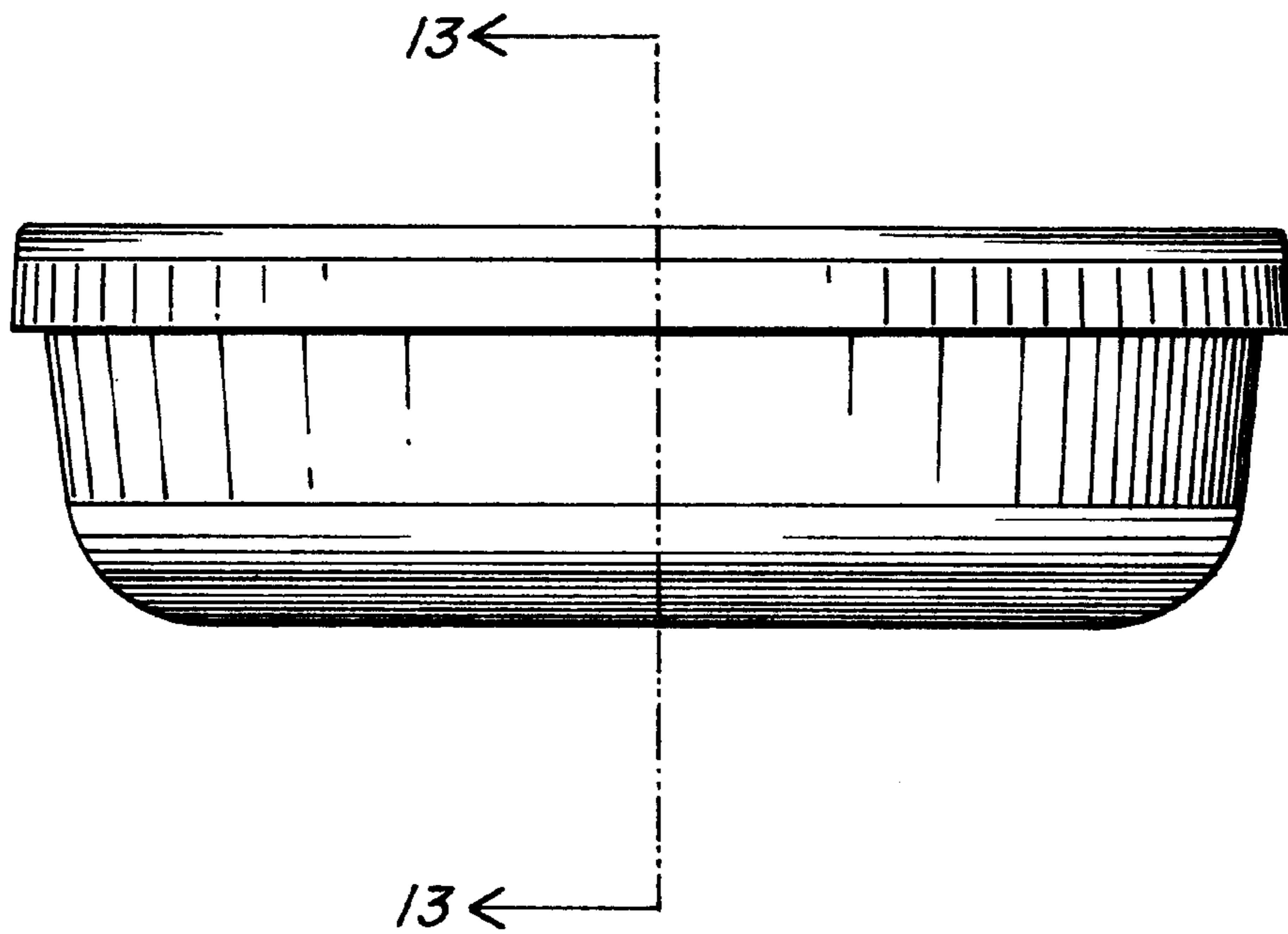

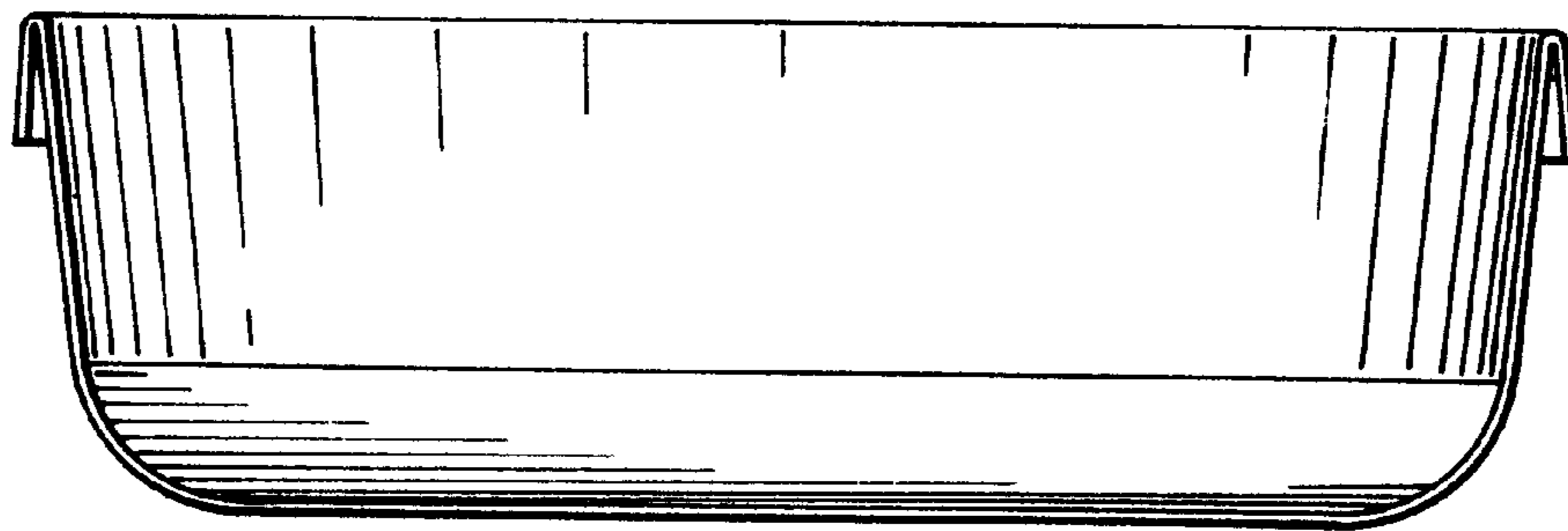

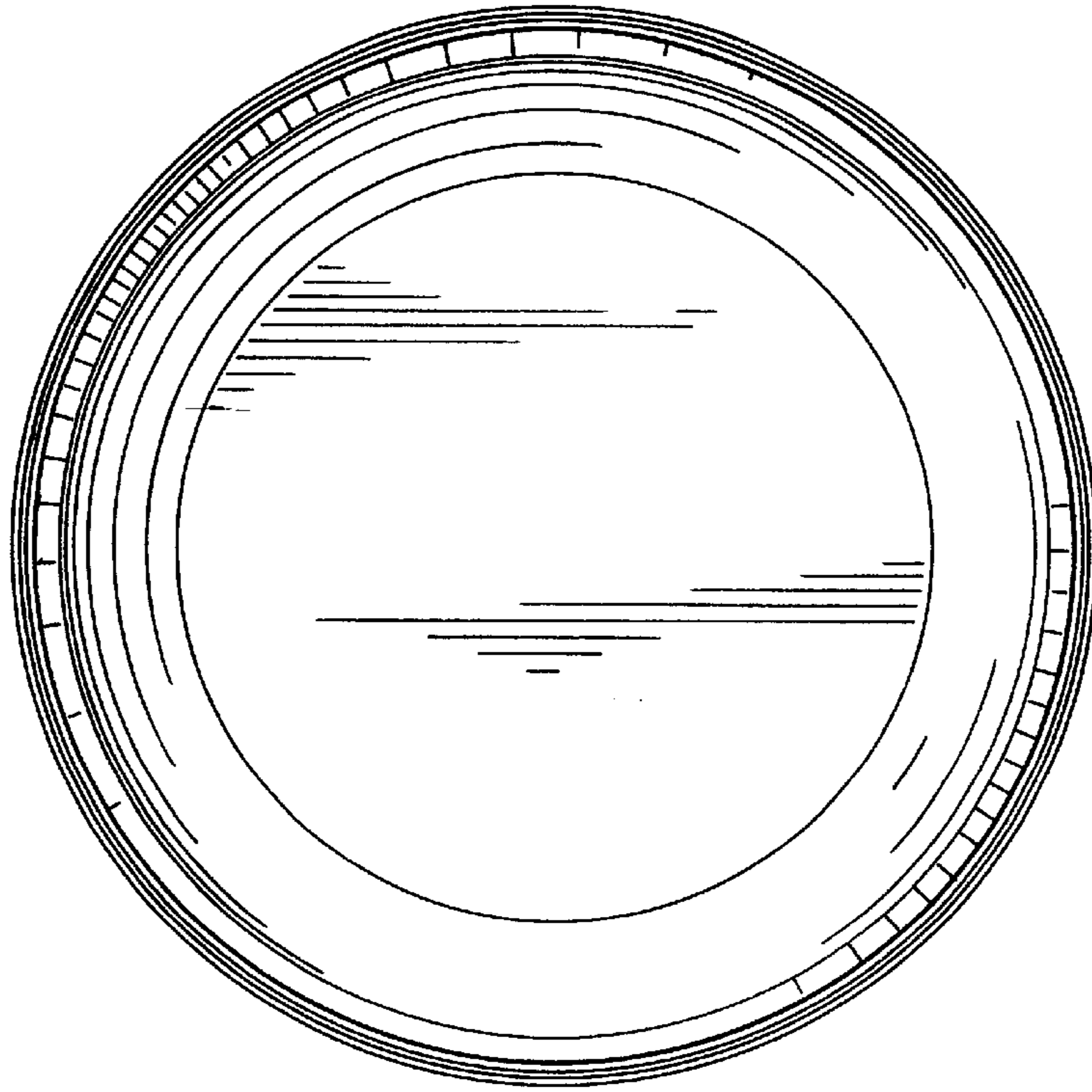

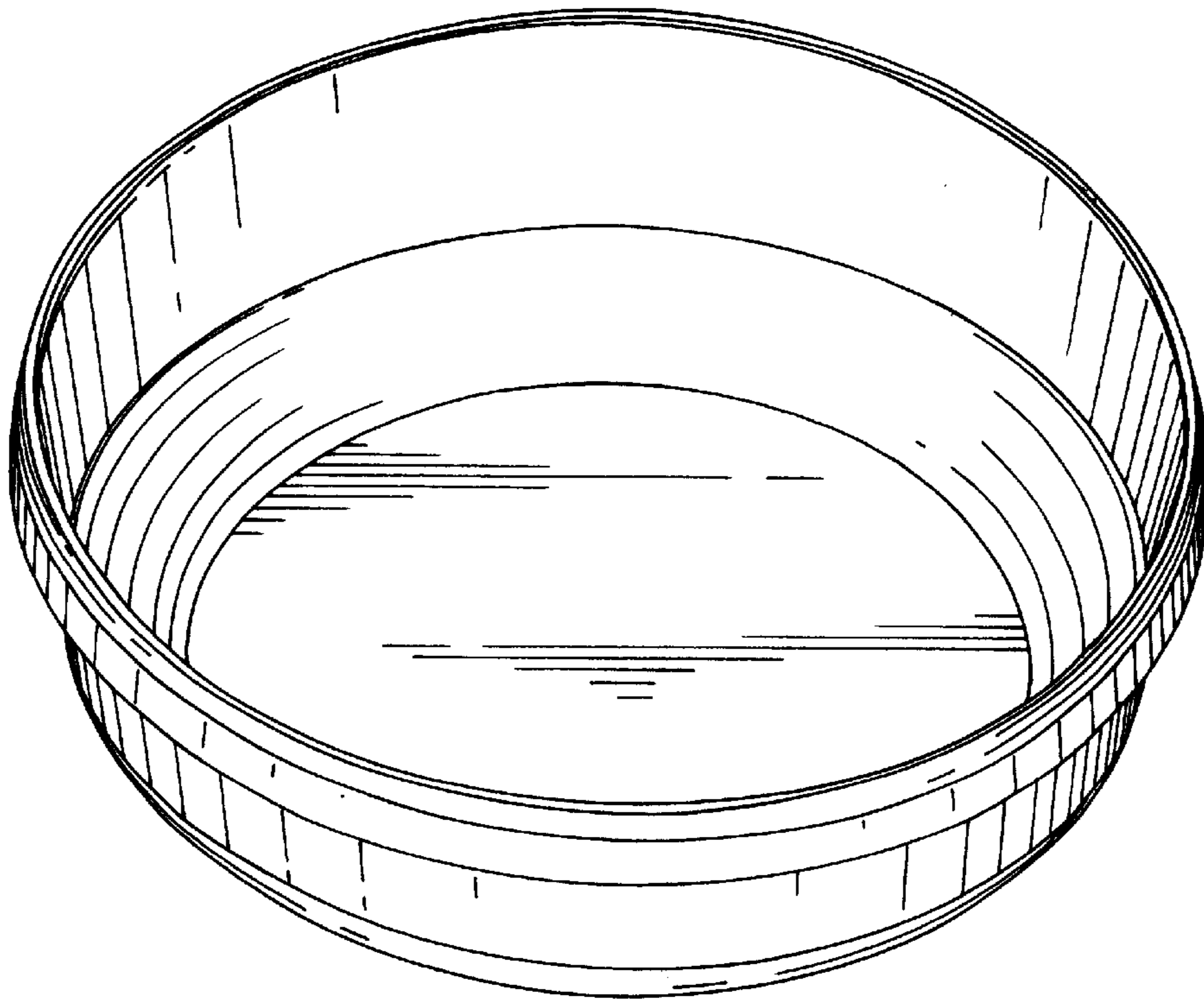
