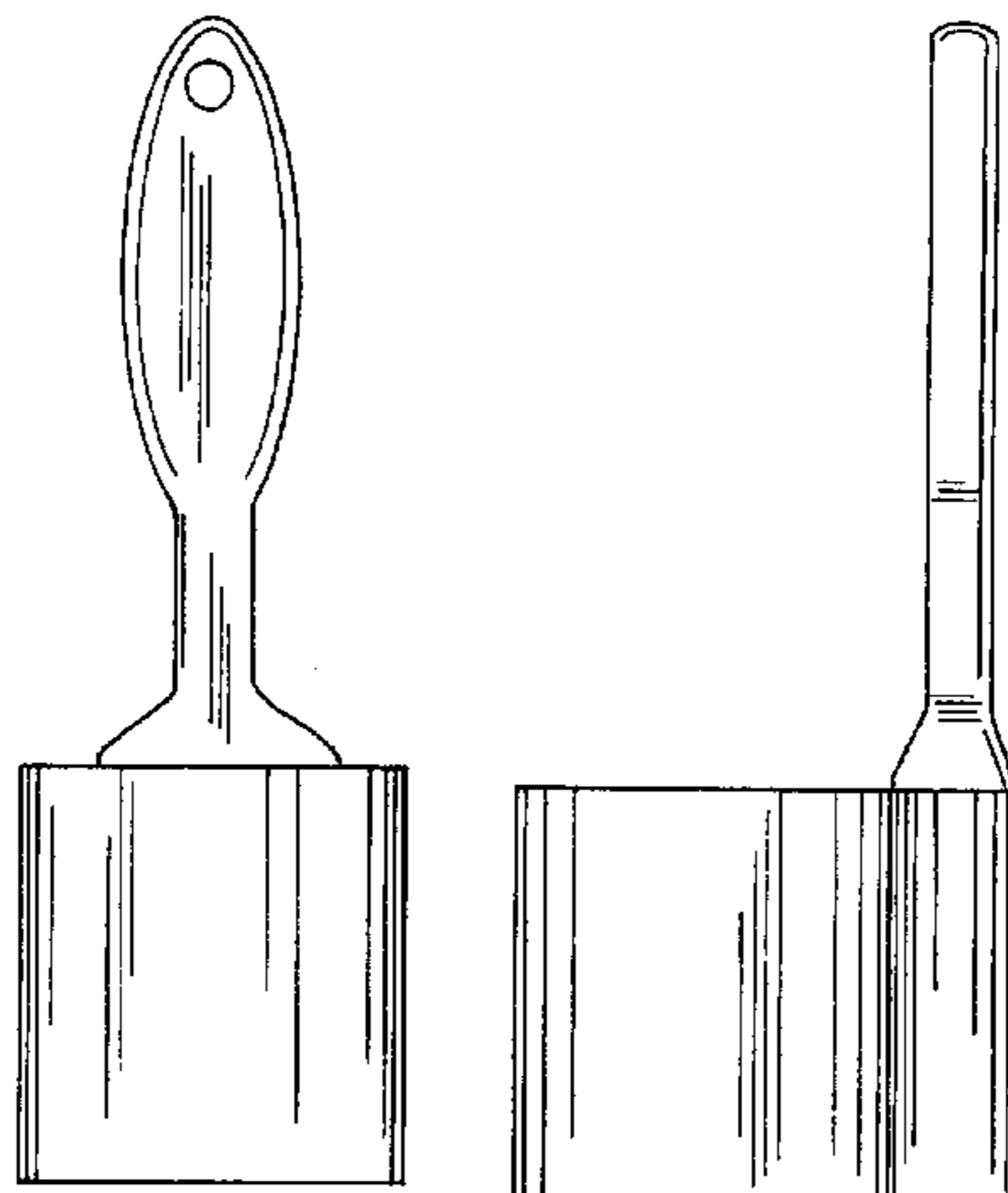
FIG. 1 is a rear elevational view of a combined candy brush and container therefor showing my new design;

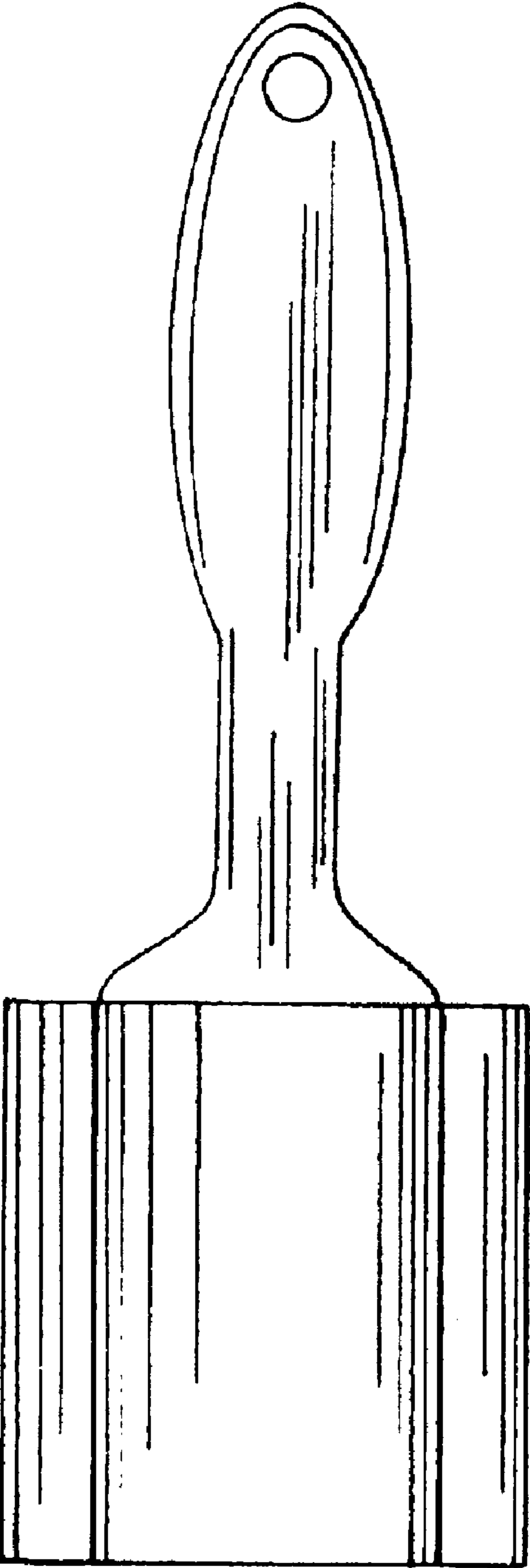

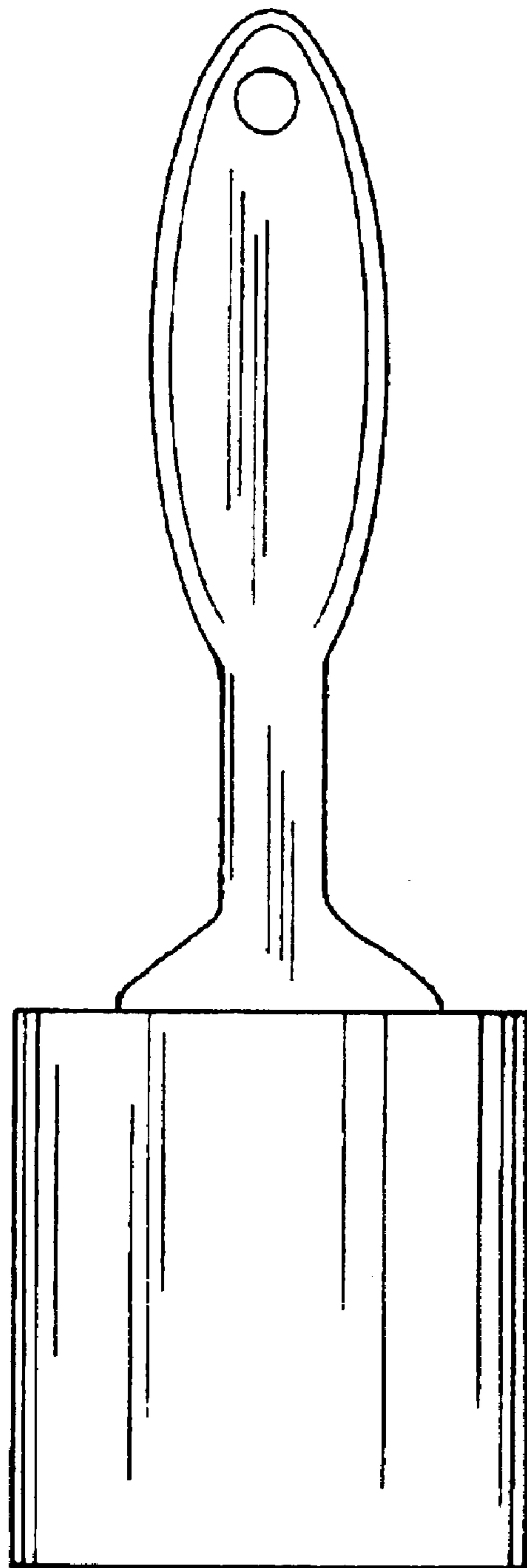

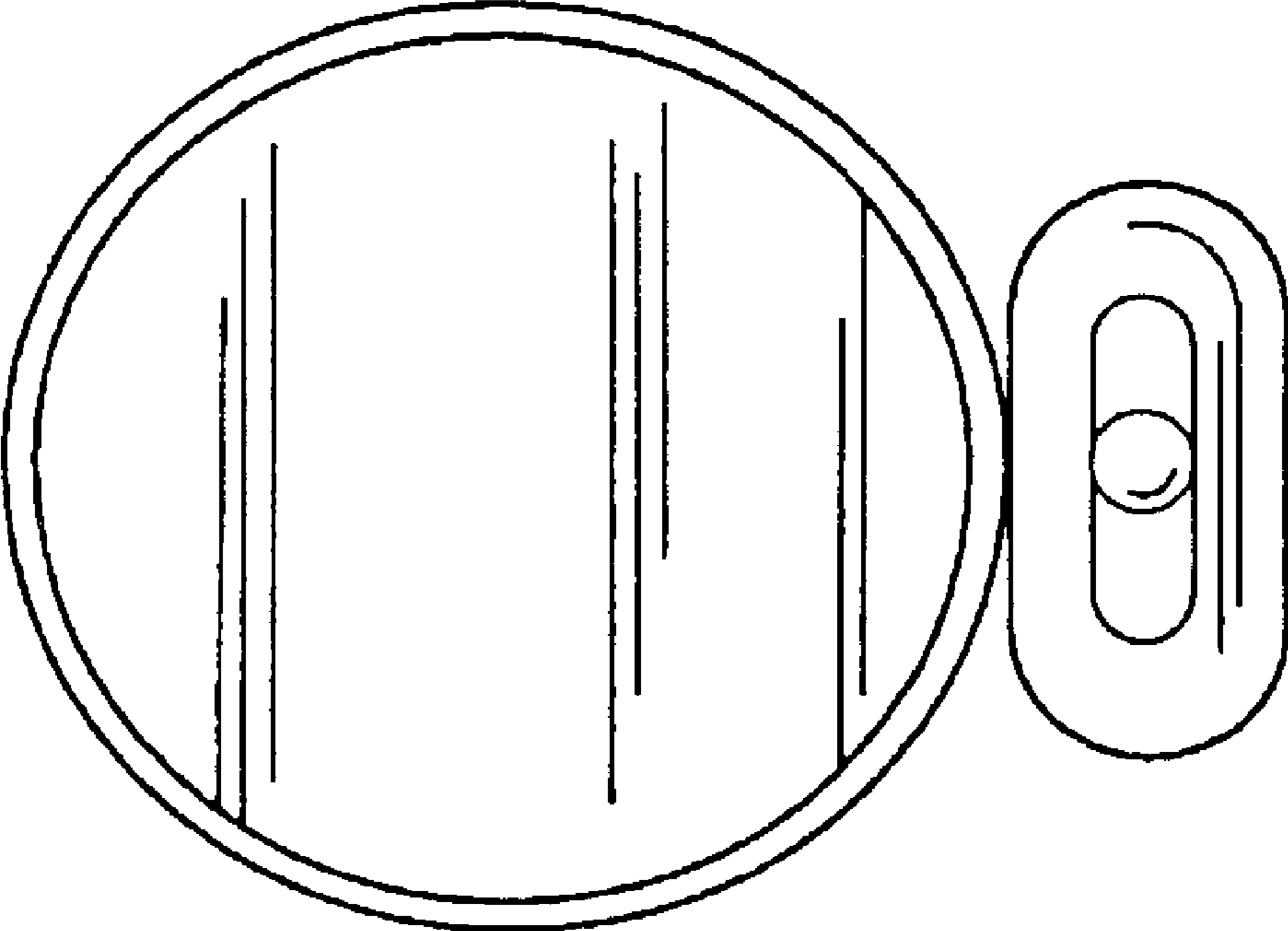

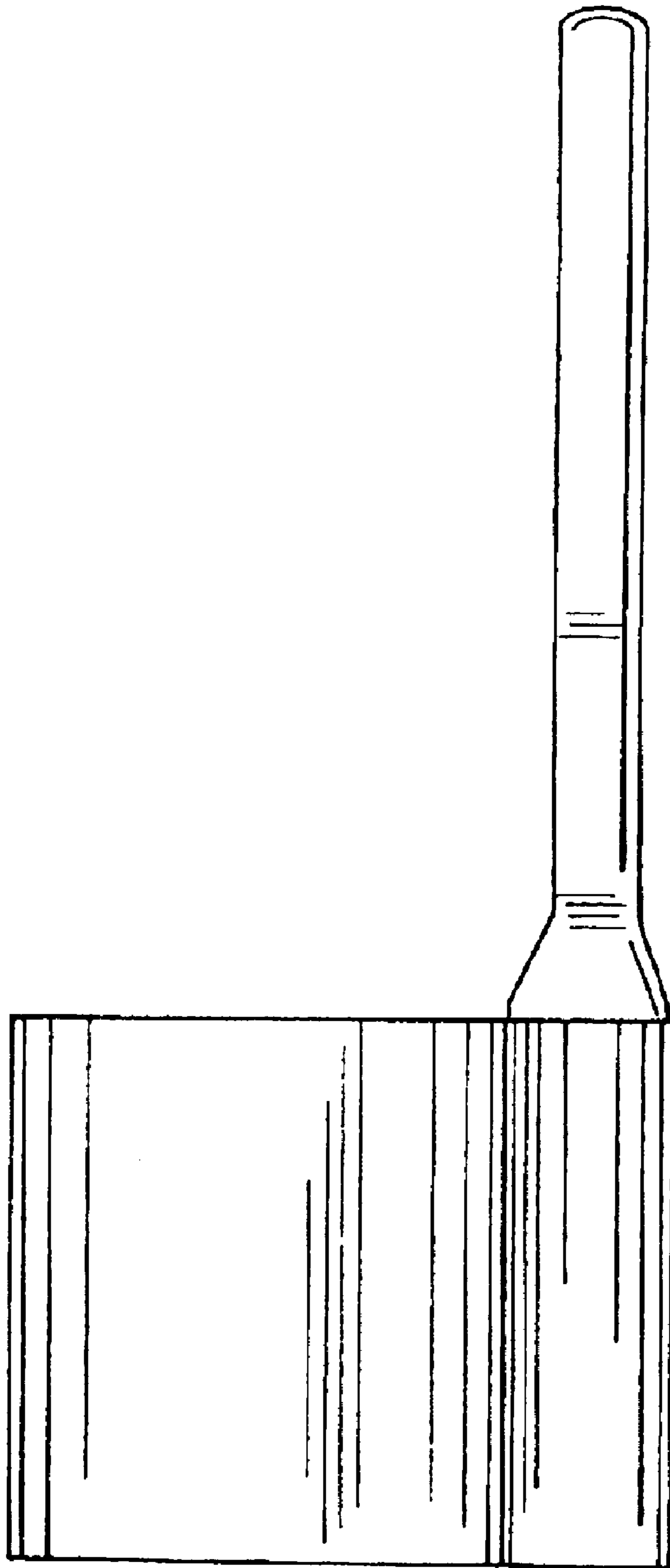
