(57) **CLAIM**

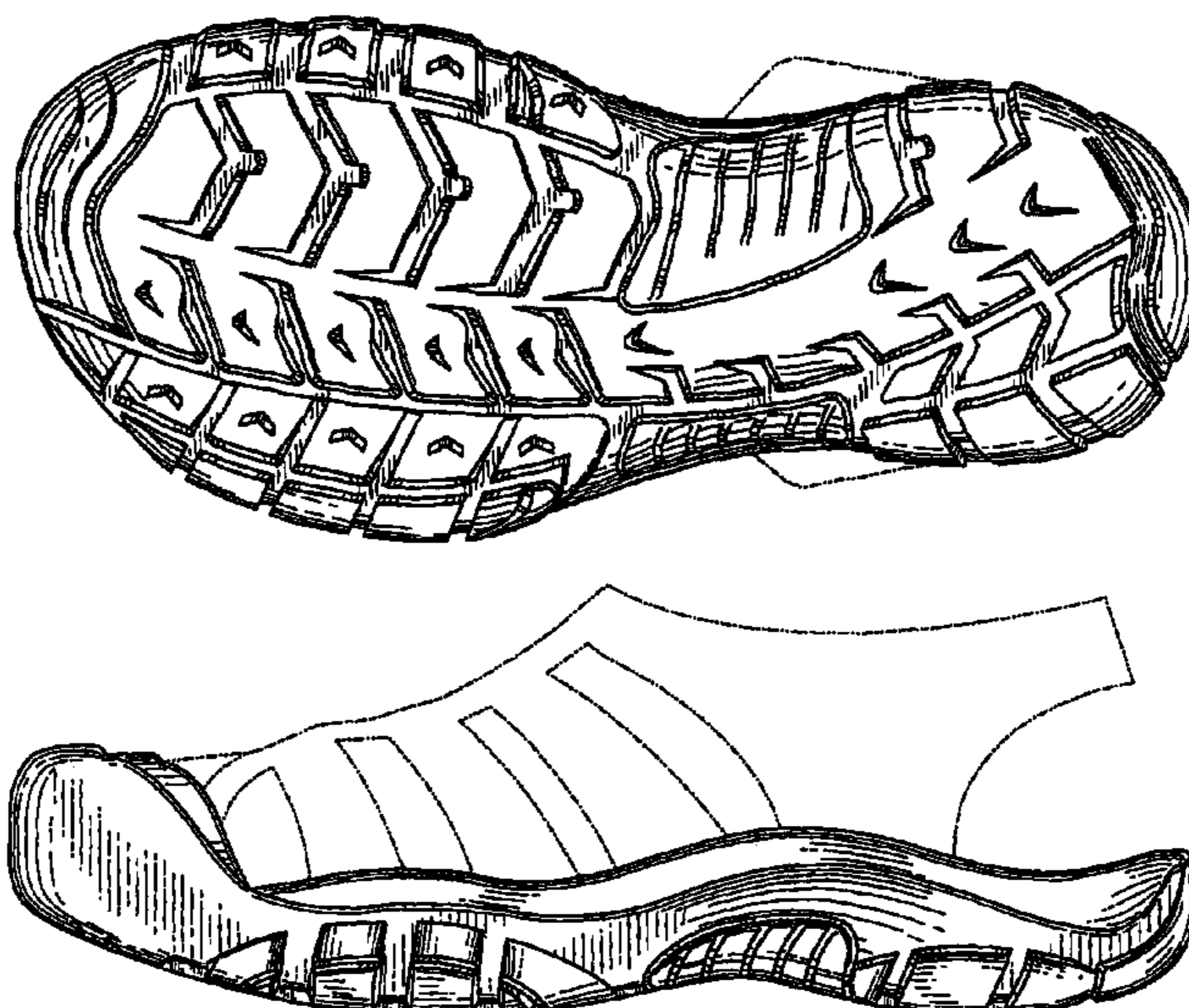
The ornamental design for a cleated sandal sole, as shown and described.

DESCRIPTION

FIG. 1 is a downward, offset front perspective view of the sandal outsole;
FIG. 2 is a top view of the sandal outsole;
FIG. 3 is a bottom view of the sandal outsole;
FIG. 4 is an inside side view of the sandal outsole;
FIG. 5 is an outside side view of the sandal outsole;
FIG. 6 is a front view of the sandal outsole;
FIG. 7 is a rear view of the sandal outsole; and,
FIG. 8 a perspective view of the bottom of the sandal outsole.

The broken lines showing the upper throughout the views are included for the purpose of showing the portion of the design that forms no part of the claim.

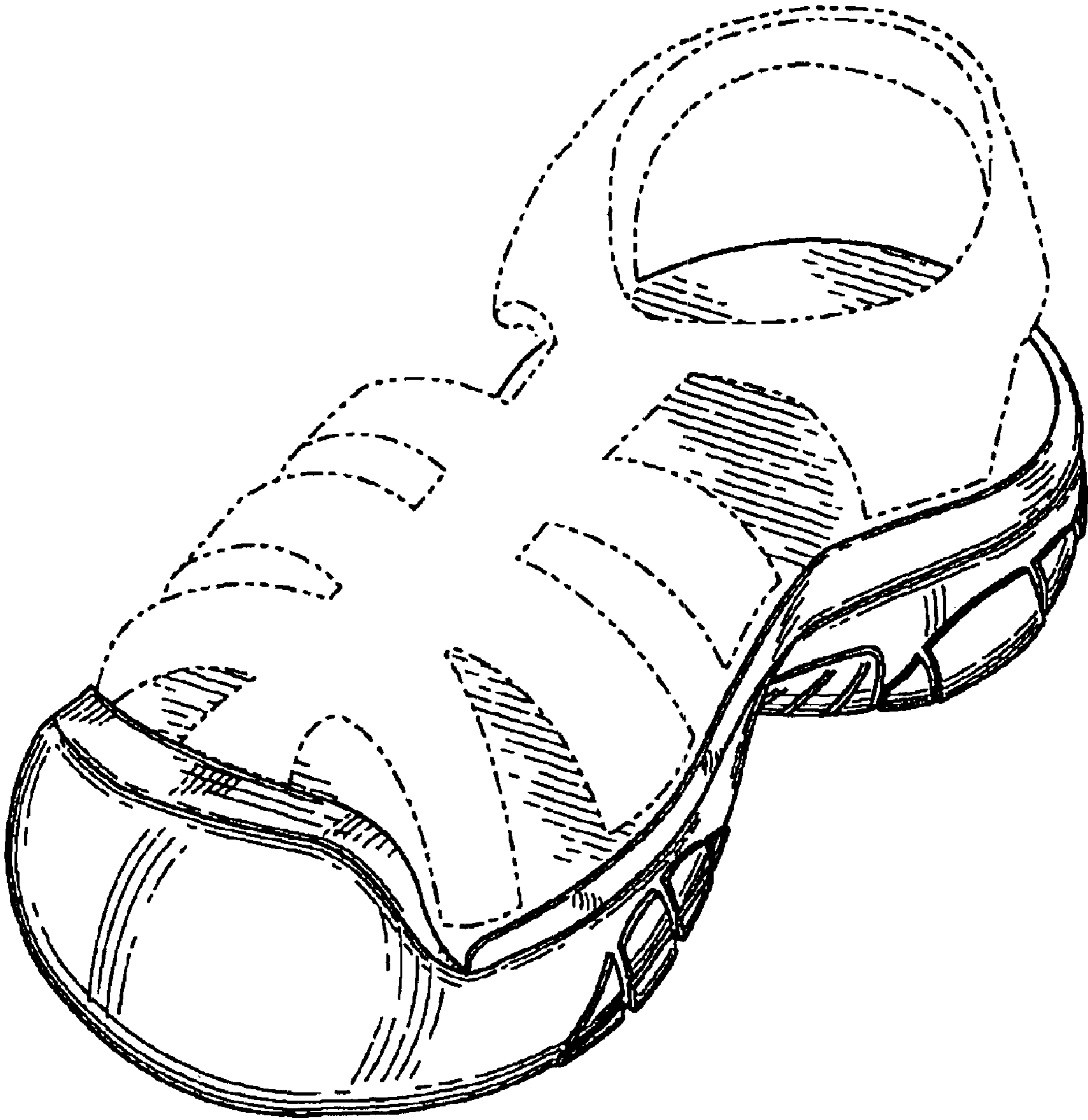

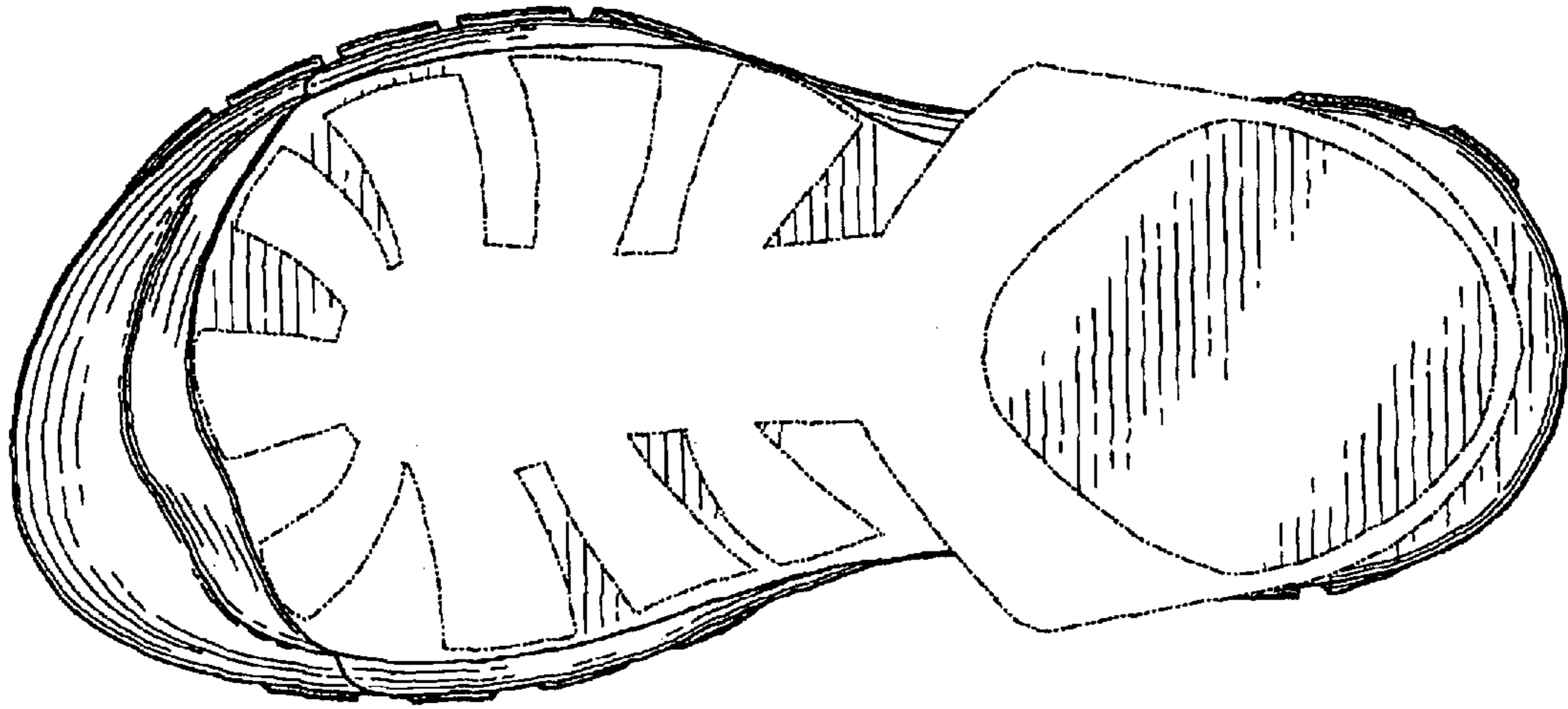

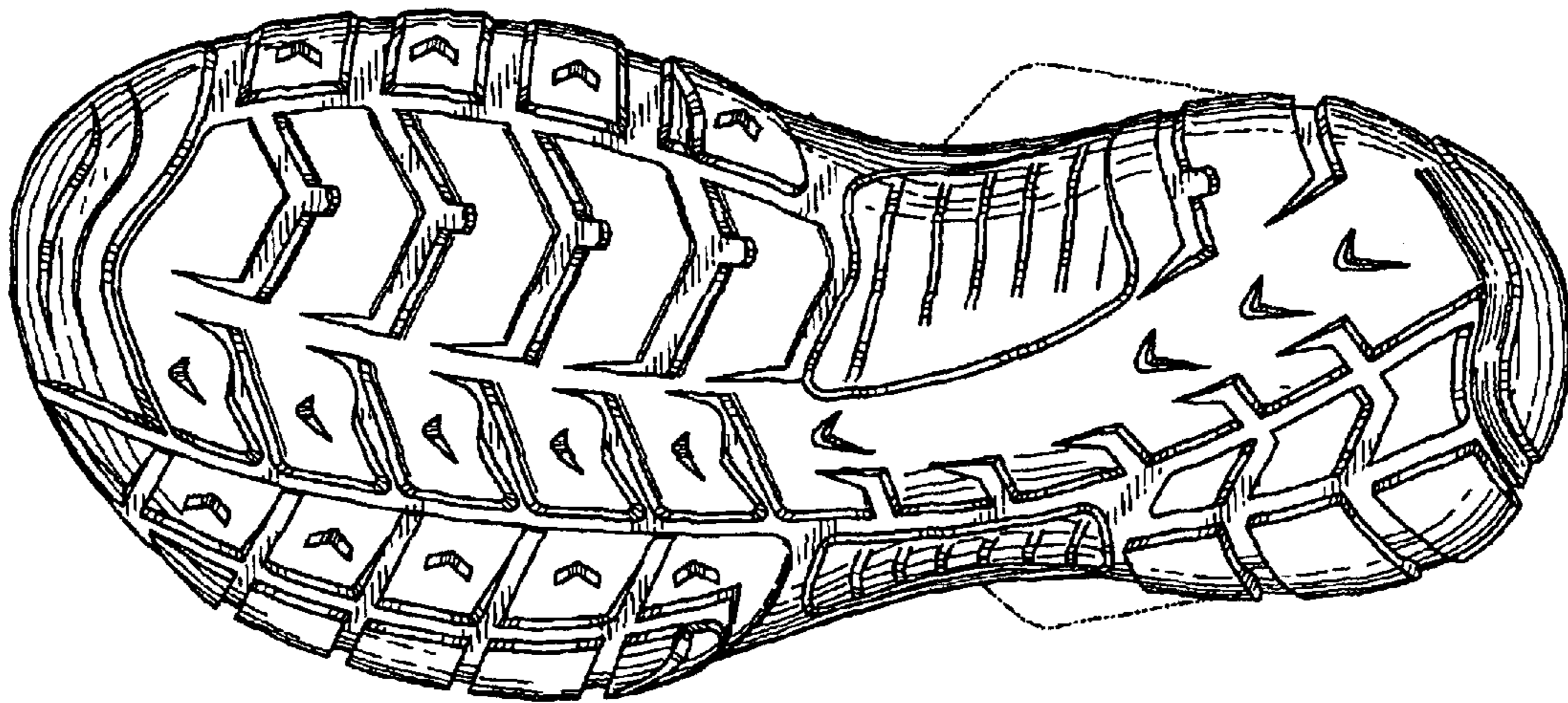

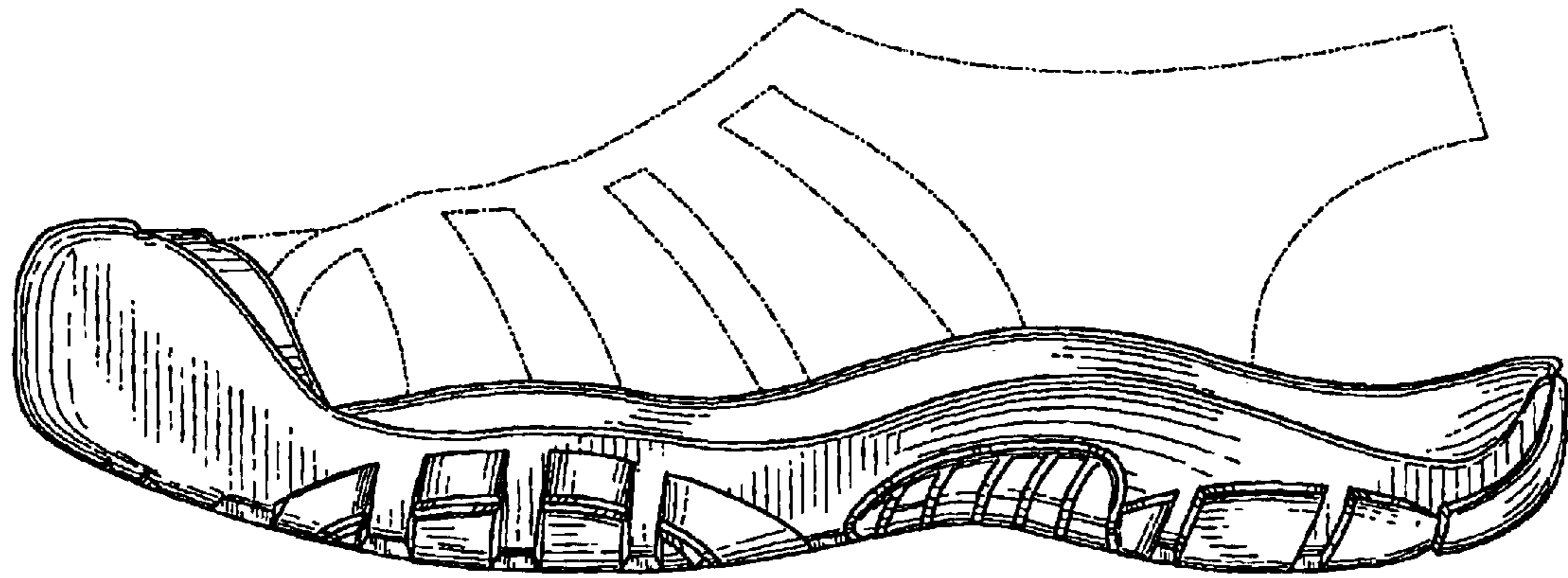

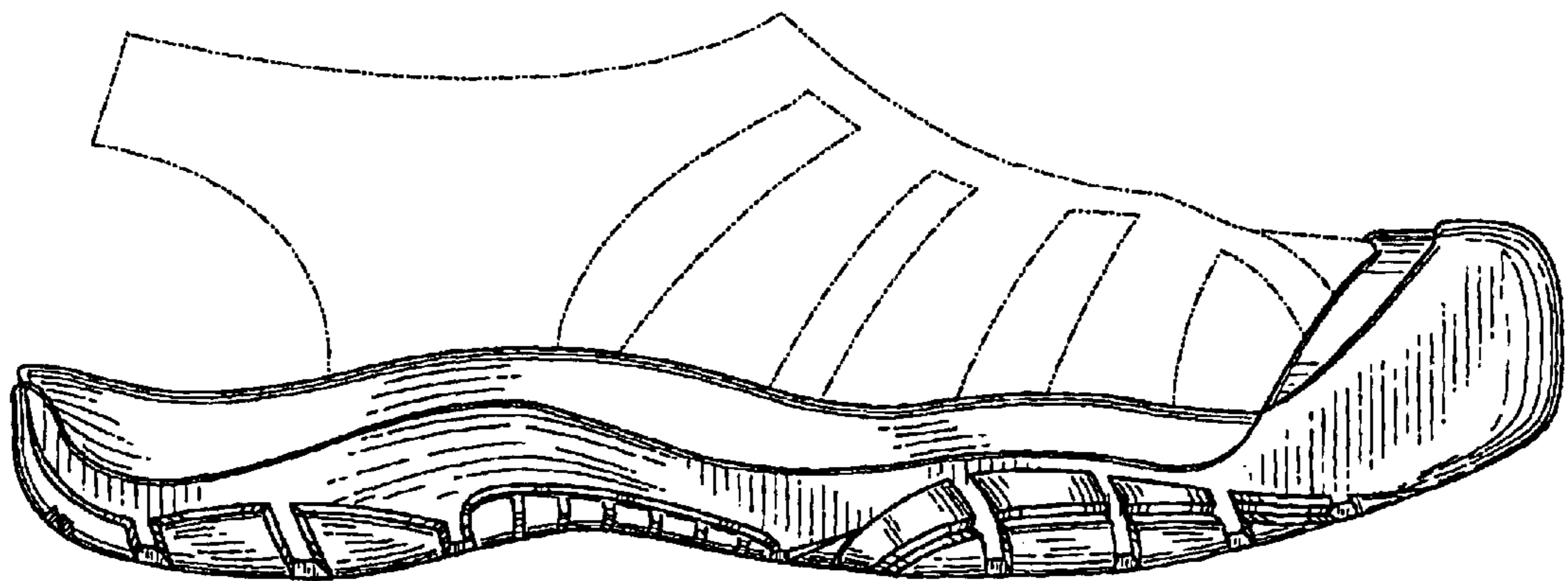

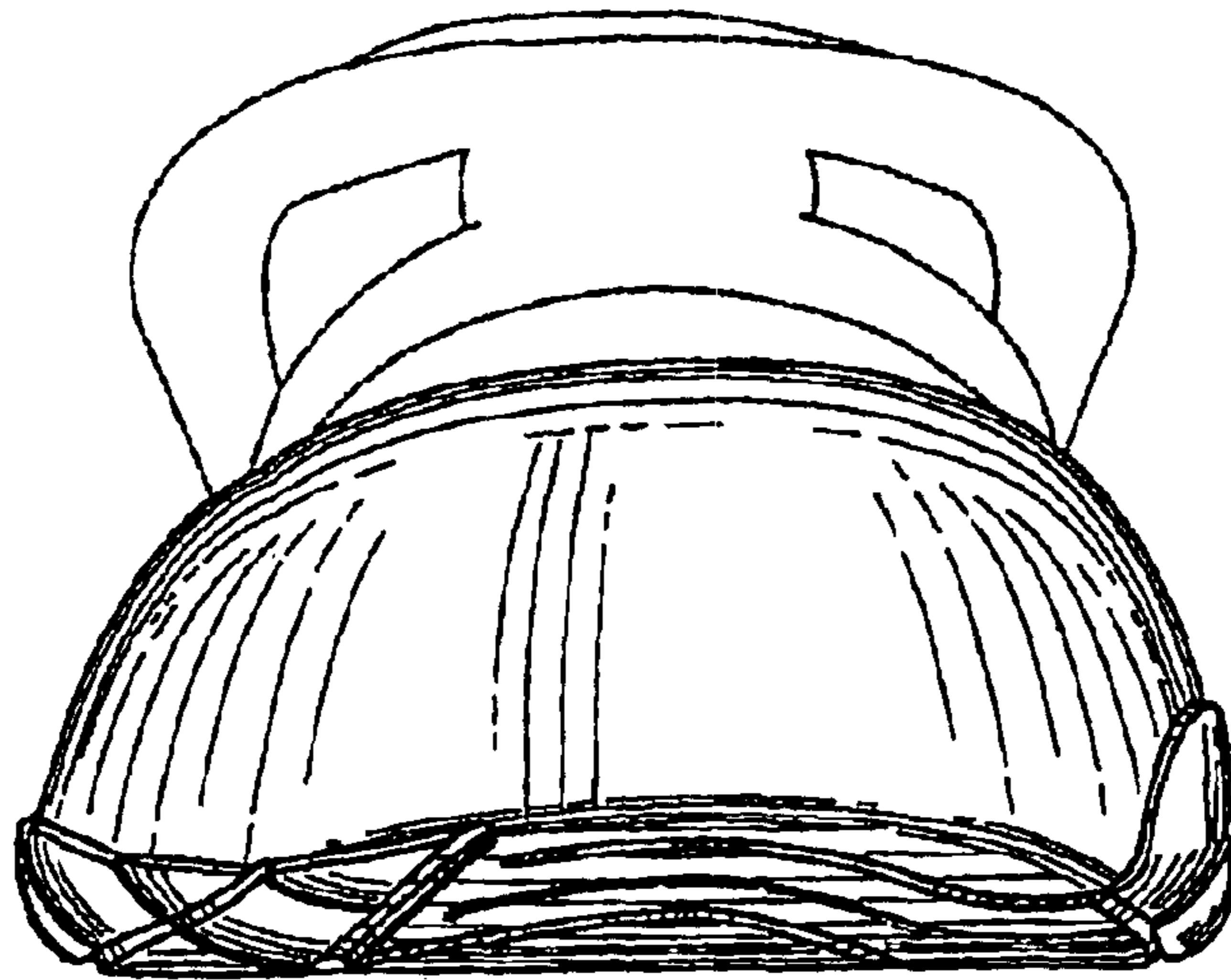

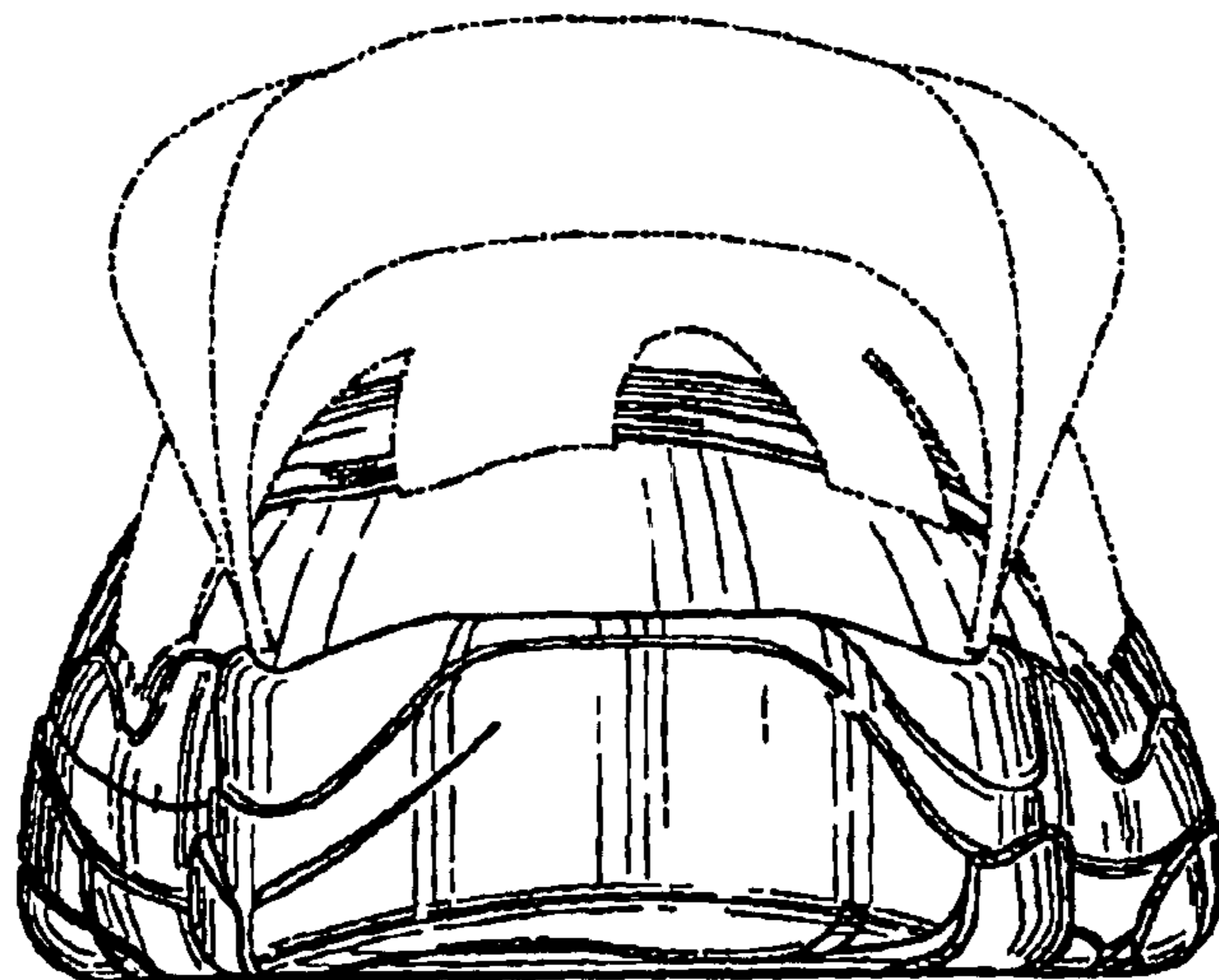
