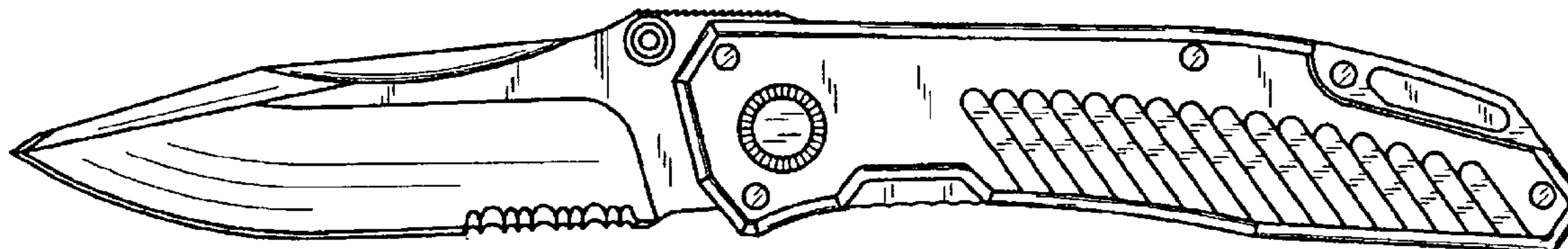
(57) **CLAIM**

The ornamental design for a knife, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of the design of the present invention for a folding knife, showing the knife in an extended position;
 FIG. 2 is a right side elevational view of the knife of FIG. 1;
 FIG. 3 is a front elevational view of the knife of FIG. 1;
 FIG. 4 is a rear elevational view of the knife of FIG. 1;
 FIG. 5 is a top plan view of the knife of FIG. 1;
 FIG. 6 is a bottom plan view of the knife of FIG. 1;
 FIG. 7 is a left side elevational view, similar to FIG. 1, of the folding knife showing the knife in a stowed position; and,
 FIG. 8 is a right side elevational view, similar to FIG. 2, of the folding knife showing the knife in a stowed position.
 The broken lines shown are for illustrative purposes only and form no part of the claimed design.

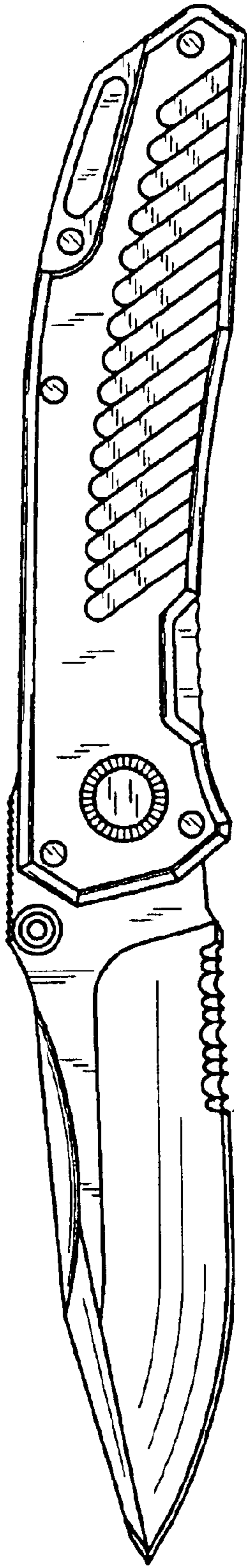

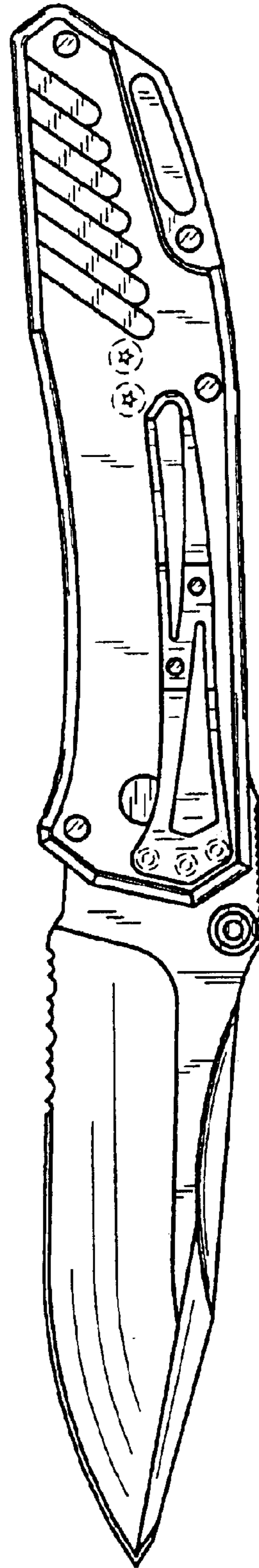

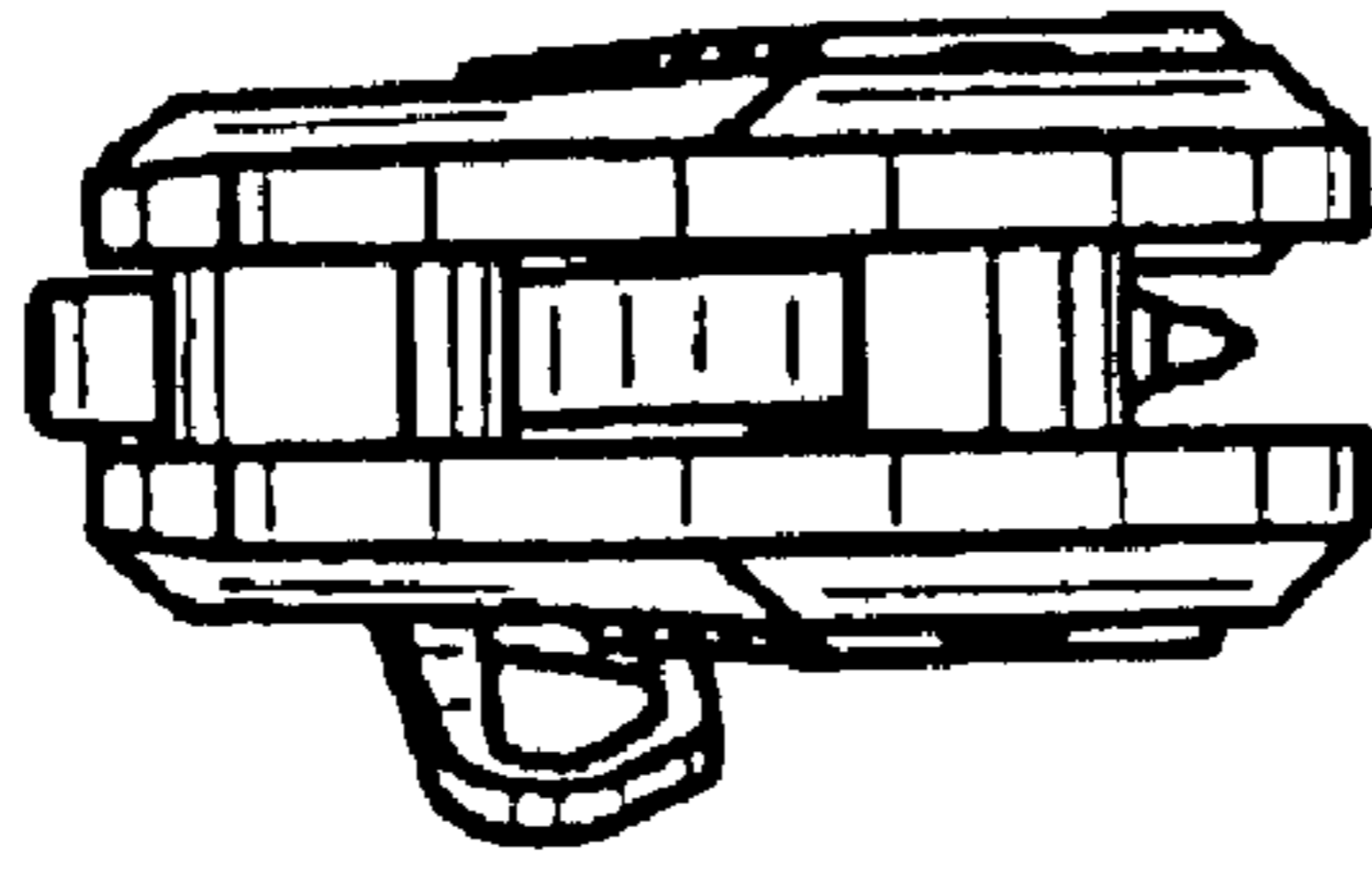

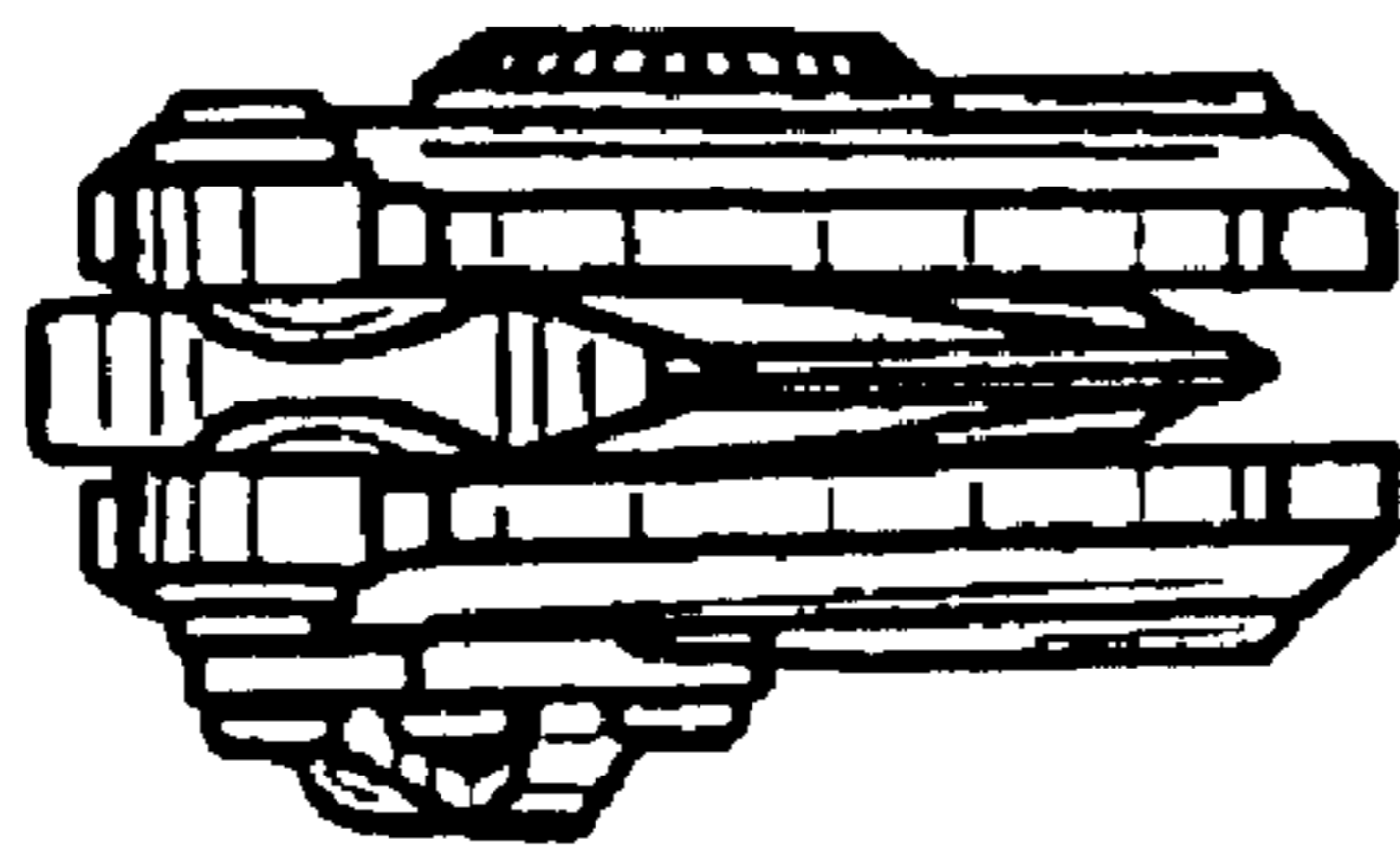

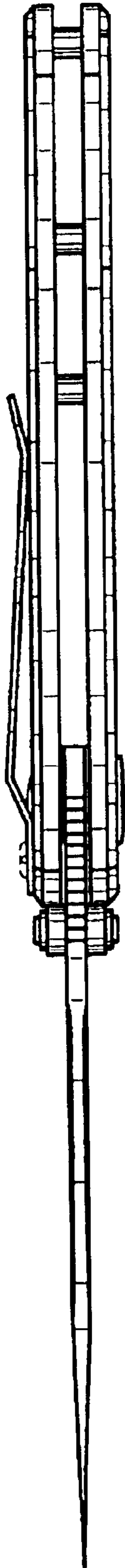

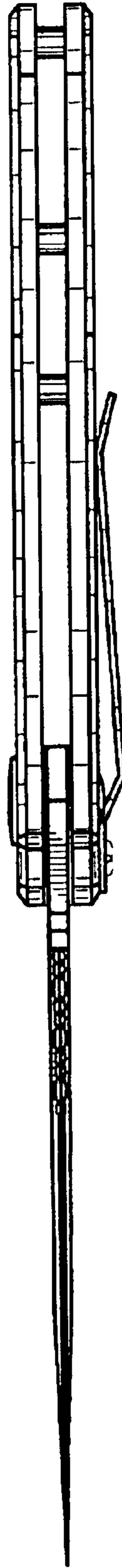

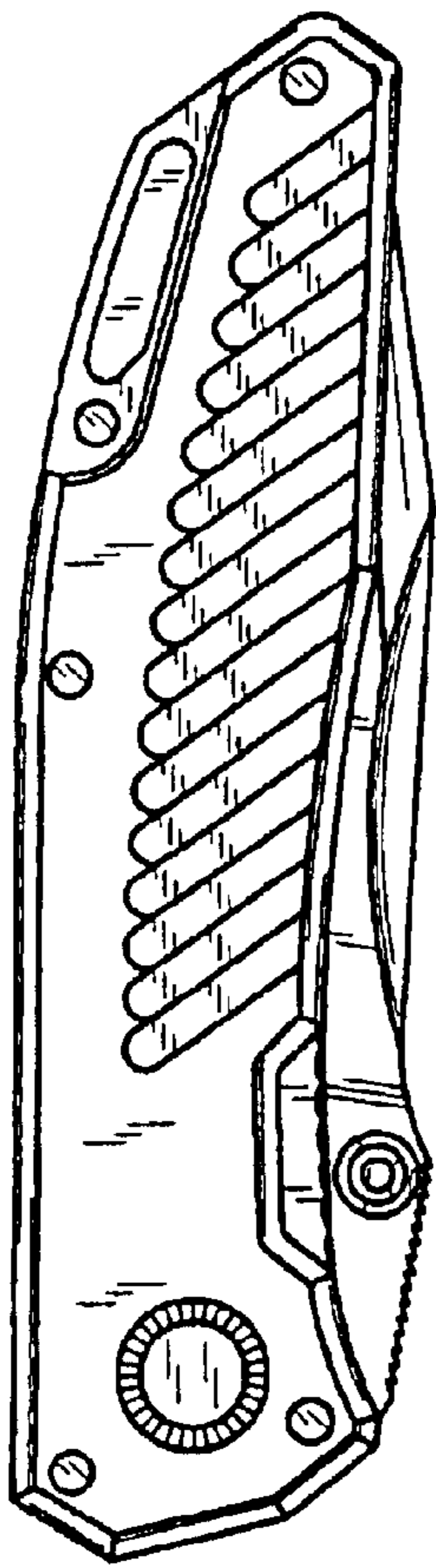

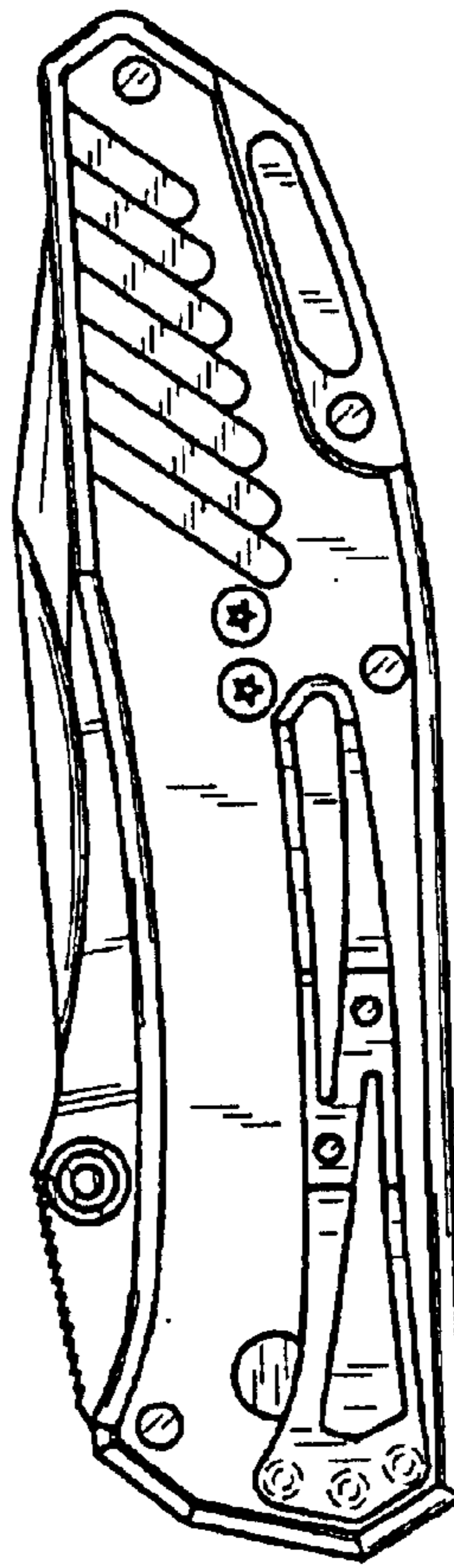
