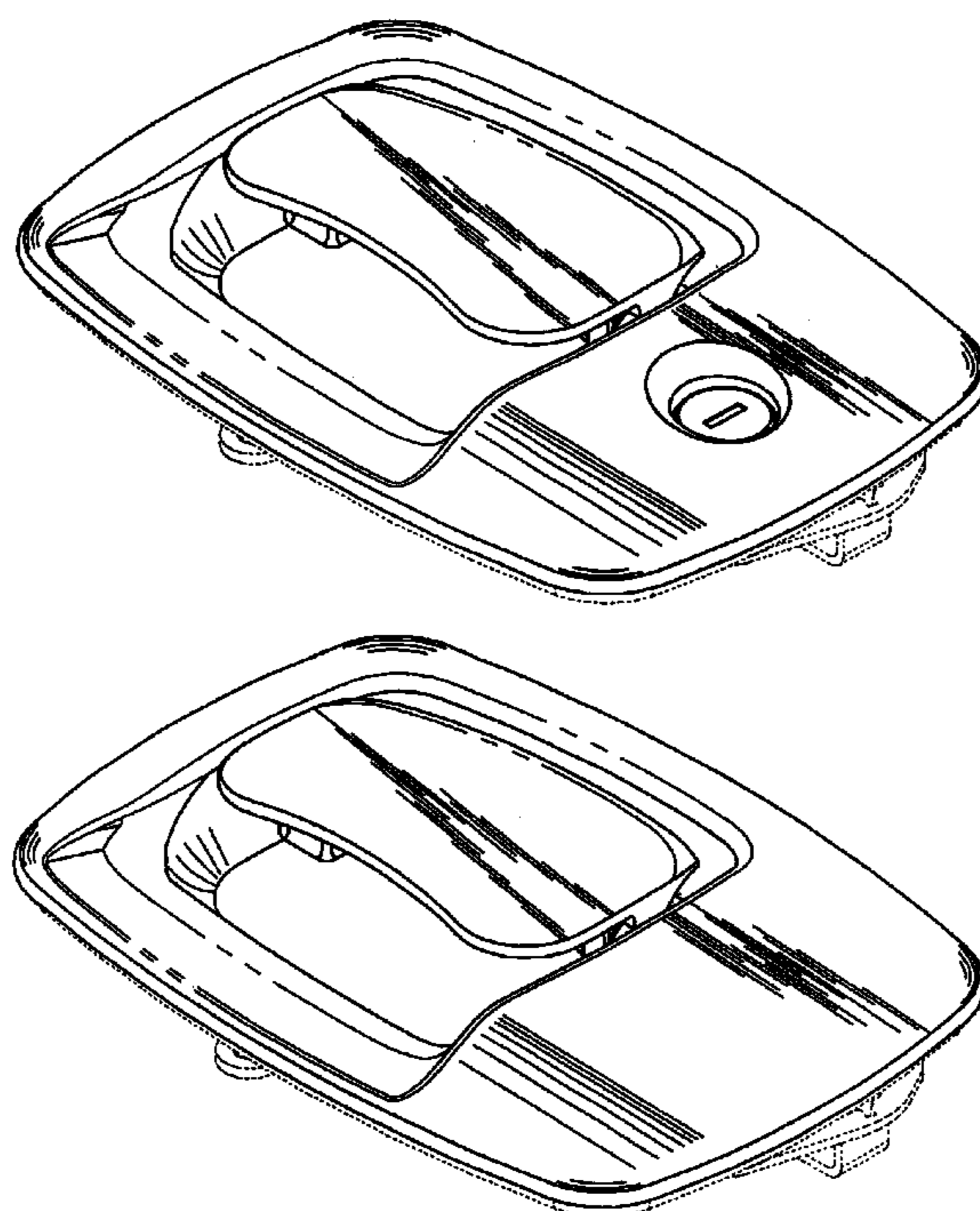
FIG. 8 is a top plan view of the second embodiment, similar to FIG. 2; and,

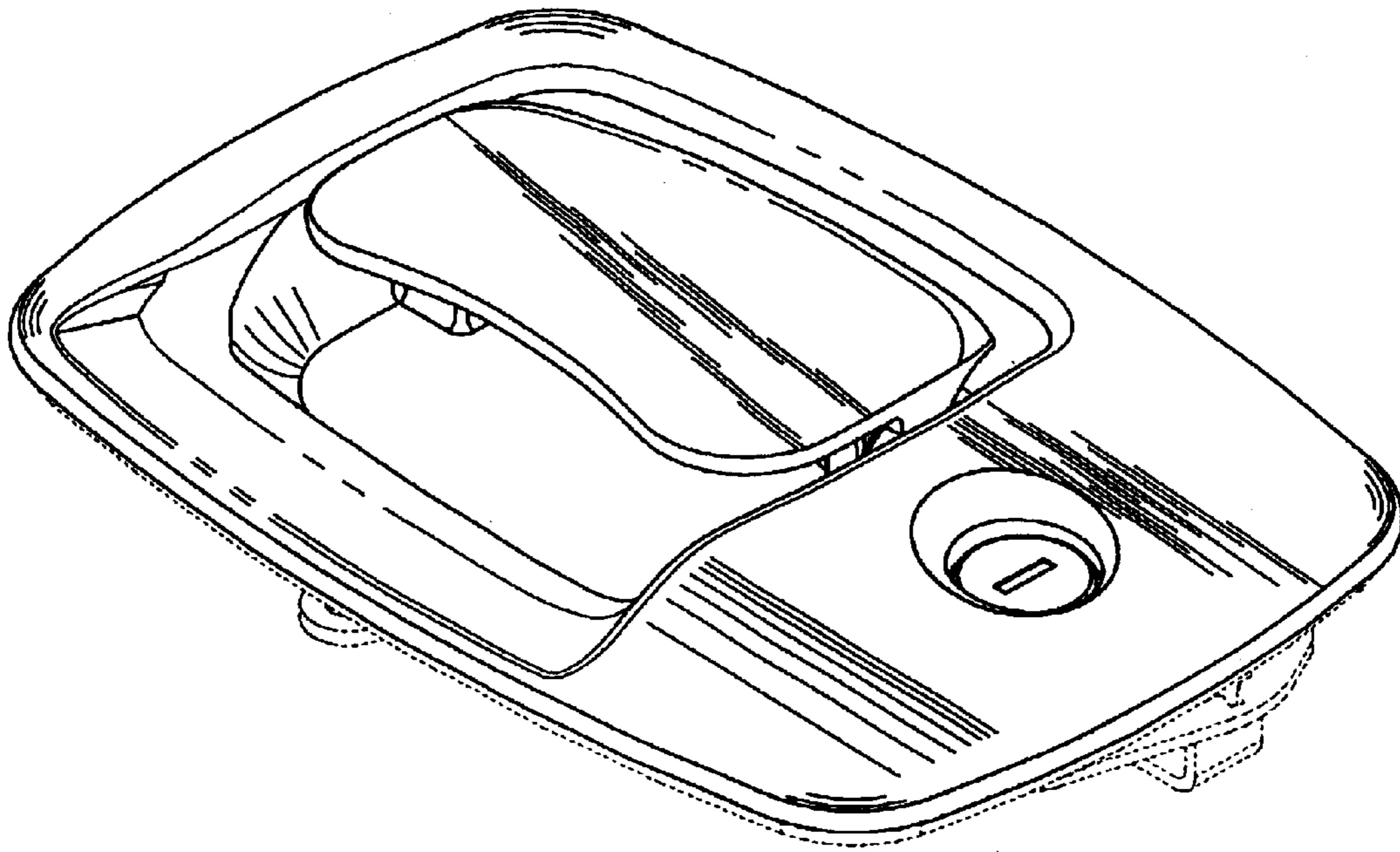

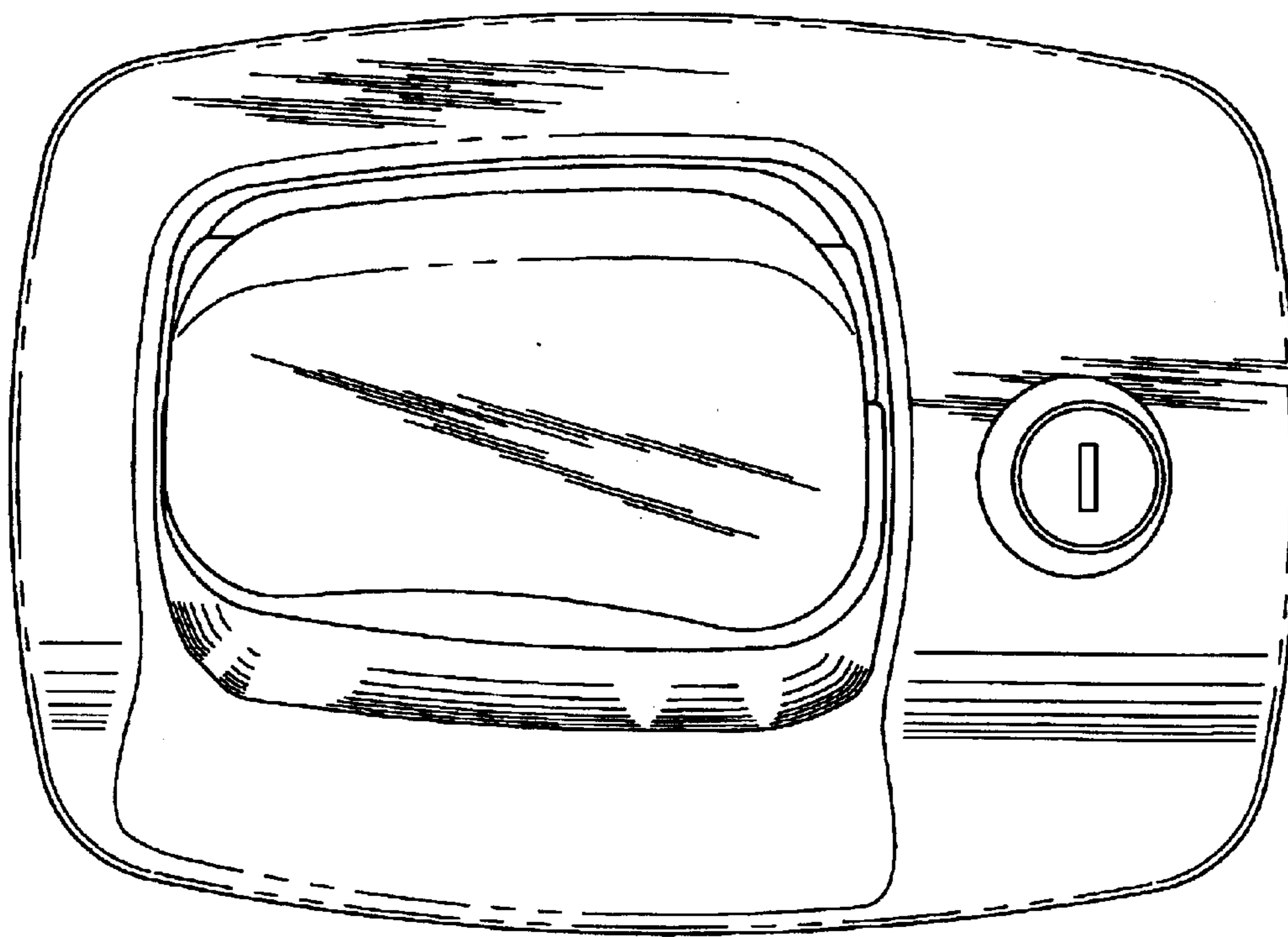

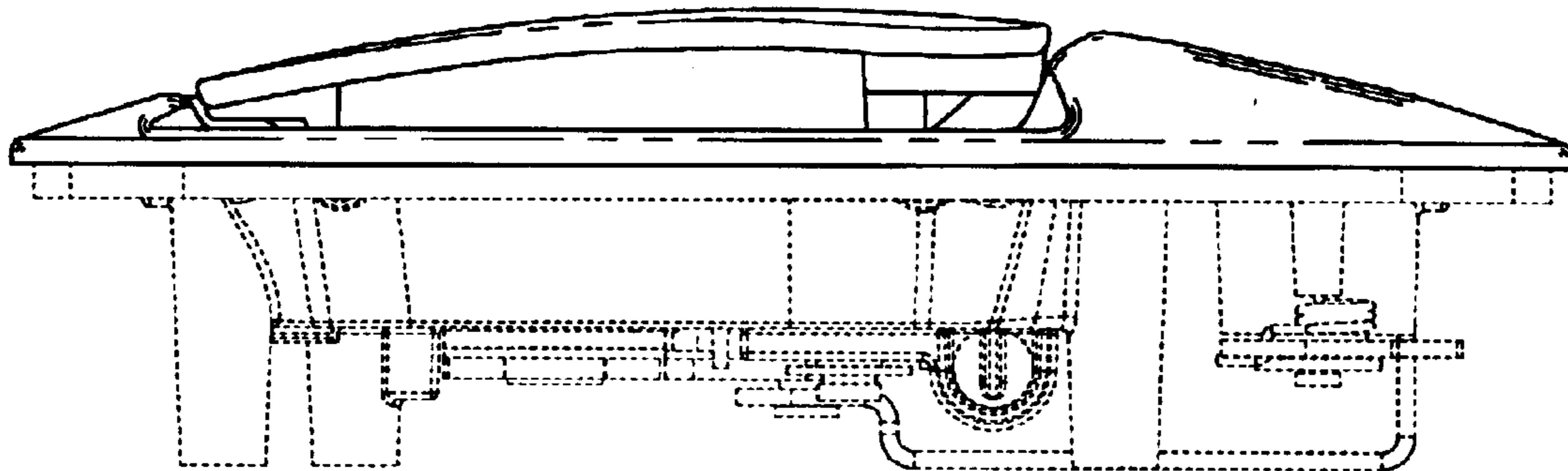

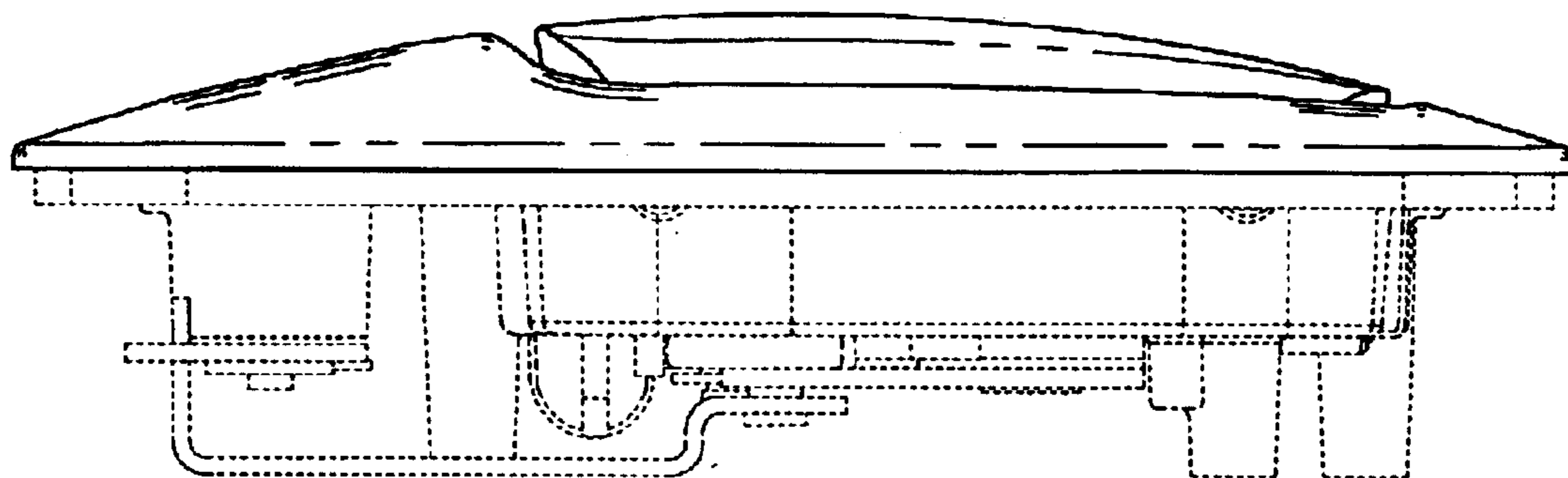

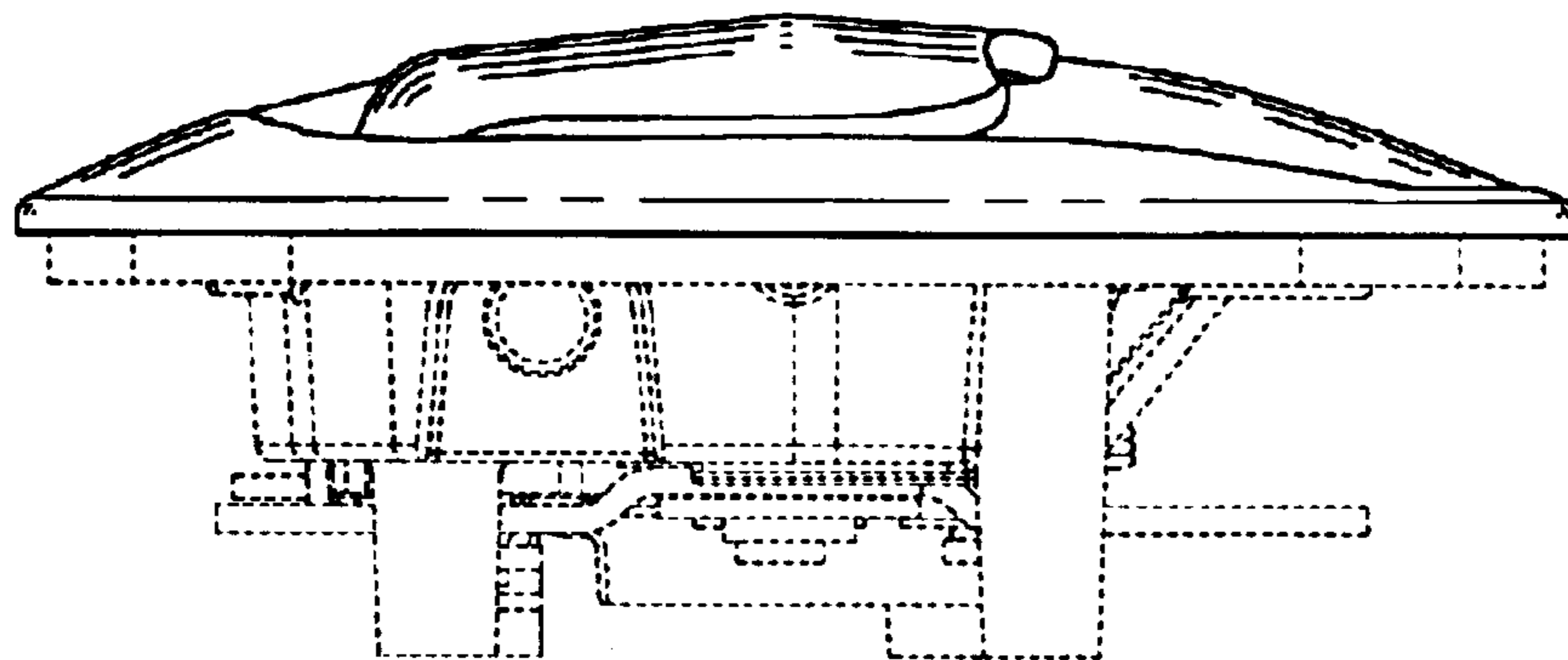

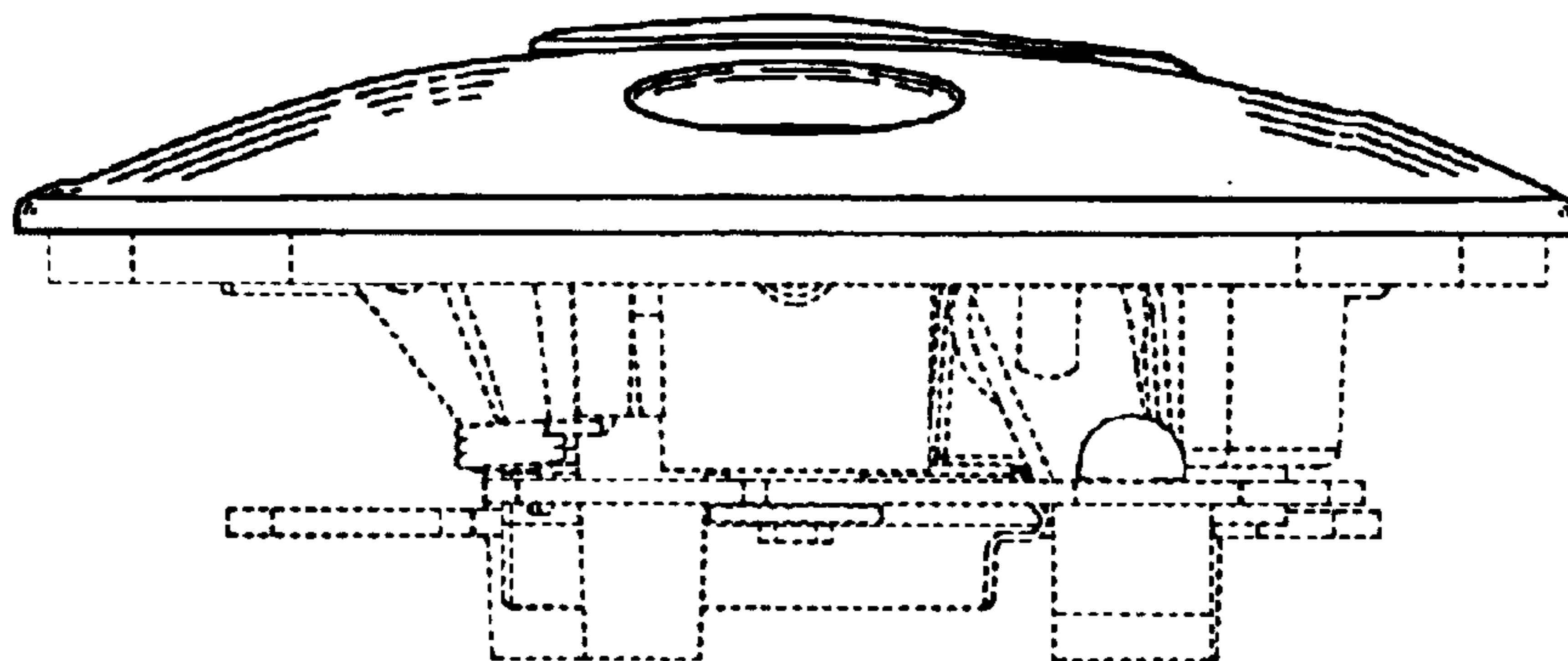

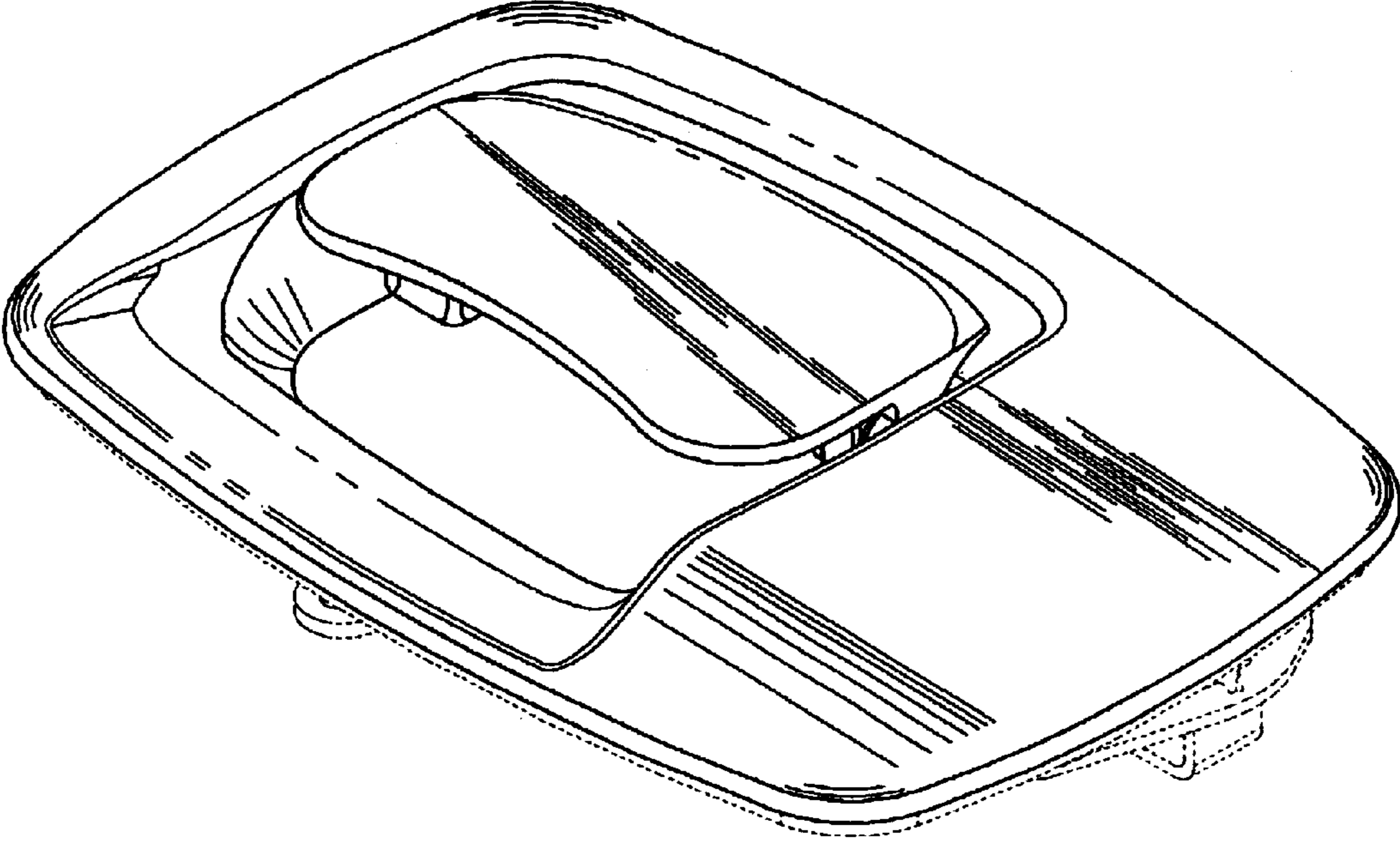

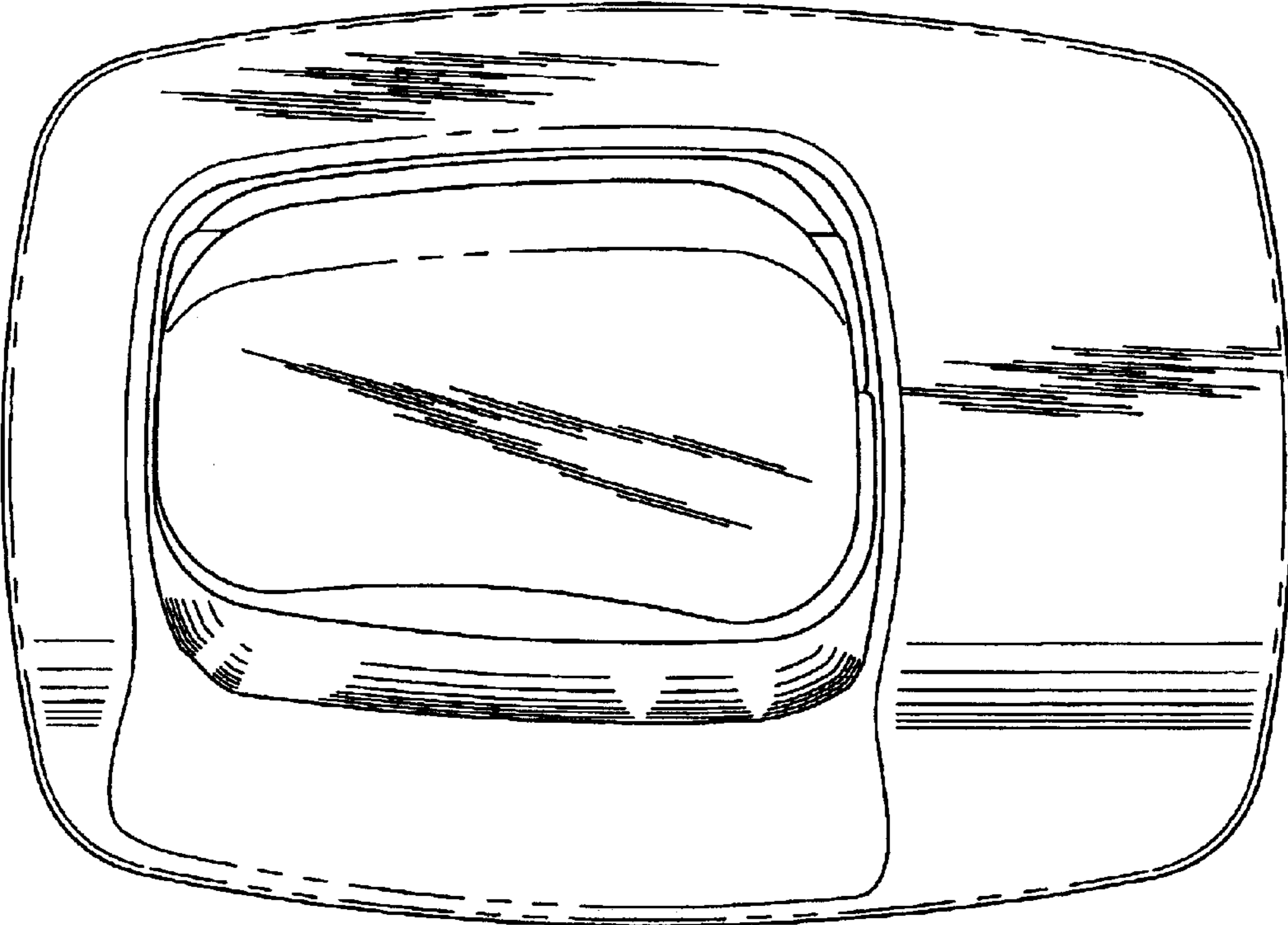

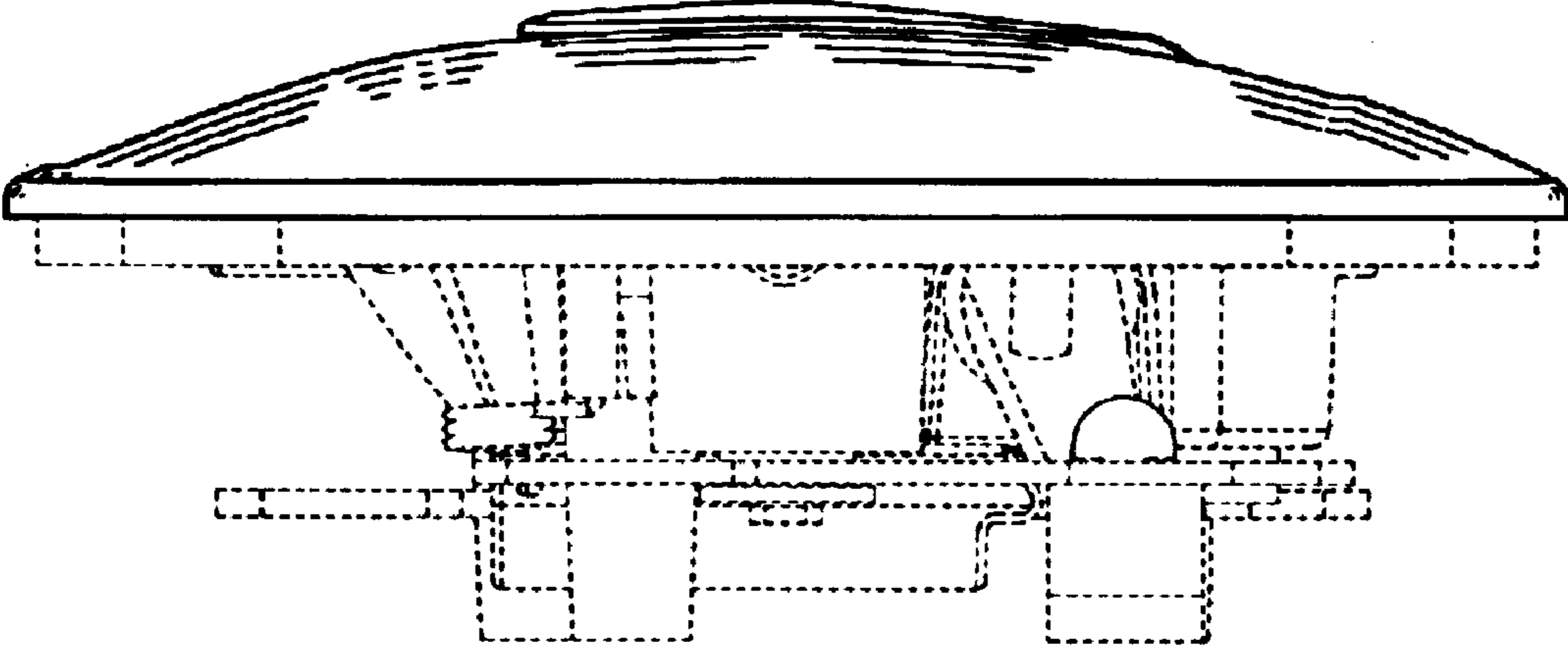
