DESCRIPTION

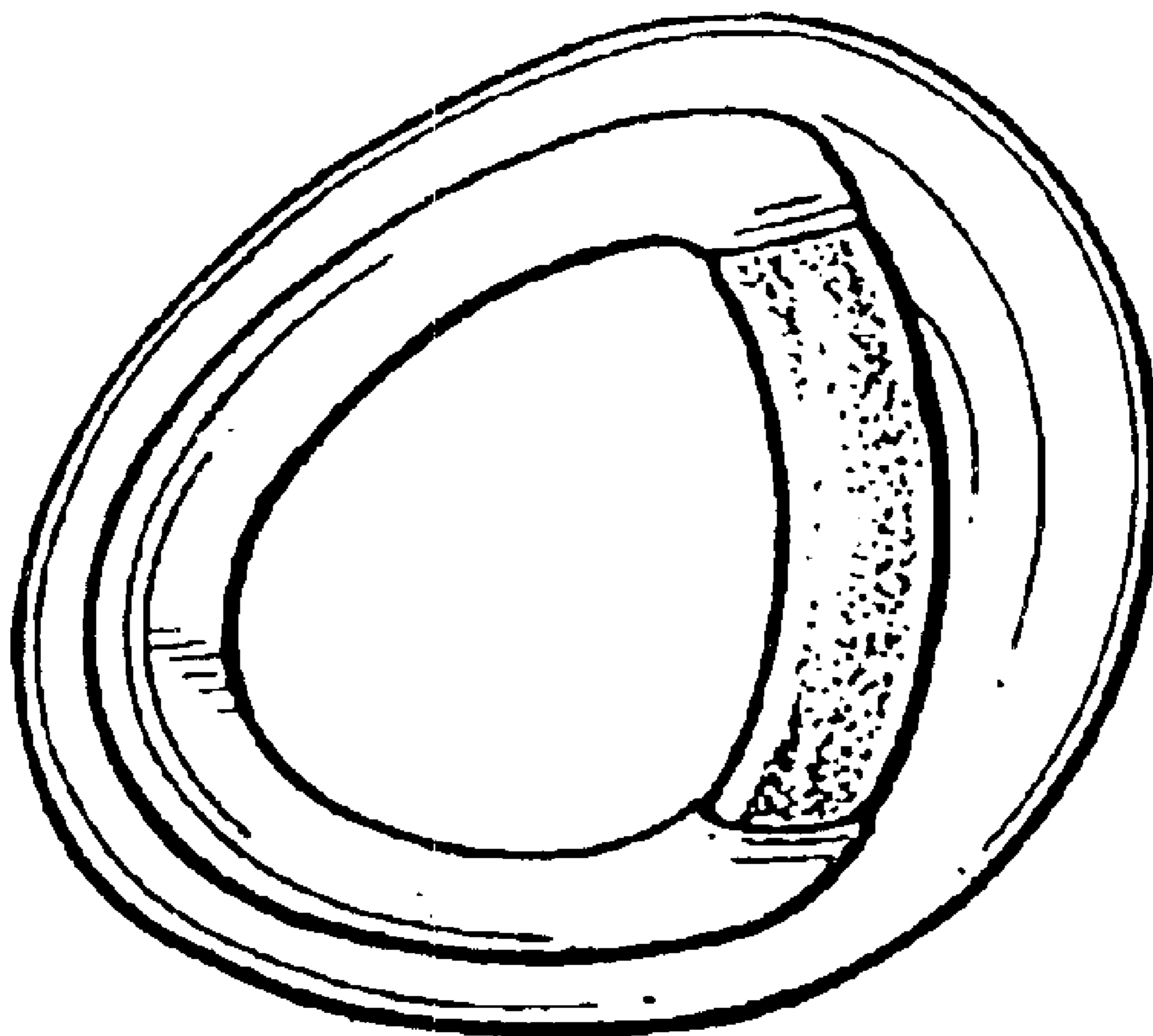
FIG. 1 is a perspective view of a first embodiment of a surface configuration of a door latch for a vehicle according to our novel design;

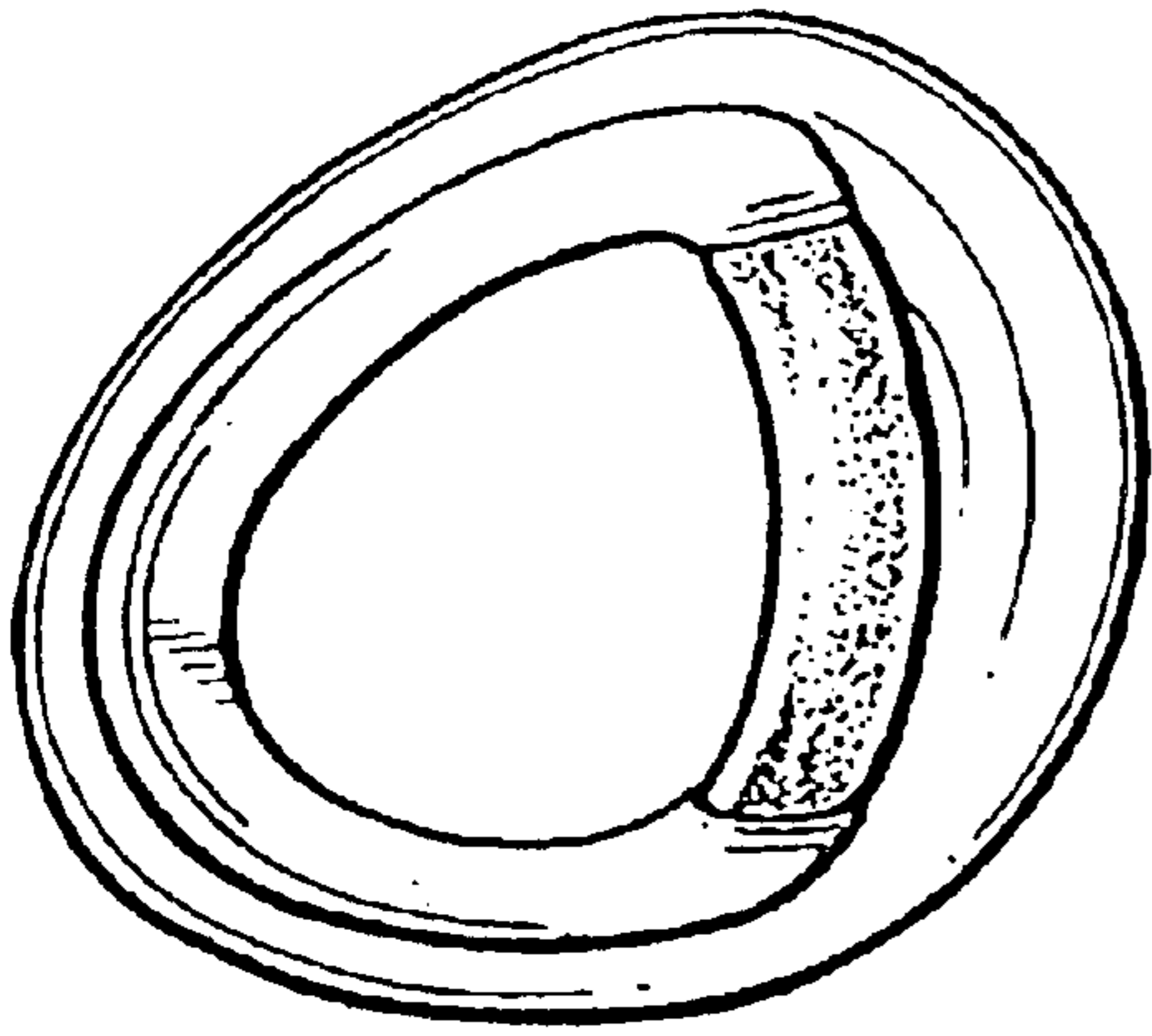

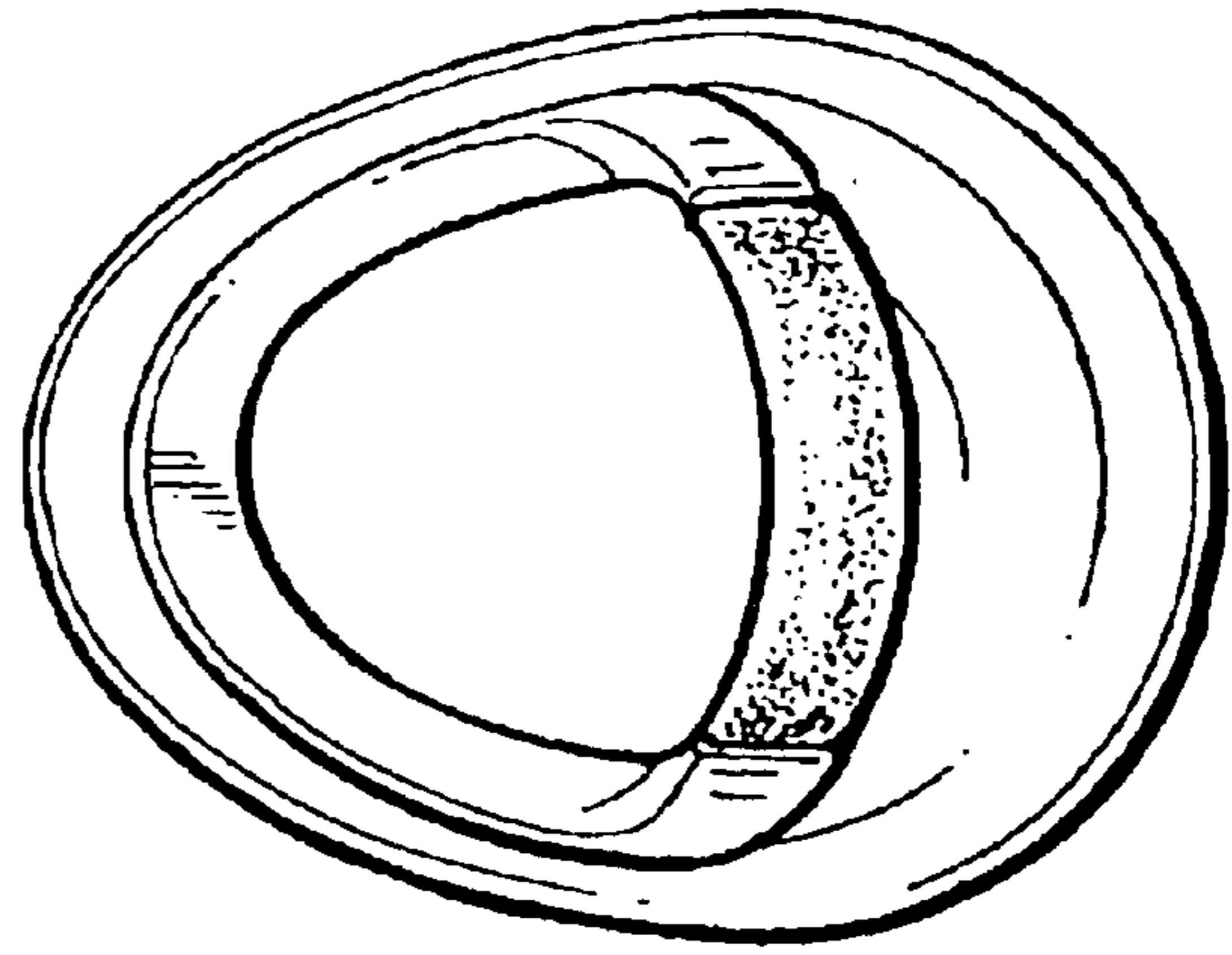

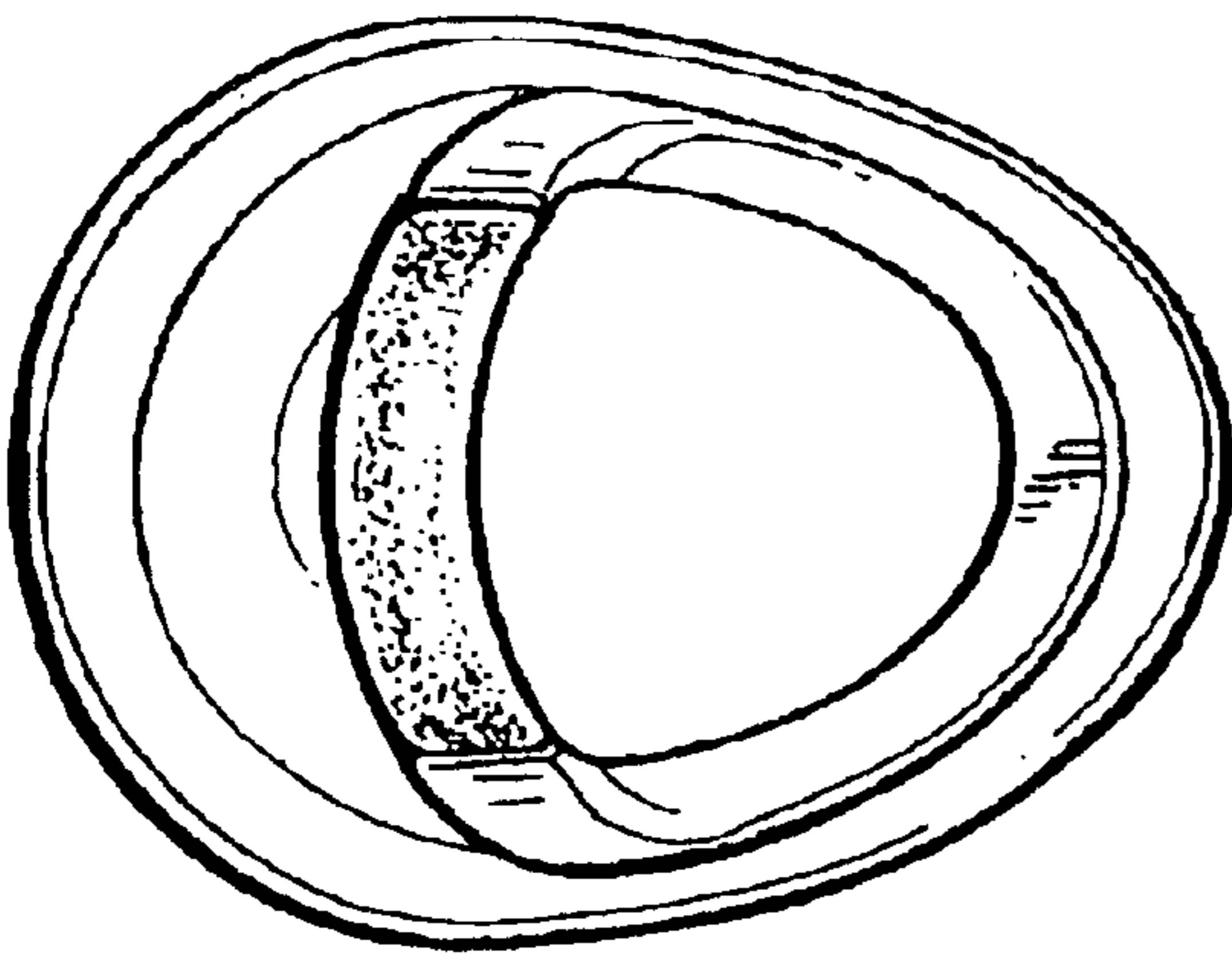

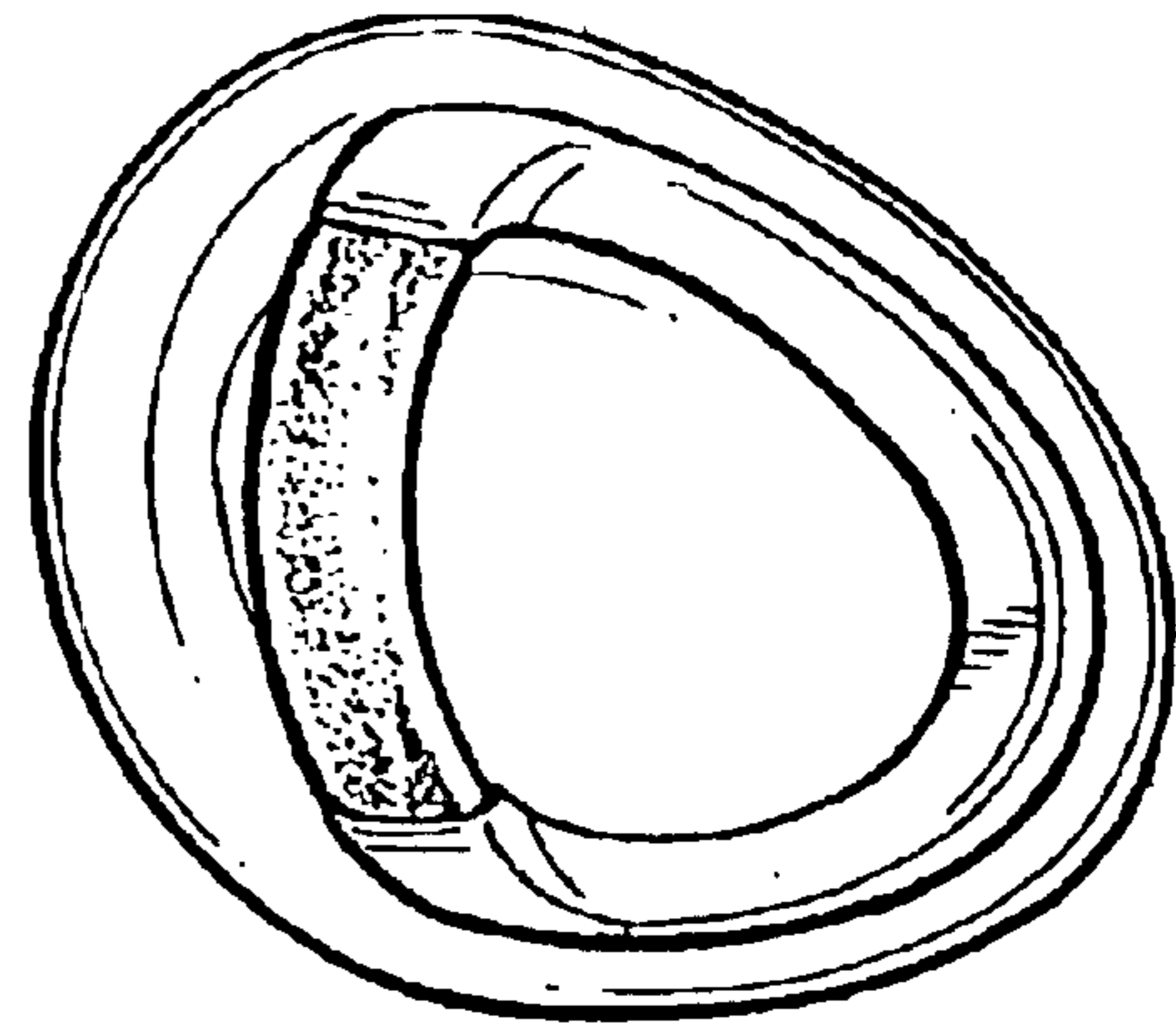
