DESCRIPTION

FIG. 11 is a bottom view thereof.

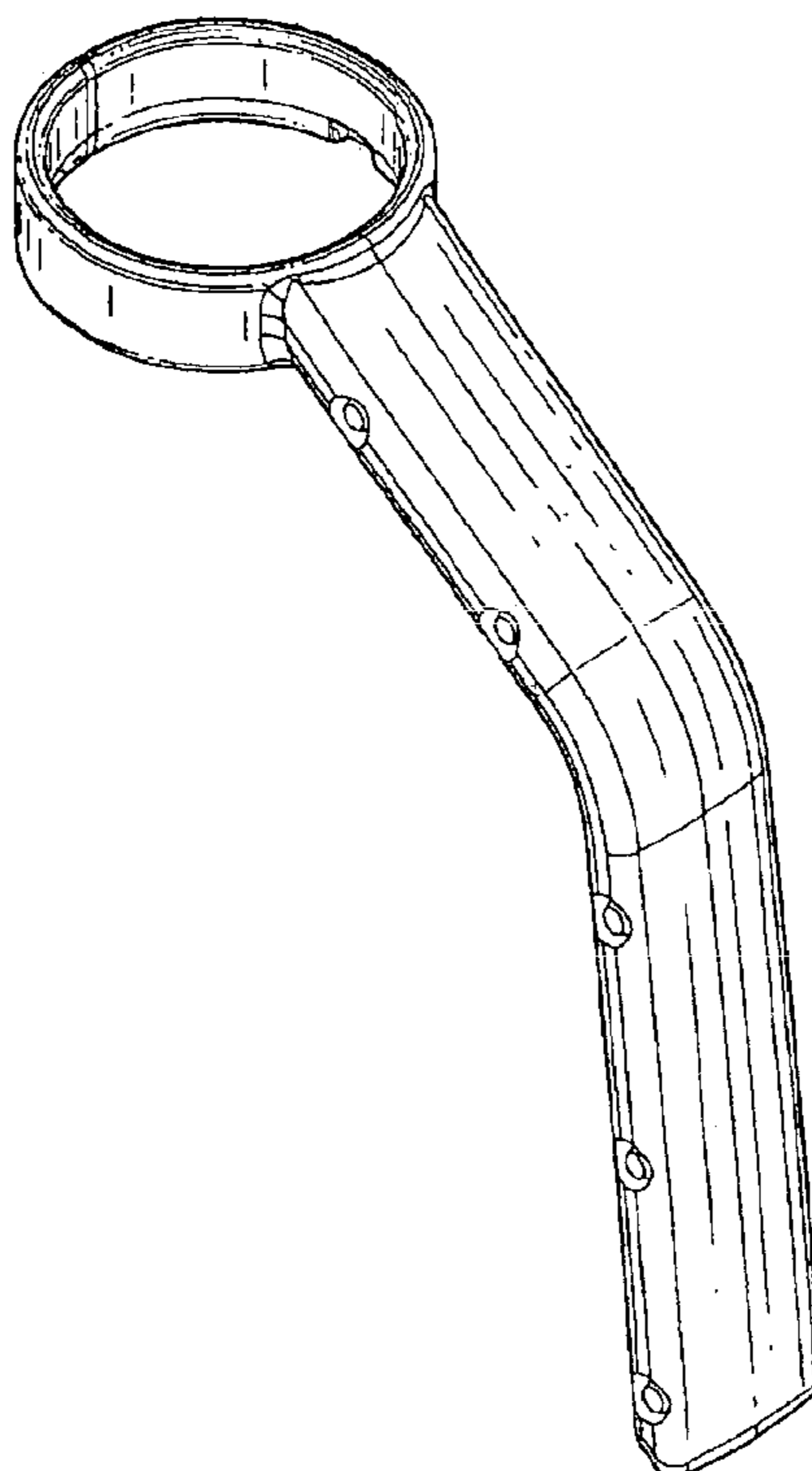
FIG. 12 is a back view thereof.

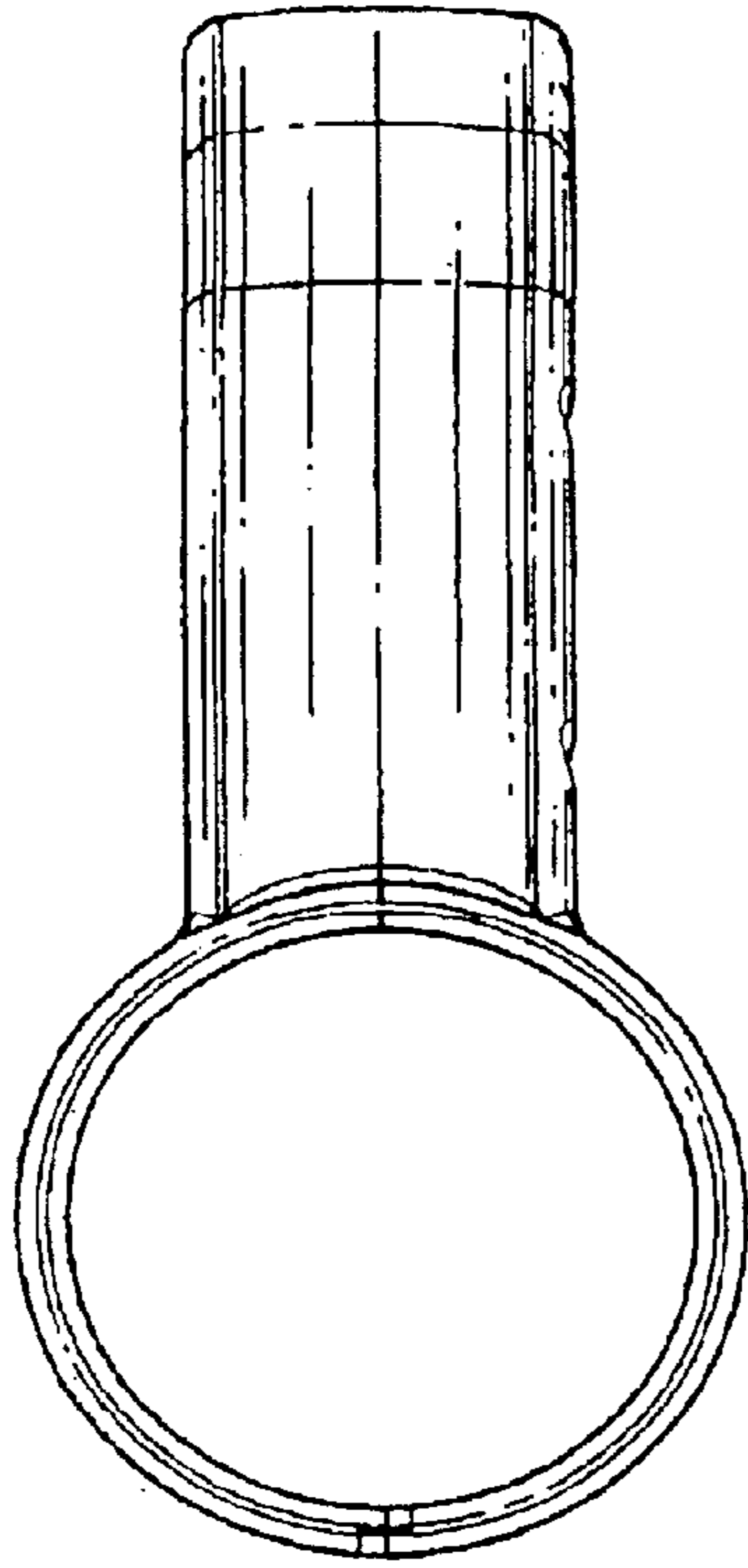

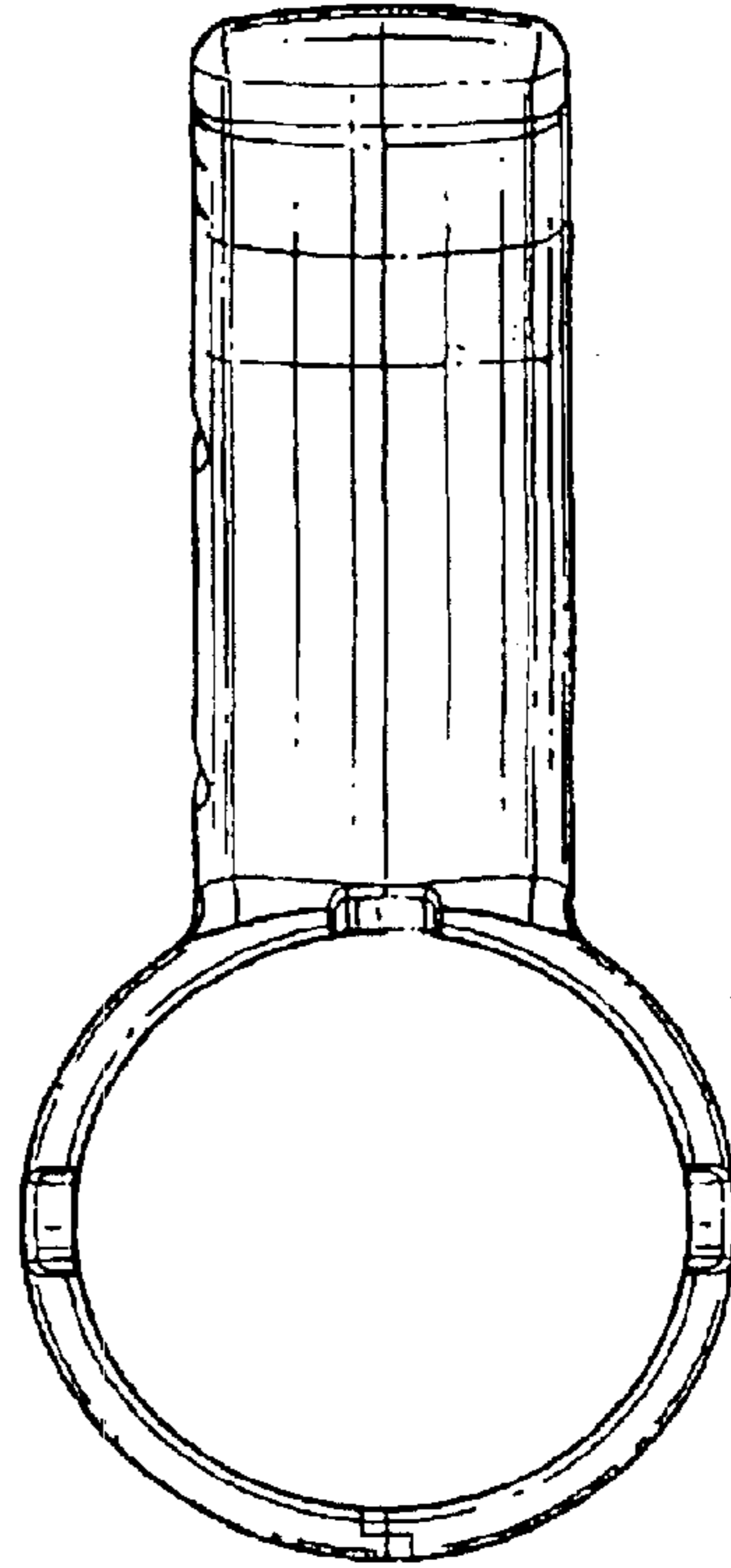

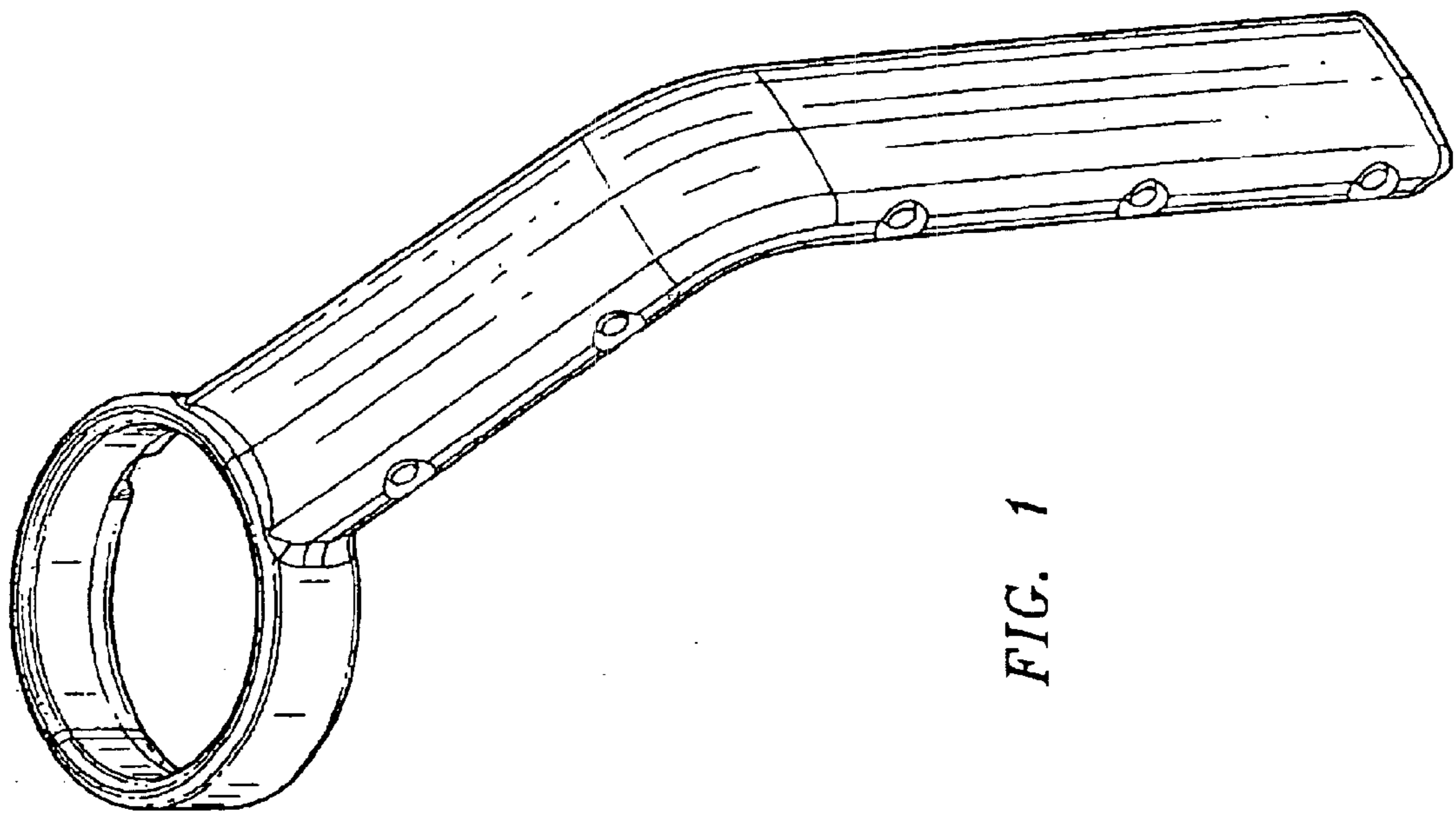

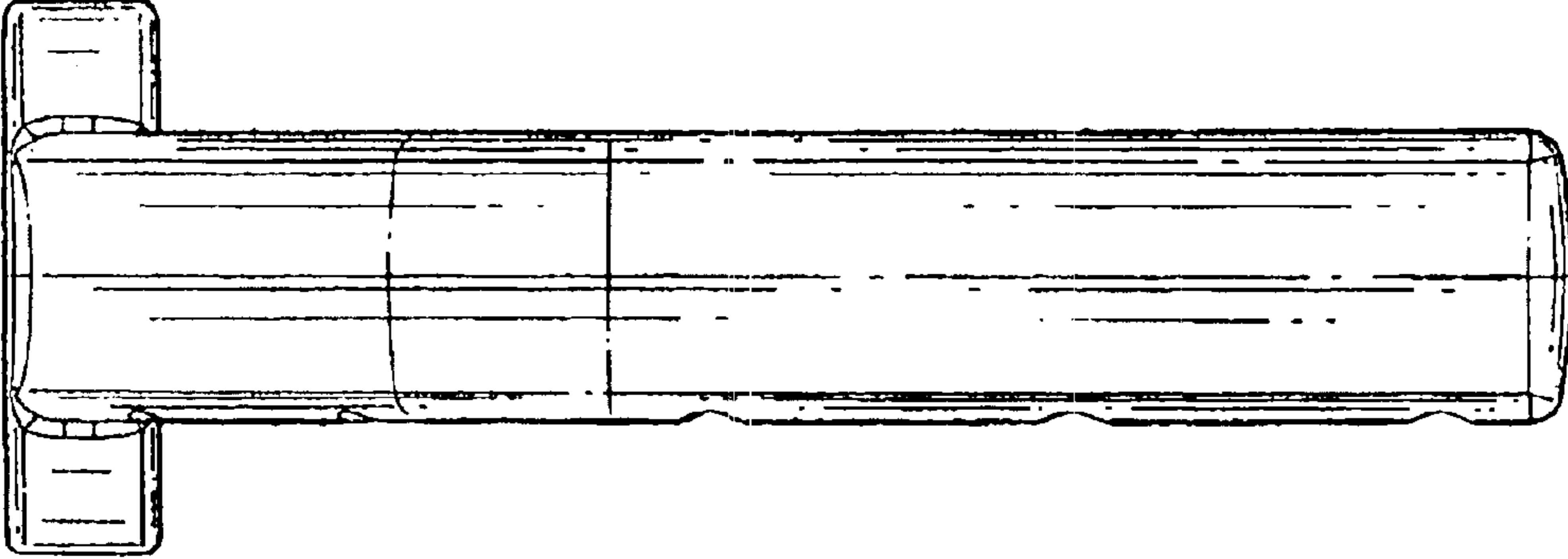

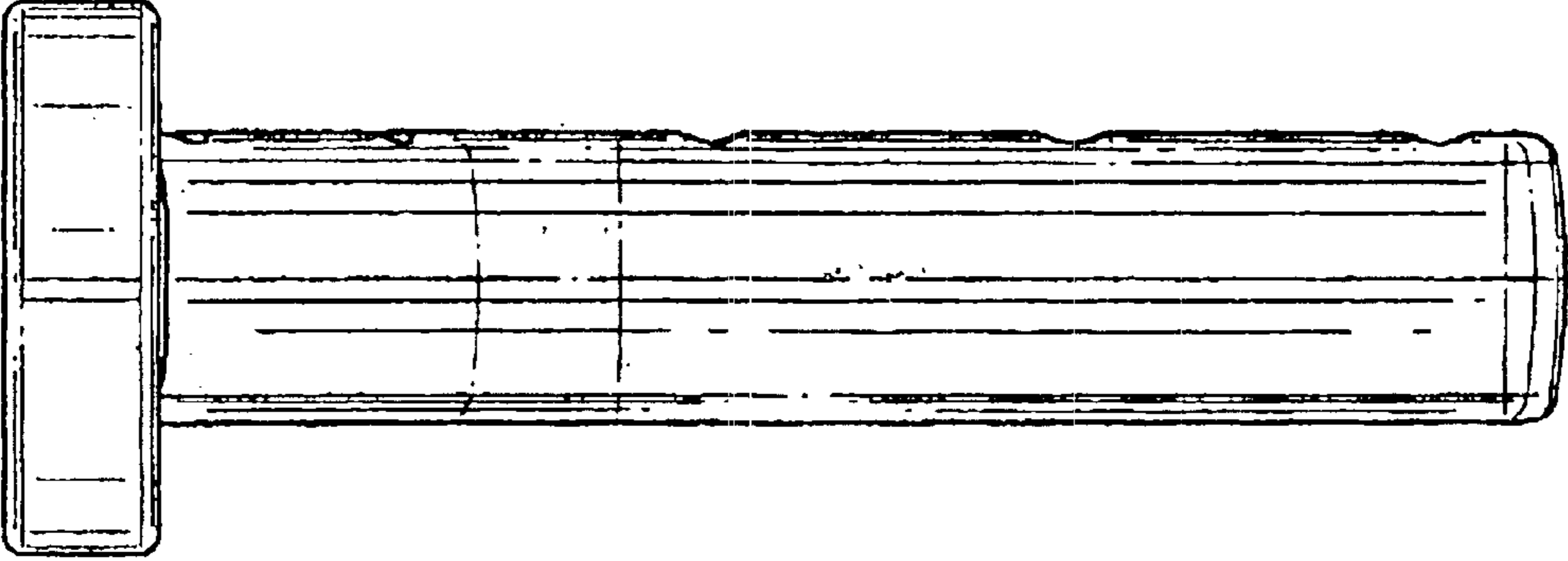

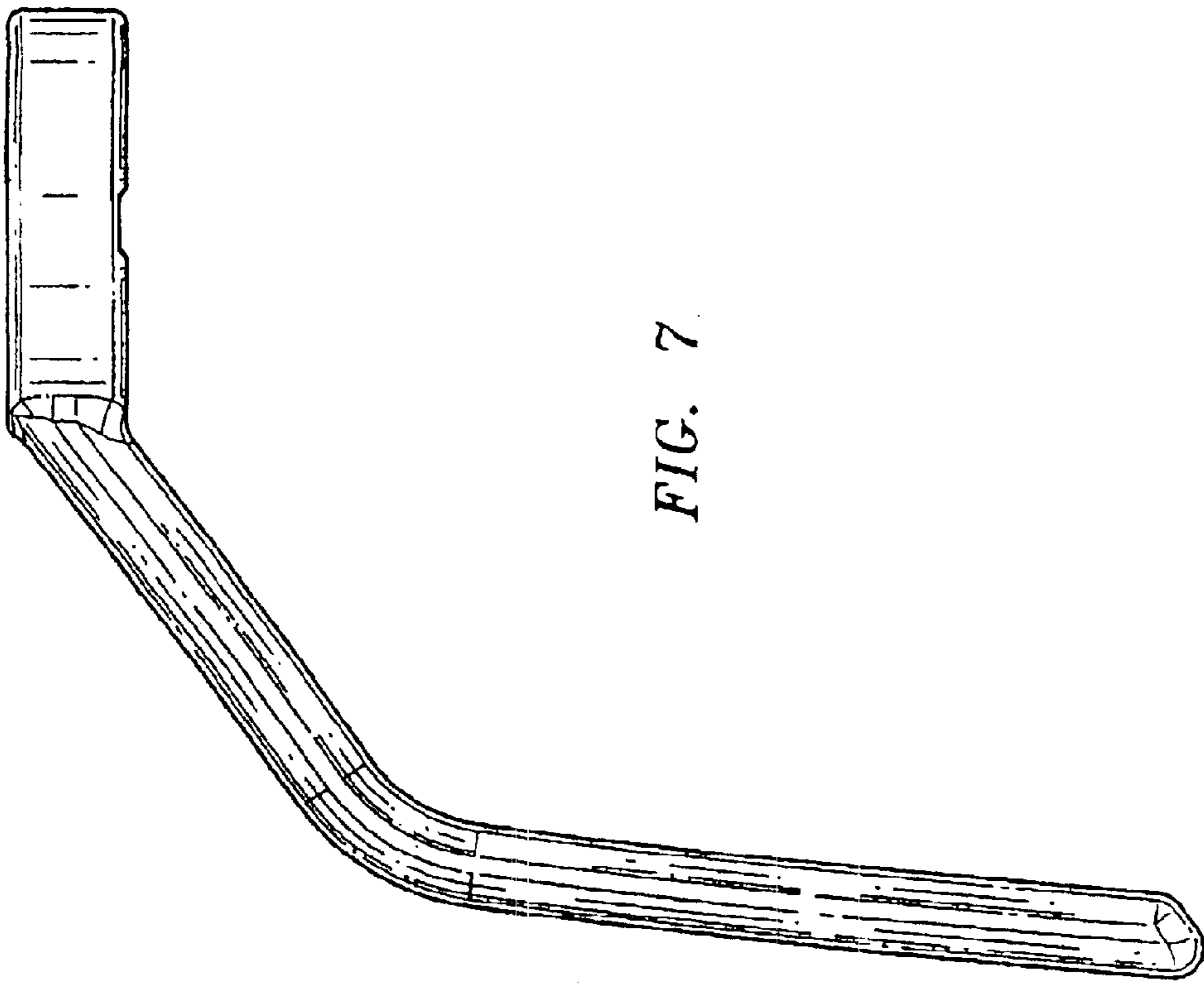

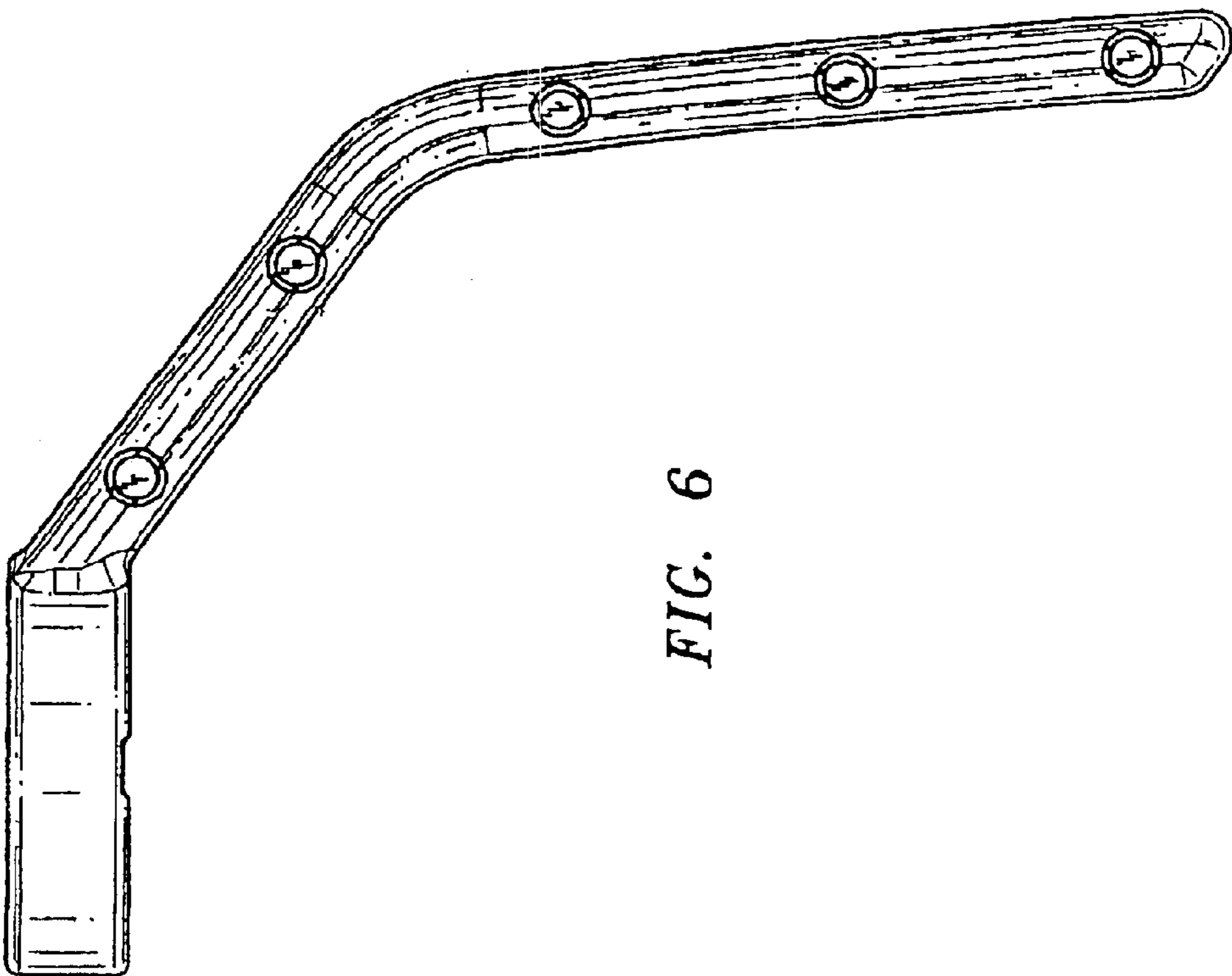

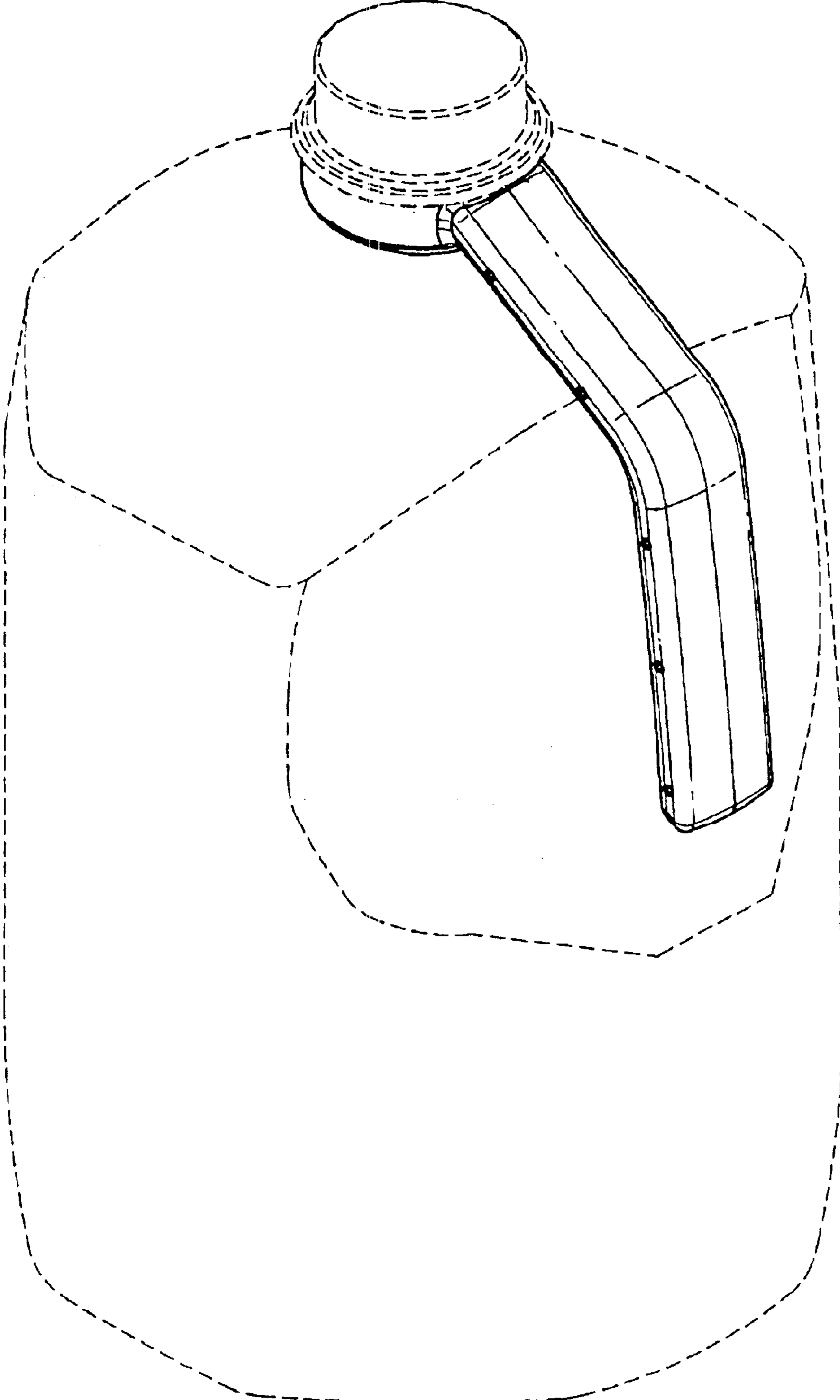

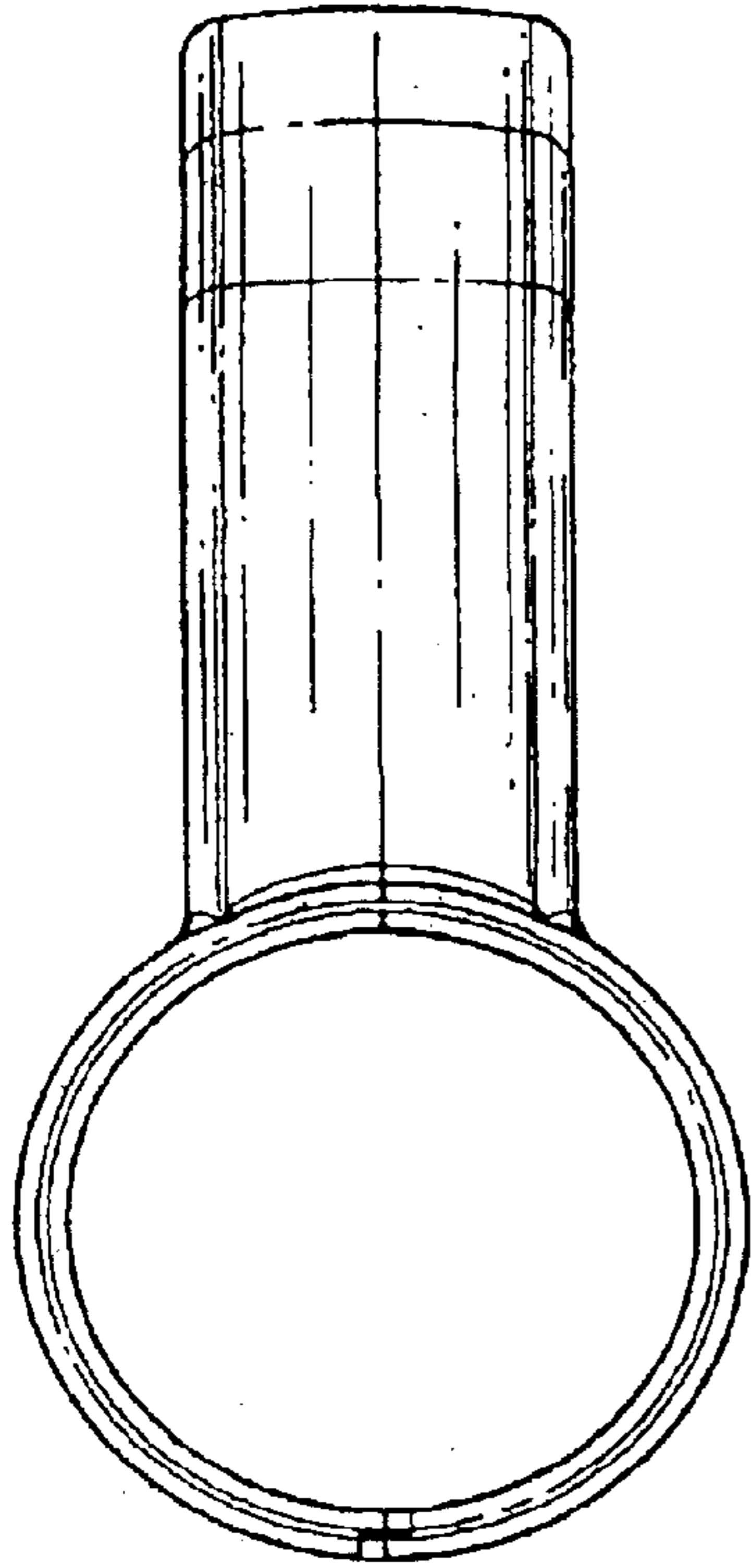

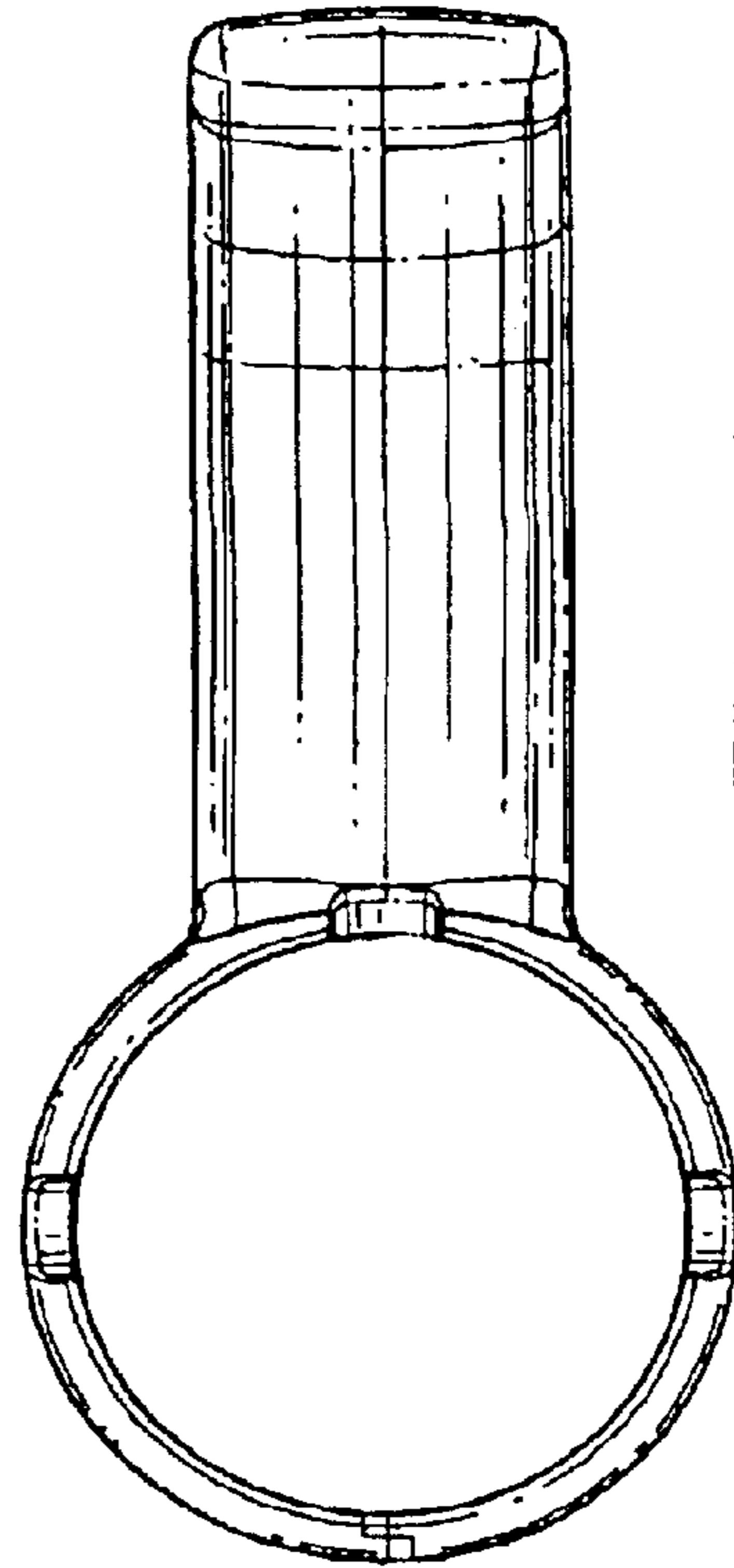

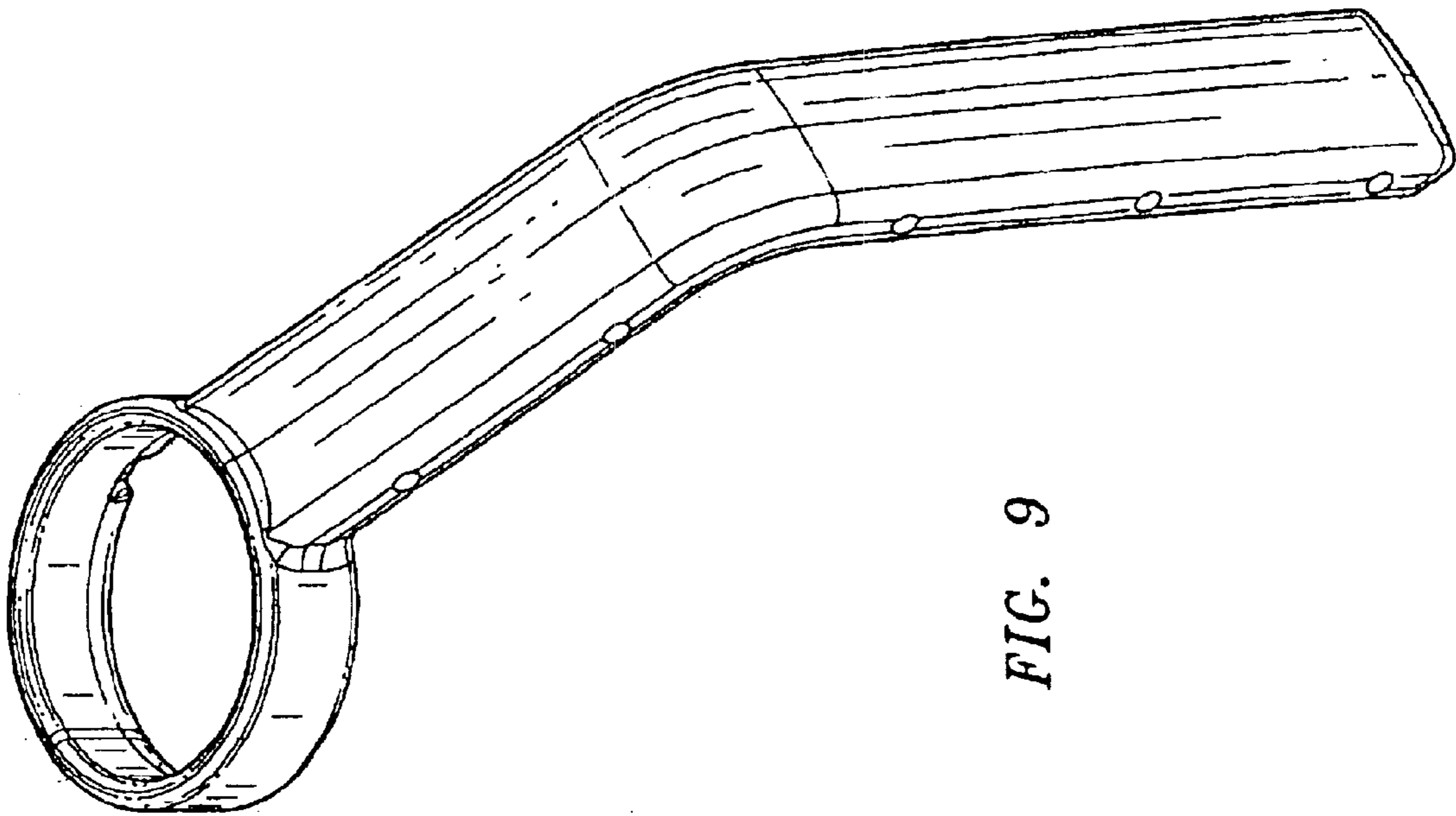

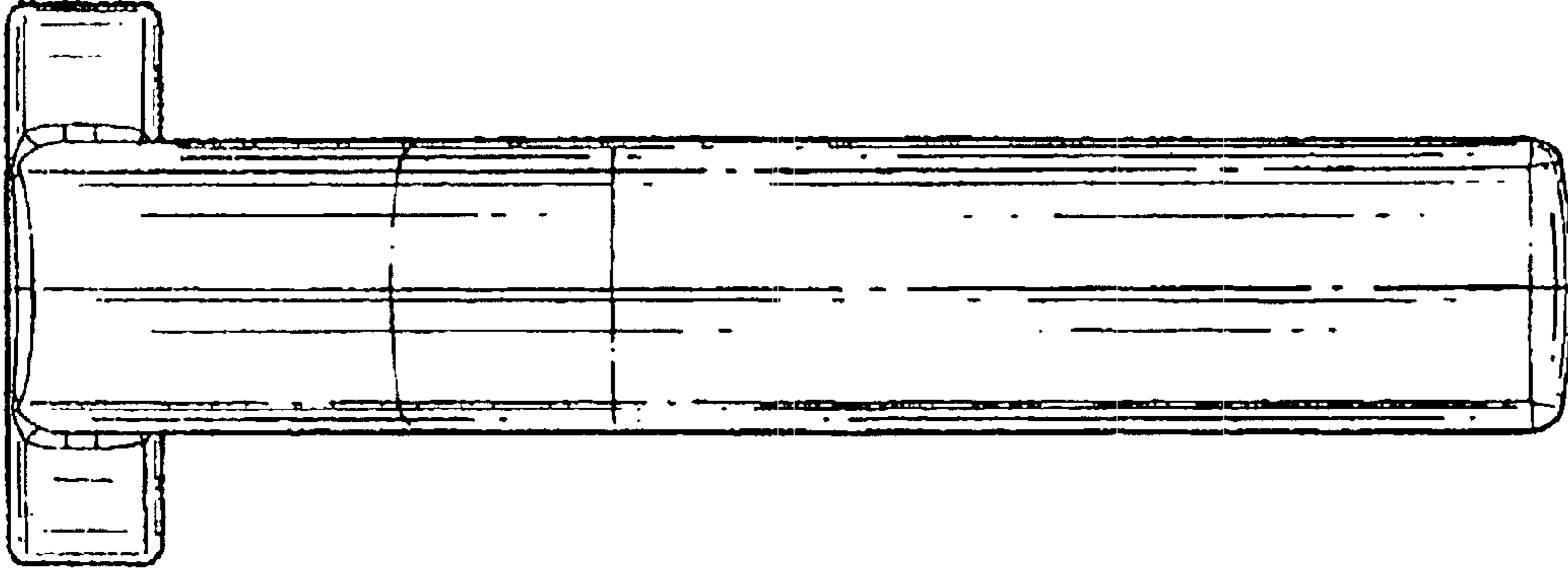

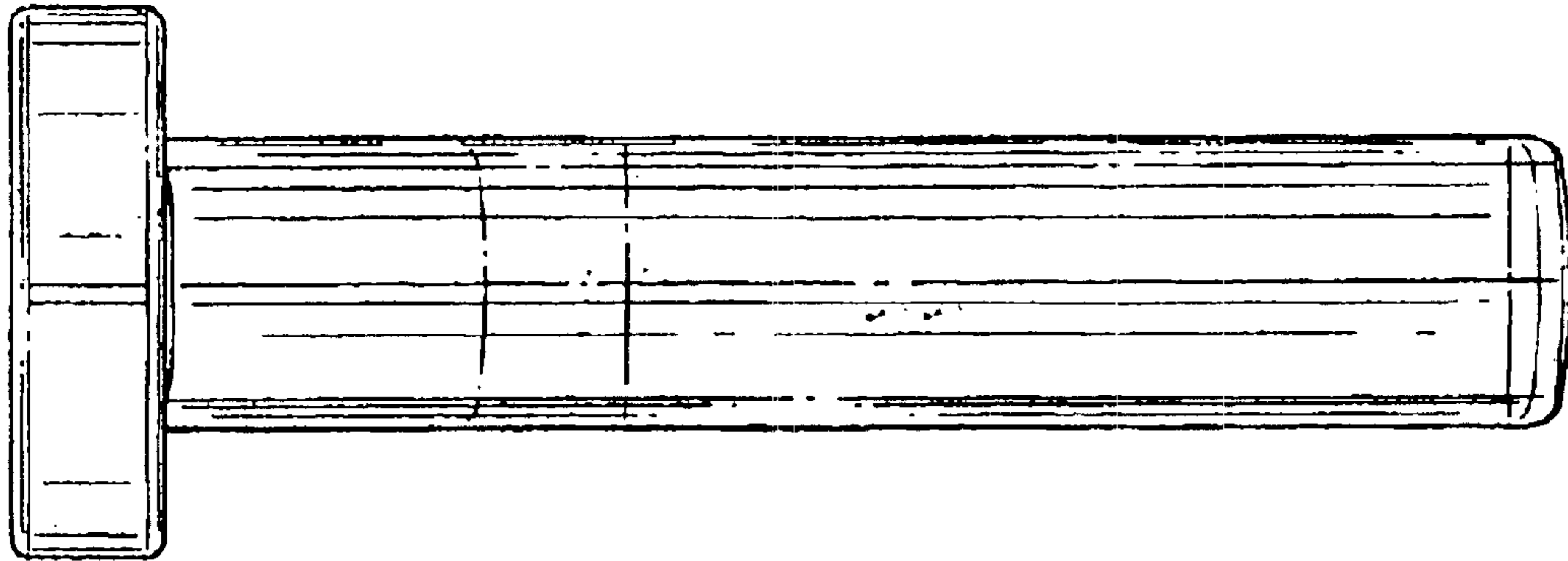

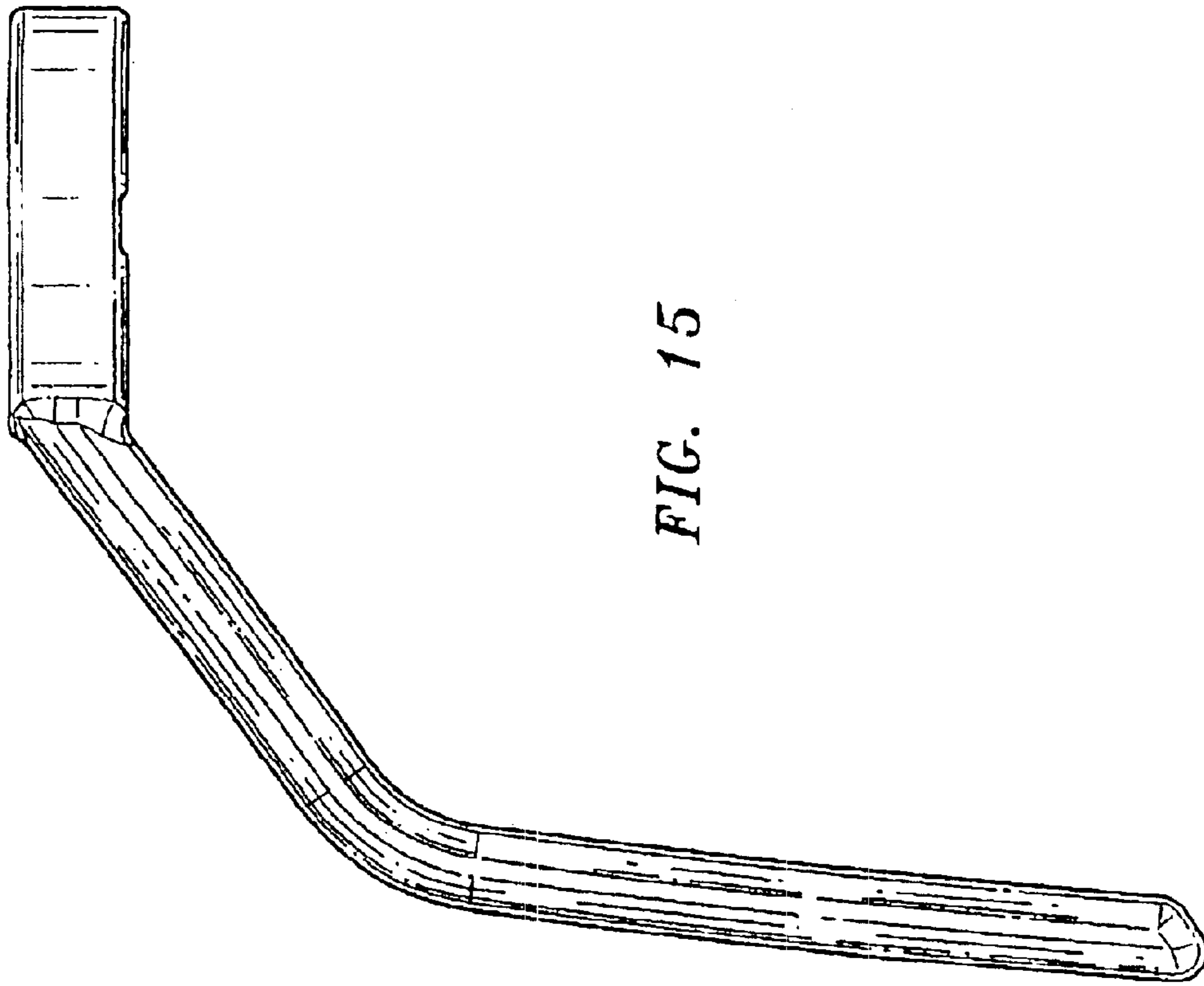

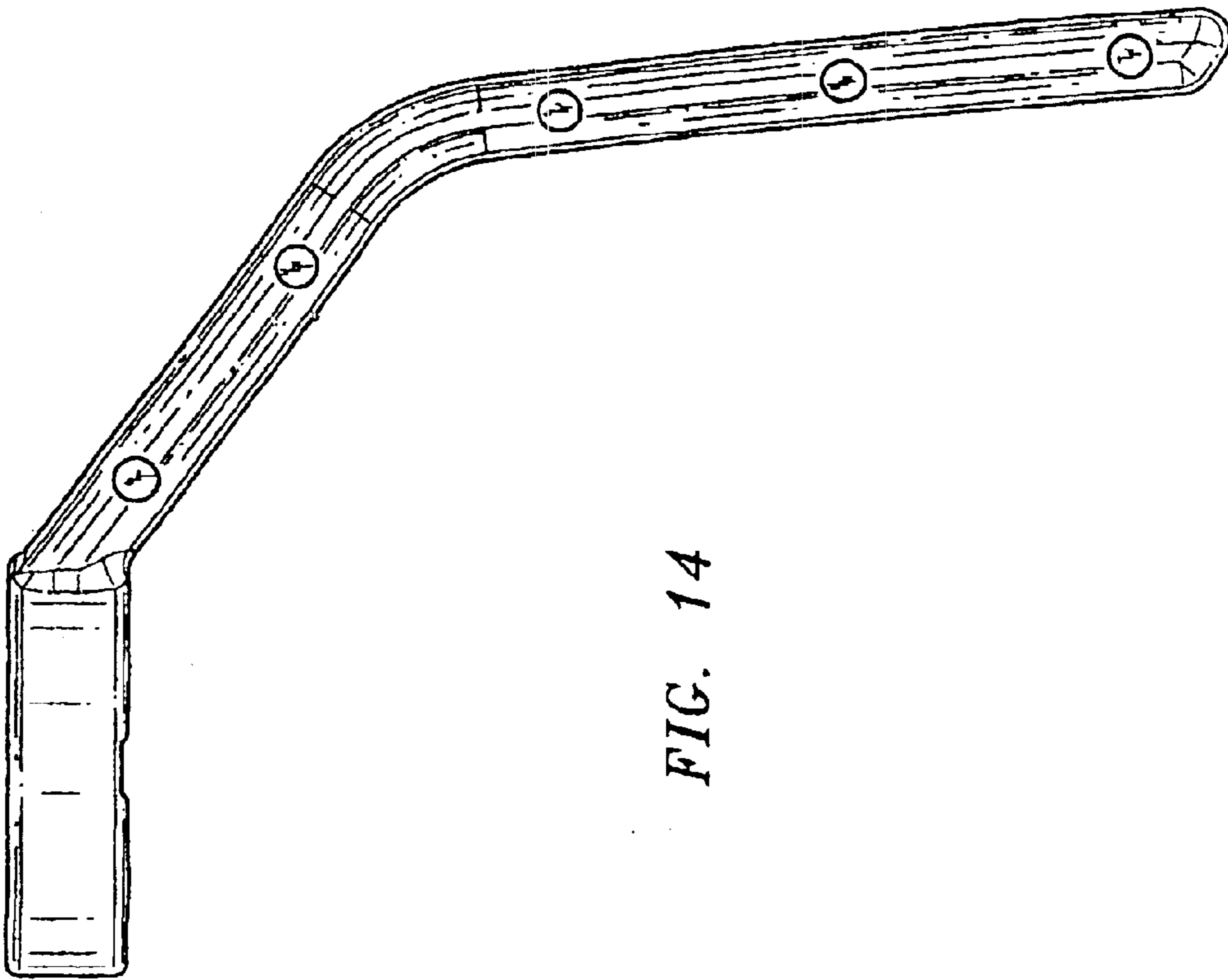
