(57) **CLAIM**

The ornamental design for an under-the-rim dispenser for a toilet bowl, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the under-the-rim dispenser for a toilet bowl;

FIG. 2 is a front view of the under-the-rim dispenser for a toilet bowl;

FIG. 3 is a rear view of the under-the-rim dispenser for a toilet bowl;

FIG. 4 is a right-side view of the under-the-rim dispenser for a toilet bowl;

FIG. 5 is a left-side view of the under-the-rim dispenser for a toilet bowl;

FIG. 6 is a top view of the under-the-rim dispenser for a toilet bowl, in which the hook shown in broken lines in FIGS. 1–5 is sectioned in order to show the entire top of the claimed design for the under-the-rim dispenser for a toilet bowl; and,

FIG. 7 is a bottom view of the under-the-rim dispenser for a toilet bowl.

The broken lines, shown in FIGS. 1–7, form no part of the claim.

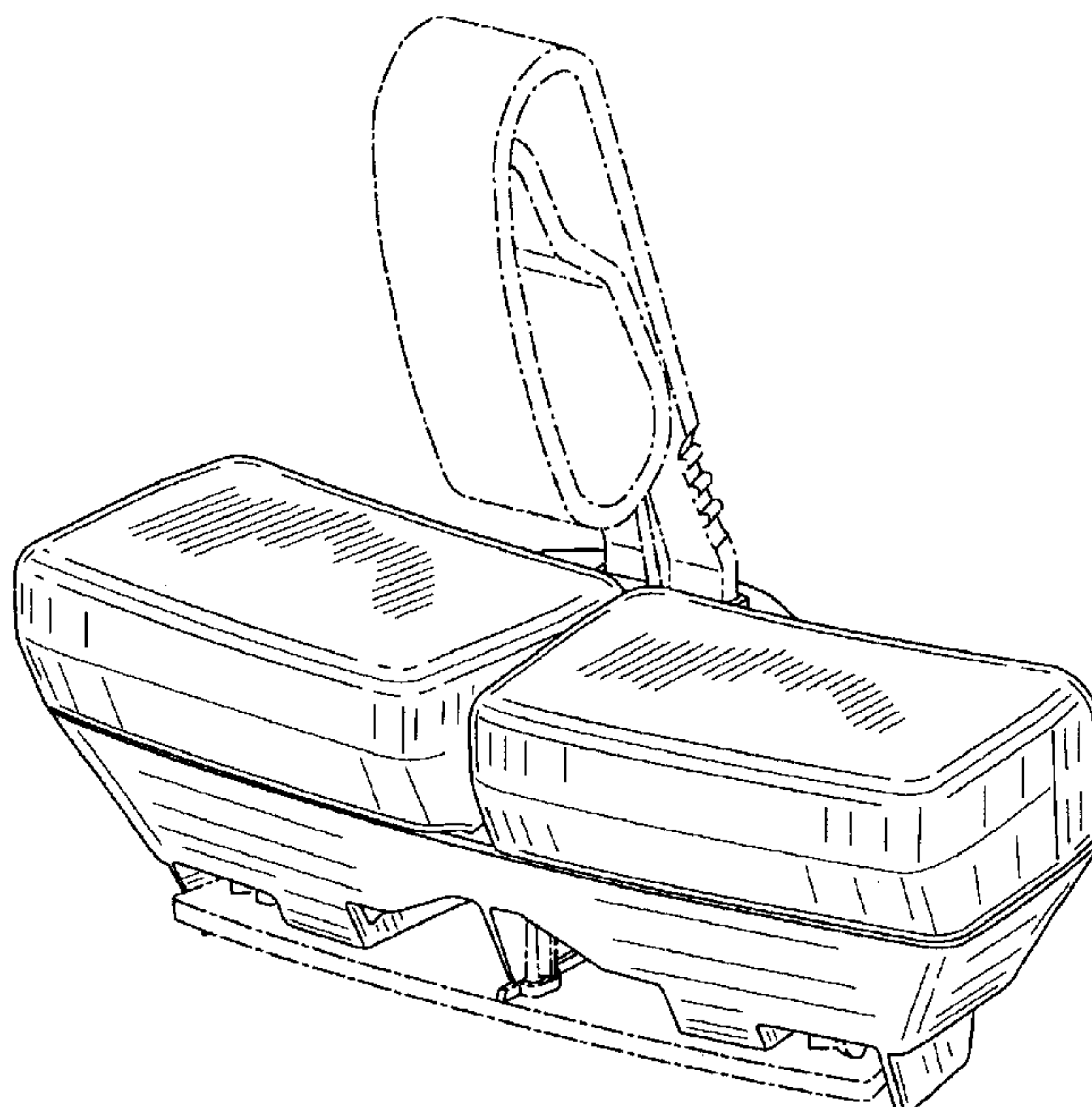

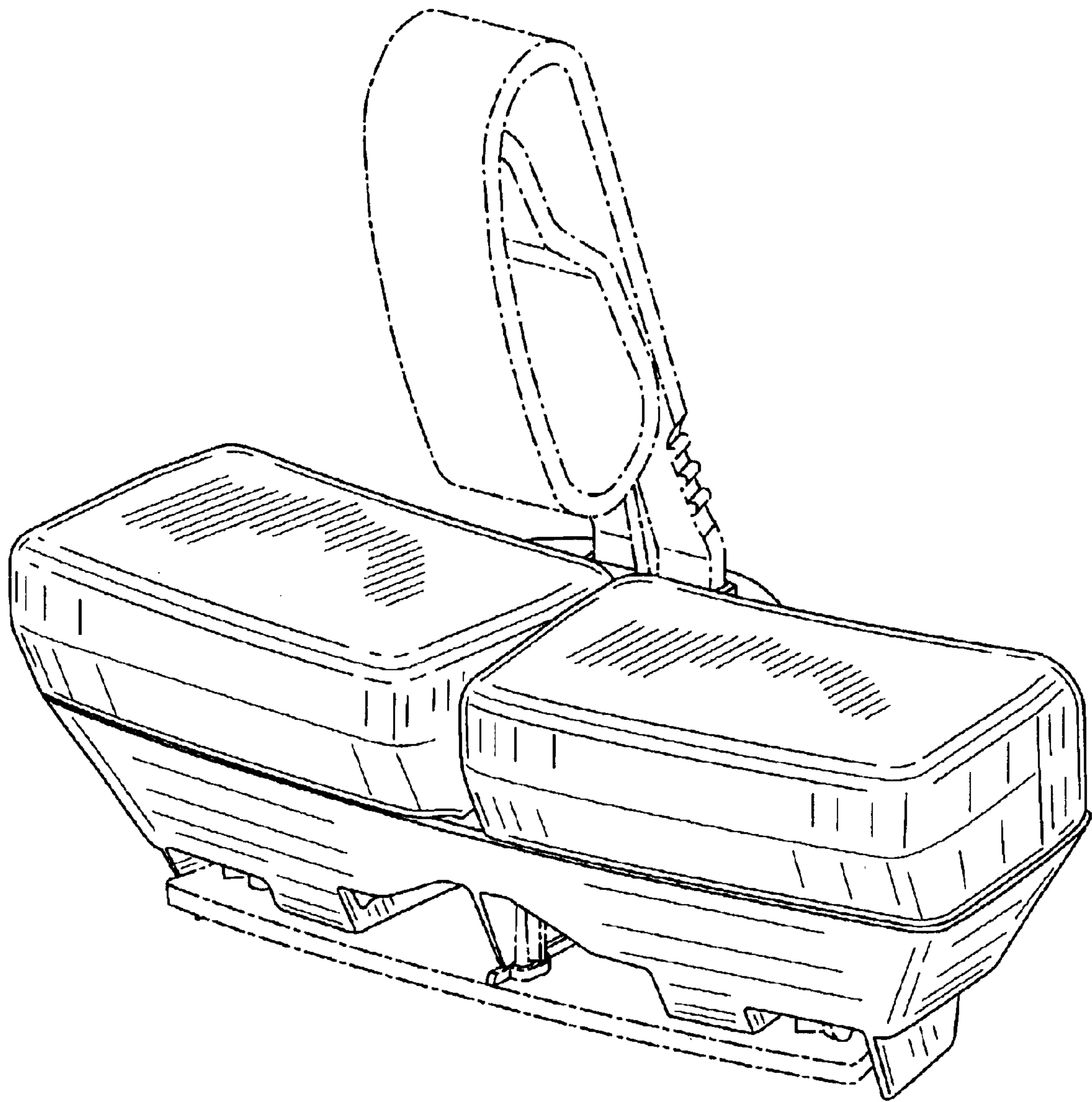

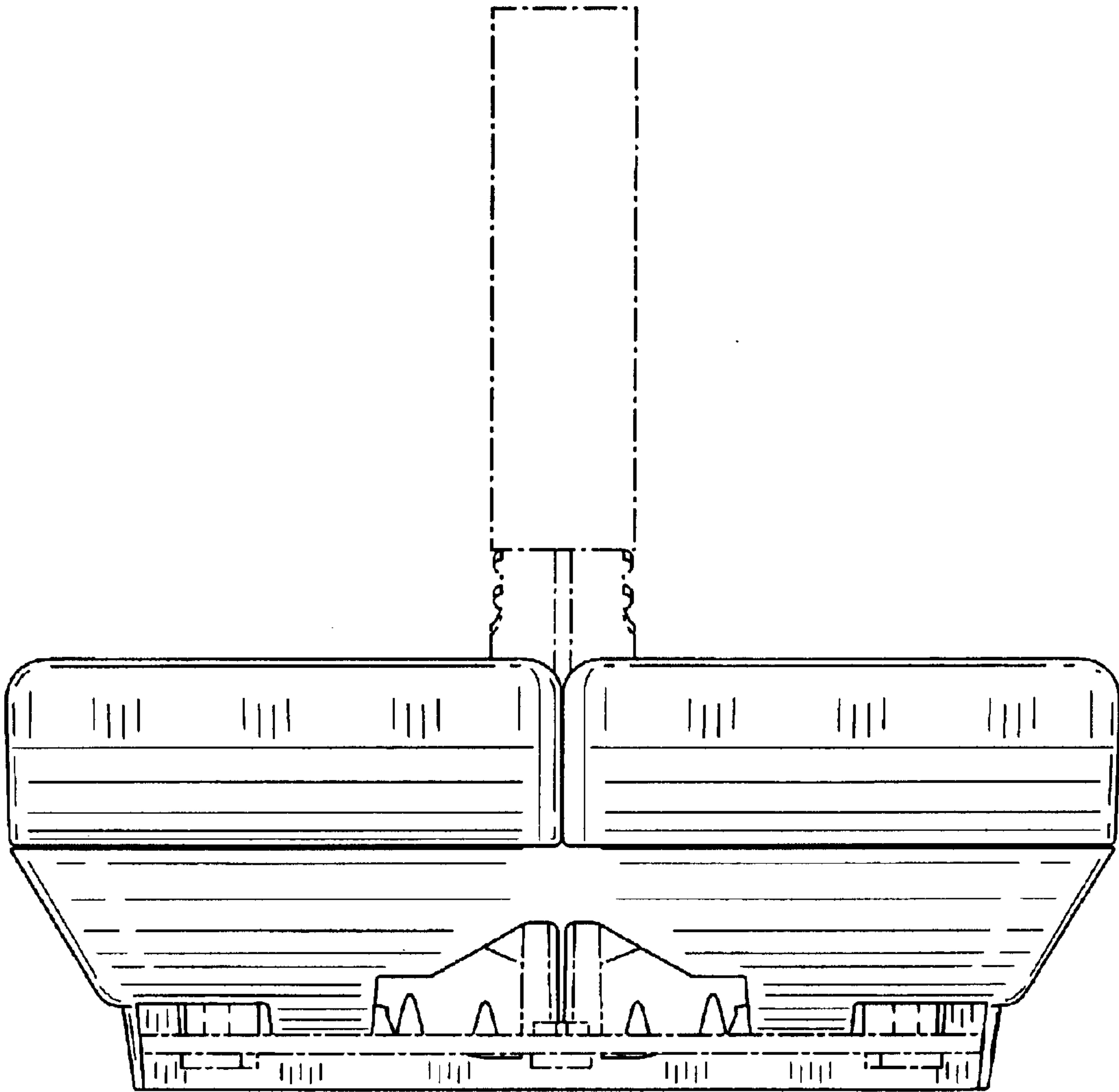

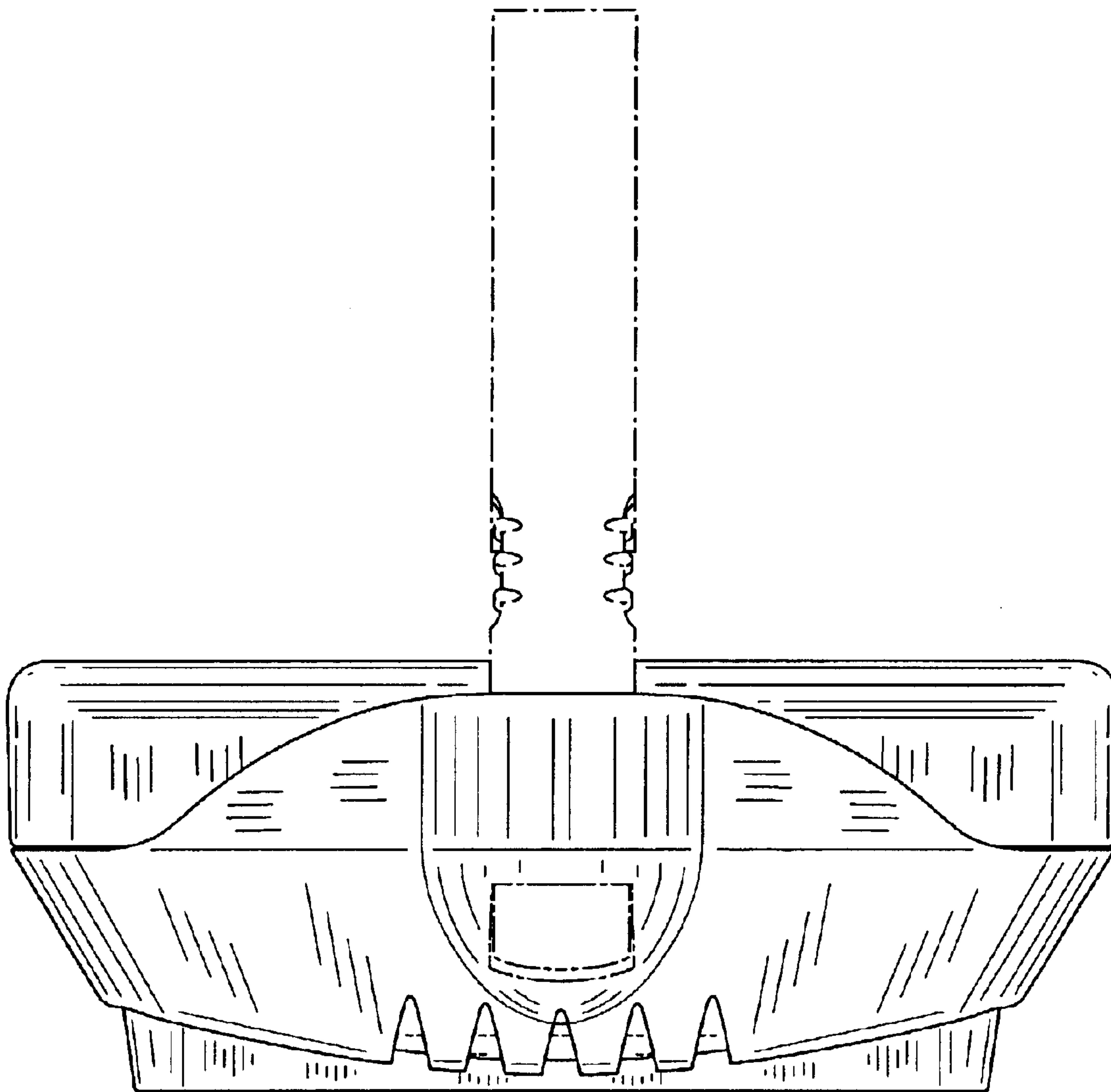

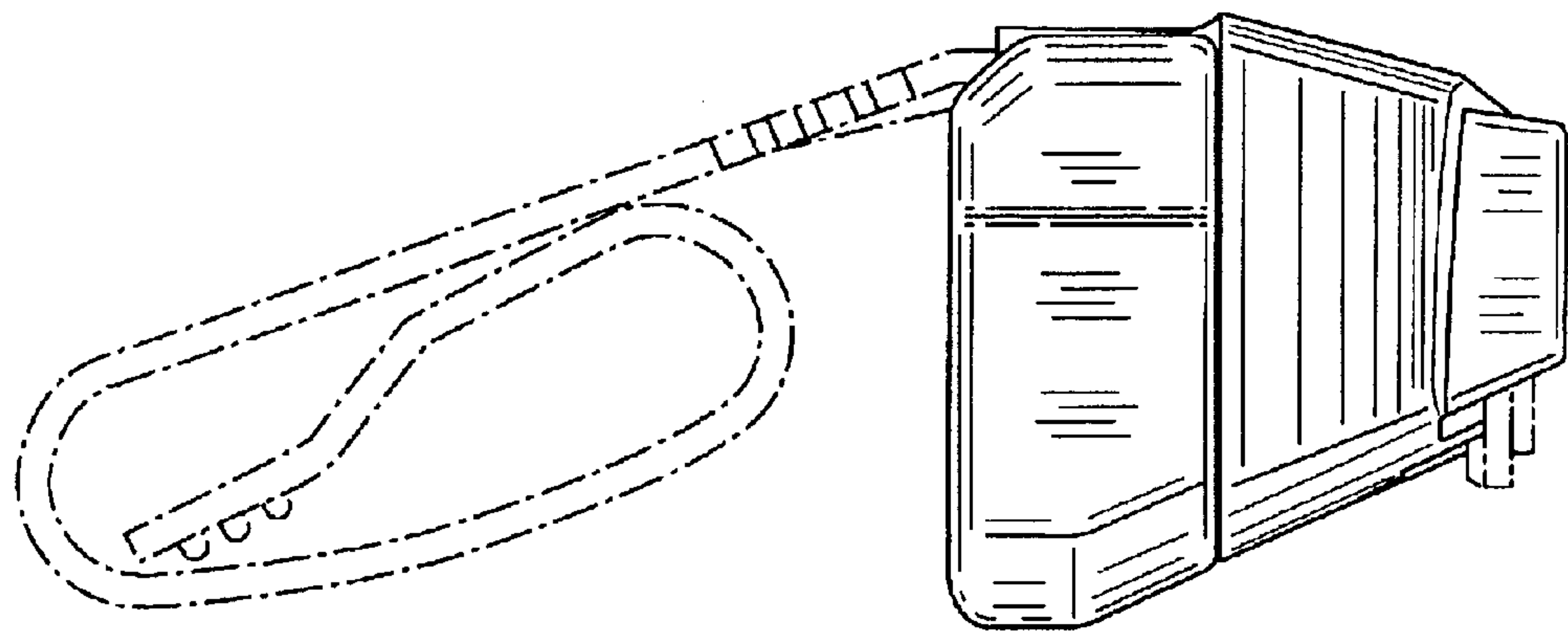

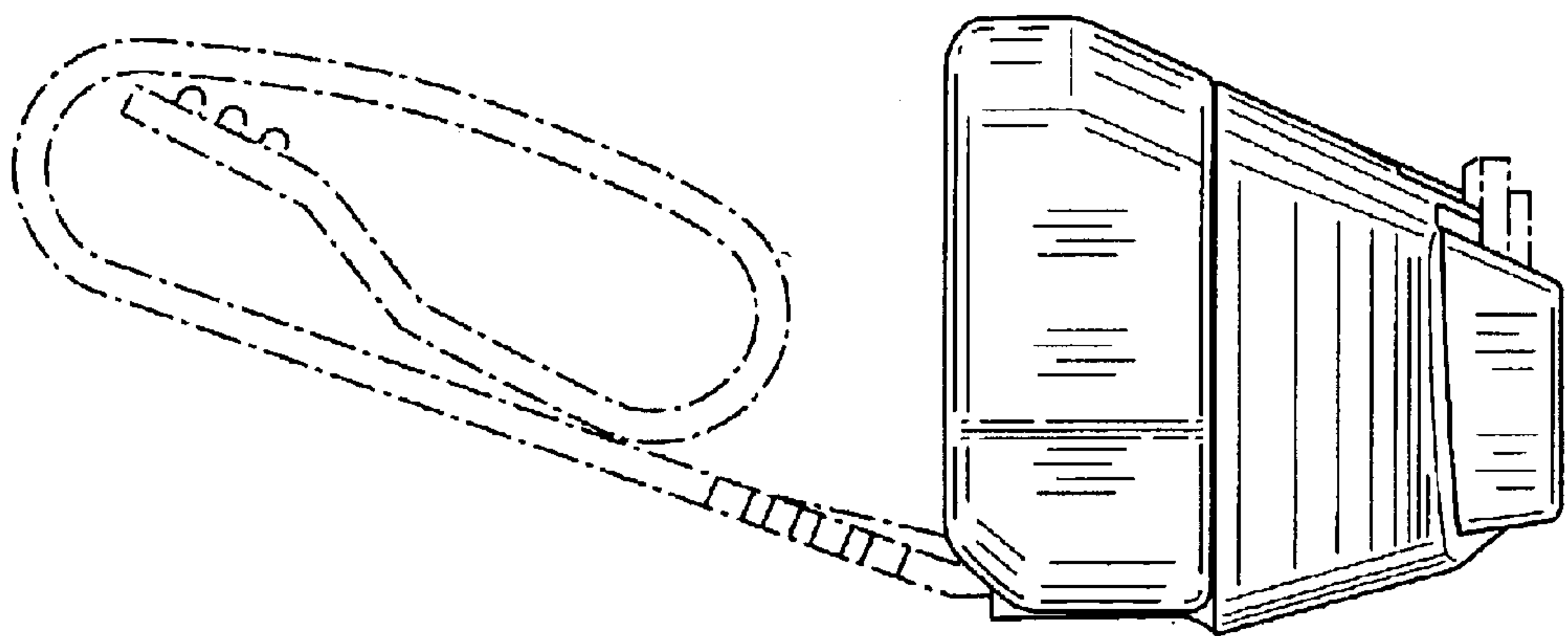

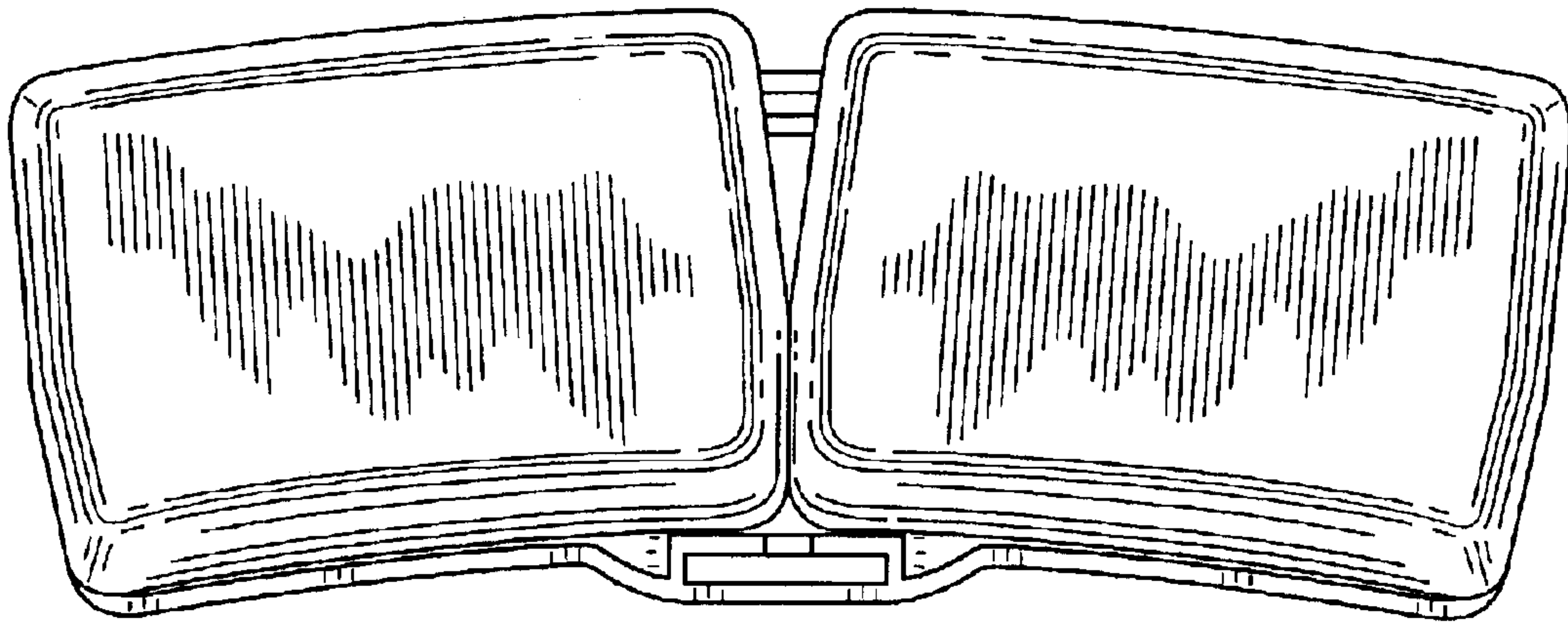

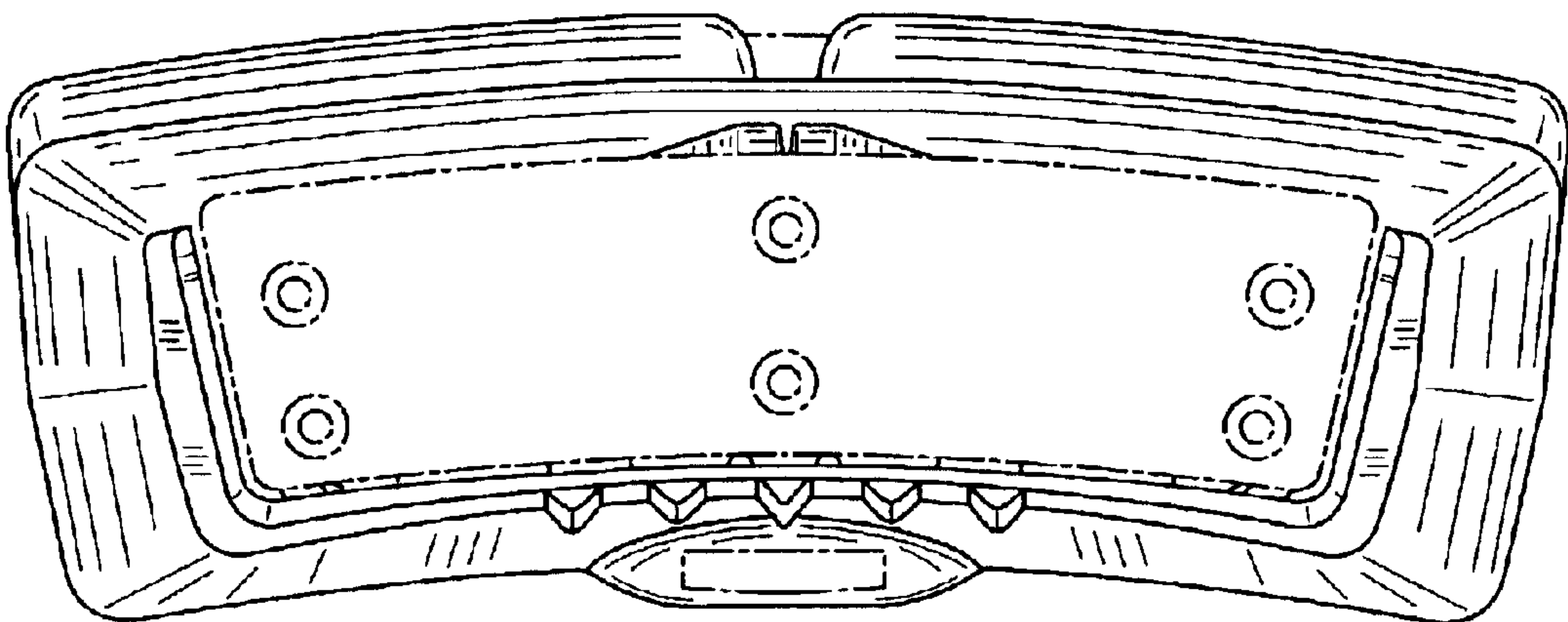
