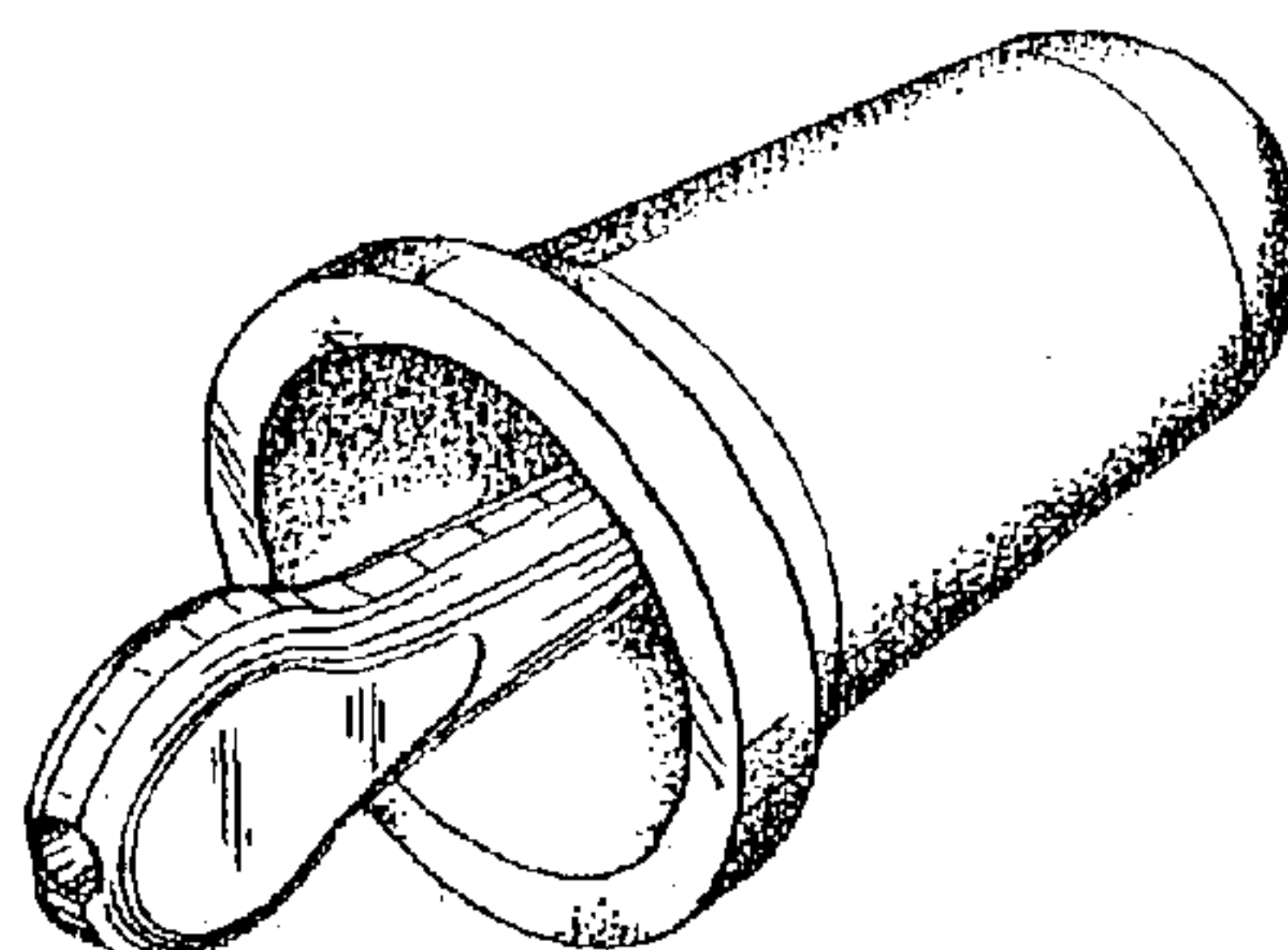
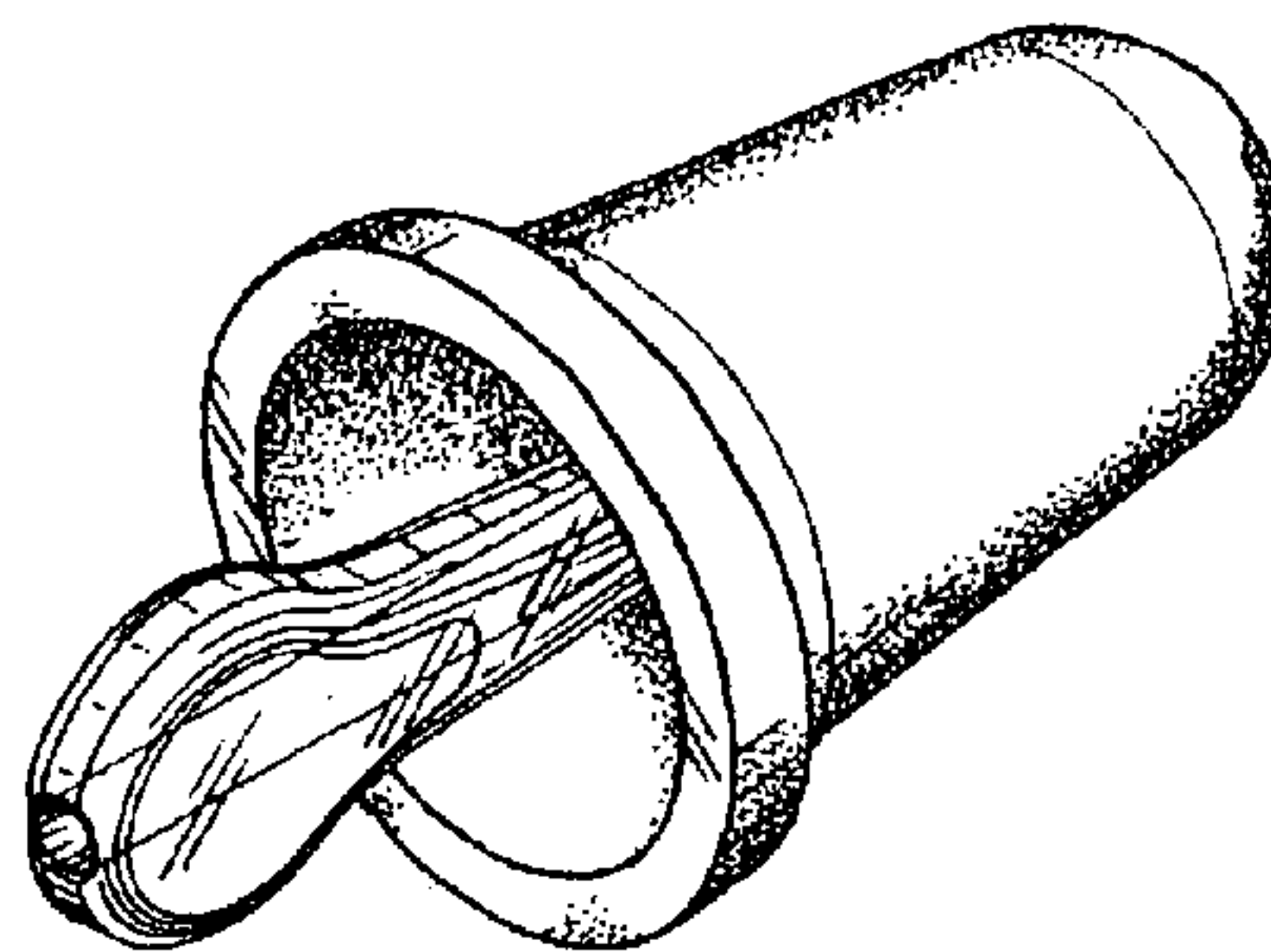
FIG. 1 is a perspective view of our new stemmed earplug;

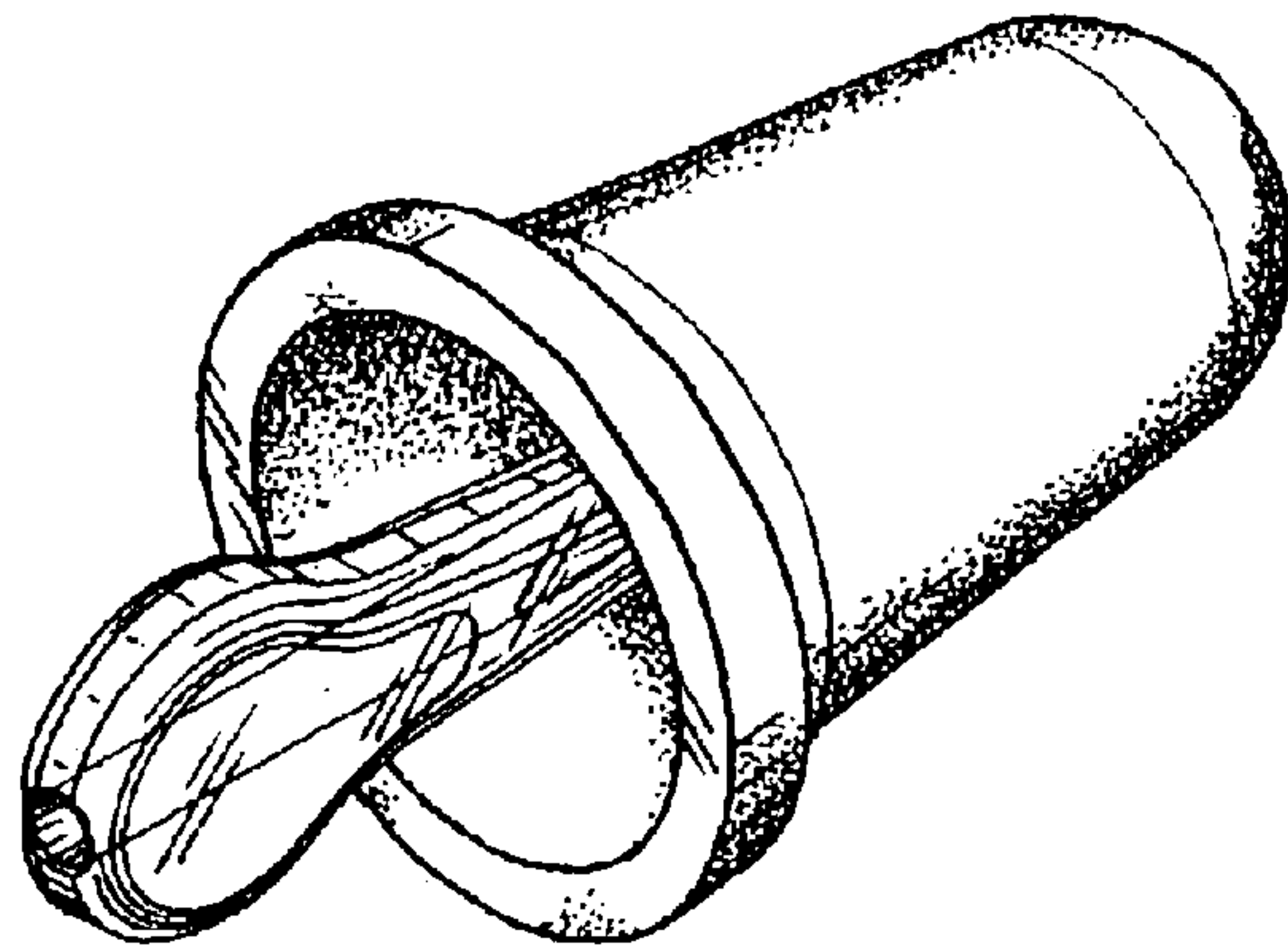

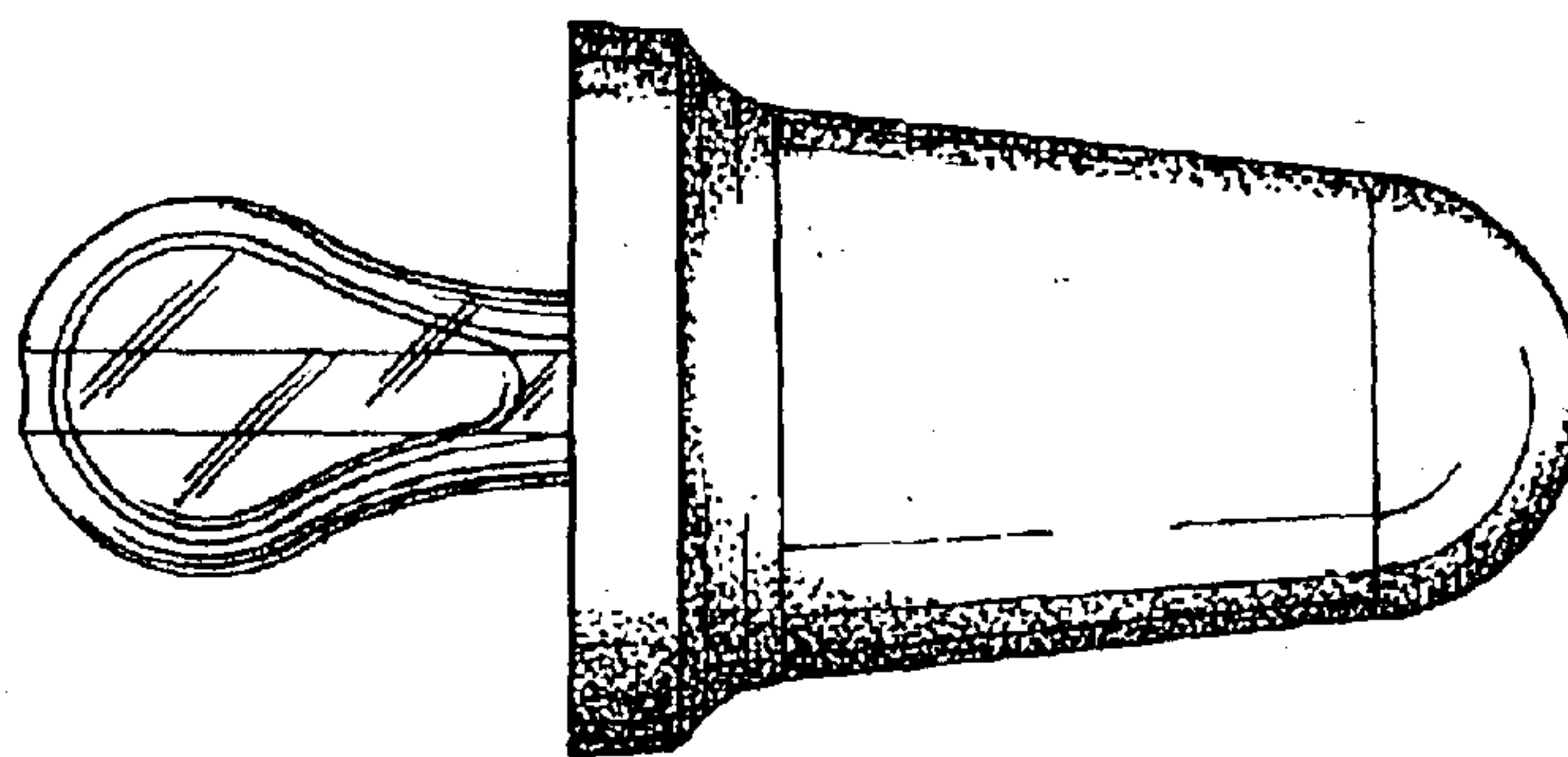

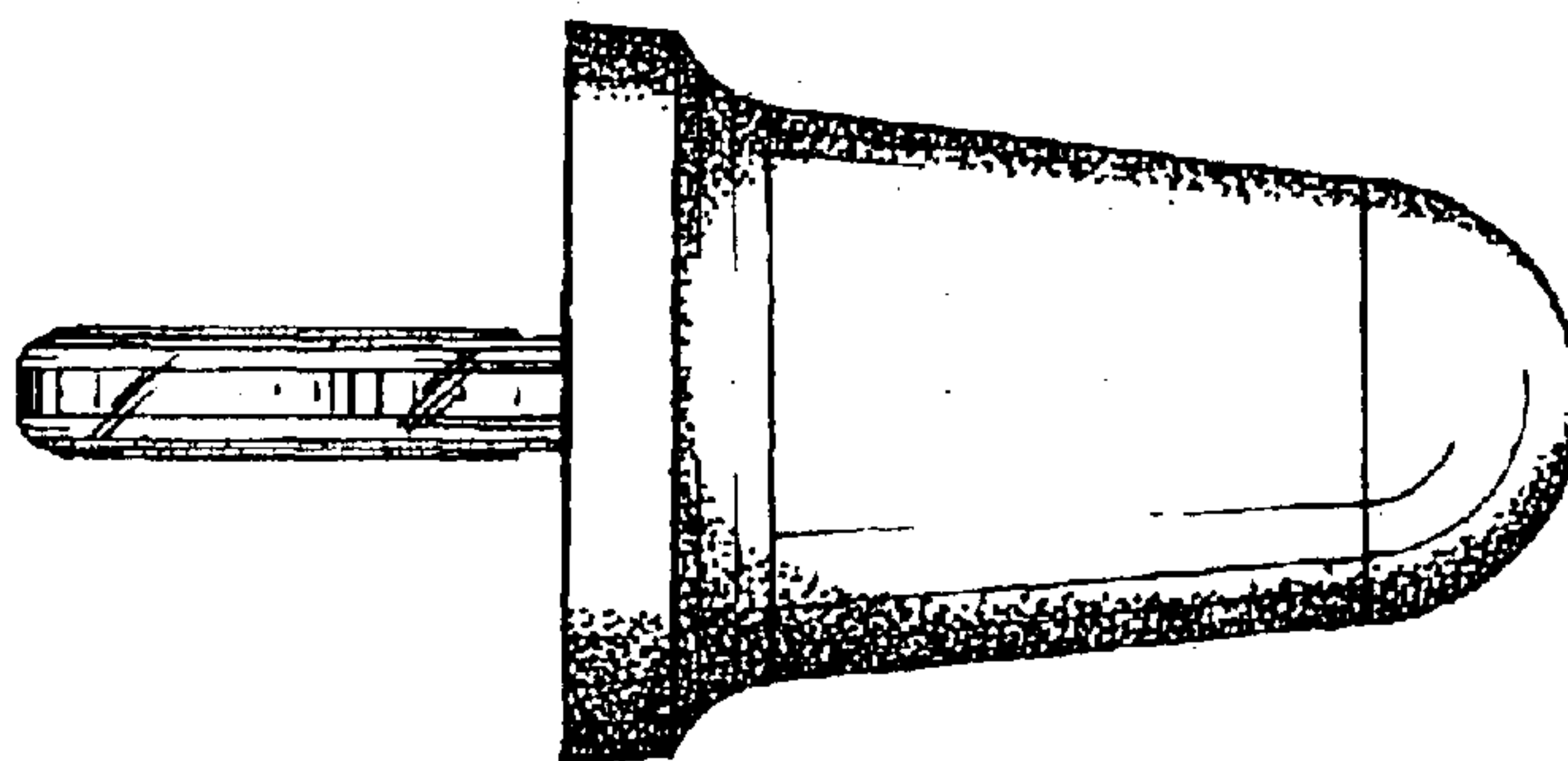

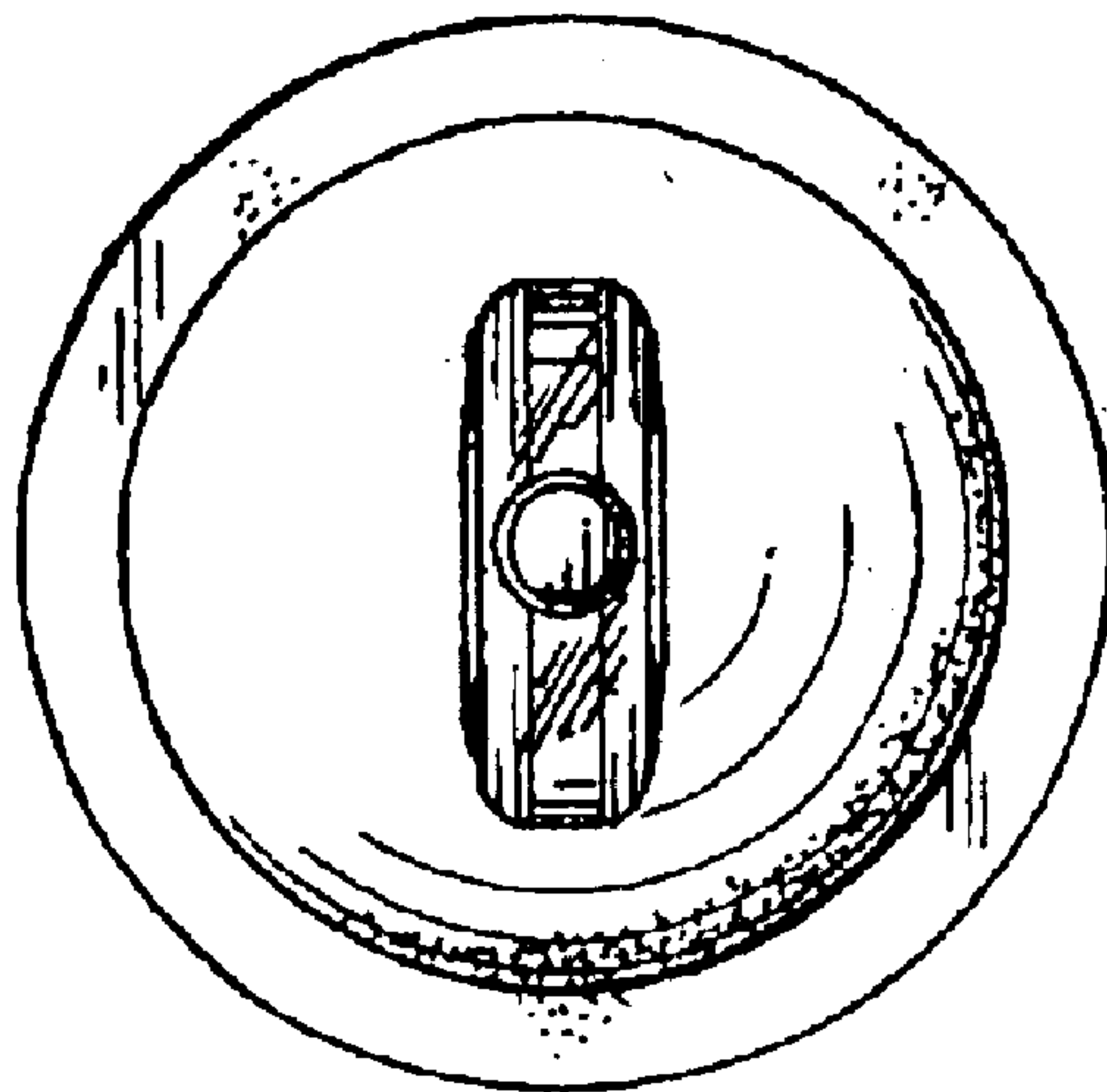

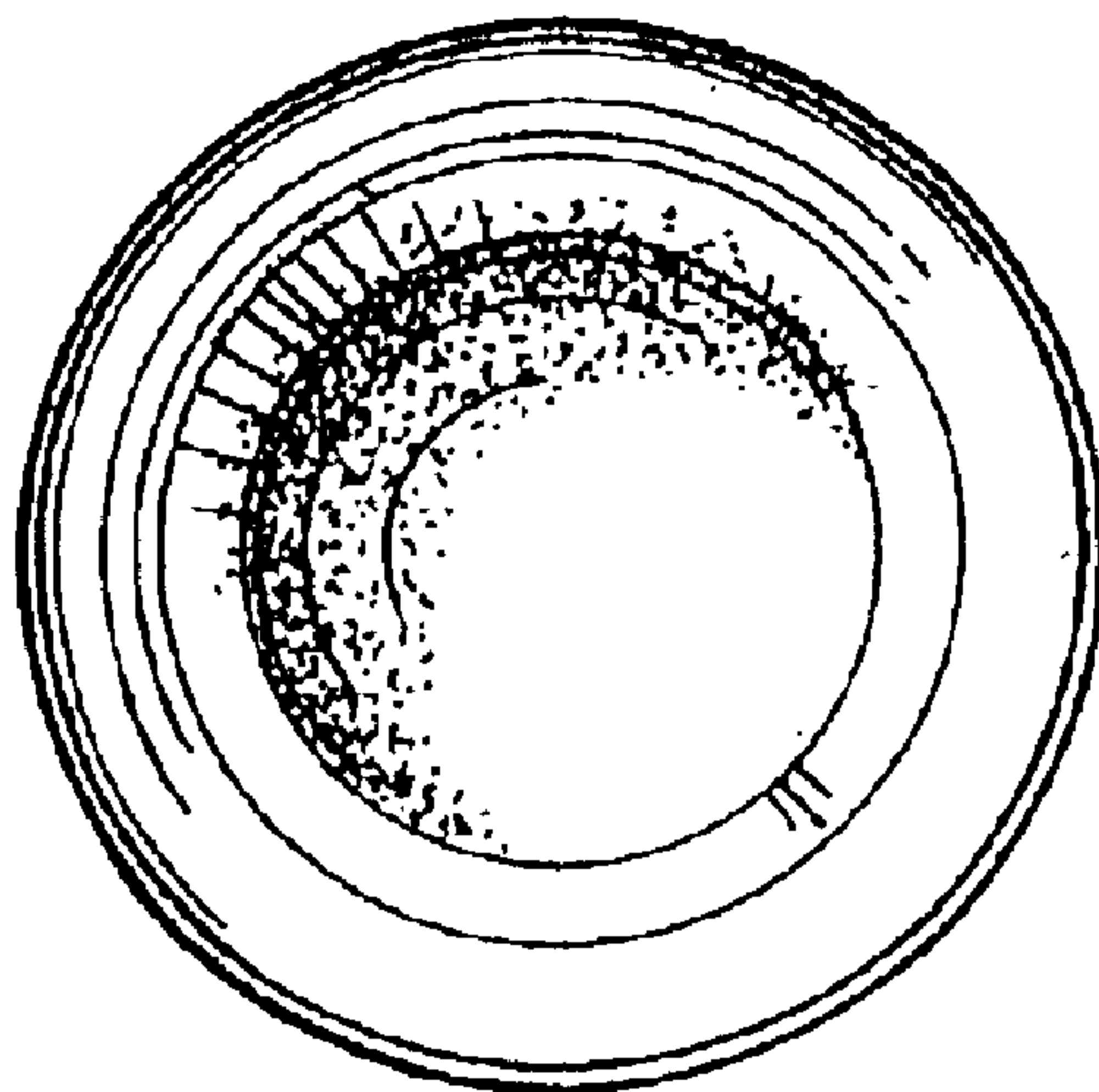

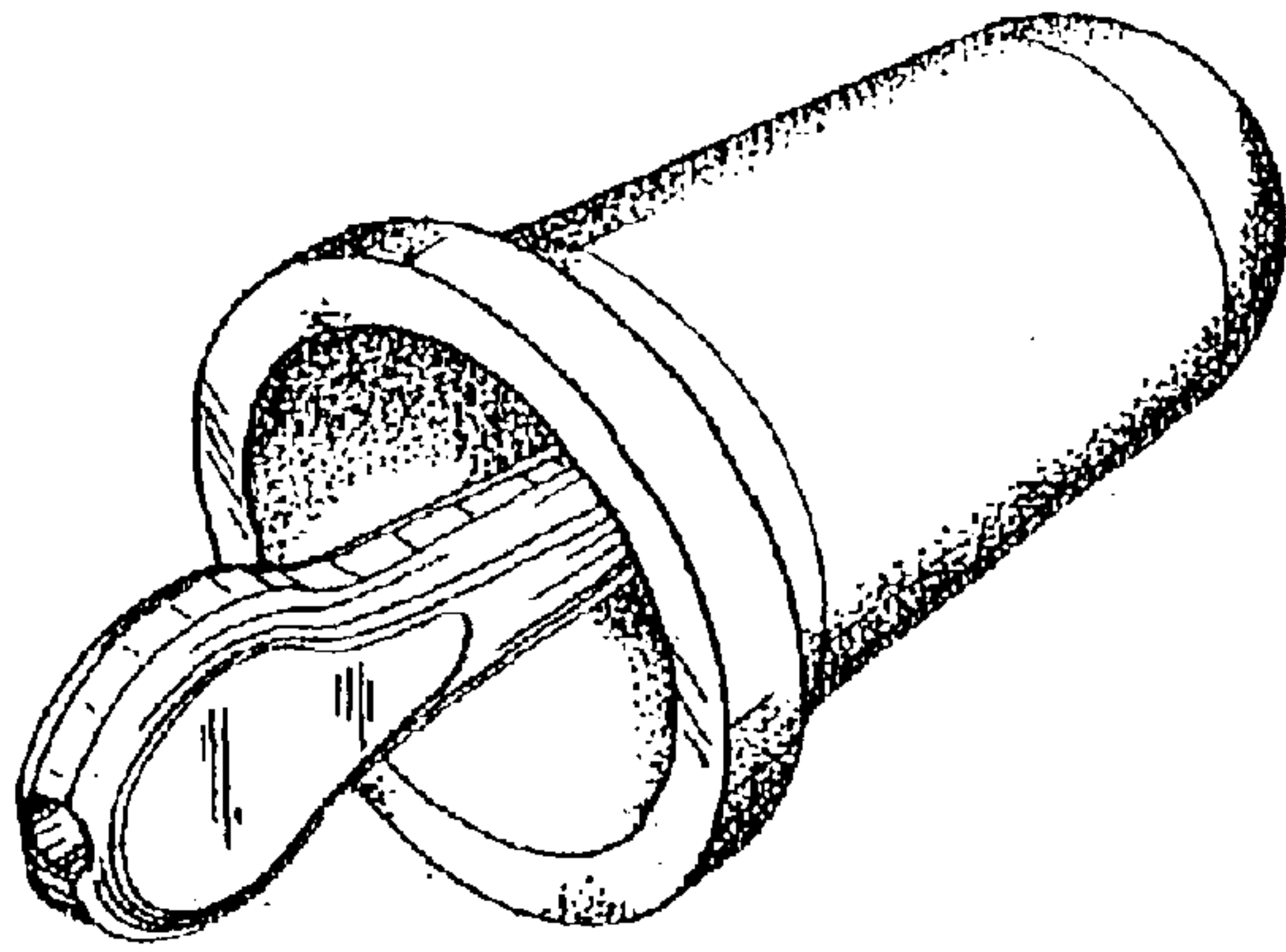

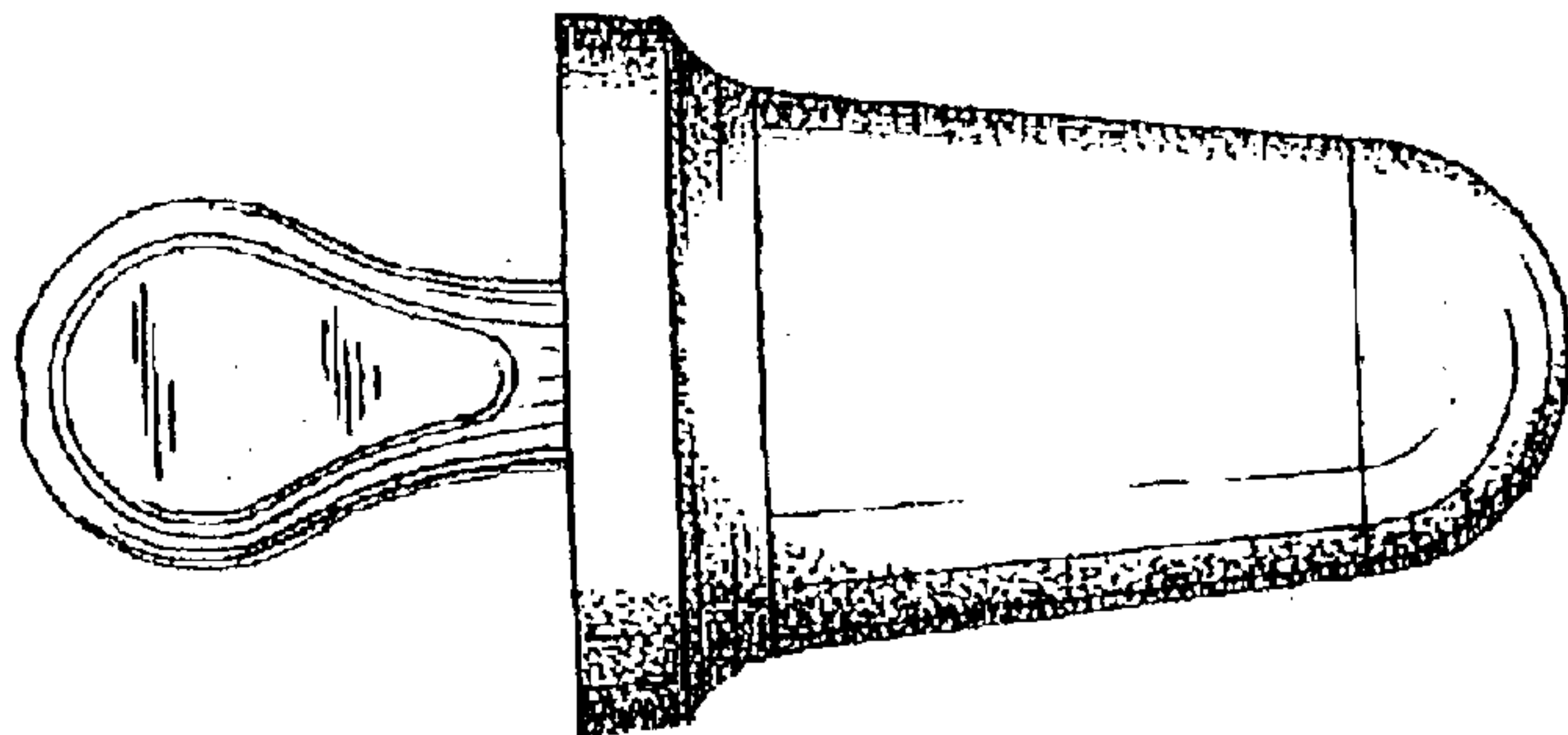

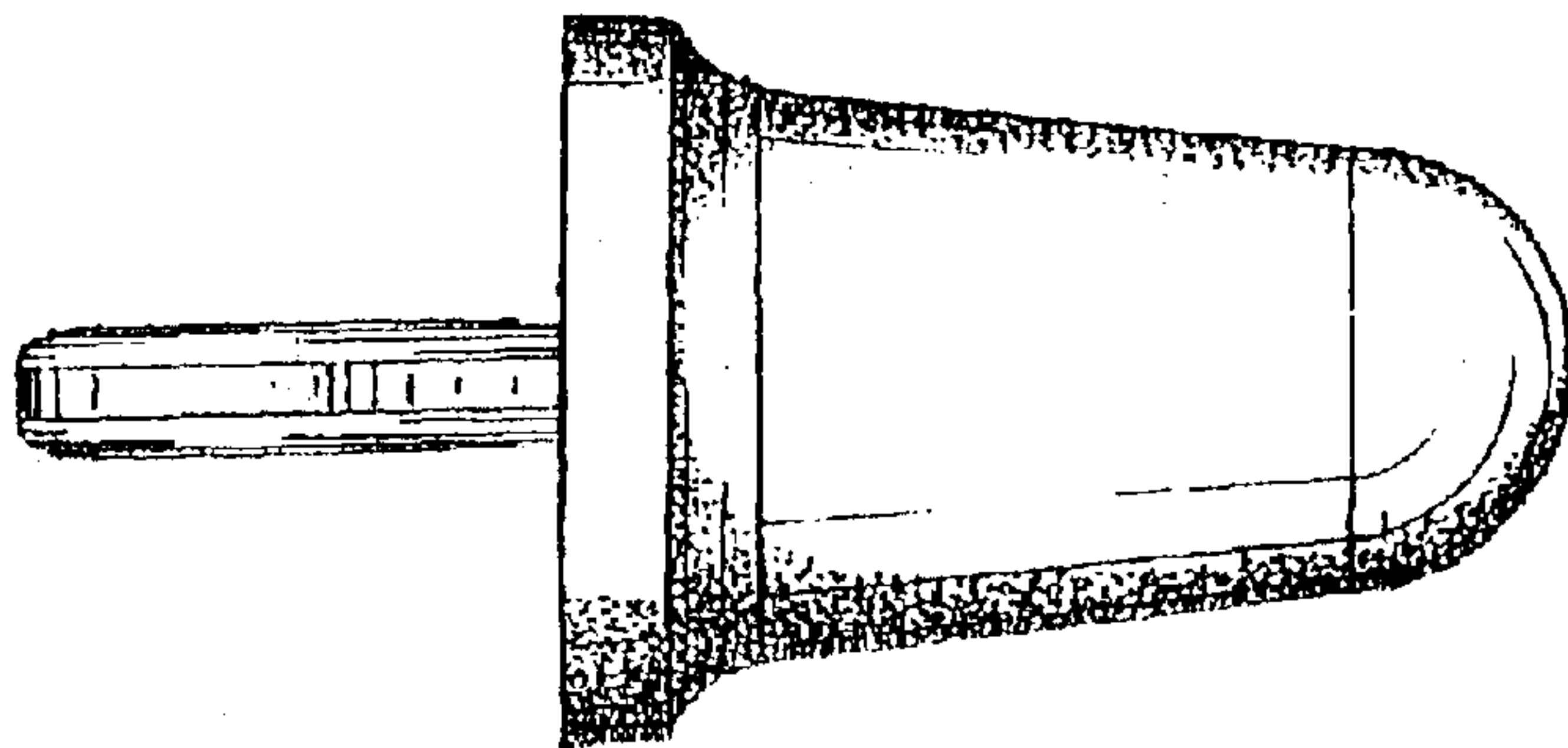

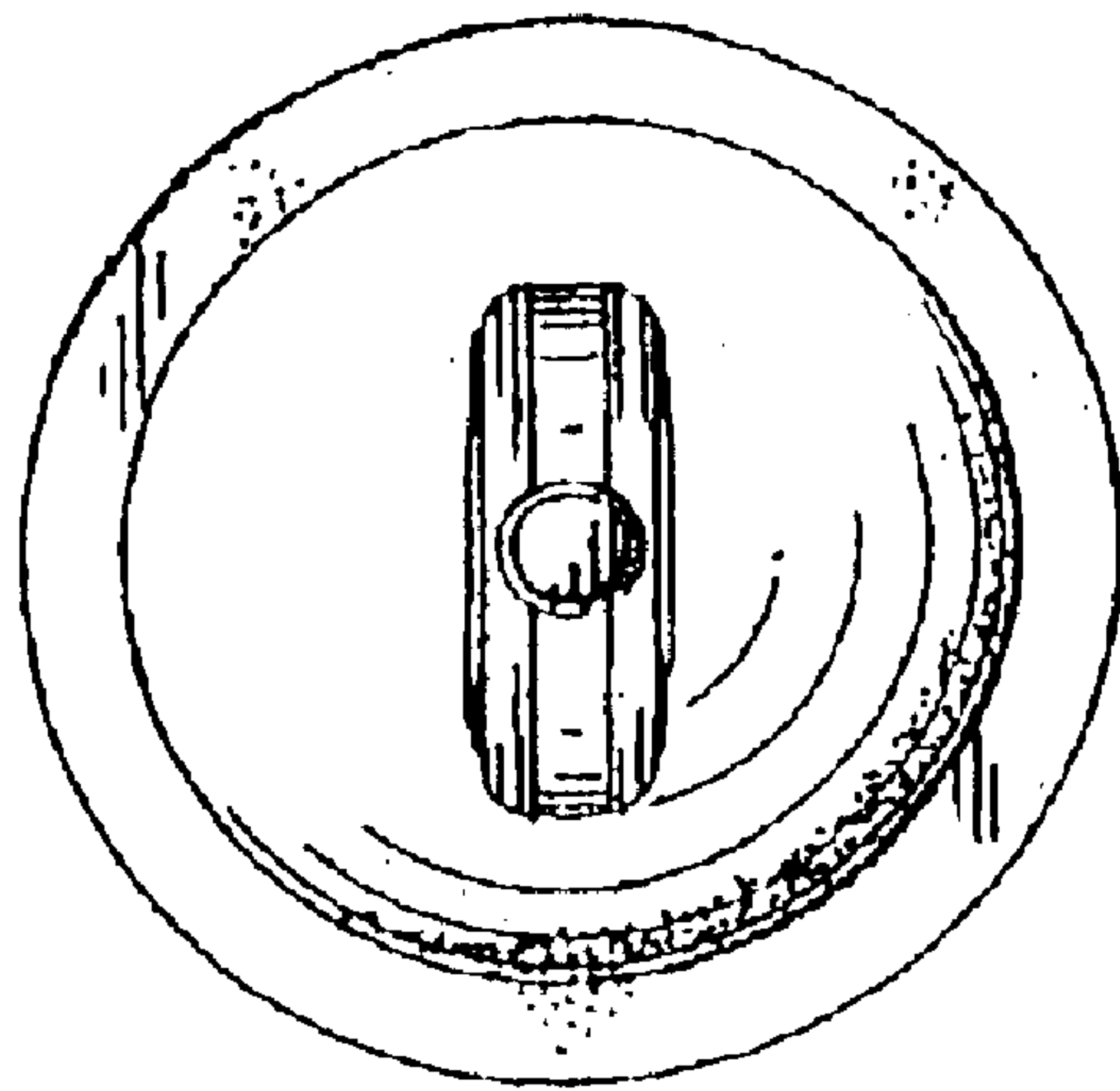

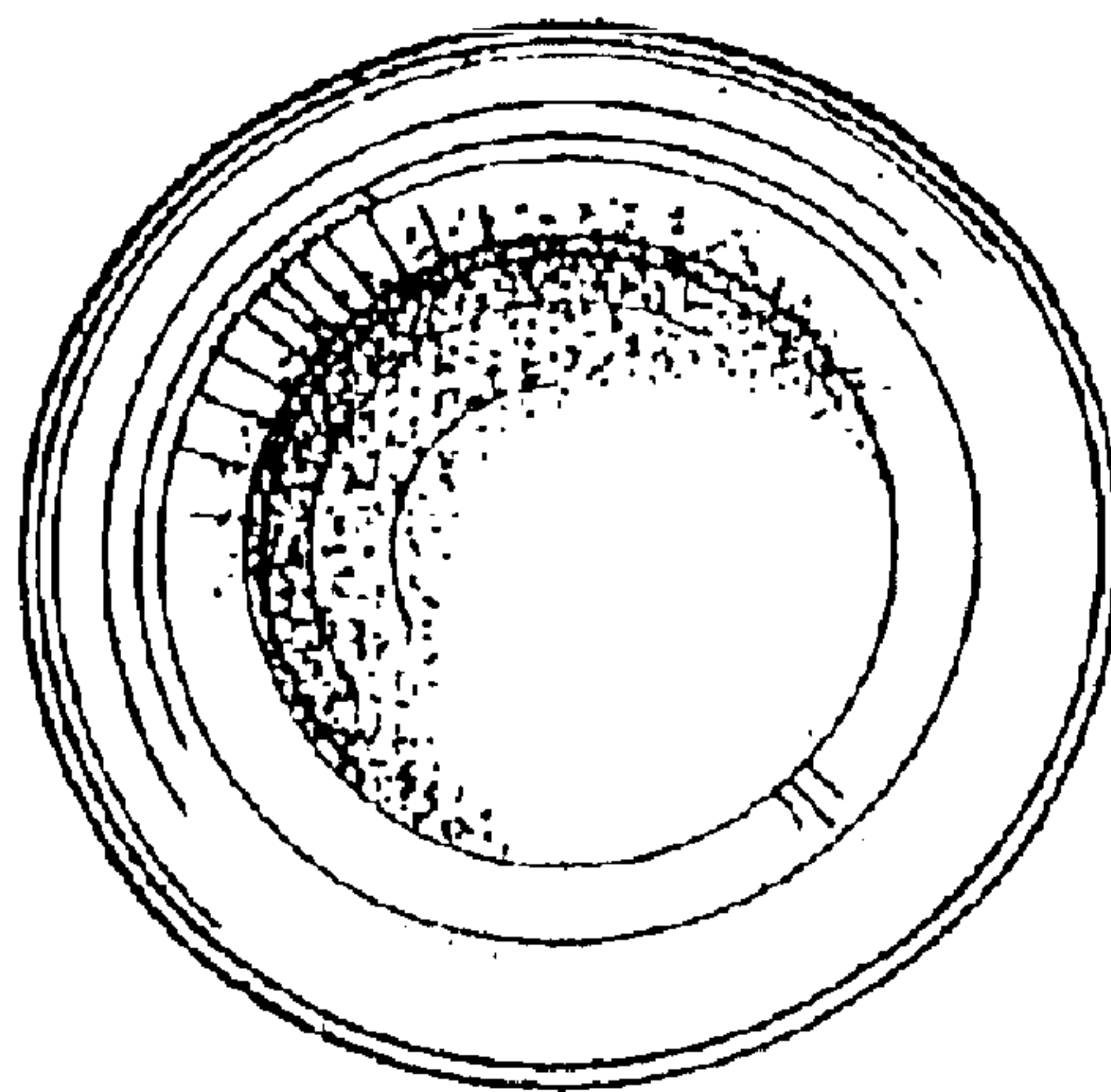
