(57) **CLAIM**

The ornamental design for a windowed protective cover, as shown and described.

DESCRIPTION

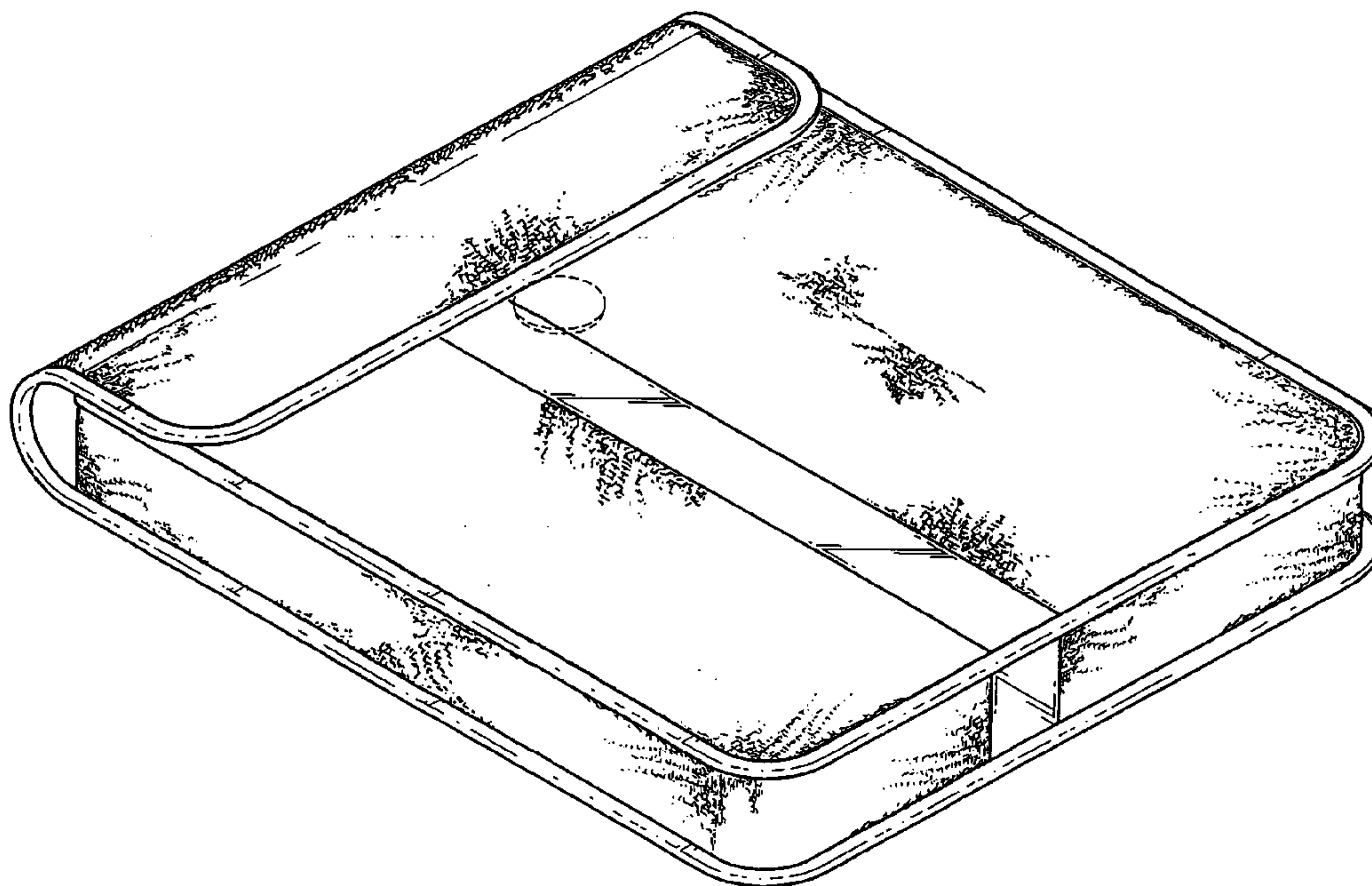
FIG. 1 is an isometric view of a windowed protective cover of the present invention, wherein the broken line depiction of the fastener is included for illustrative purposes and forms no part of the claimed design.

FIG. 2 is a front view of the windowed protective cover, wherein the broken line depiction of the fastener is included for illustrative purposes and forms no part of the claimed design.

FIG. 3 is a bottom view of the windowed protective cover. FIG. 4 is a top view of the windowed protective cover; and, FIG. 5 is a side view of the windowed protective cover, wherein the broken line depiction of the fastener is included for illustrative purposes and forms no part of the claimed design, each of the side images being a mirror image thereof.

The back surface of the windowed protective cover forms no part of the claimed design.

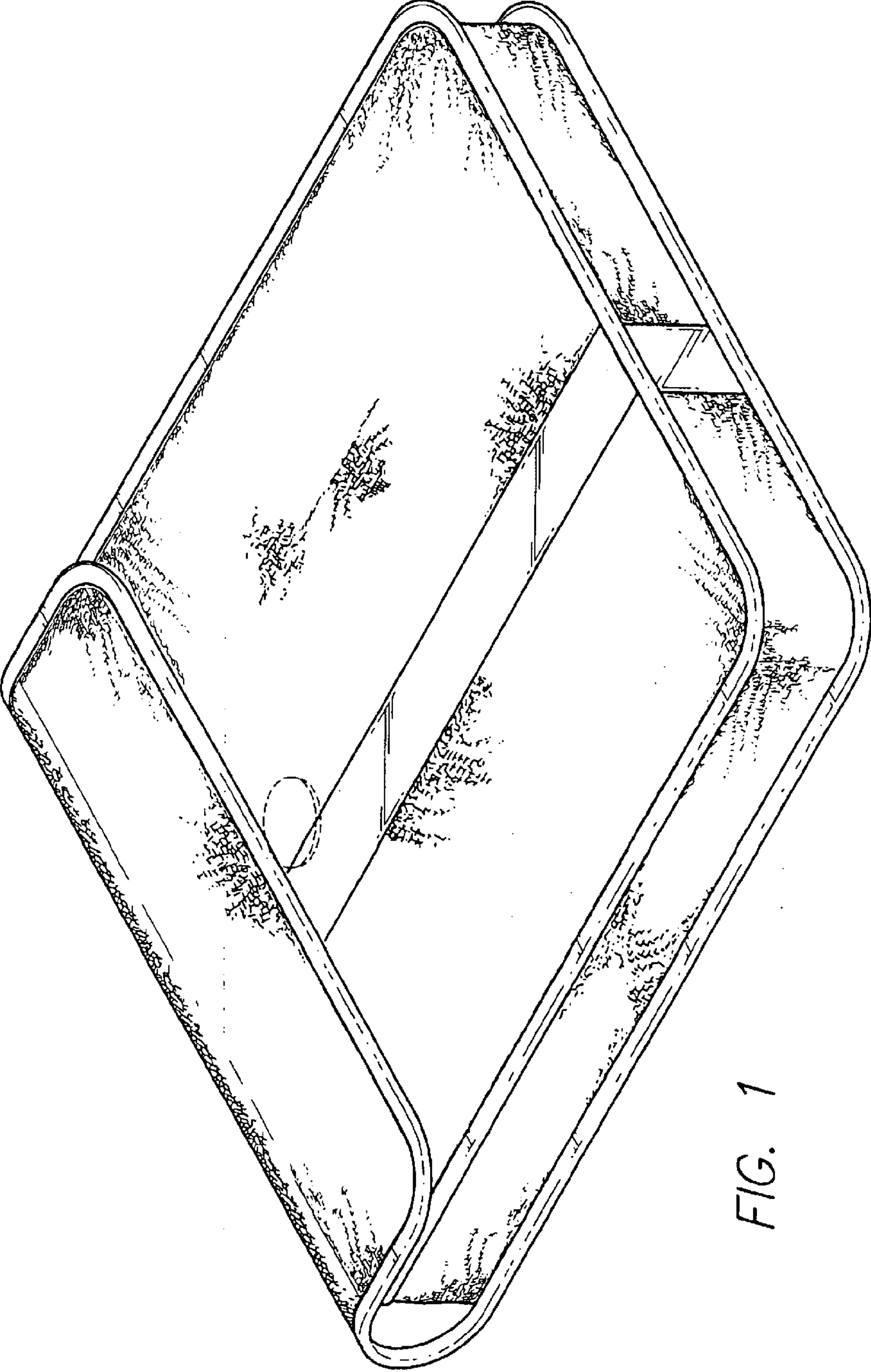

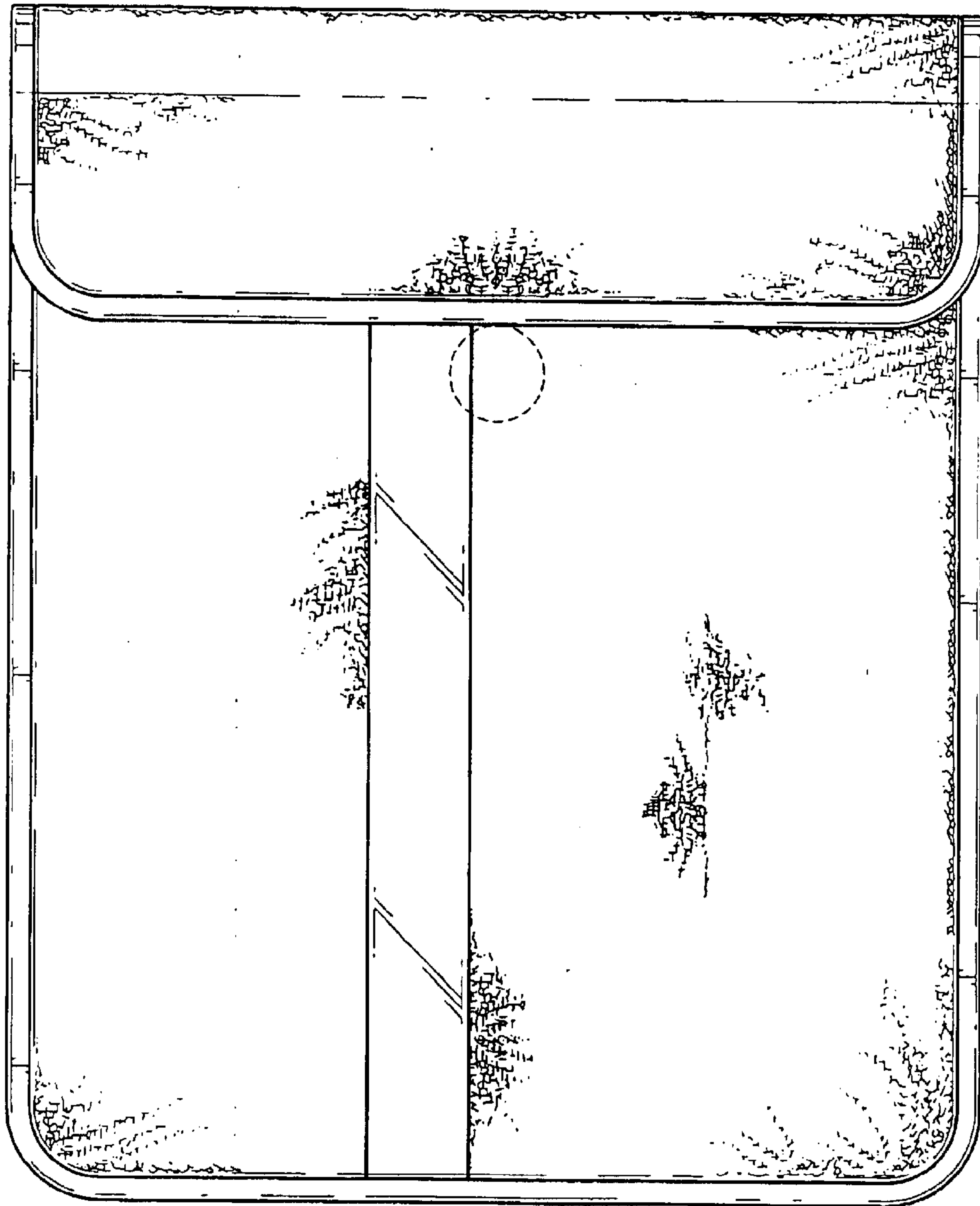

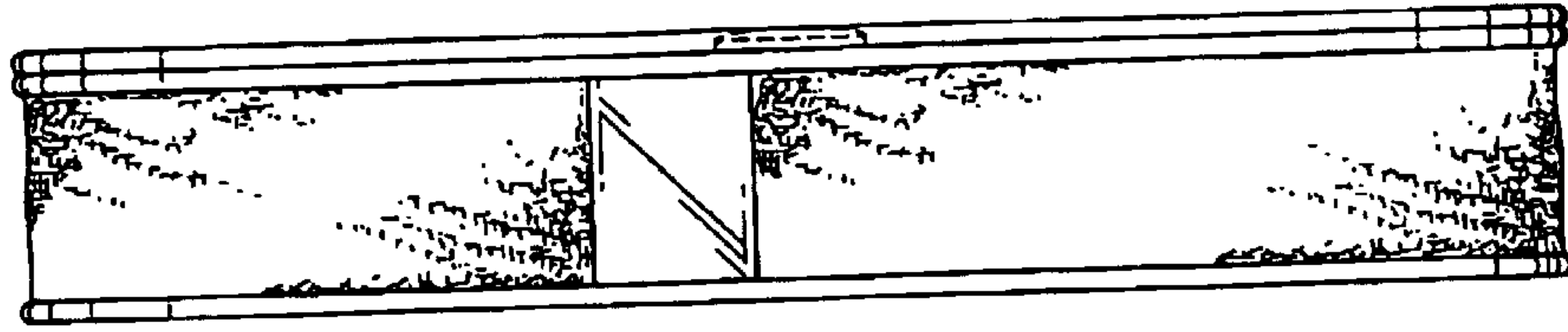

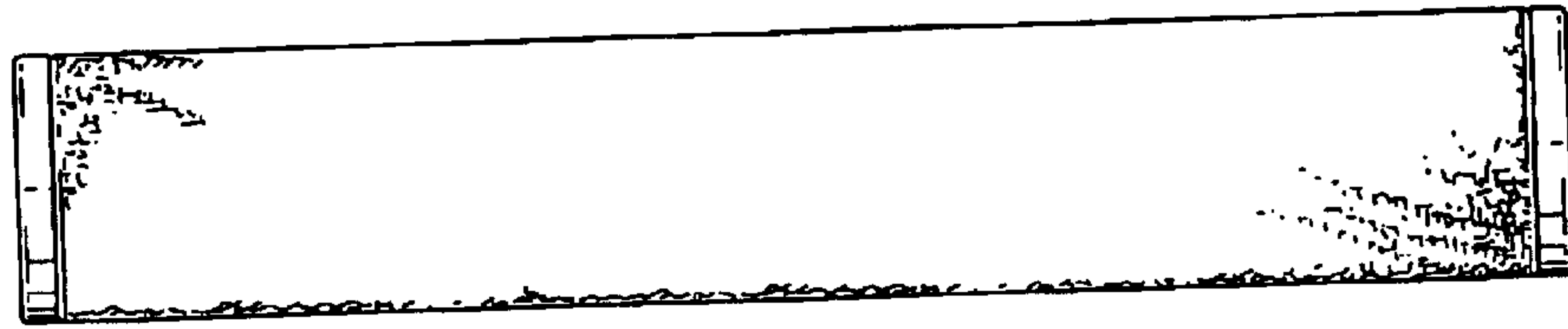

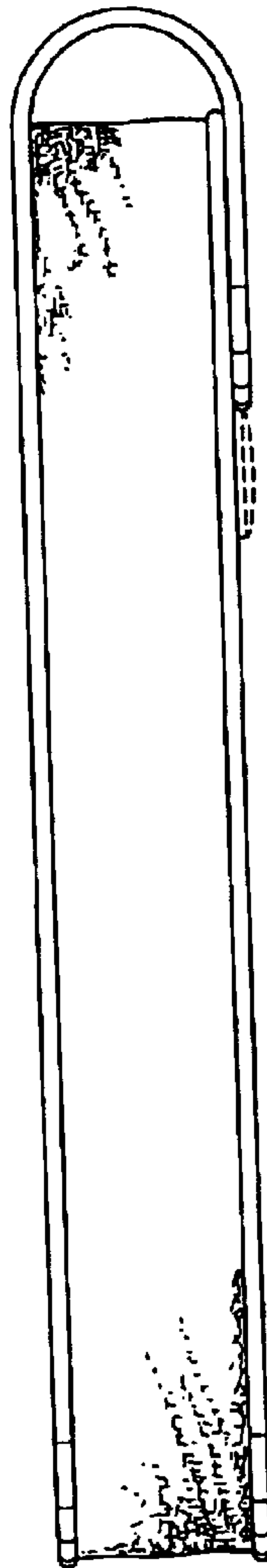
