The ornamental design for a whimsical novelty, as shown and described herein.

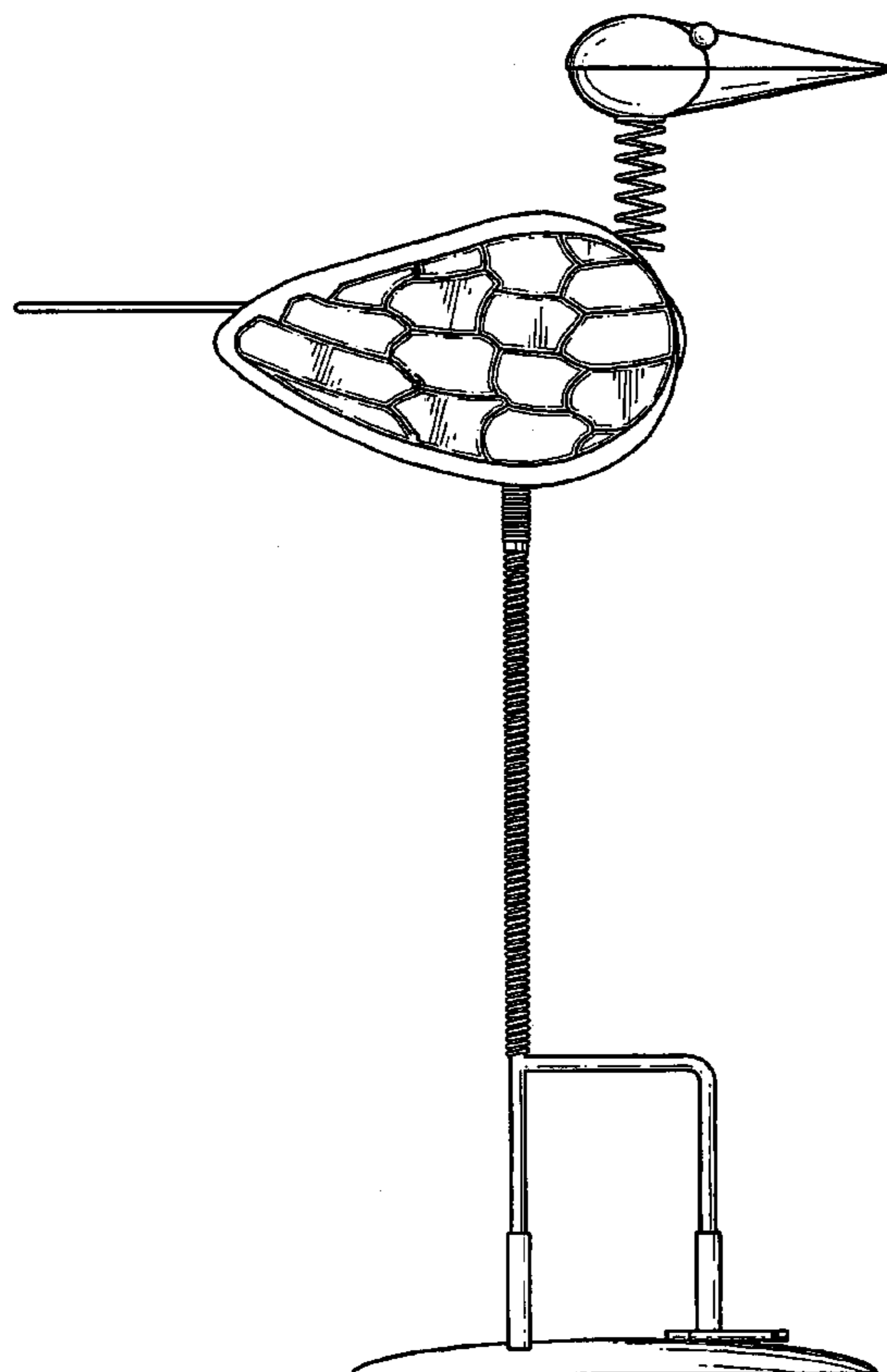
DESCRIPTION

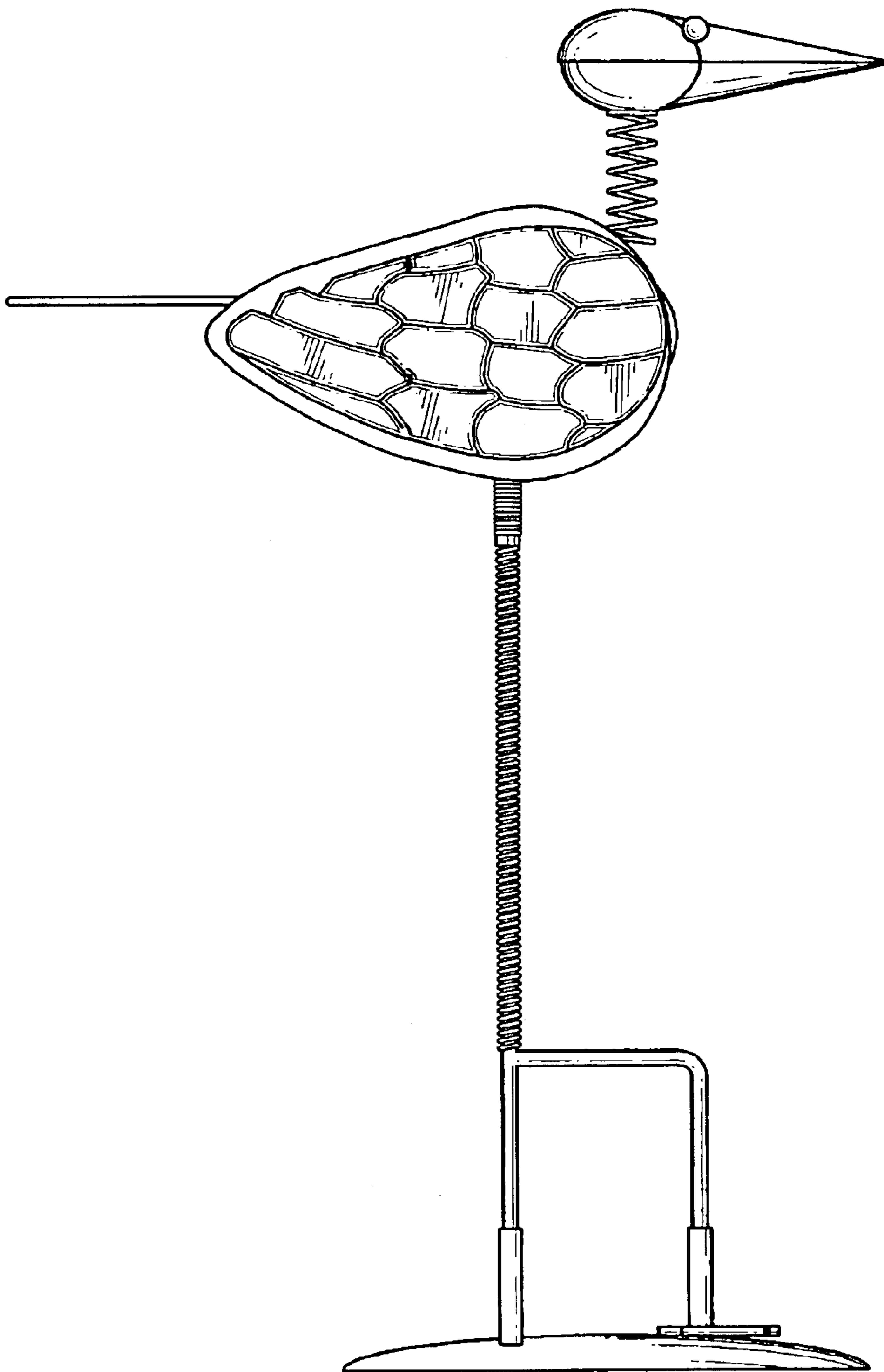

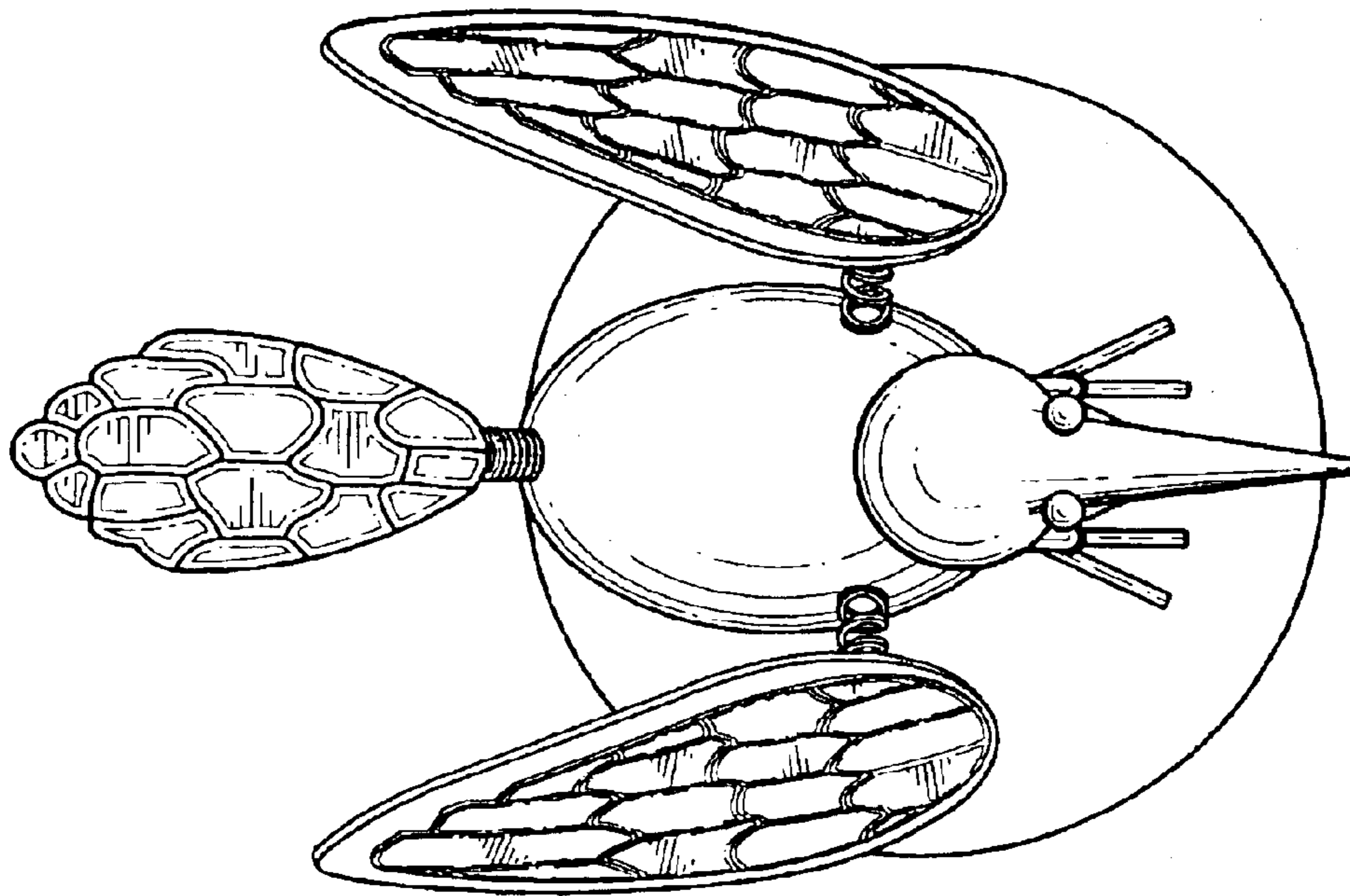

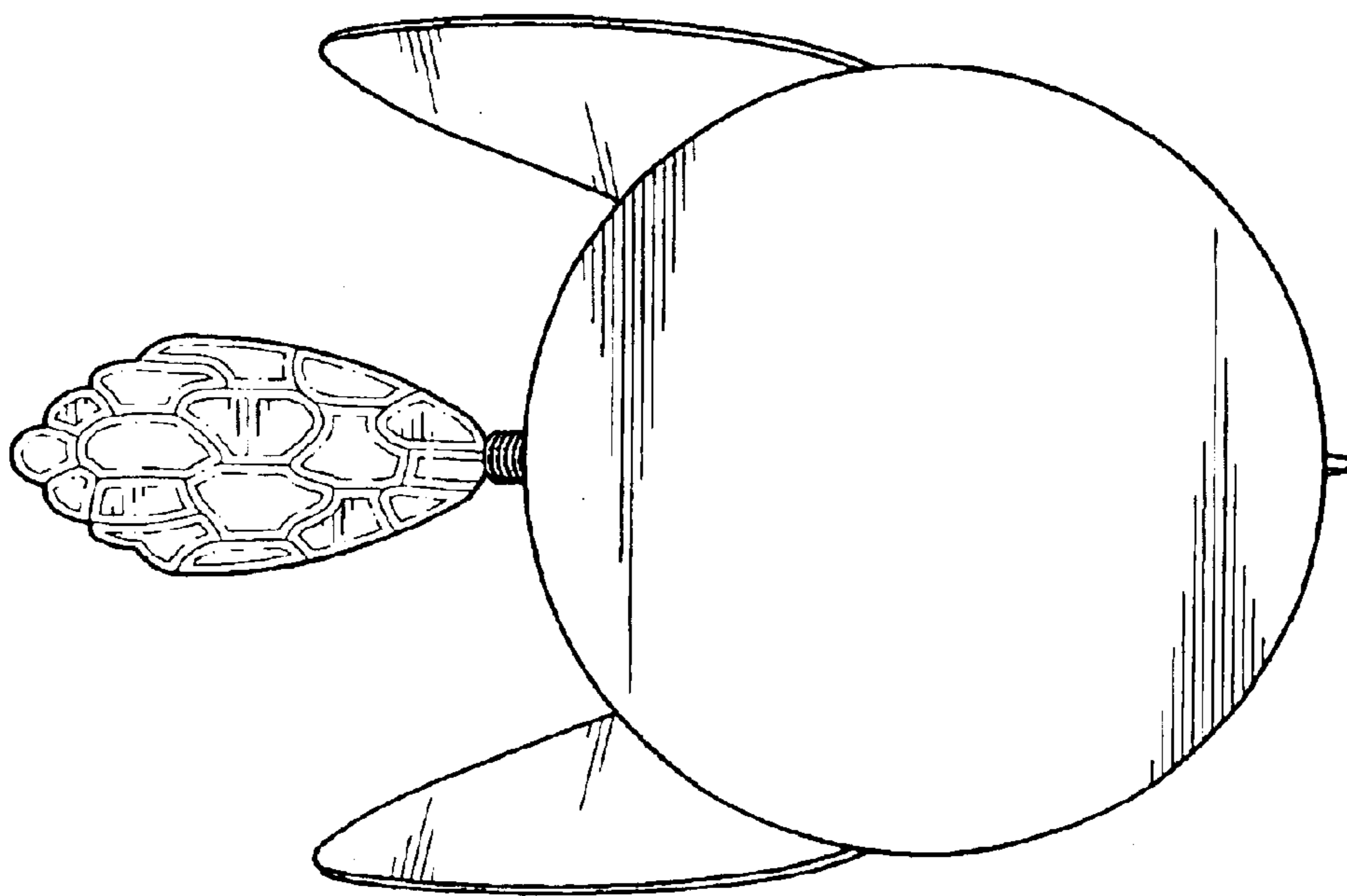

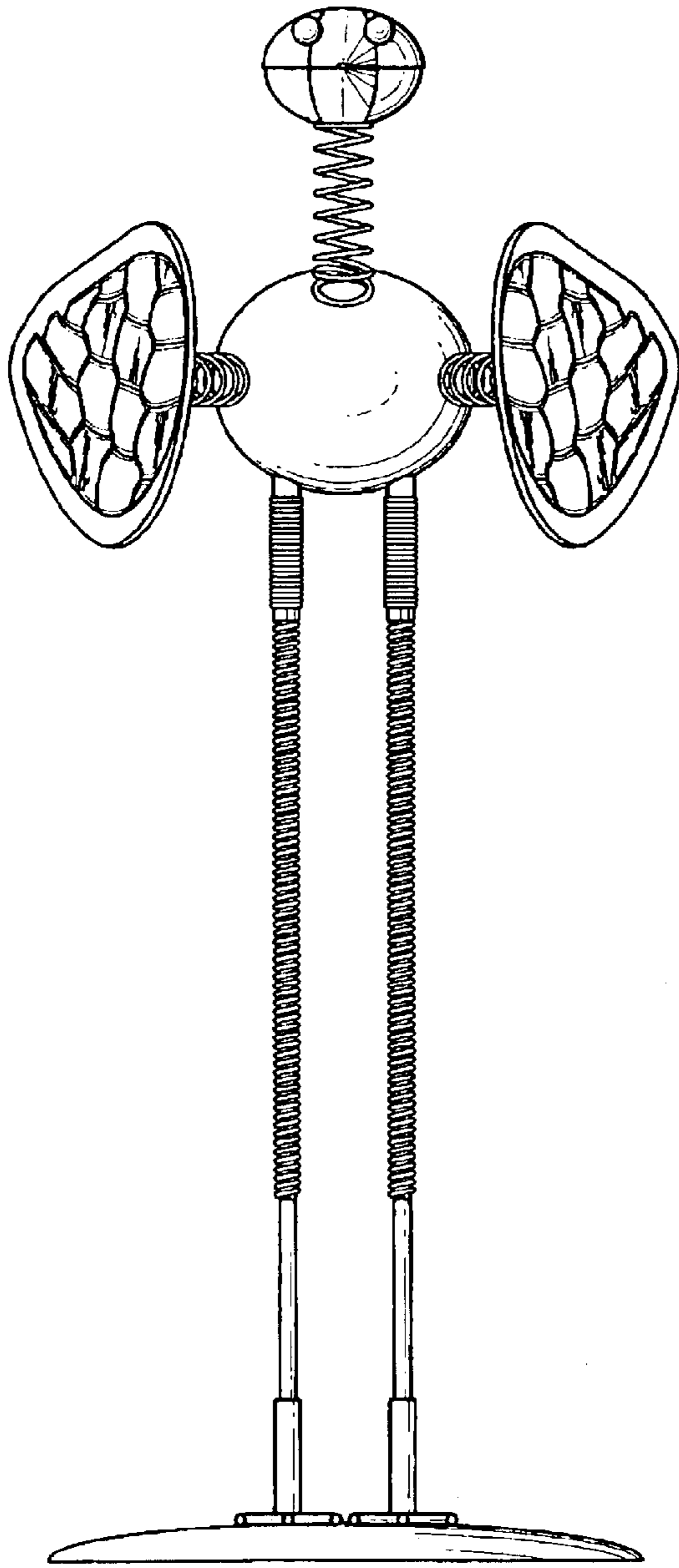

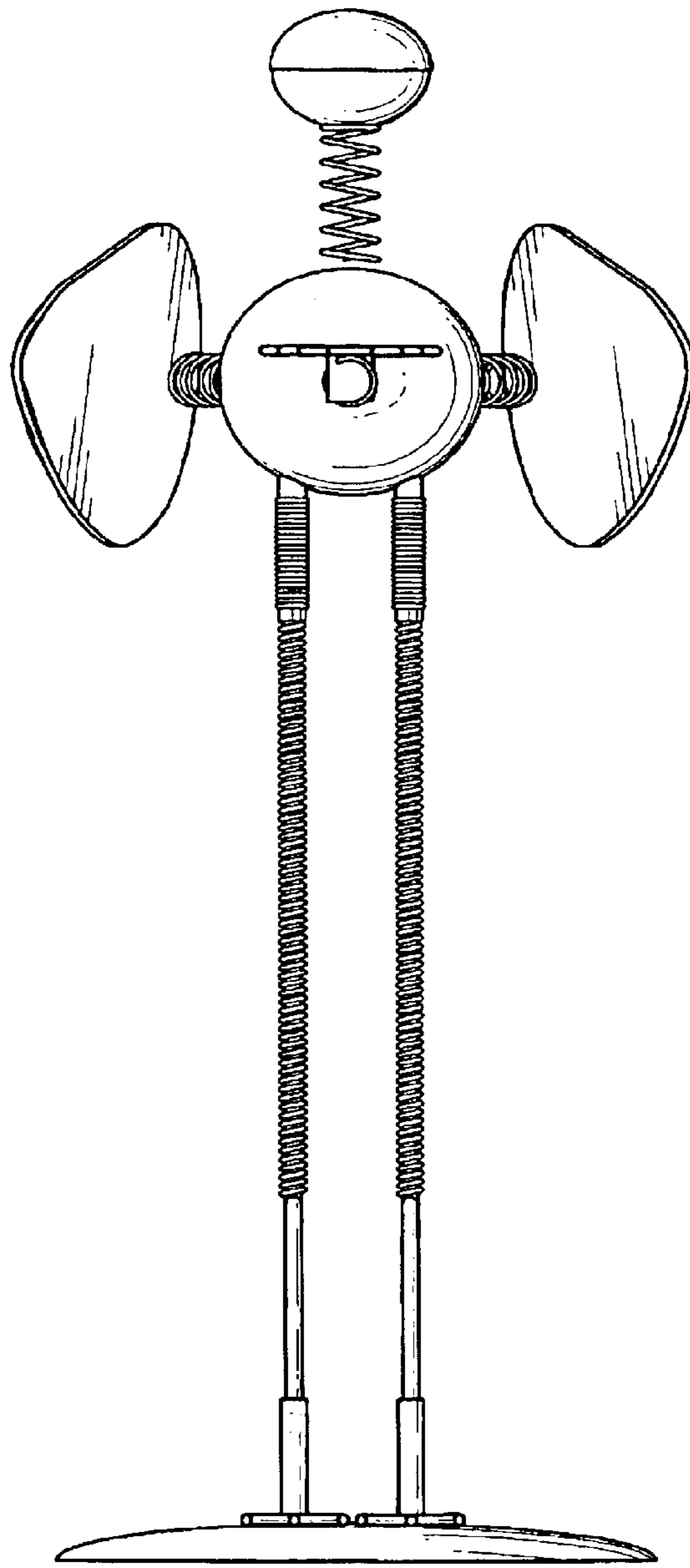
