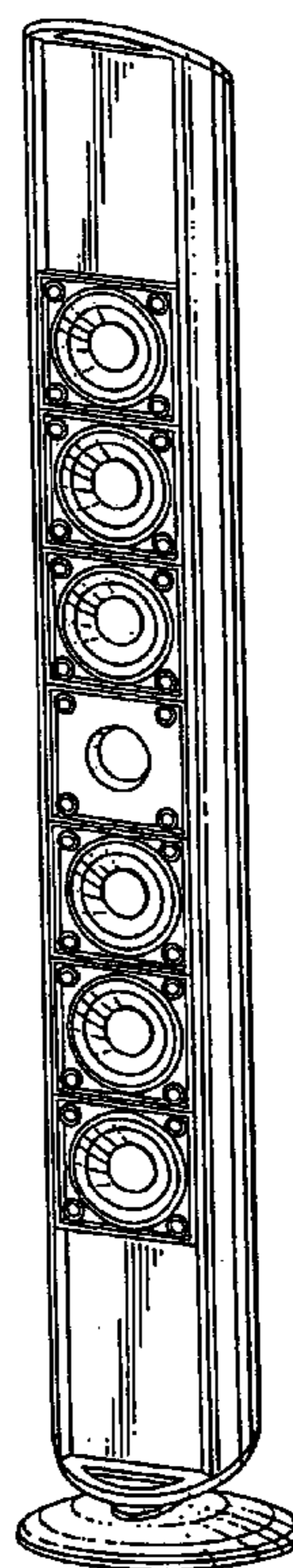
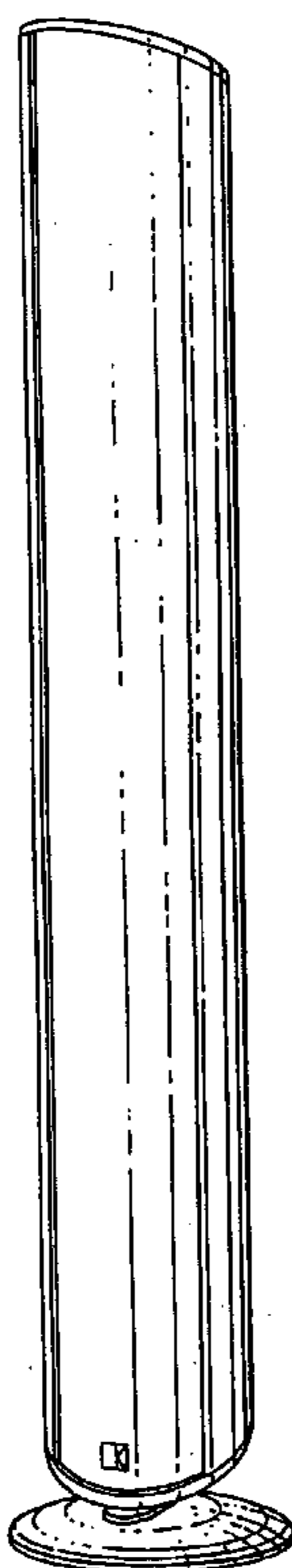
(57) **CLAIM**

I claim the ornamental design for a loudspeaker, substan-  
tially as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the loudspeaker of the preferred  
embodiment of the present invention; and  
FIG. 2 is a rear view of the loudspeaker of the preferred  
embodiment of the present invention;  
FIG. 3 is a side view of the loudspeaker of the preferred

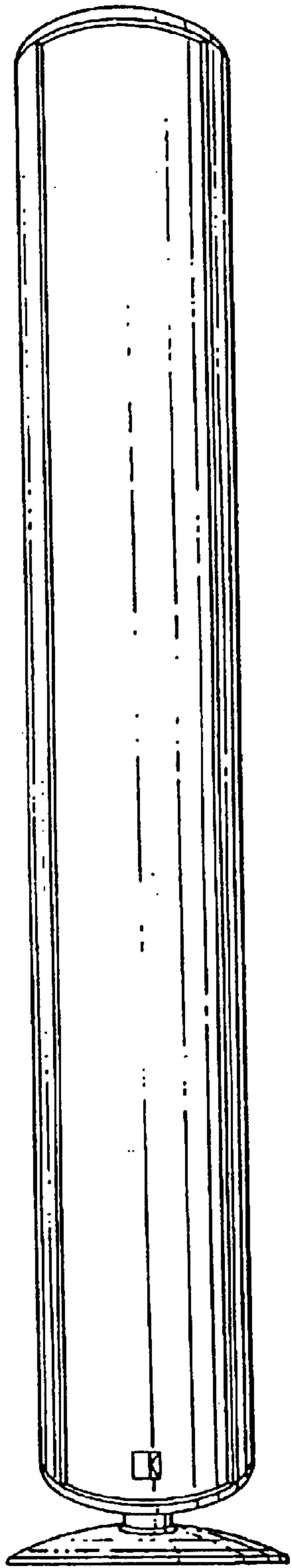

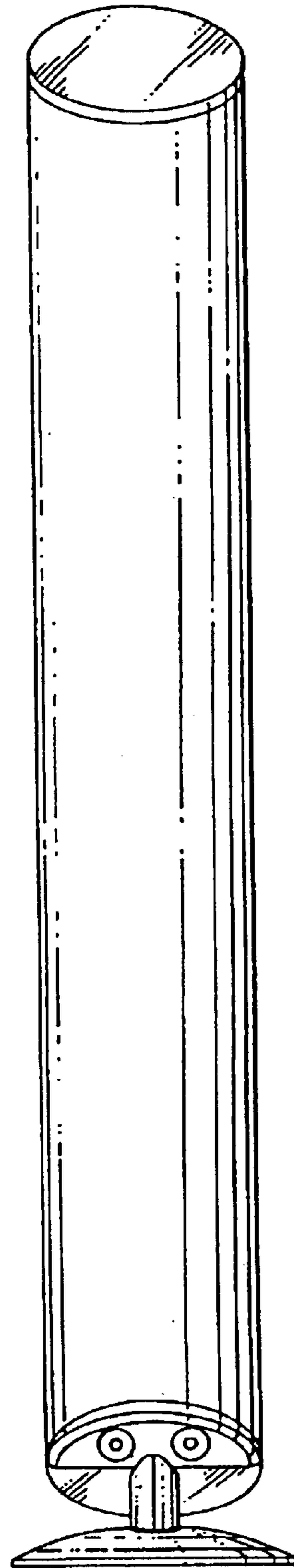

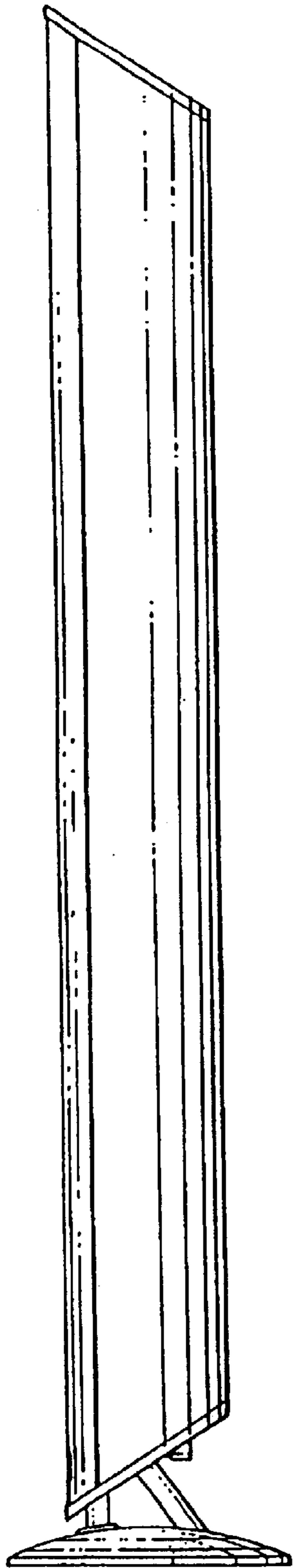

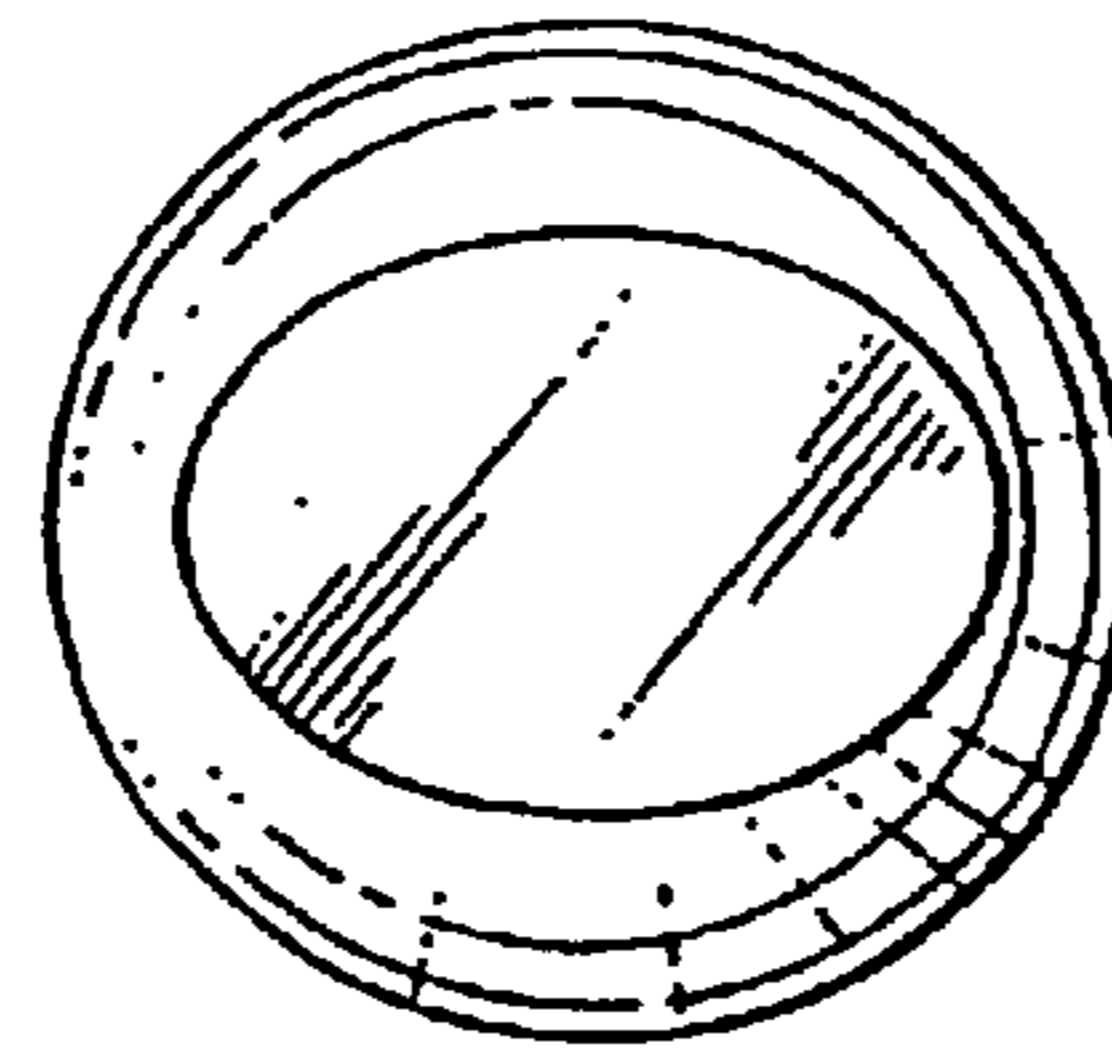

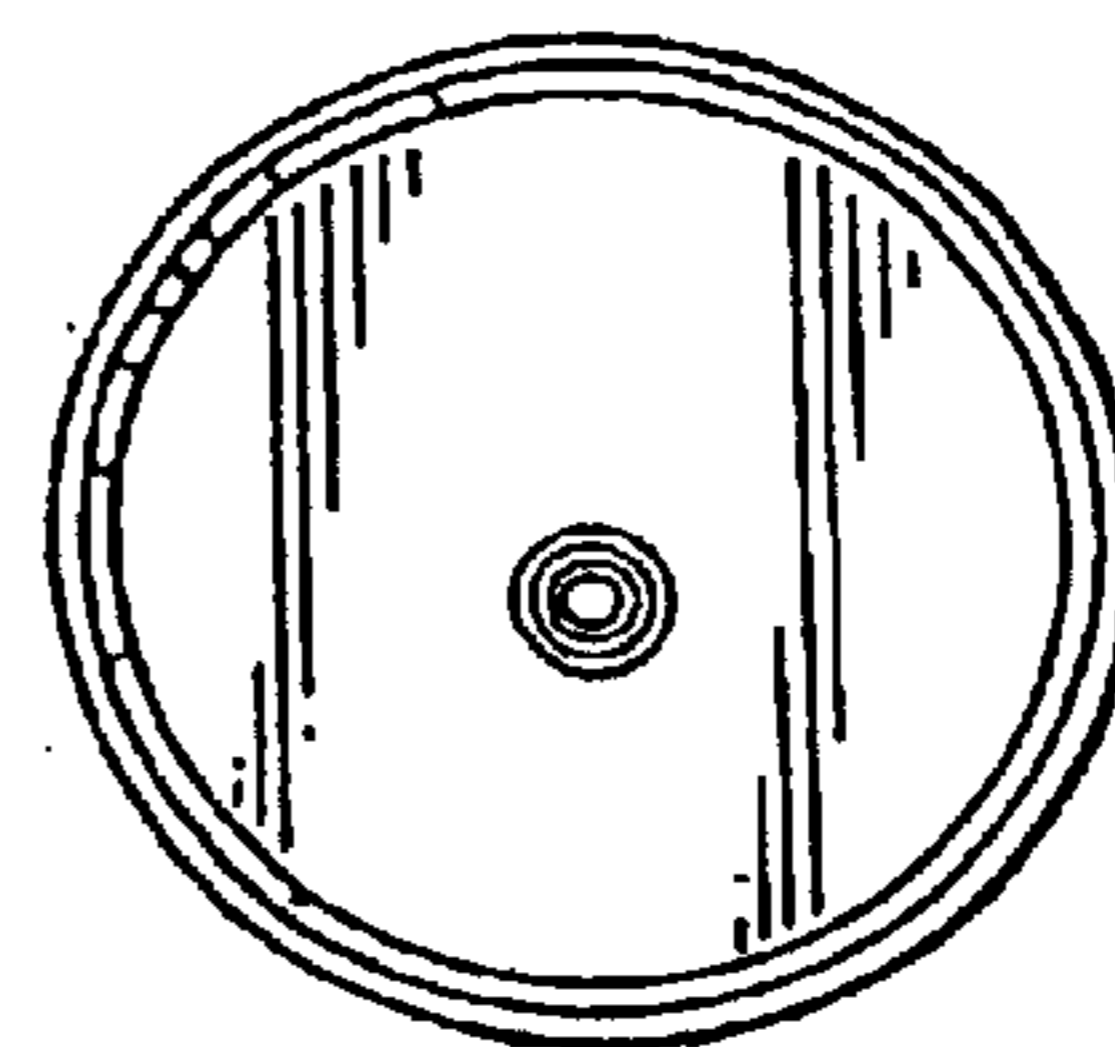

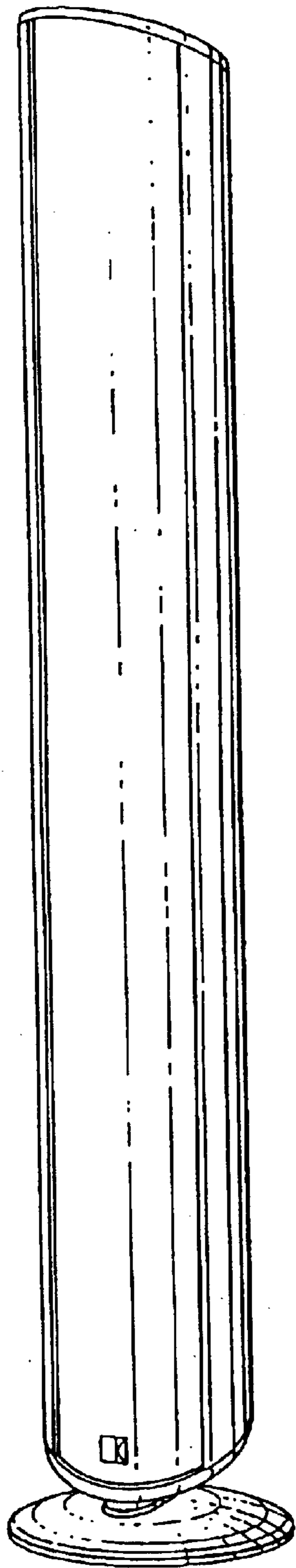

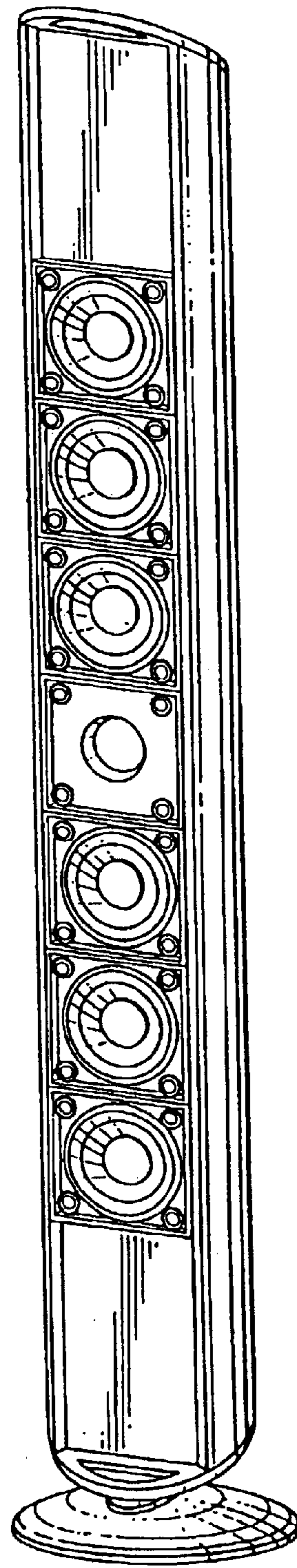
