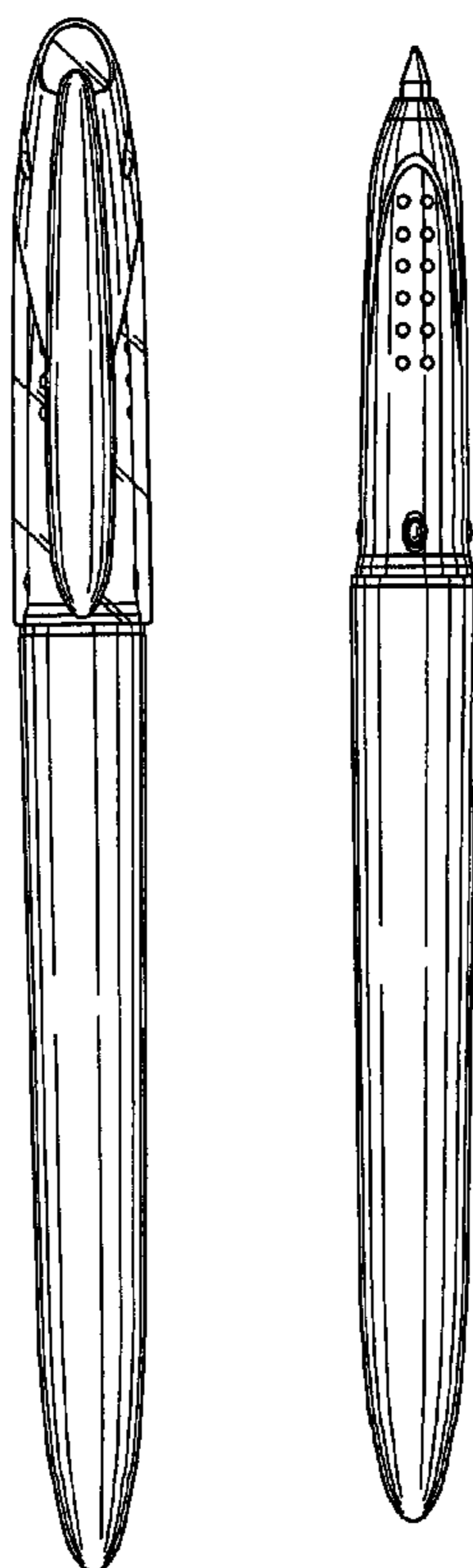
(57) **CLAIM**

The ornamental design for a ball point pen, as shown and described.

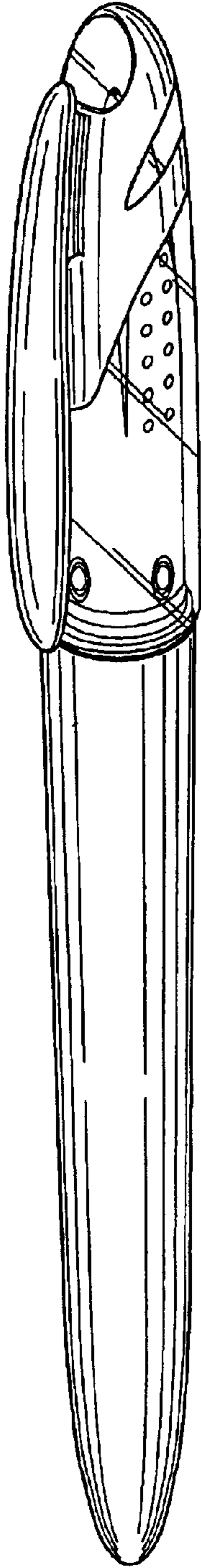
**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and right side of a ball point pen showing my new design;

 FIG. 14 is a cross sectional view of 14—14 as showing in FIG. 8.

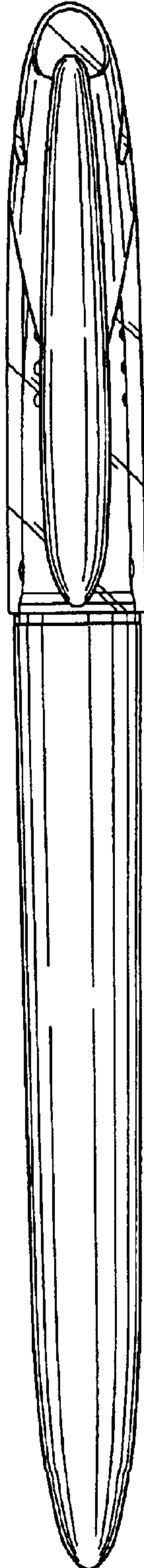

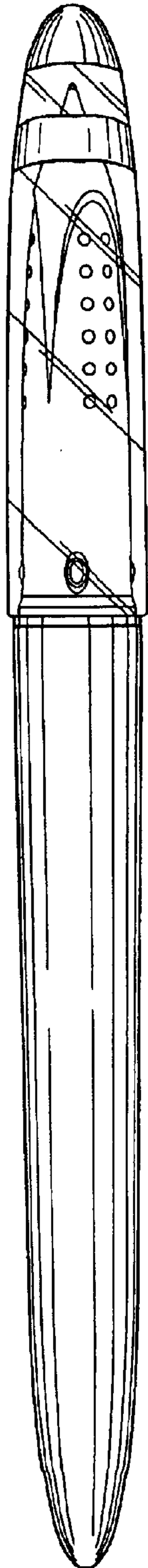

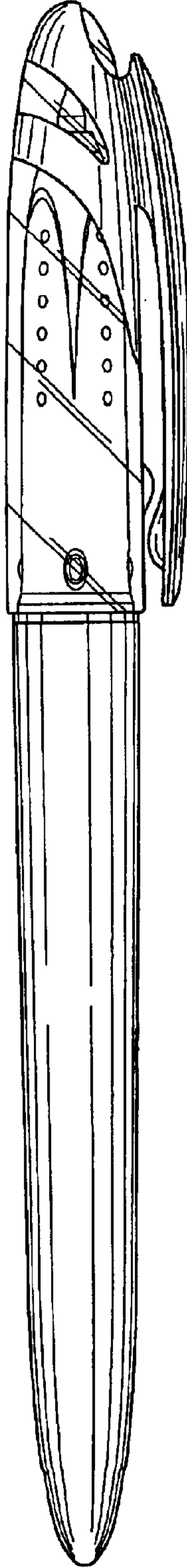

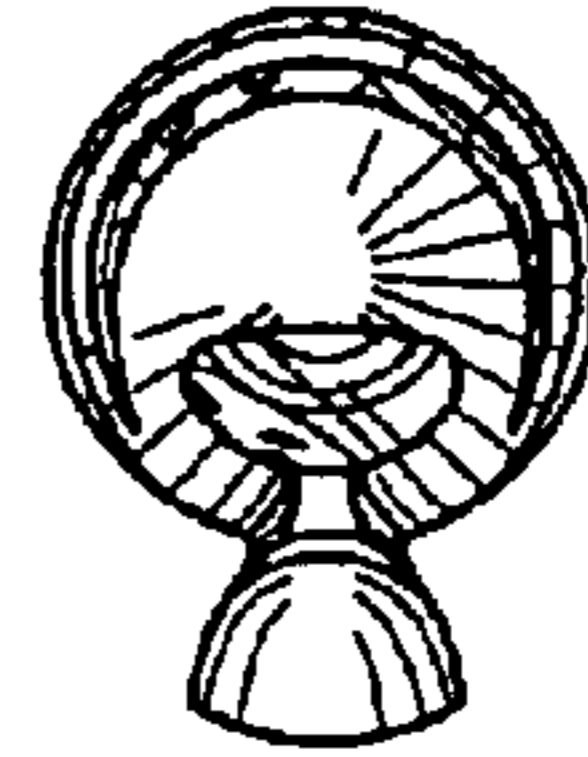

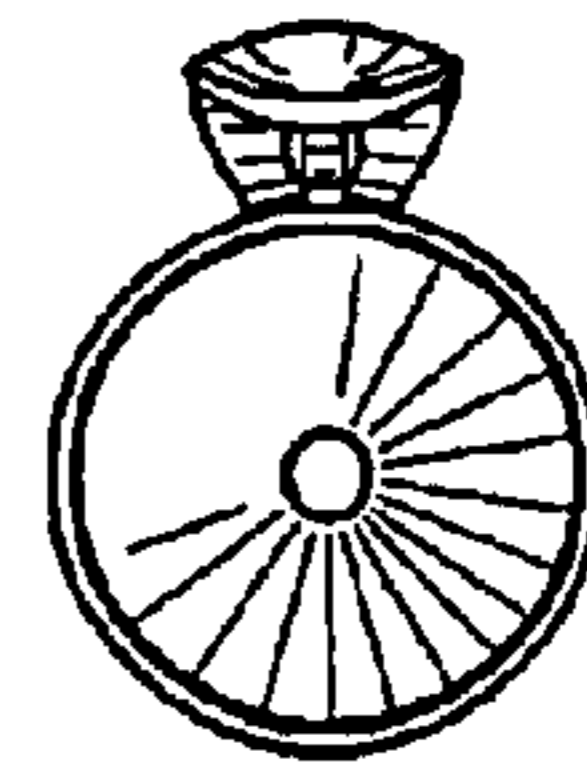

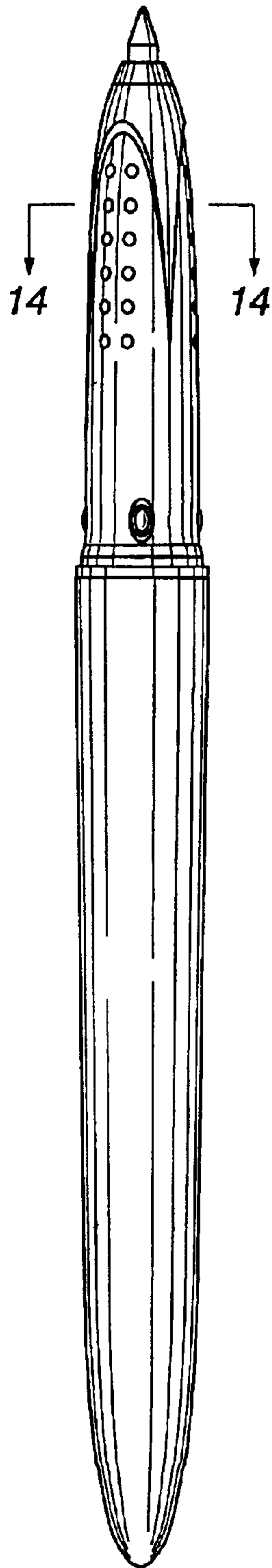

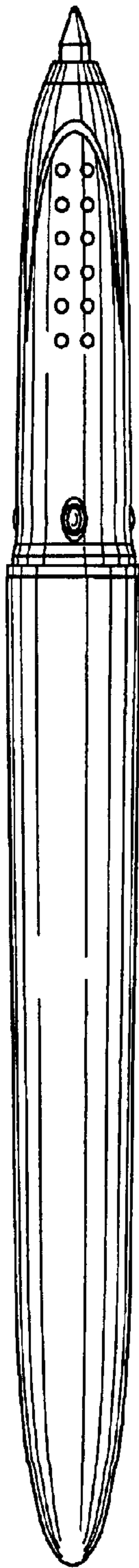

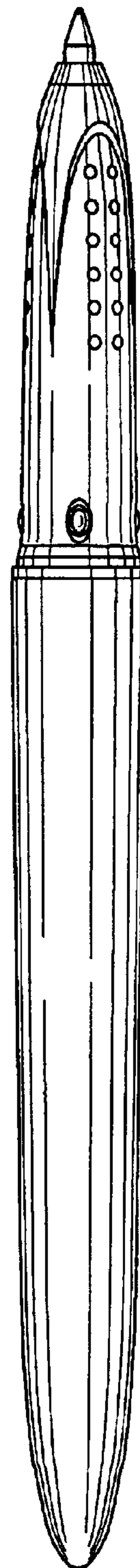

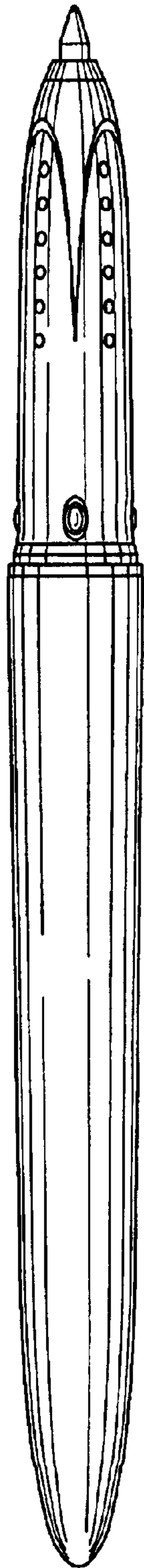

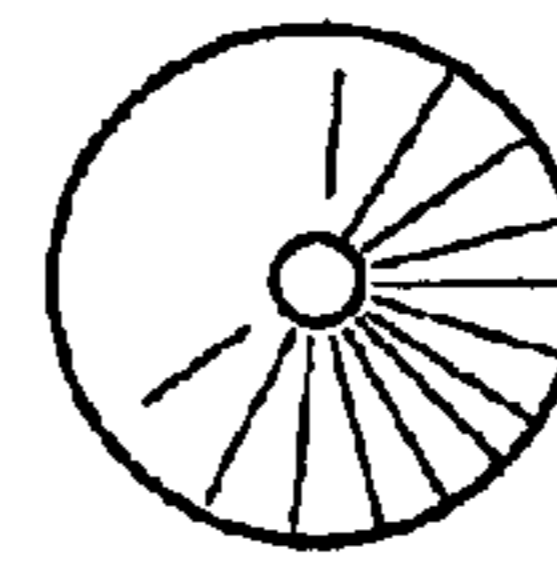
