(57) **CLAIM**

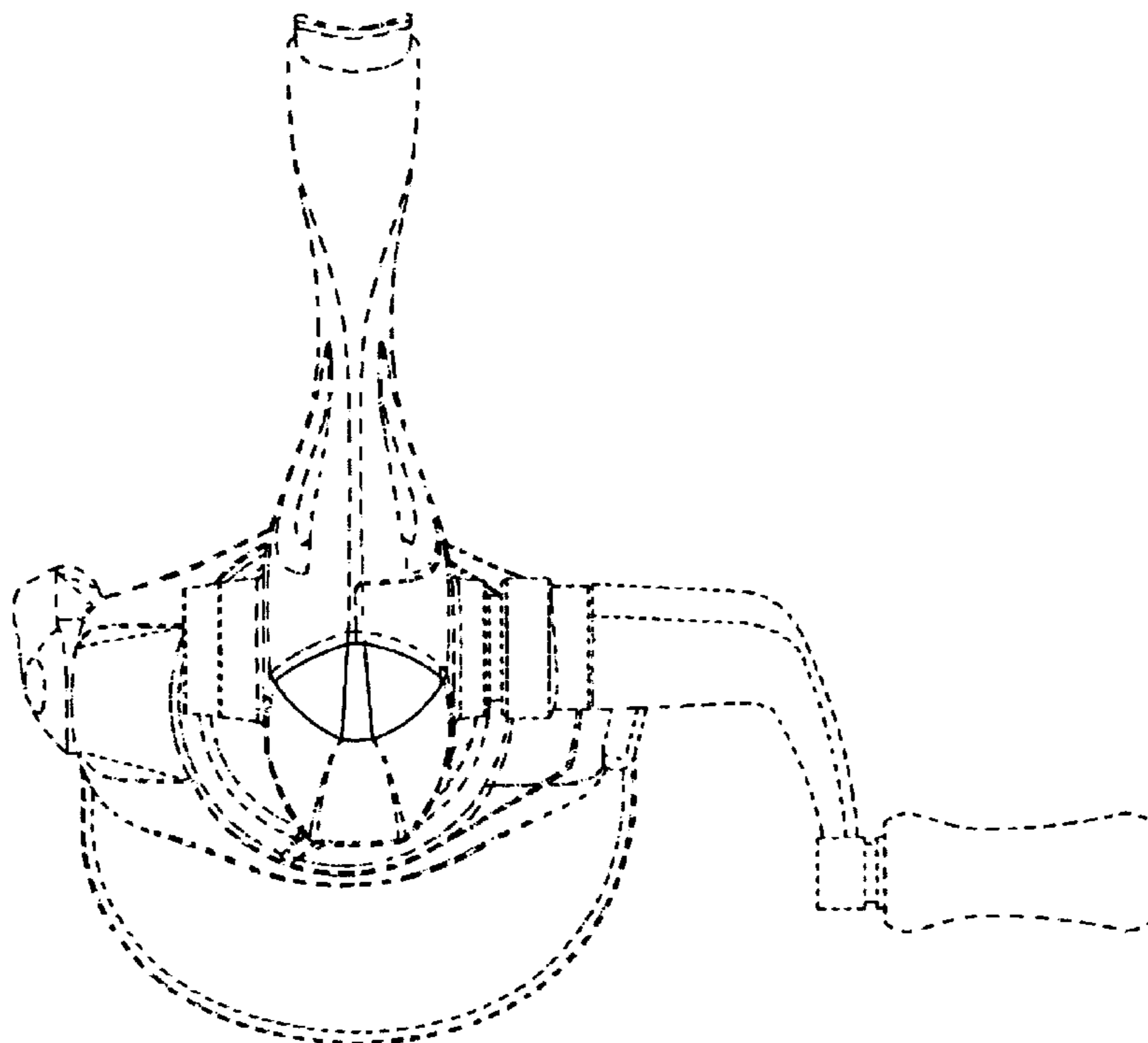
The ornamental design for a fishing reel, as shown and described.

DESCRIPTION

FIG. 1 is a front side view of a fishing reel in accordance with my new design;
 FIG. 2 is a rear side view of the fishing reel in accordance with my new design;
 FIG. 3 is a top plan view of the fishing reel in accordance with my new design;
 FIG. 4 is a bottom plan view of the fishing reel in accordance with my new design;
 FIG. 5 is a left side view of the fishing reel in accordance with my new design;
 FIG. 6 is a right side view of the fishing reel in accordance with my new design;
 FIG. 7 is a top-front side perspective view of the fishing reel in accordance with my new design; and,
 FIG. 8 is a bottom-rear side perspective view of the fishing reel in accordance with my new design.

The broken line showing the environment (the remaining structure of the fishing reel) in the Figures is for illustrative purposes only and forms no part of the claimed design. More specifically, parts of the fishing reel other than the leg end portion are hereby disclaimed.

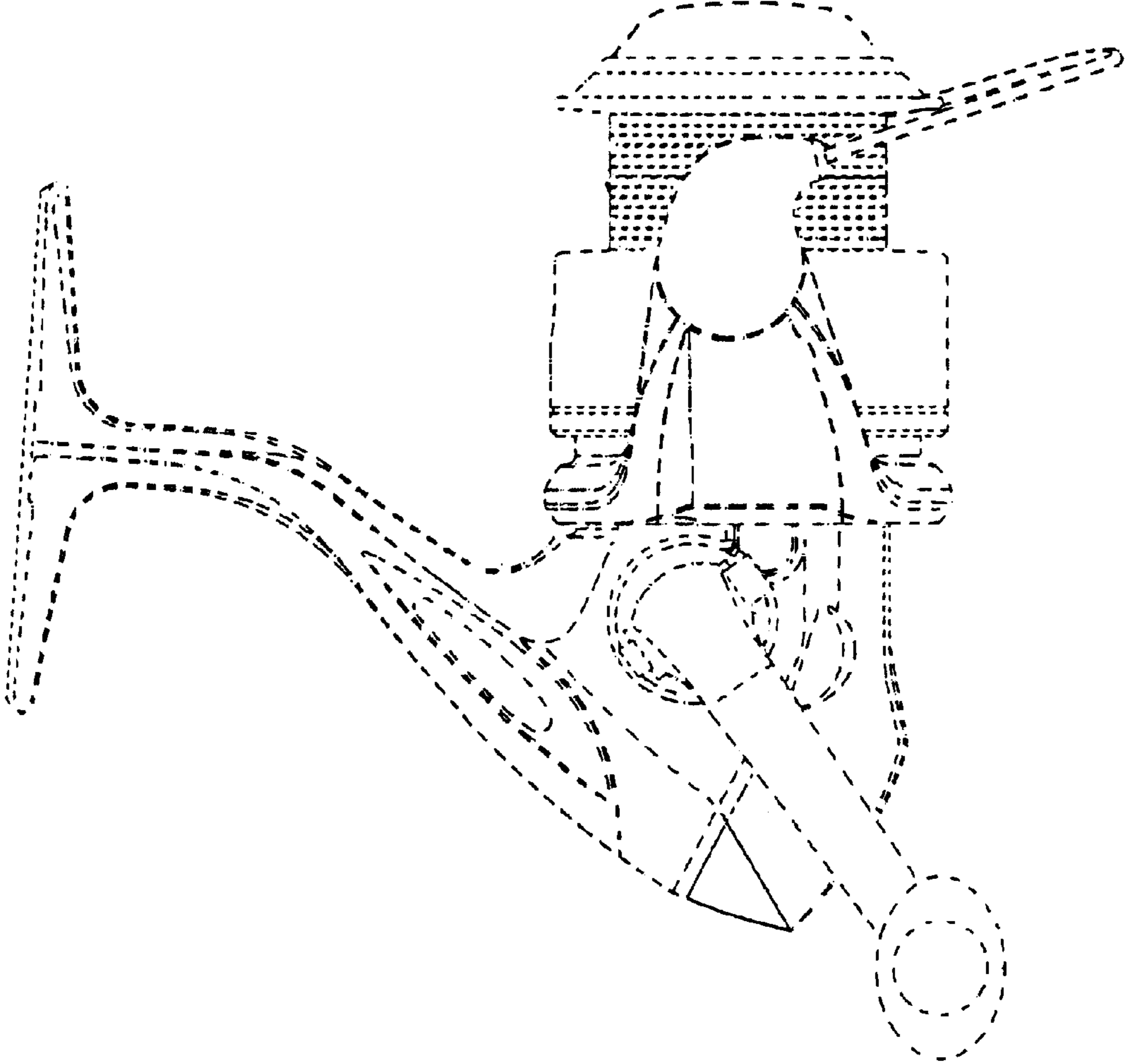

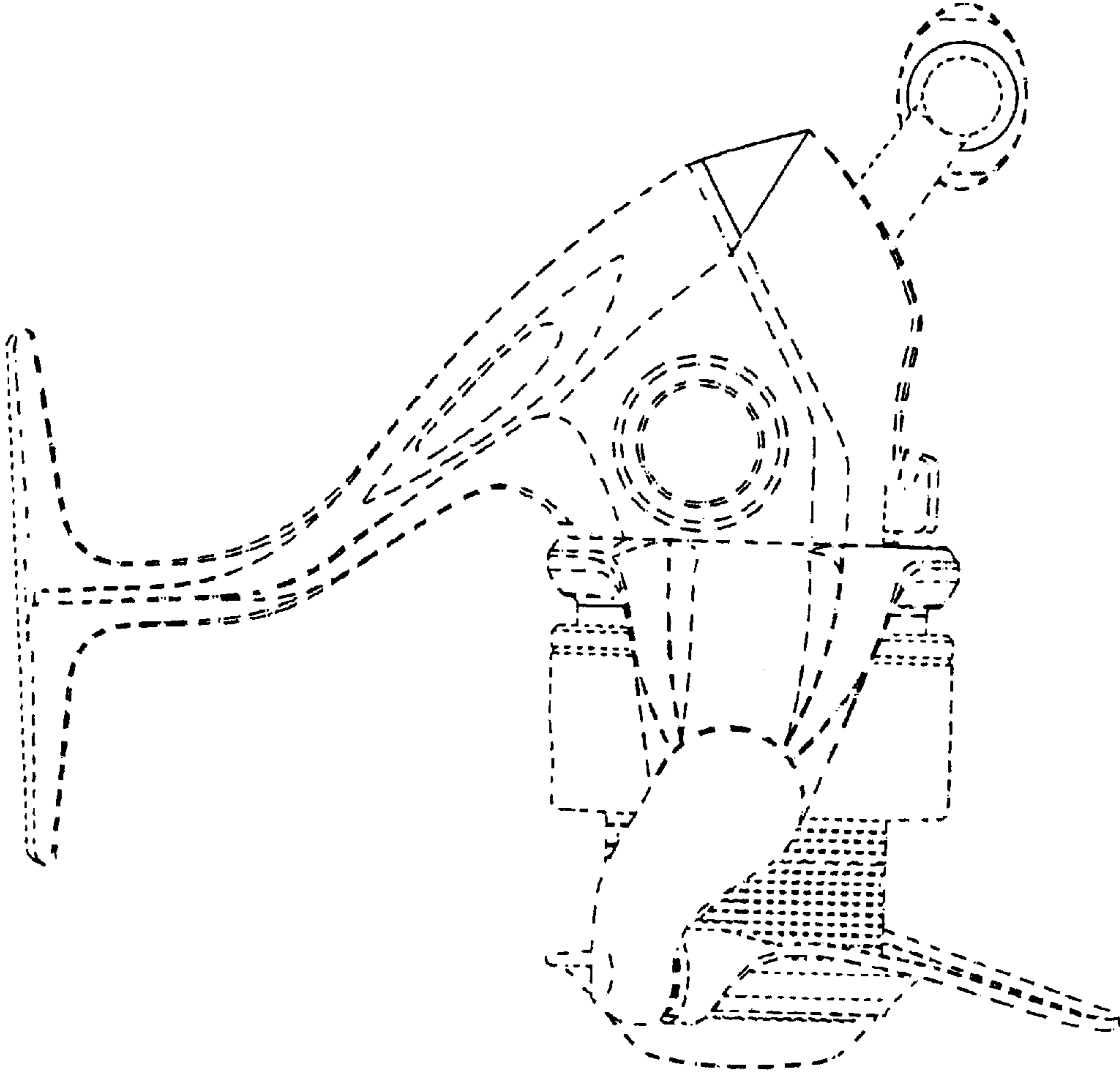
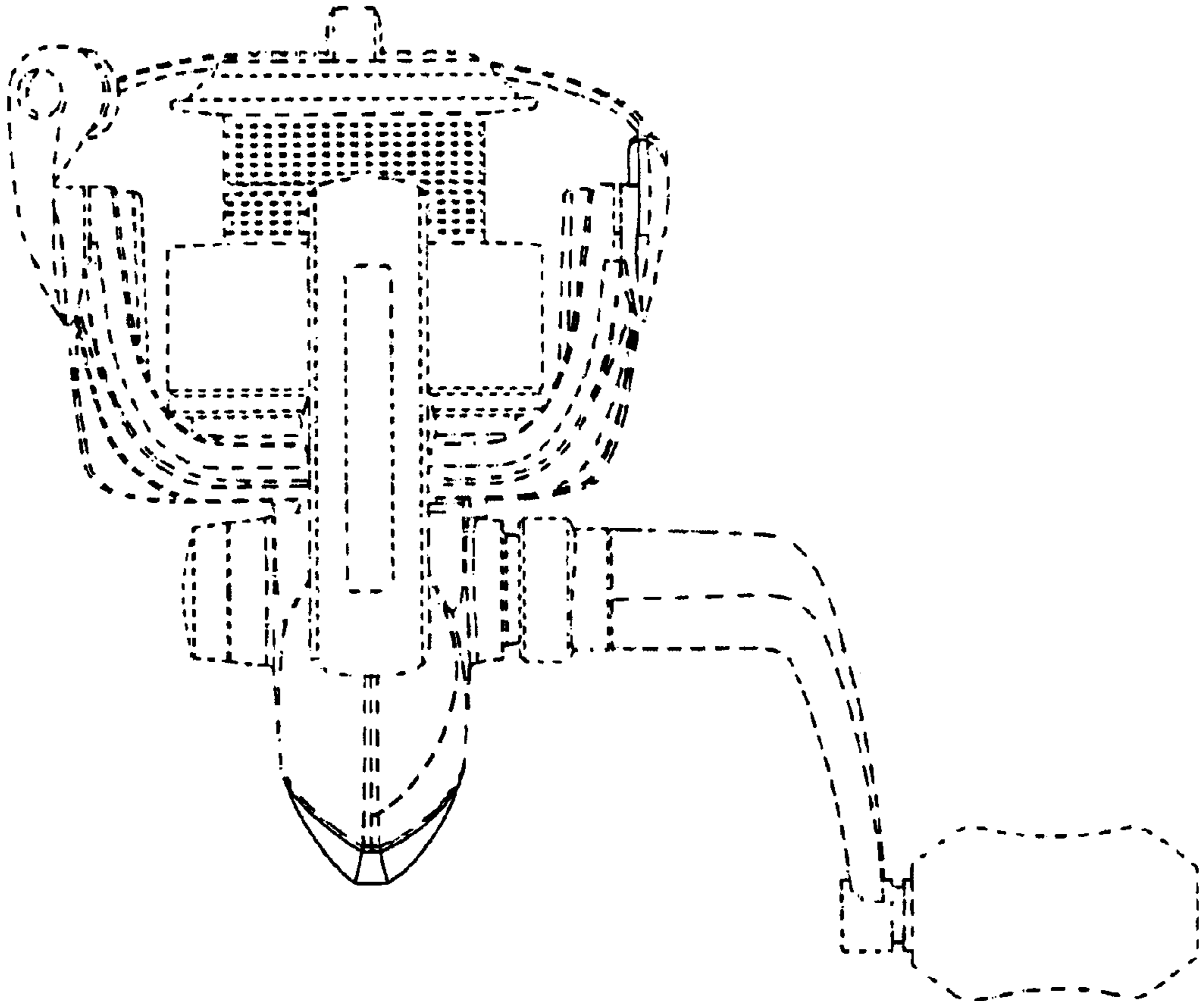

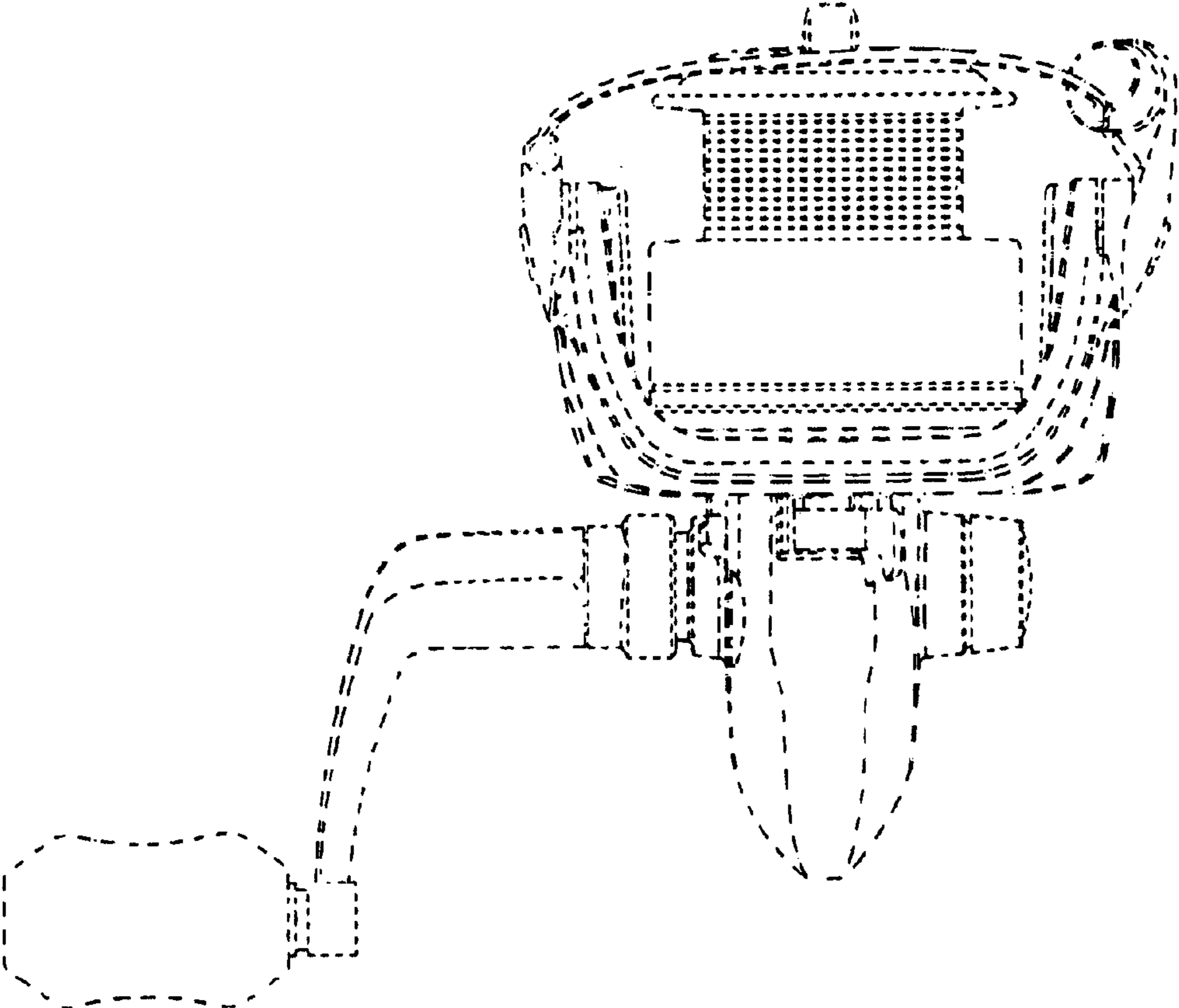
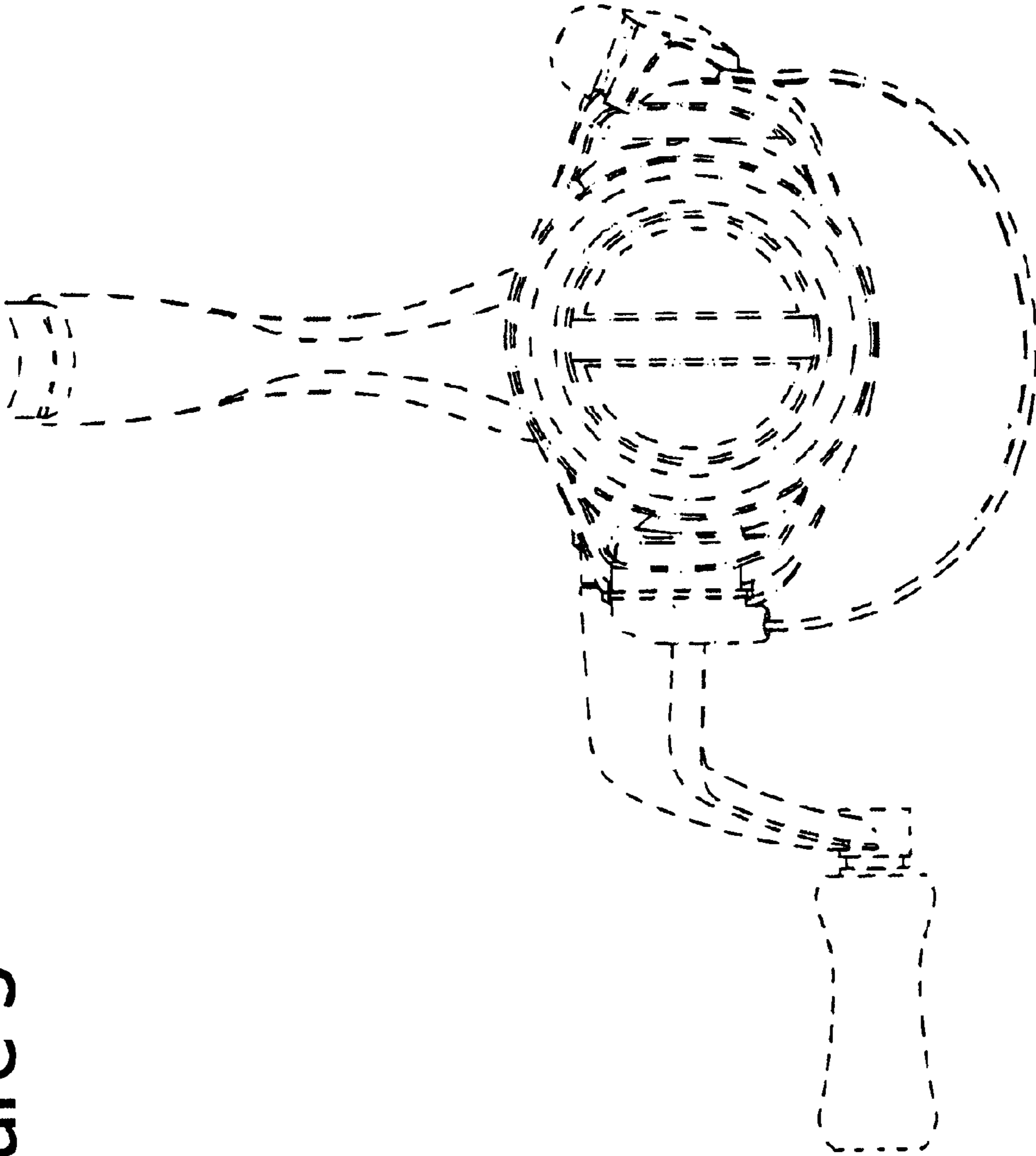

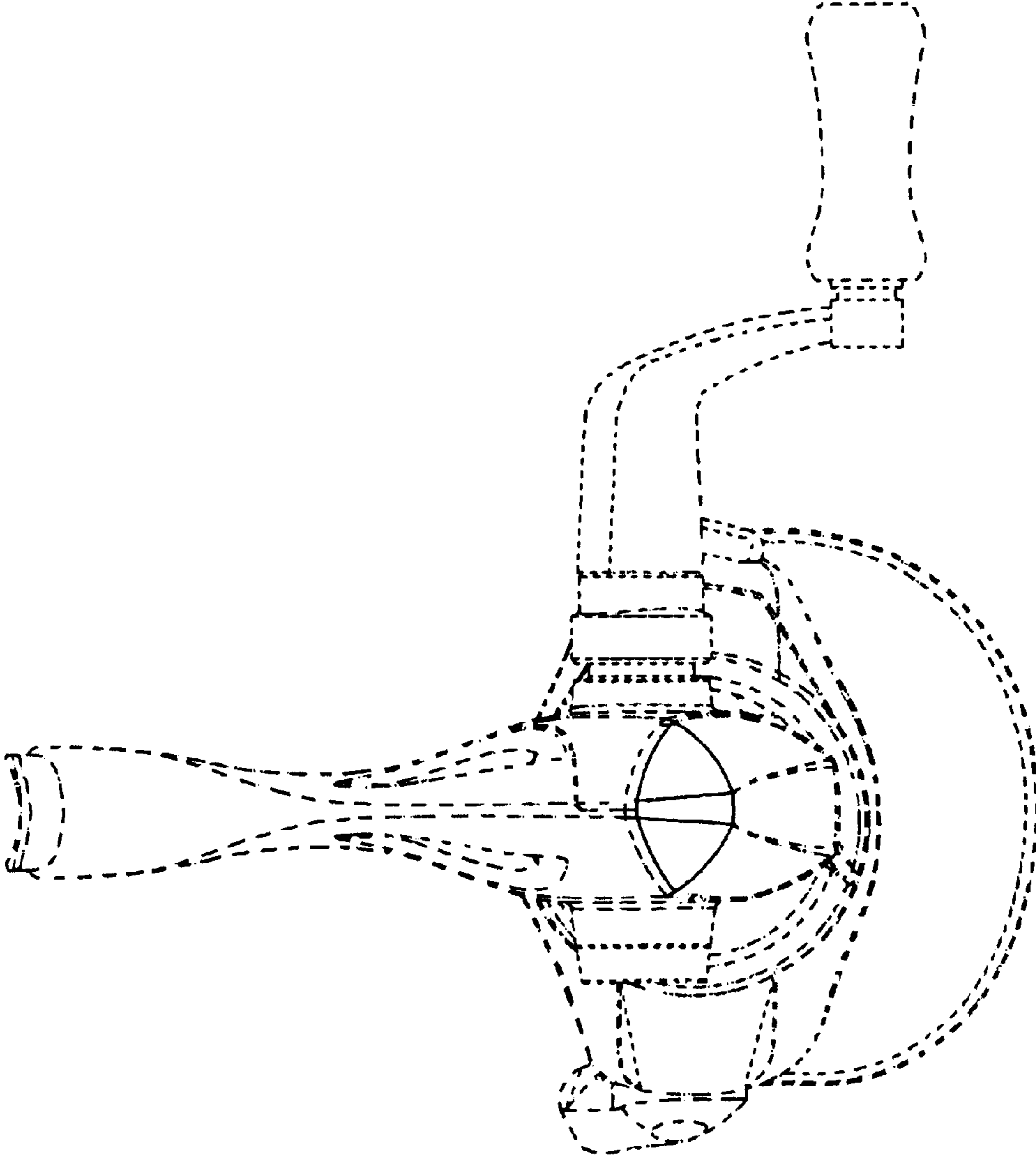

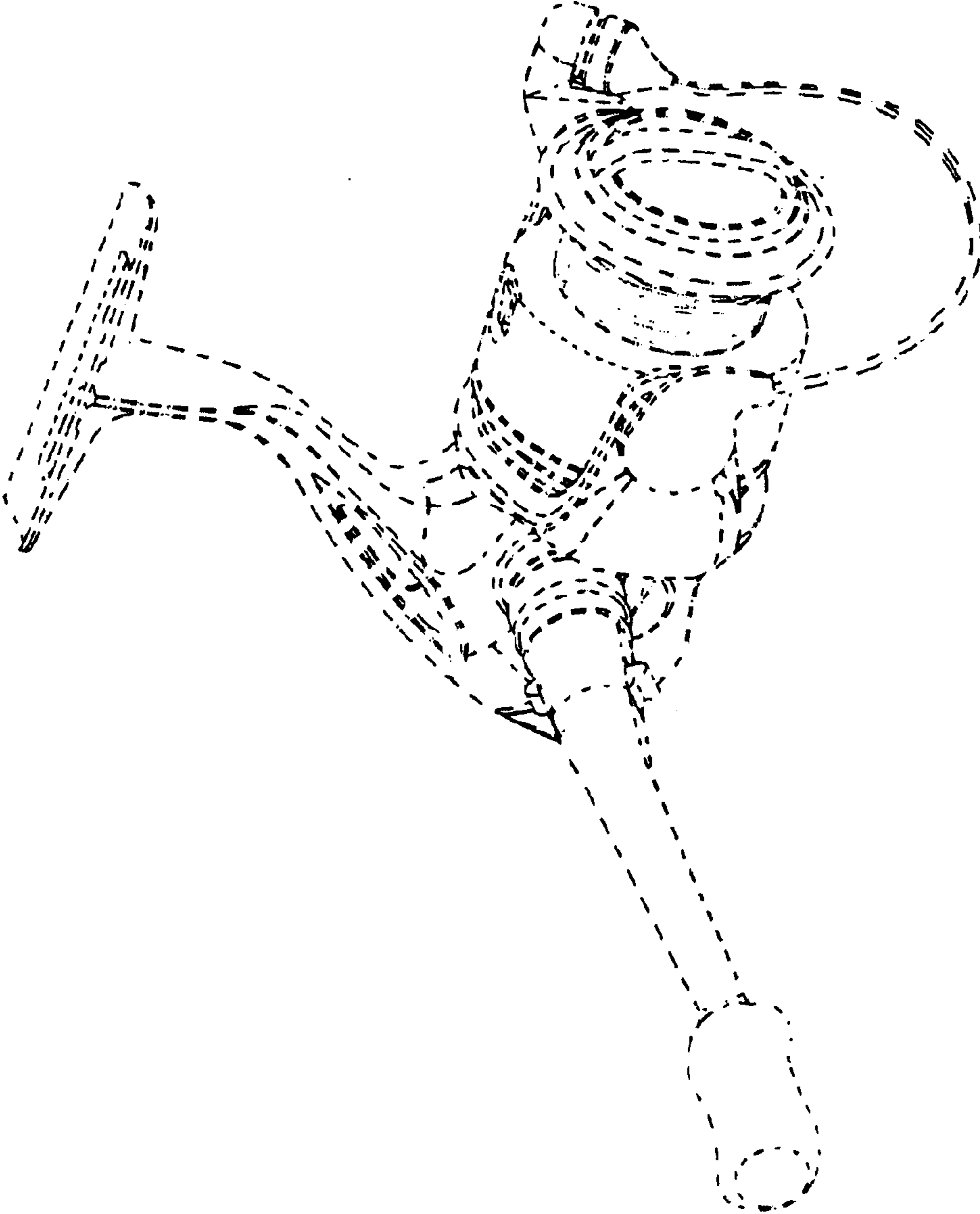

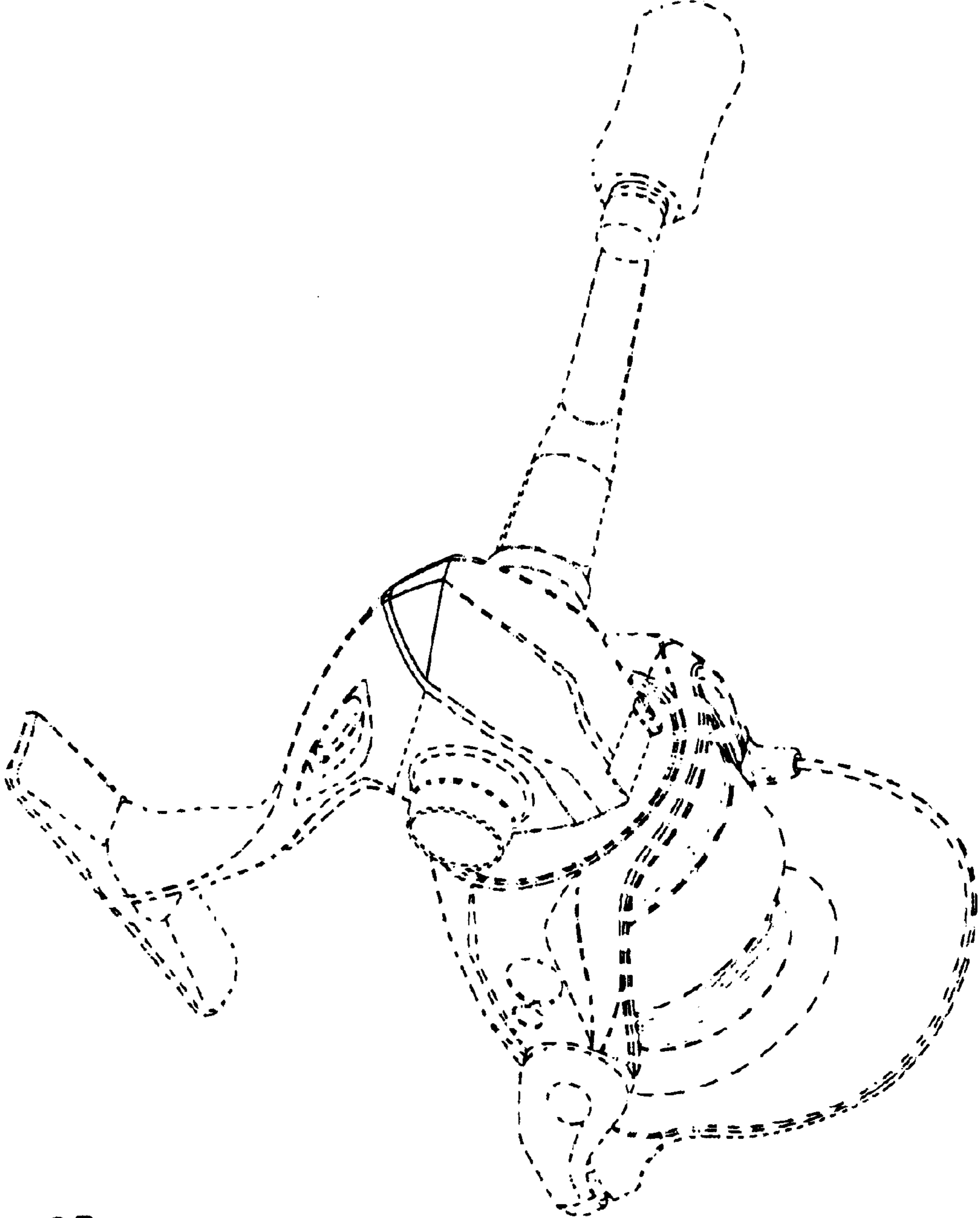
