(57) **CLAIM**

The ornamental design for a decorative light bulb, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view of a decorative light bulb, according to one preferred embodiment of this invention, with the broken line showing for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a front view of the decorative light bulb, as shown in FIG. 1;

FIG. 3 is a top view of the decorative light bulb, as shown in FIG. 1;

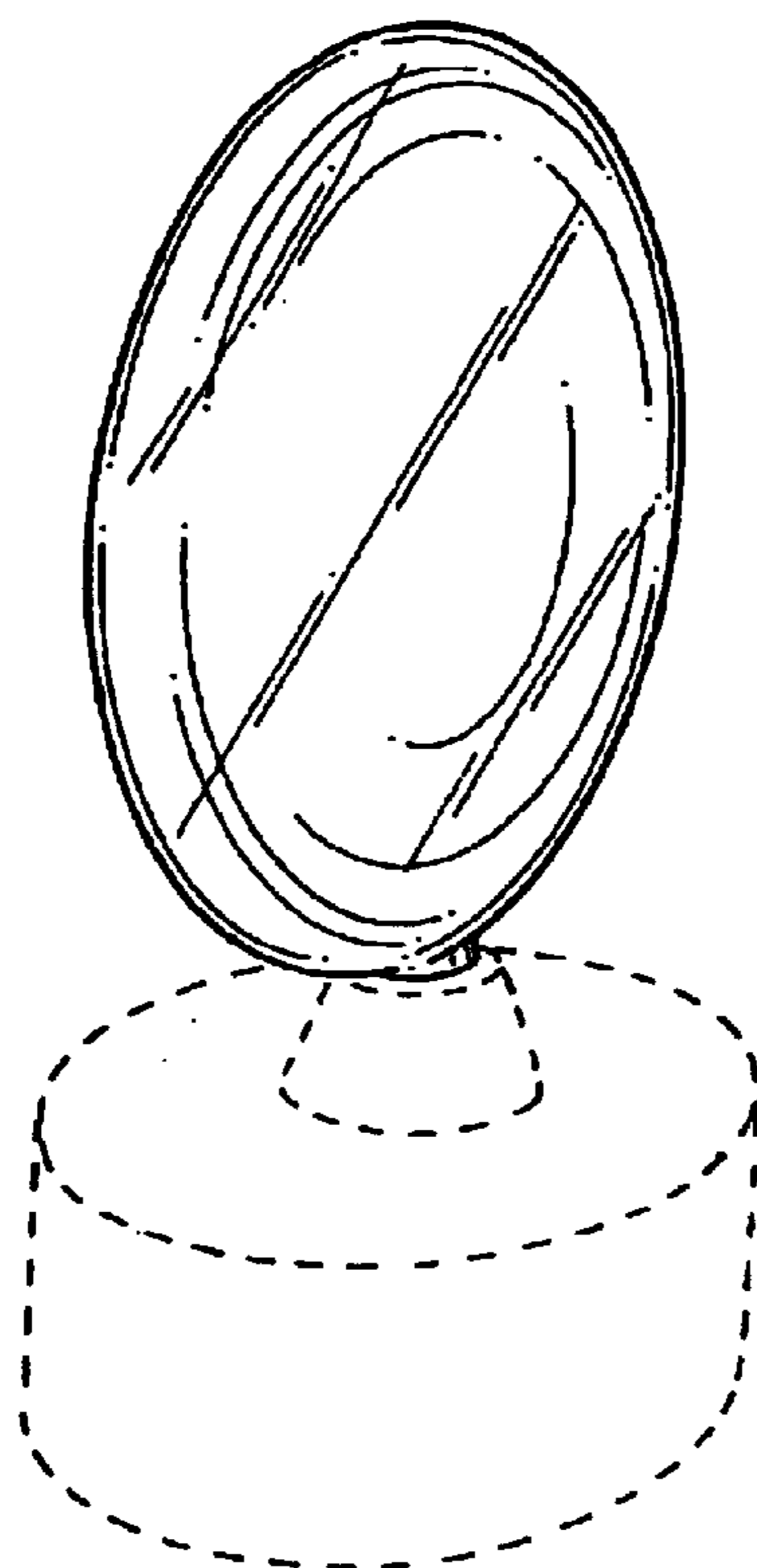
FIG. 4 is a bottom view of the decorative light bulb, as shown in FIG. 1;

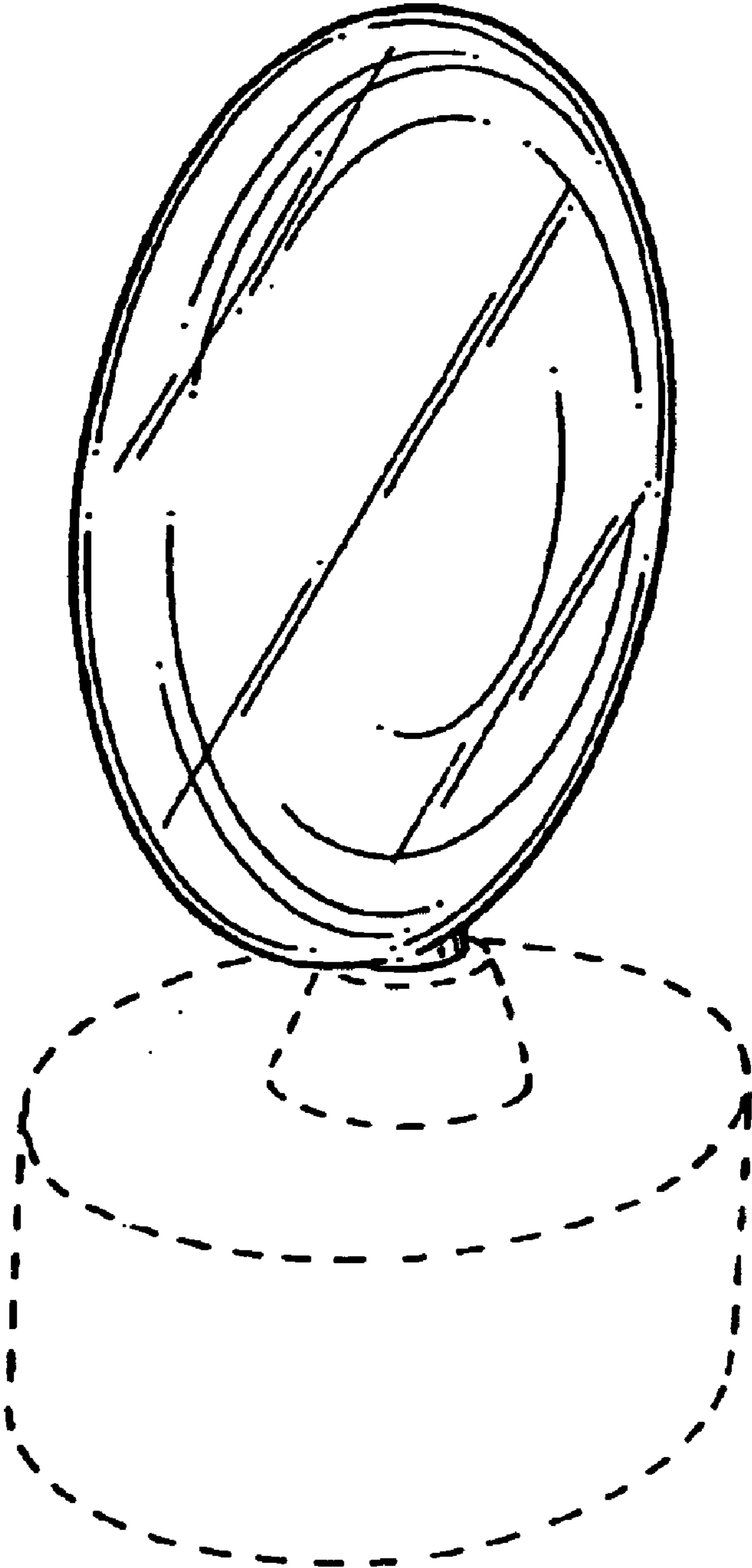

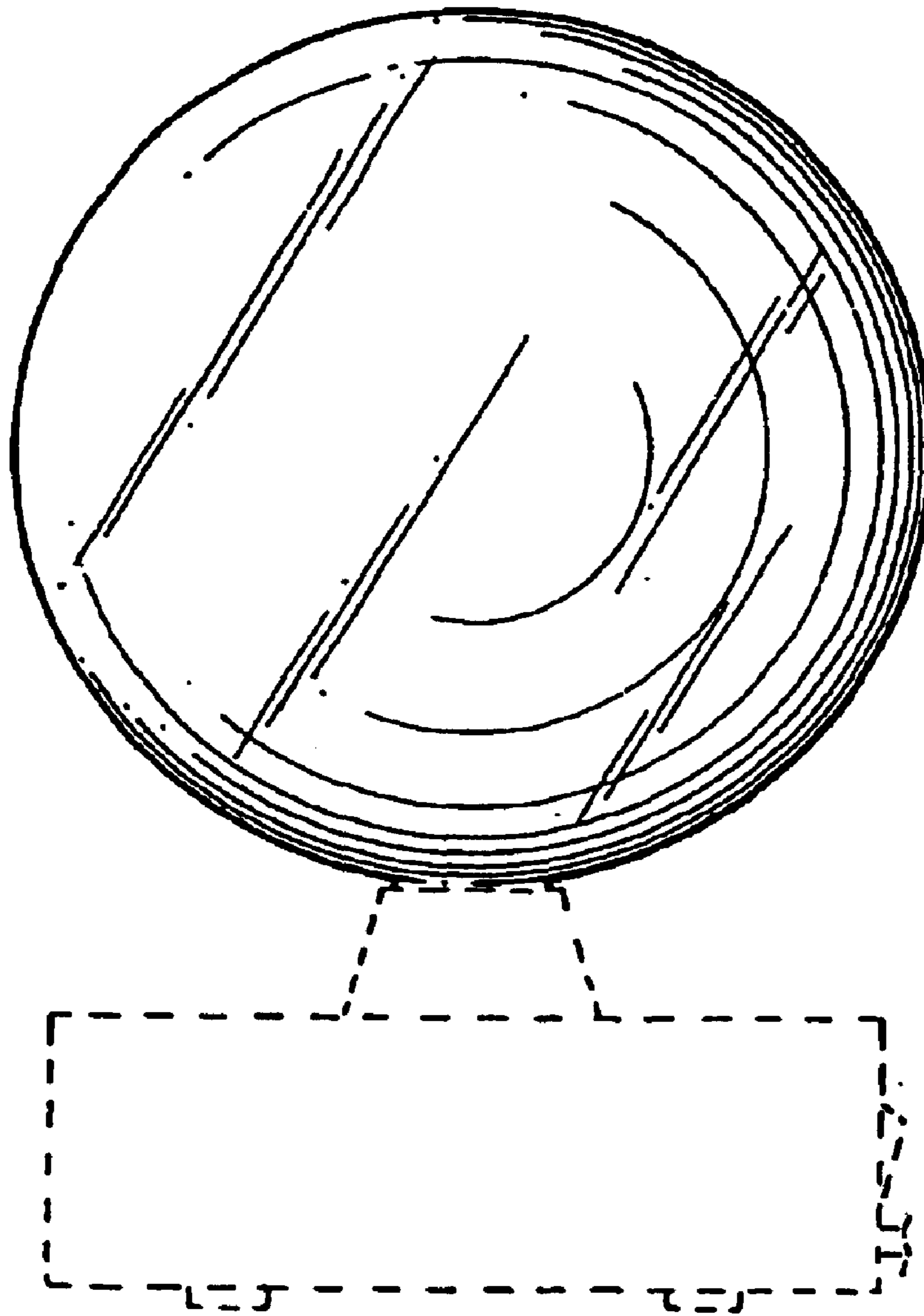

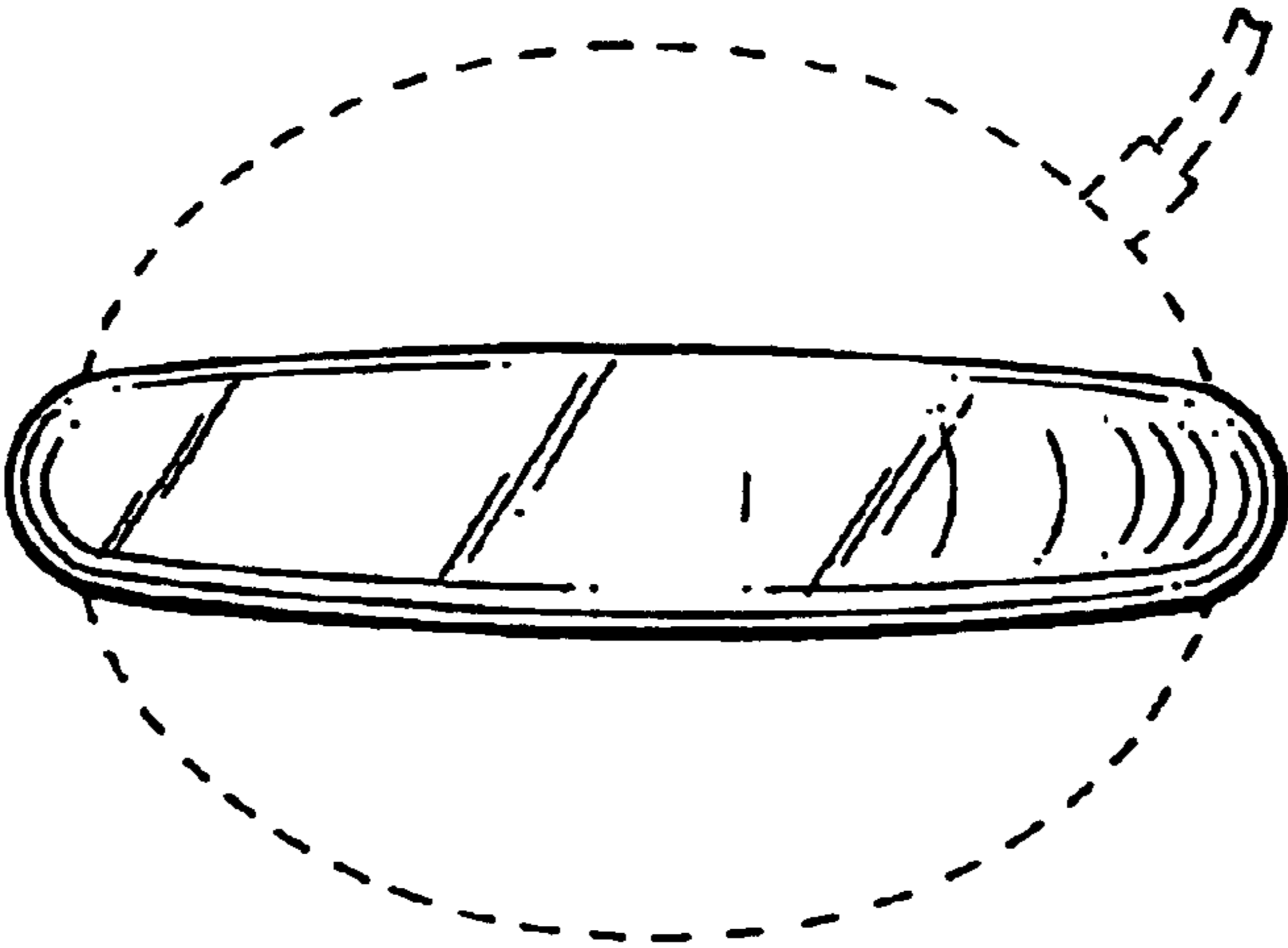

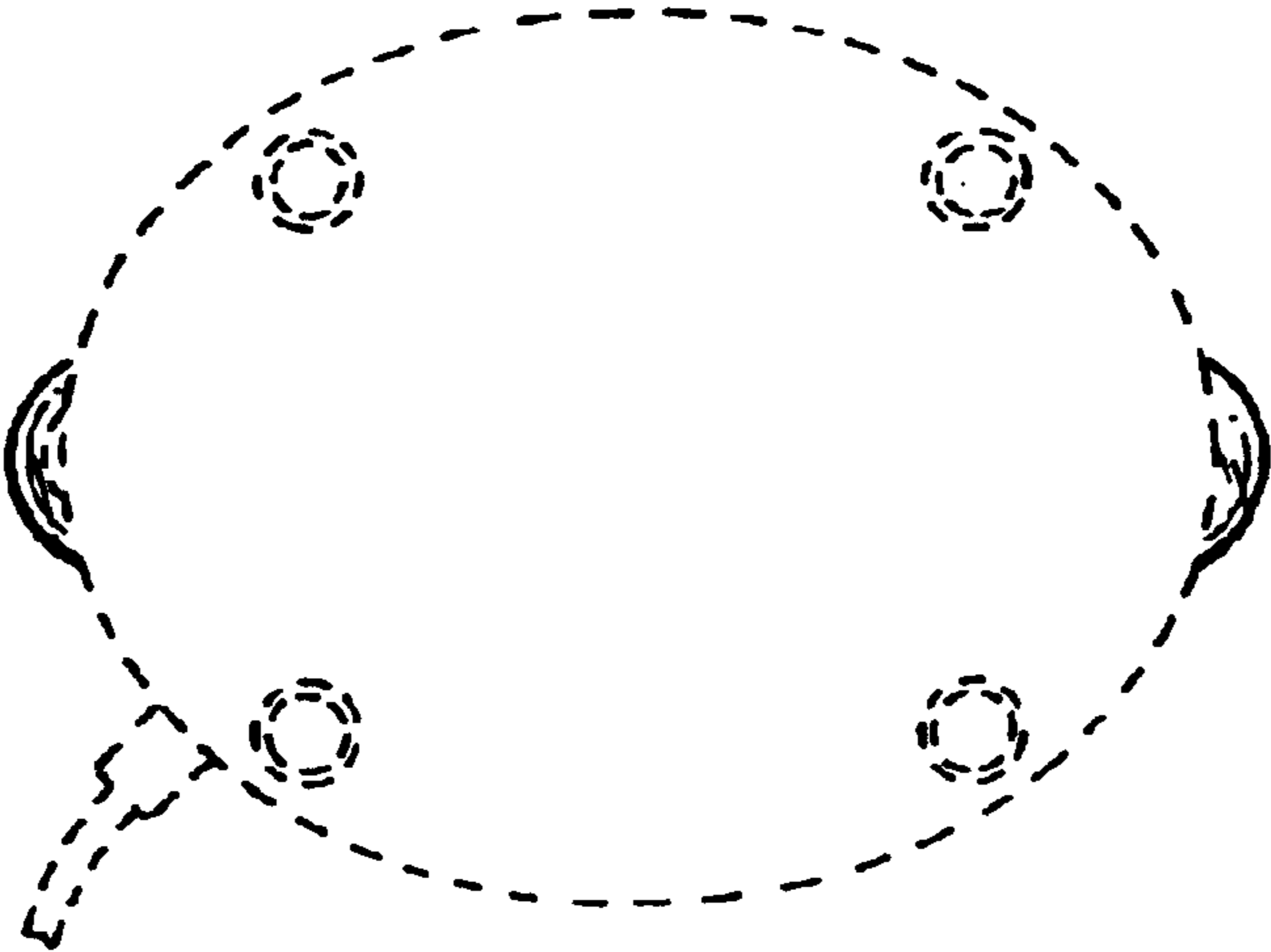

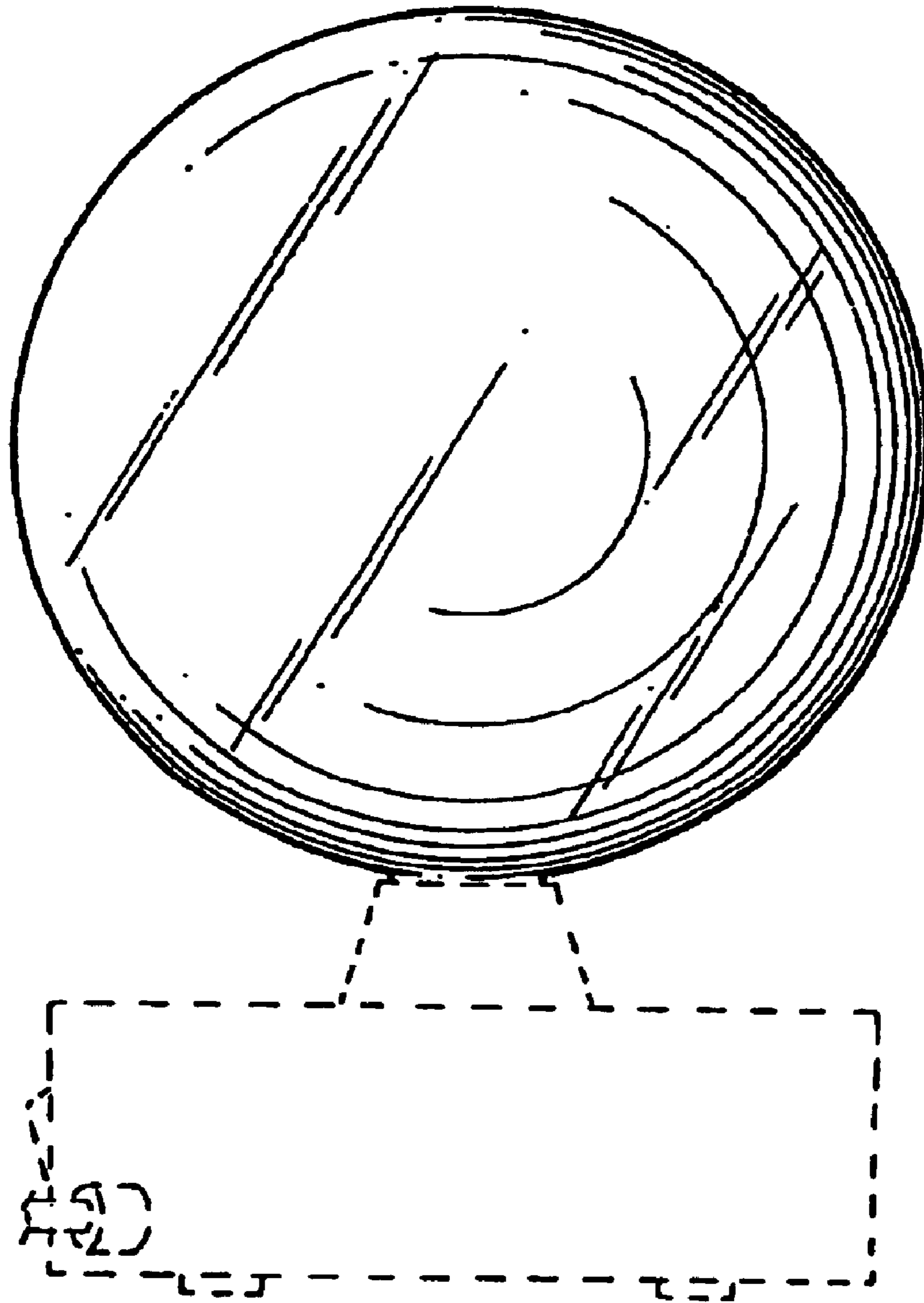

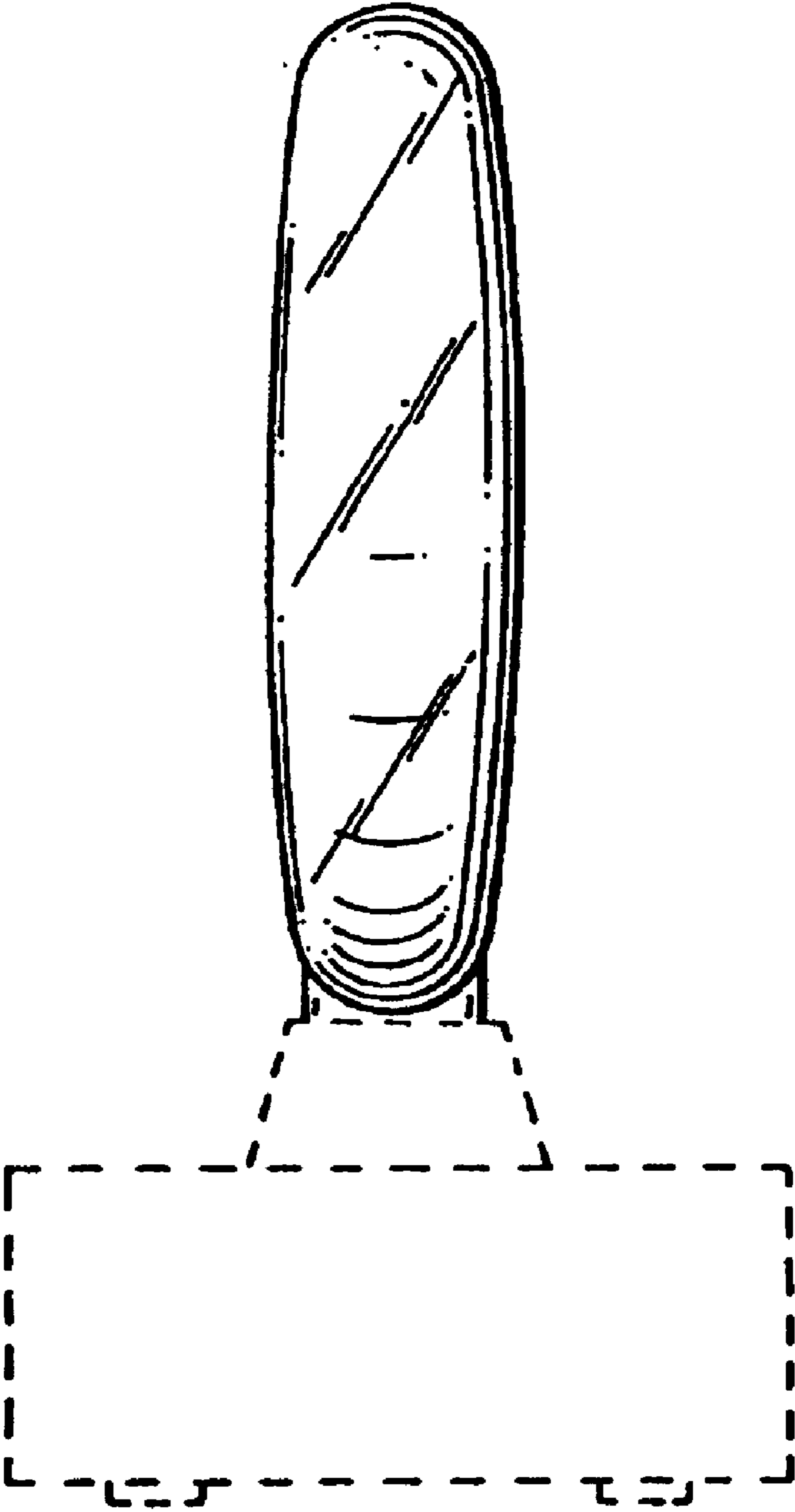

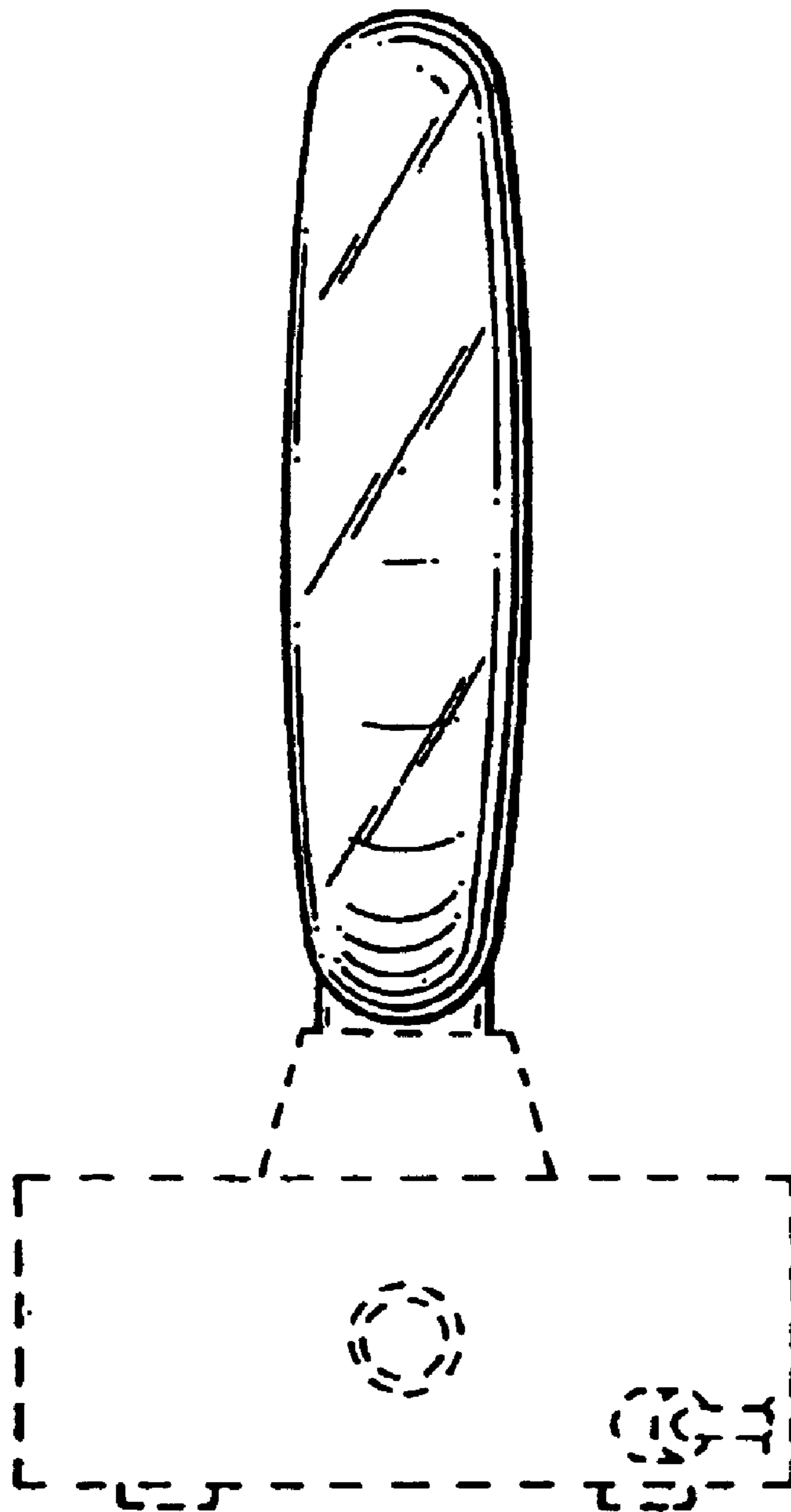
