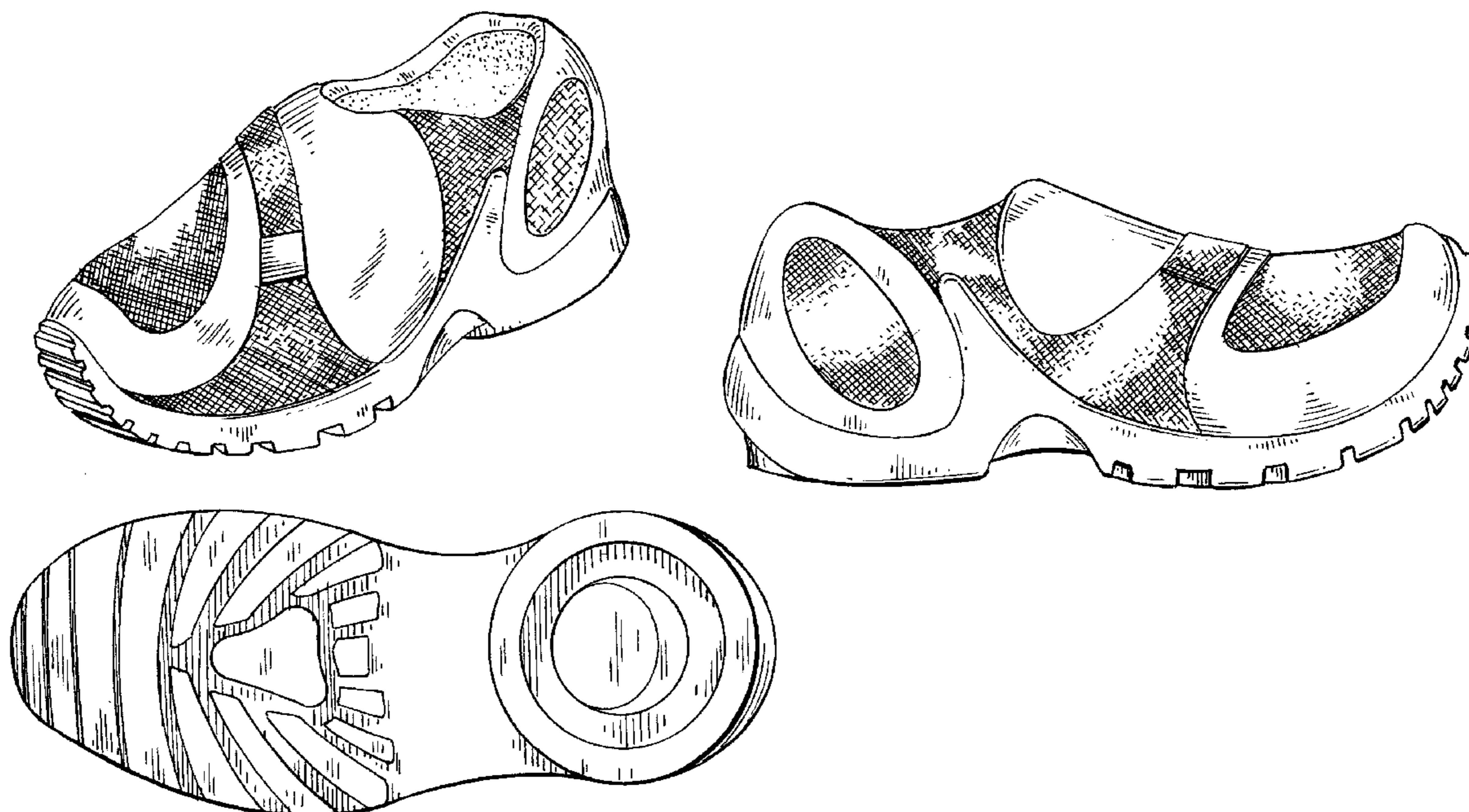
(57) **CLAIM**

The ornamental design for an athletic shoe, as shown and described.

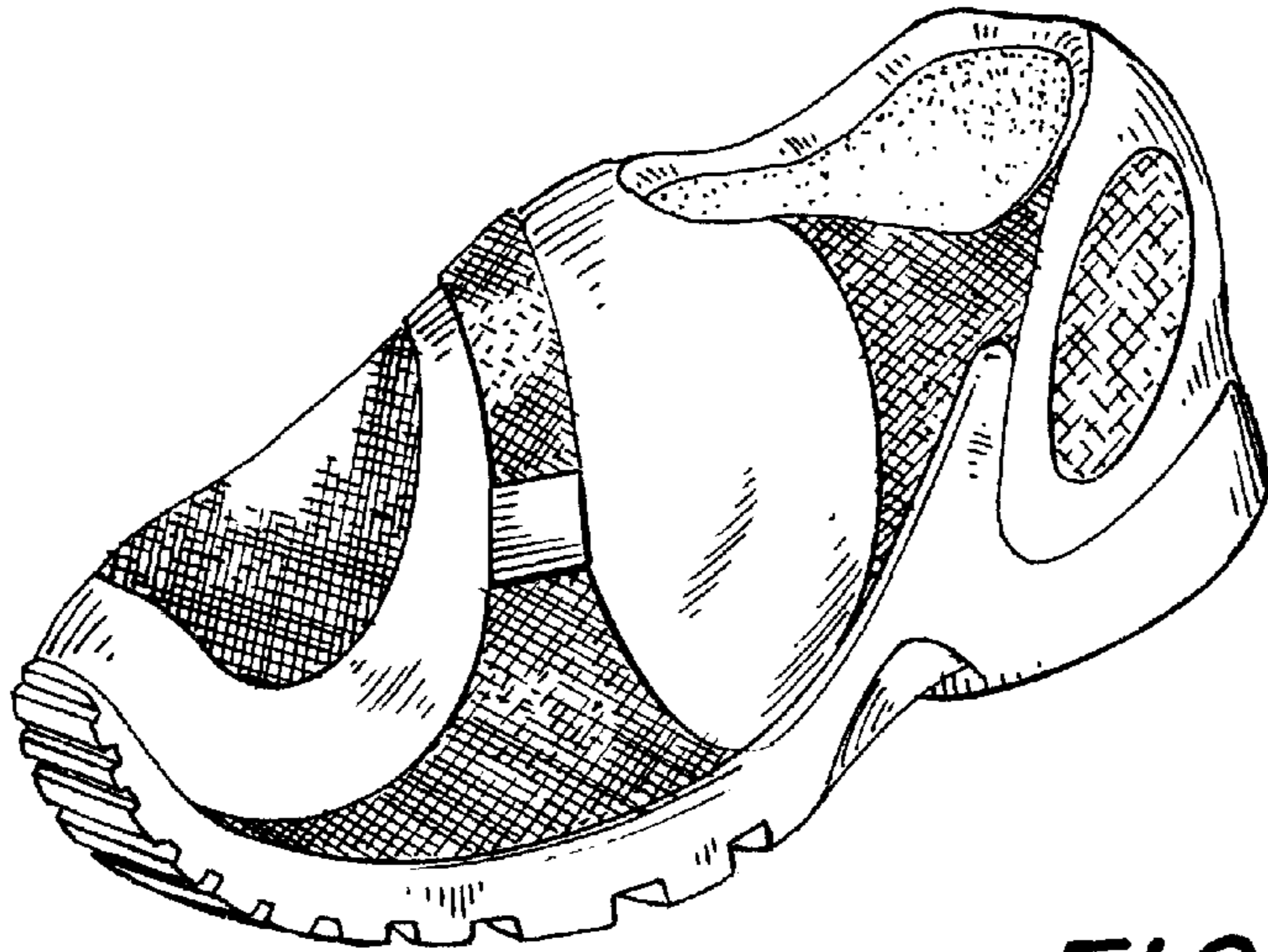
**DESCRIPTION**

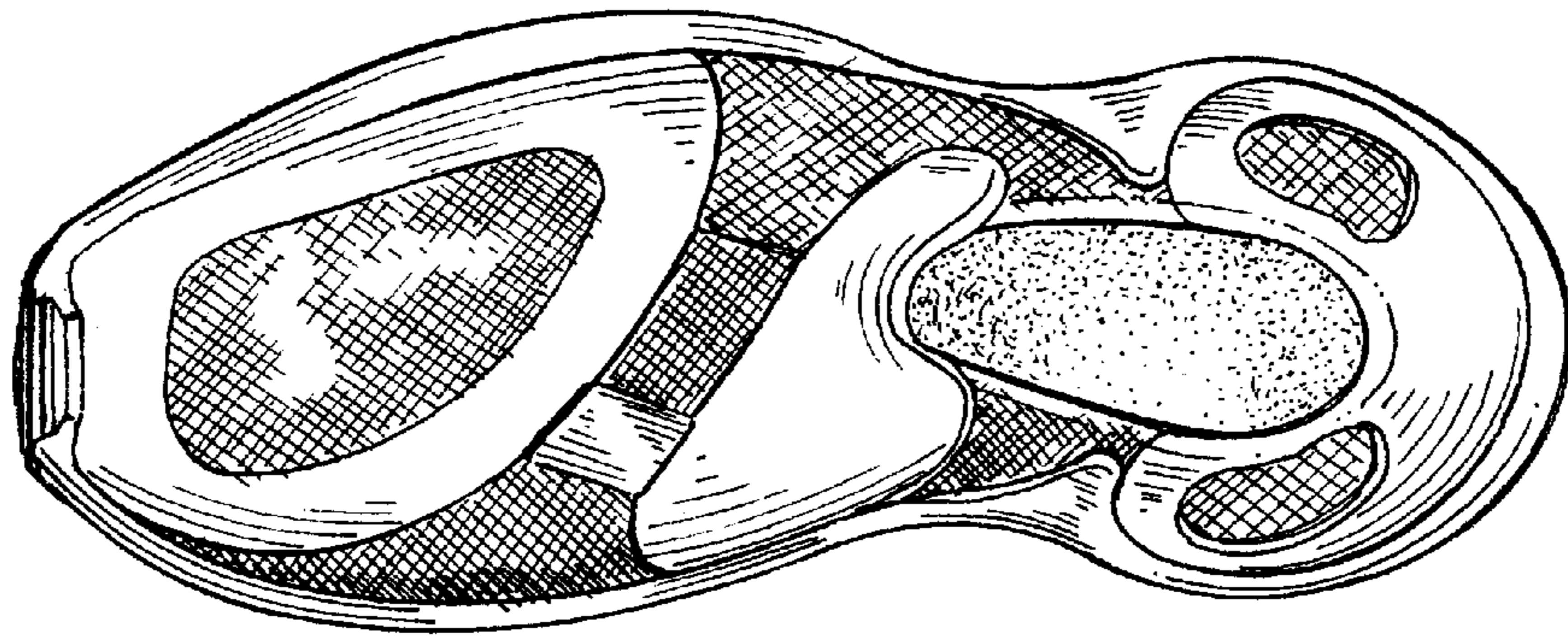

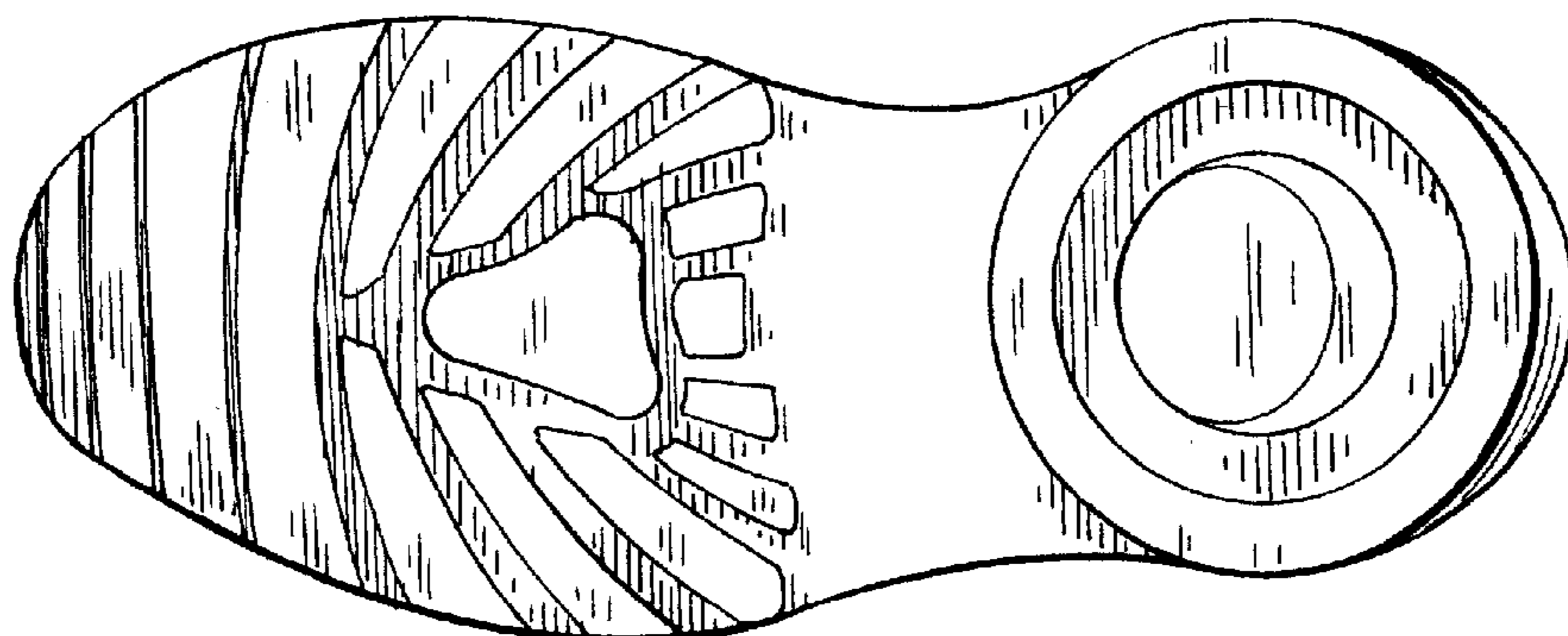

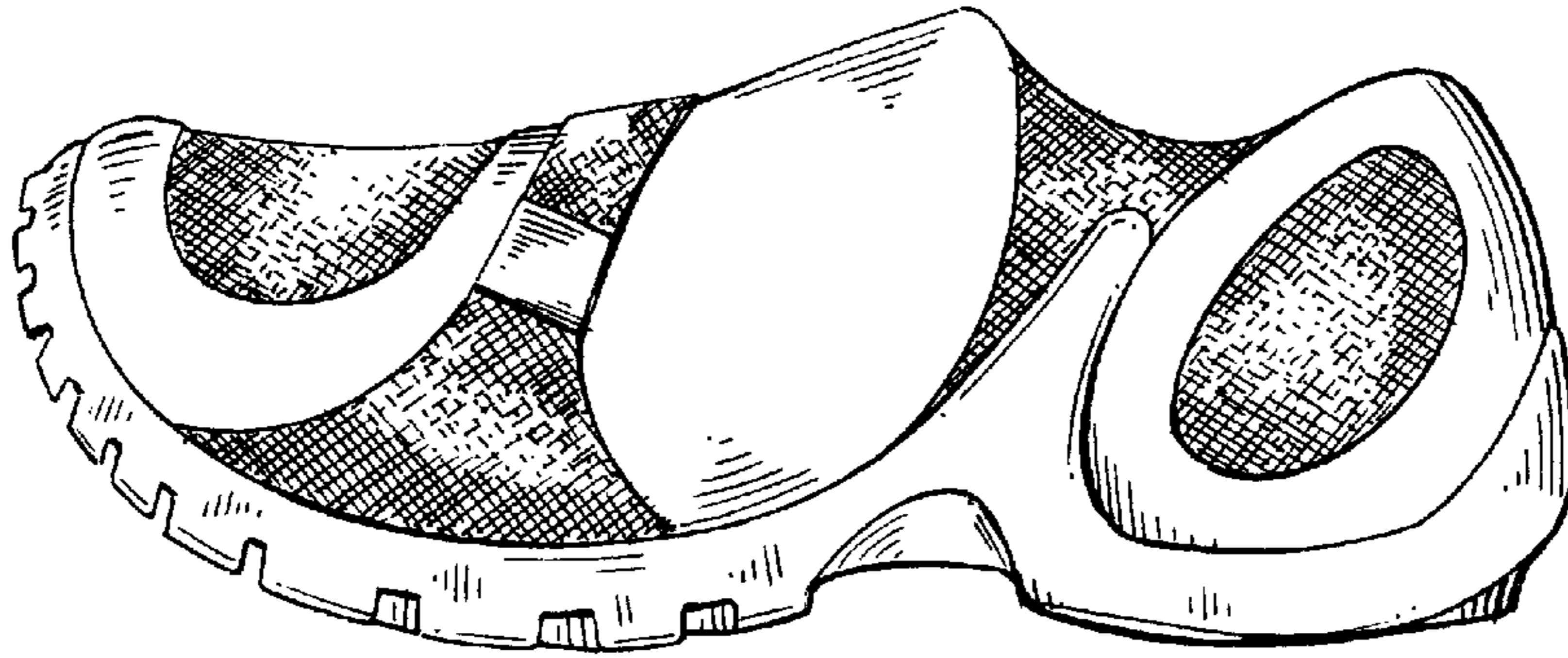

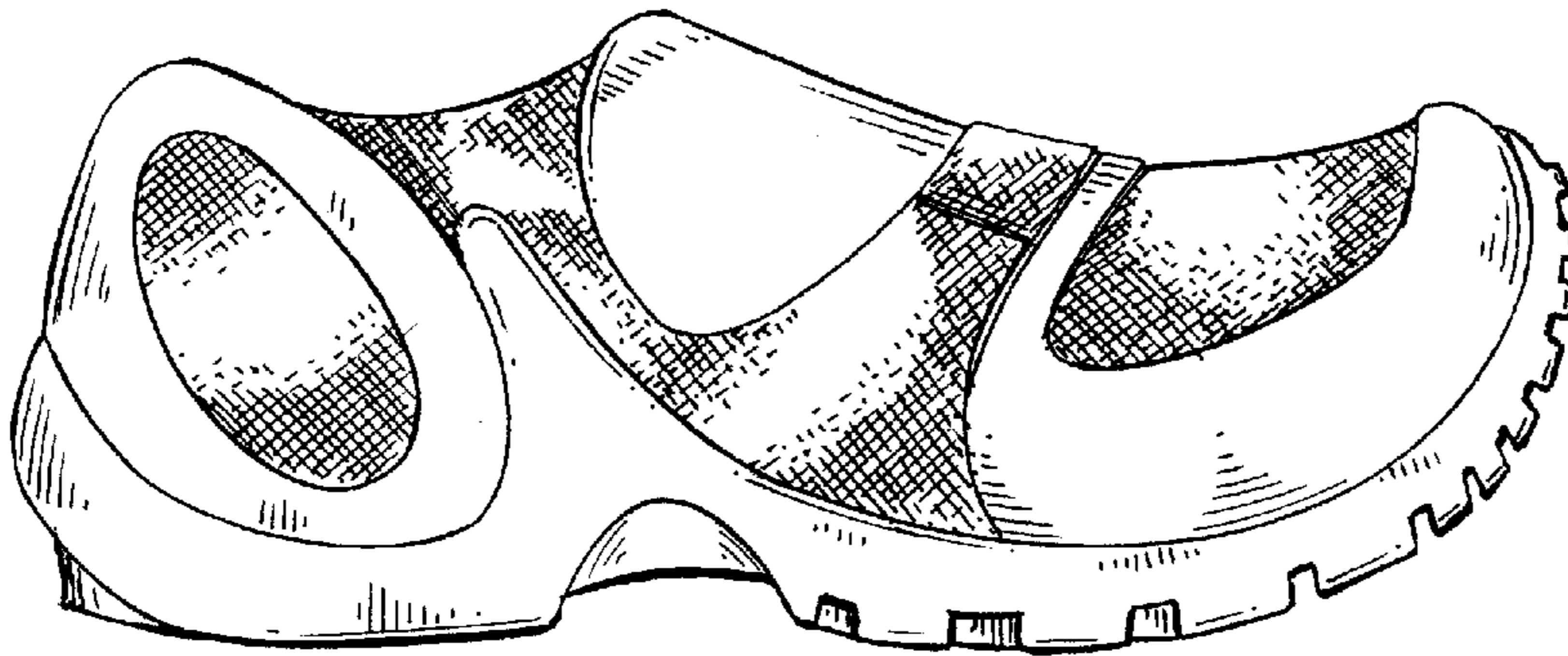

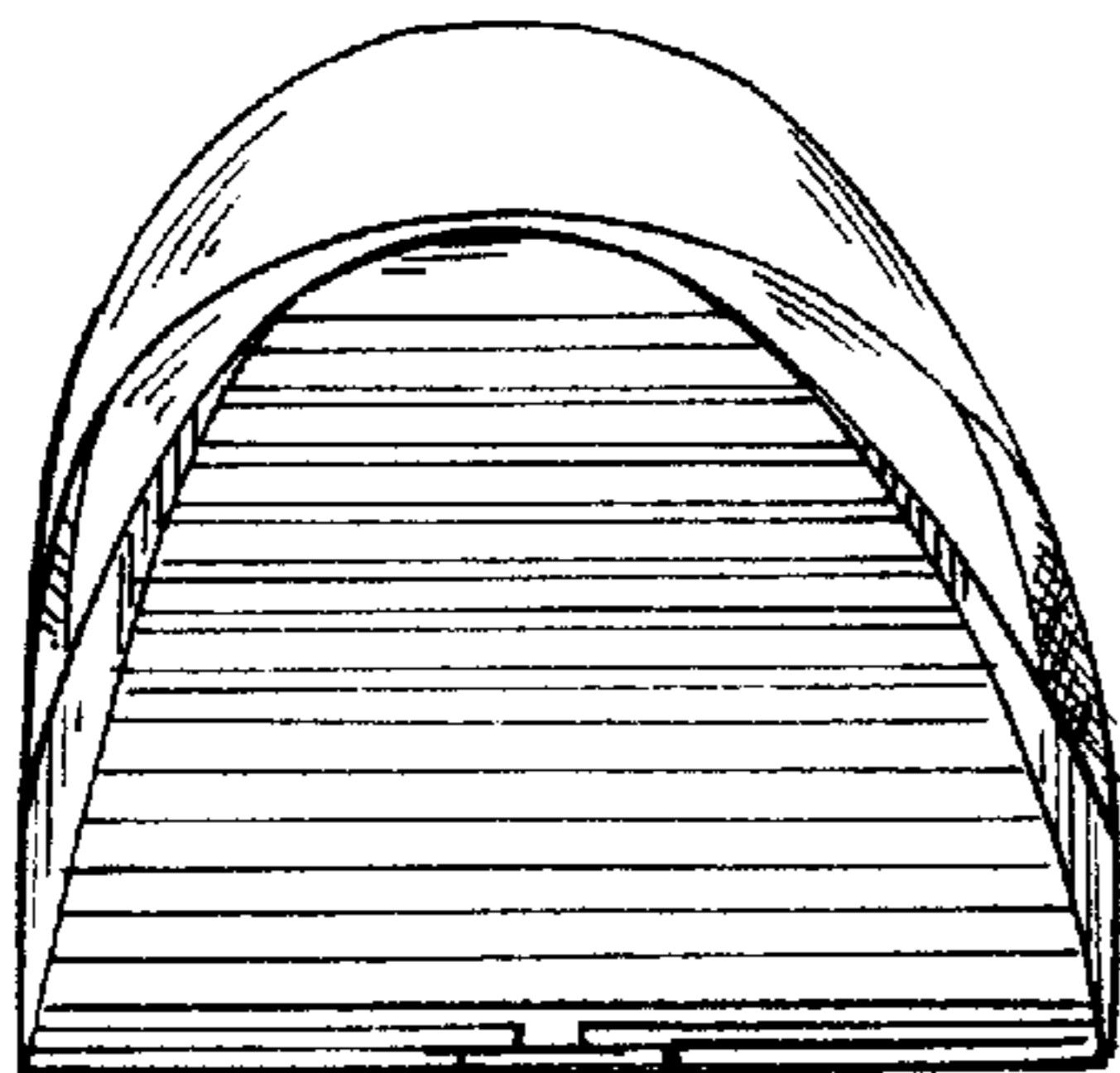
