(57) **CLAIM**

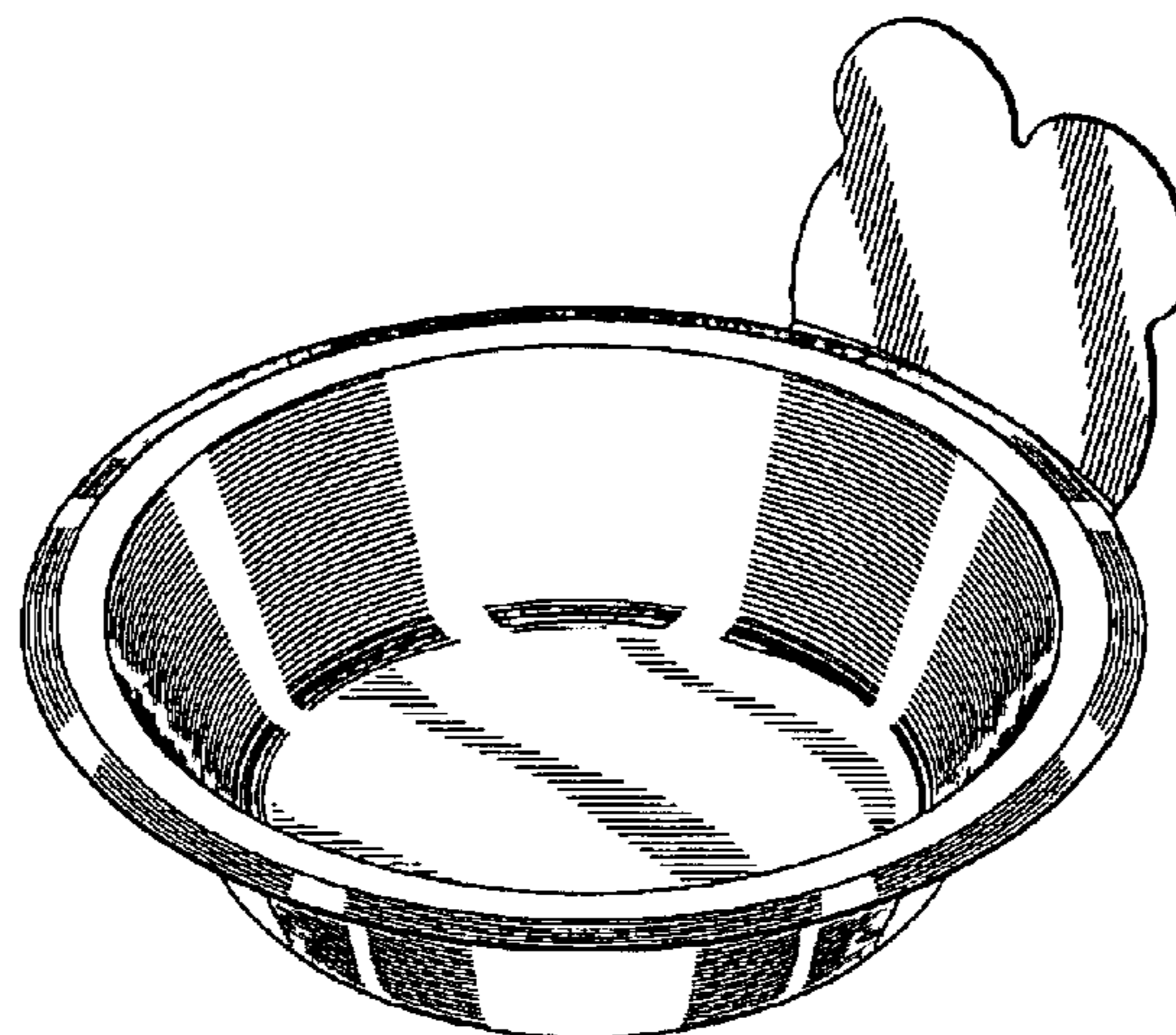
The ornamental design for a bowl having a display tab, as shown.

**DESCRIPTION**

Cross-Reference is made to copending U.S. Design patent application Ser. No. 29/199,069 entitled “Bowl Having a Display Tab,” filed on Feb. 9, 2004, which is incorporated herein by reference in its entirety.

FIG. 1 is a perspective view of a bowl having a display tab. FIG. 2 is a top plan view of a bowl having a display tab. FIG. 3 is a bottom plan view of a bowl having a display tab. FIG. 4 is a left-side elevational view of a bowl having a display tab. FIG. 5 is a right-side elevational view of a bowl having a display tab. FIG. 6 is a front-end elevational view of a bowl having a display tab; and, FIG. 7 is a back-end elevational view of a bowl having a display tab.

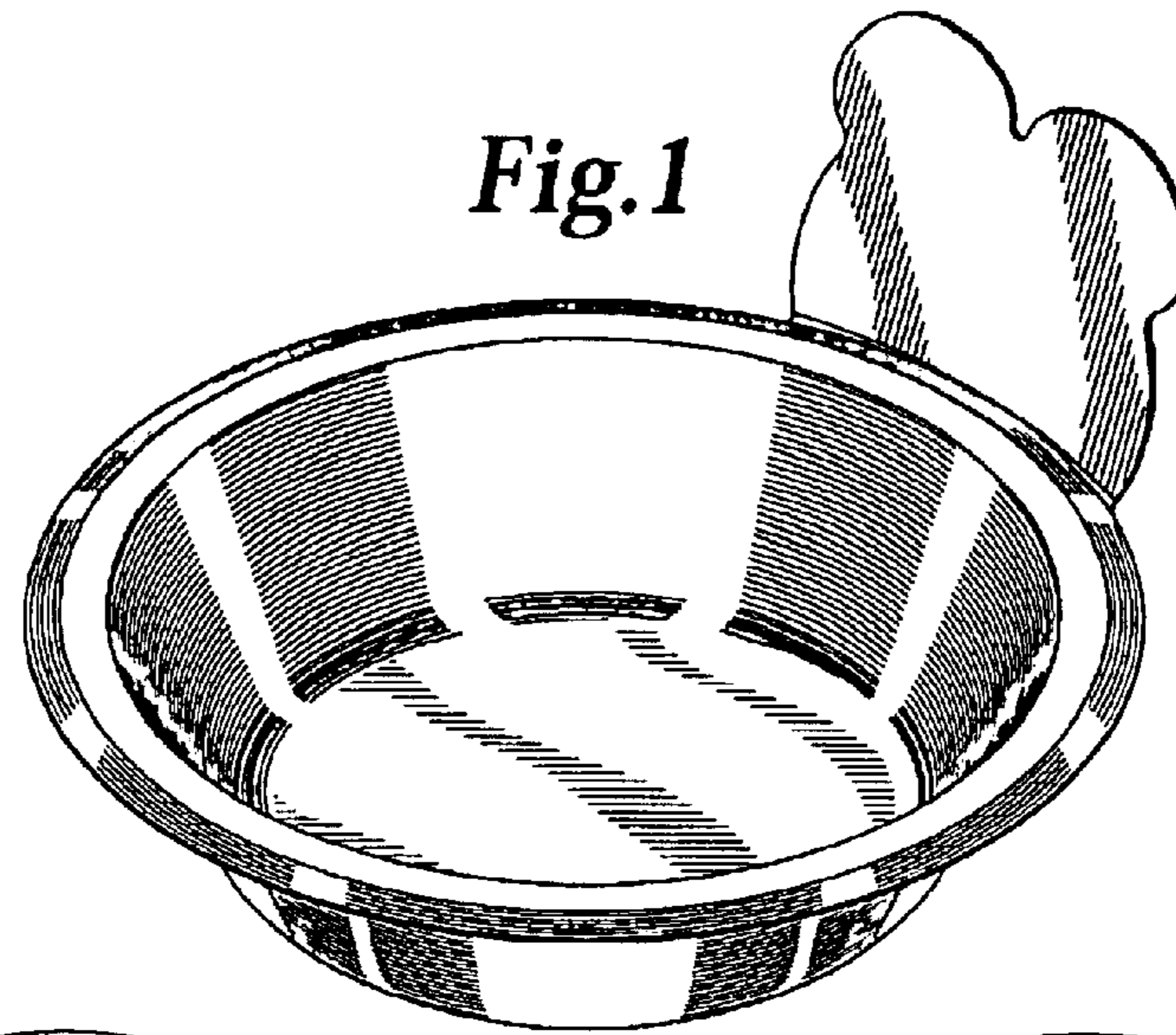

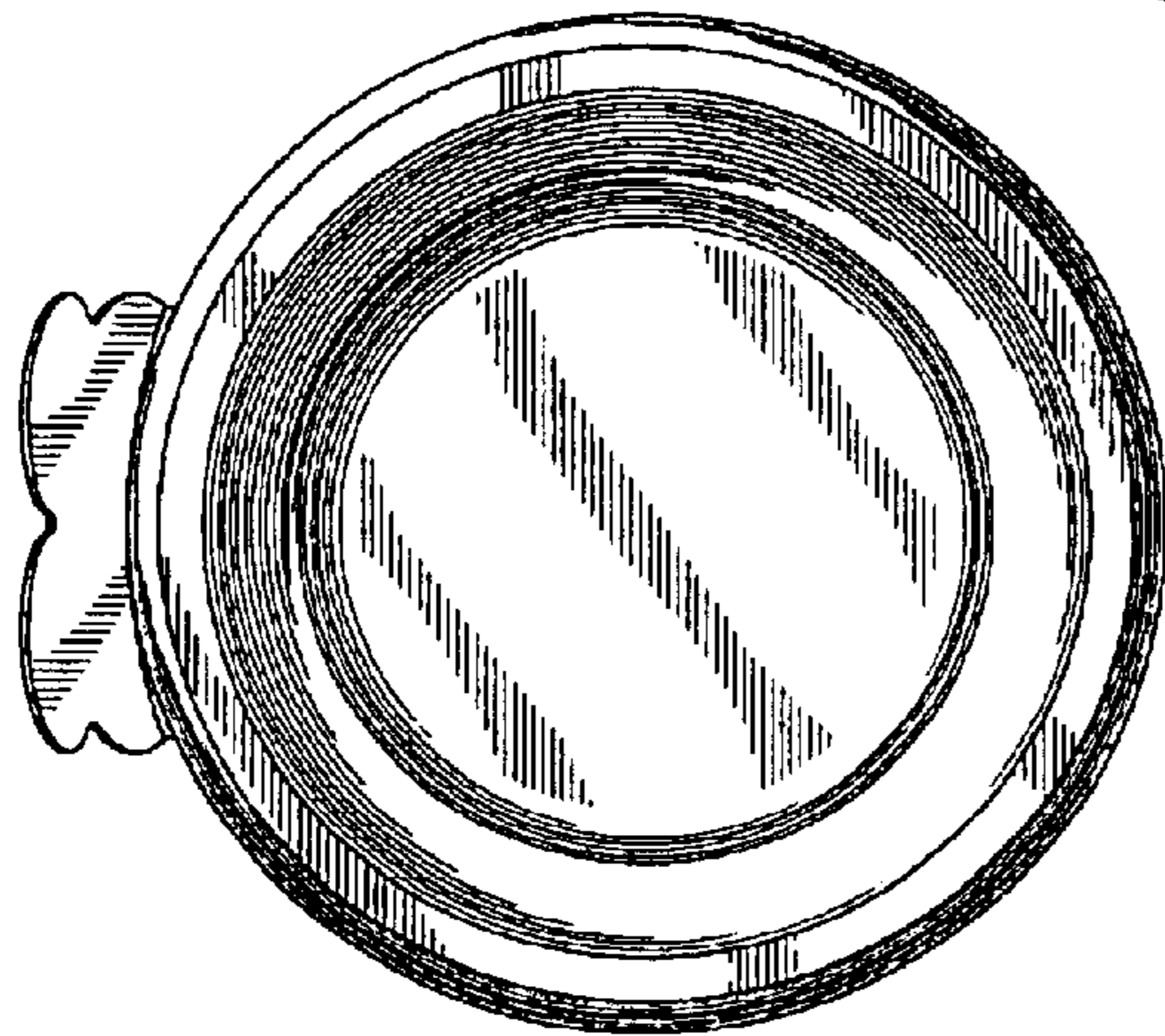

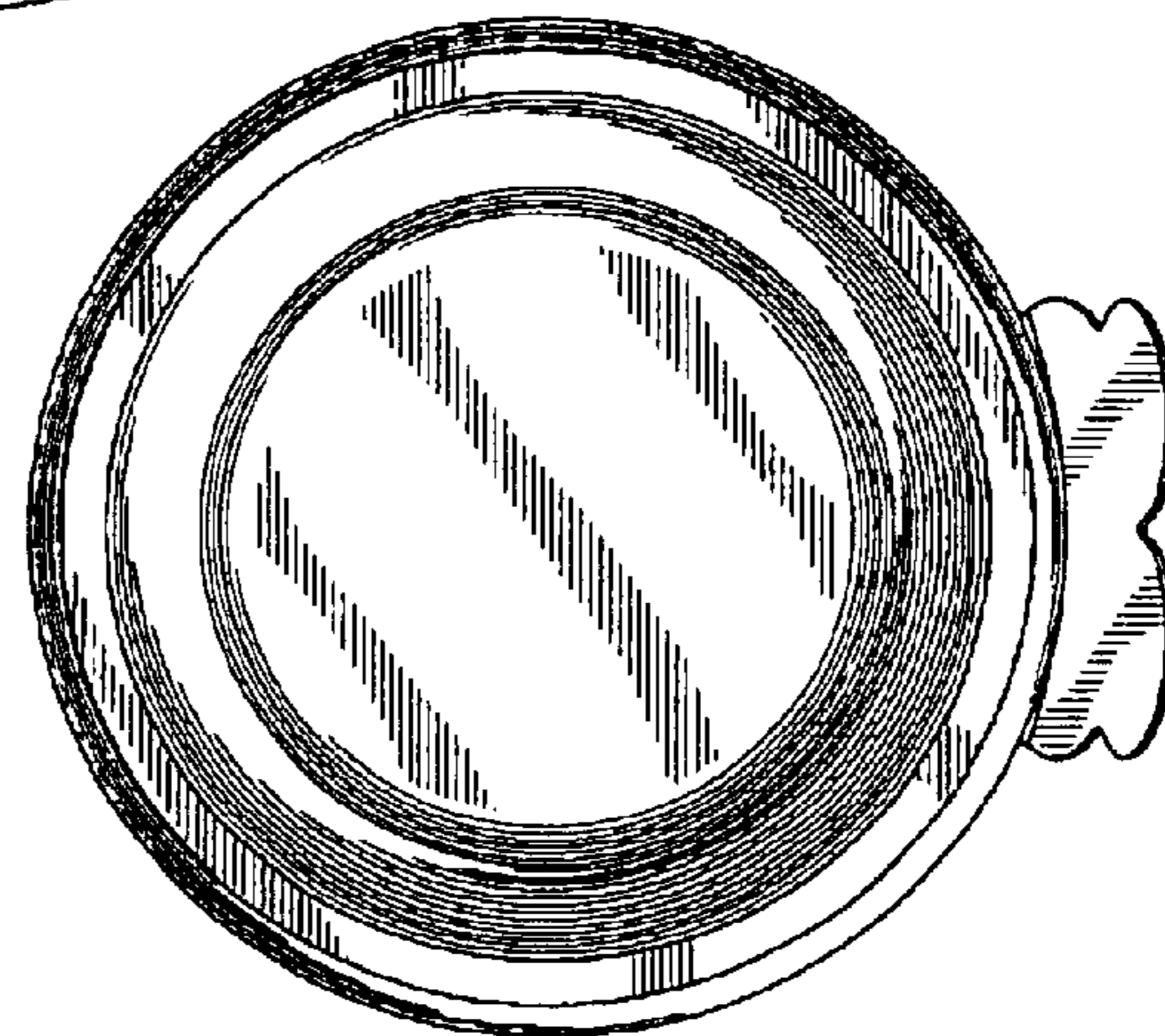

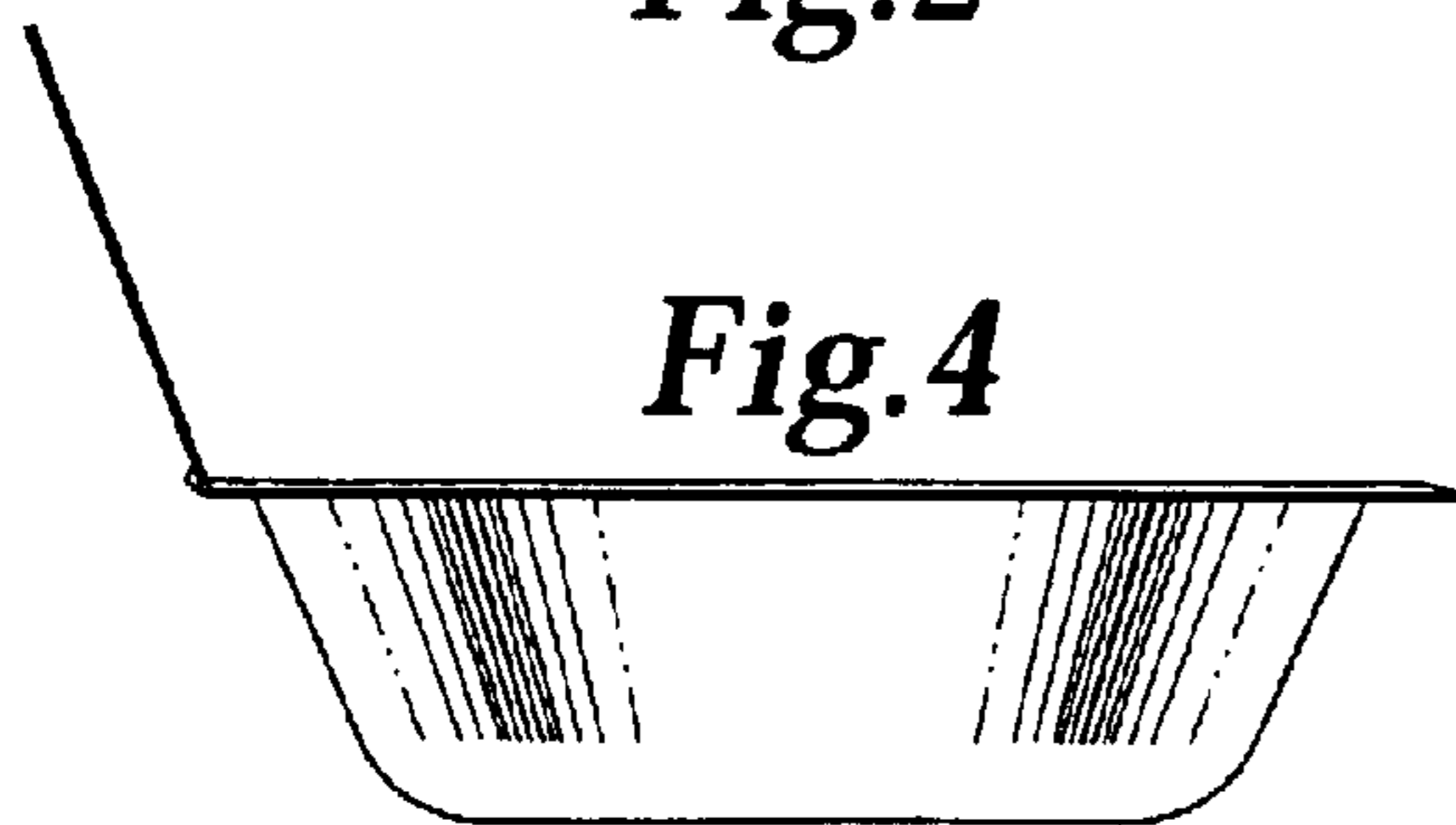

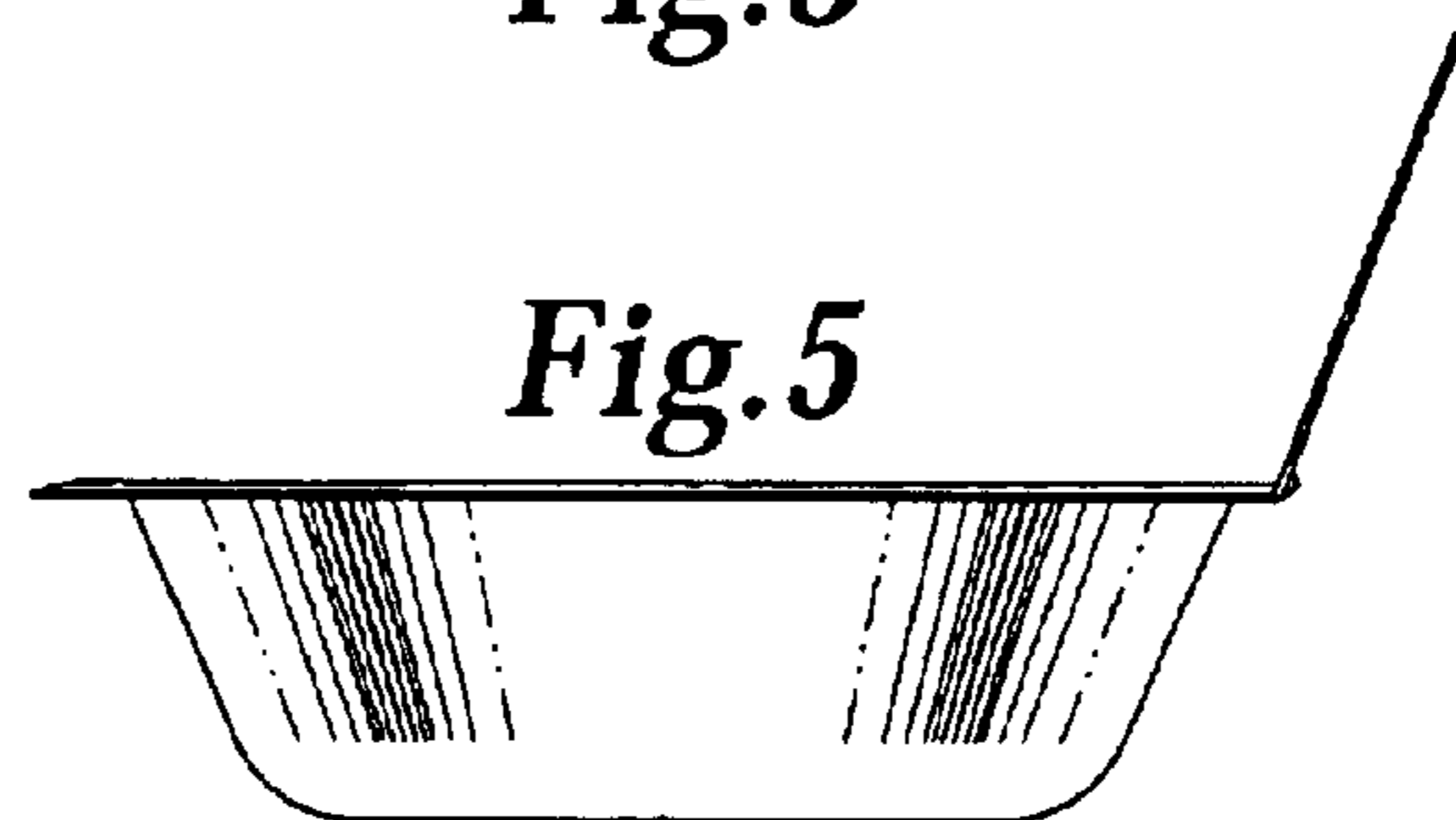

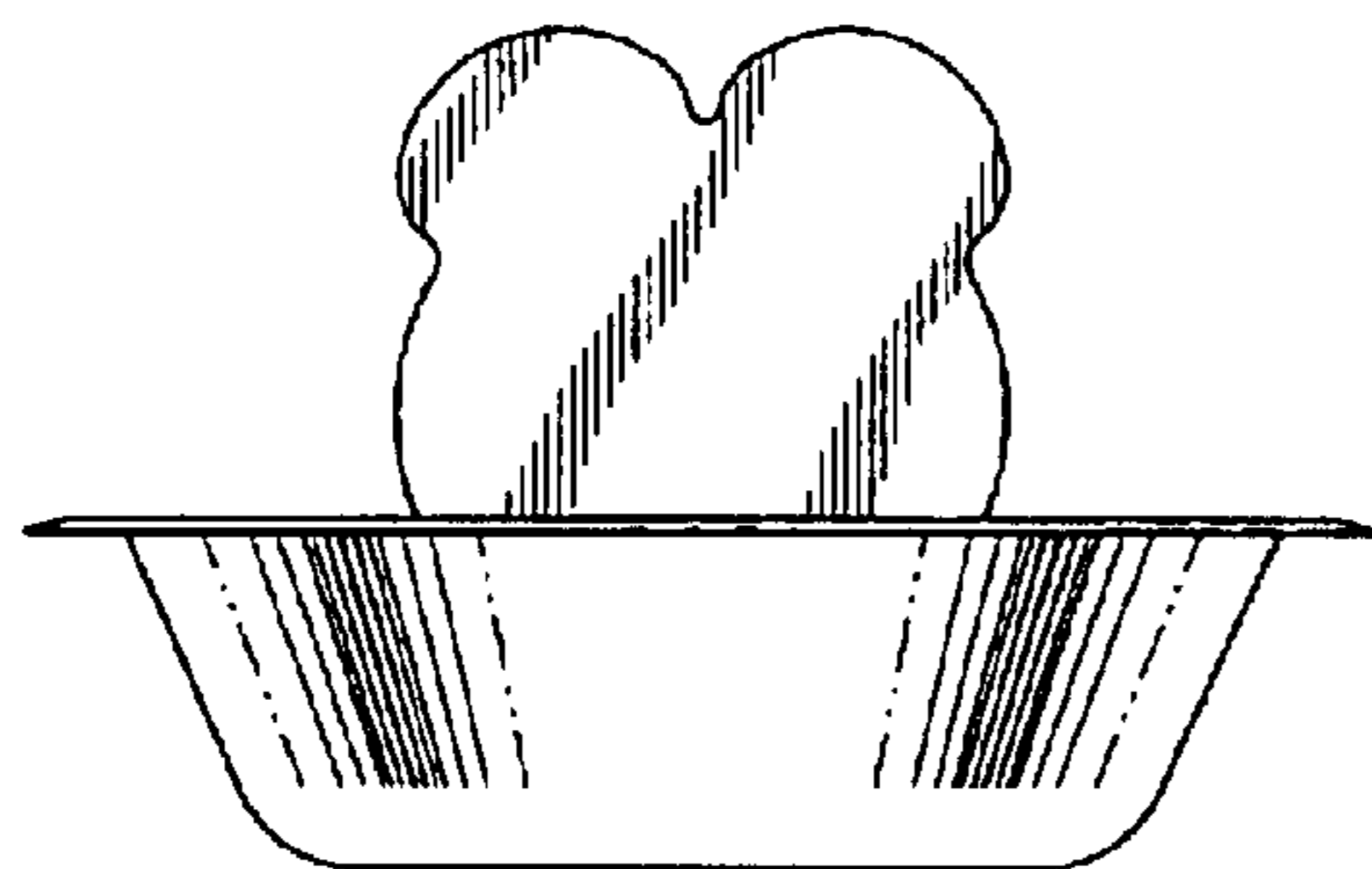

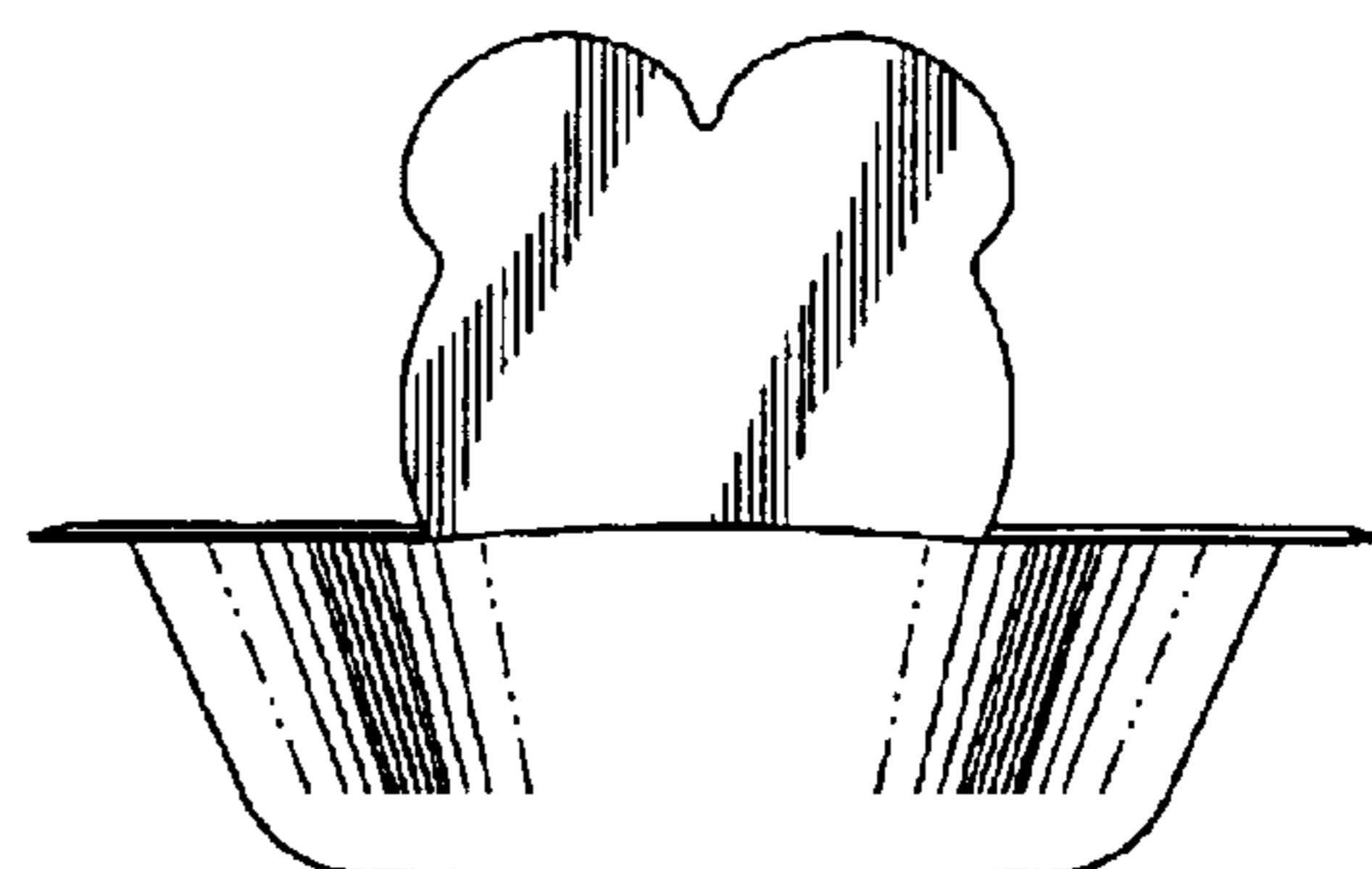
