(57) **CLAIM**

The ornamental design for a set of cutlery, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the claimed design embodied in a table knife;

FIG. 2 is a front view of the table knife illustrated in FIG. 1;

FIG. 3 is a side view of the table knife illustrated in FIG. 1, the opposite side being a mirror image thereof;

FIG. 4 is a back view of the table knife illustrated in FIG. 1;

FIG. 5 is a top view of the table knife illustrated in FIG. 1;

FIG. 6 is a bottom view of the table knife illustrated in FIG. 1;

FIG. 7 is a perspective view of the claimed design embodied in a table fork;

FIG. 8 is a front view of the table fork illustrated in FIG. 7;

FIG. 9 is a side view of the table fork illustrated in FIG. 7, the opposite side being a mirror image thereof;

FIG. 10 is a back view of the table fork illustrated in FIG. 7;

FIG. 11 is a top view of the table fork illustrated in FIG. 7;

FIG. 12 is a bottom view of the table fork illustrated in FIG. 7;

FIG. 13 is a perspective view of the claimed design embodied in a soup spoon;

FIG. 14 is a front view of the soup spoon illustrated in FIG. 13;

FIG. 15 is a side view of the soup spoon illustrated in FIG. 13, the opposite side being a mirror image thereof;

FIG. 16 is a back view of the soup spoon illustrated in FIG. 13;

FIG. 17 is a top view of the soup spoon illustrated in FIG. 13; and,

FIG. 18 is a bottom view of the soup spoon illustrated in FIG. 13.

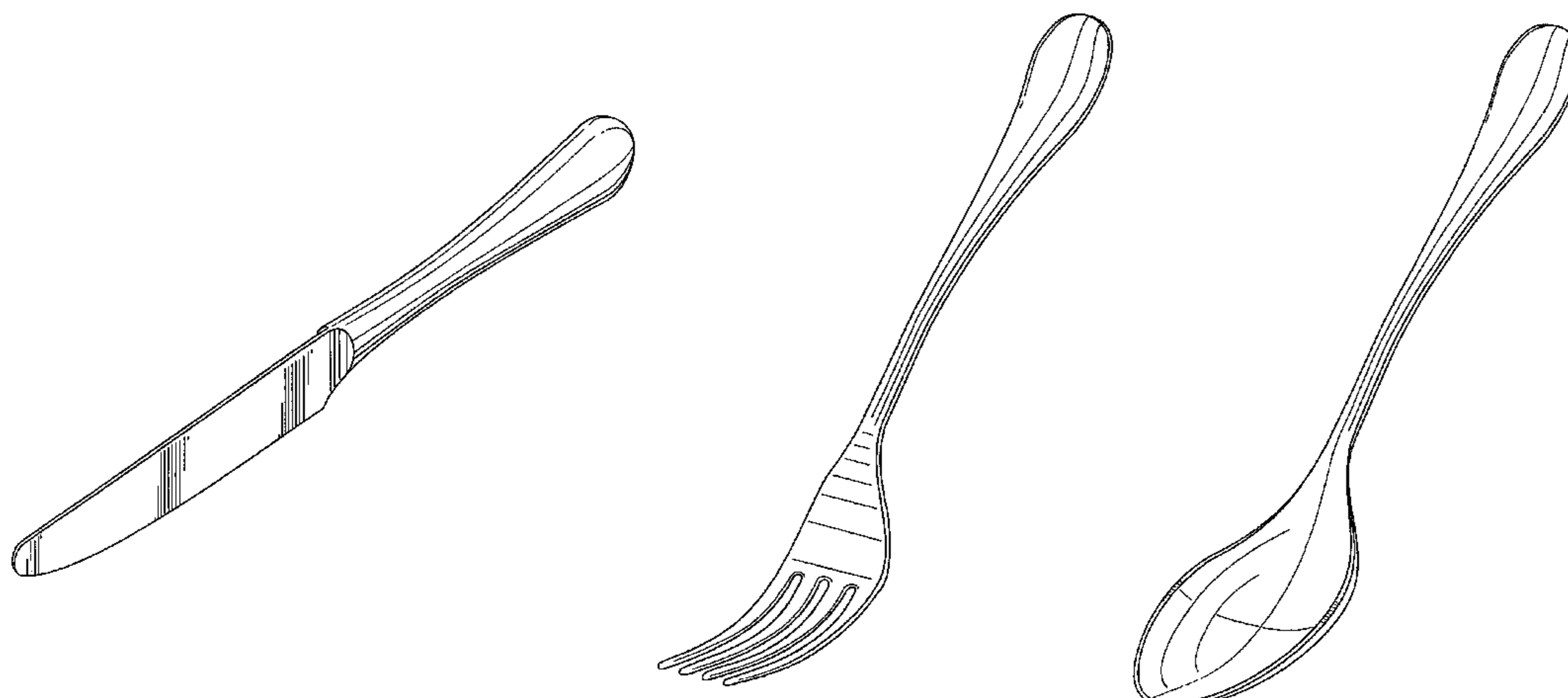

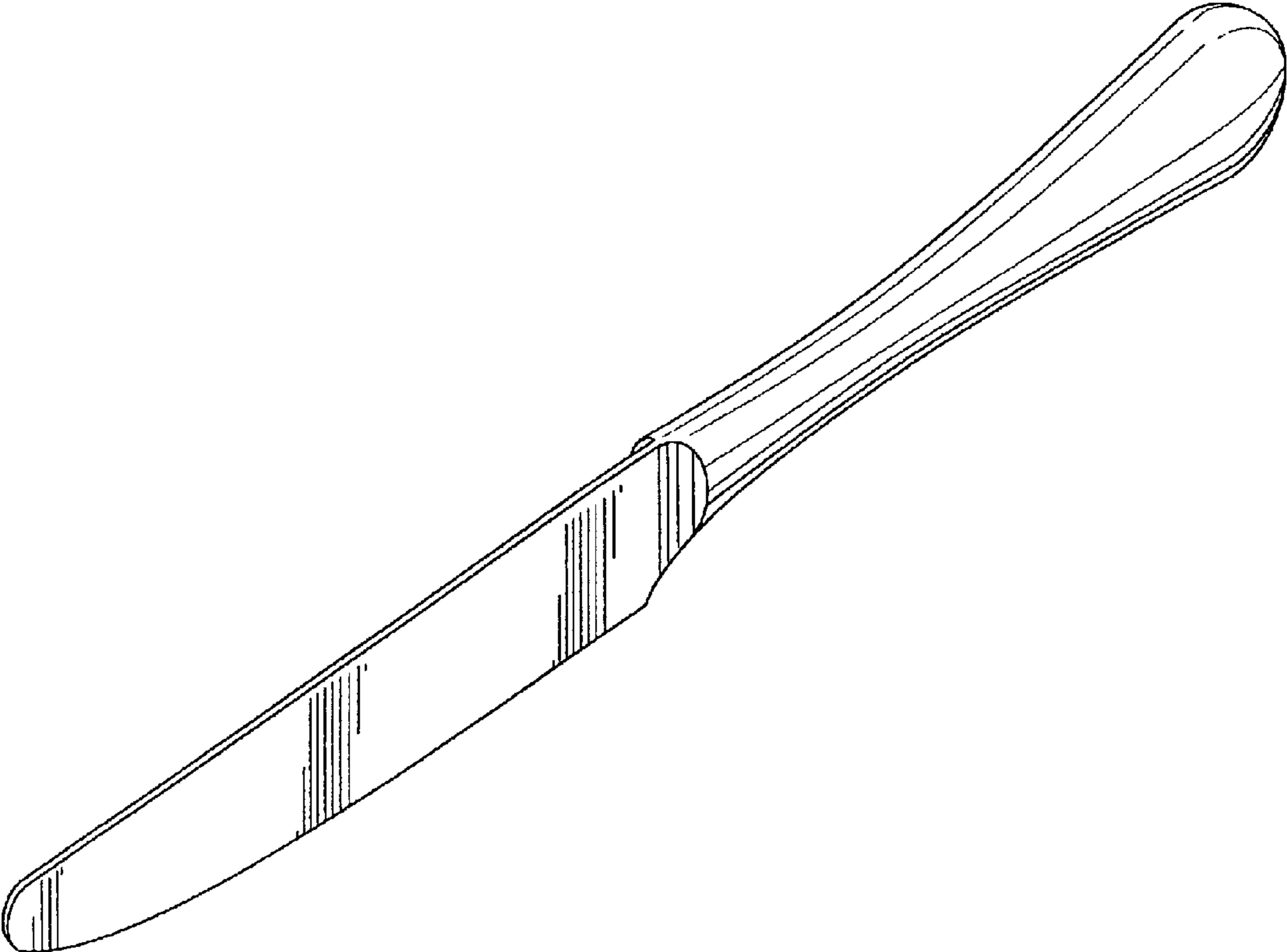

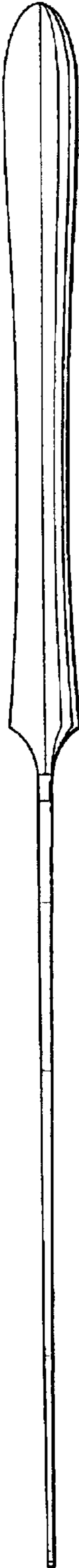

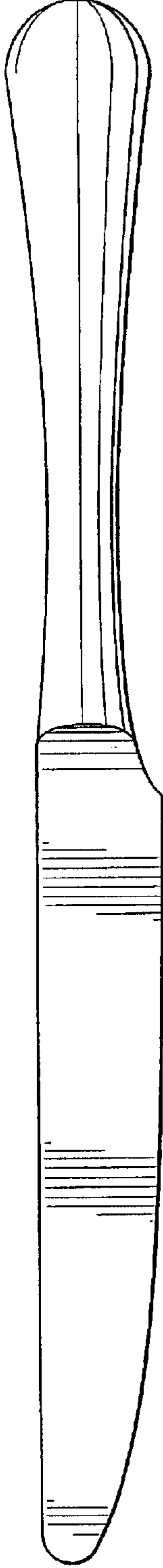

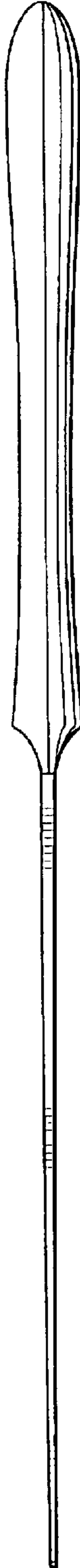

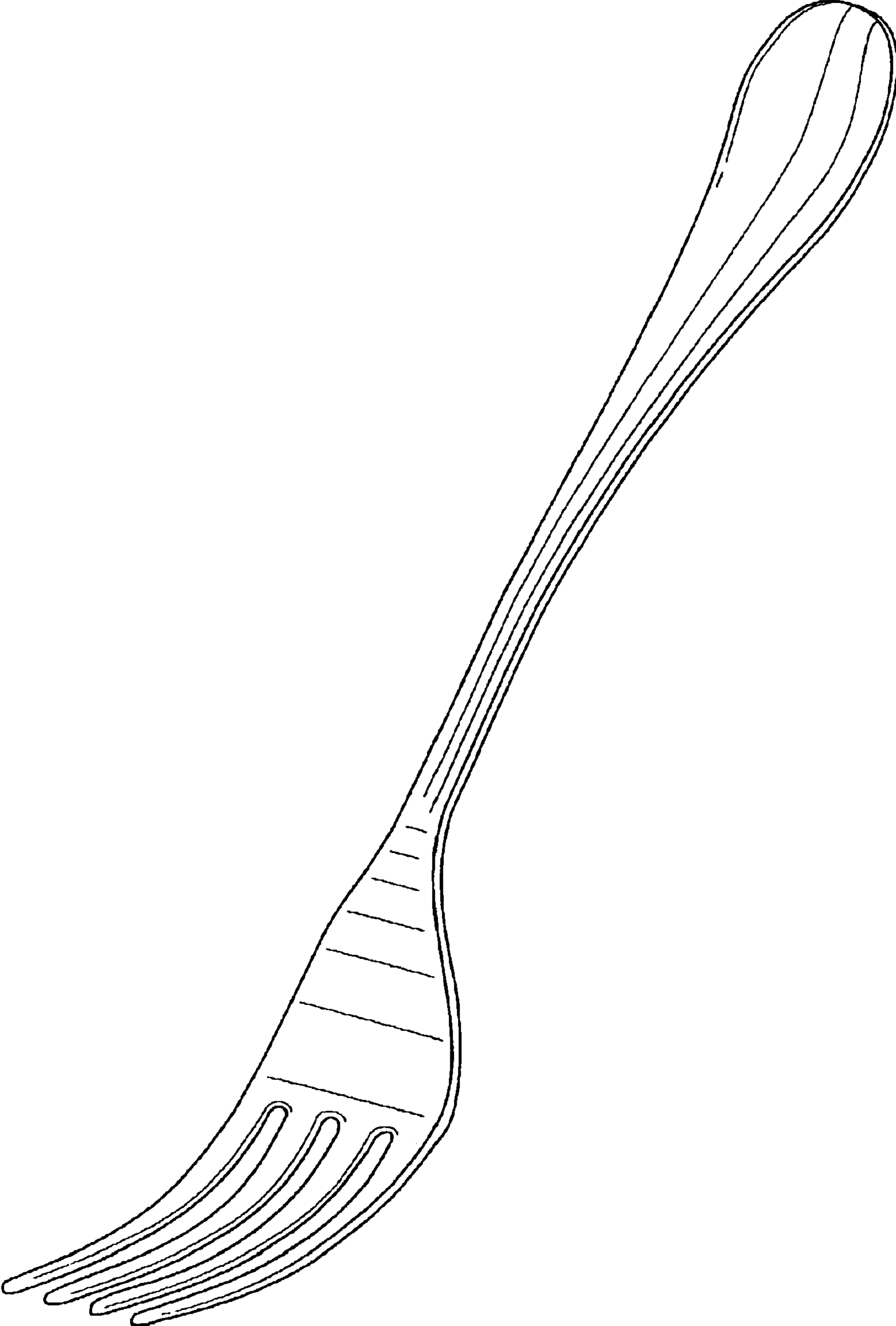

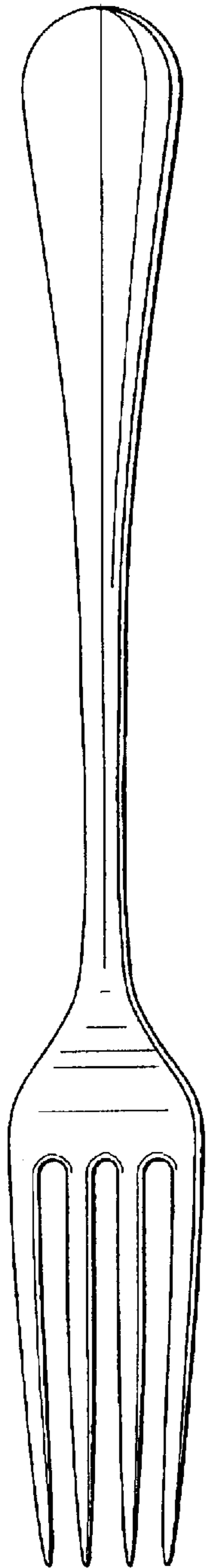

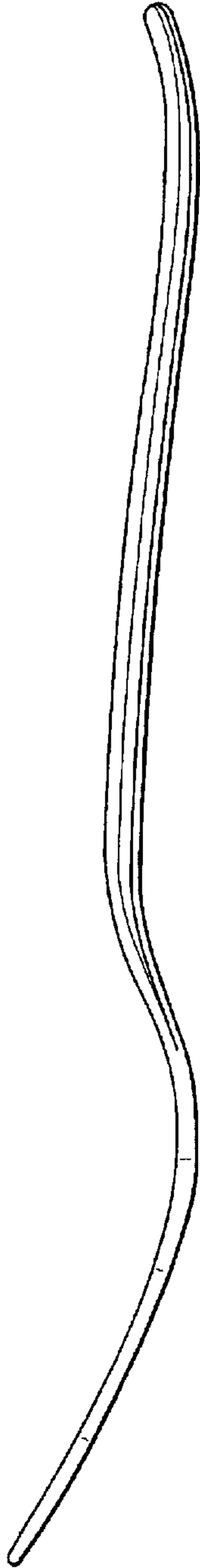

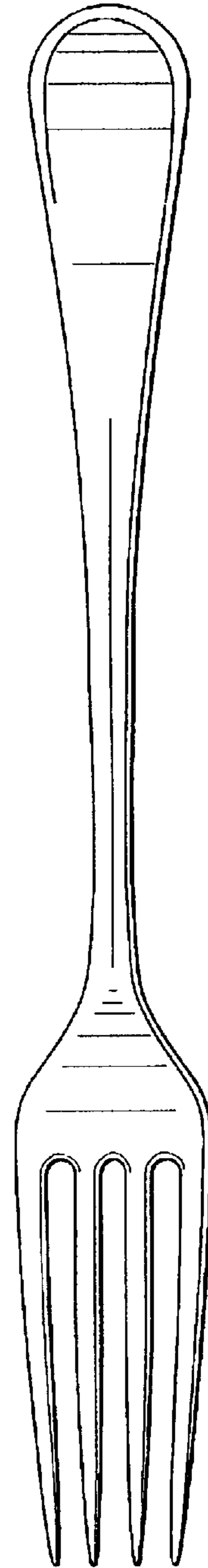

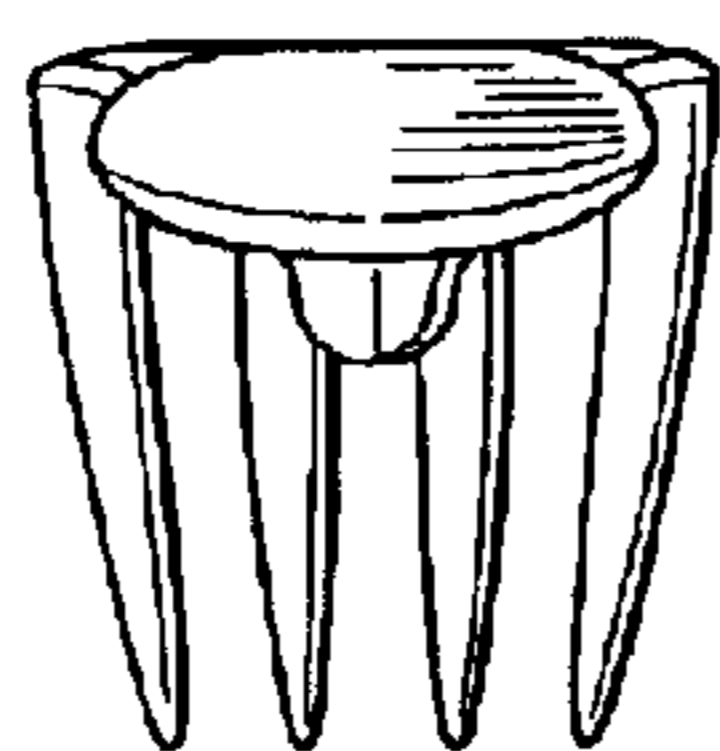

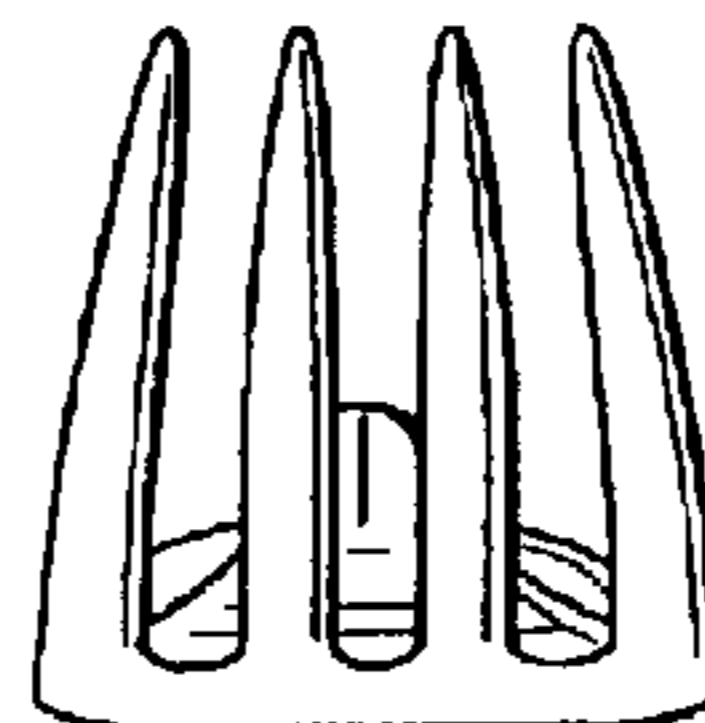

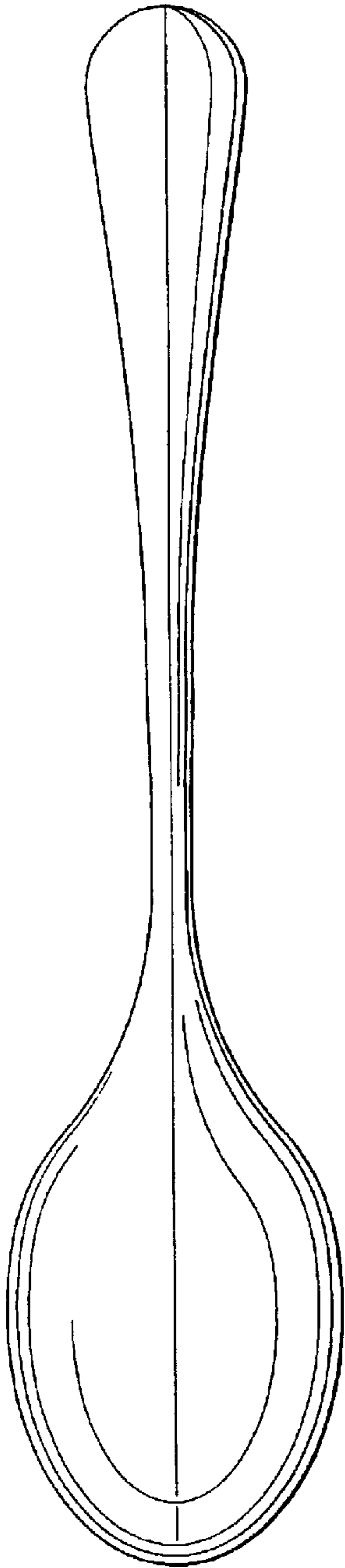

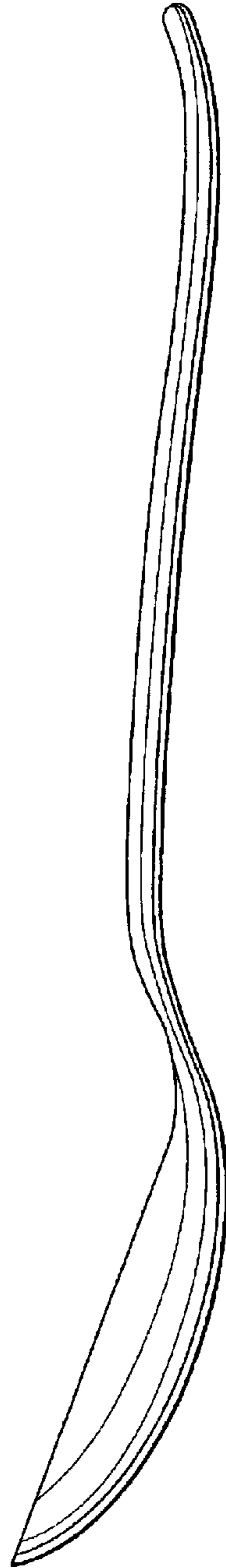

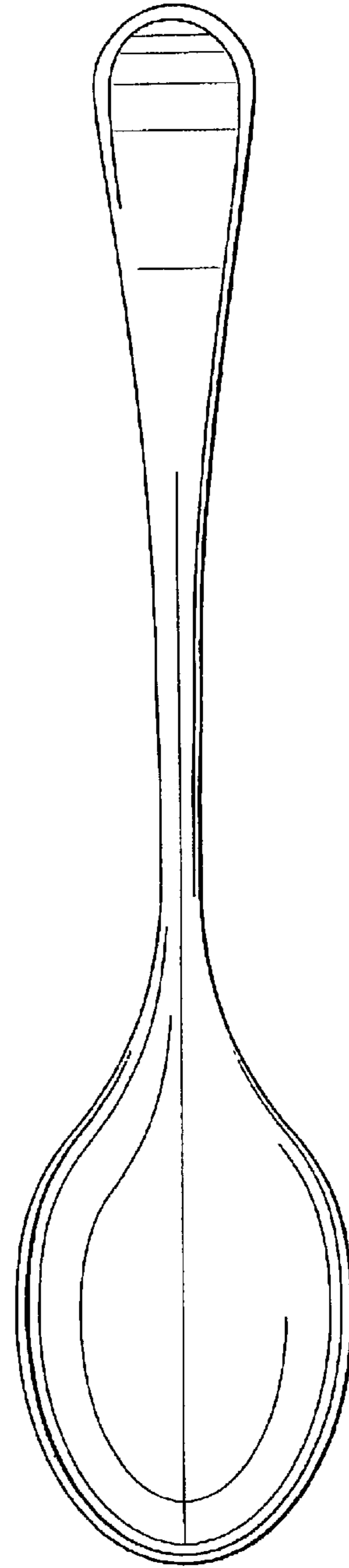

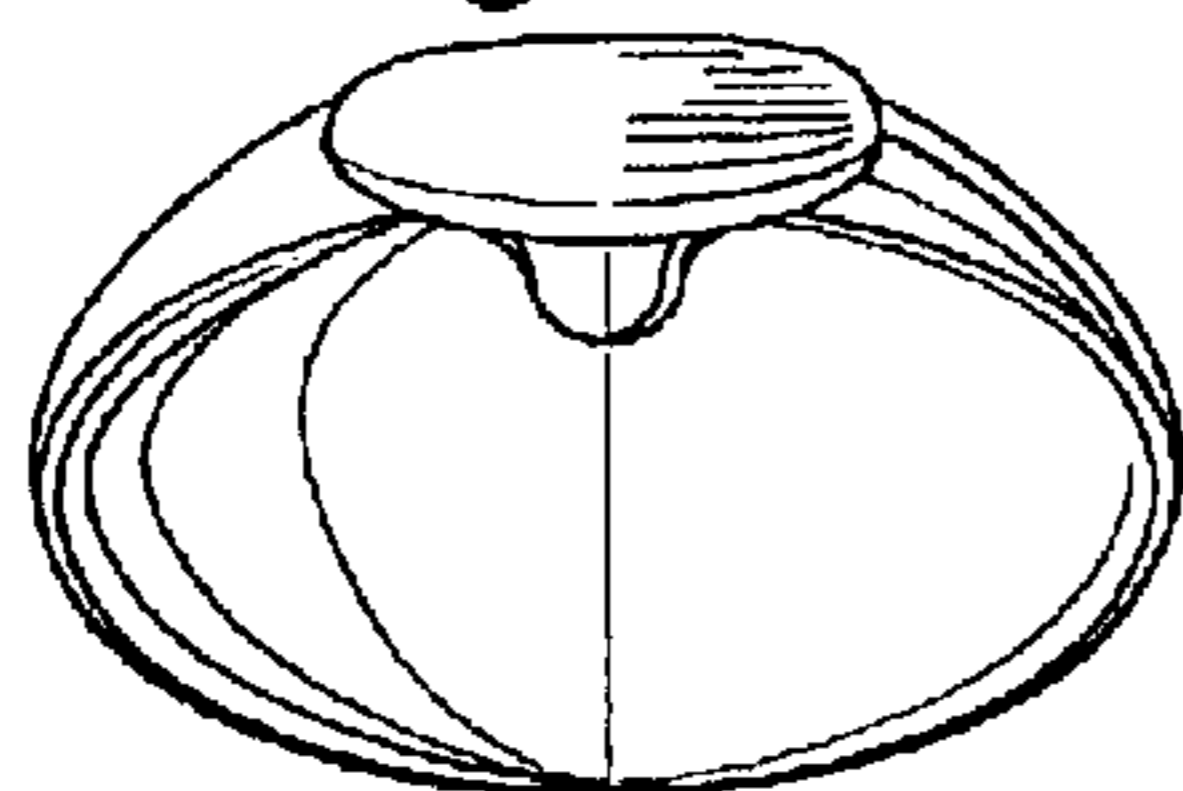
