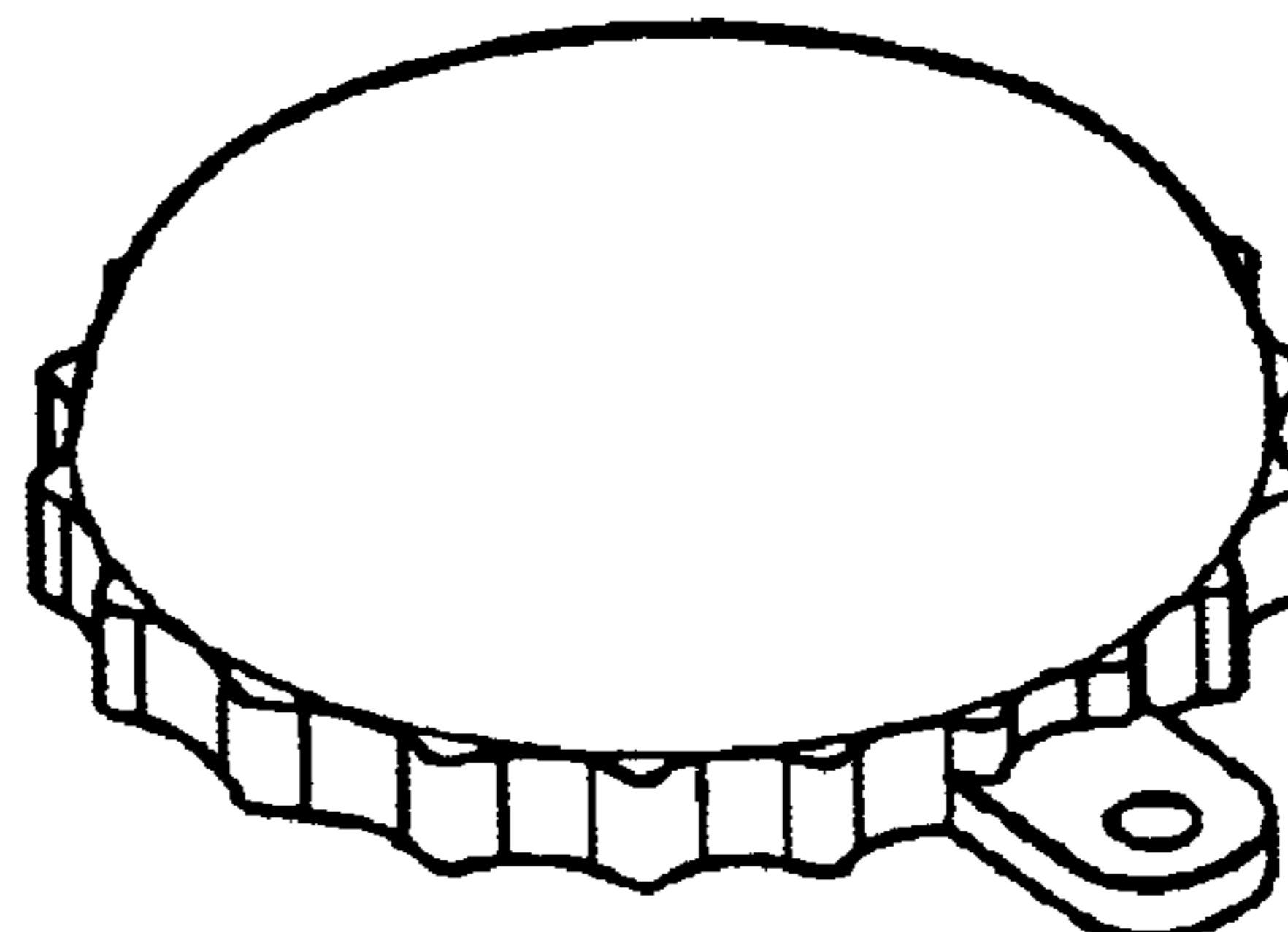
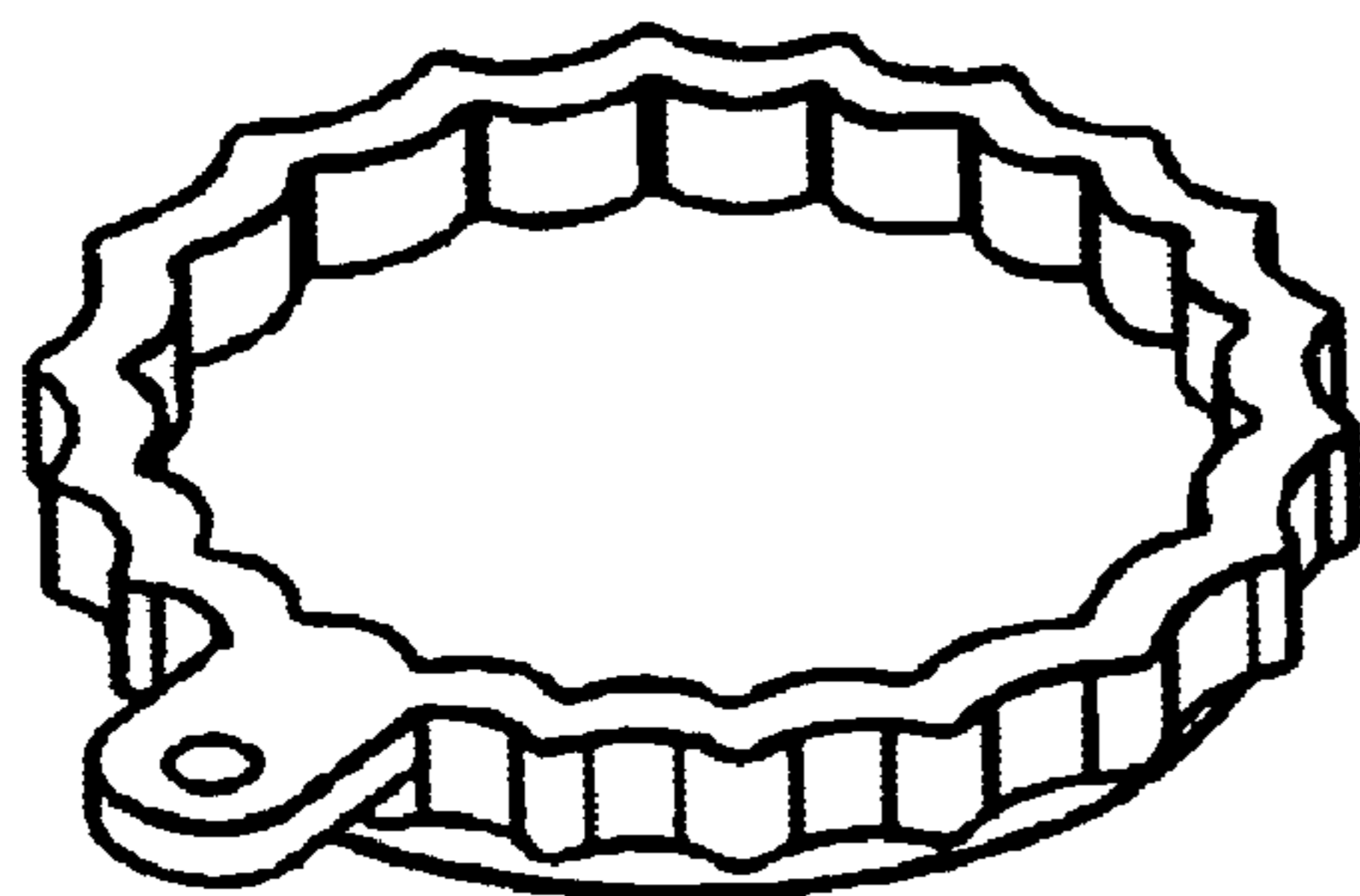

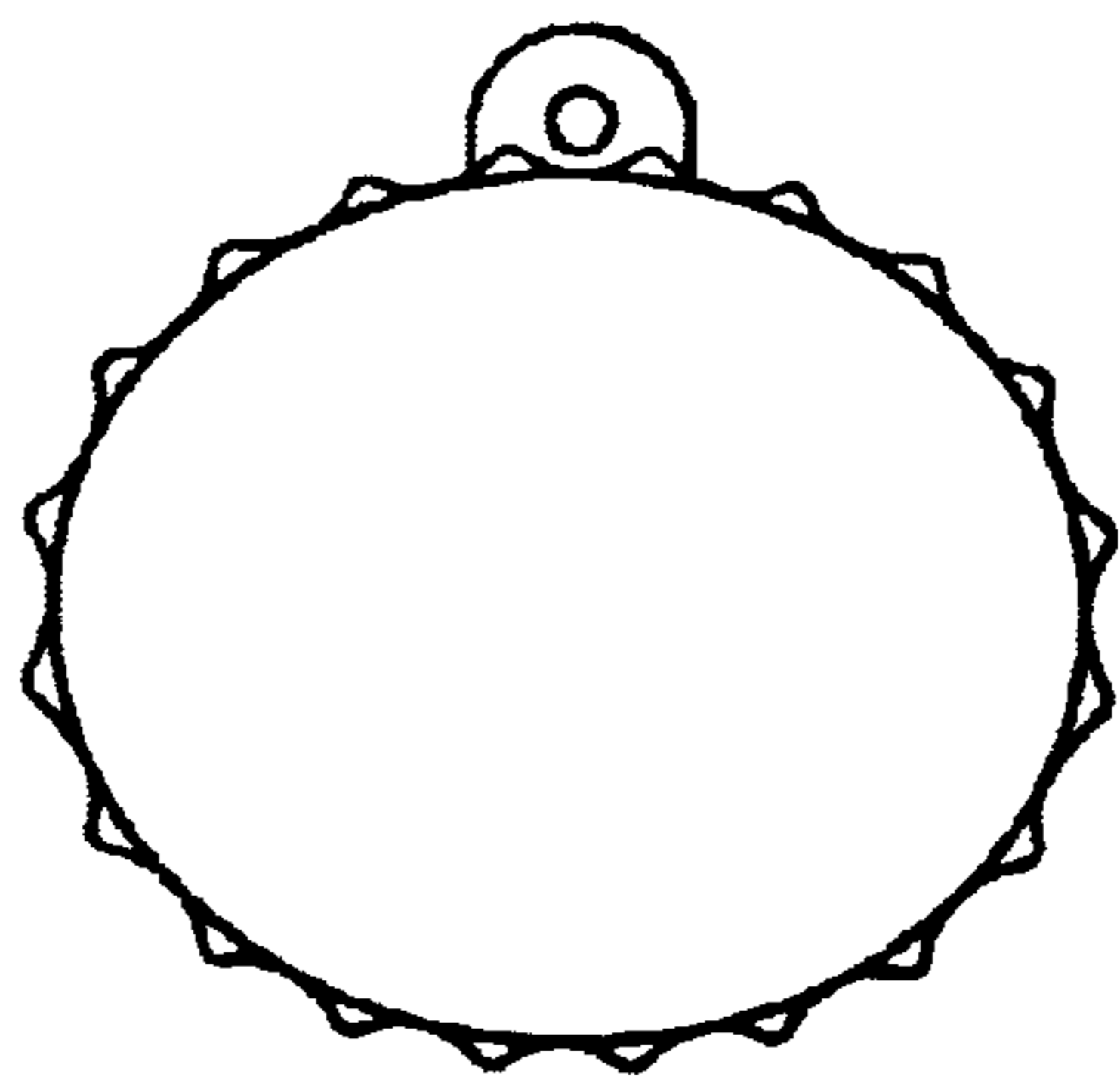
The ornamental design for a bottle cap opener, as shown.

**DESCRIPTION**

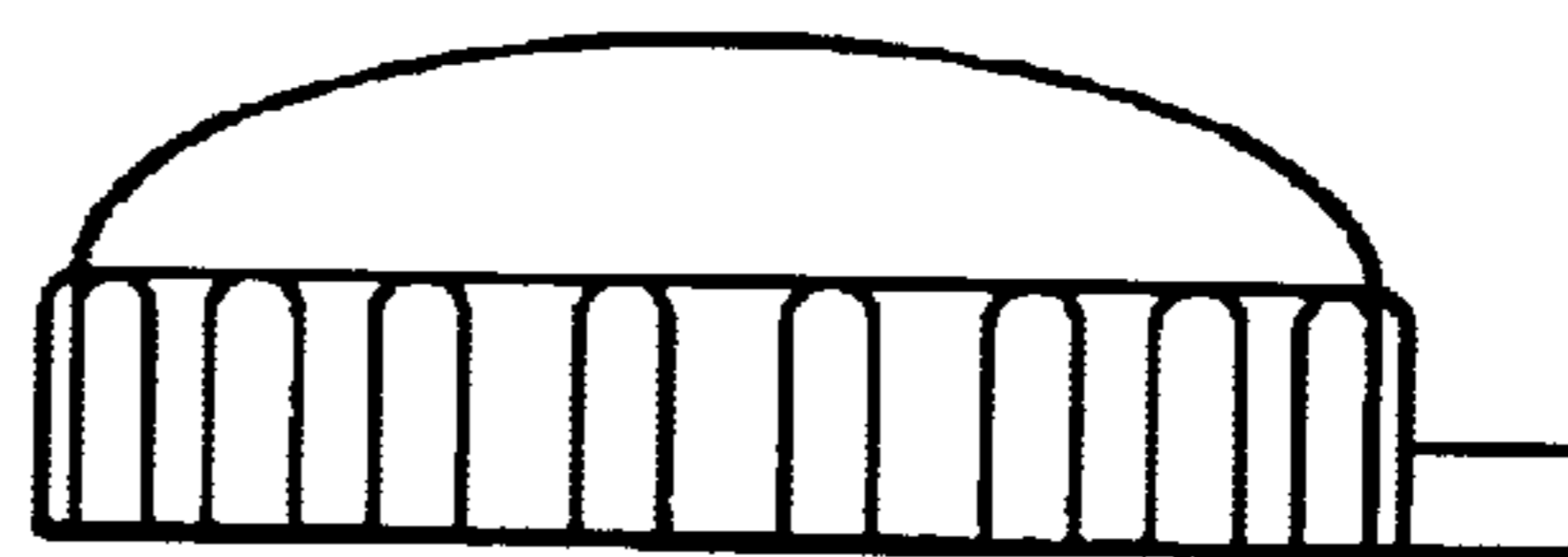
FIG. 1 is a top view of the bottle cap opener;

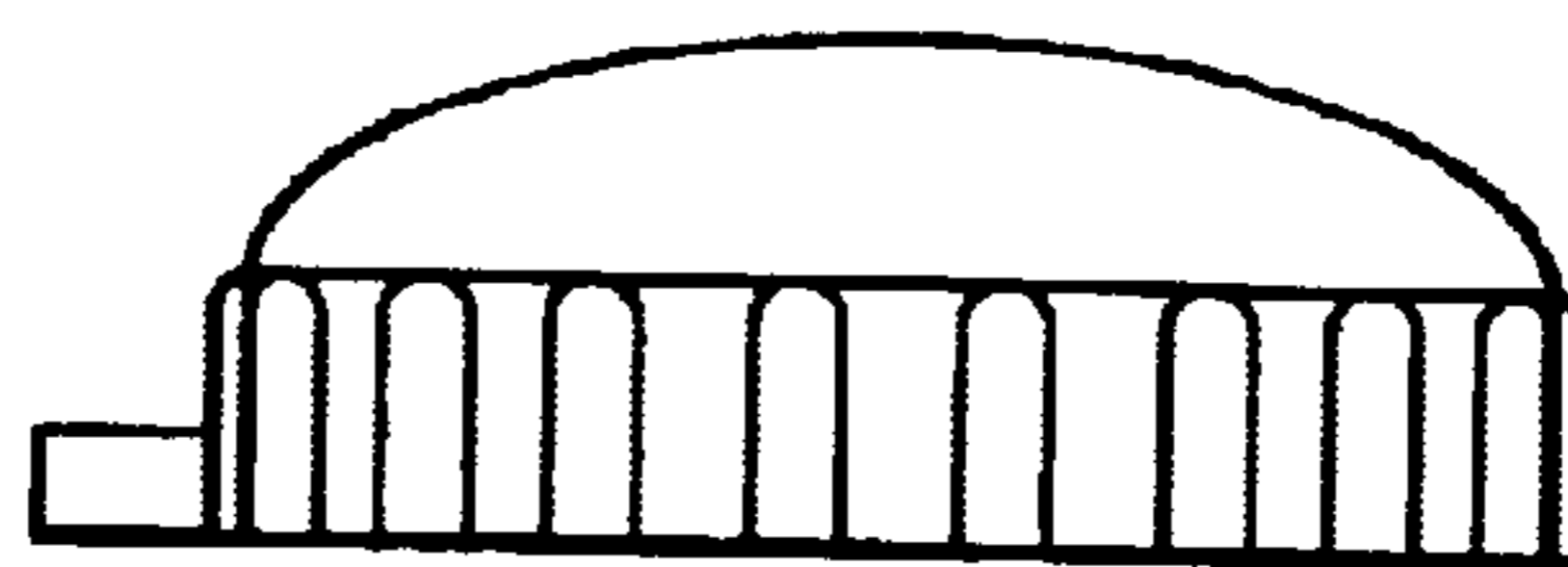




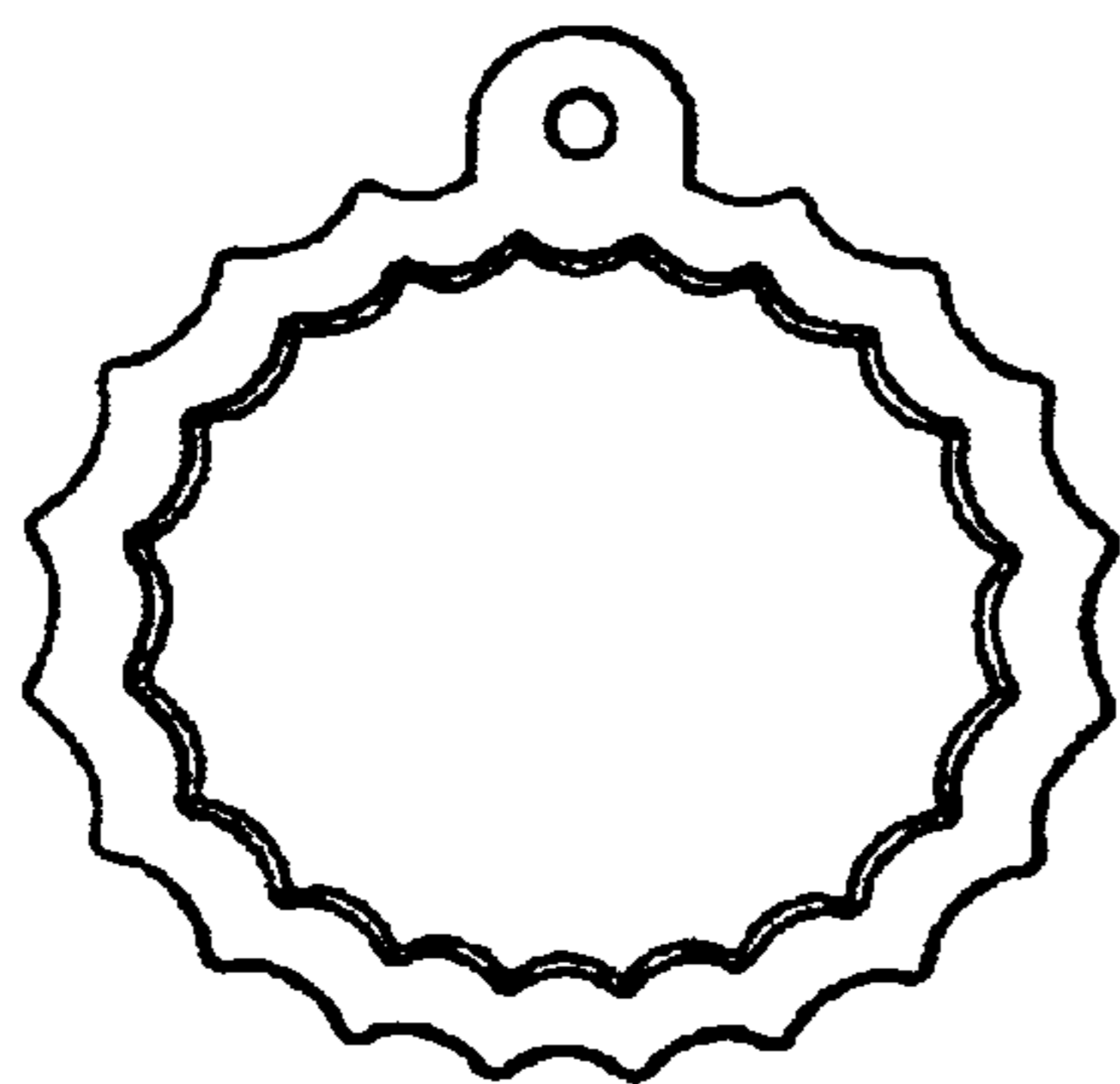

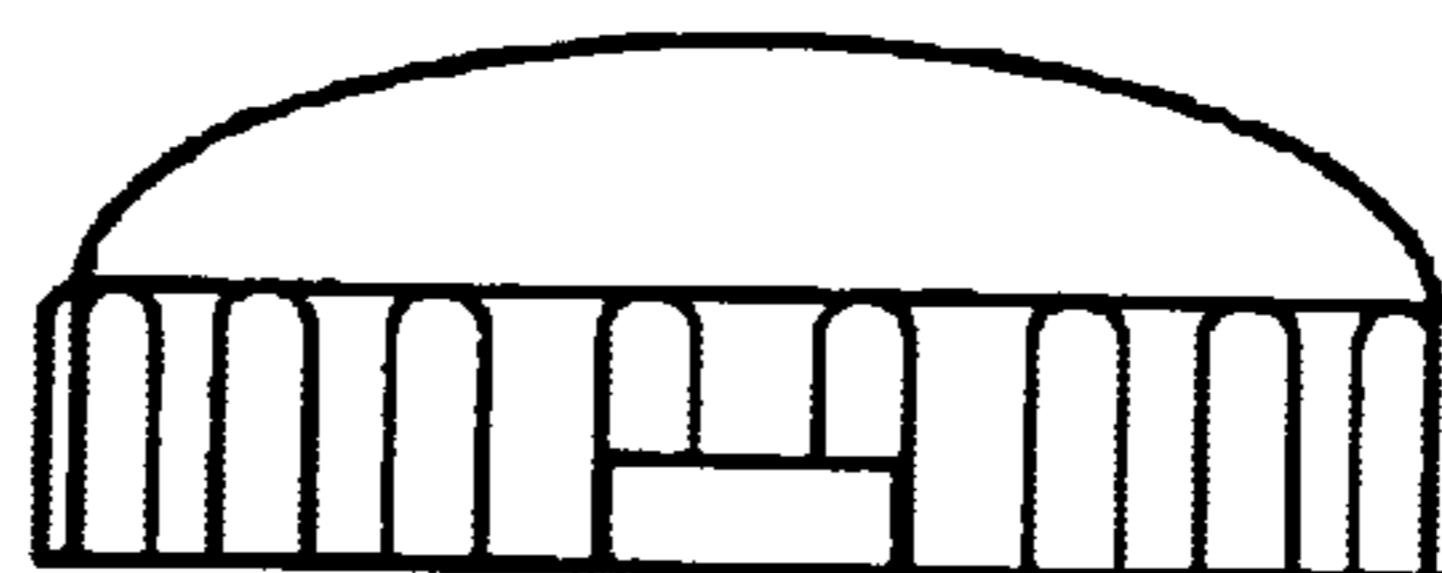

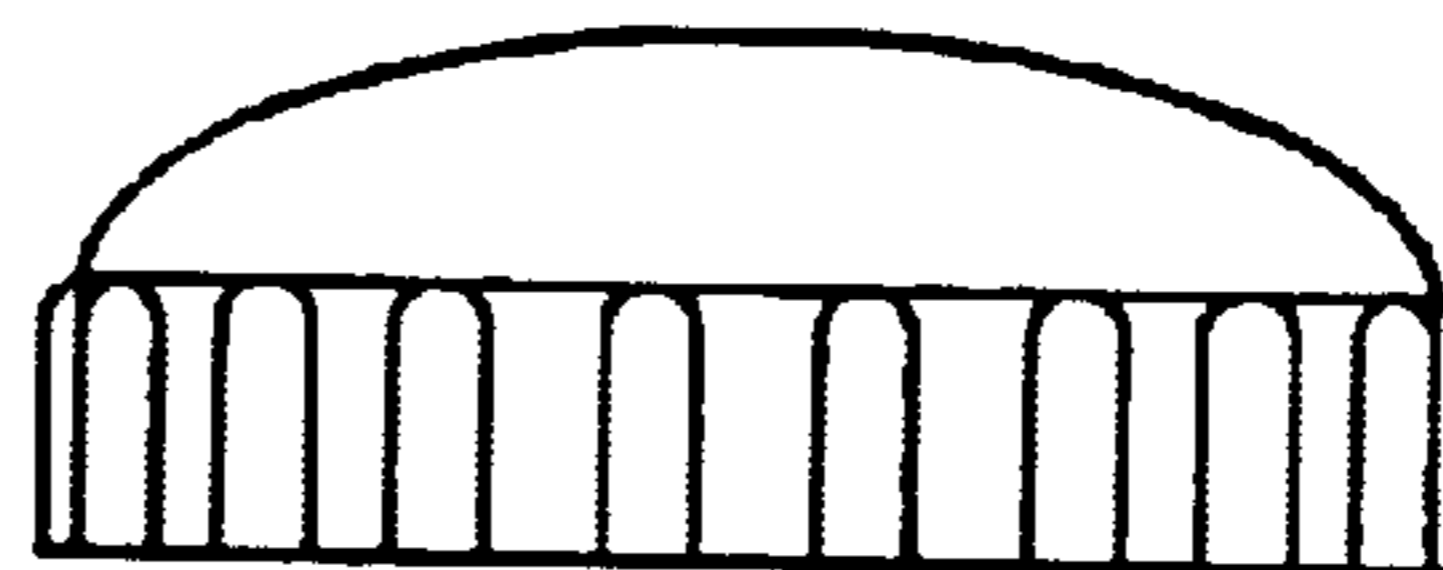

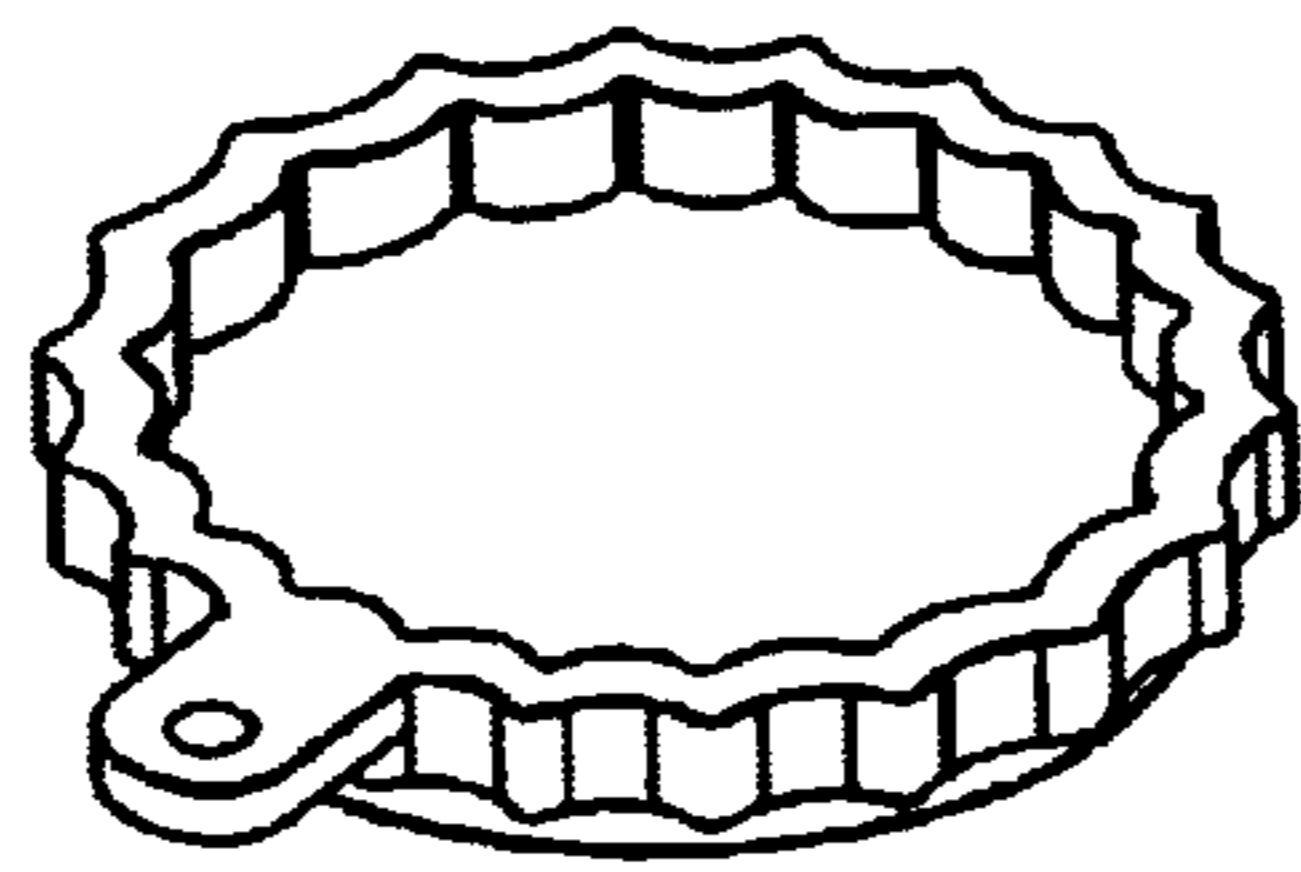

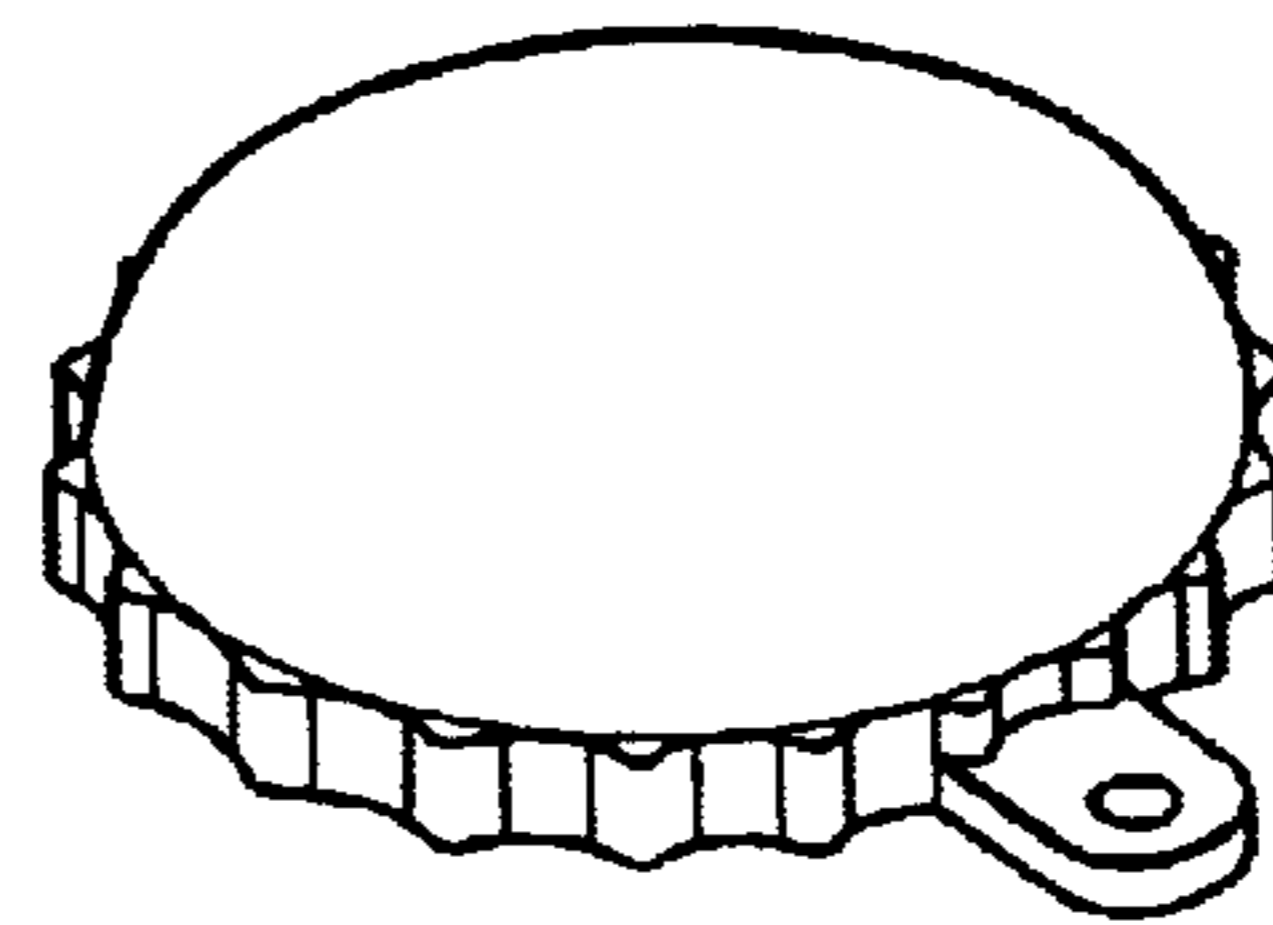
