DESCRIPTION

FIG. 1 is a front elevational view of the mobile POS embodying our new design;

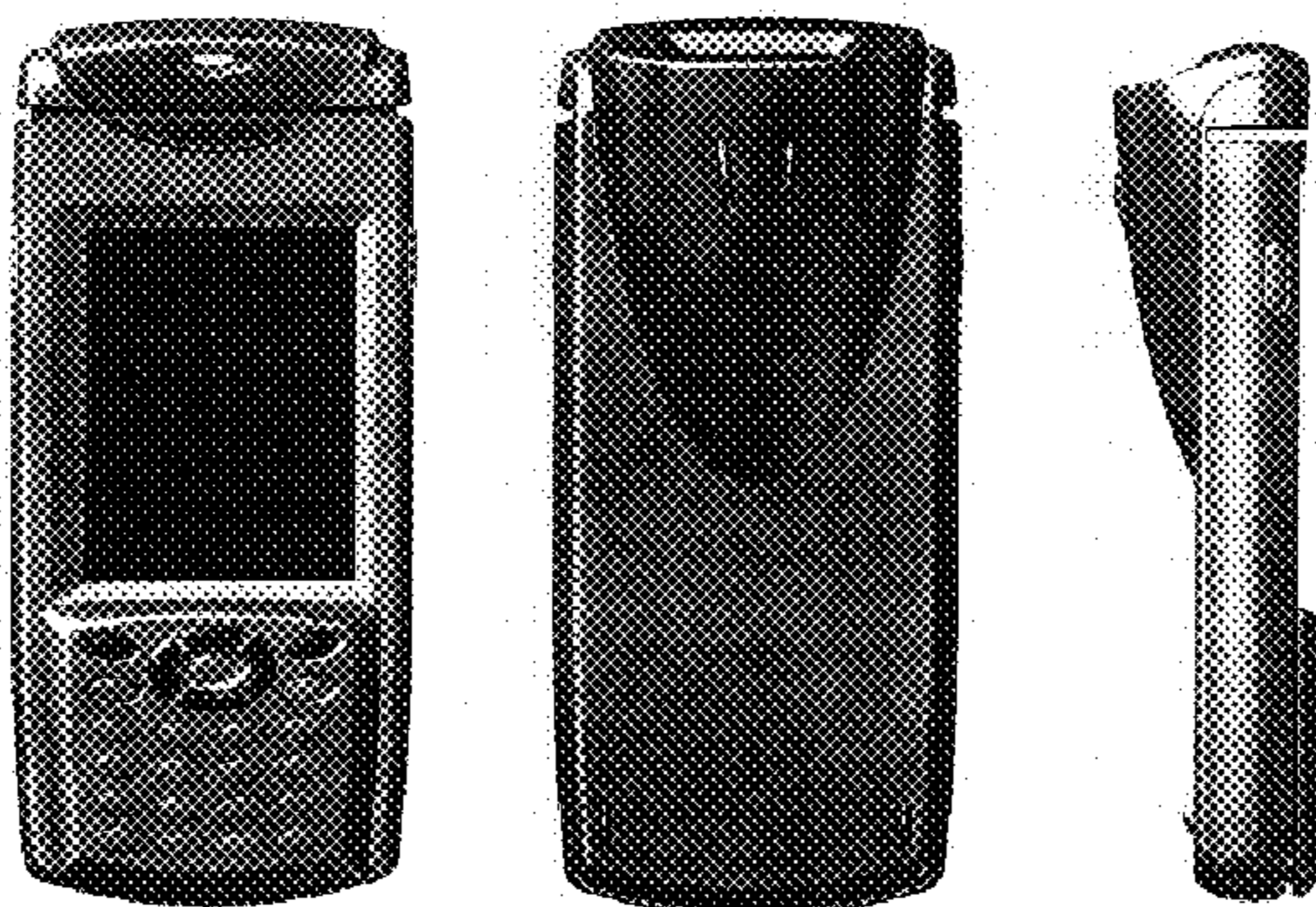

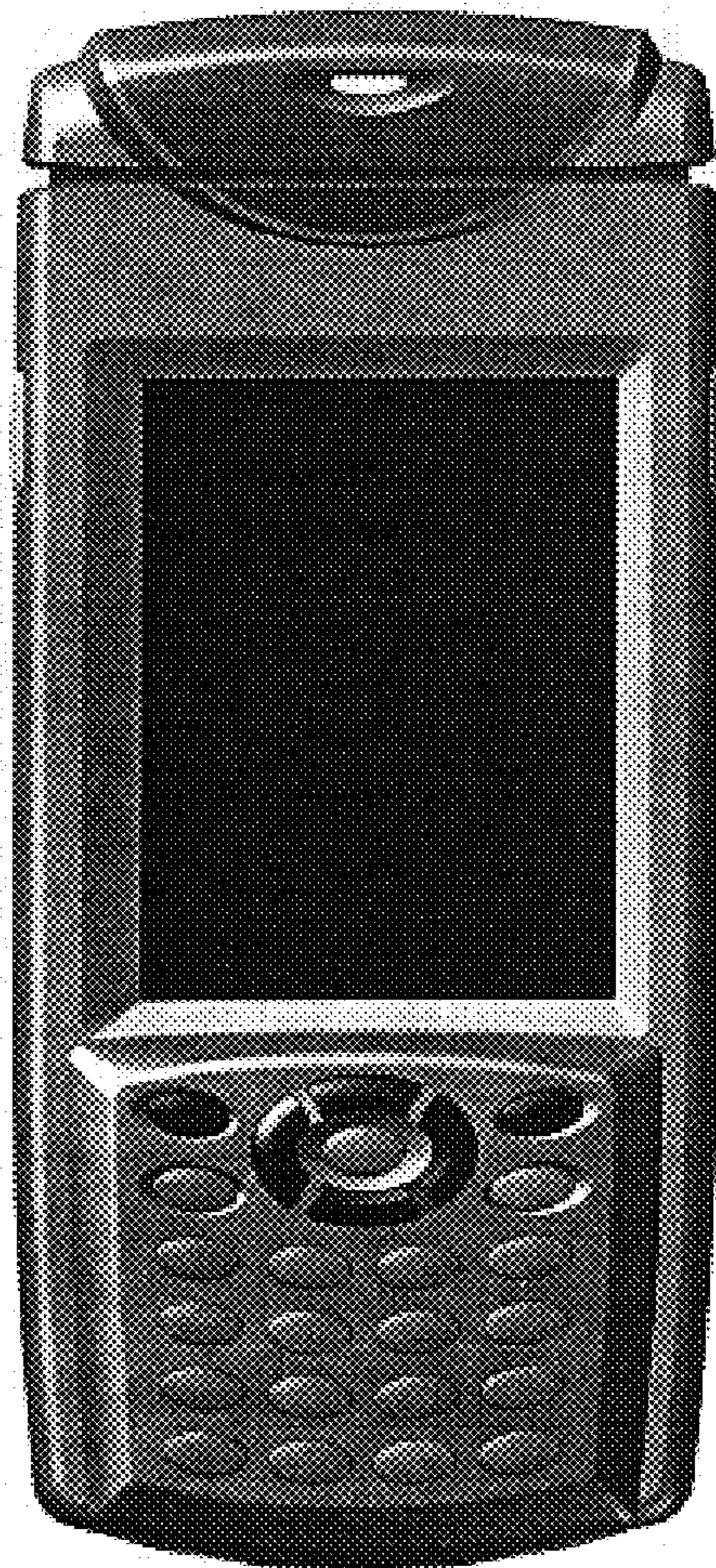

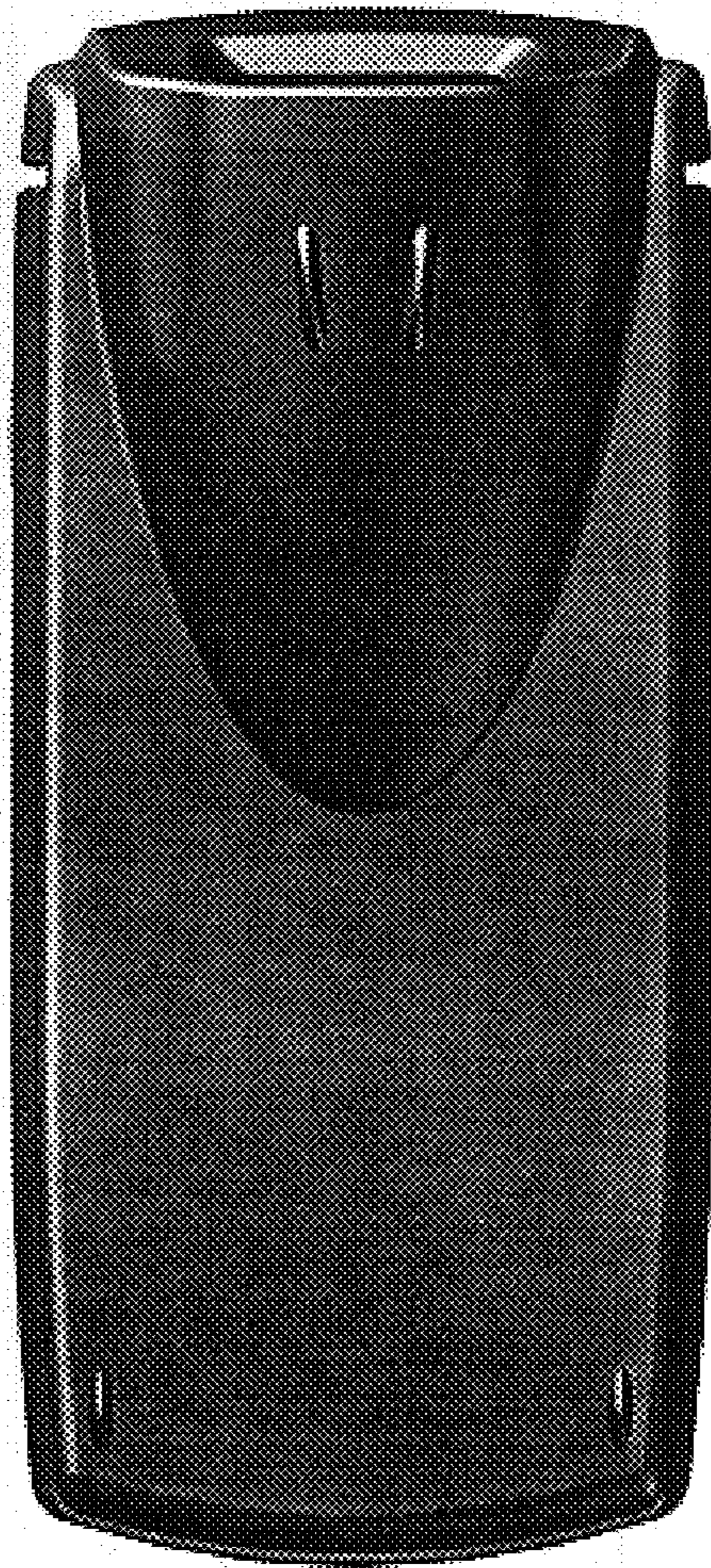

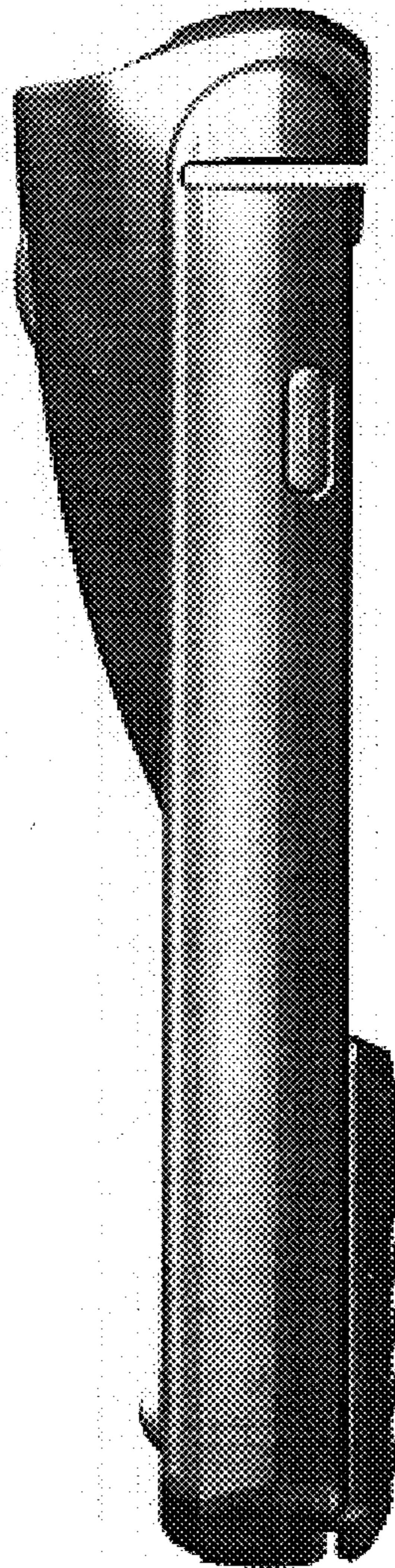

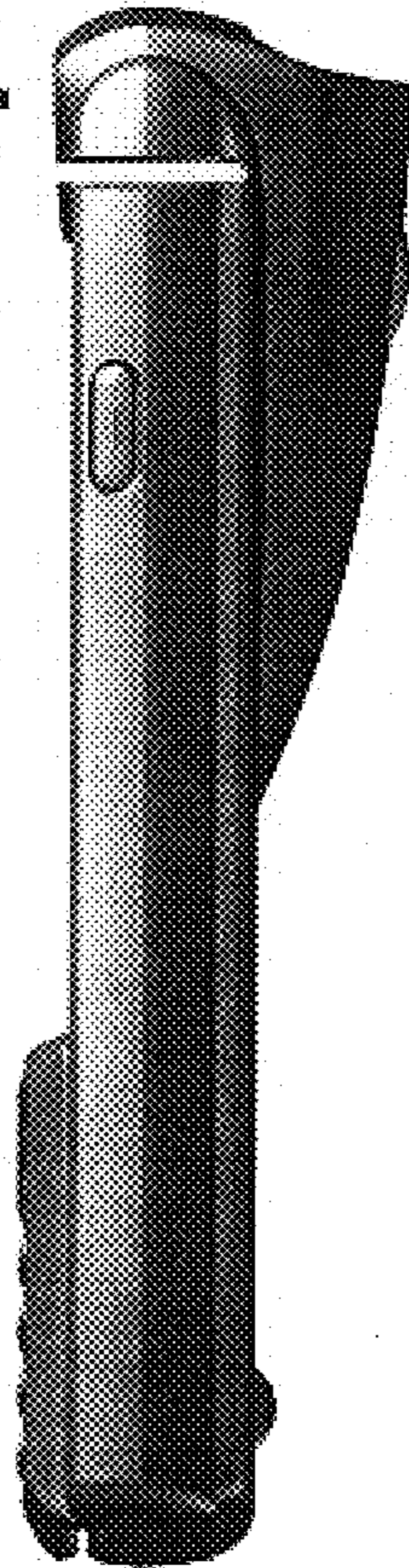

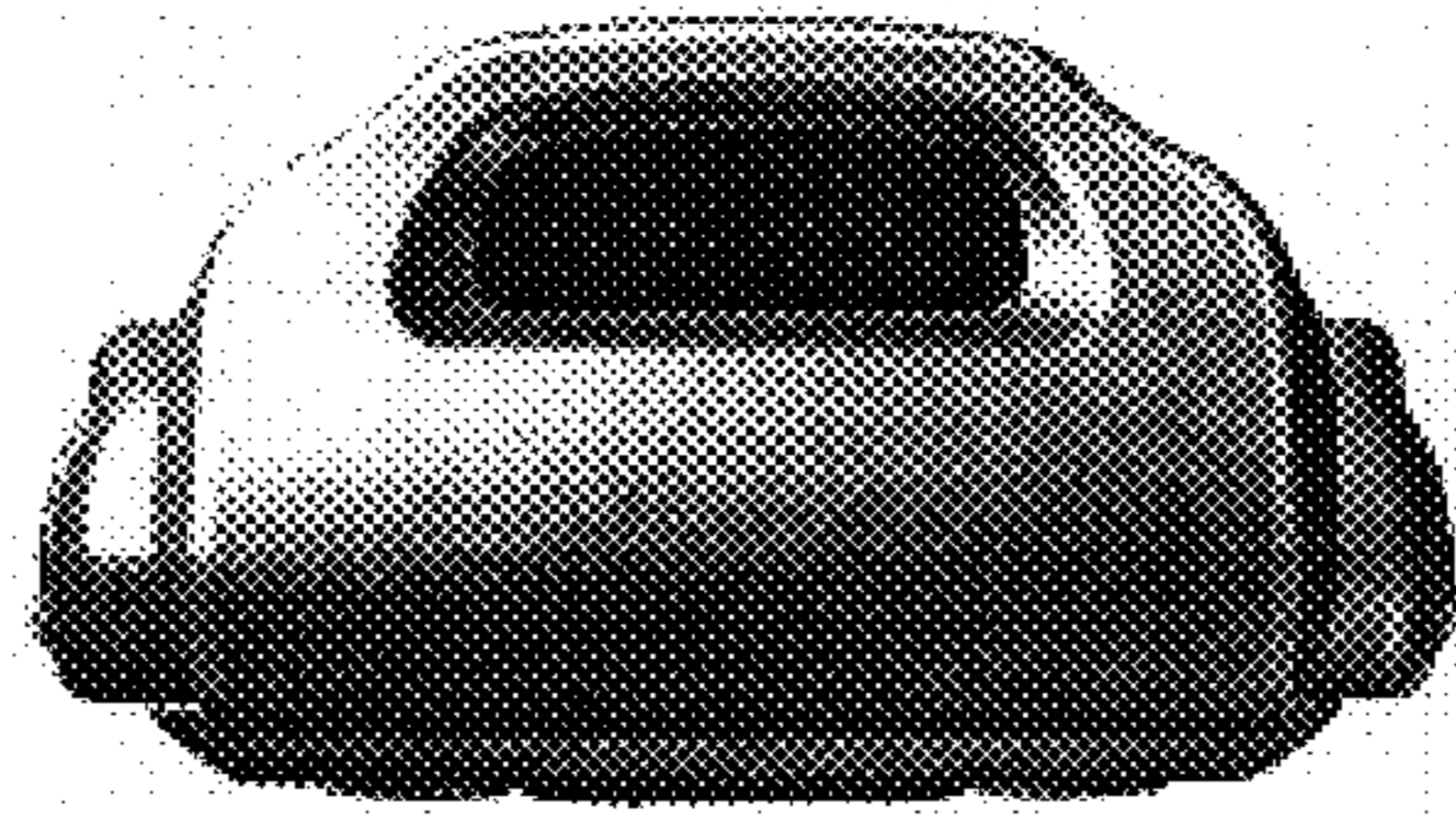

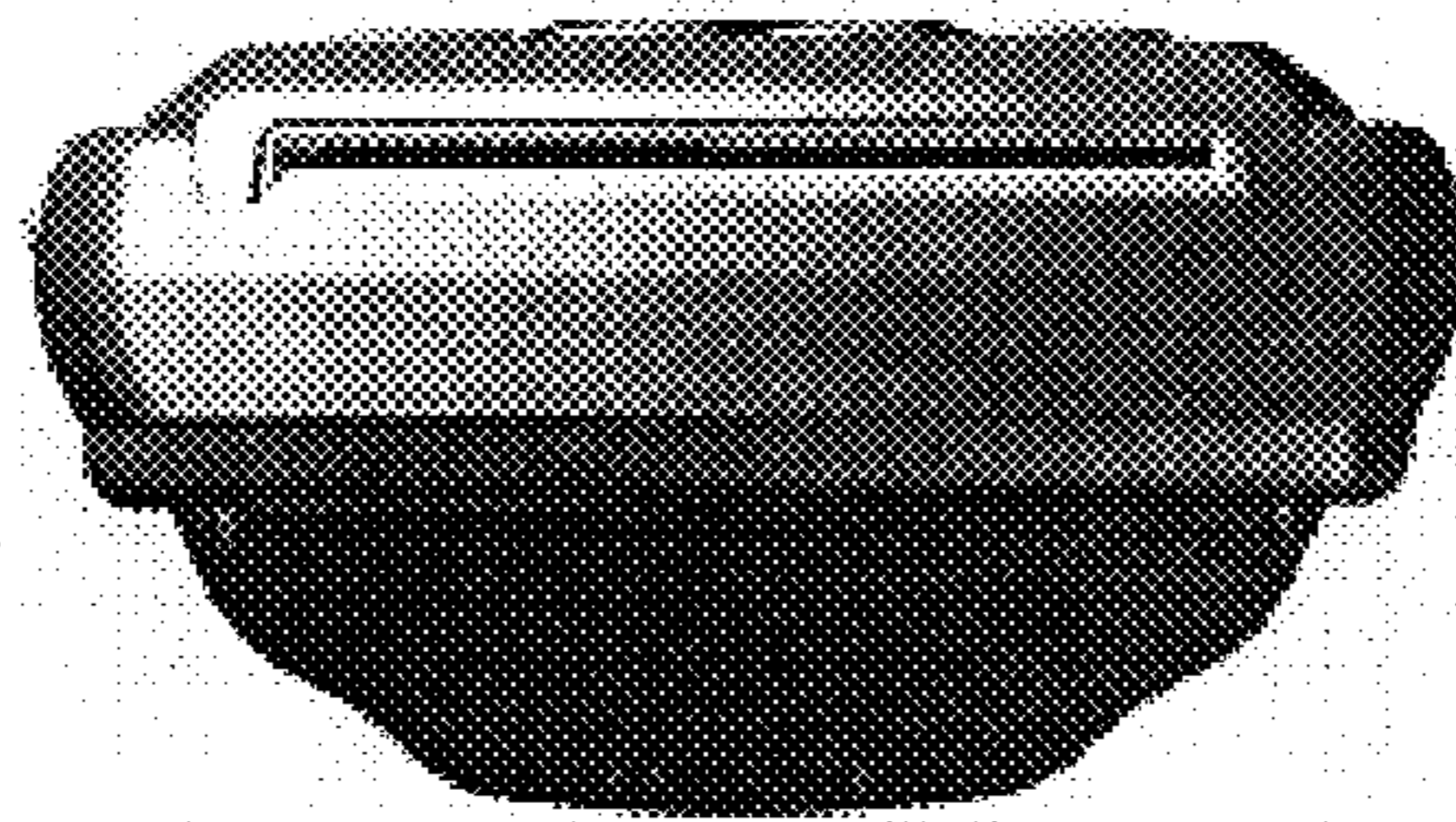
