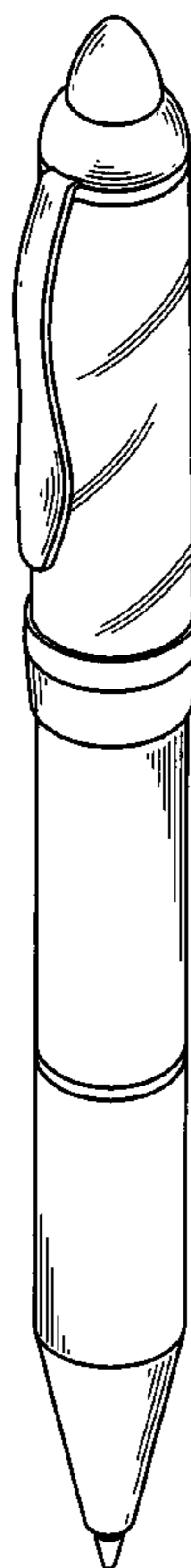
(57) **CLAIM**

The ornamental design for a light pen with stylus for PDA, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a light pen with stylus for PDA showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a second perspective view of the light pen with stylus for PDA, the ornaments depicted by means of broken lines being shown for illustrative purposes only and forming no part of the claimed design.

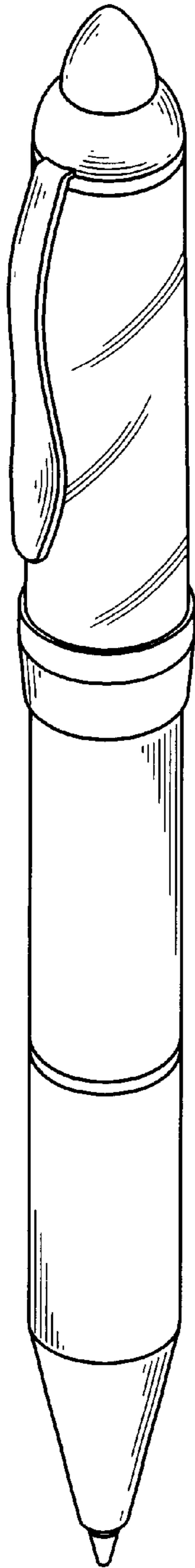

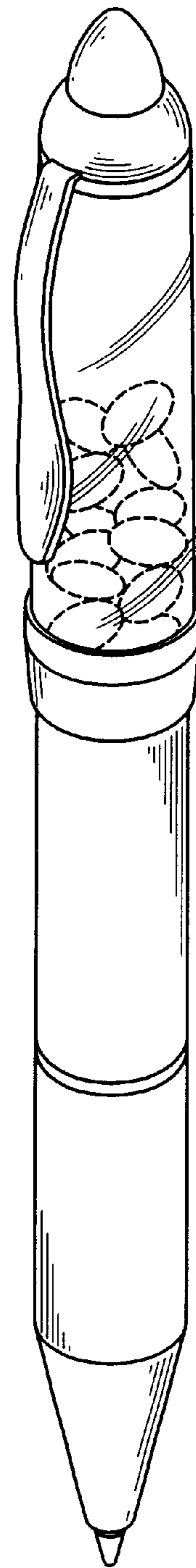

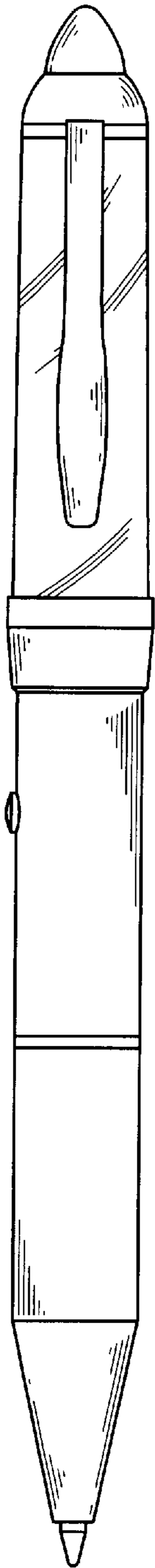

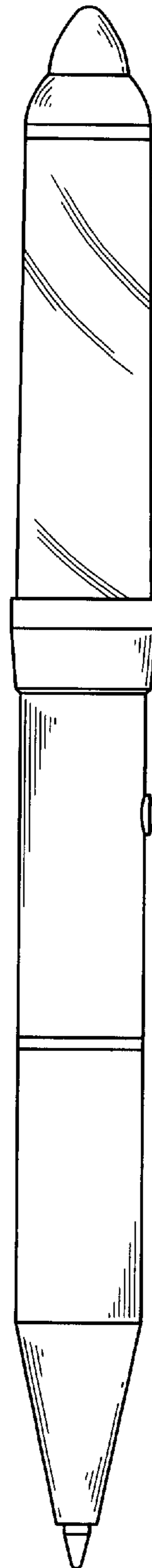

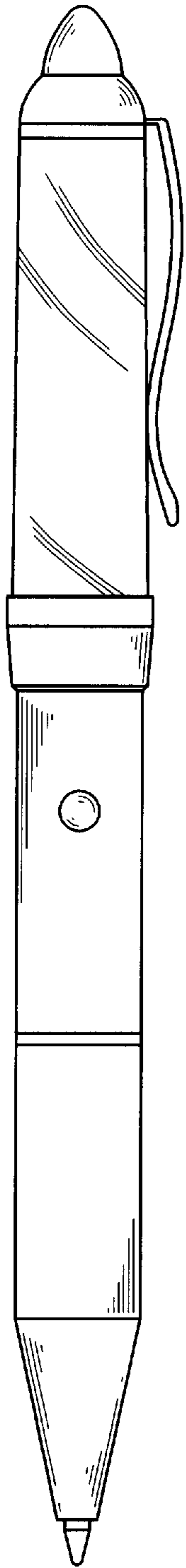

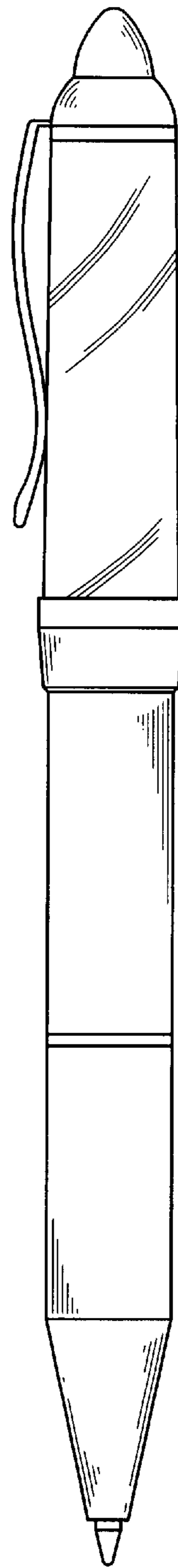

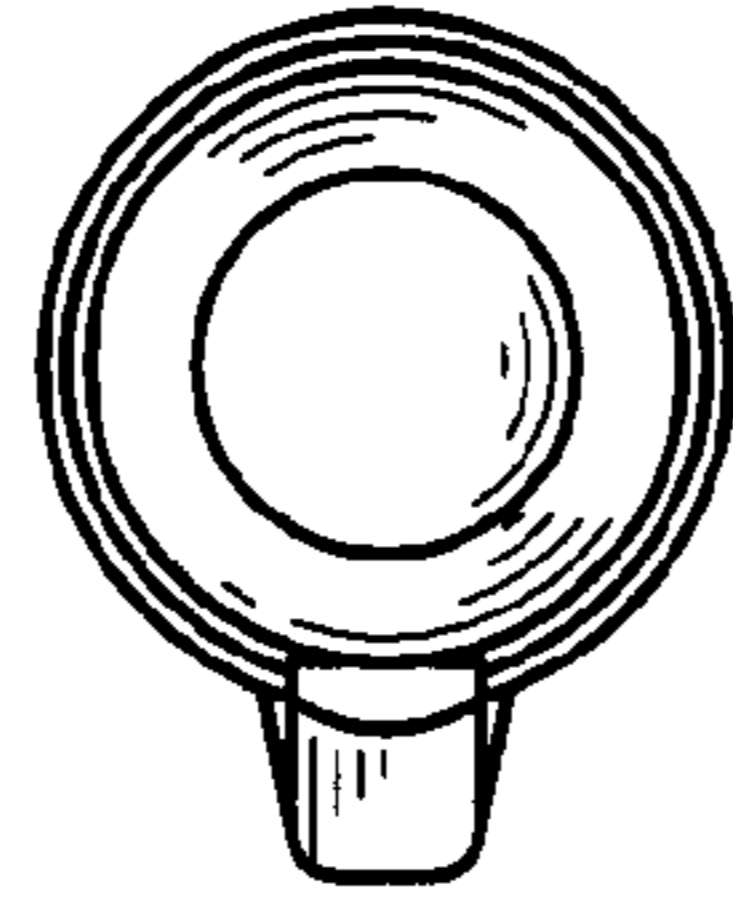

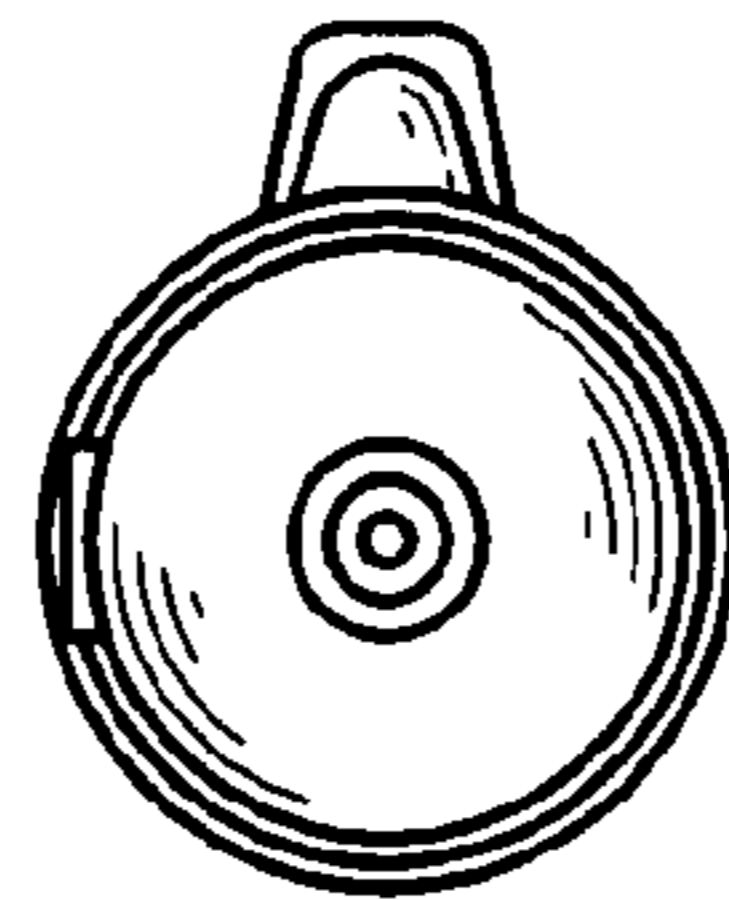
