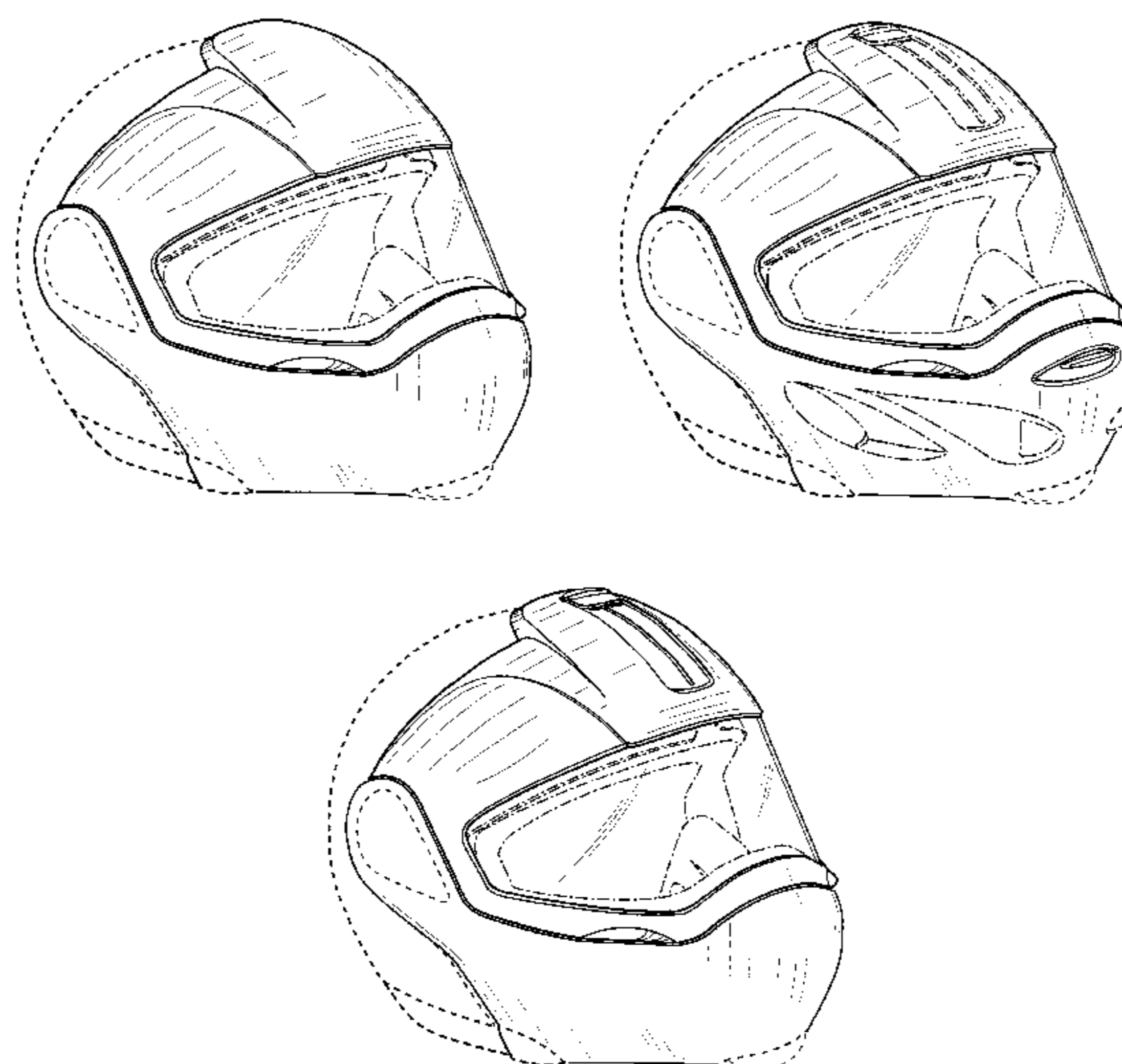
(57) **CLAIM**

I claim the ornamental design for a full-face helmet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a full-face helmet showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a rear elevation view thereof;
FIG. 8 is a front perspective view of a second embodiment thereof;
FIG. 9 is a front elevation view of FIG. 8;
FIG. 10 is a top plan view of FIG. 8;
FIG. 11 is a right side elevation view of FIG. 8;
FIG. 12 is a left side elevation view of FIG. 8;
FIG. 13 is a bottom plan view of FIG. 8;
FIG. 14 is a rear elevation view of FIG. 8;
FIG. 15 is a front perspective view of a third embodiment thereof;
FIG. 16 is a front elevation view of FIG. 15;
FIG. 17 is a top plan view of FIG. 15;
FIG. 18 is a right side elevation view of FIG. 15;
FIG. 19 is a left side elevation view of FIG. 15;
FIG. 20 is a bottom plan view of FIG. 15; and,

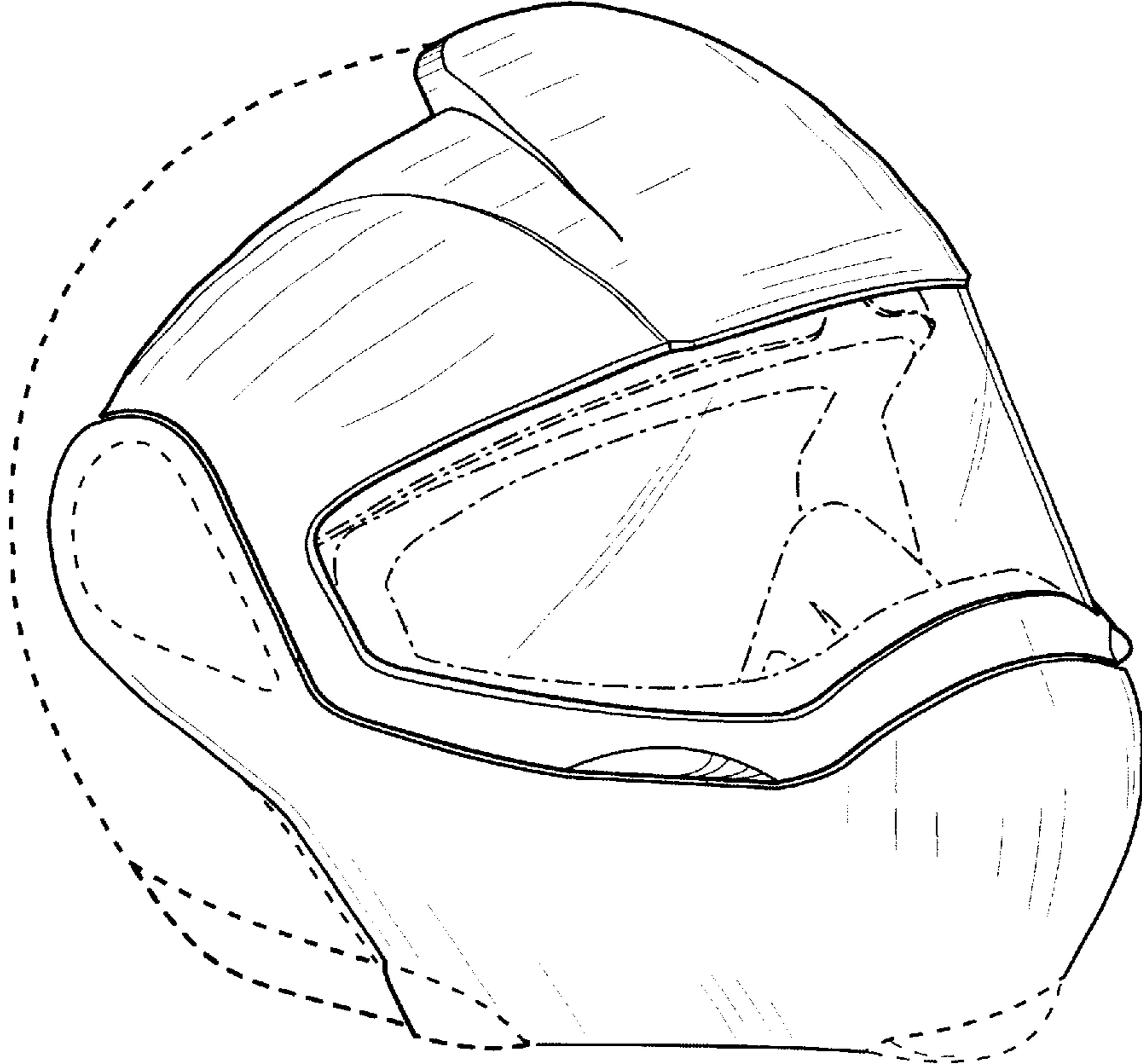

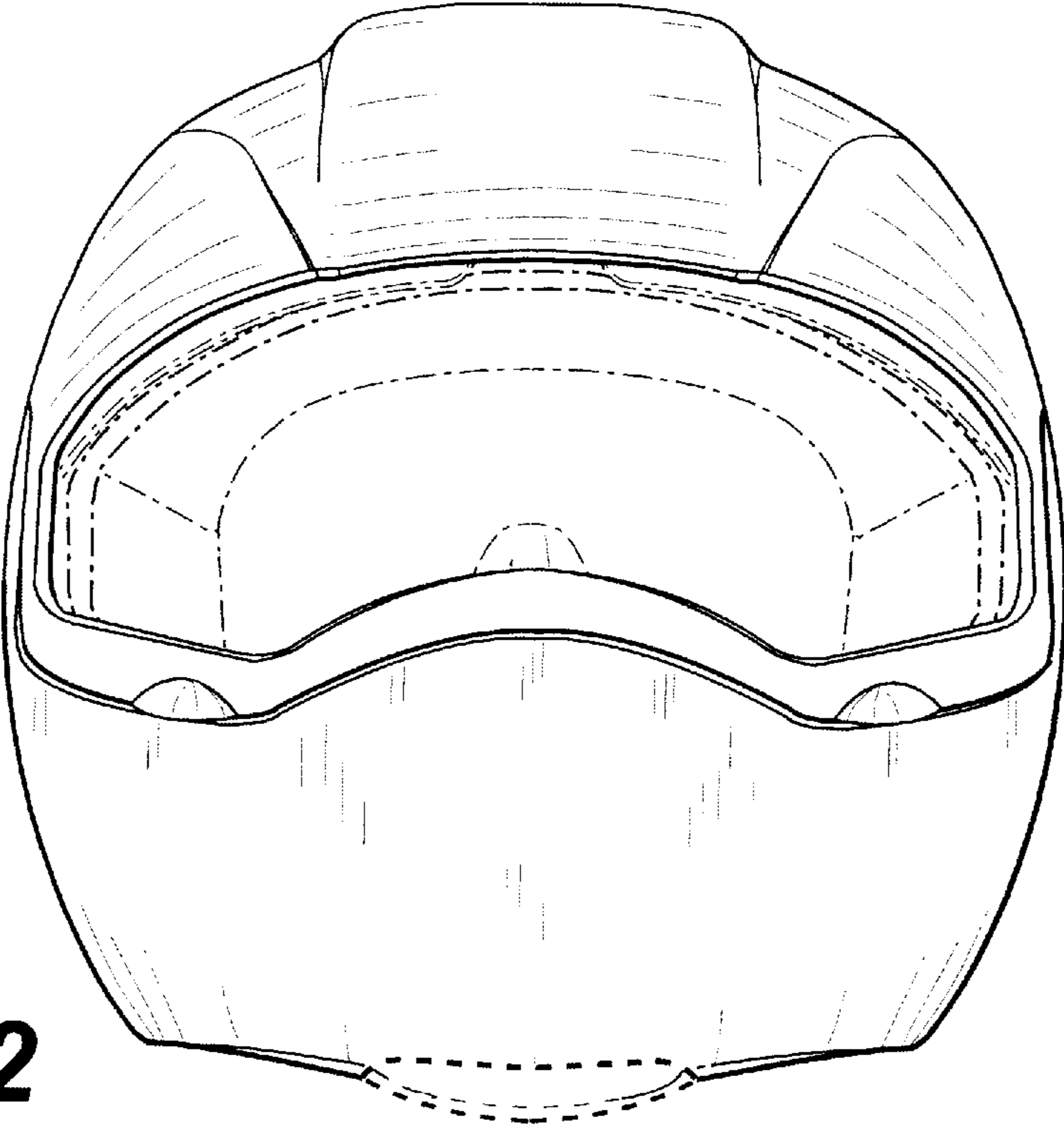

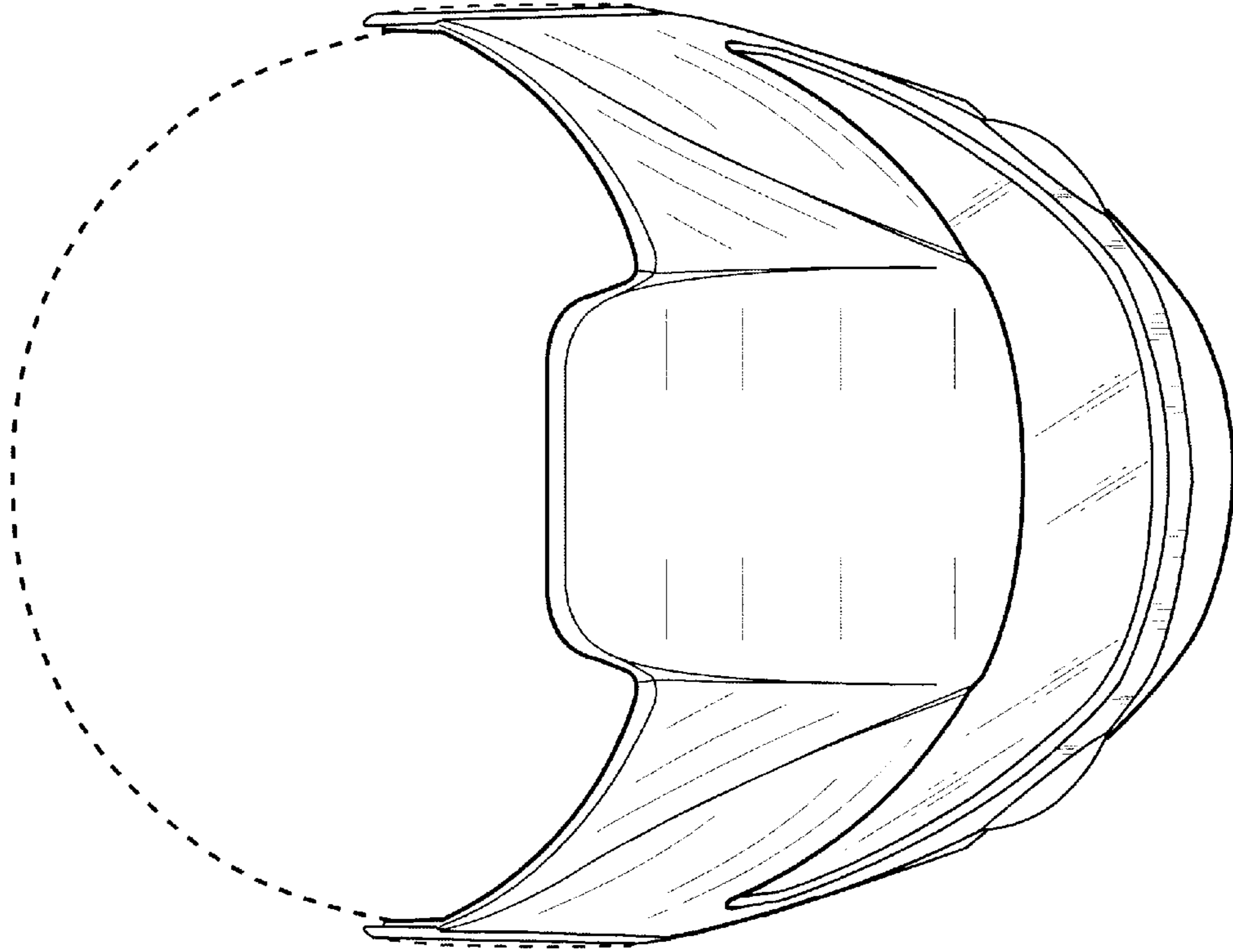

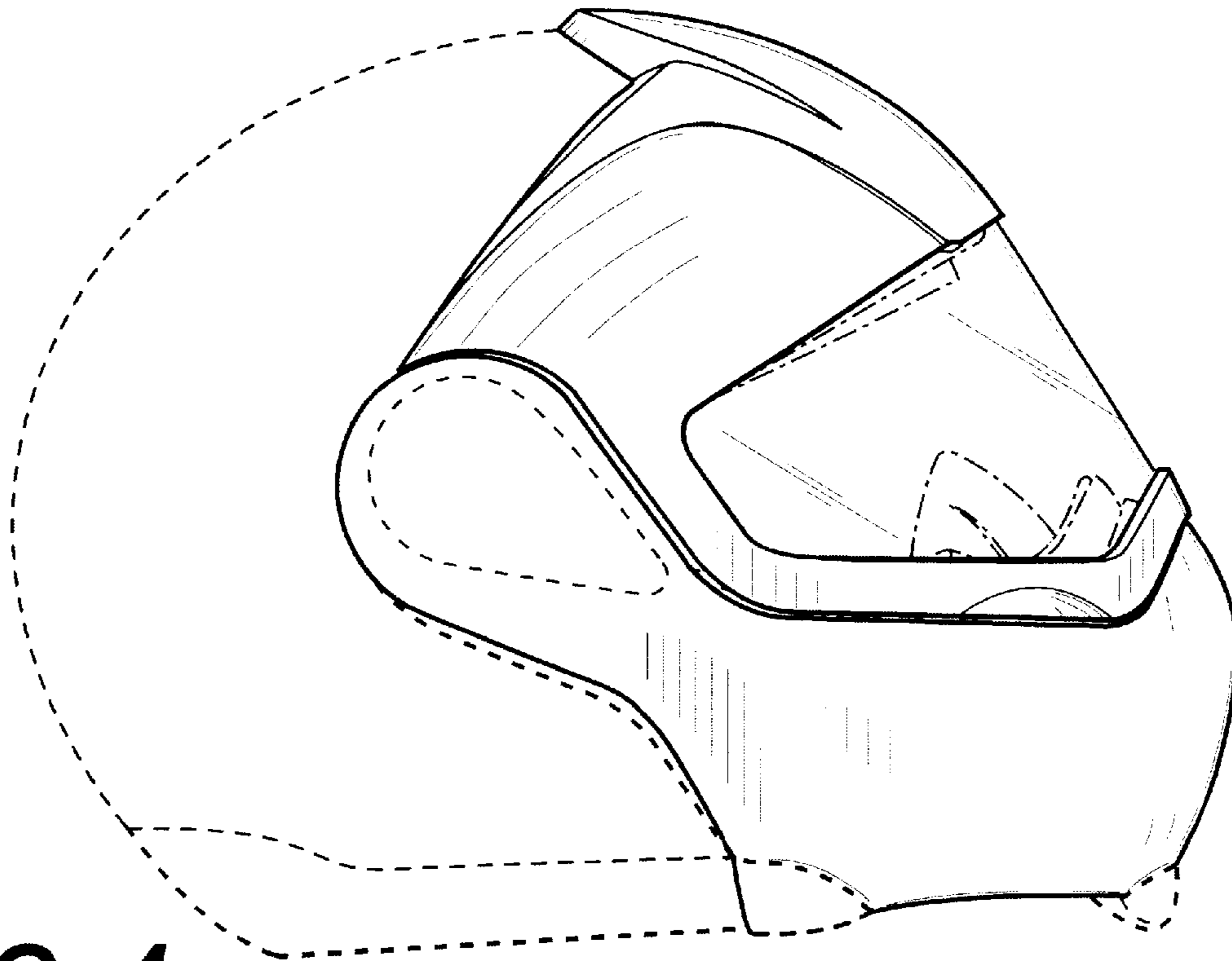

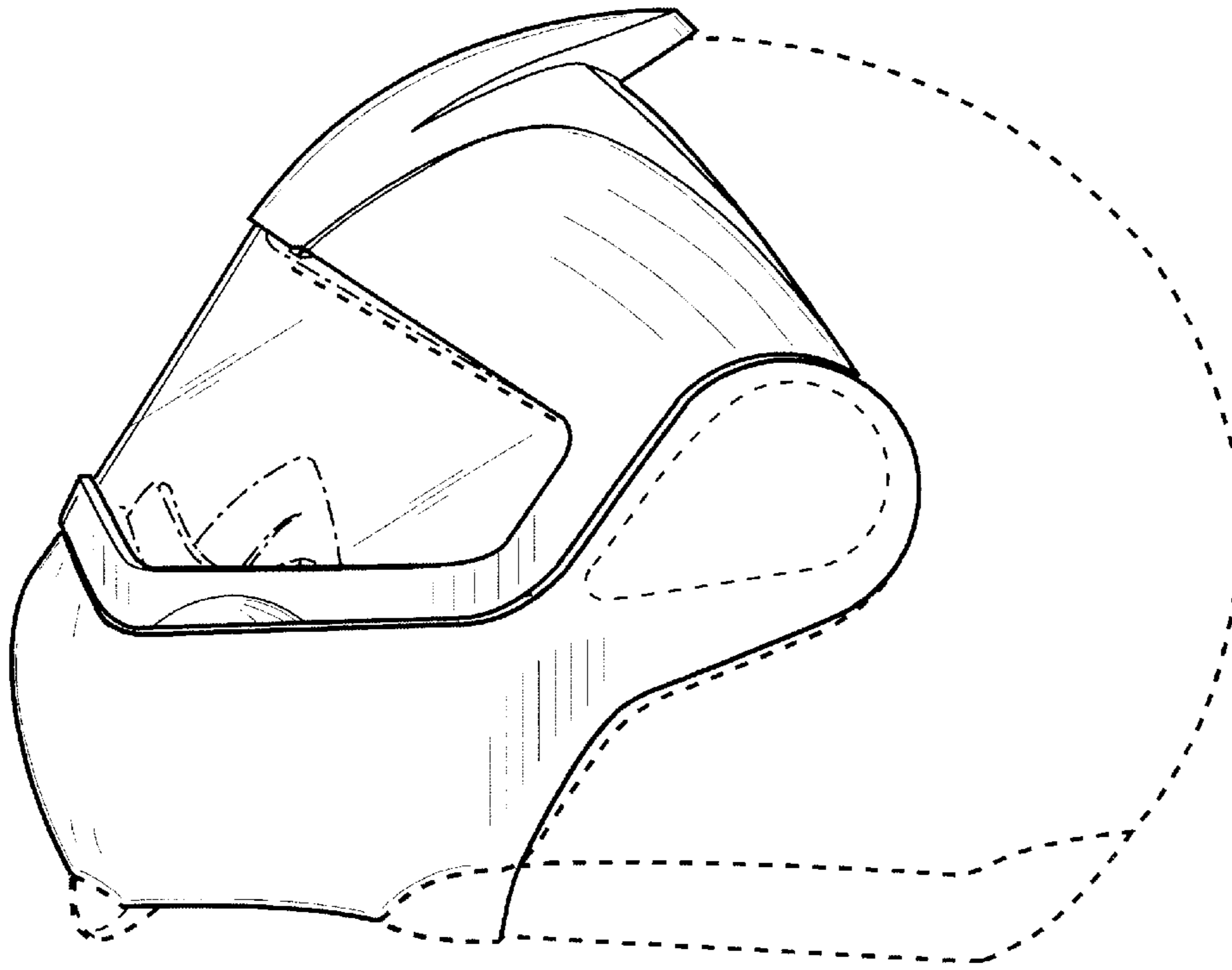

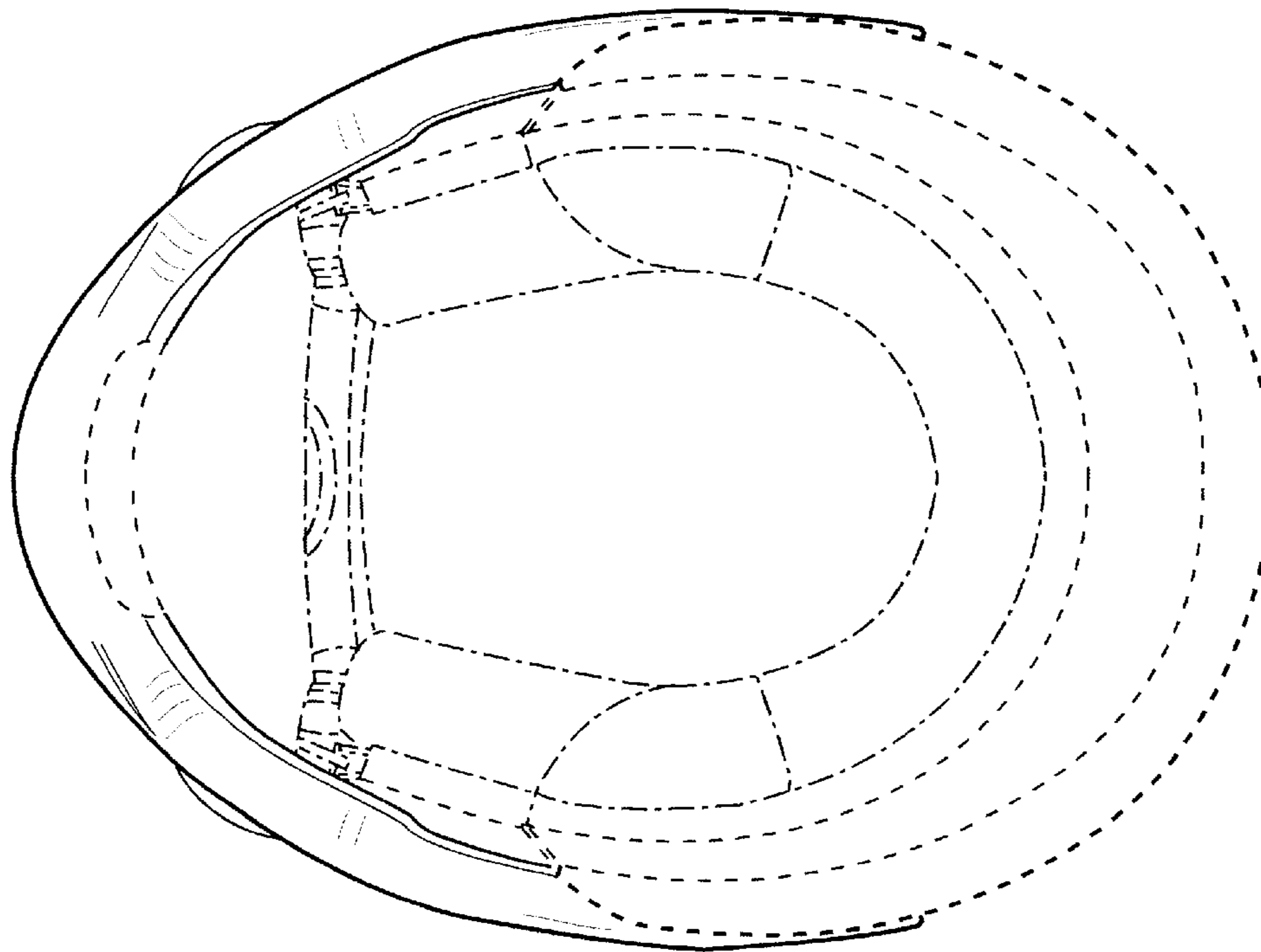

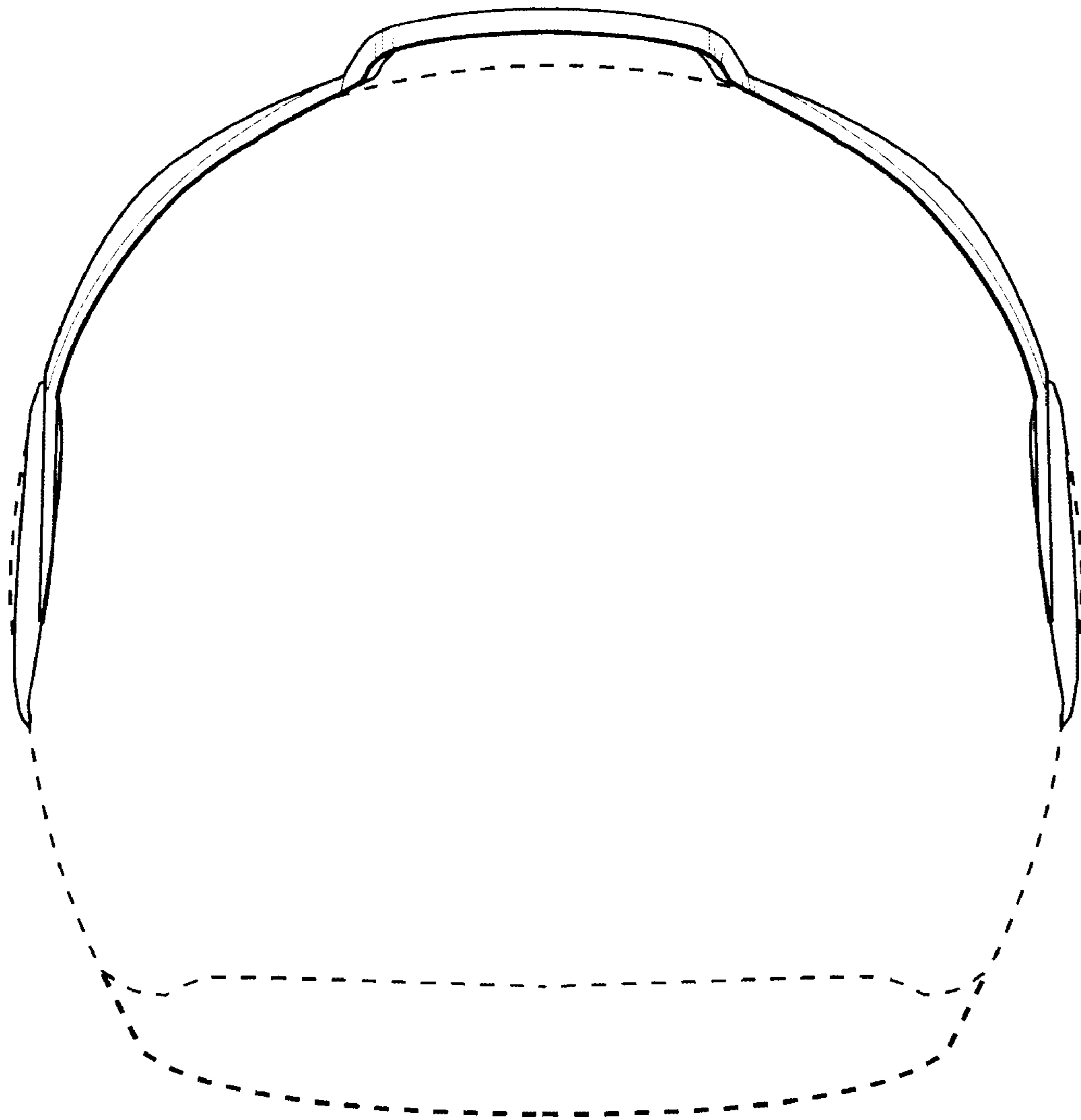

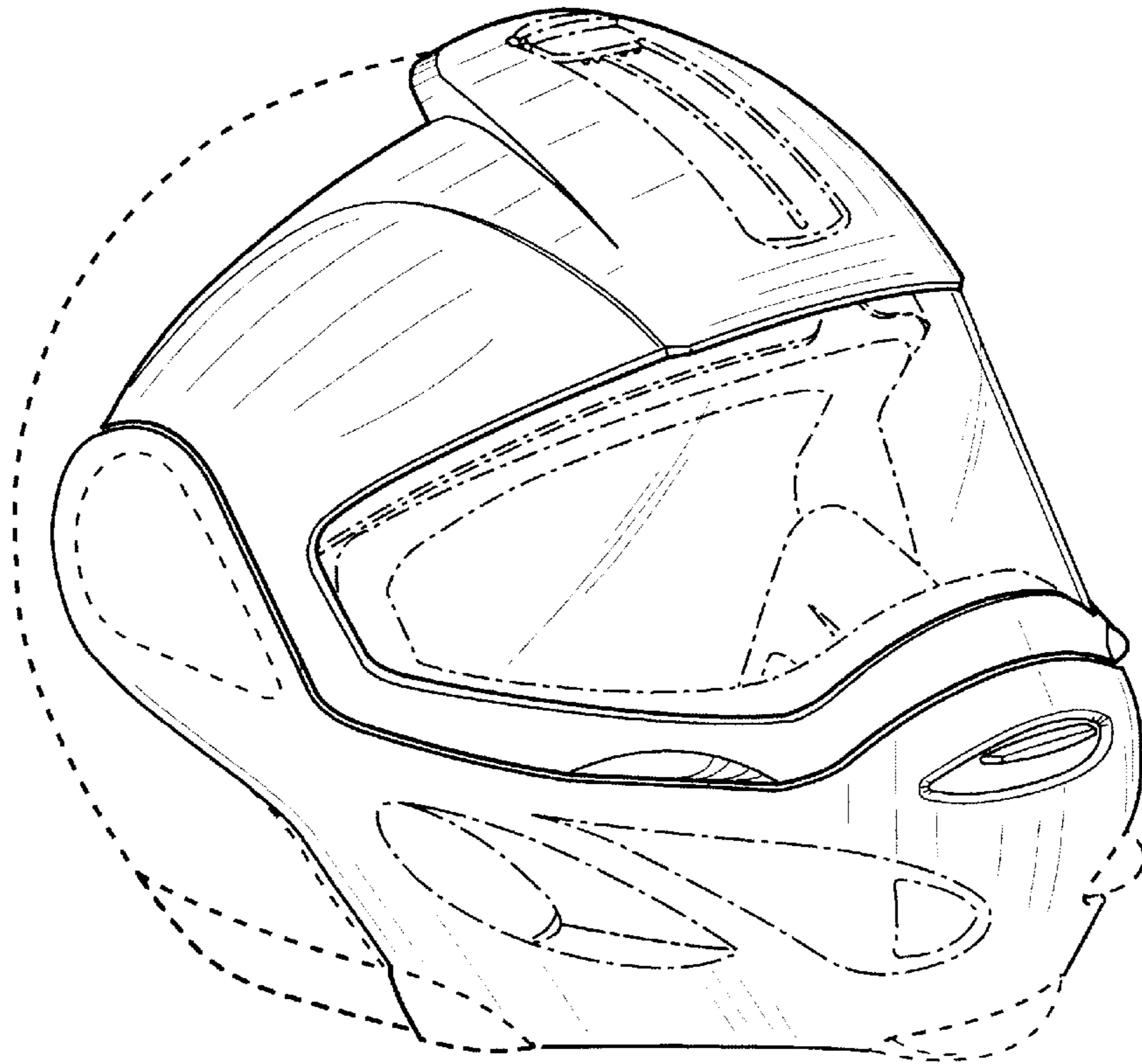

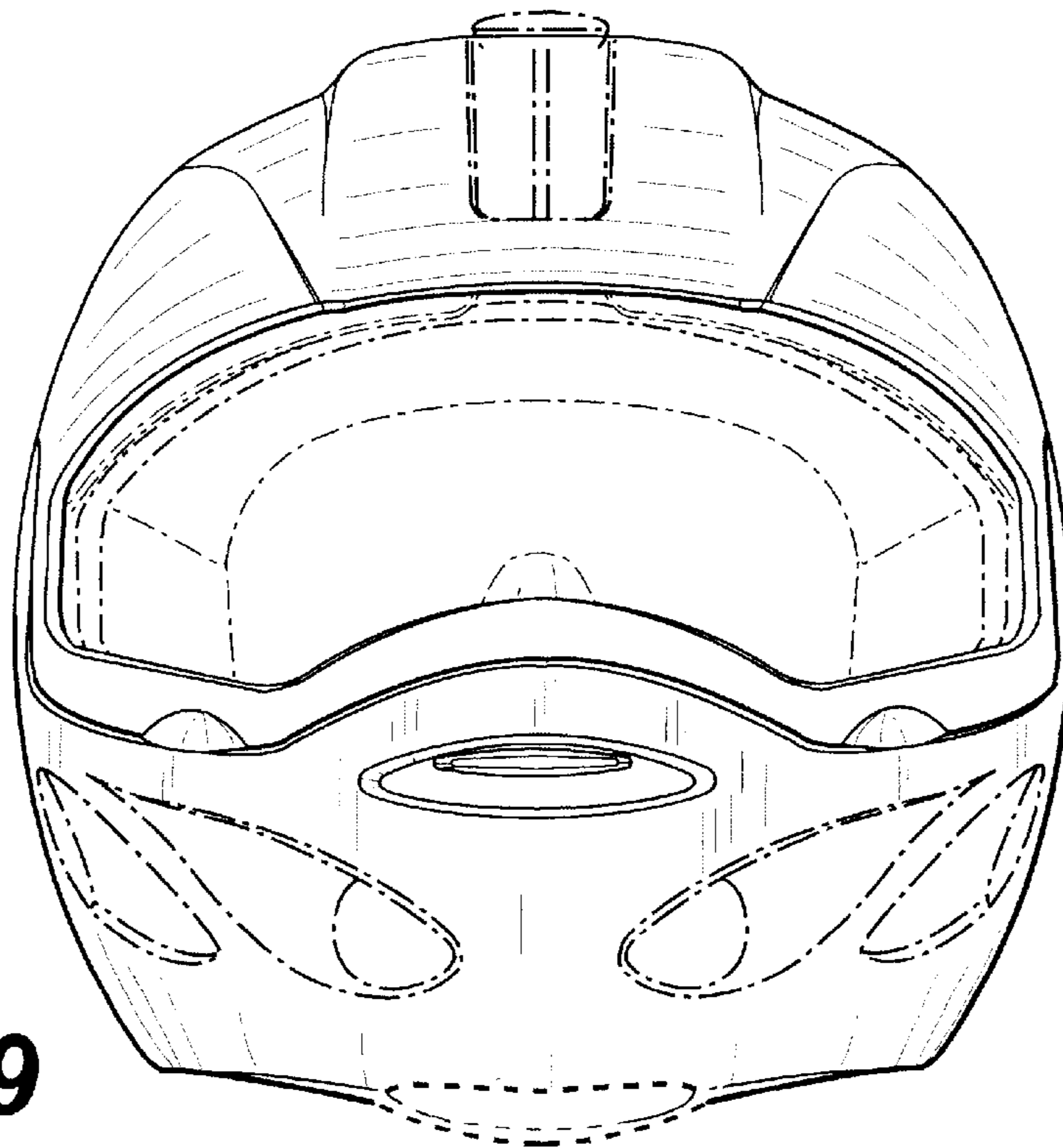

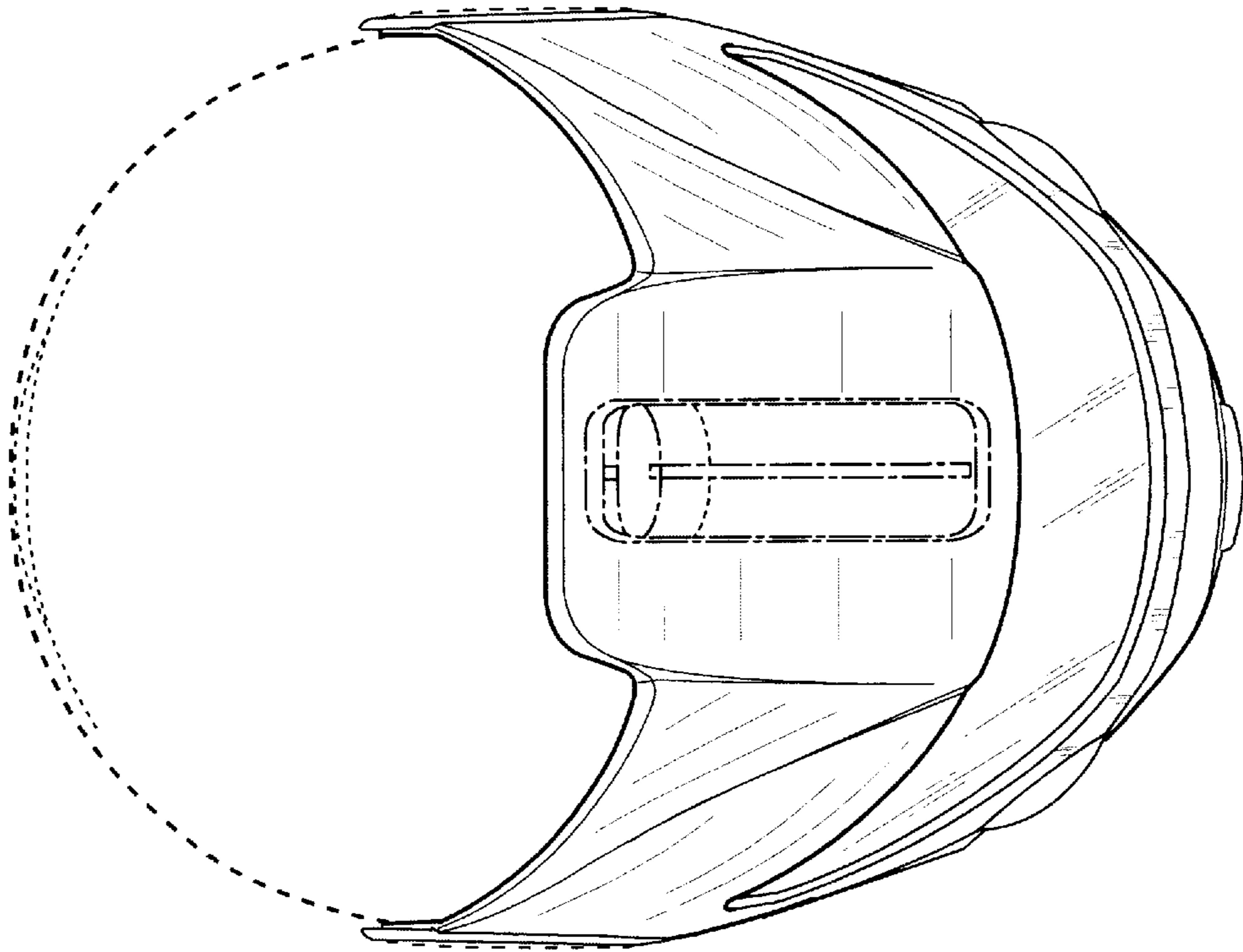

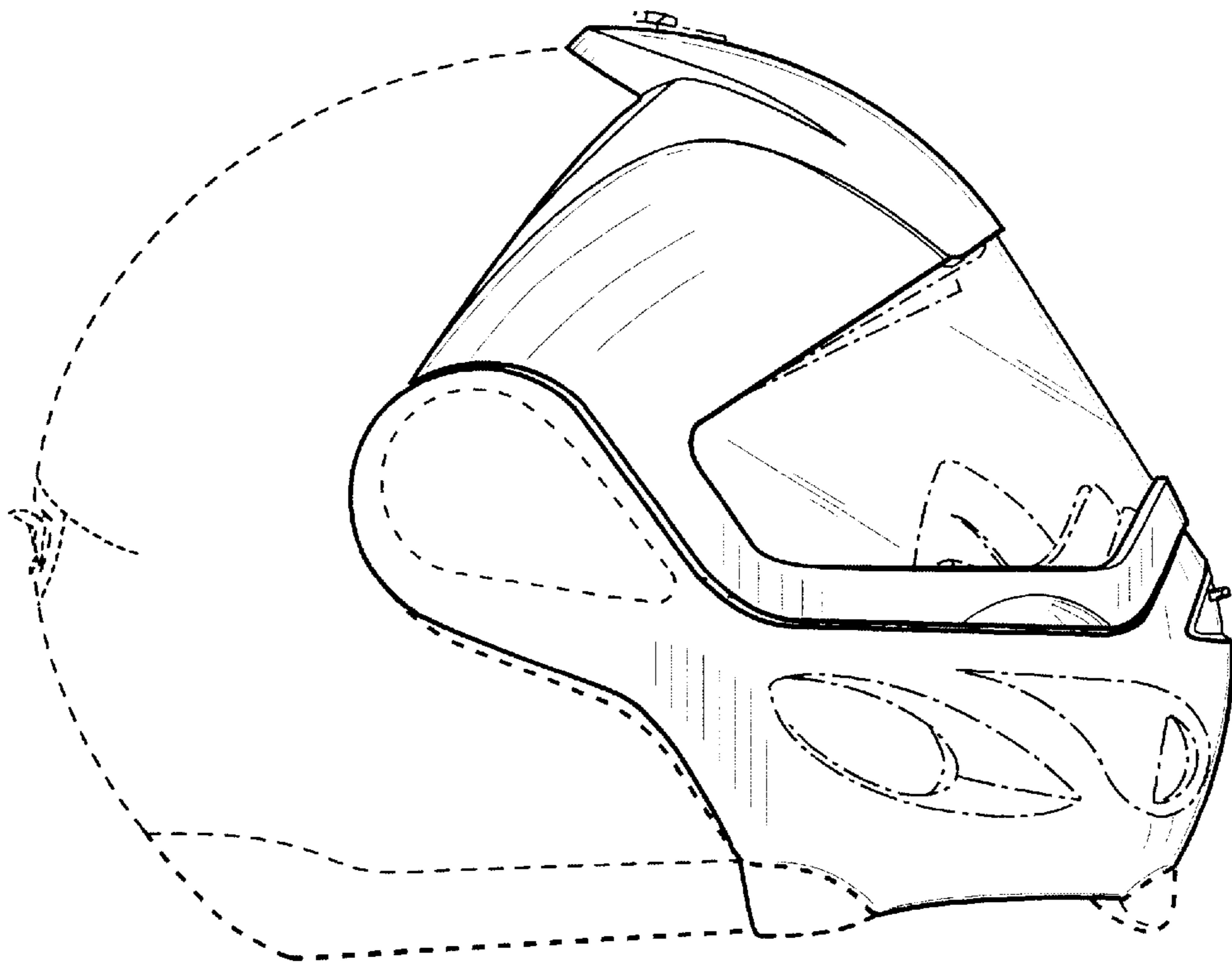

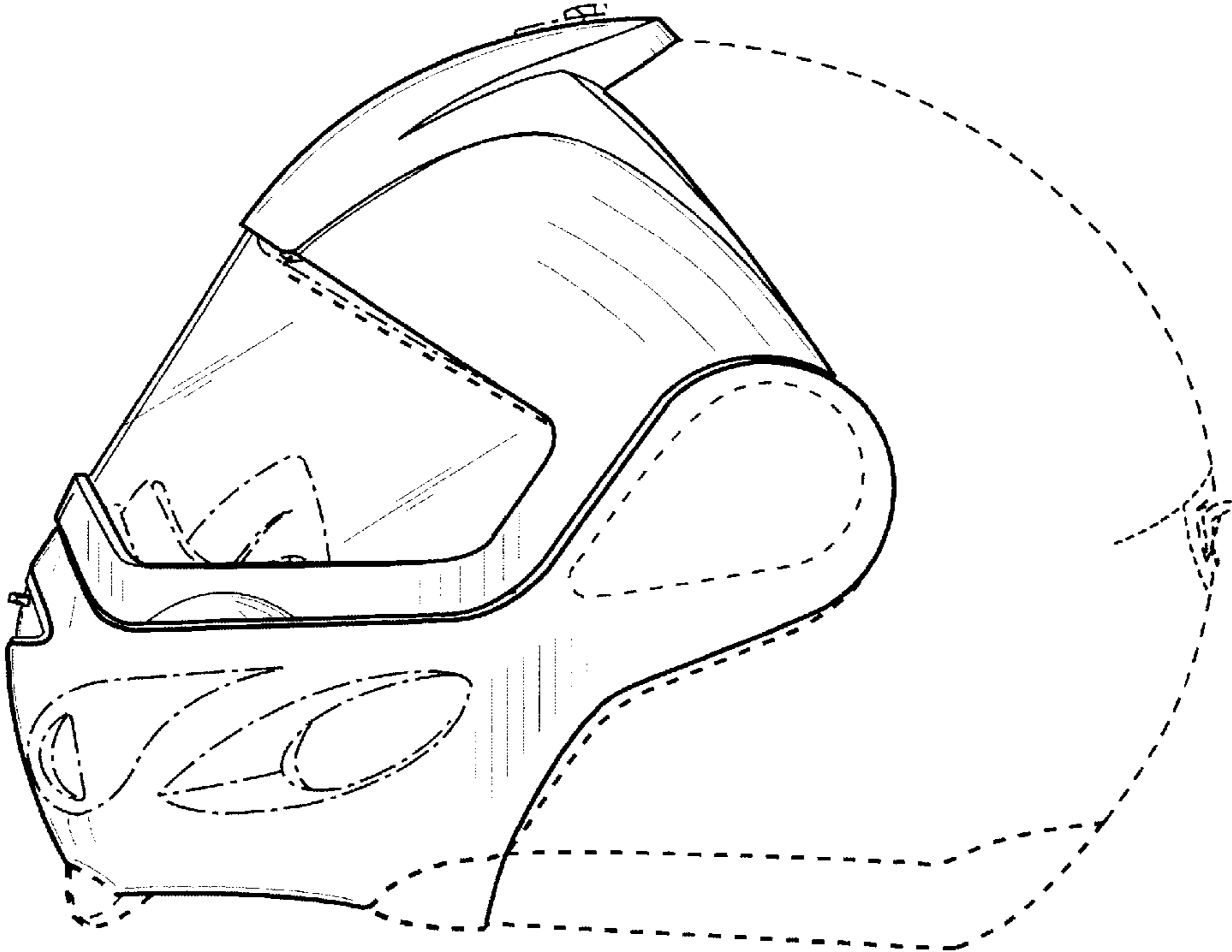

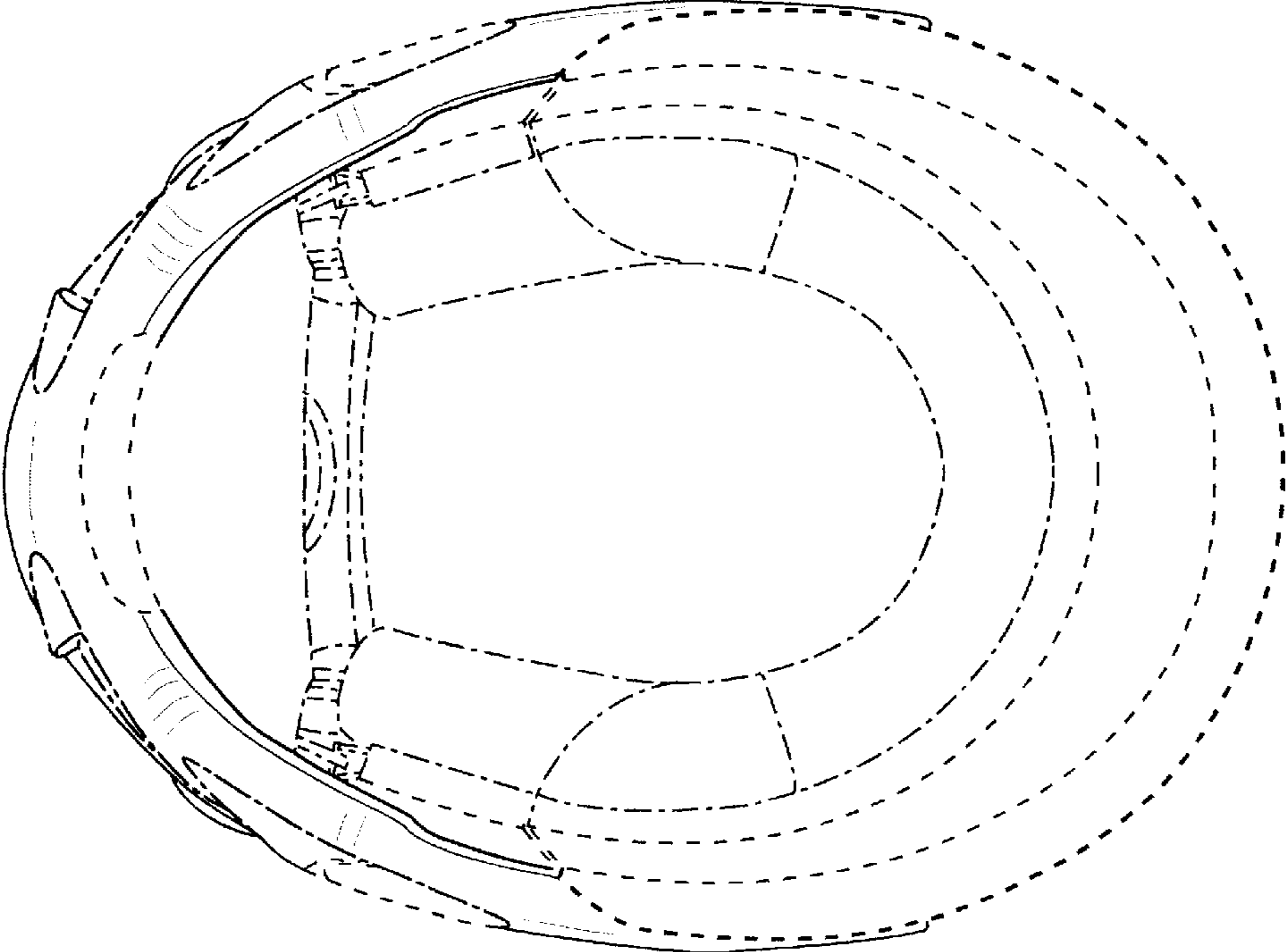

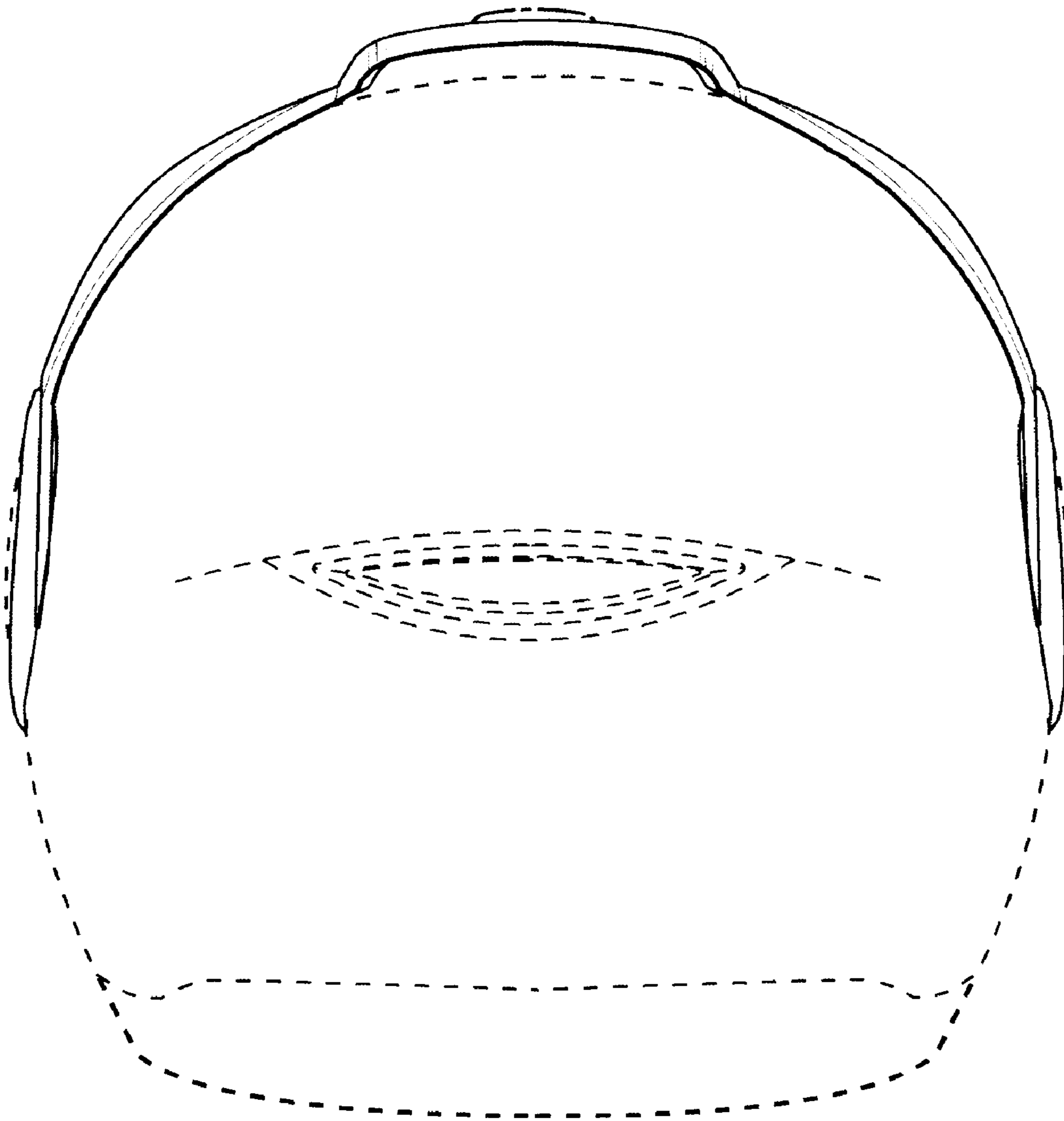

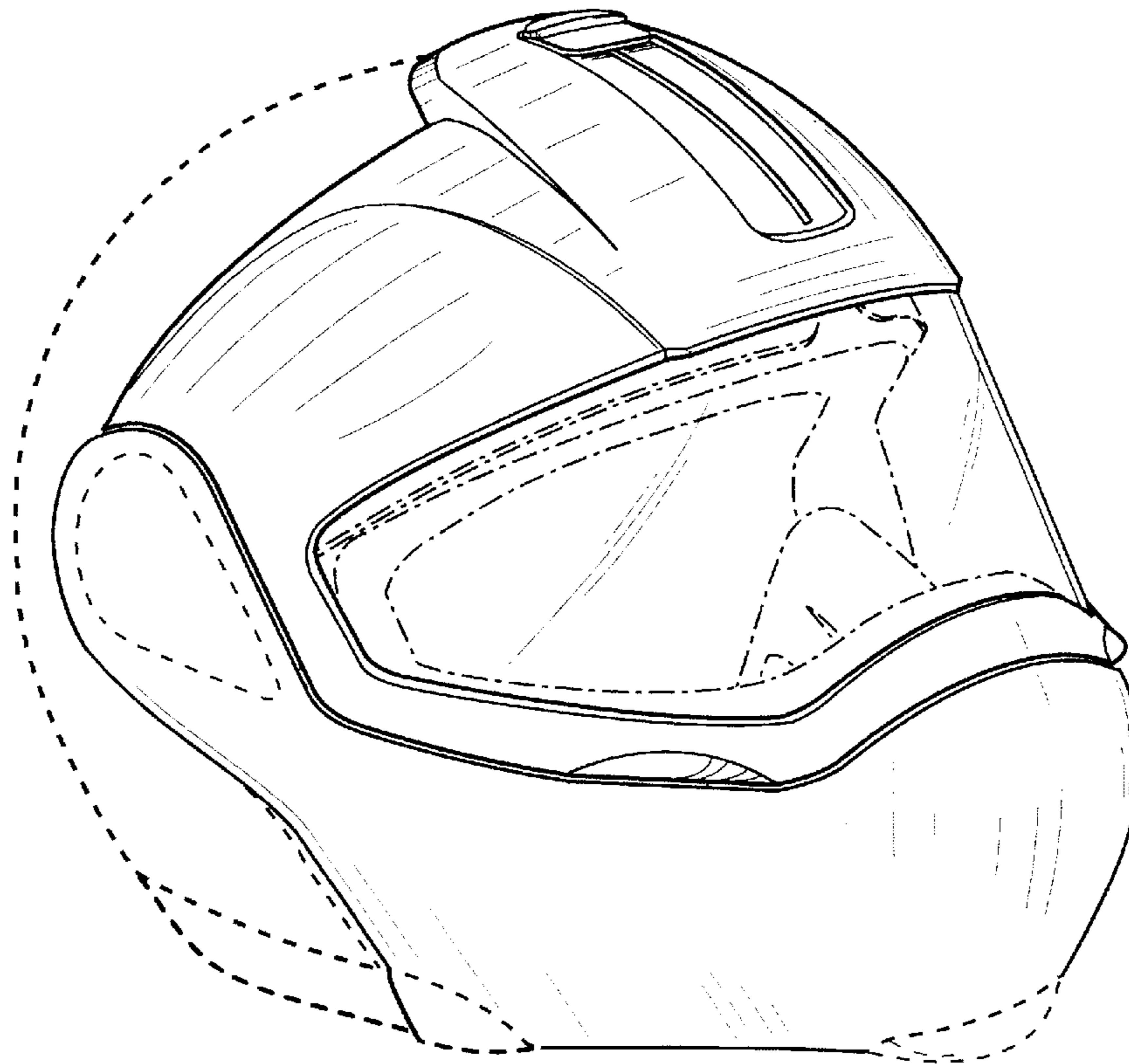

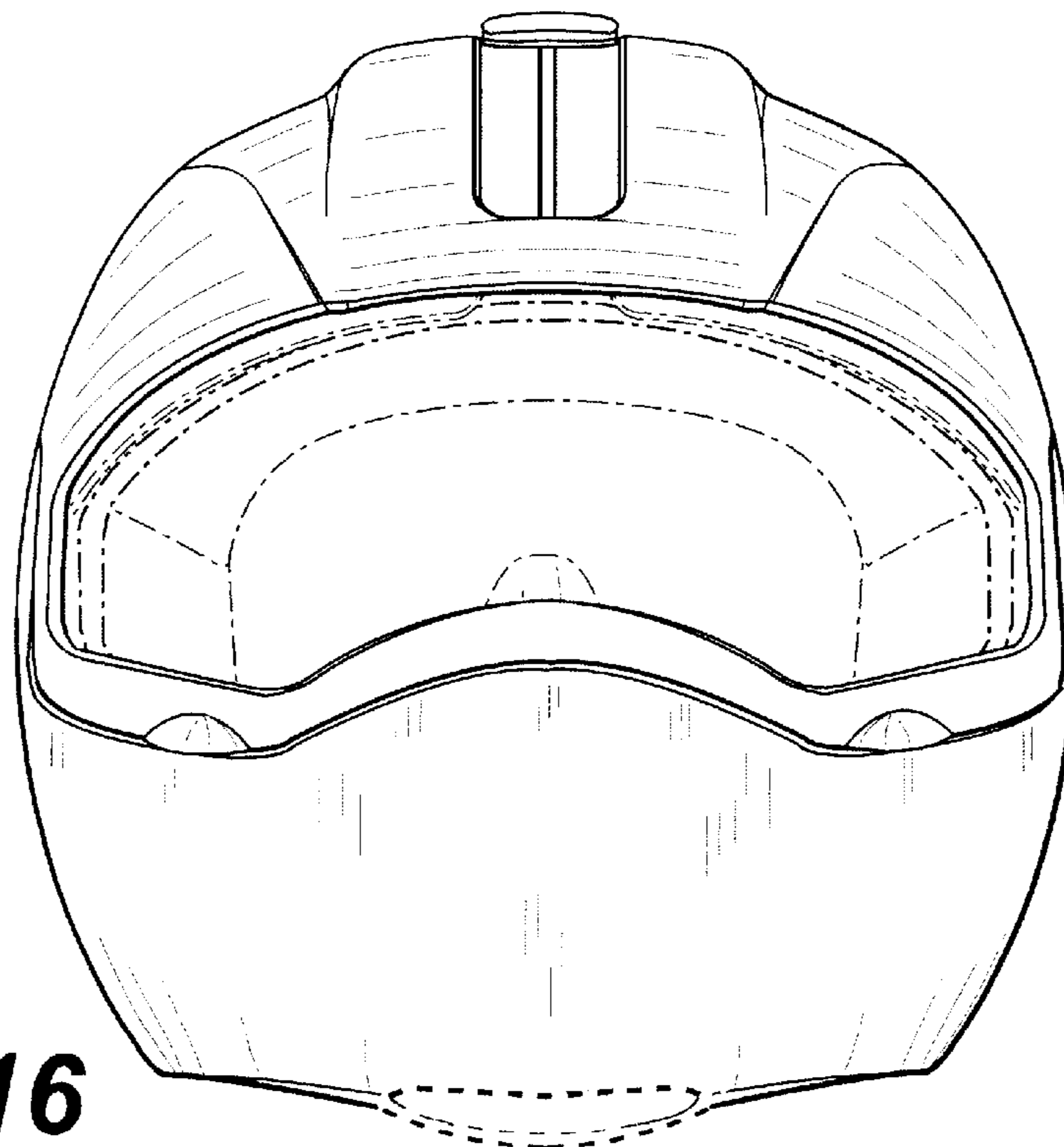

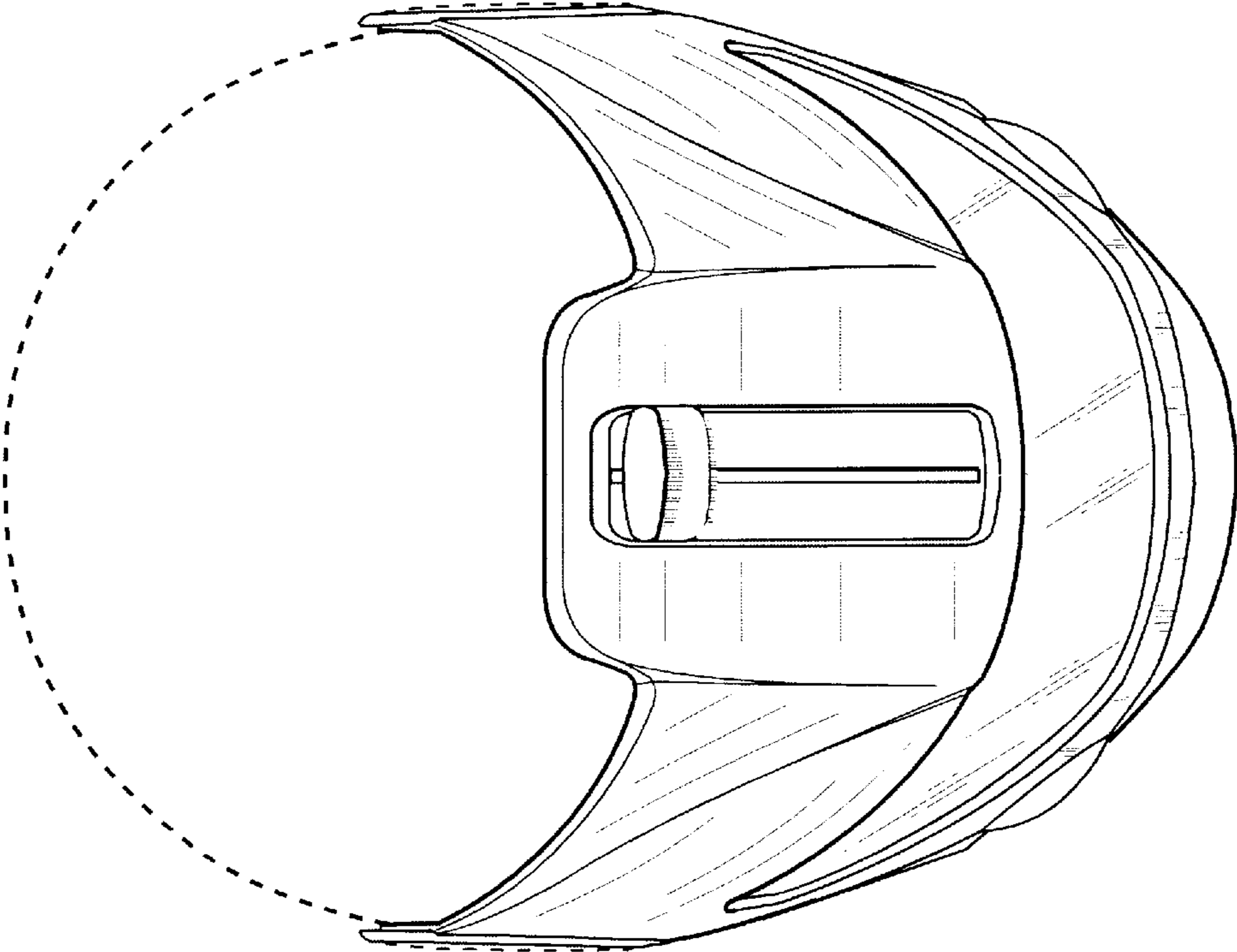

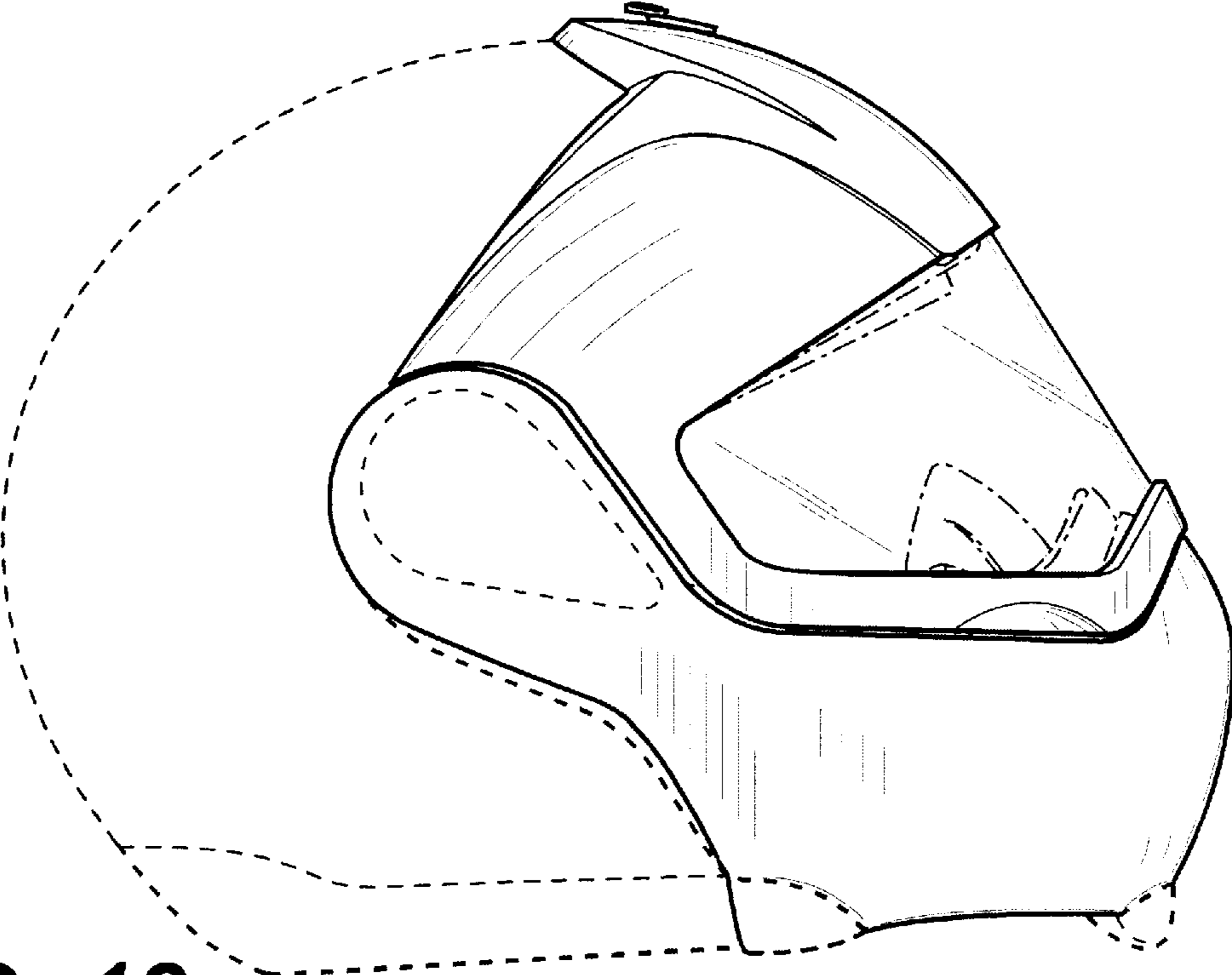

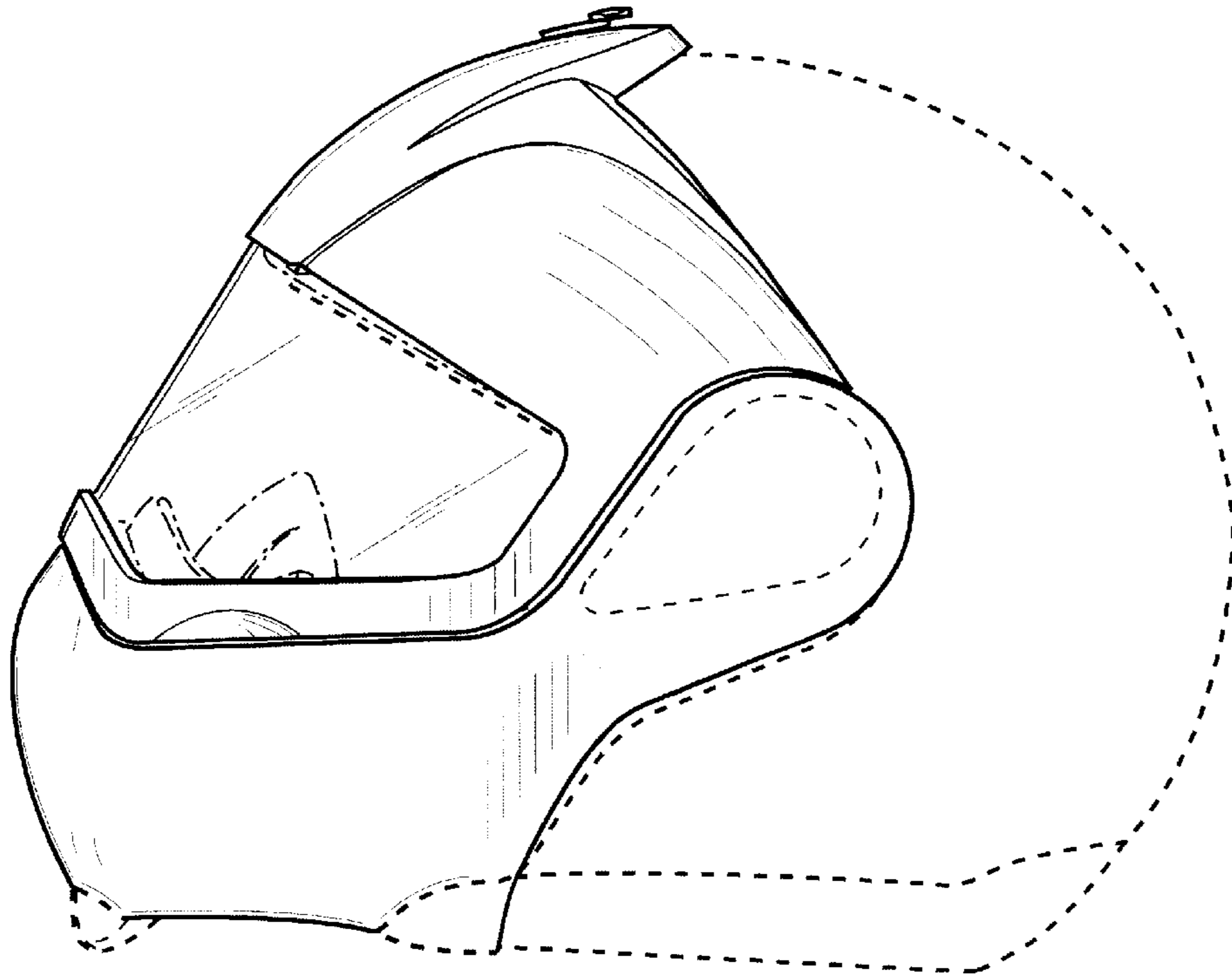

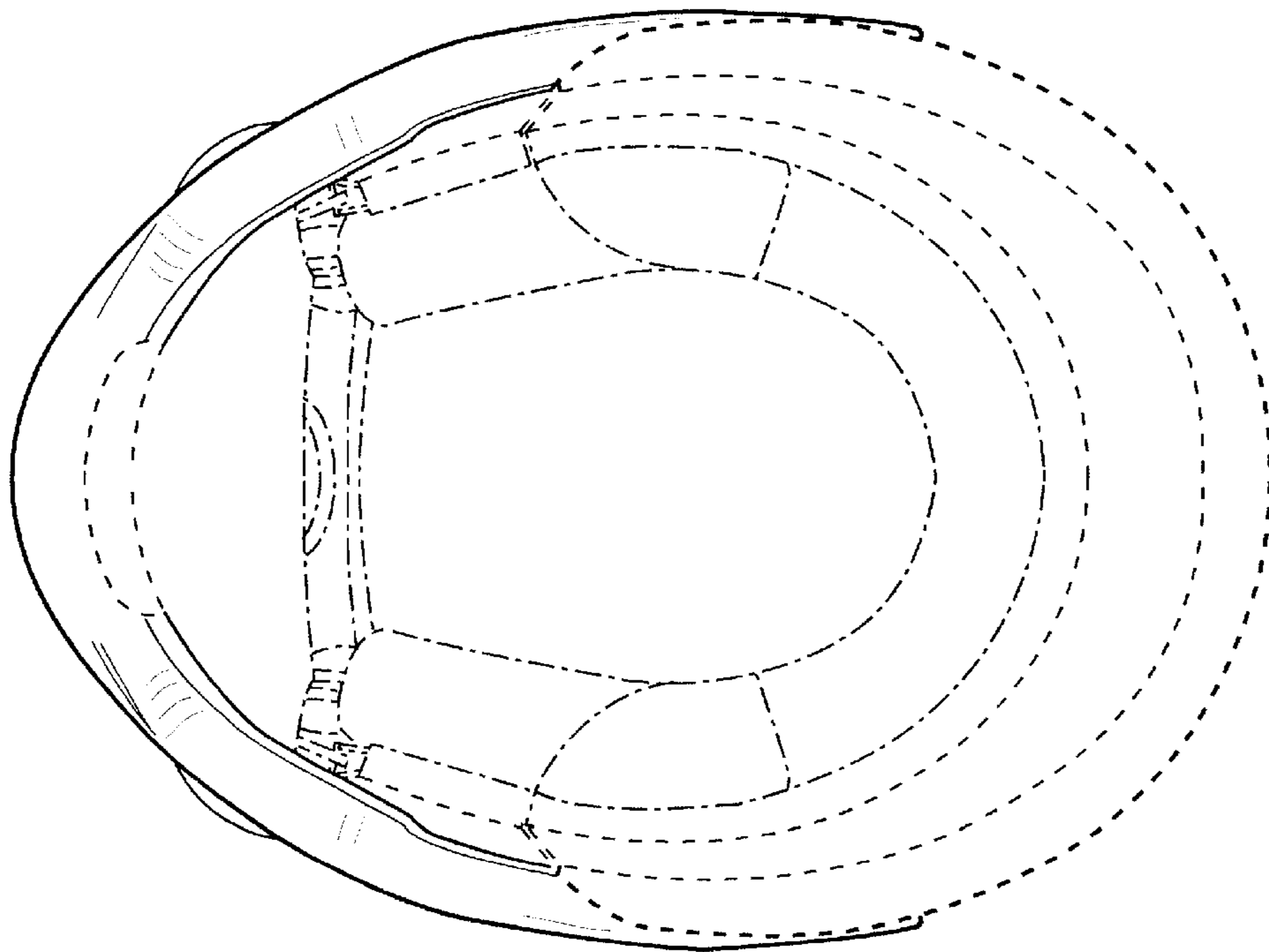

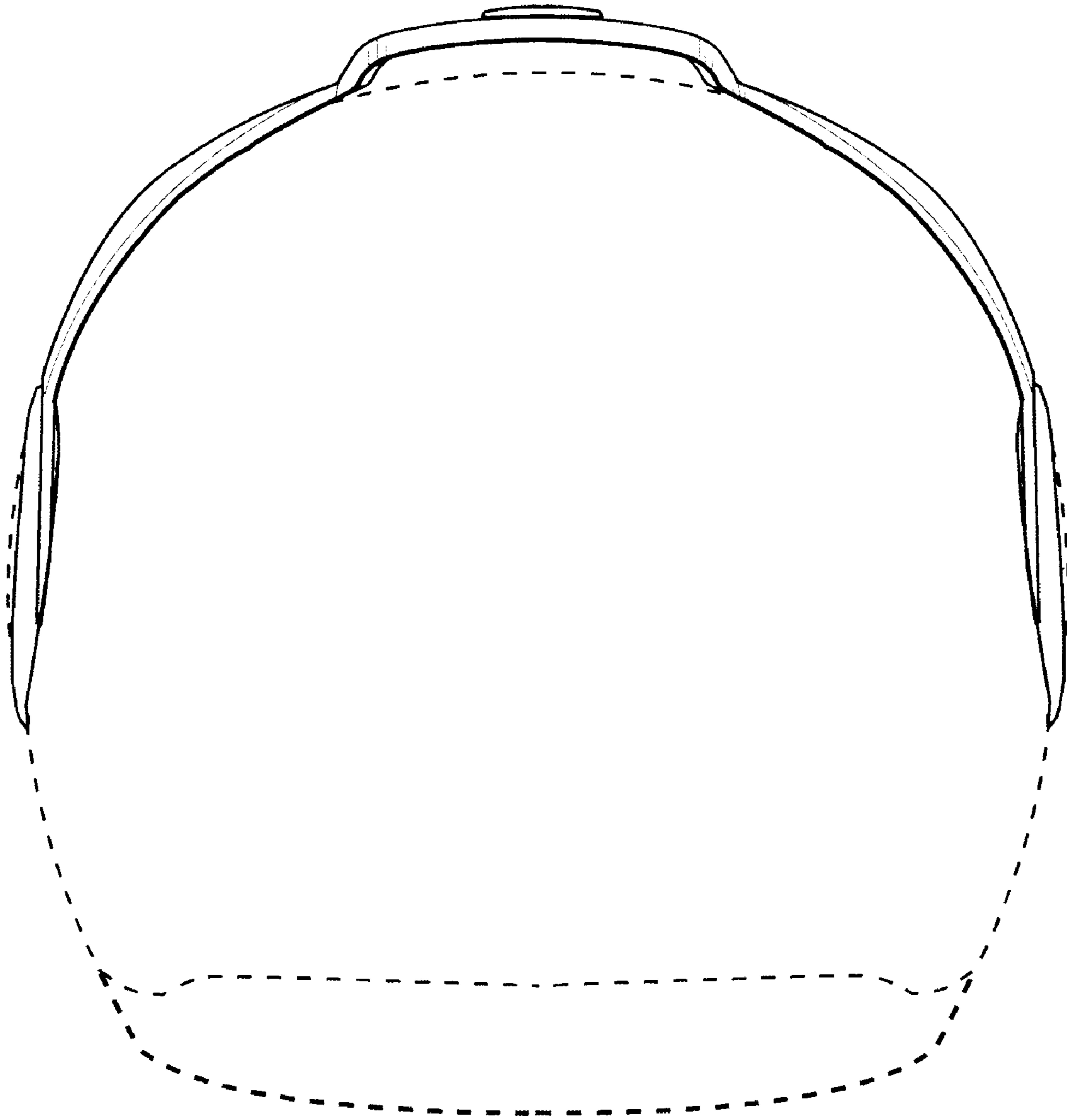
