chew, as shown and described.

**DESCRIPTION**

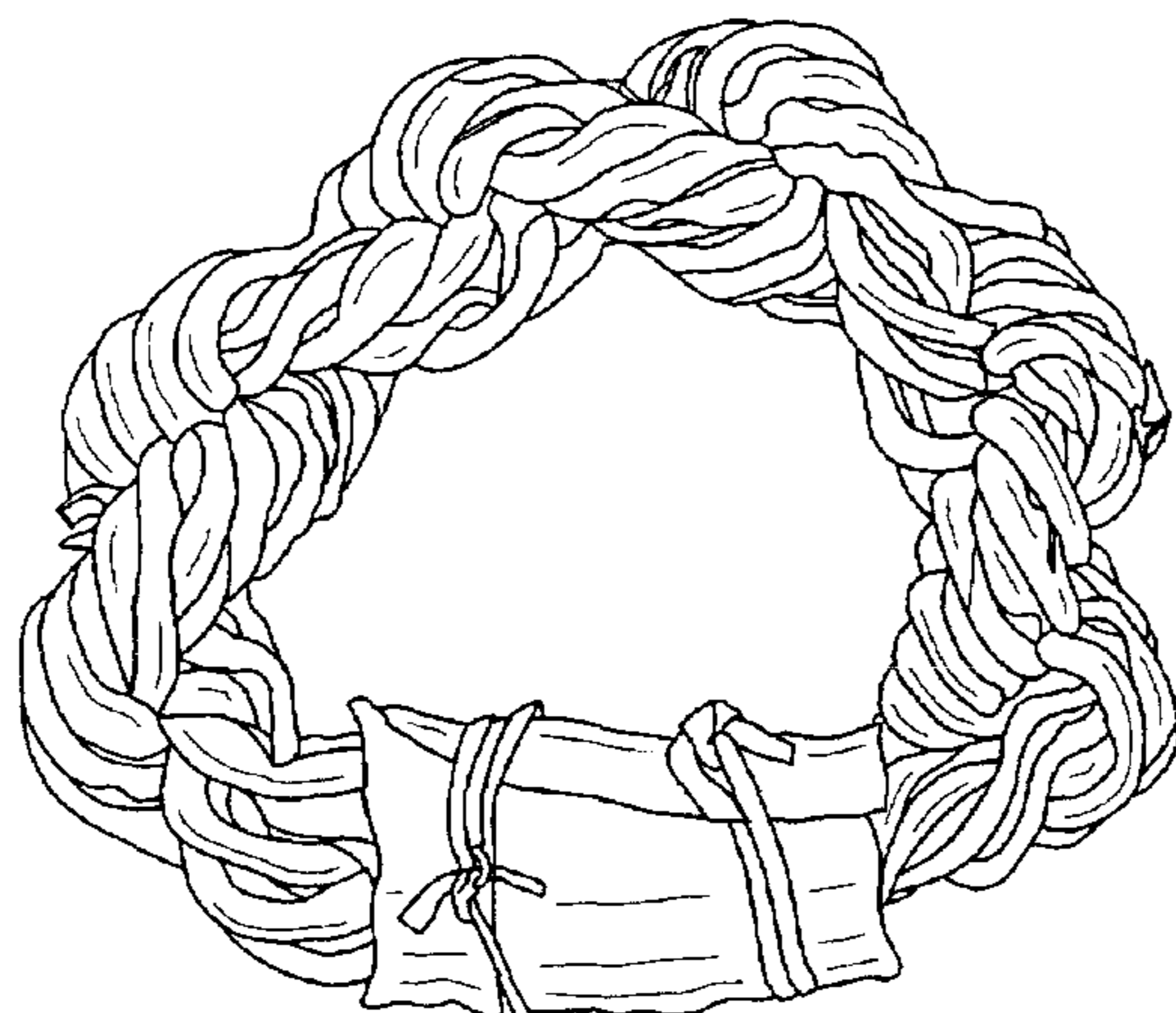
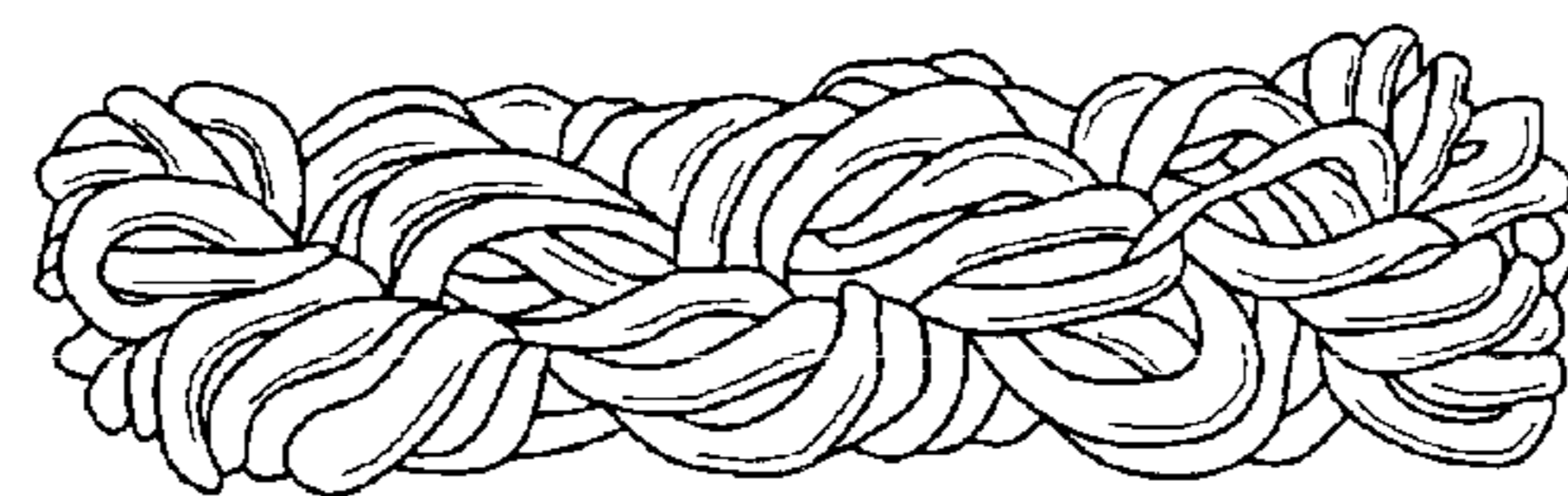
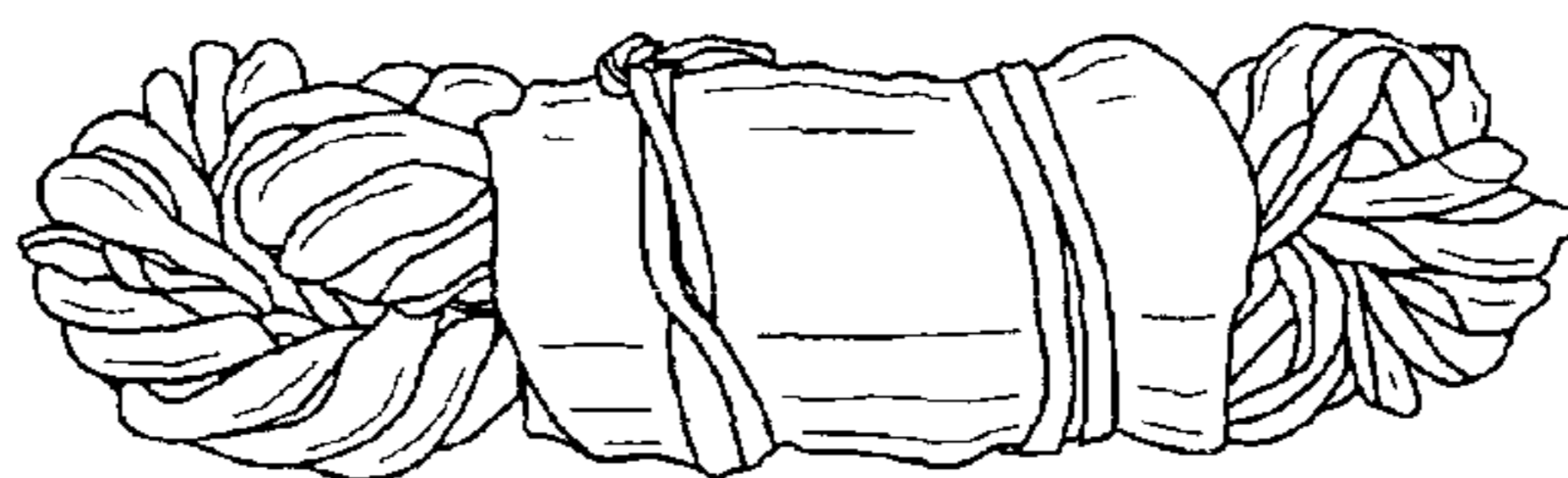

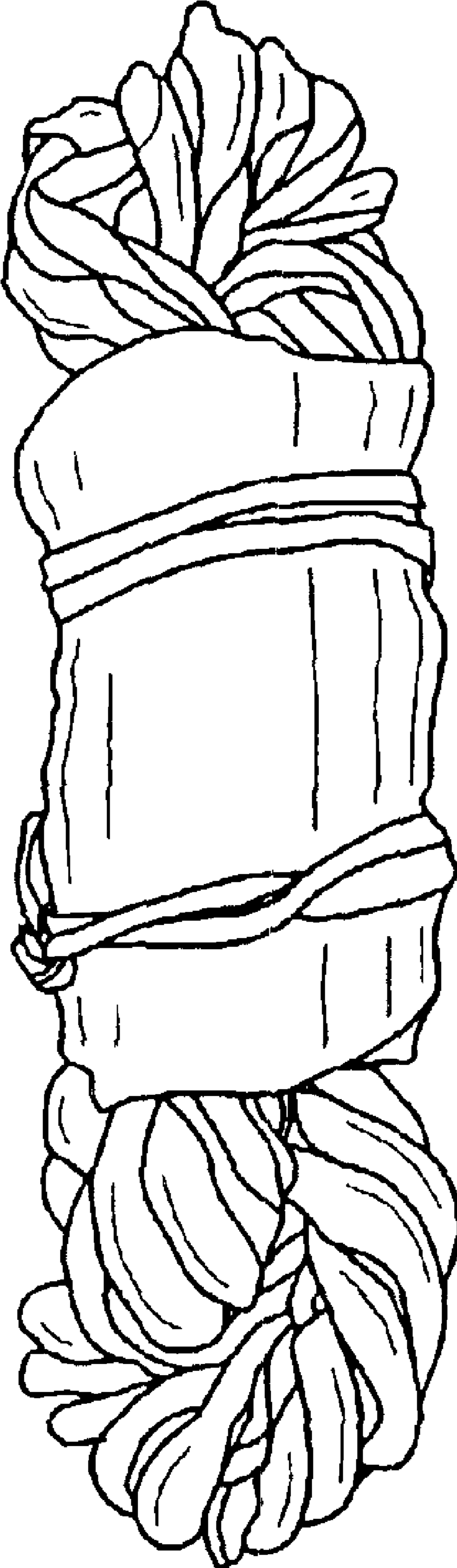

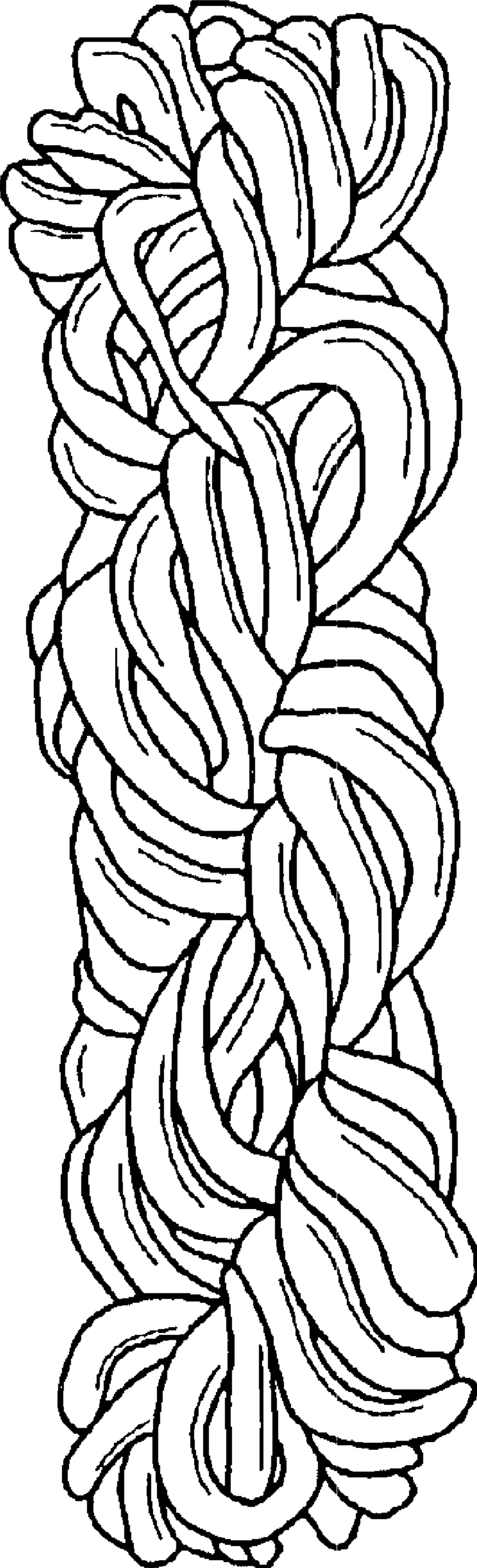

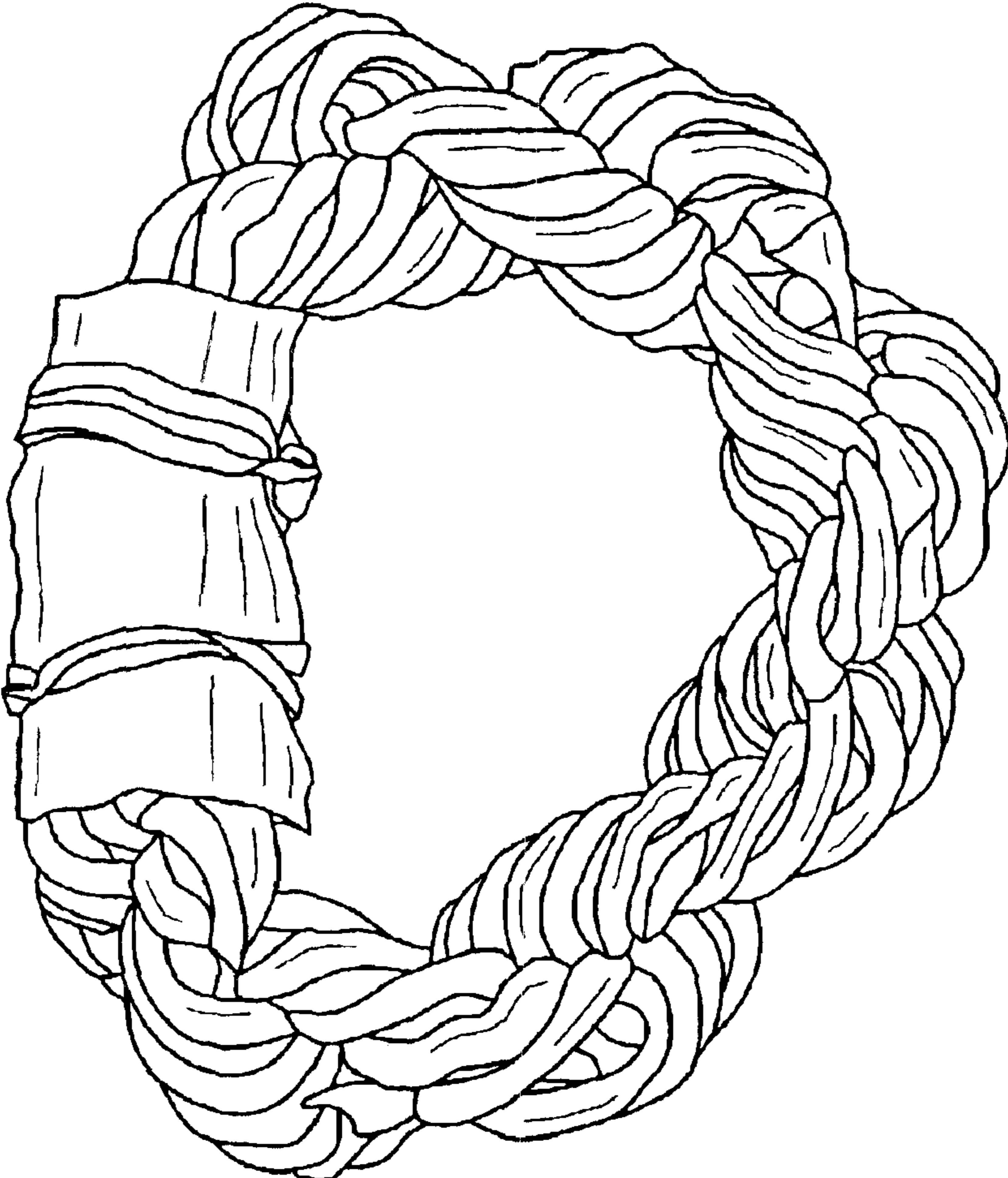

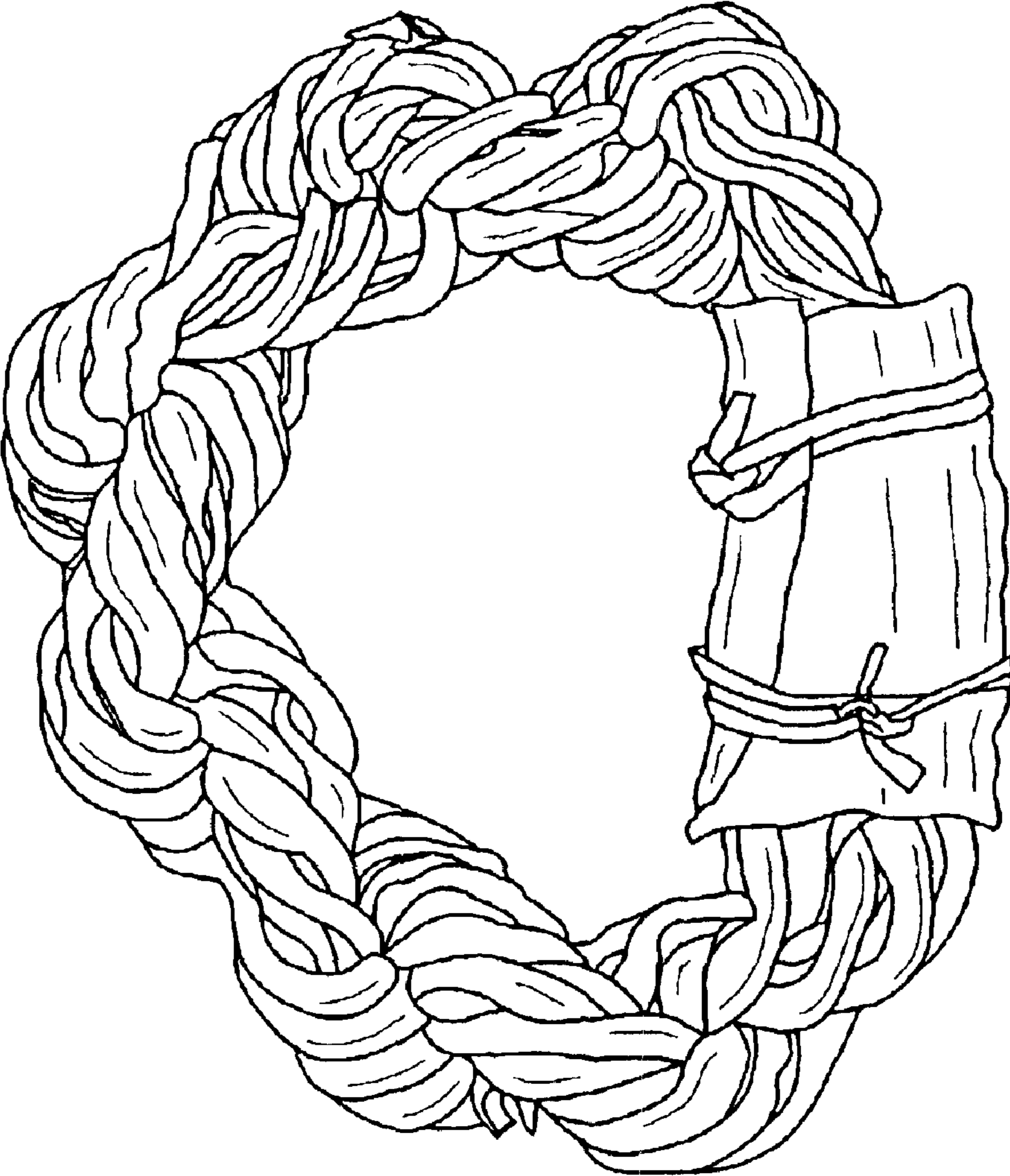

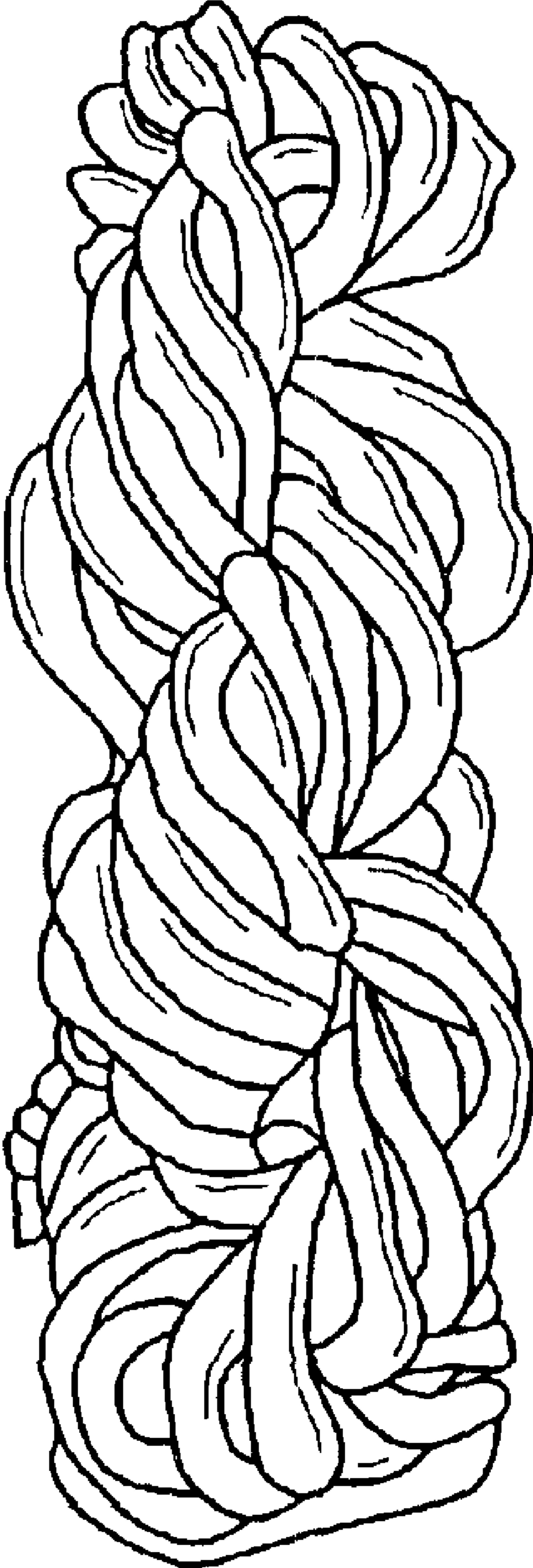
