(57) **CLAIM**

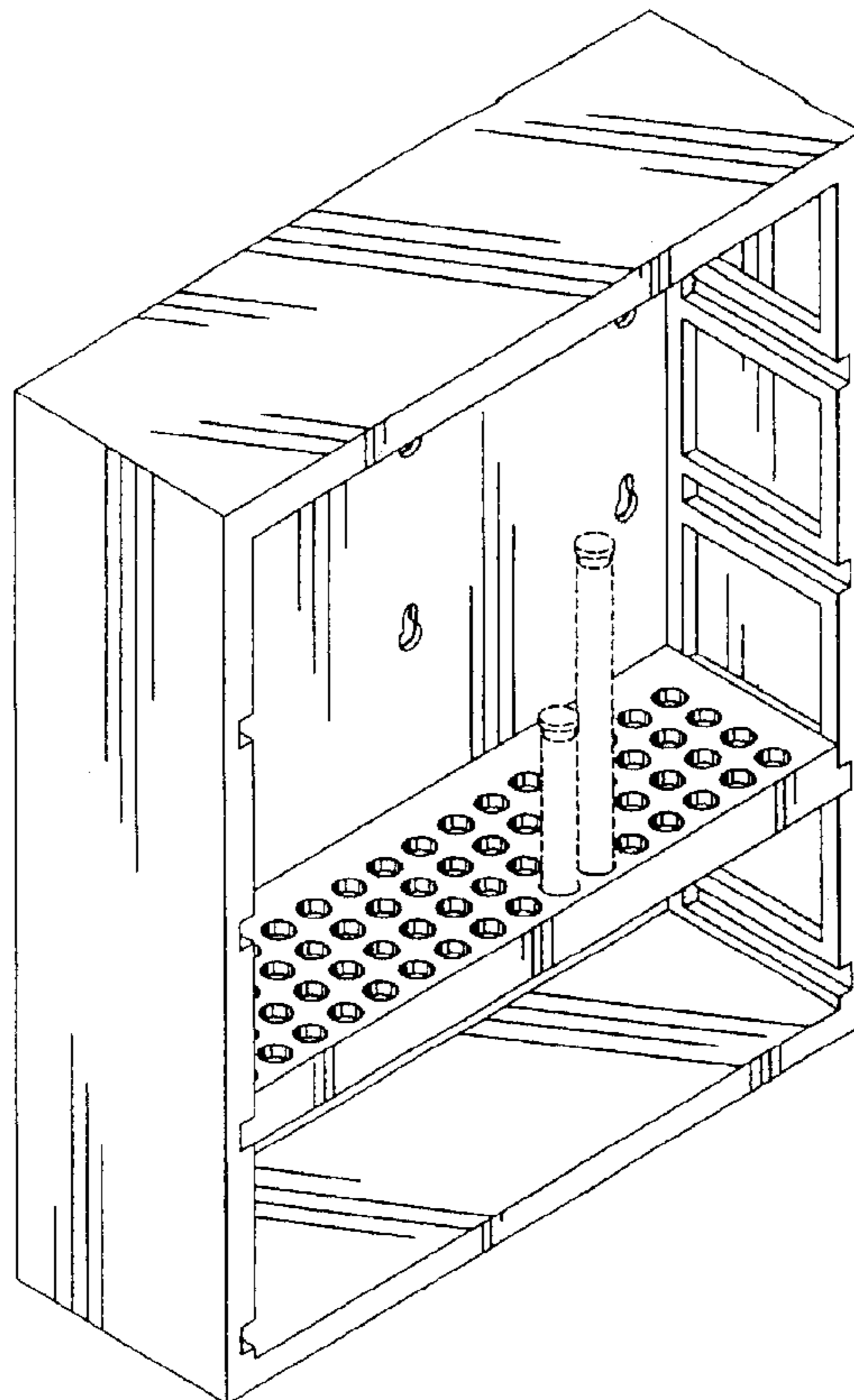
The ornamental design of a bead storage cabinet, as shown

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of
the bead storage cabinet showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a front perspective view of a second embodiment
of the bead storage cabinet showing my new design; and,
FIG. 8 is a top view of FIG. 7.

The rear and bottom views of the second embodiment are the
same as the rear and bottom views of the first embodiment.

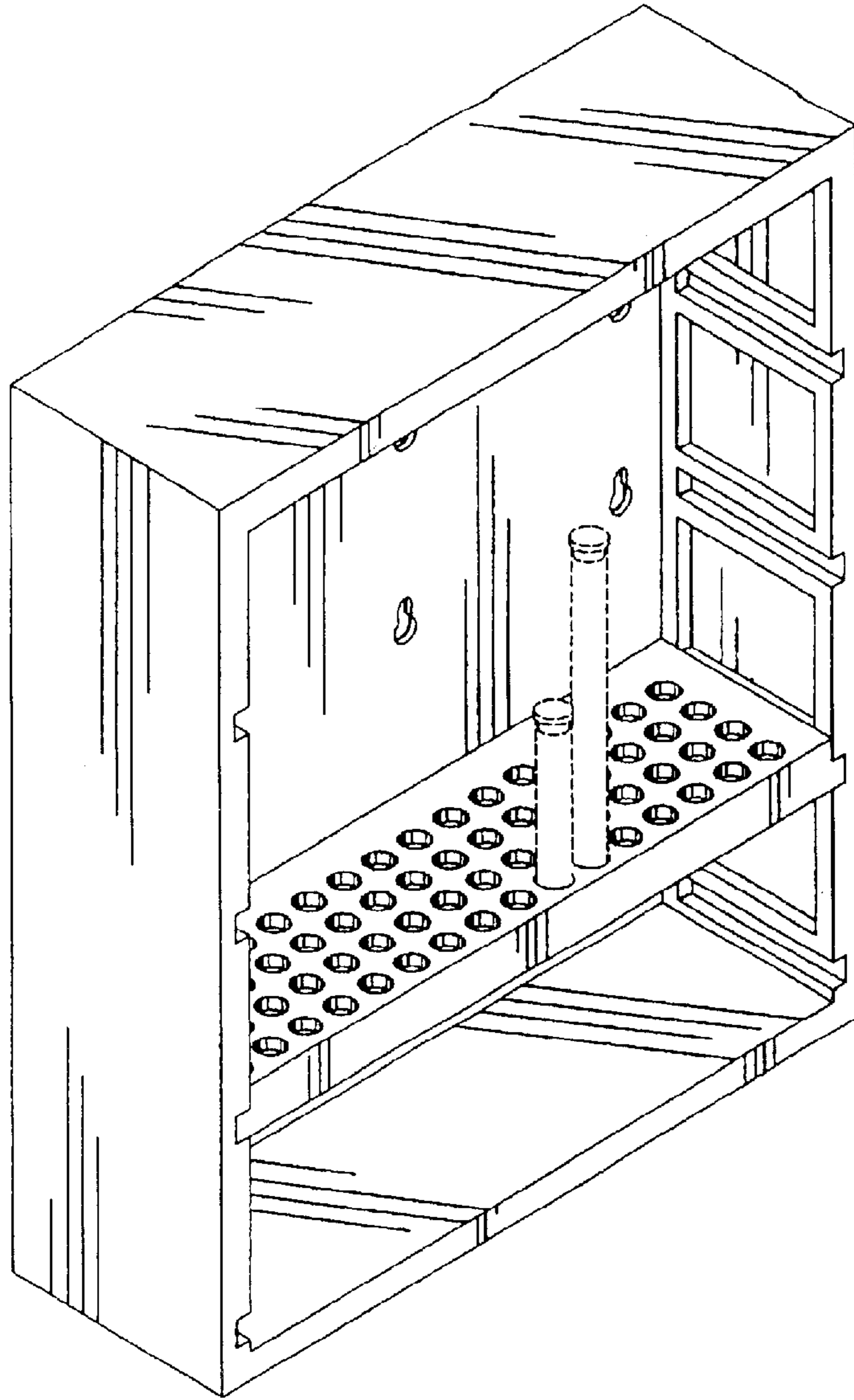

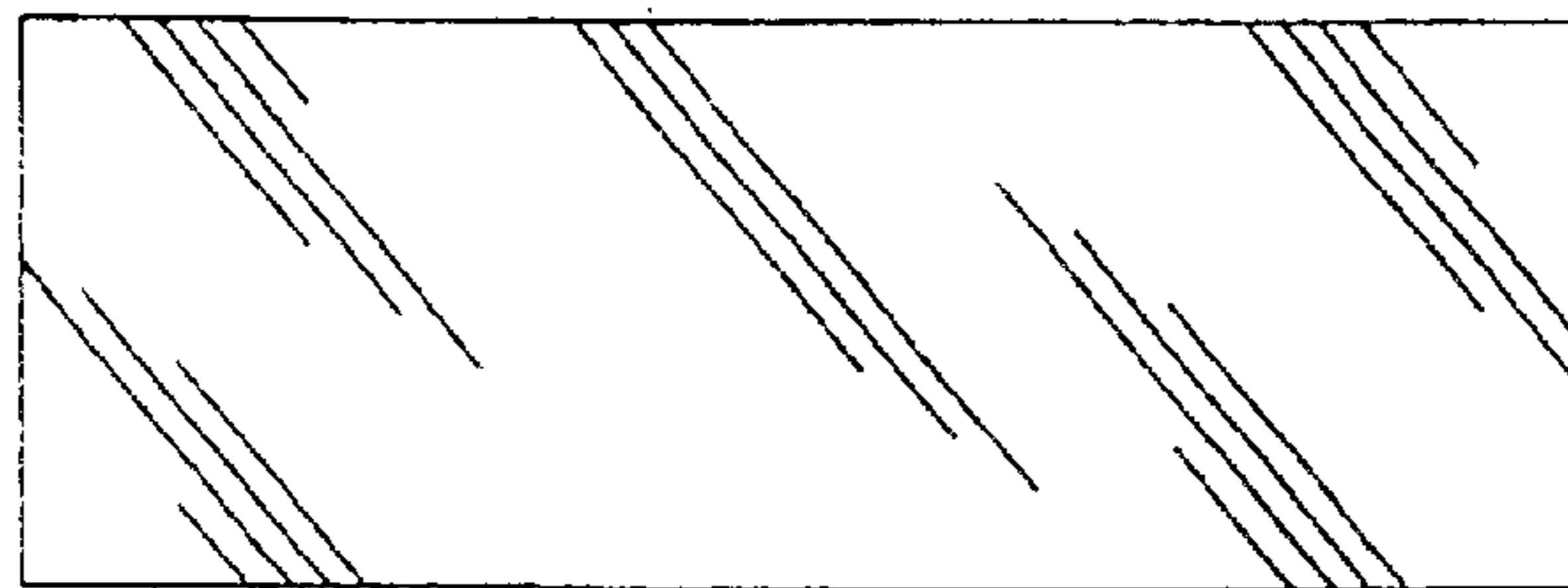

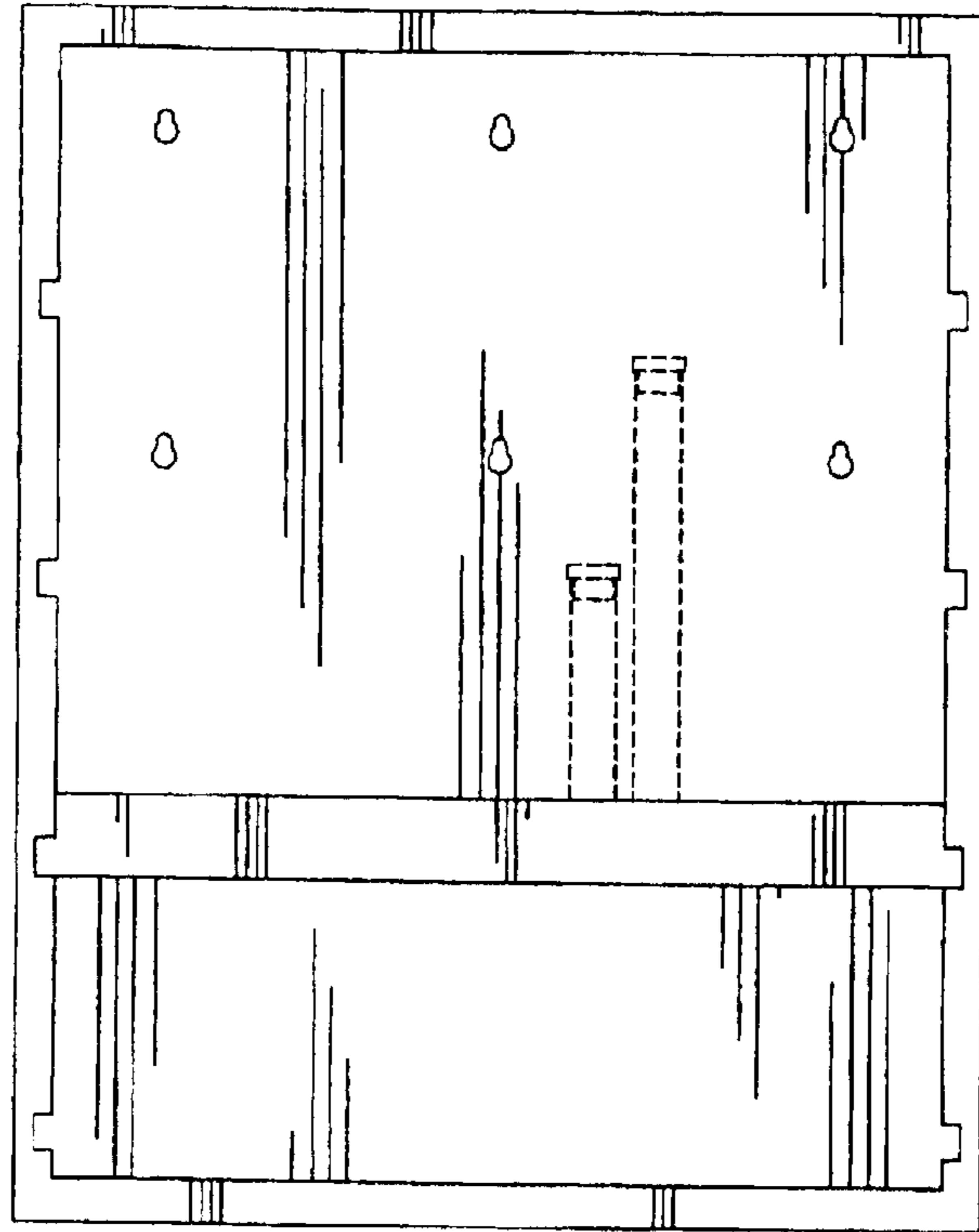

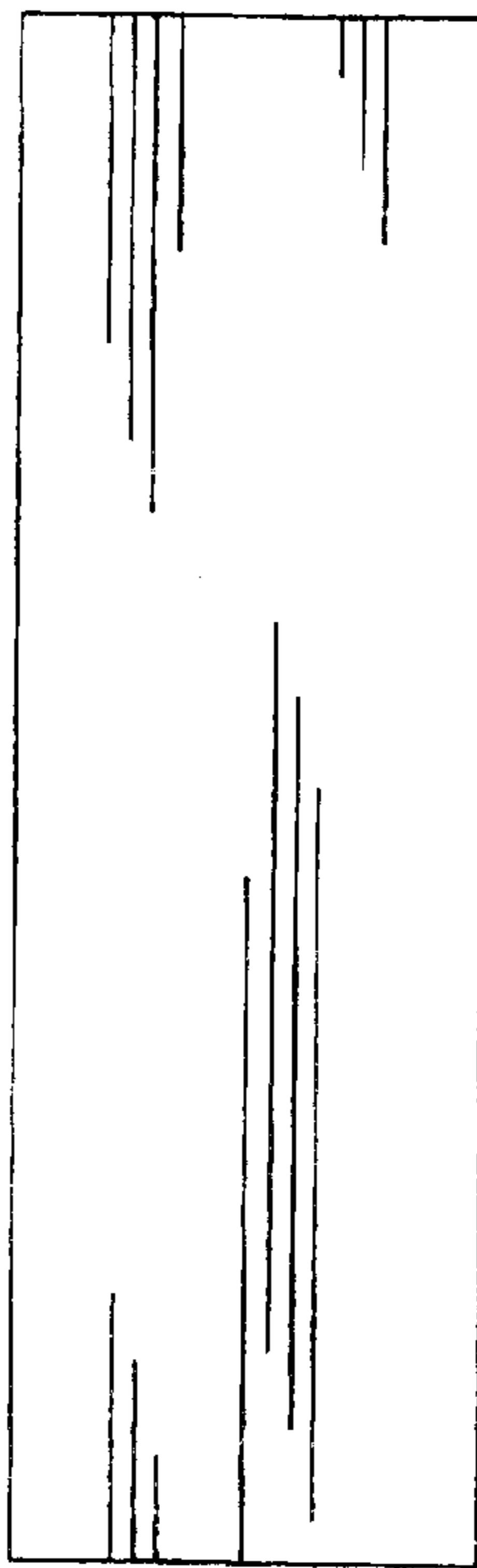

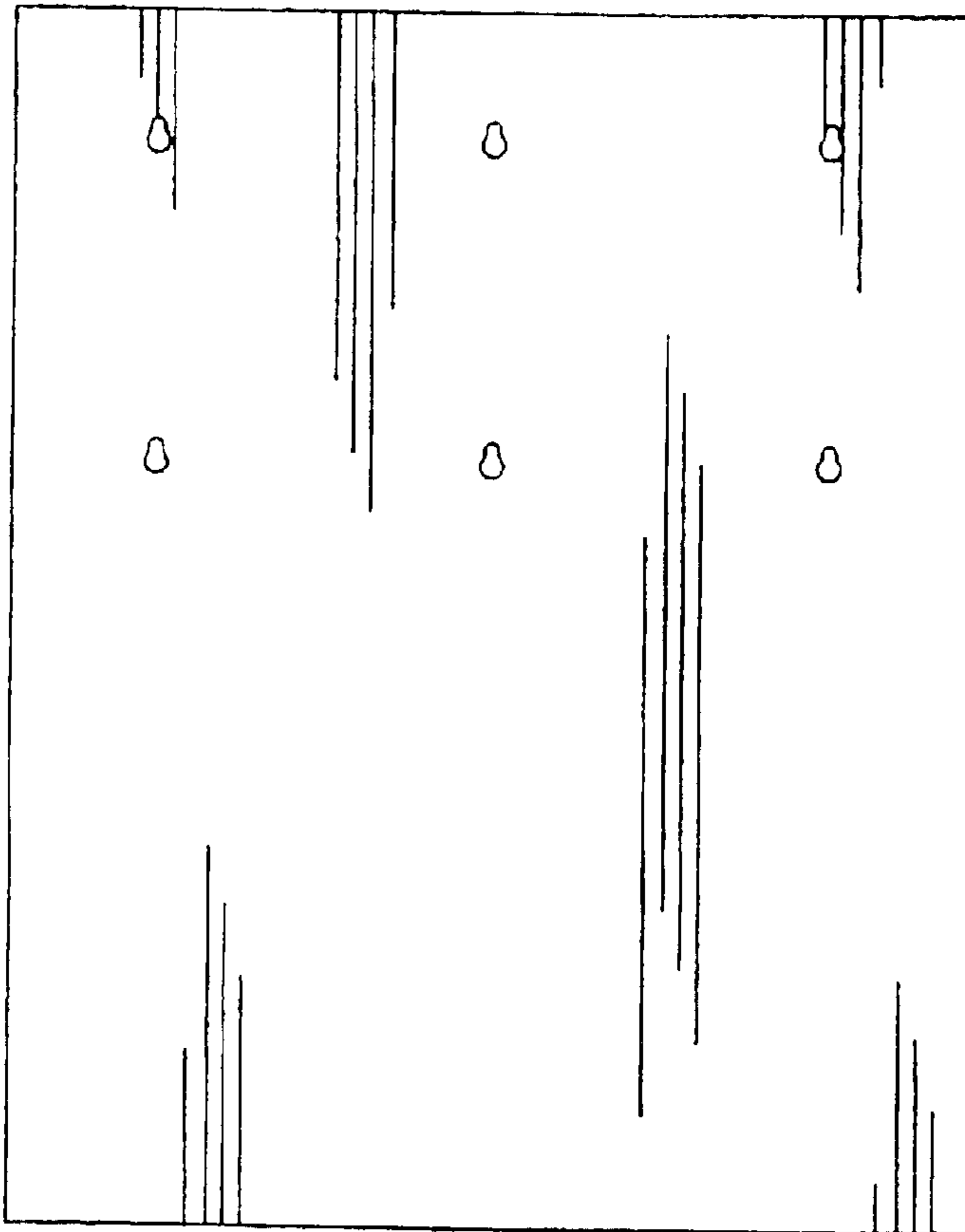

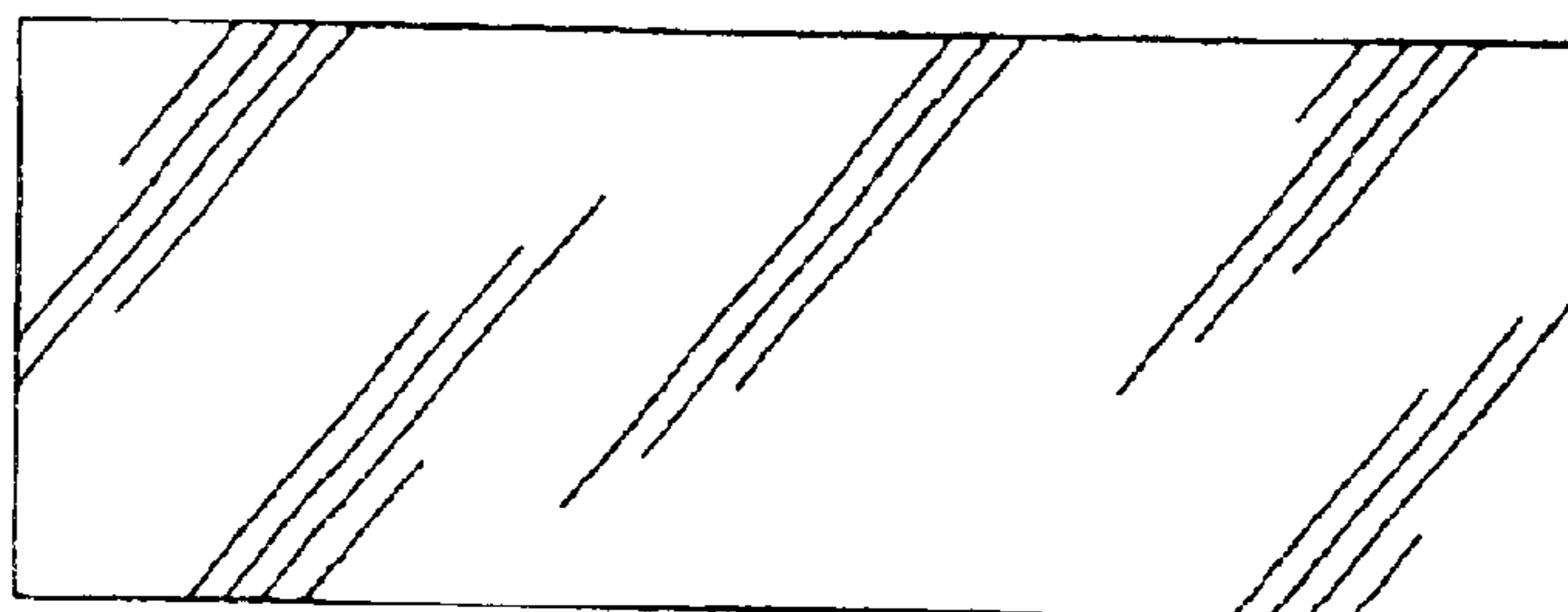

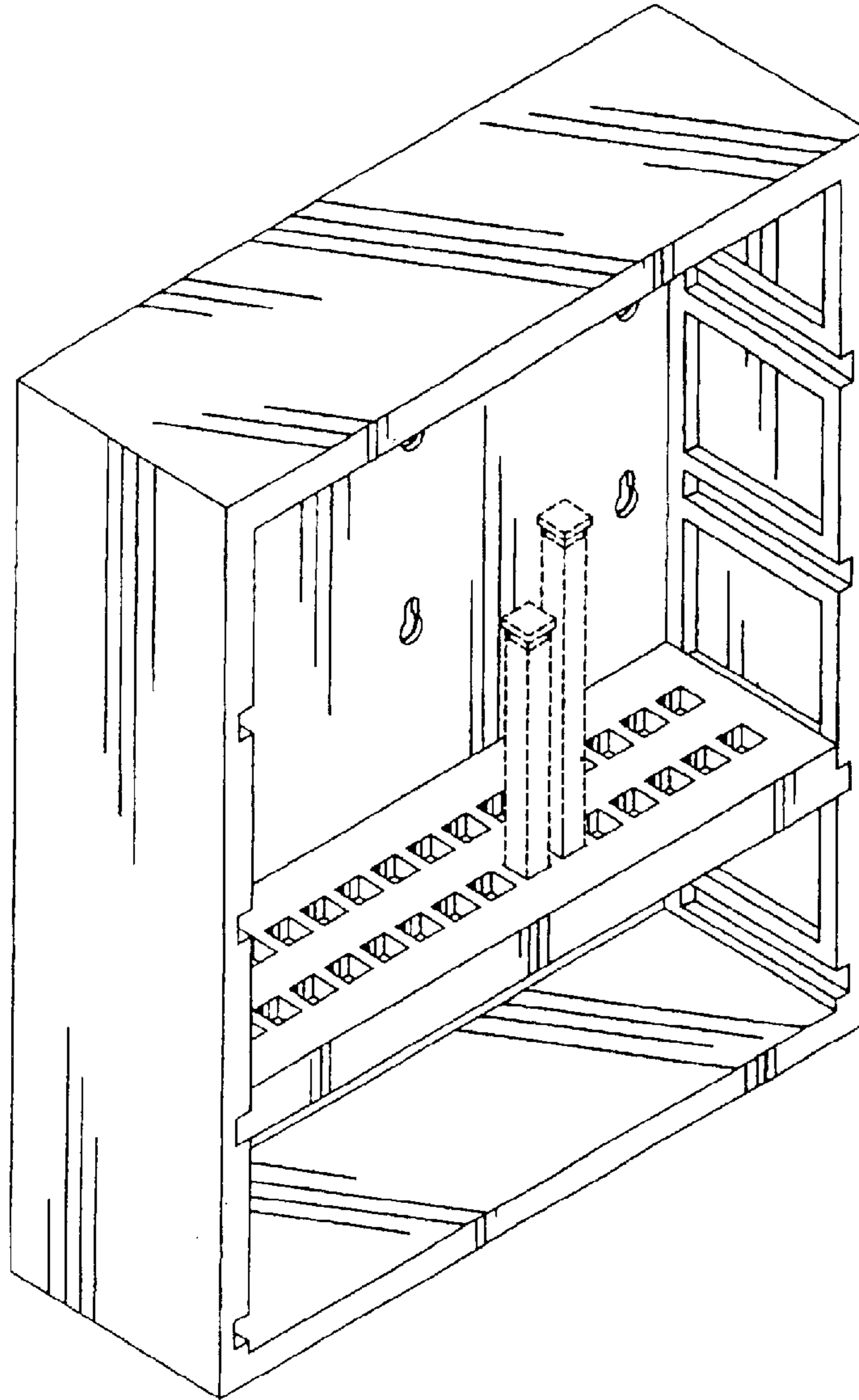

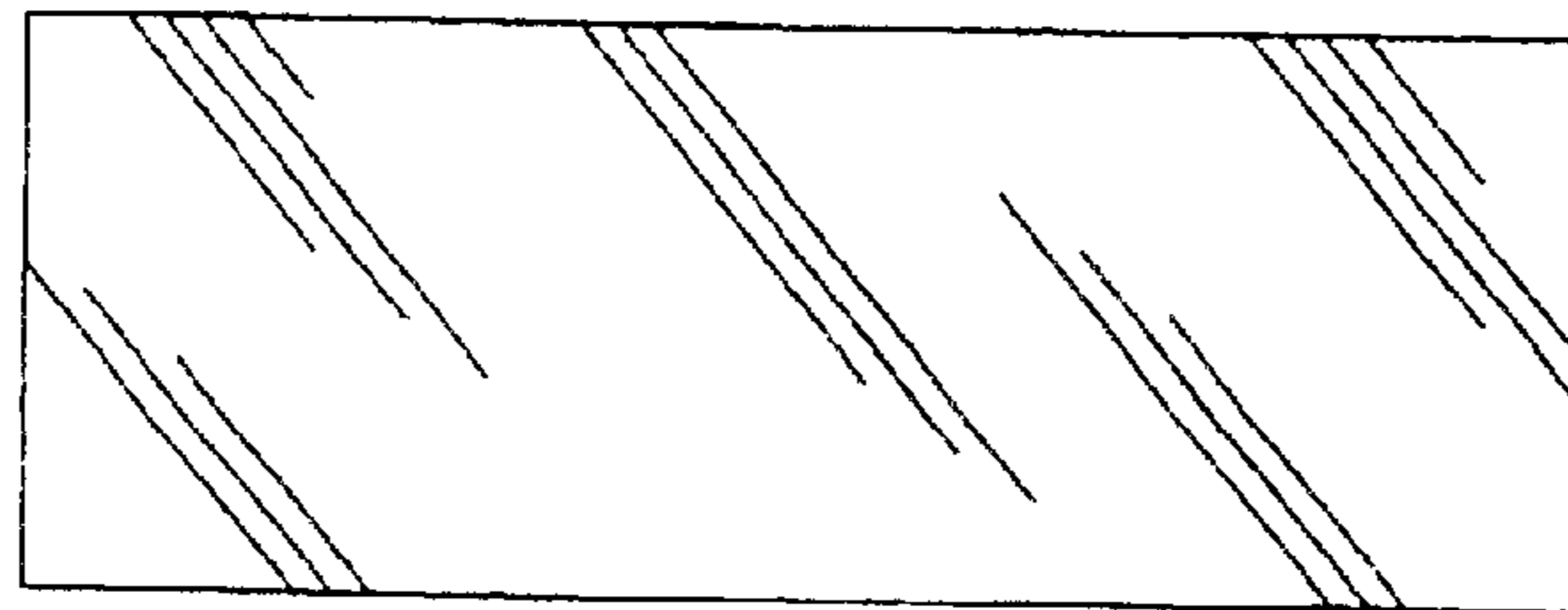
