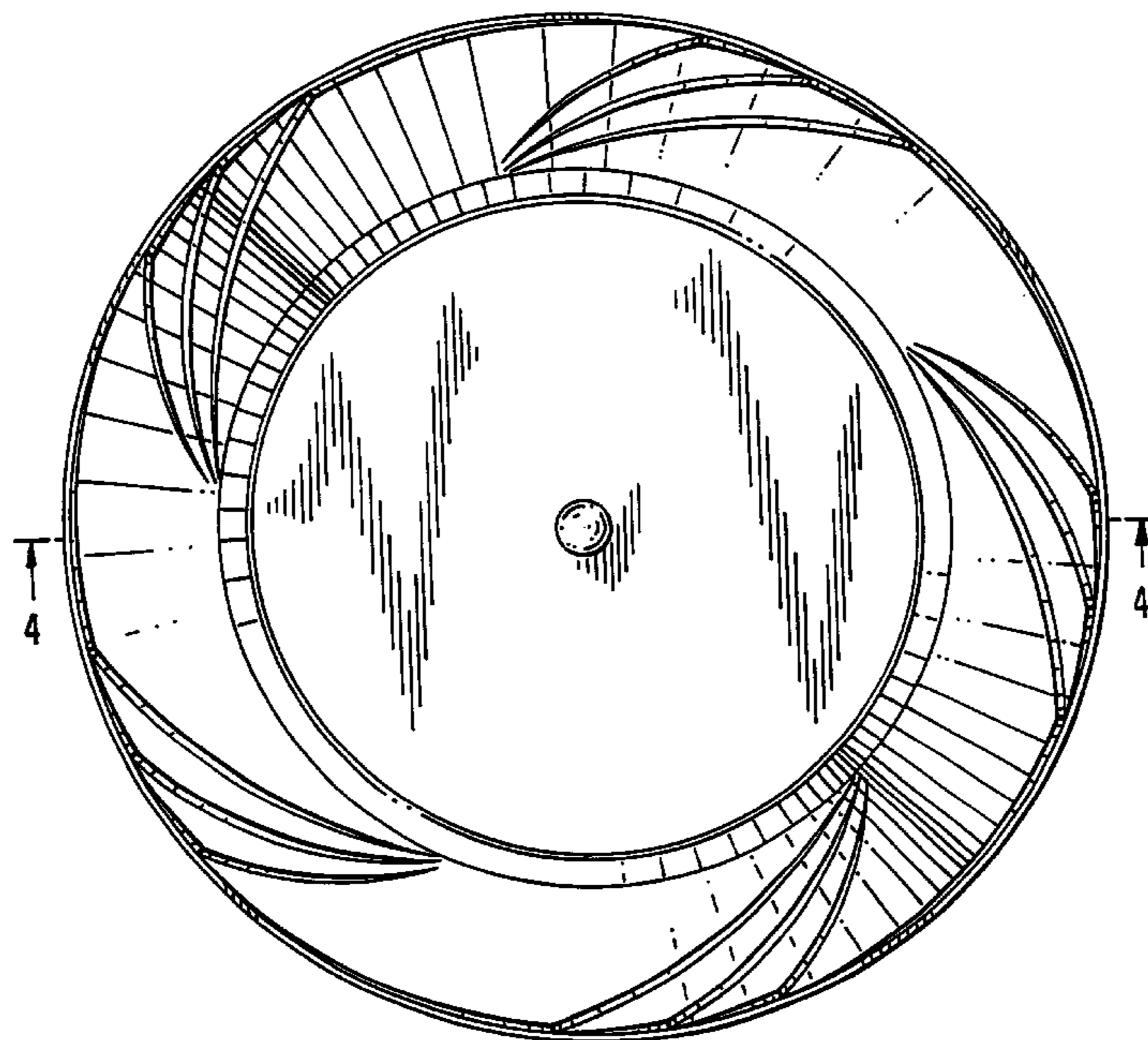
(57) **CLAIM**

The ornamental design for a plate, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a plate;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a side elevational view thereof;
FIG. 4 is a side cross-sectional view thereof, taken along line
4 of FIG. 1;
FIG. 5 is a top plan view of a second embodiment of a plate;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a side elevational view thereof; and,
FIG. 8 is a side cross-sectional view thereof, taken along line
8 of FIG. 5.

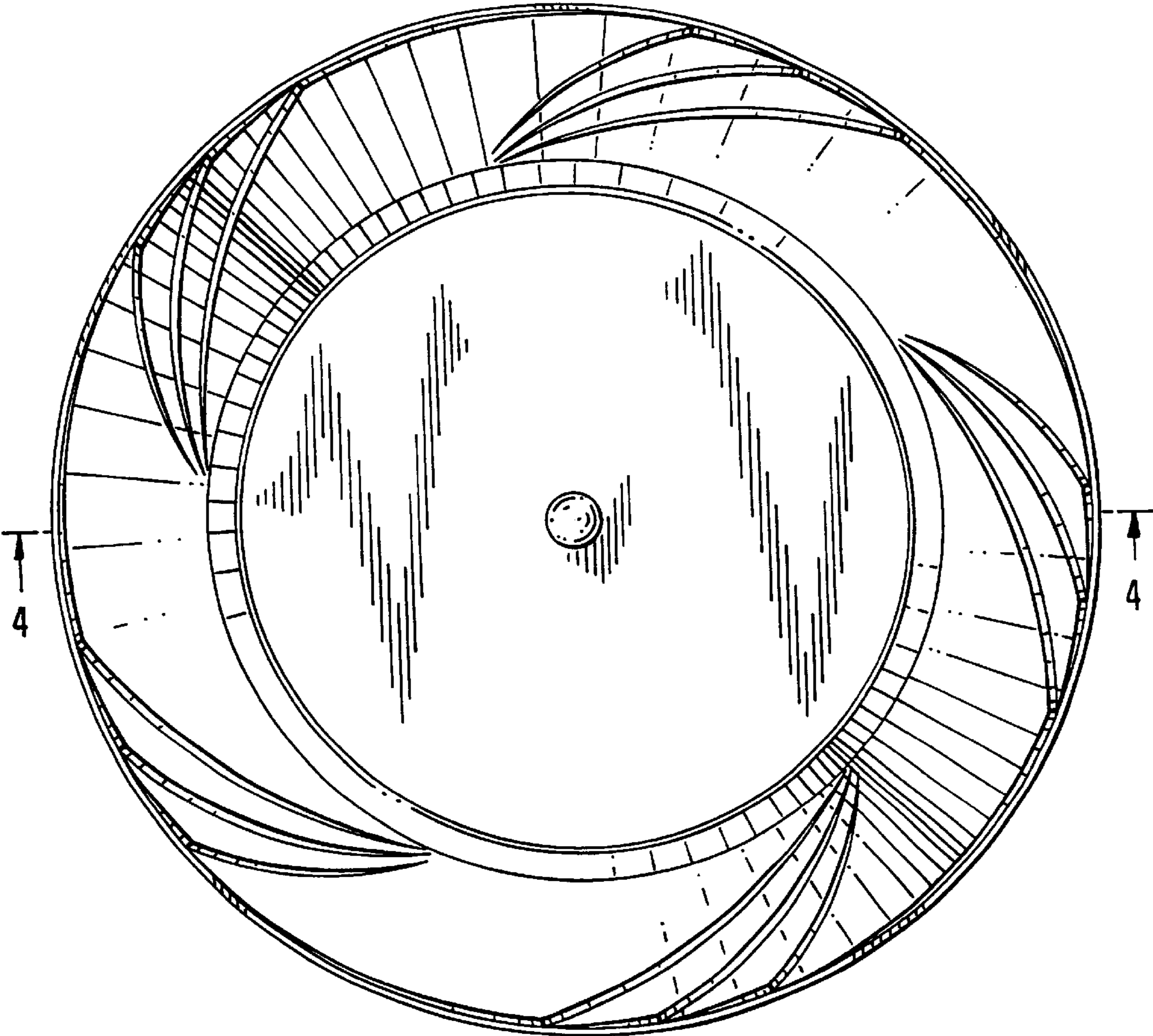

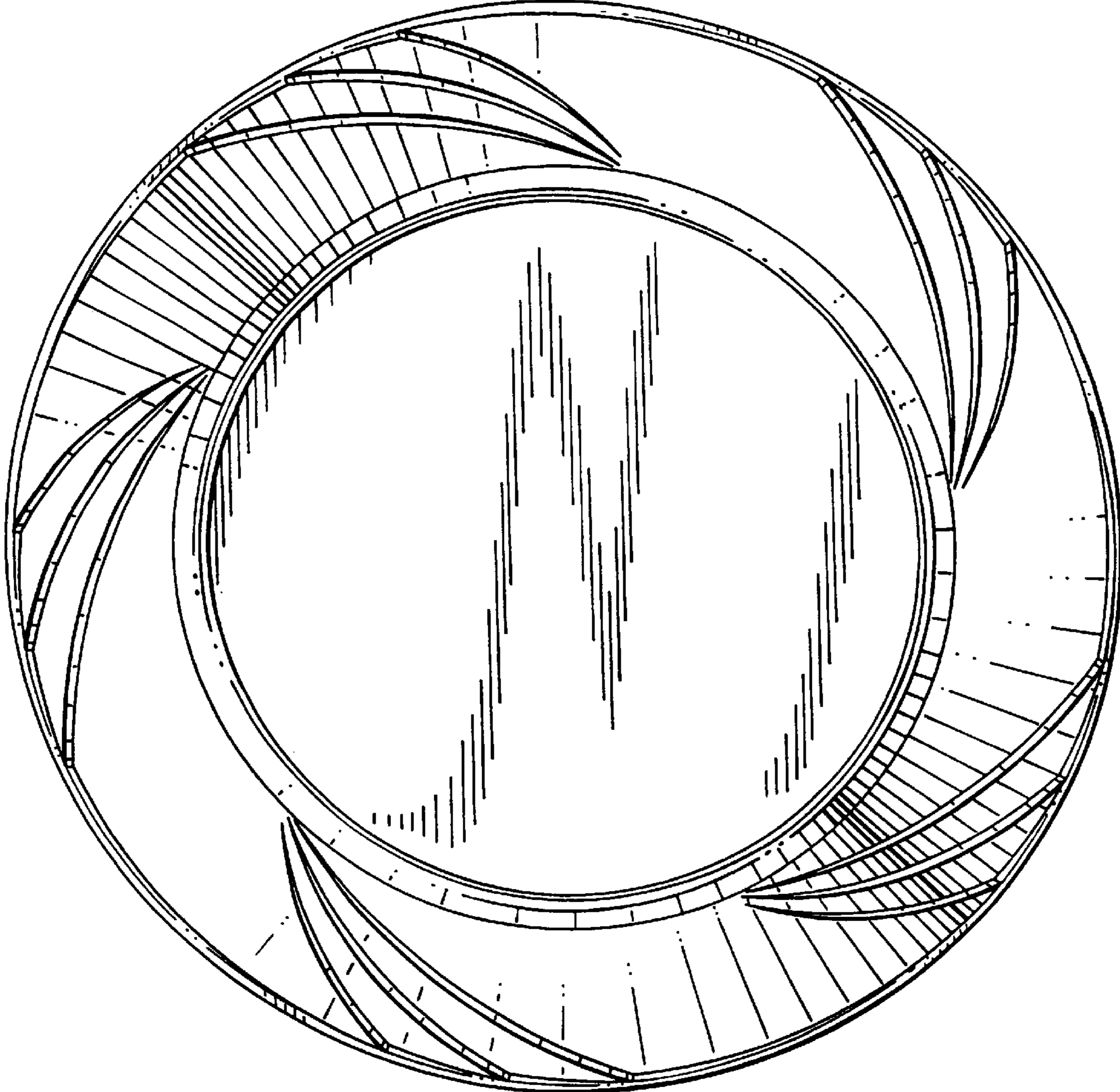

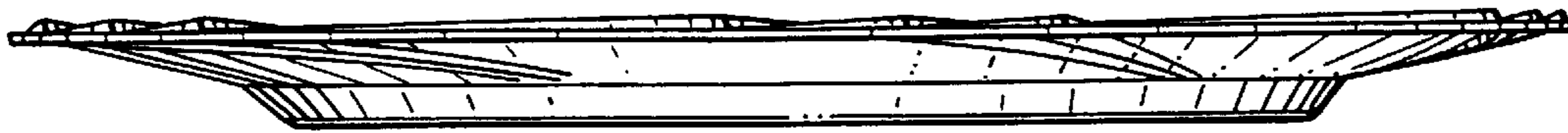

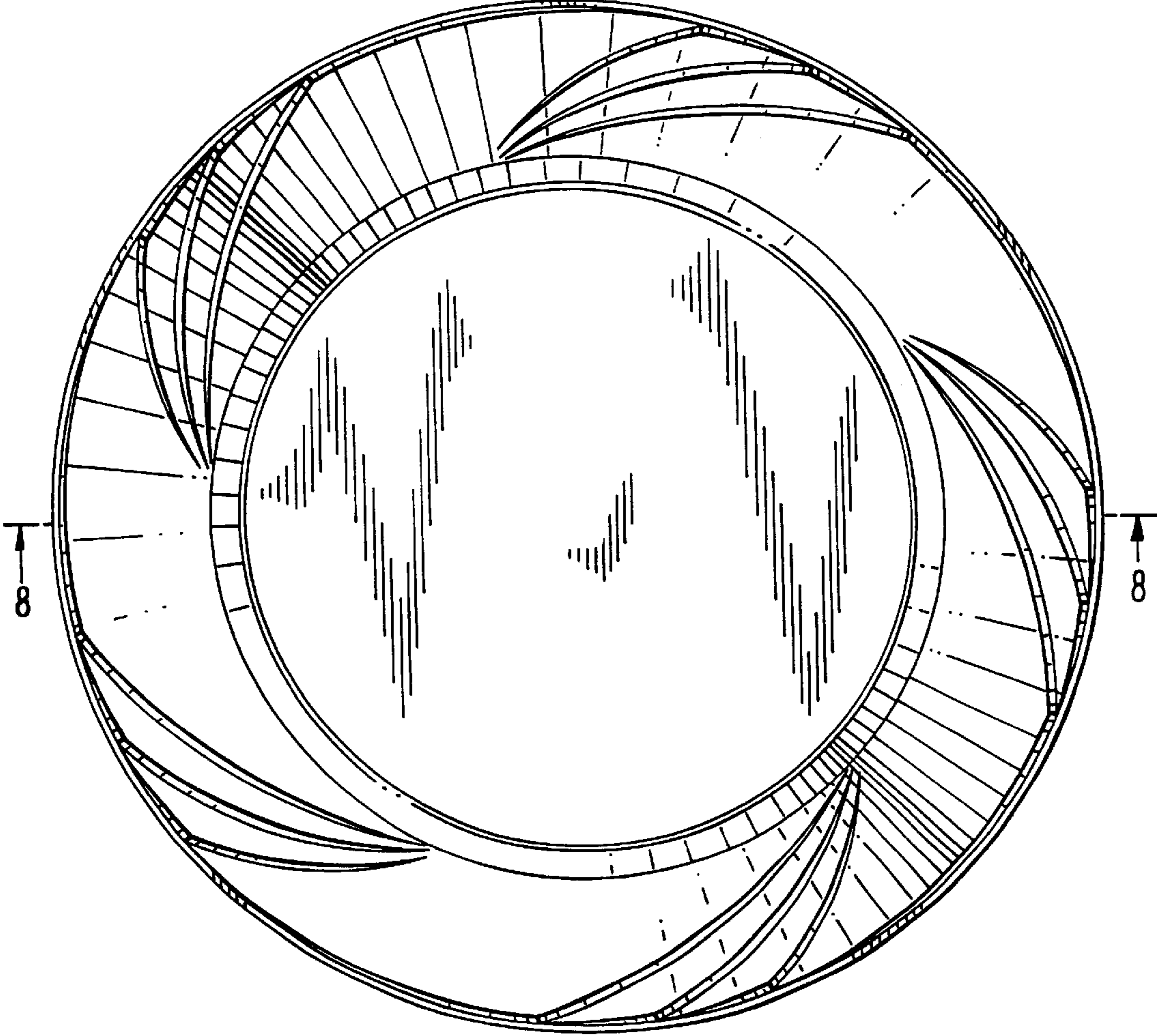

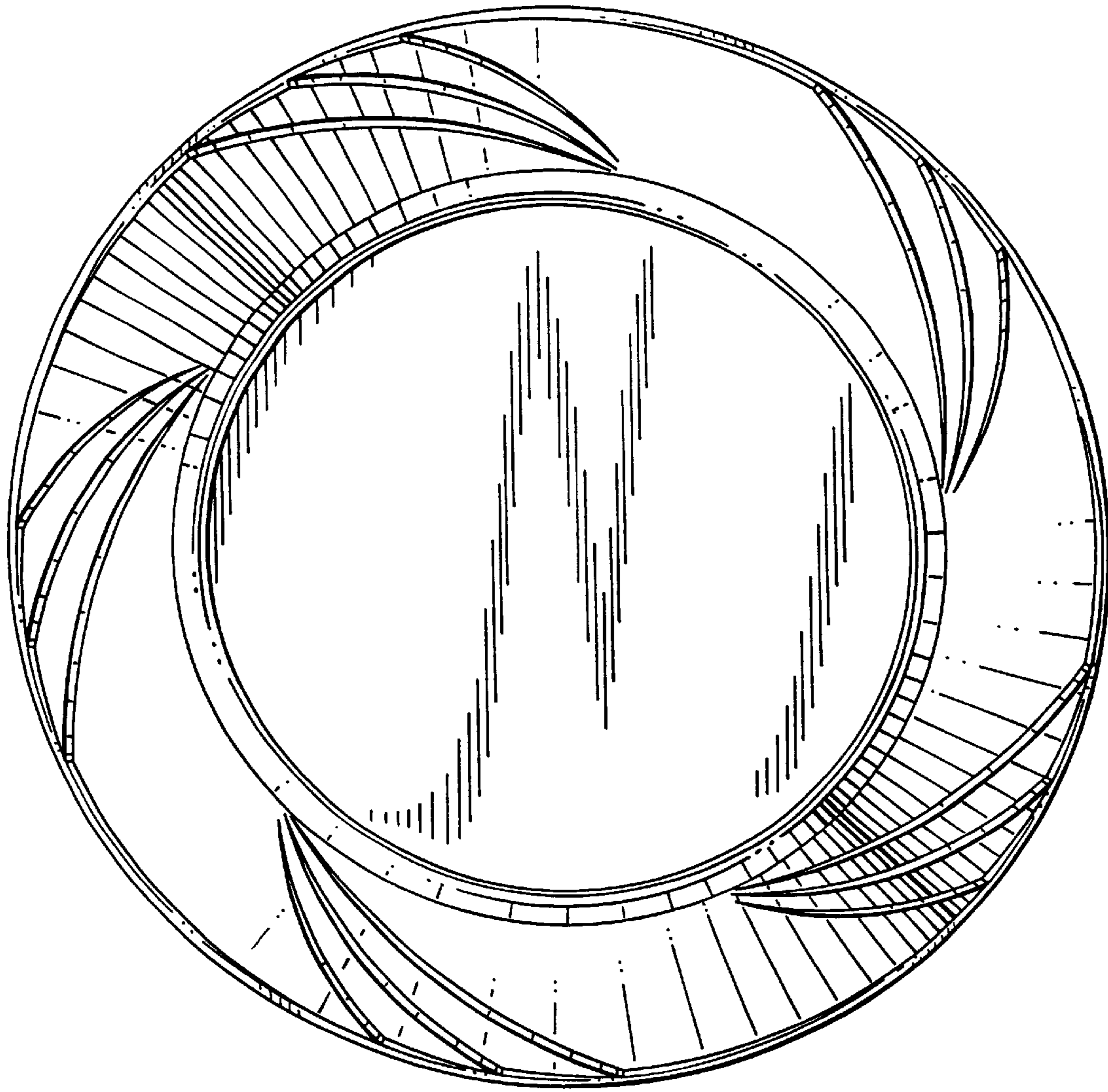

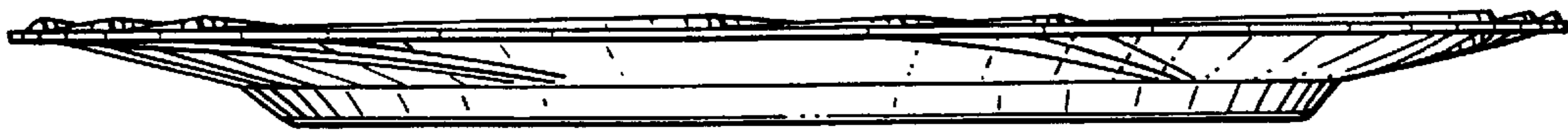
