FIG. 11 is a front view of an eleventh embodiment thereof;

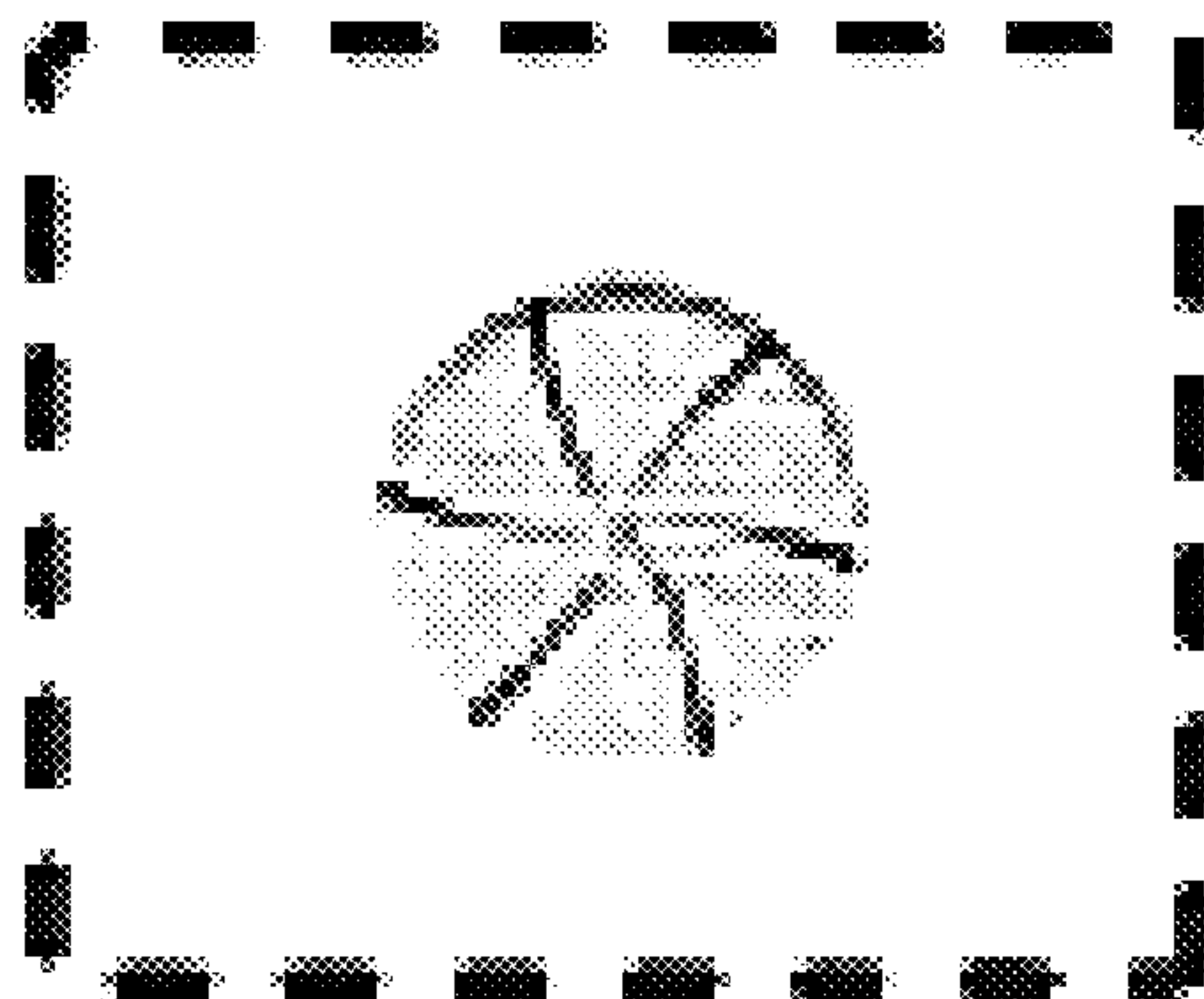

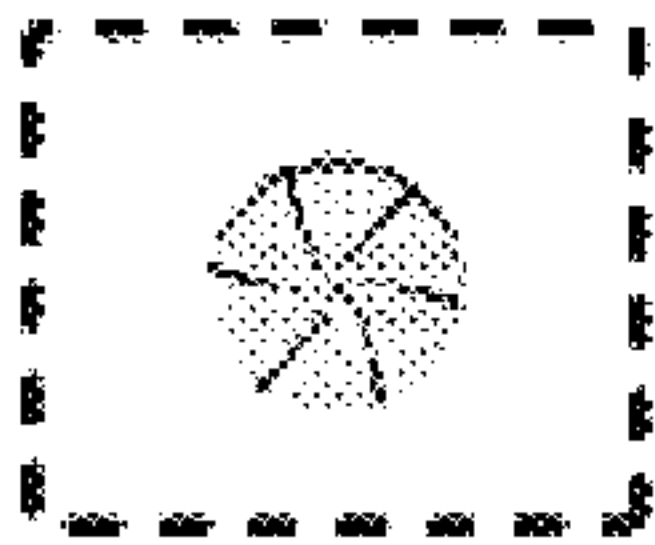

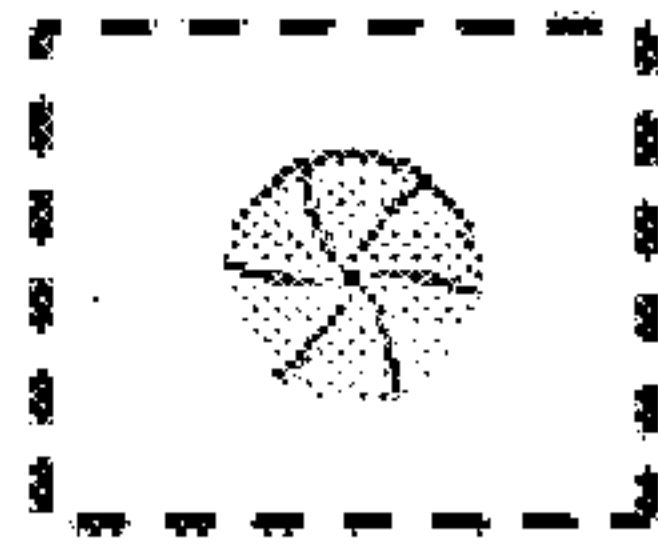

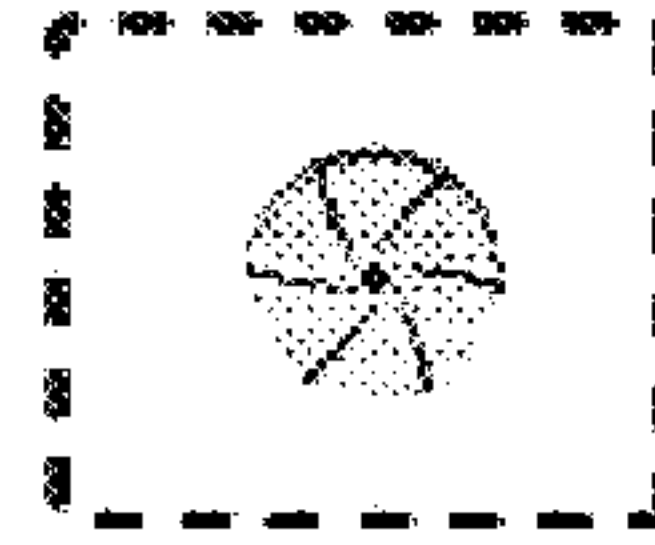

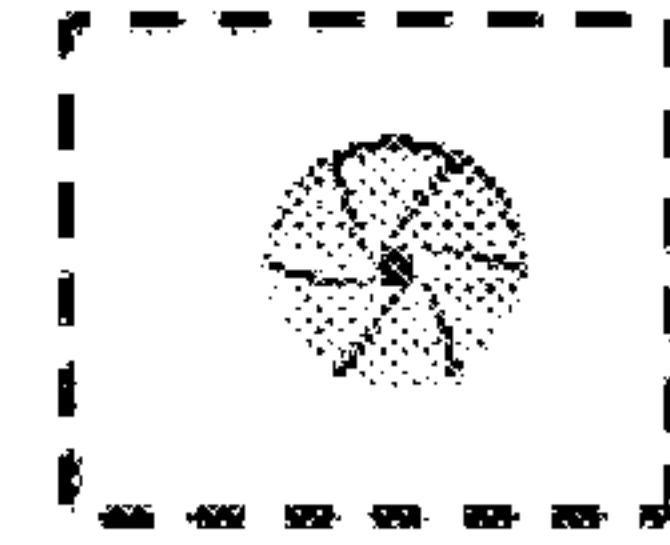

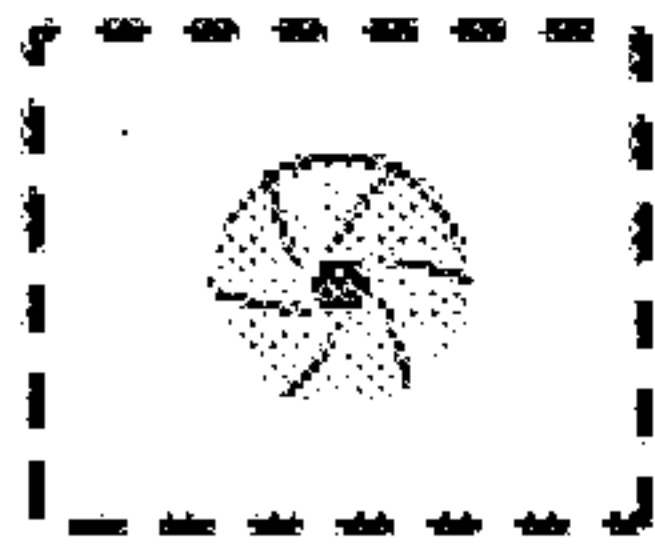

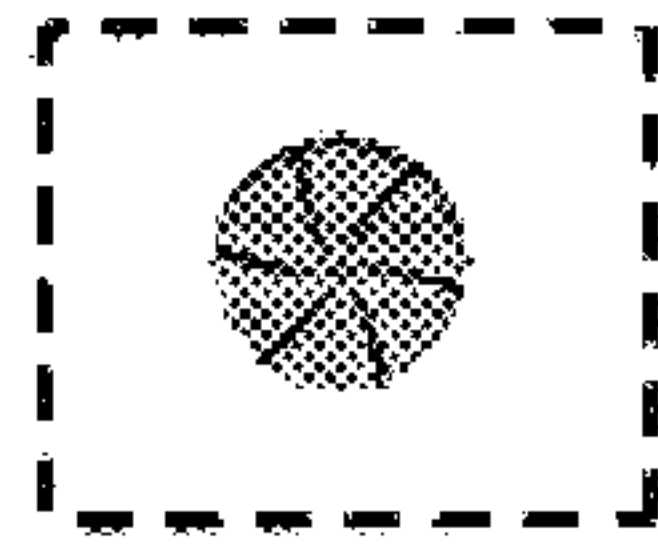

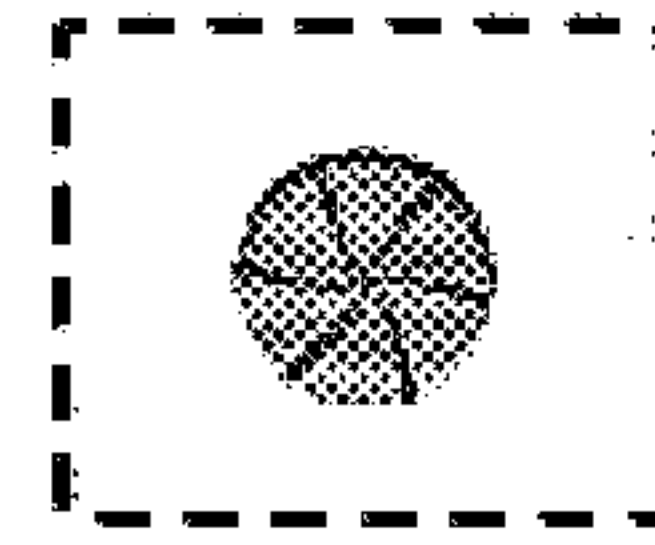

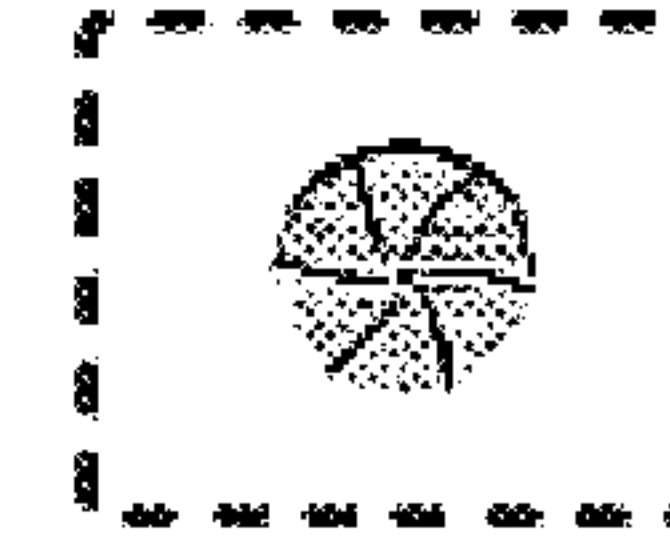

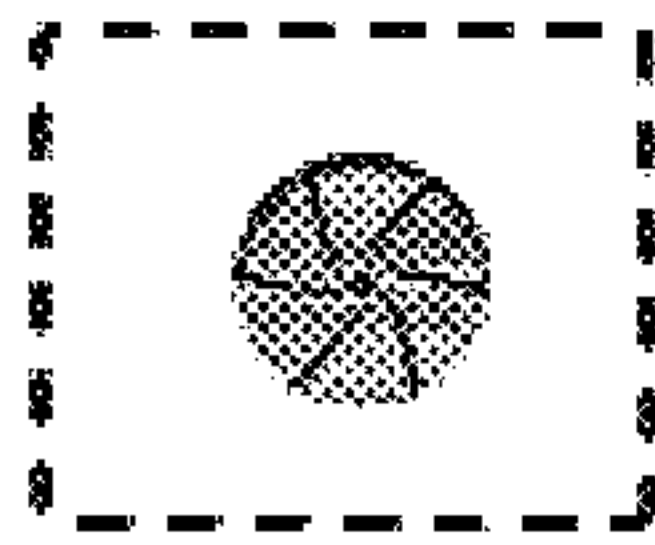

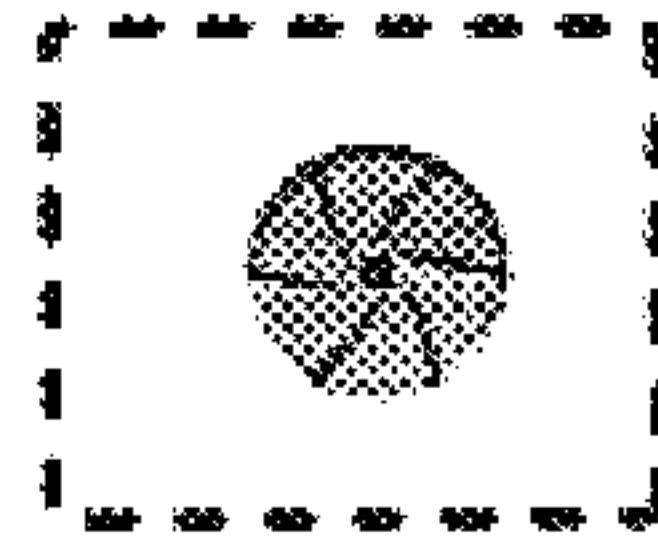

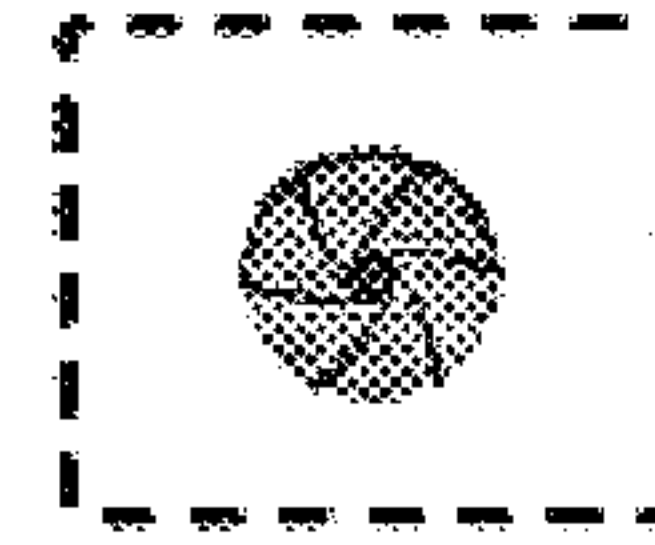

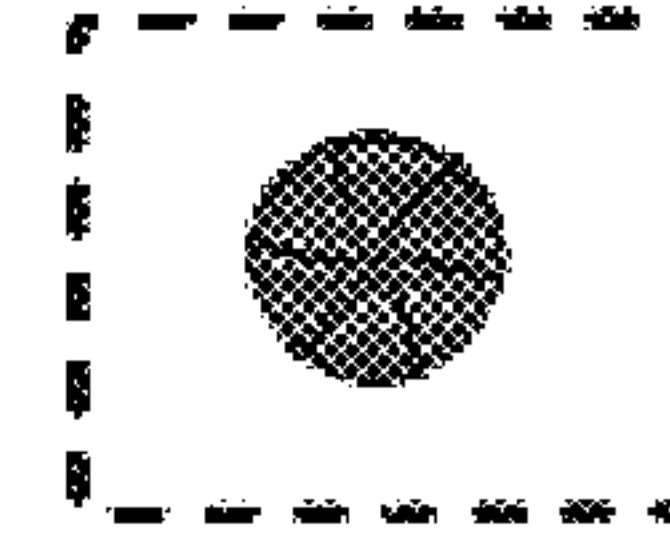
